FIG. 2 is a front elevation view thereof; the rear elevation view is a mirror image thereof;

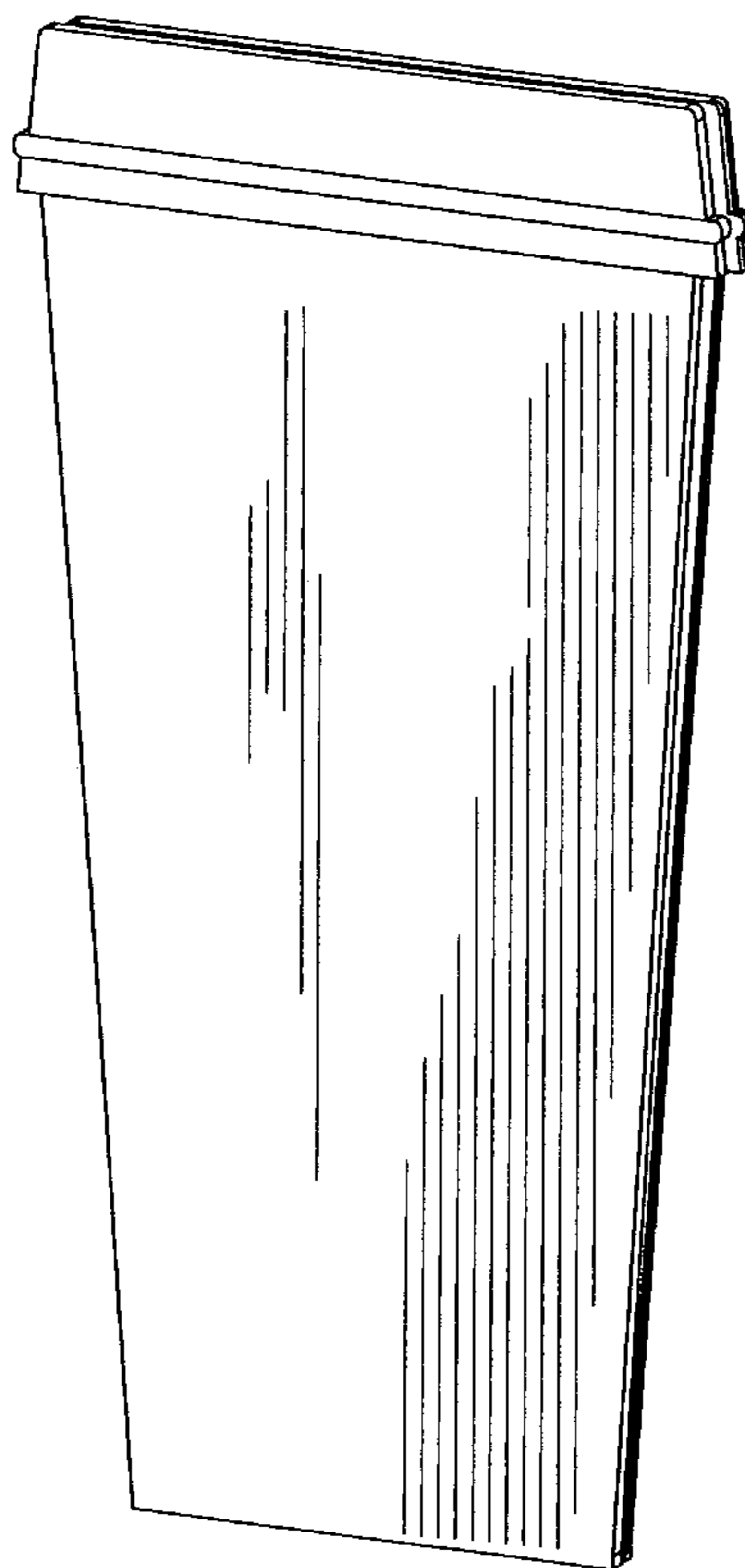
FIG. 3 is left-side elevation view thereof;

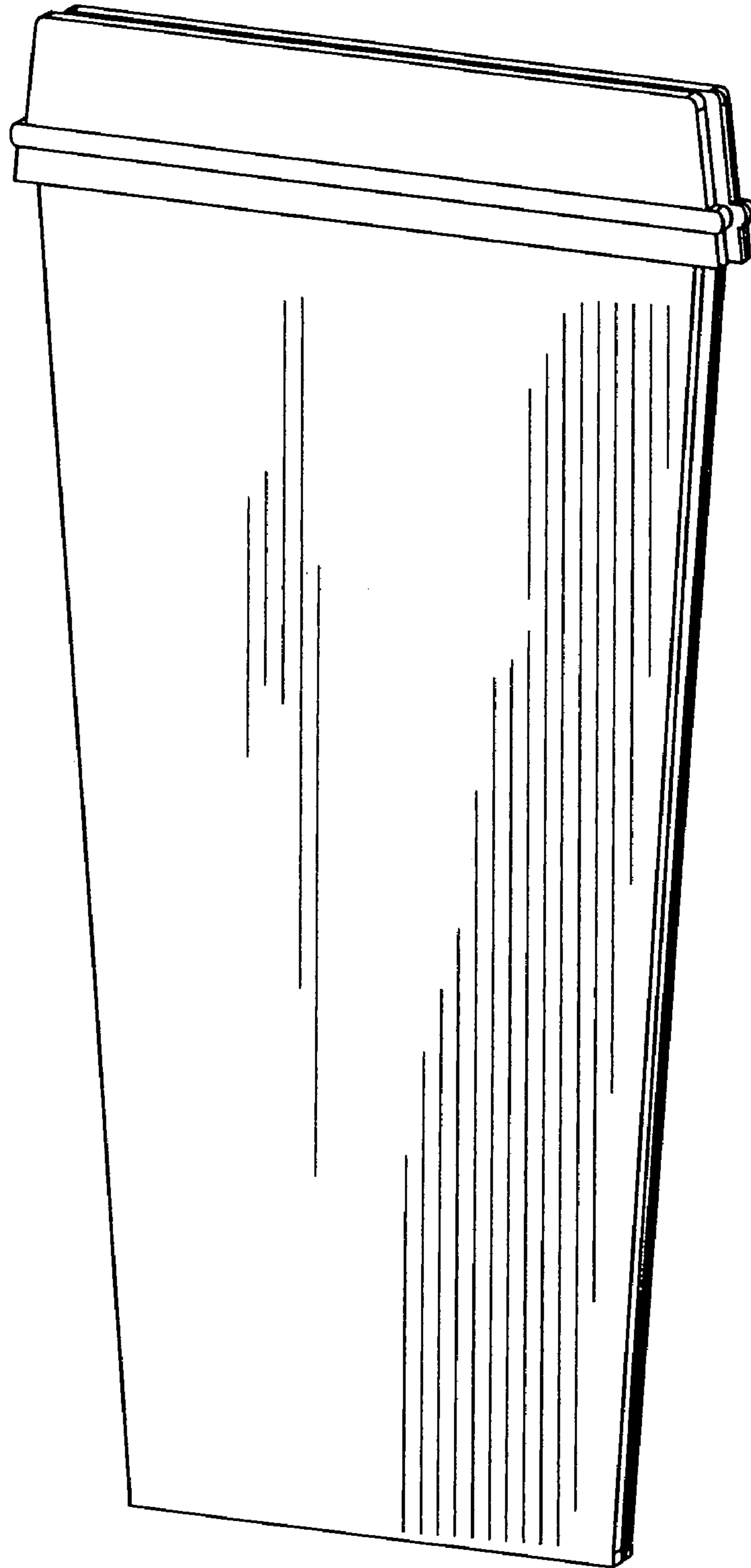

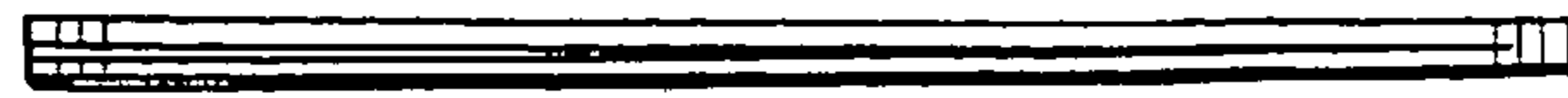

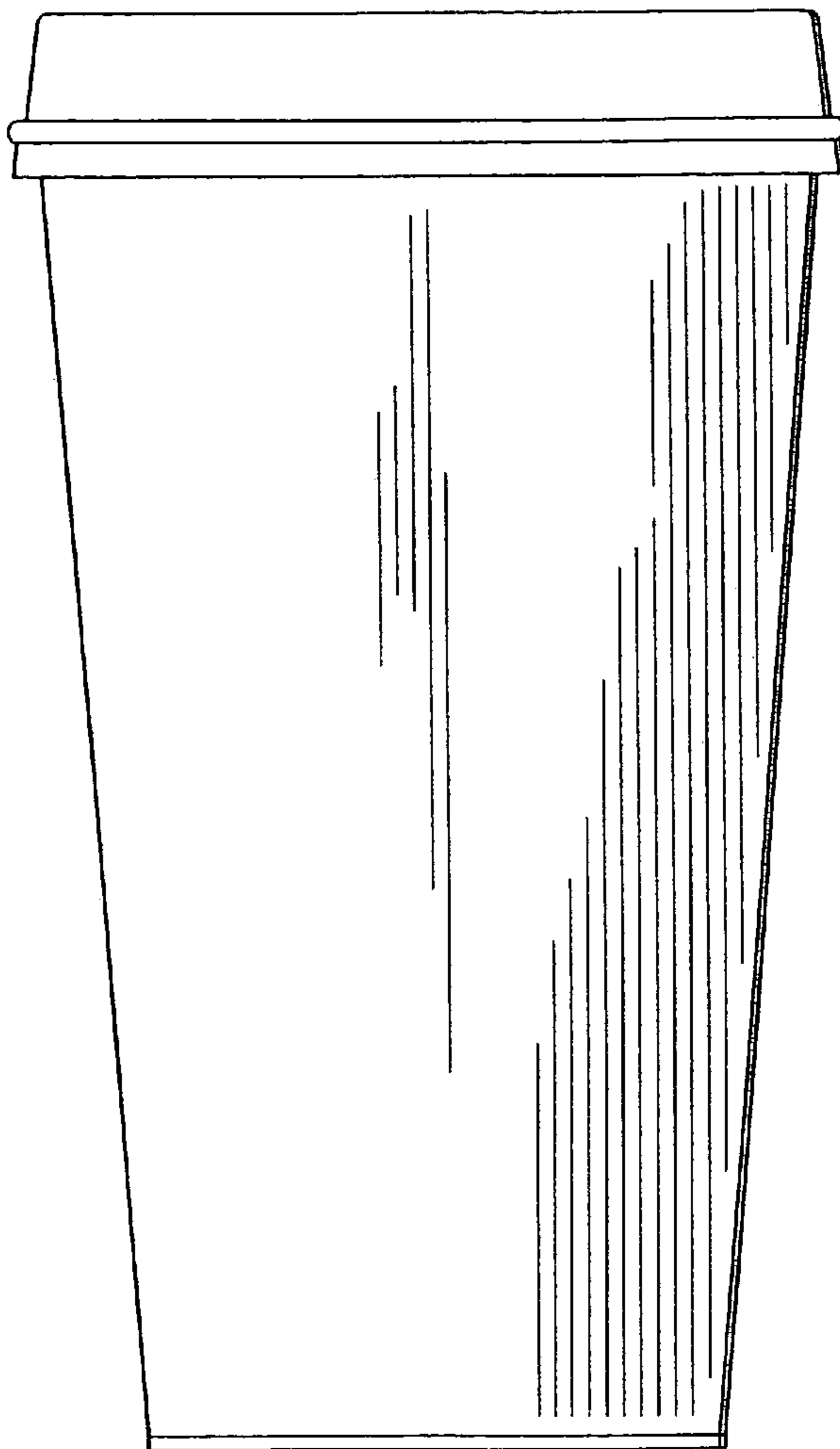
