DESCRIPTION

FIG. 1 is a front and side perspective view of a cardbar showing my new design;

FIG. 3 is a left elevational view thereof;

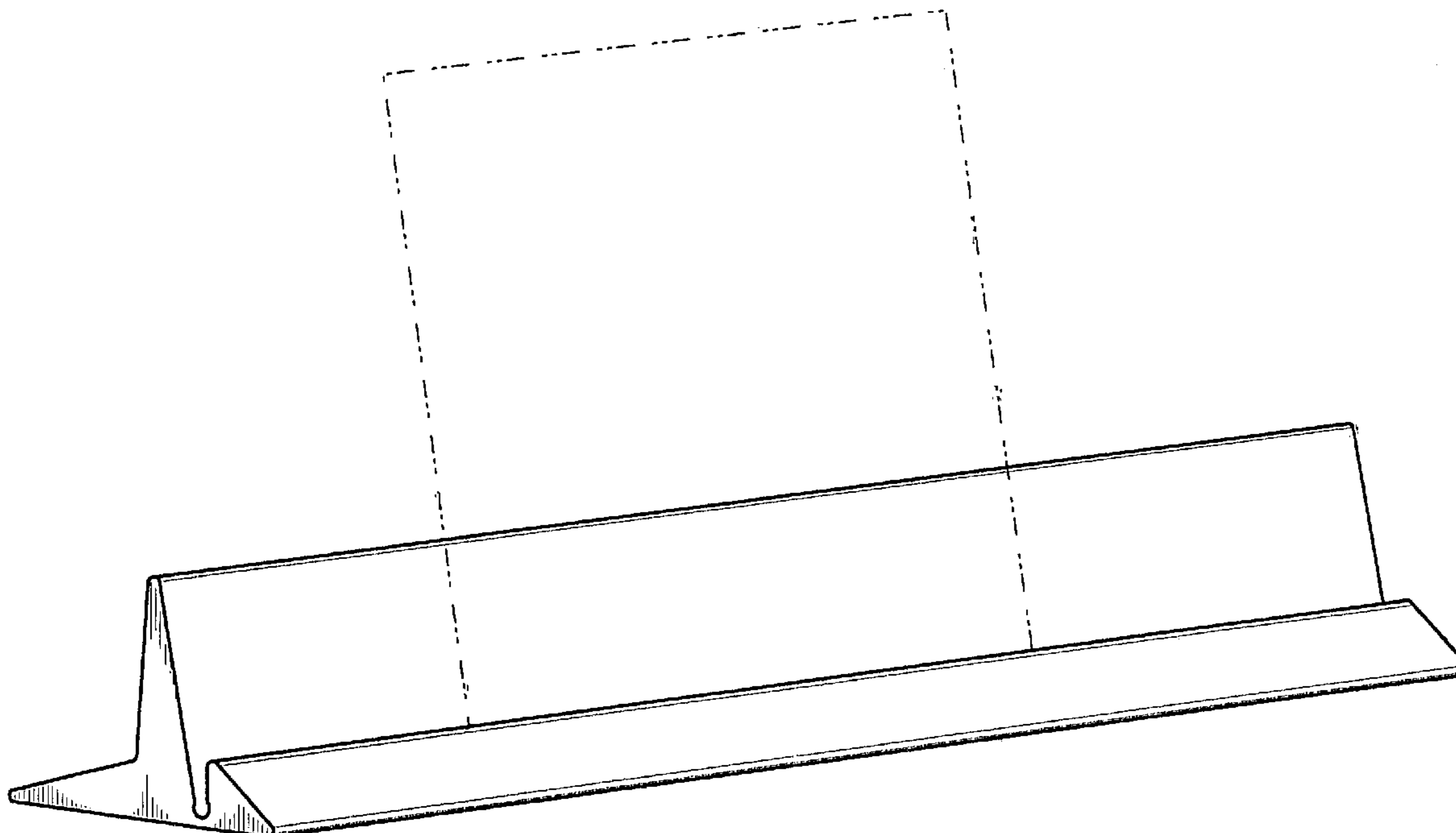
FIG. 4 is a top plan view of the cardbar thereof;

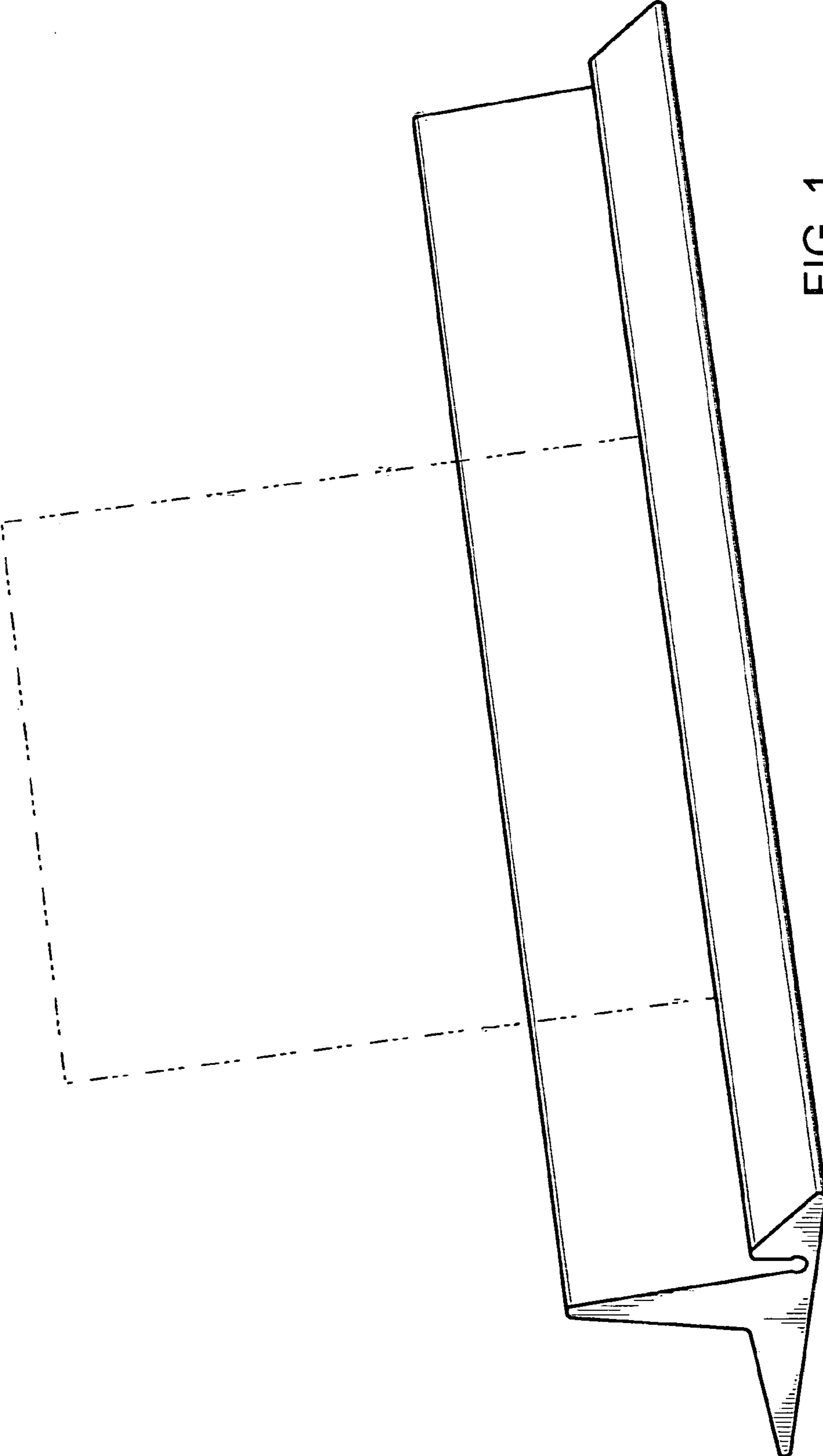

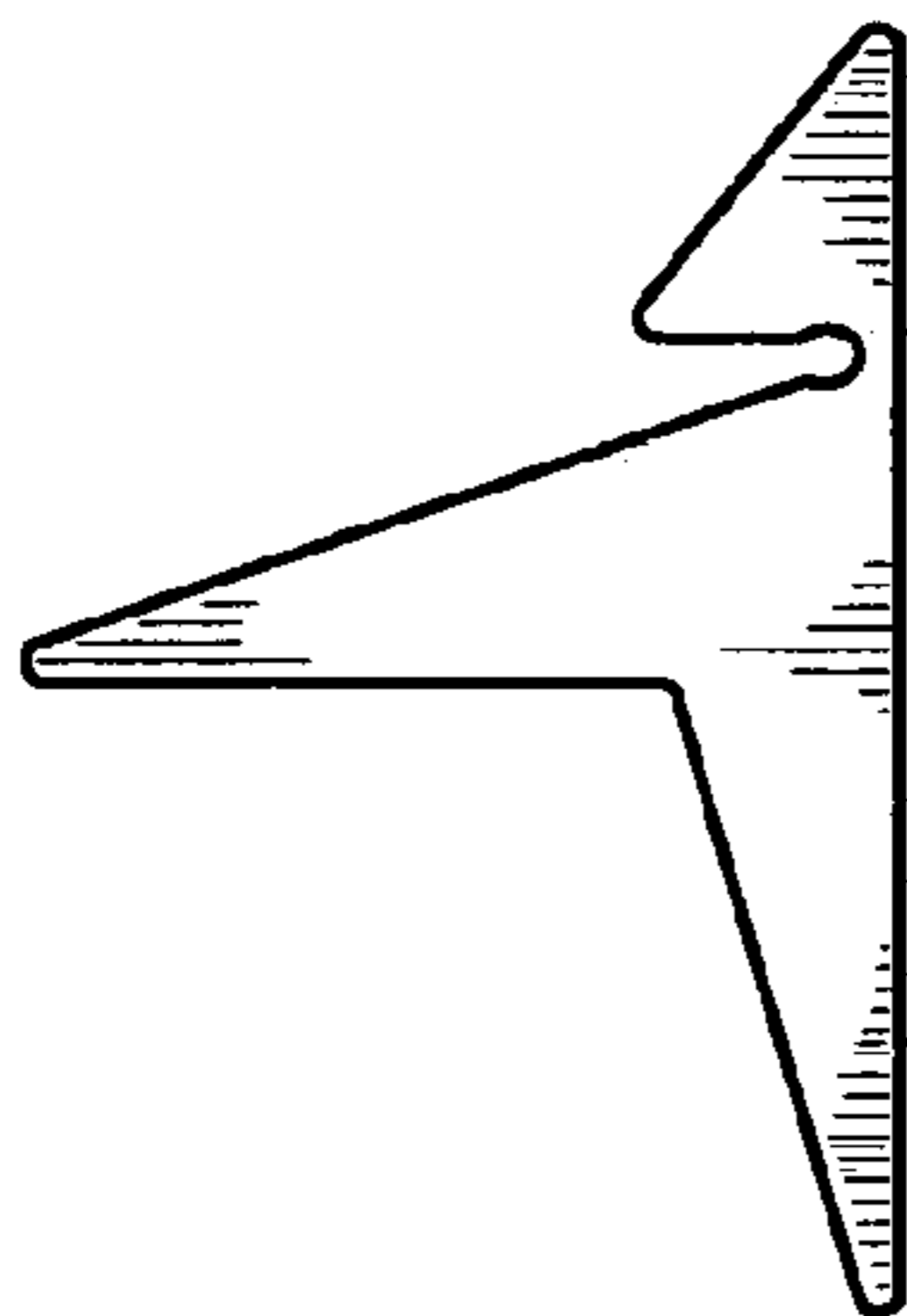

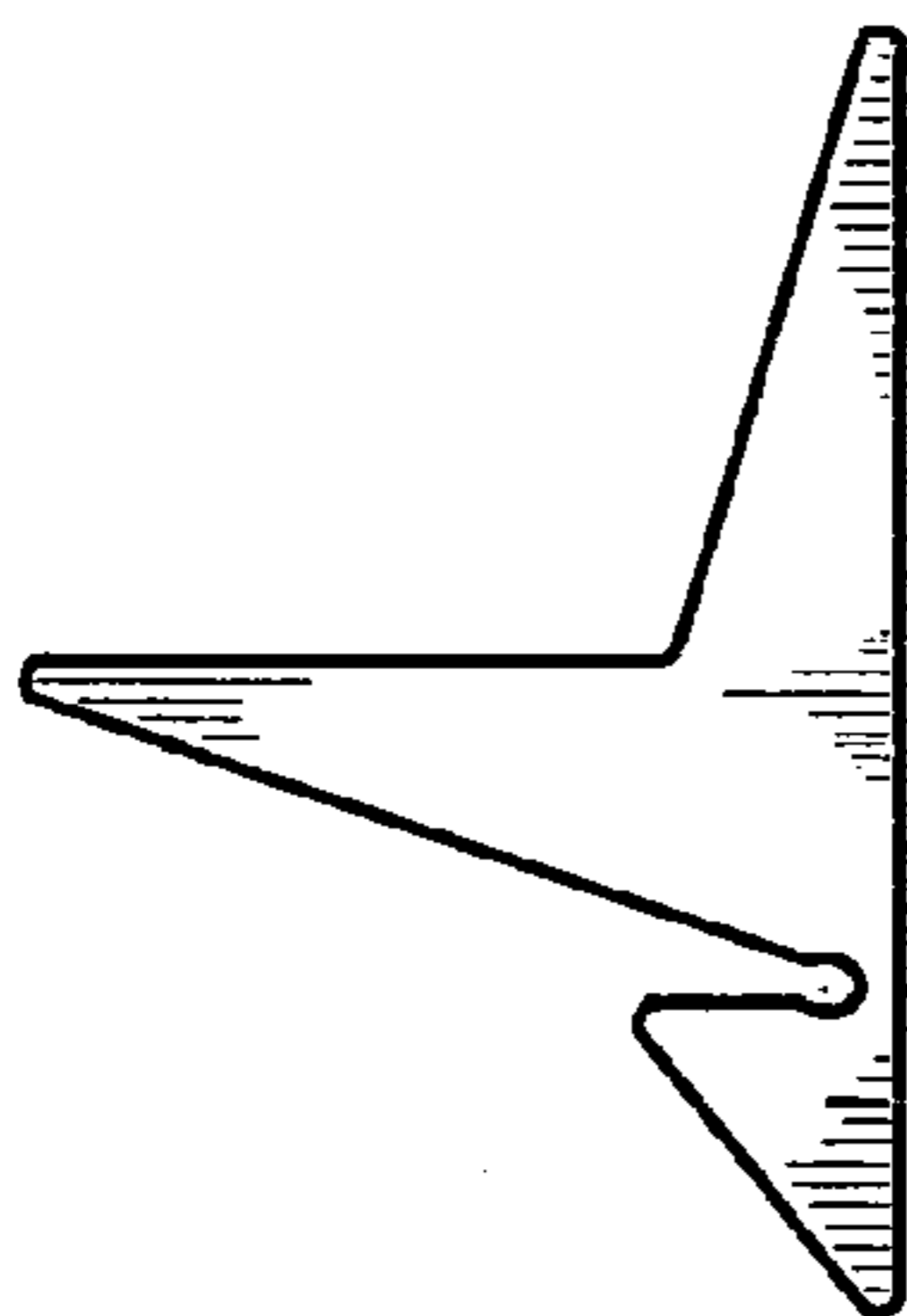

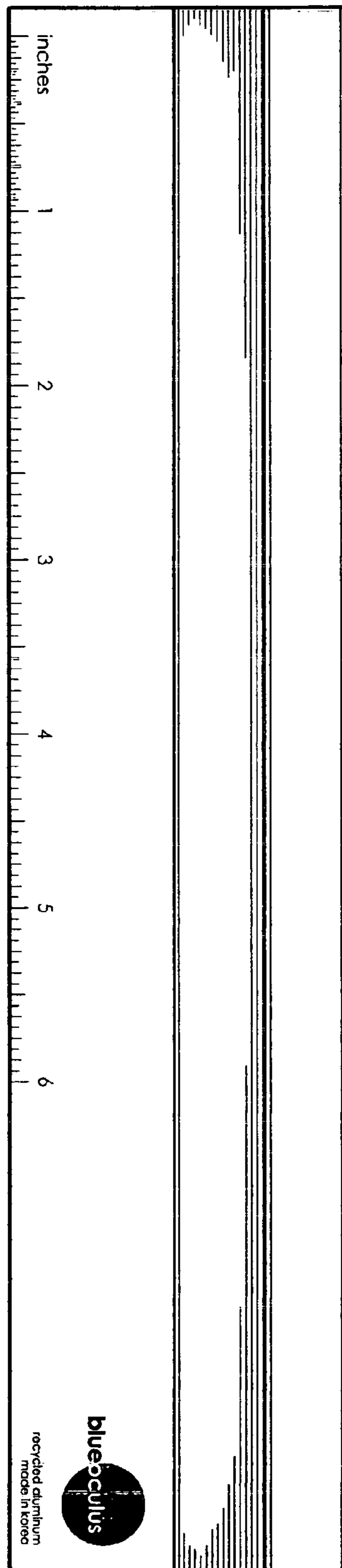

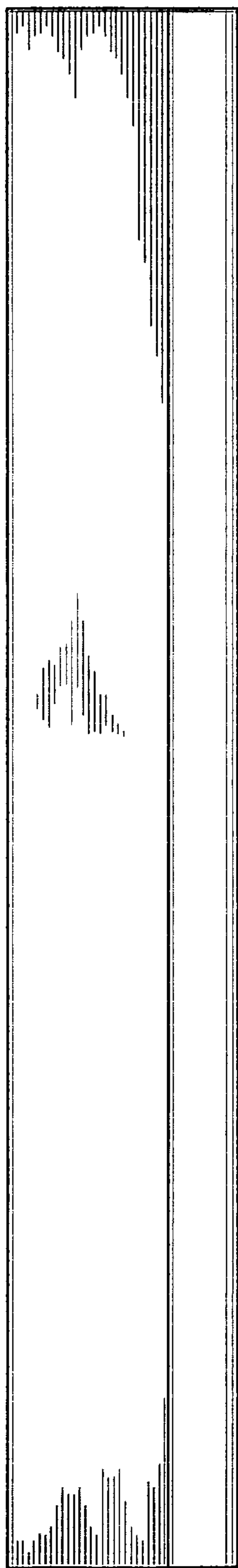

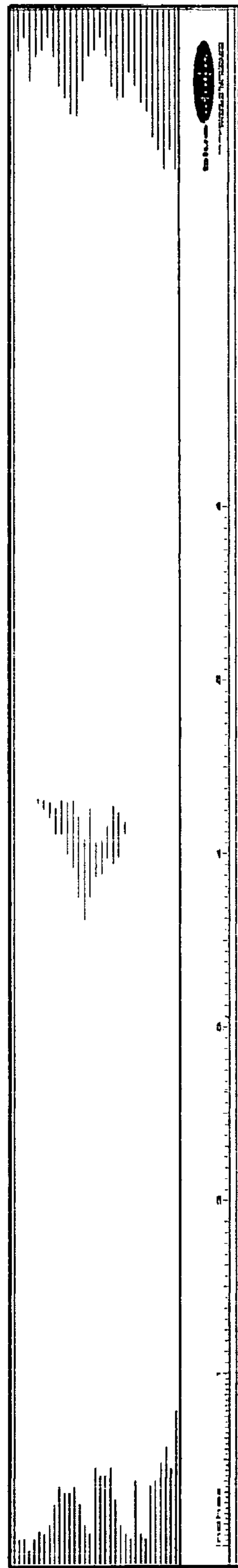
