FIG. 4 is a side elevation view of the heel of the golf club head of FIG. 1.

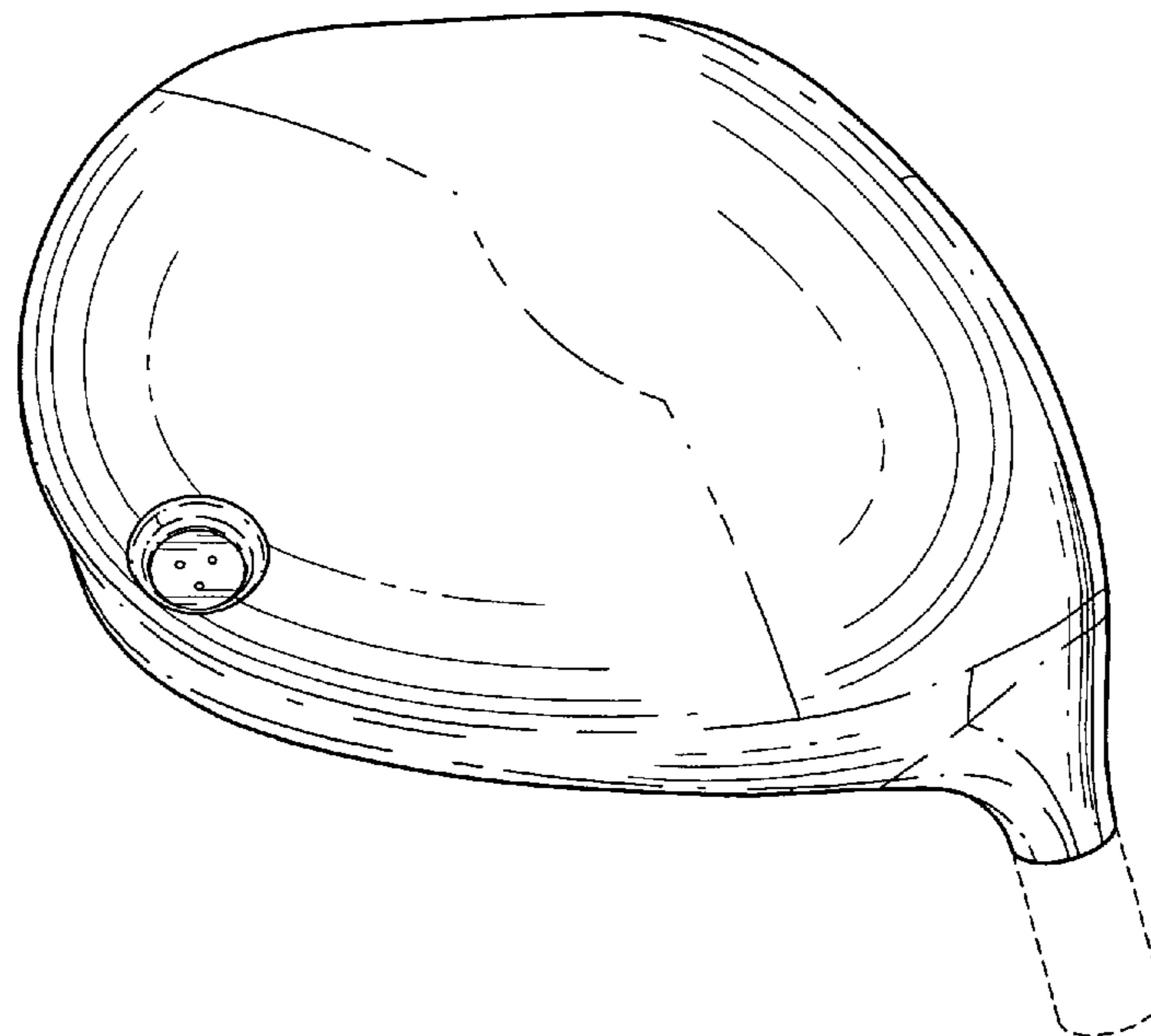
FIG. 5 is a rear elevation view of the golf club head of FIG. 1.

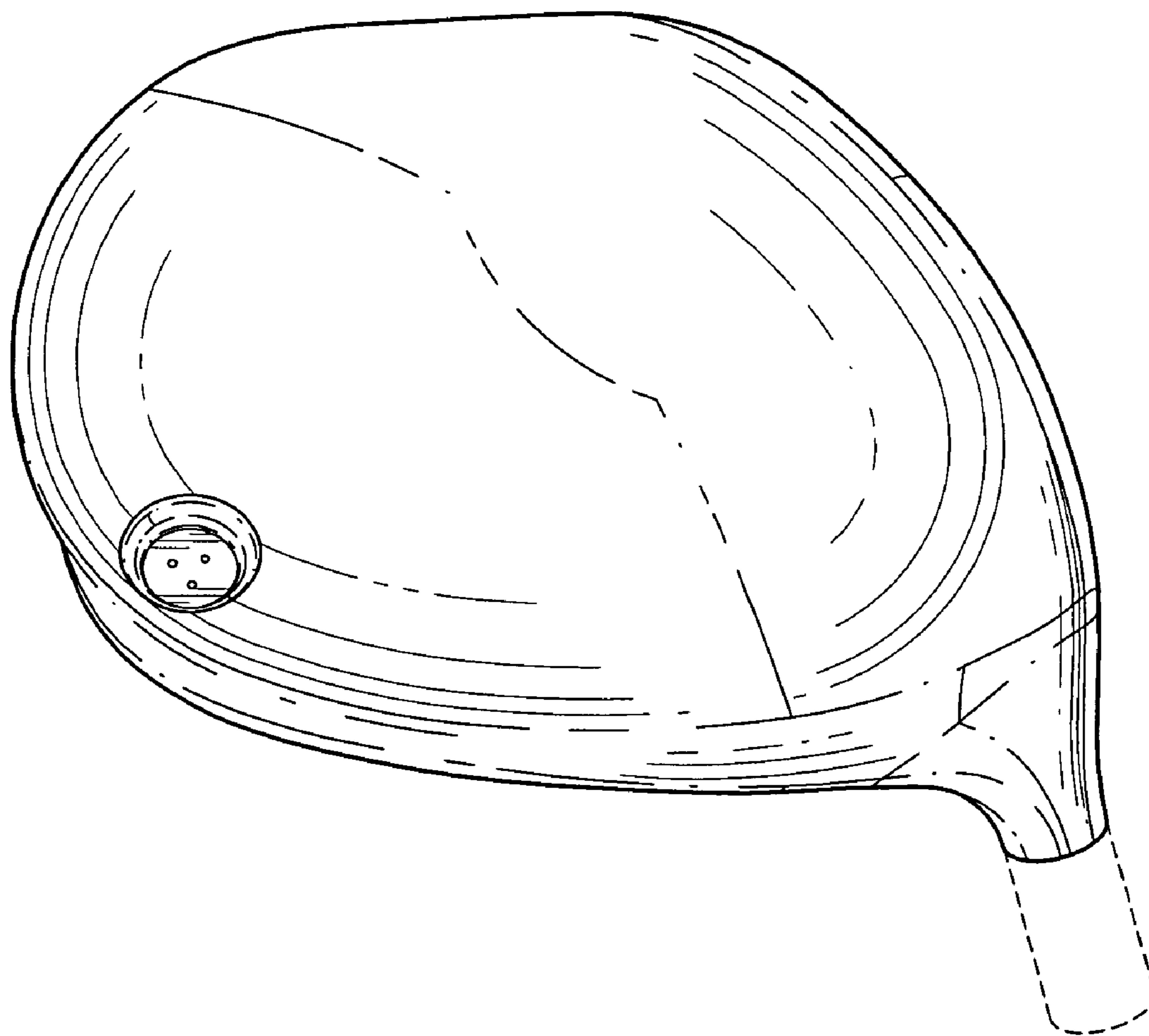

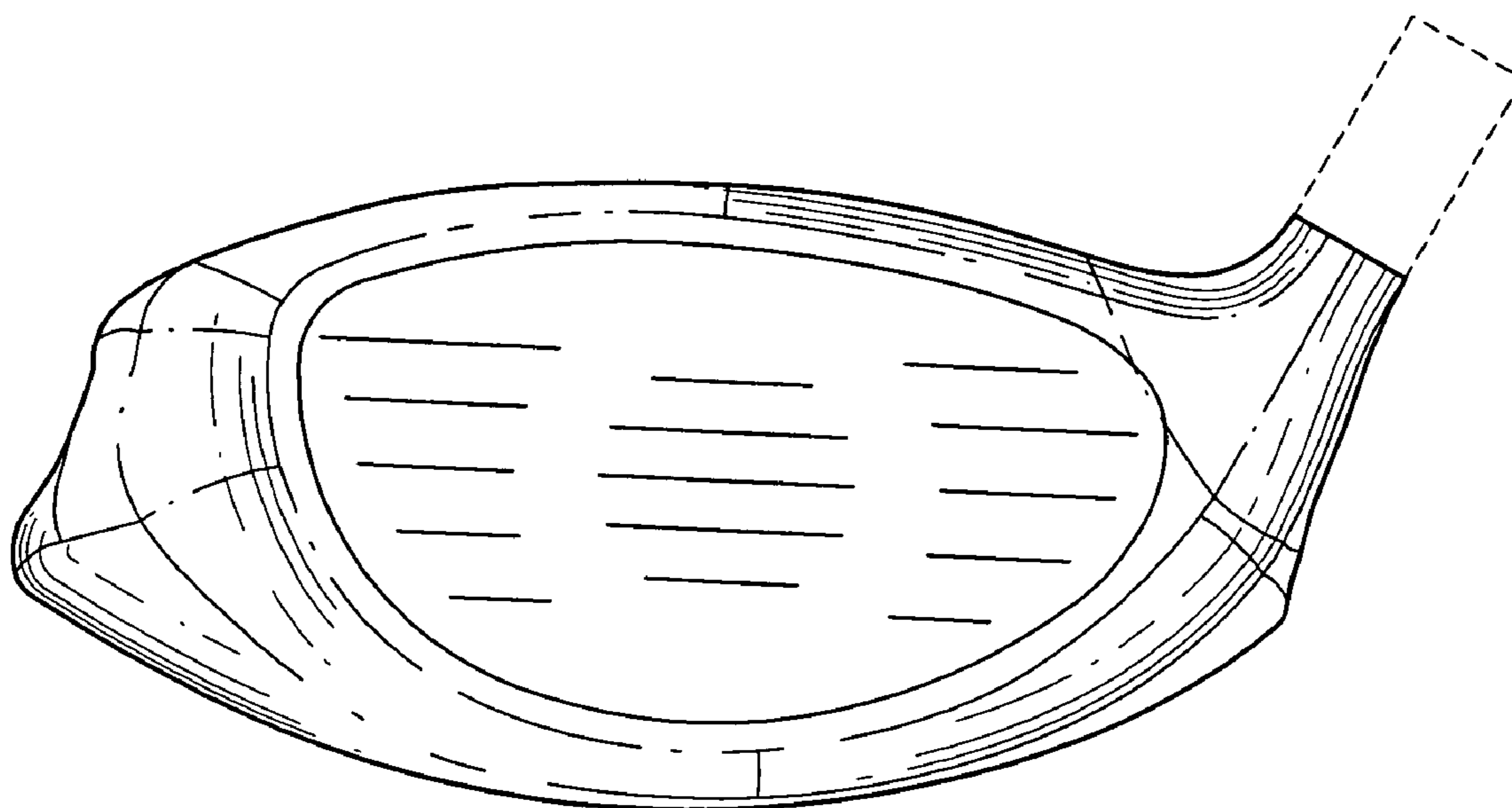

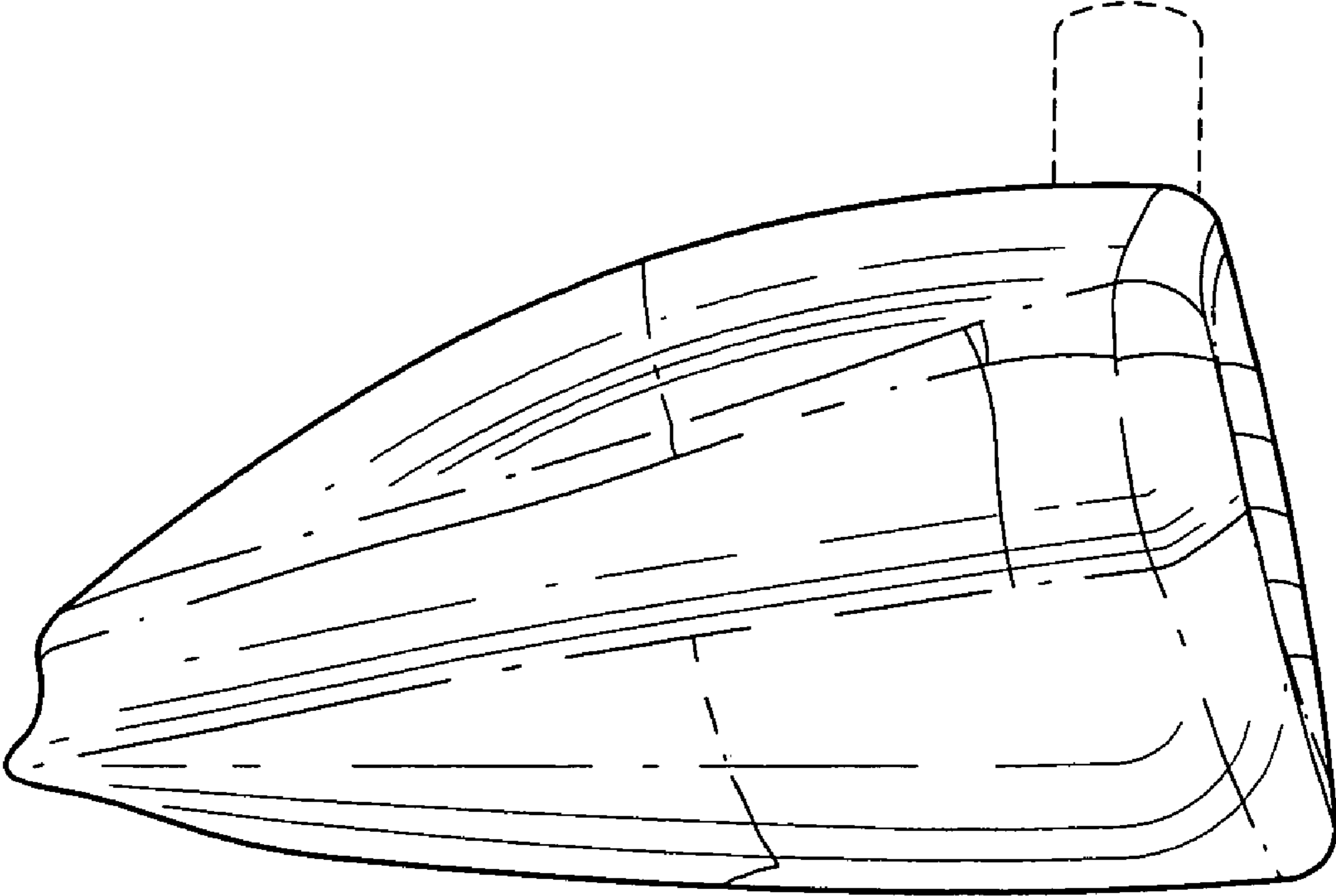

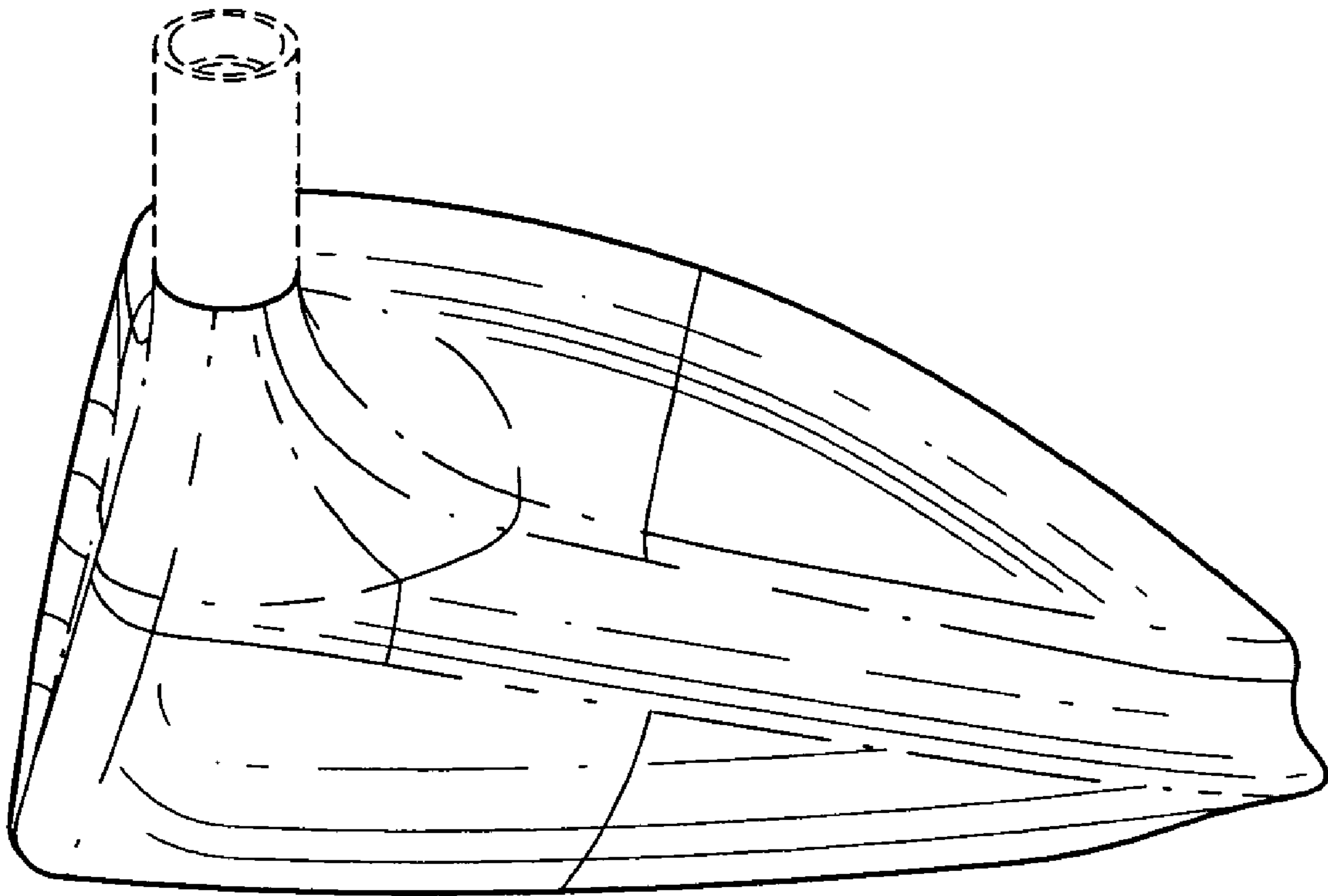

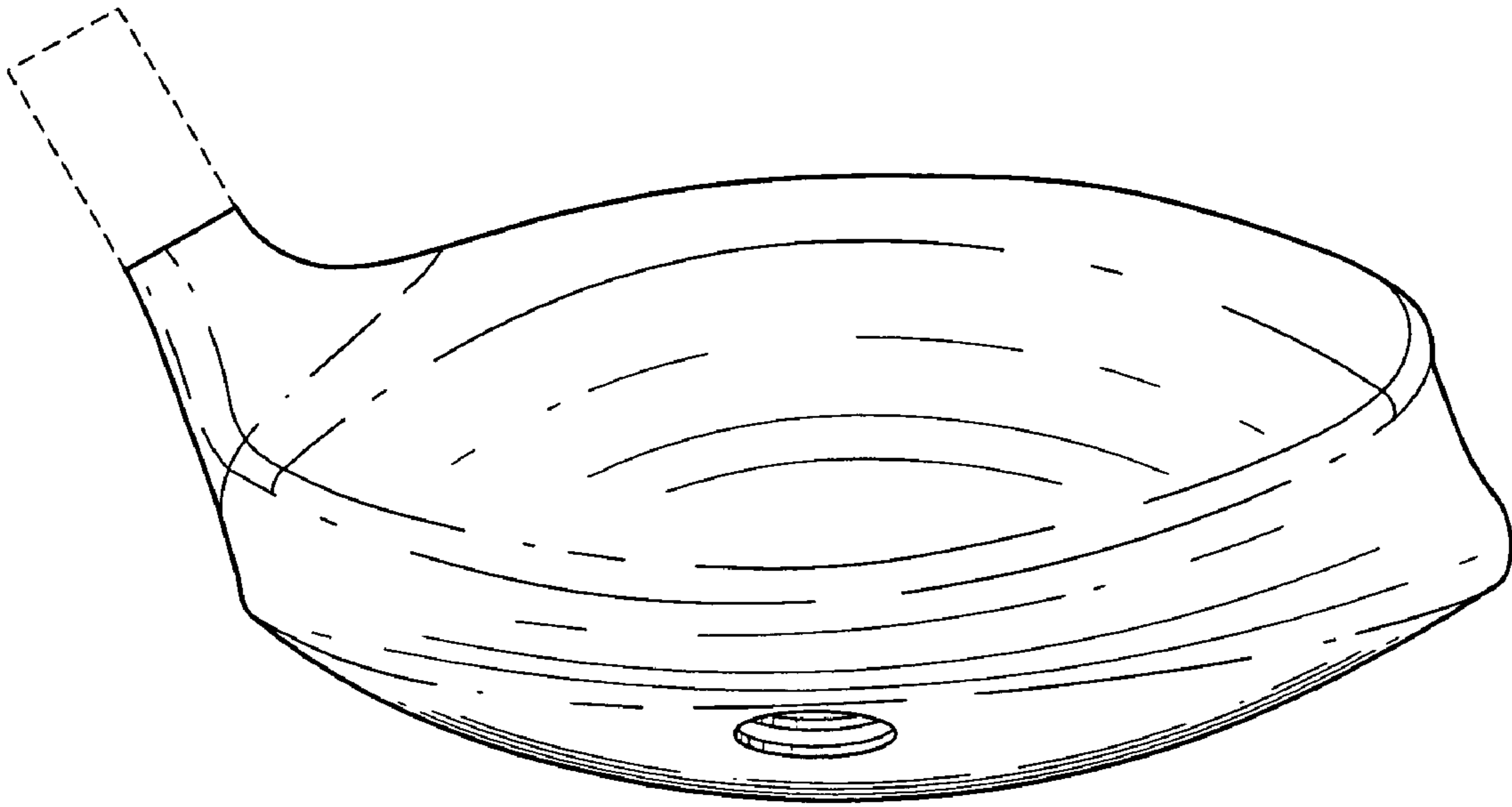

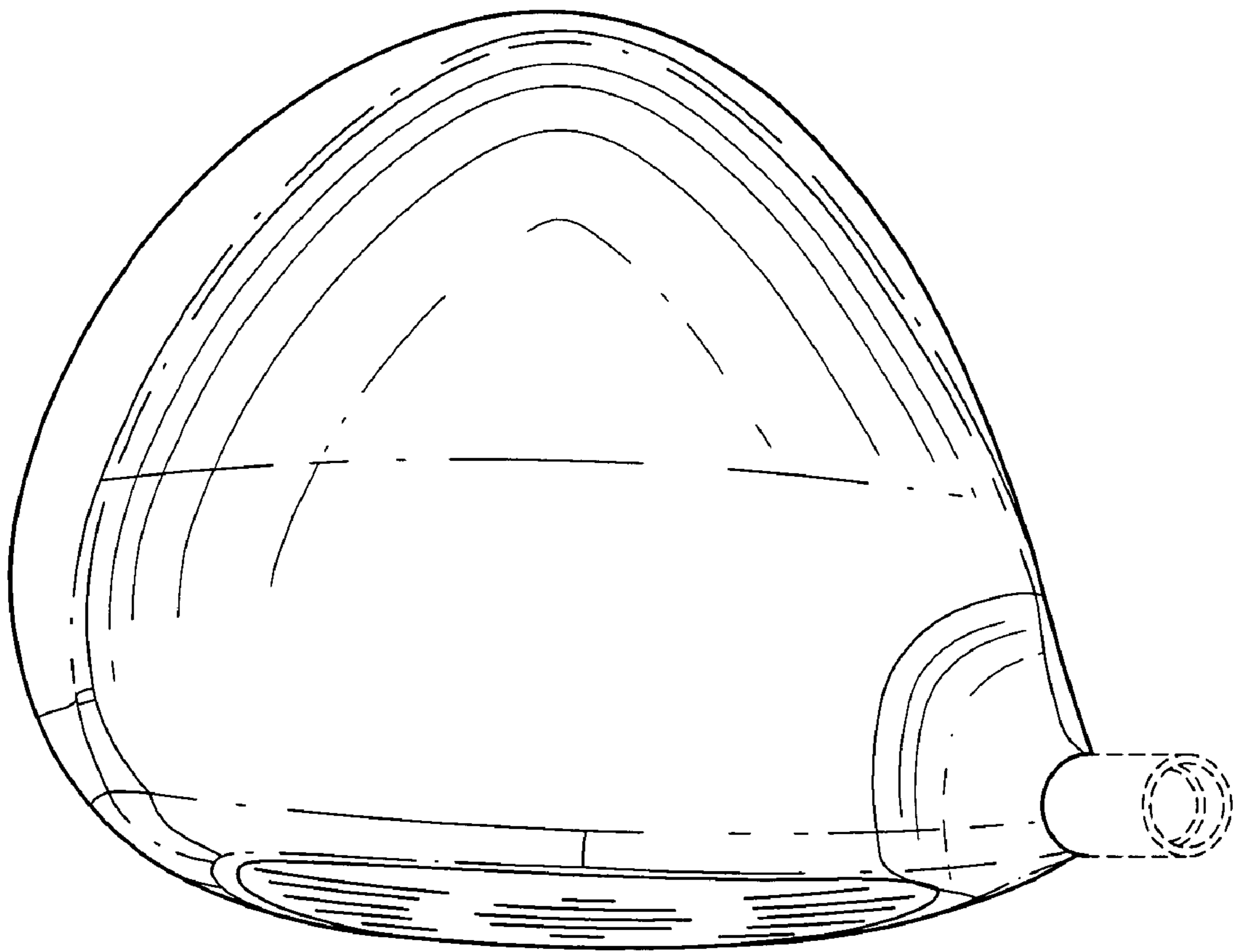

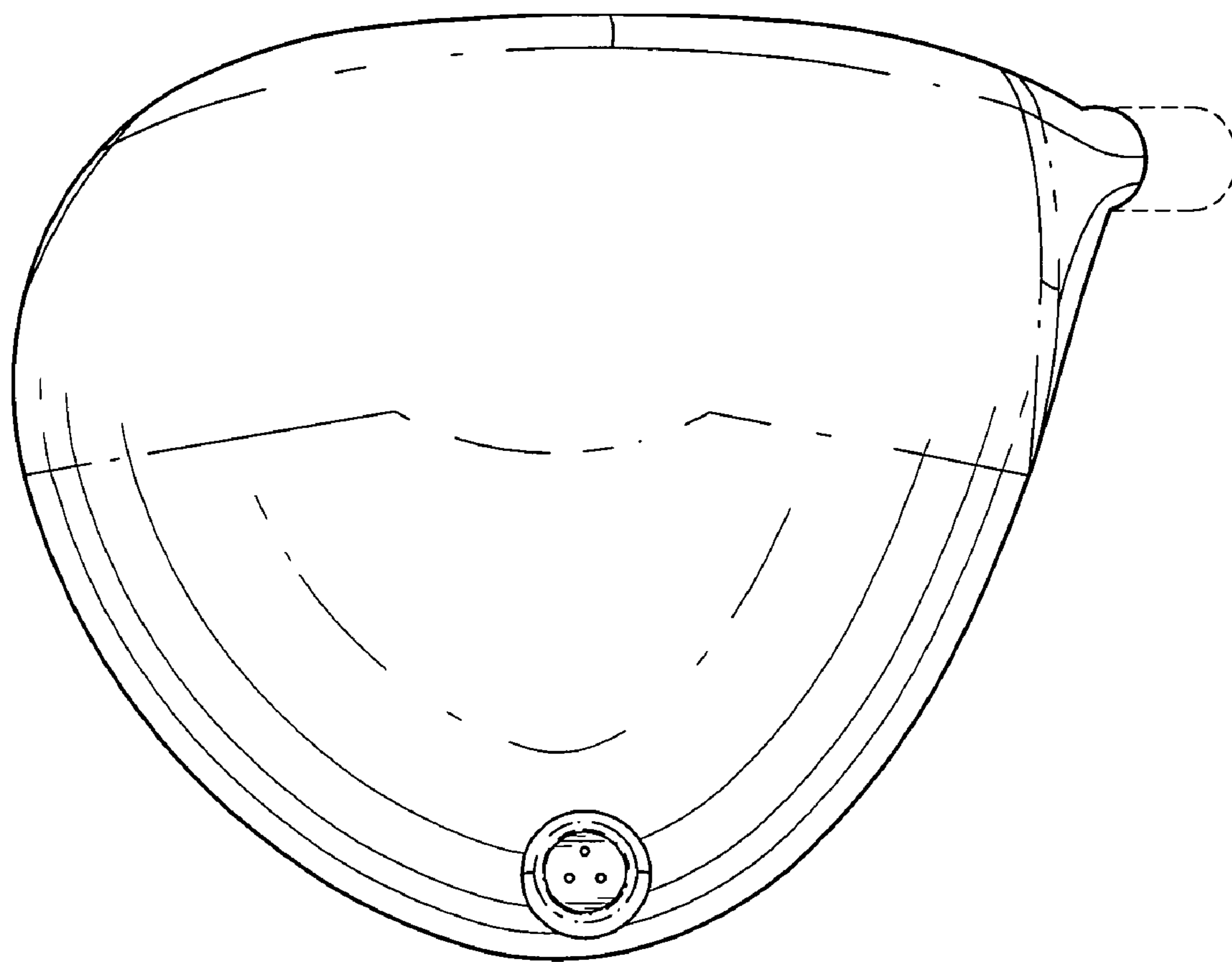
