The ornamental design for a vent cover, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of the vent cover;

FIG. 2 is a top view thereof, the bottom view being a mirror image;

FIG. 3 is a side view thereof, the opposite side view being a mirror image;

FIG. 4 is an end view thereof, the opposite end view being a mirror image;

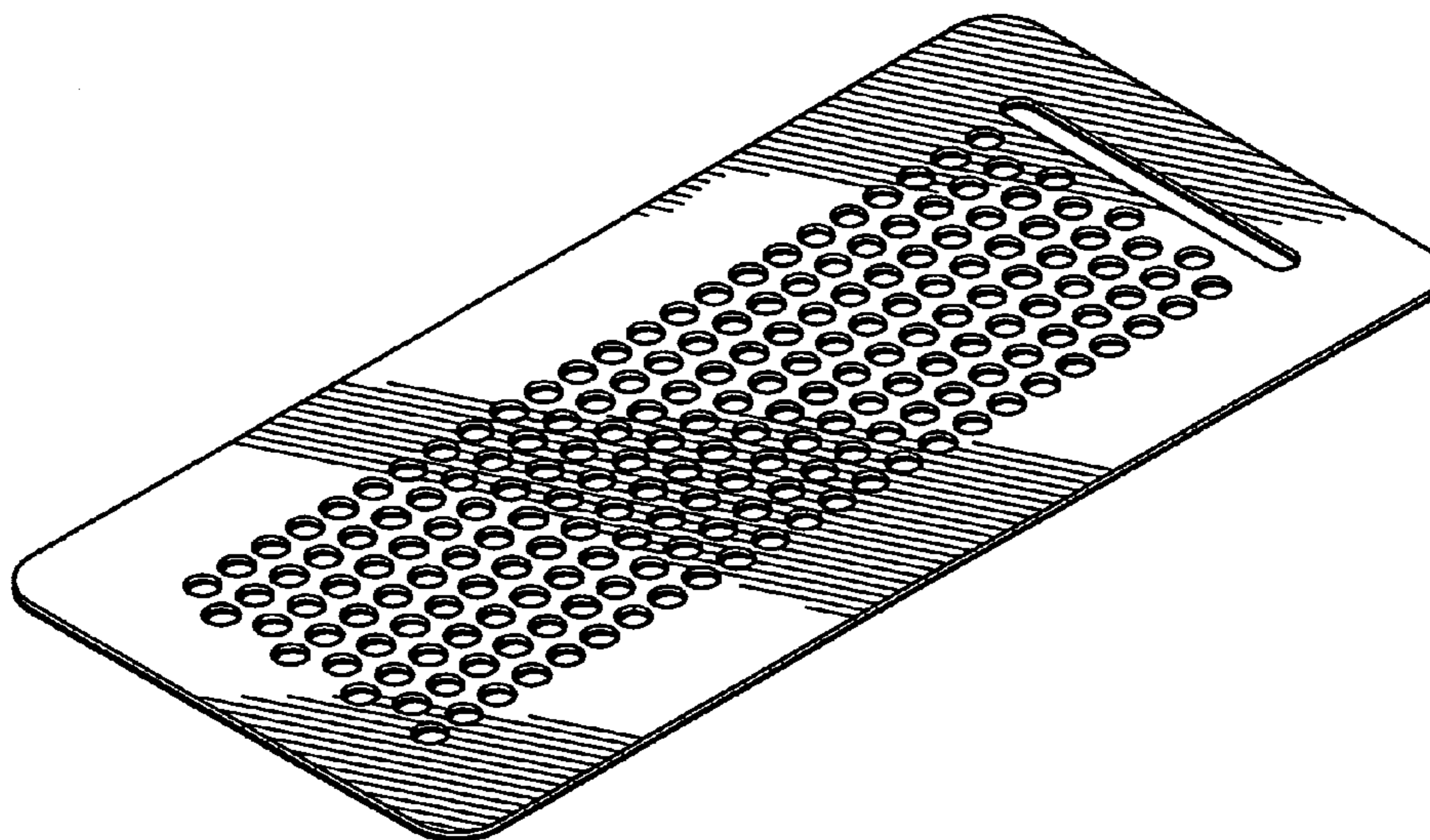
FIG. 5 is a perspective view of a second embodiment of the vent cover;

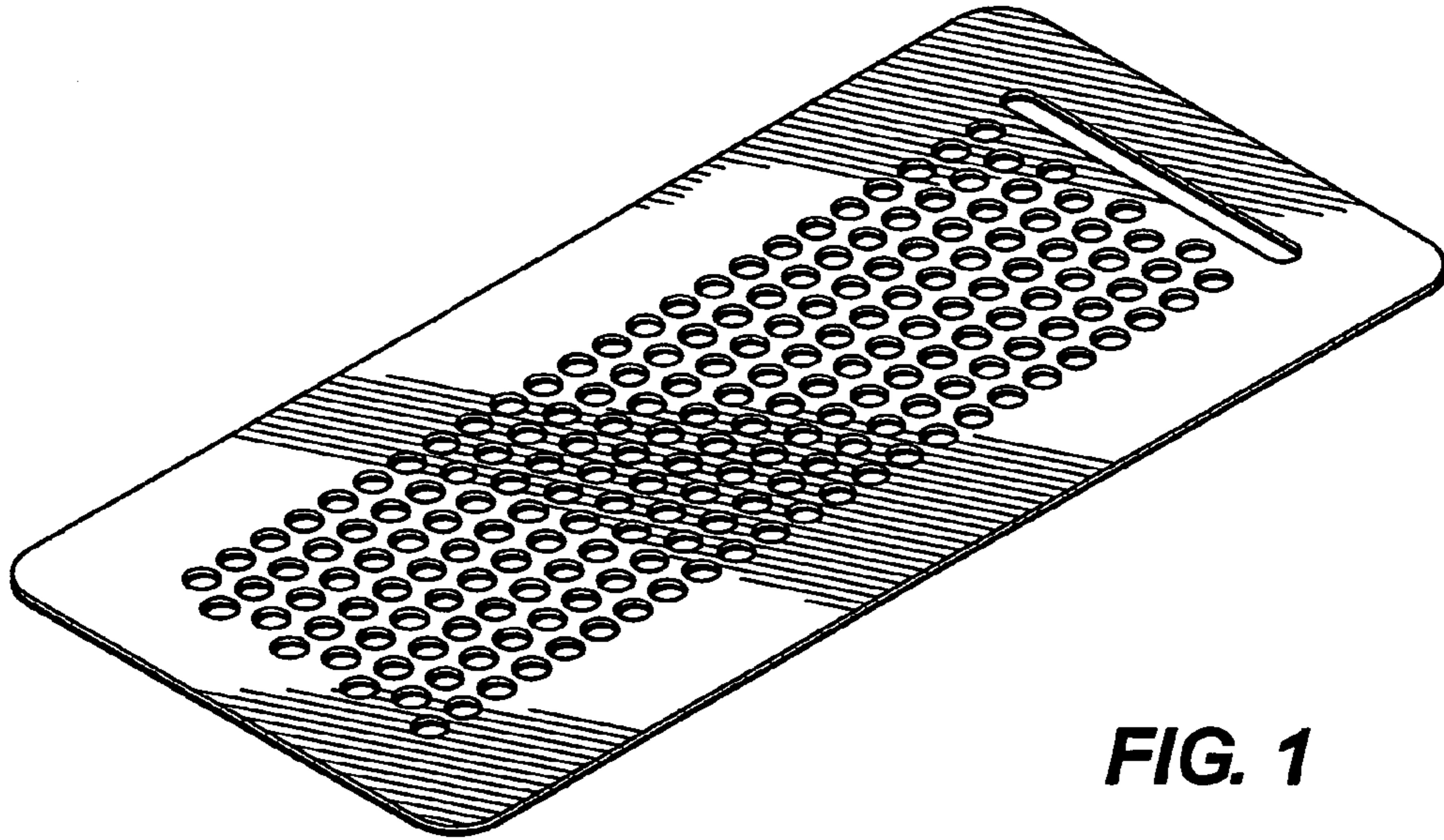

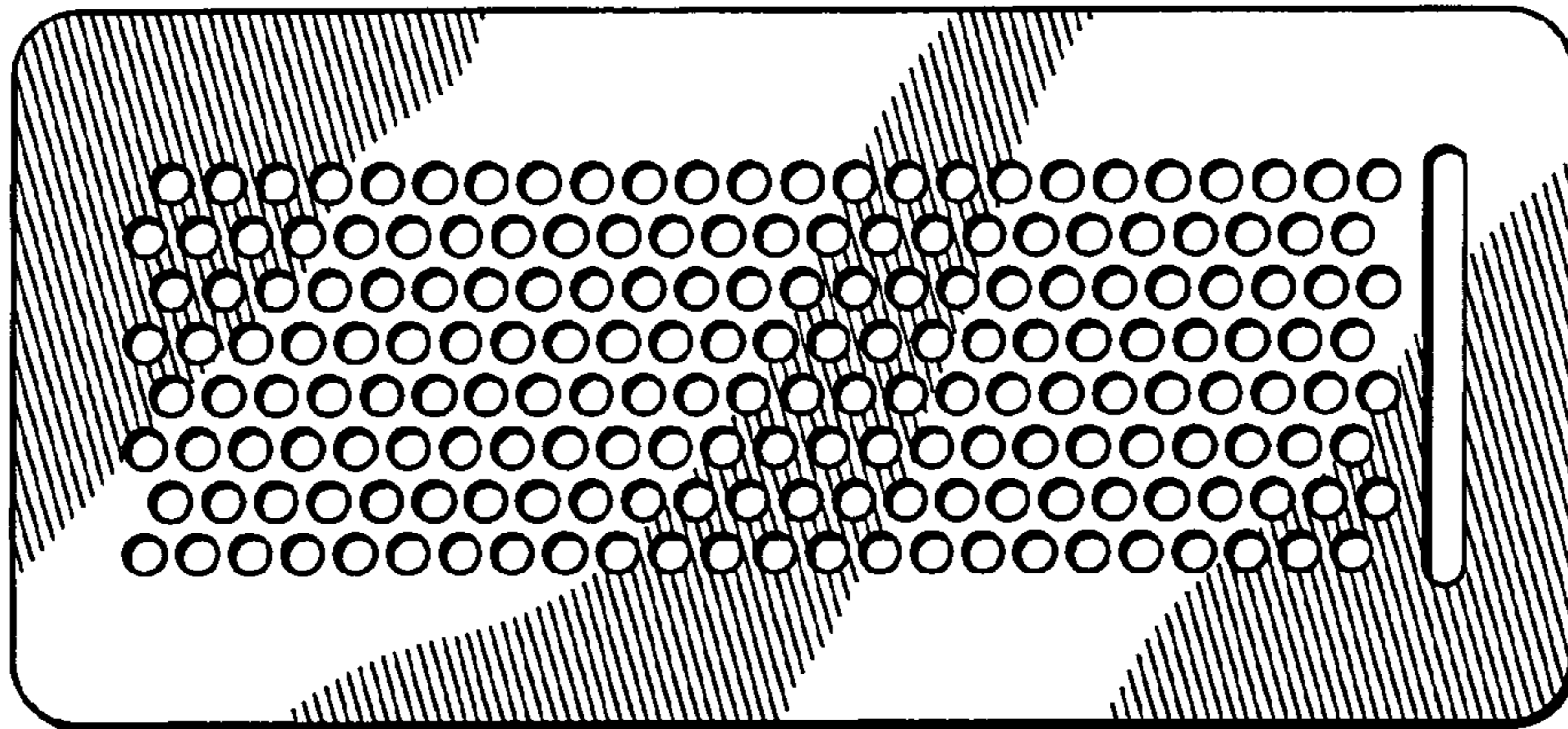

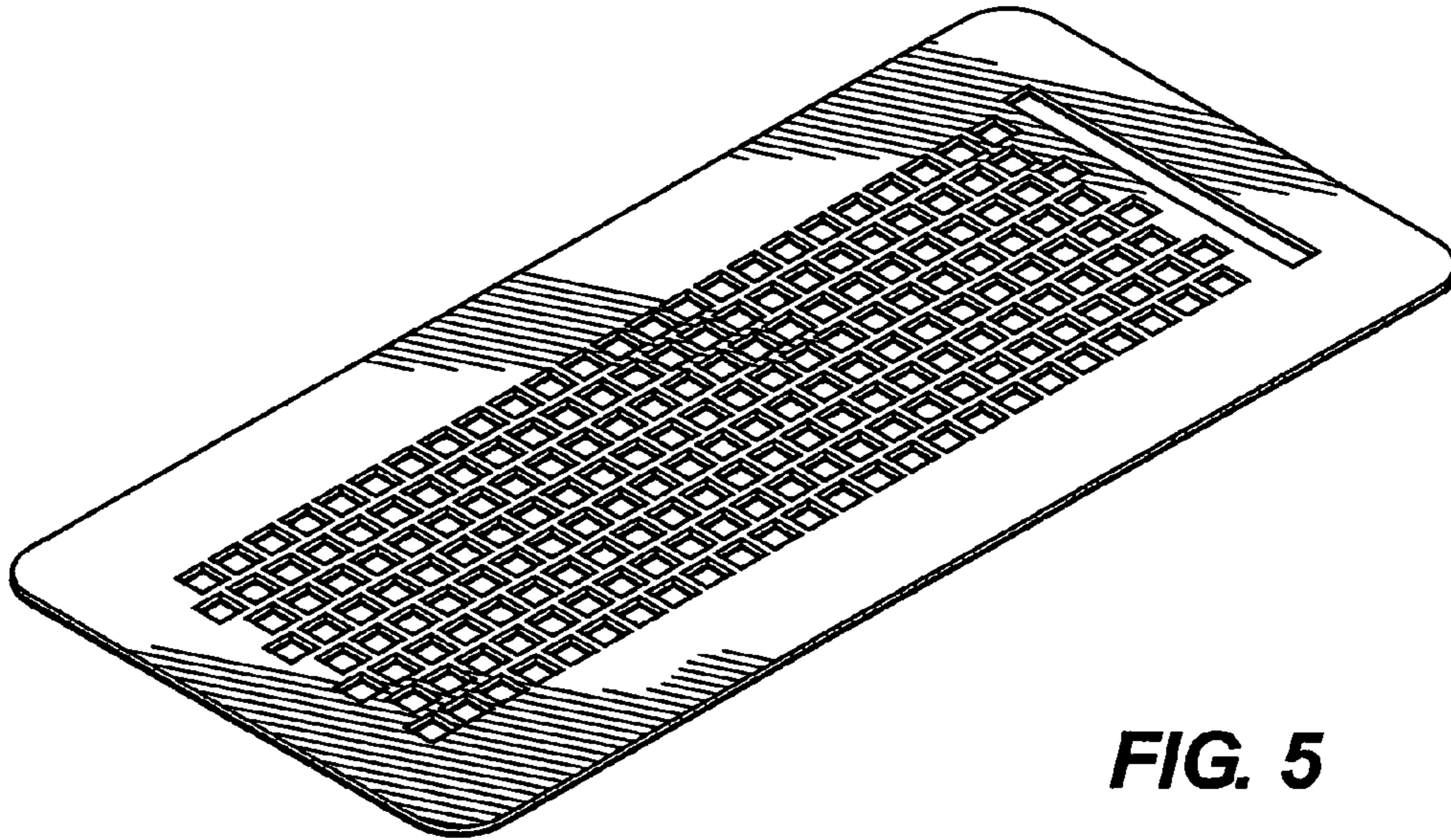

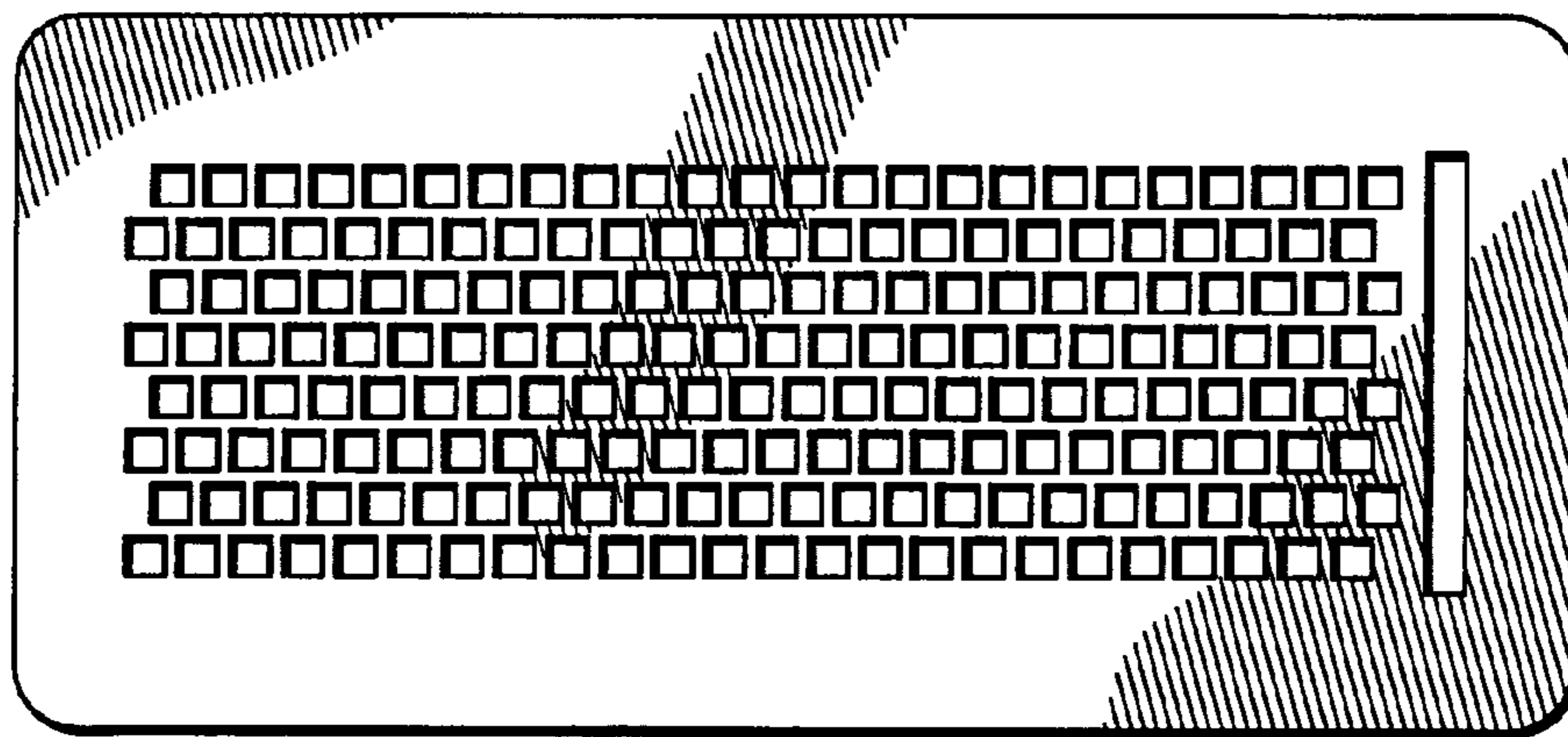
