The ornamental design for a door, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a first embodiment of the door;

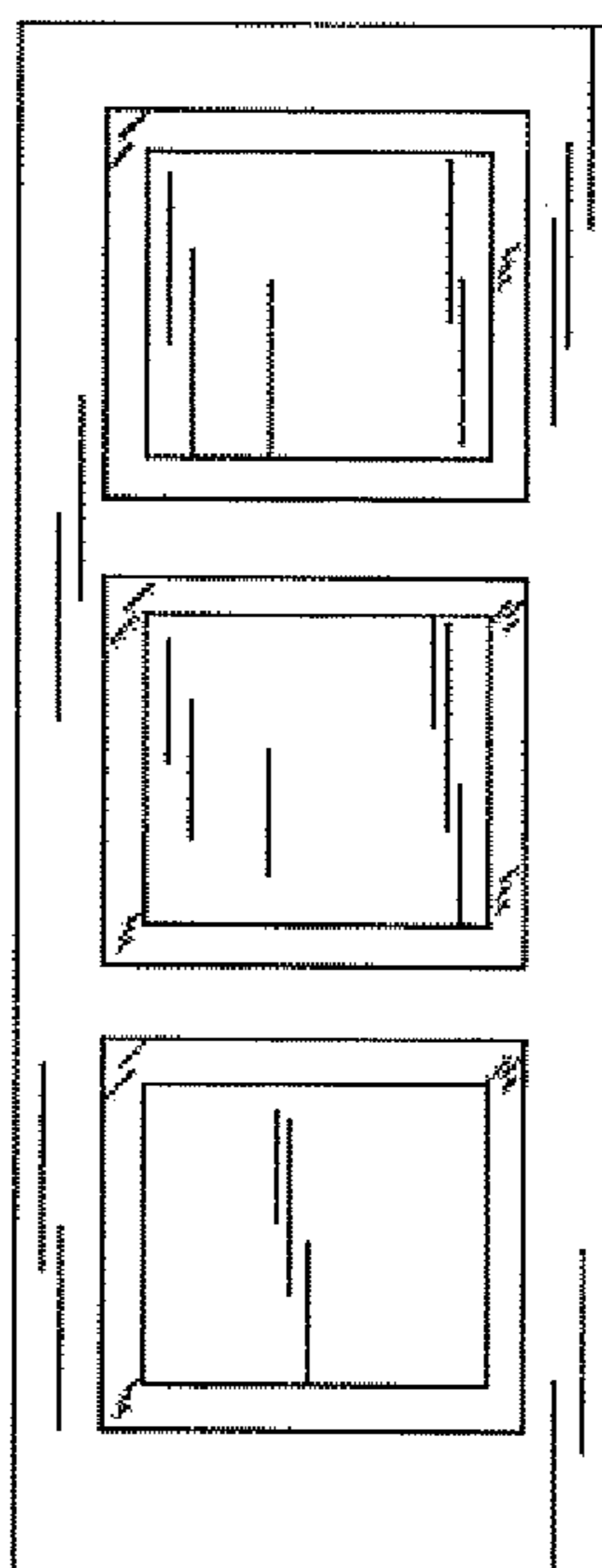

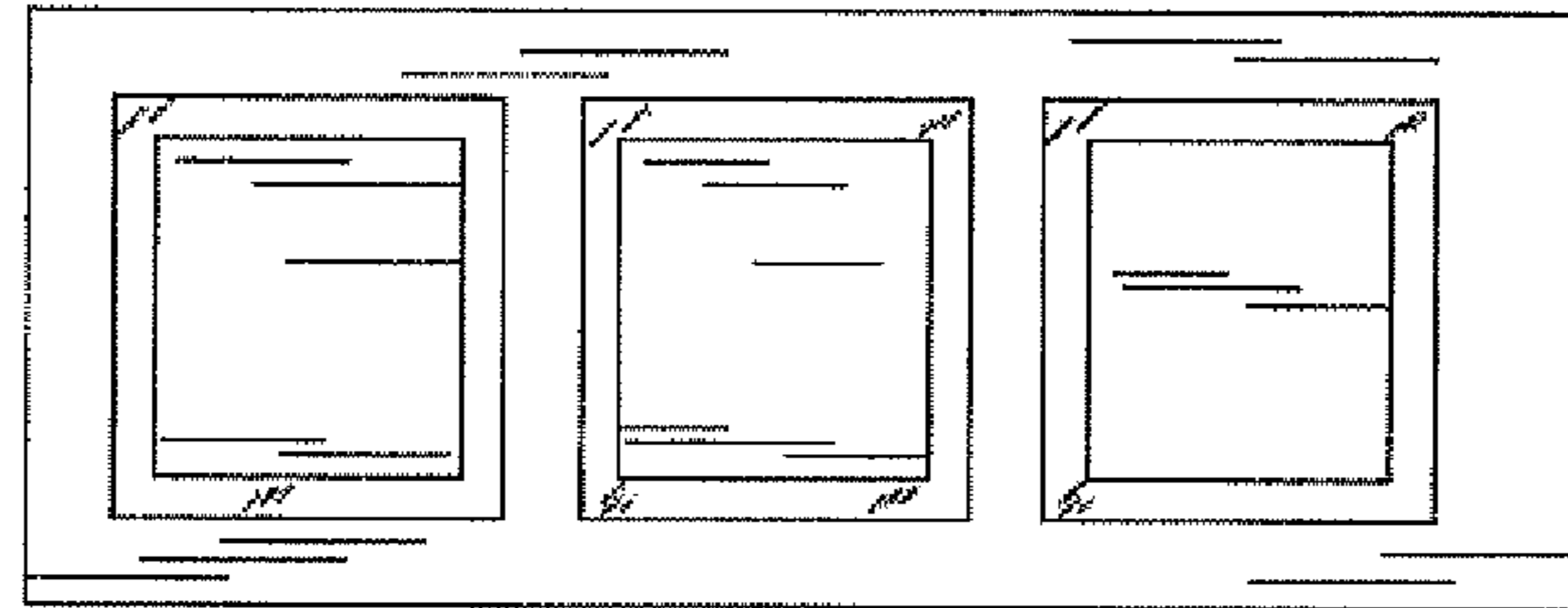

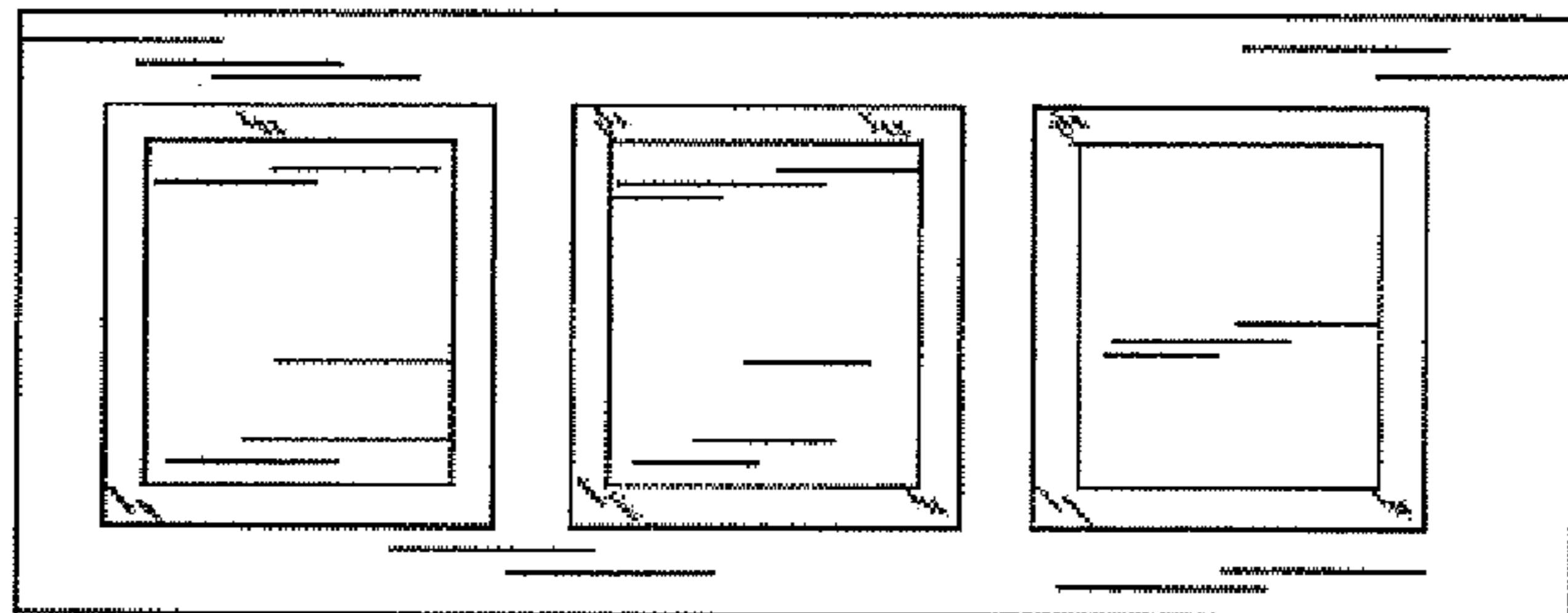

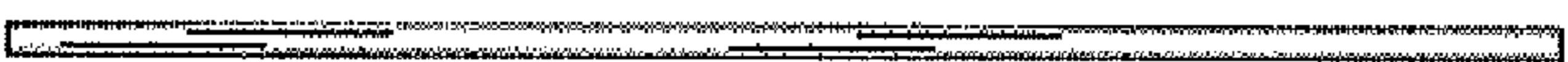

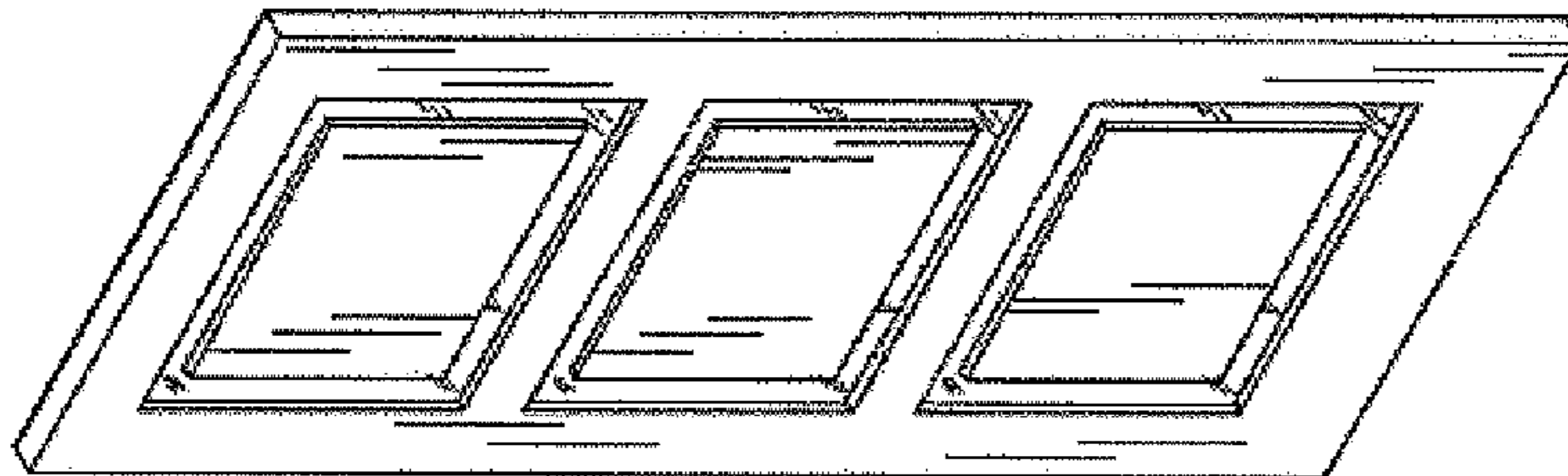

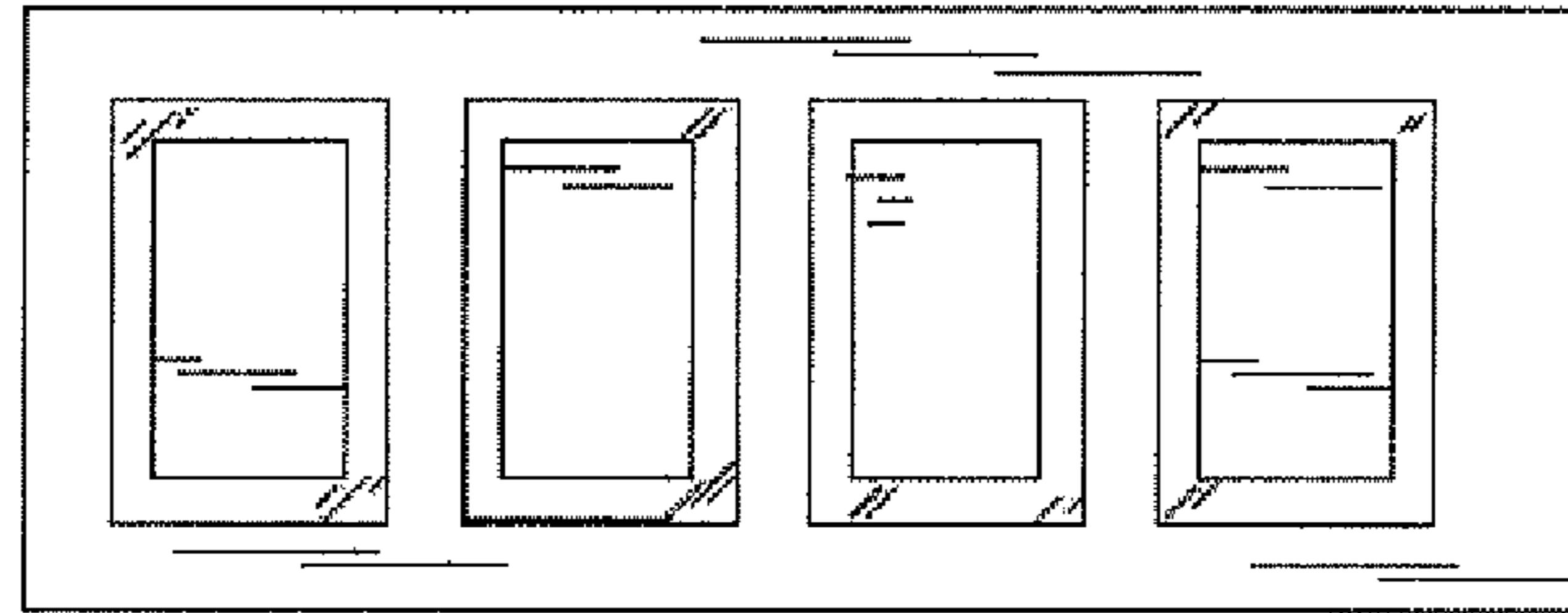

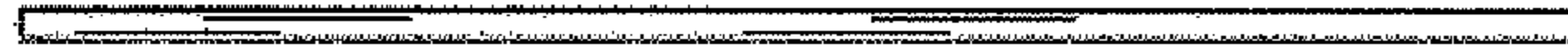

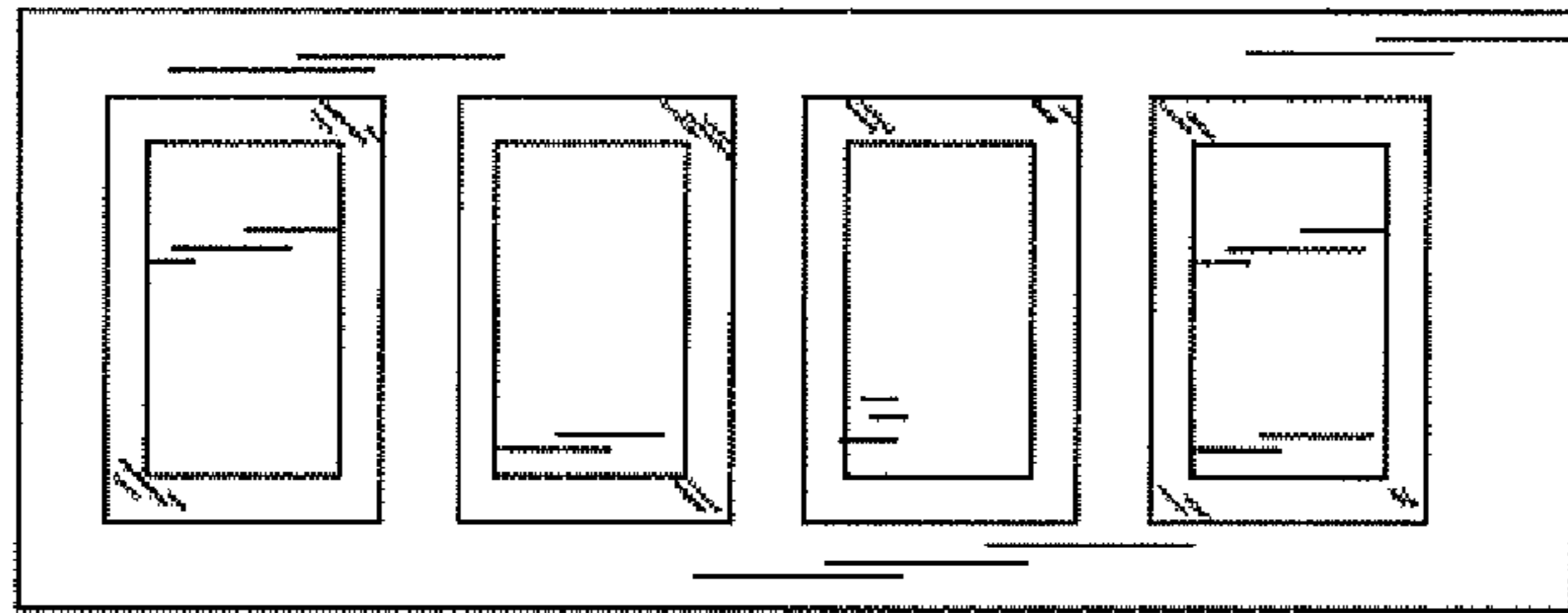

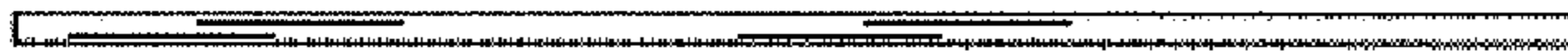

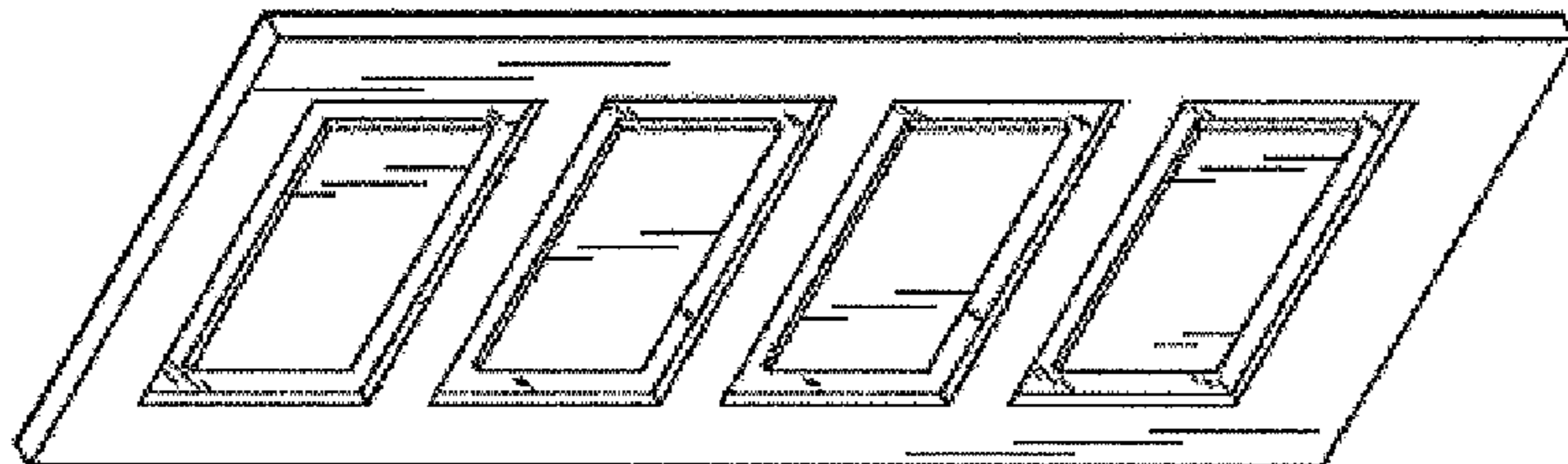
