(57) **CLAIM**

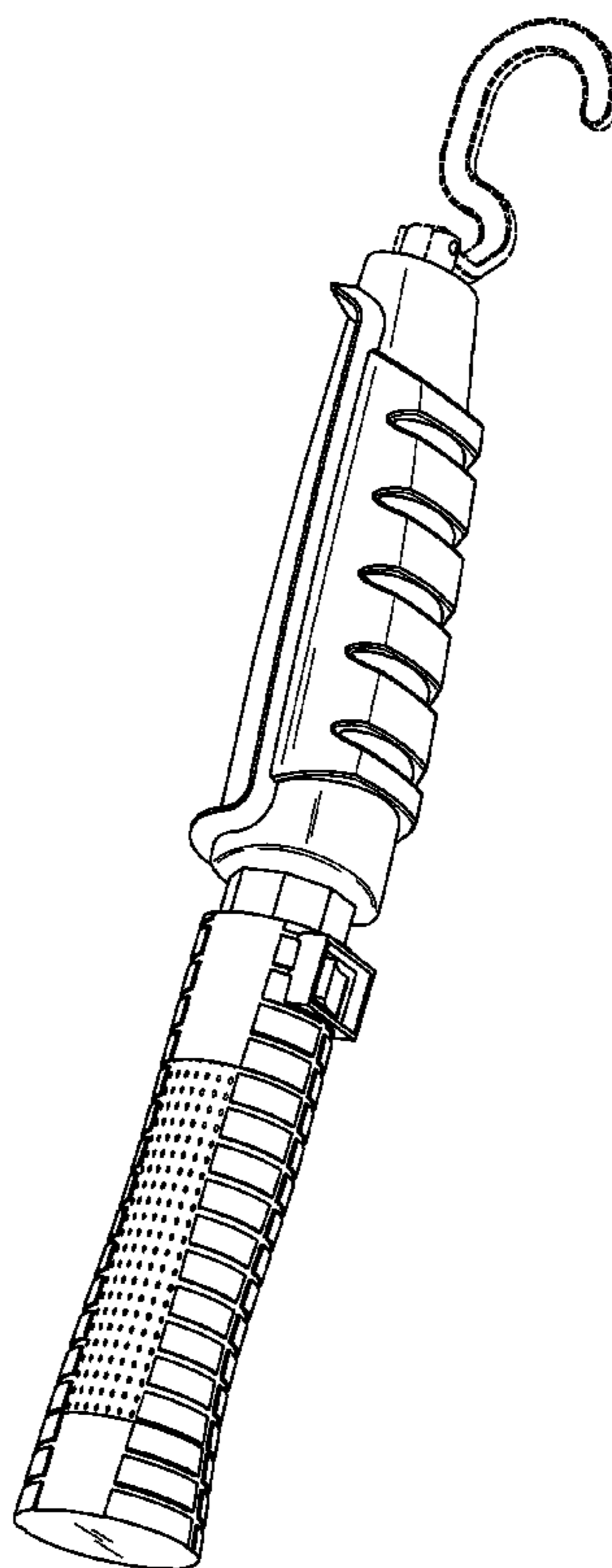
I claim. the ornamental design for a hand light, as shown and described.

**DESCRIPTION**

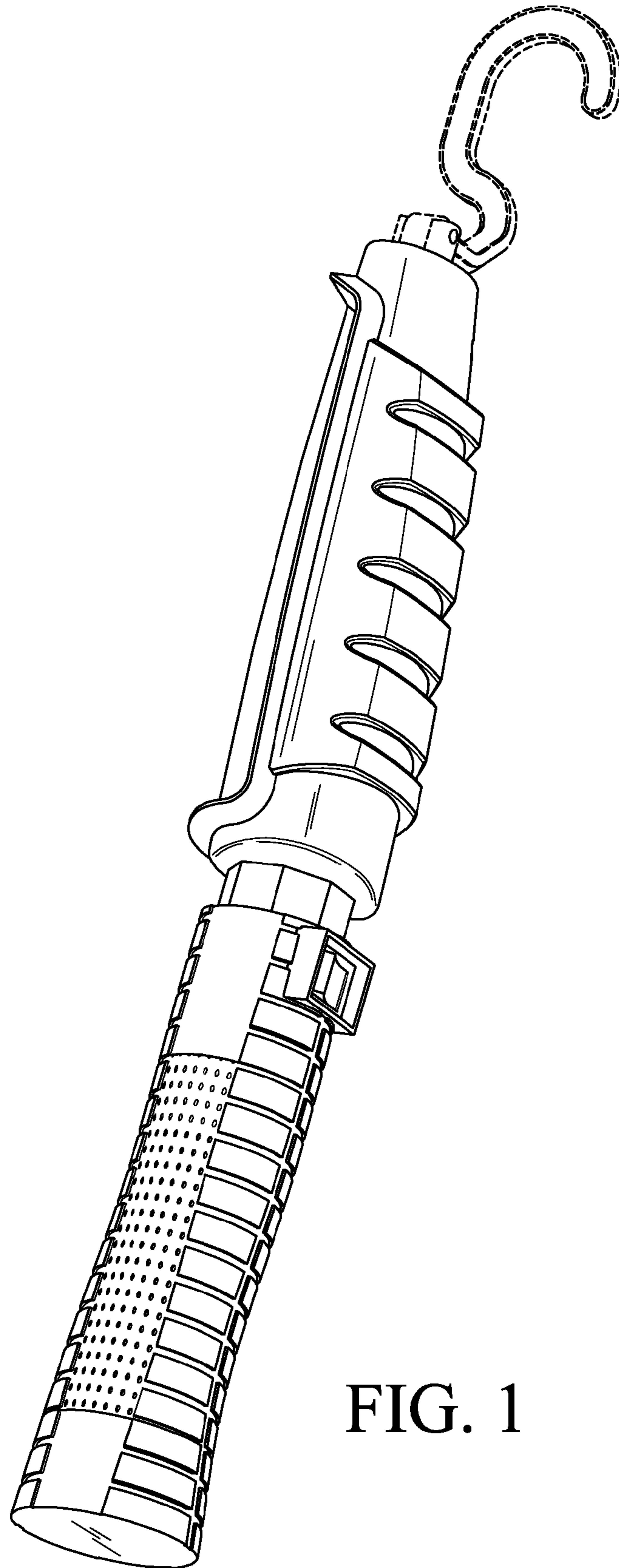

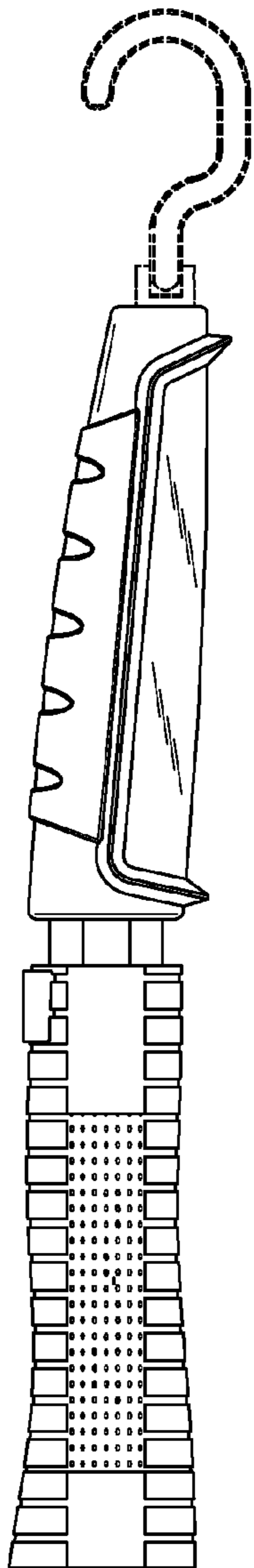

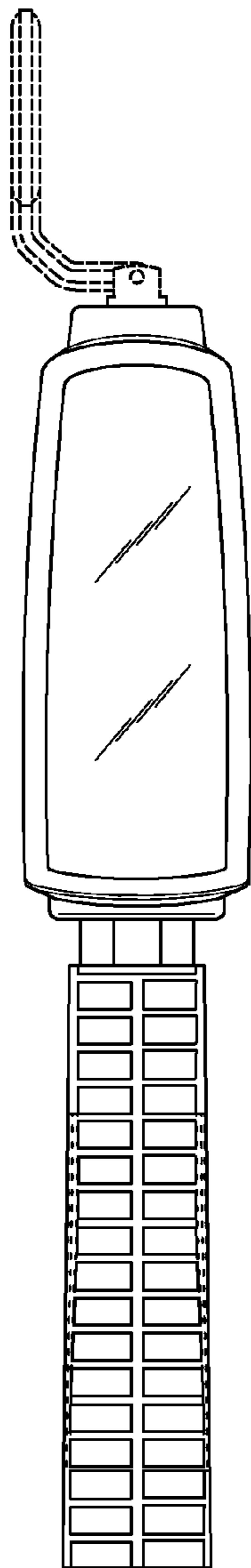

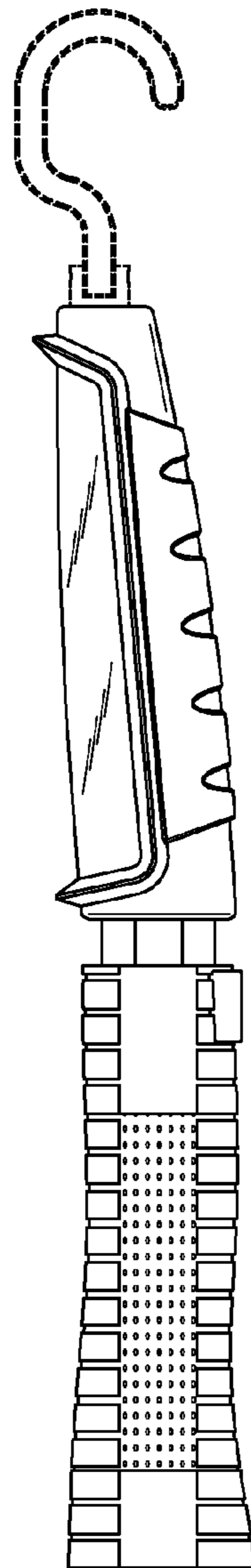

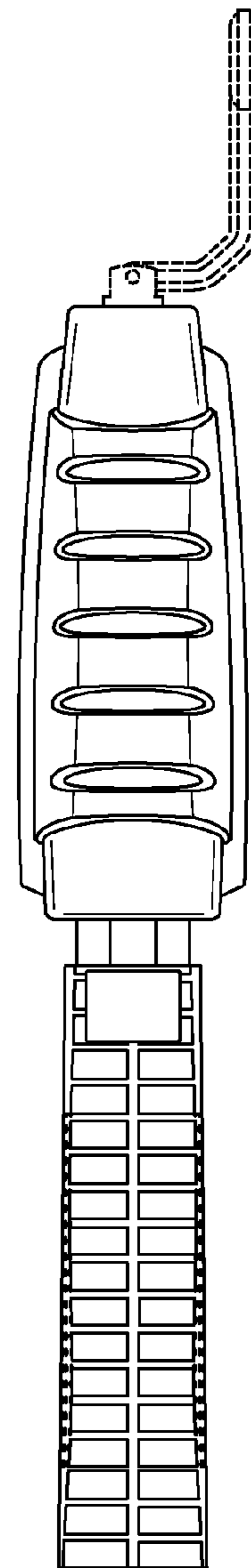
