(57) **CLAIM**

The ornamental design for a square bollard LED luminaire, as shown and described.

**DESCRIPTION**

FIG. 1 is a right-side front elevational view slightly from above of the bollard luminaire according to the invention;

FIG. 2 is a front elevational view of the luminaire;

FIGS. 3 and 4 are right- and left-hand side elevational views of the luminaire;

FIG. 5 is a top view of the luminaire;

FIG. 6 is a rear elevational view of the luminaire; and,

FIG. 7 is a fragmentary perspective view from in front and below of the upper portion of the luminaire.

The broken lines shown on the drawings depict environment only and form no part of the claimed design.

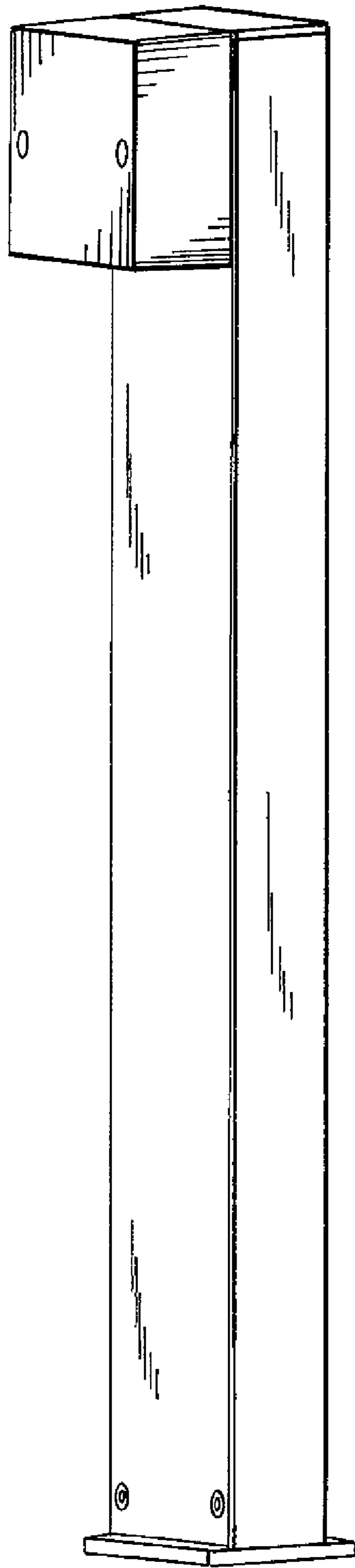

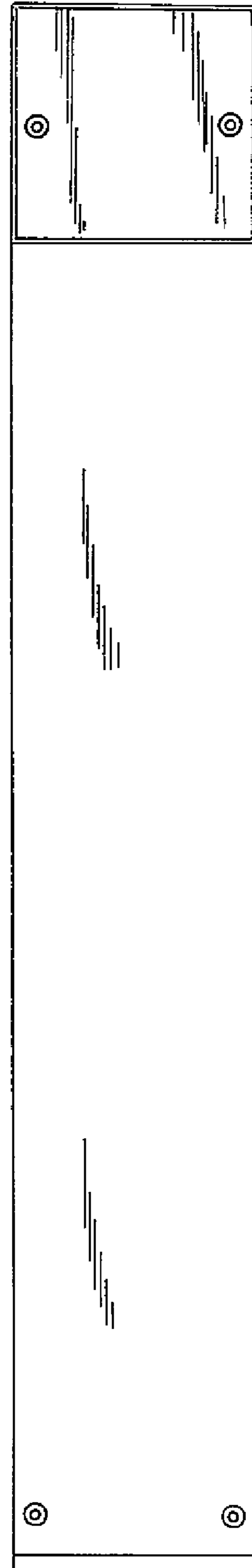

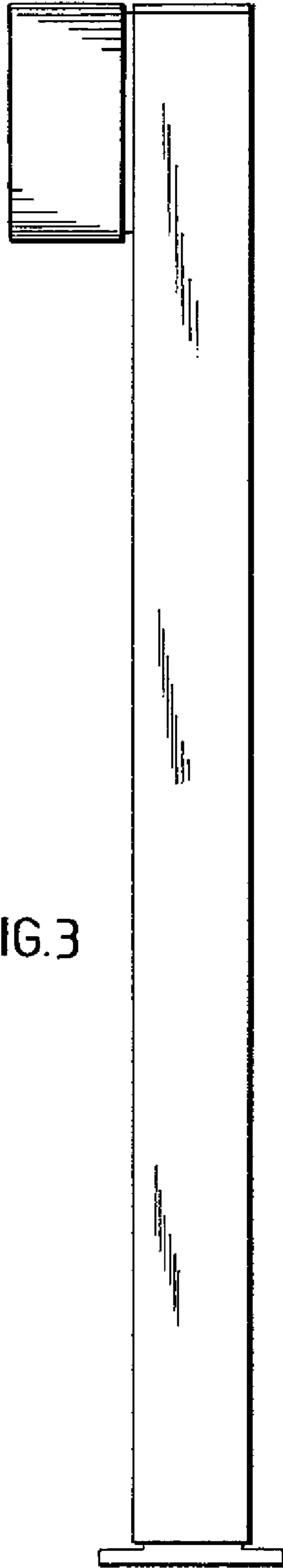

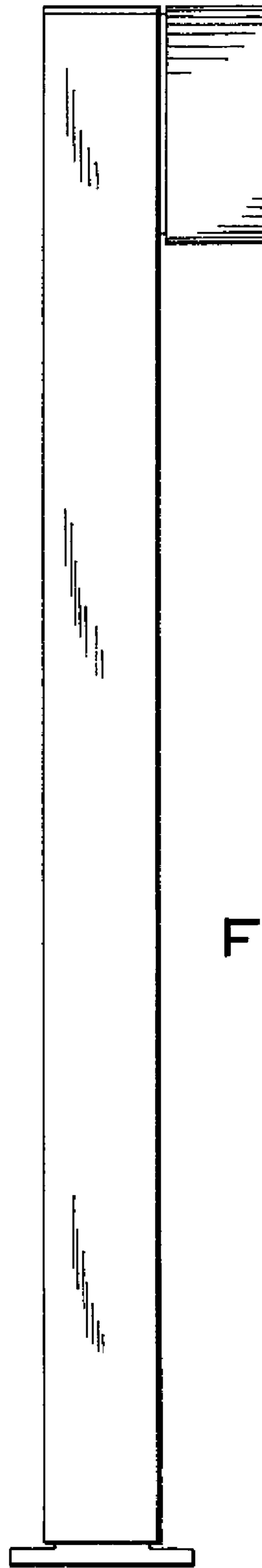

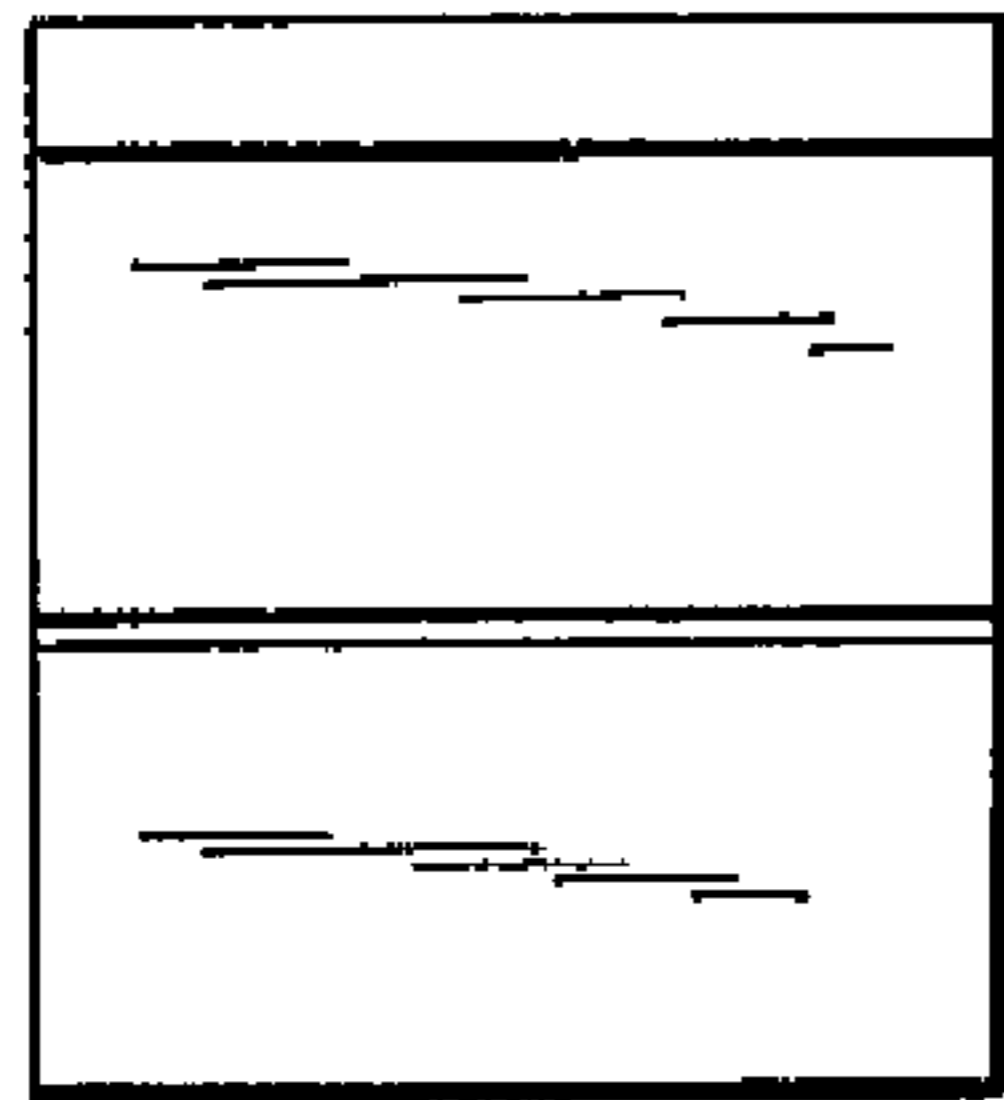

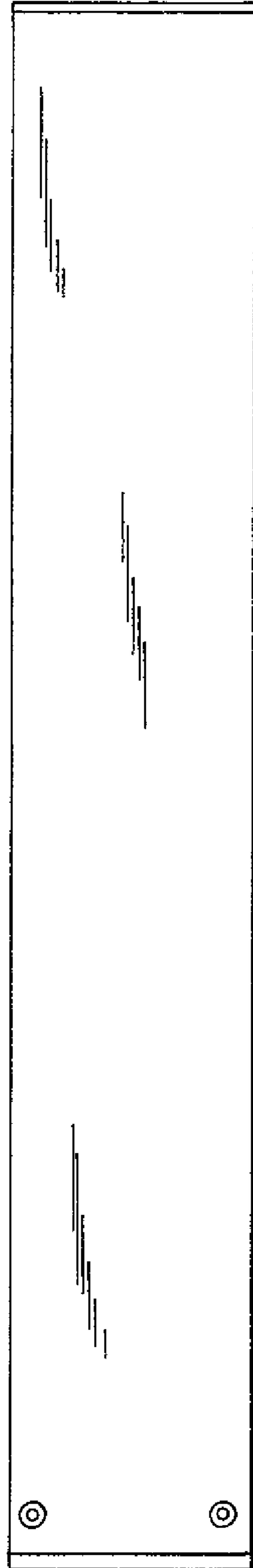

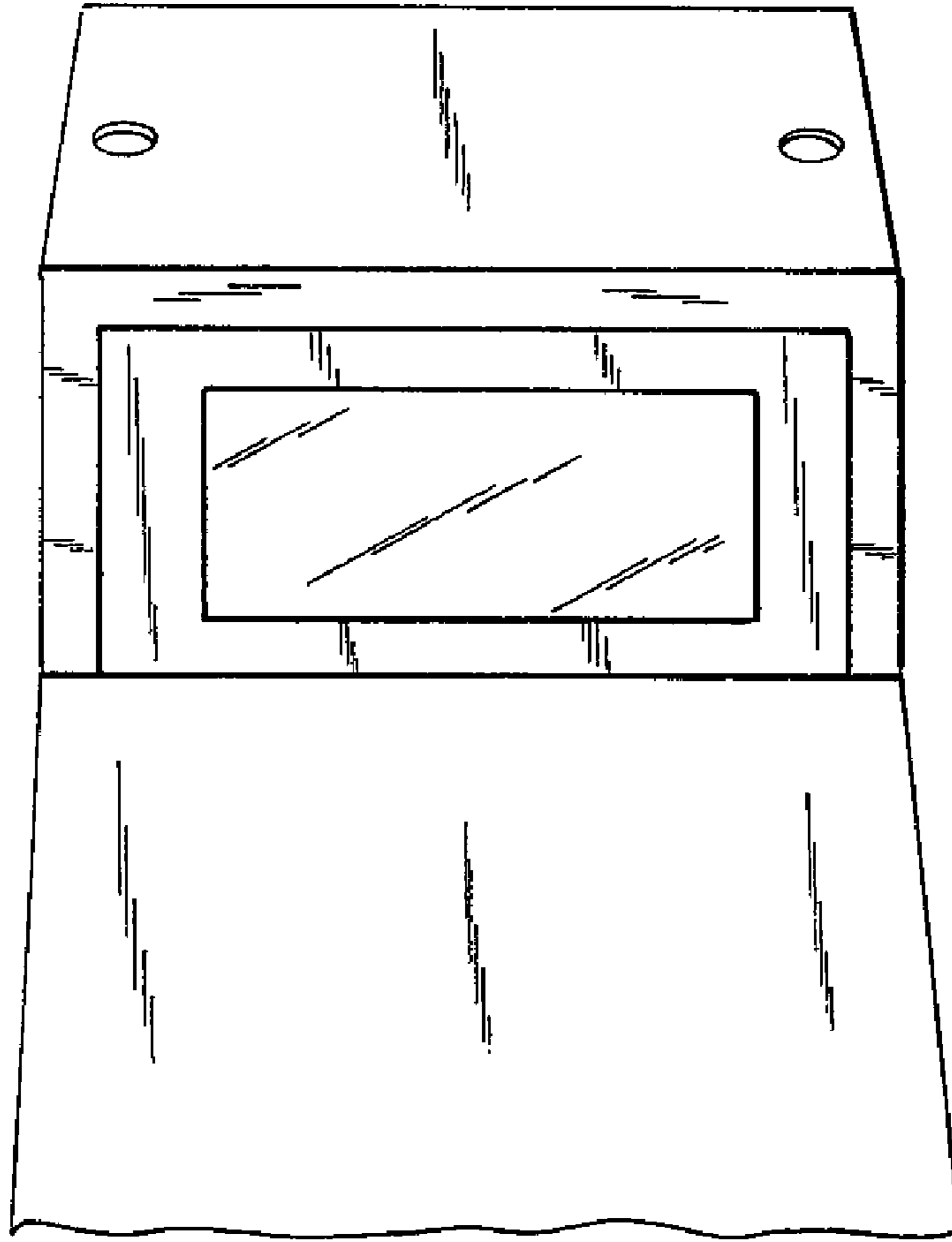
