We claim the ornamental design for a washing machine, as shown.

**DESCRIPTION**

FIG. 1 is a front, right side, top perspective view of a washing machine showing our new design;

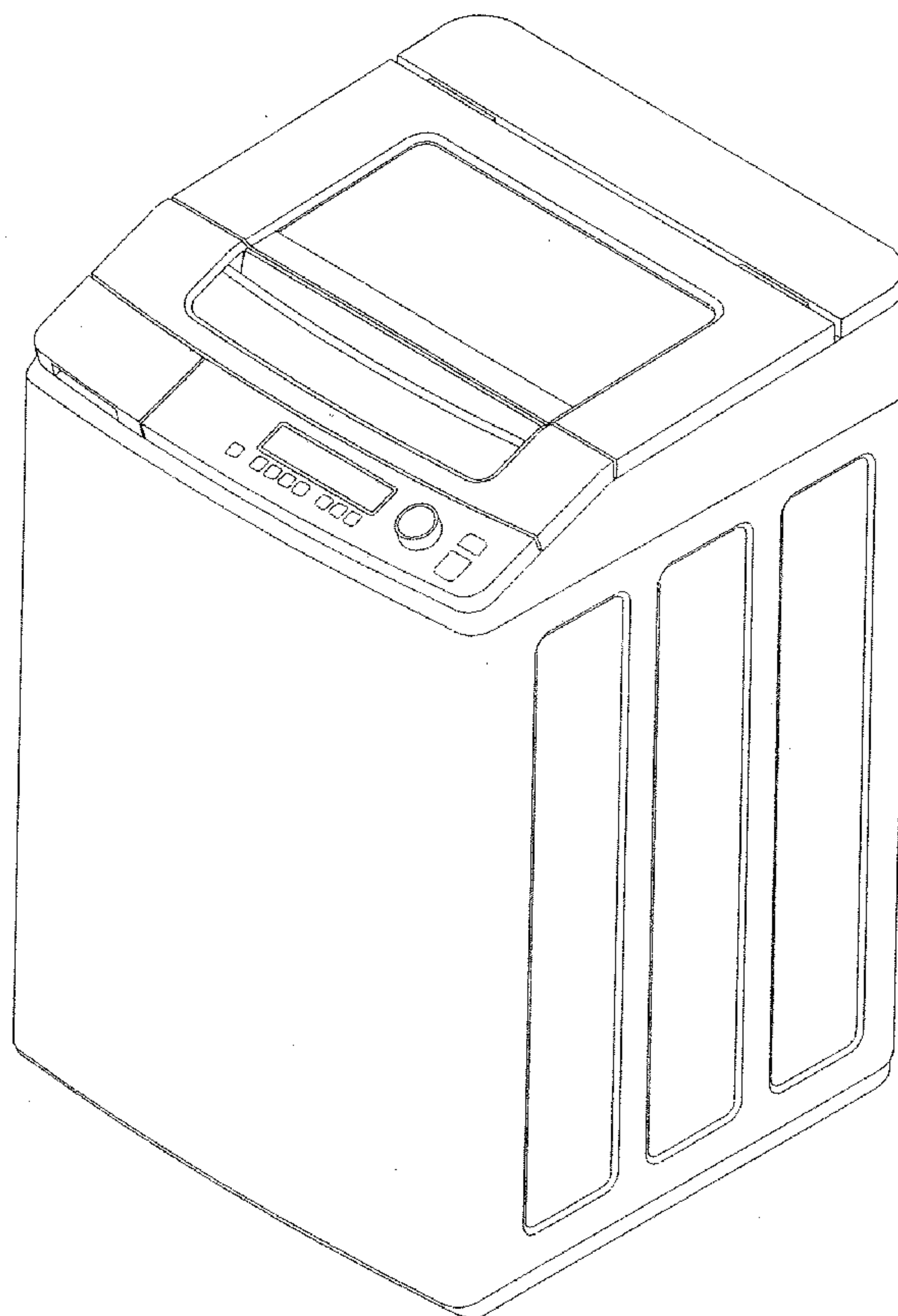

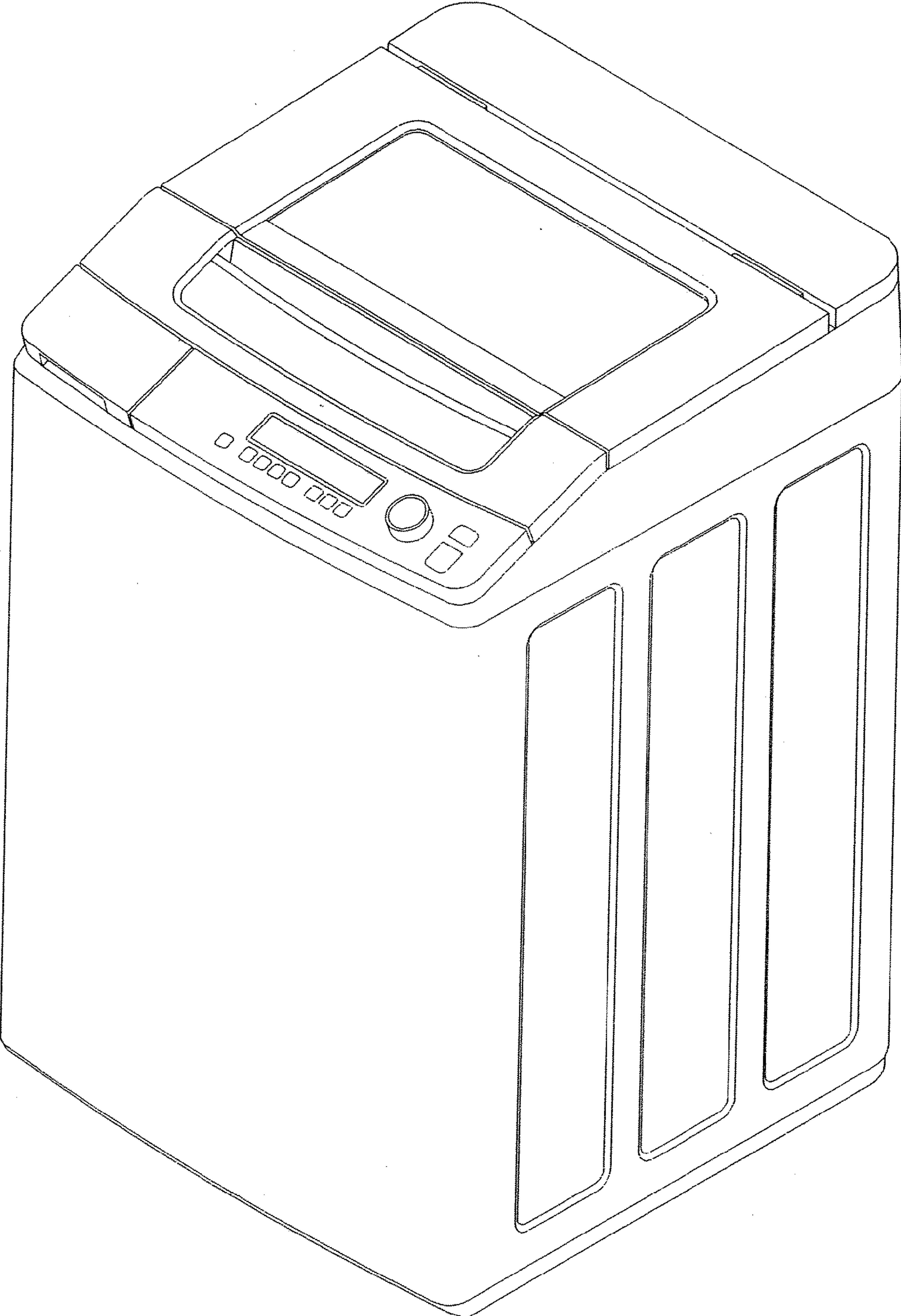

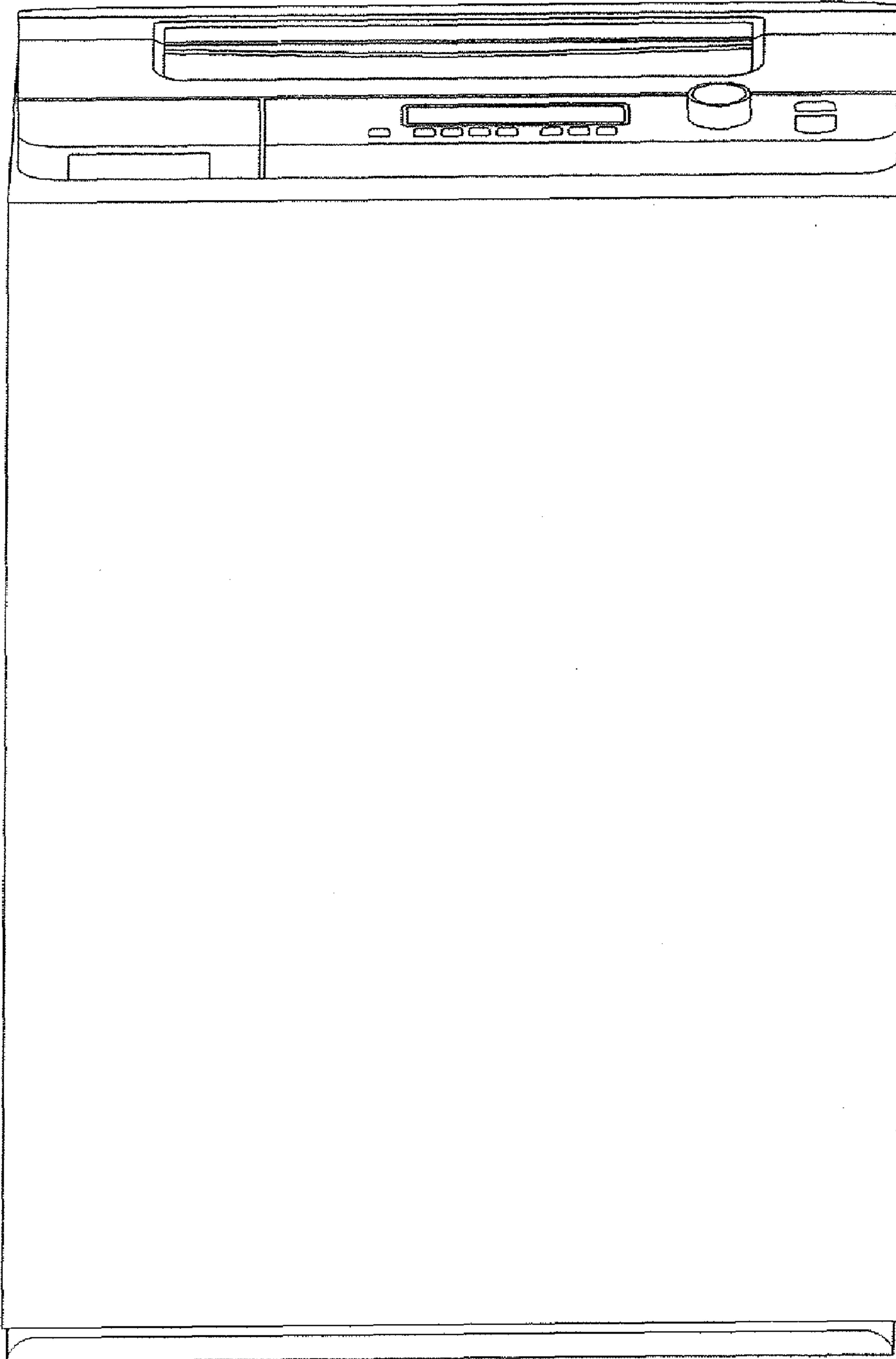

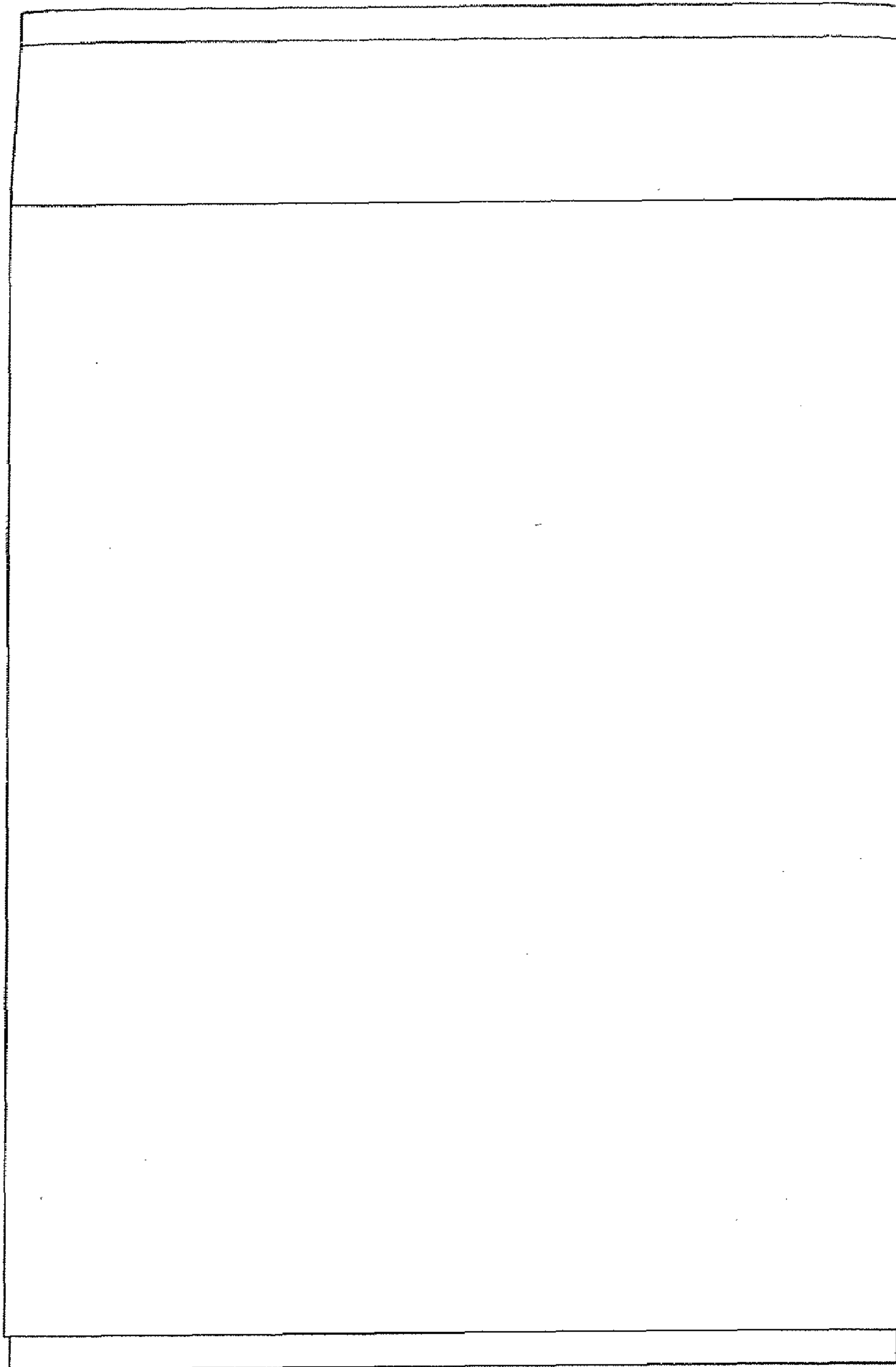

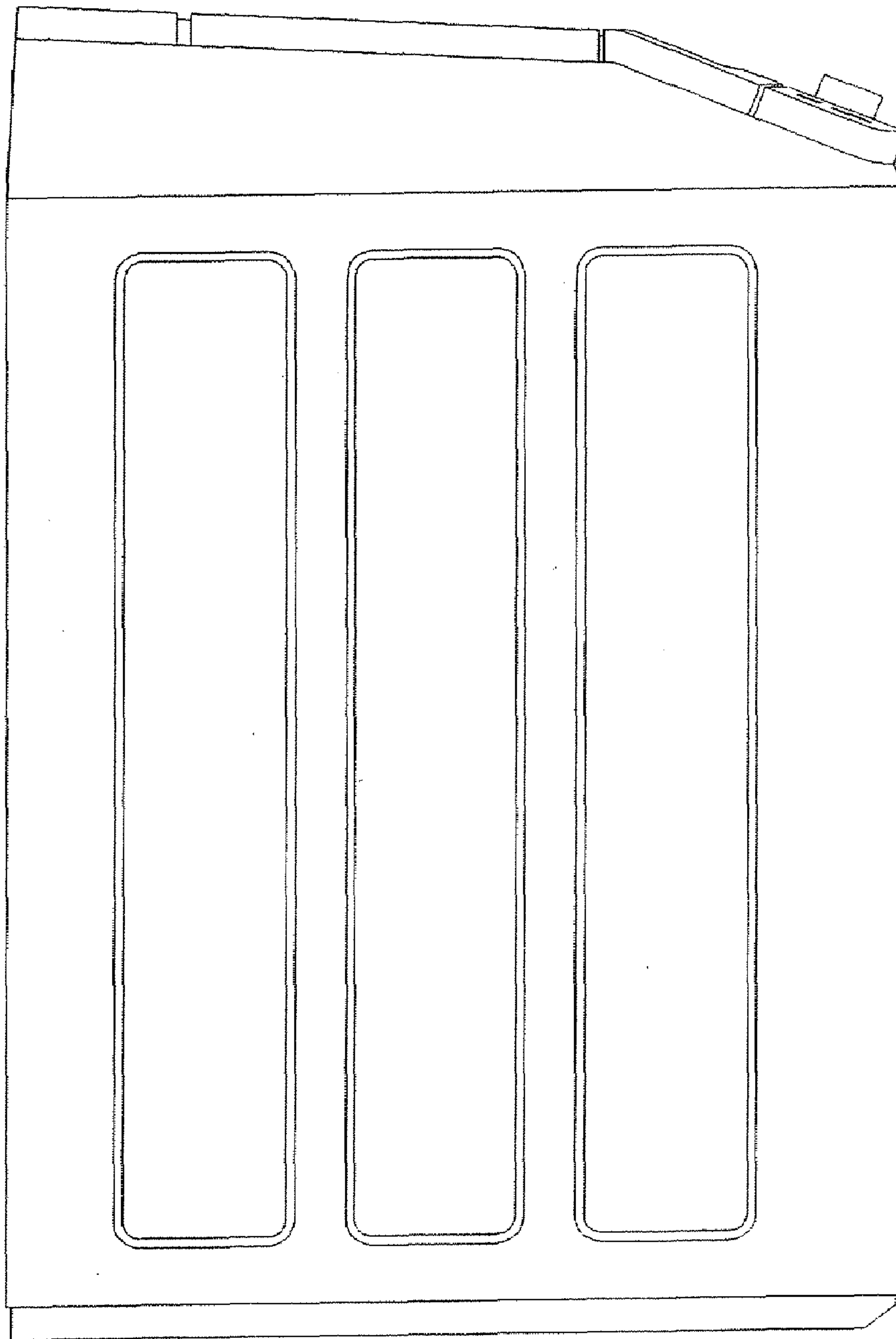

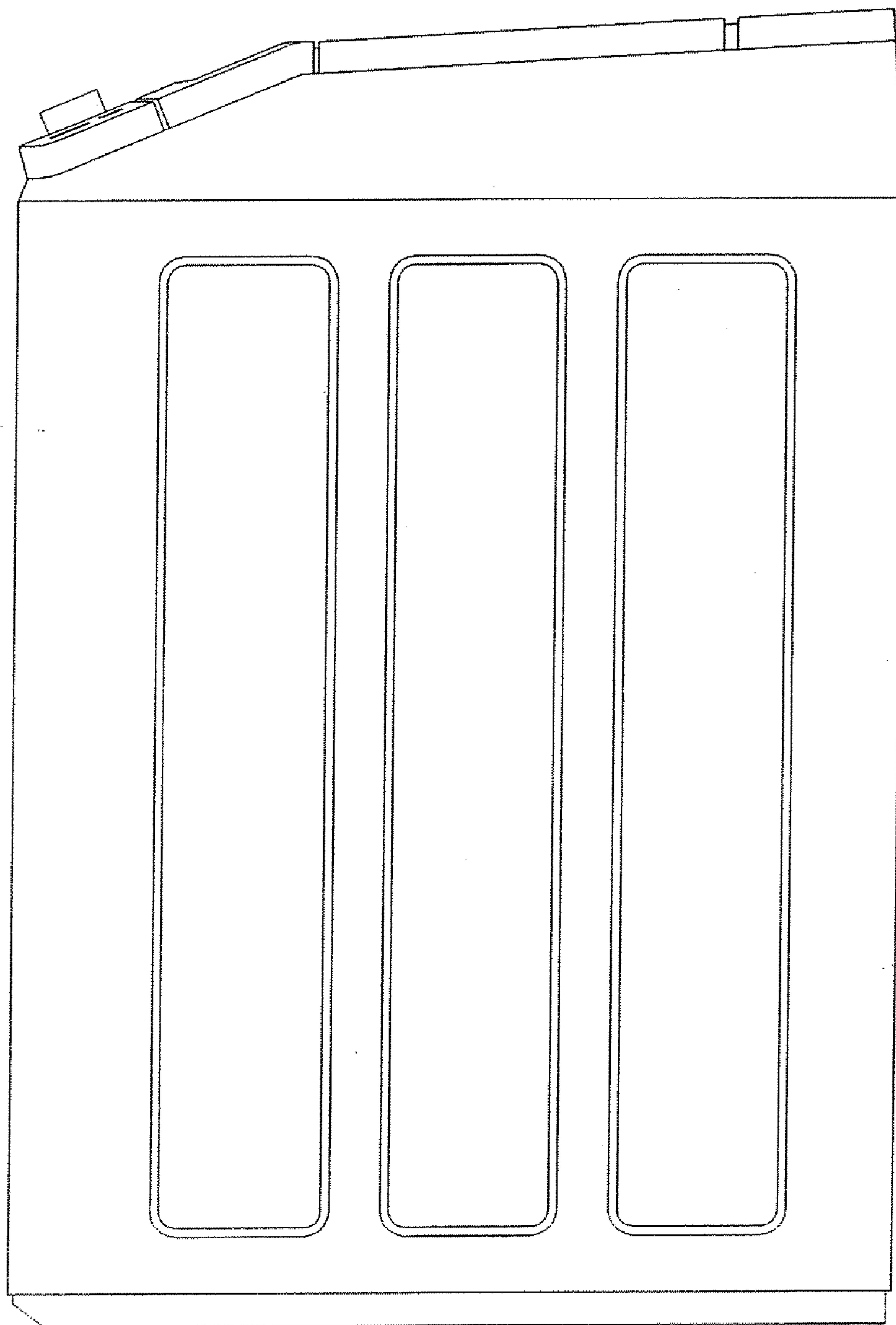
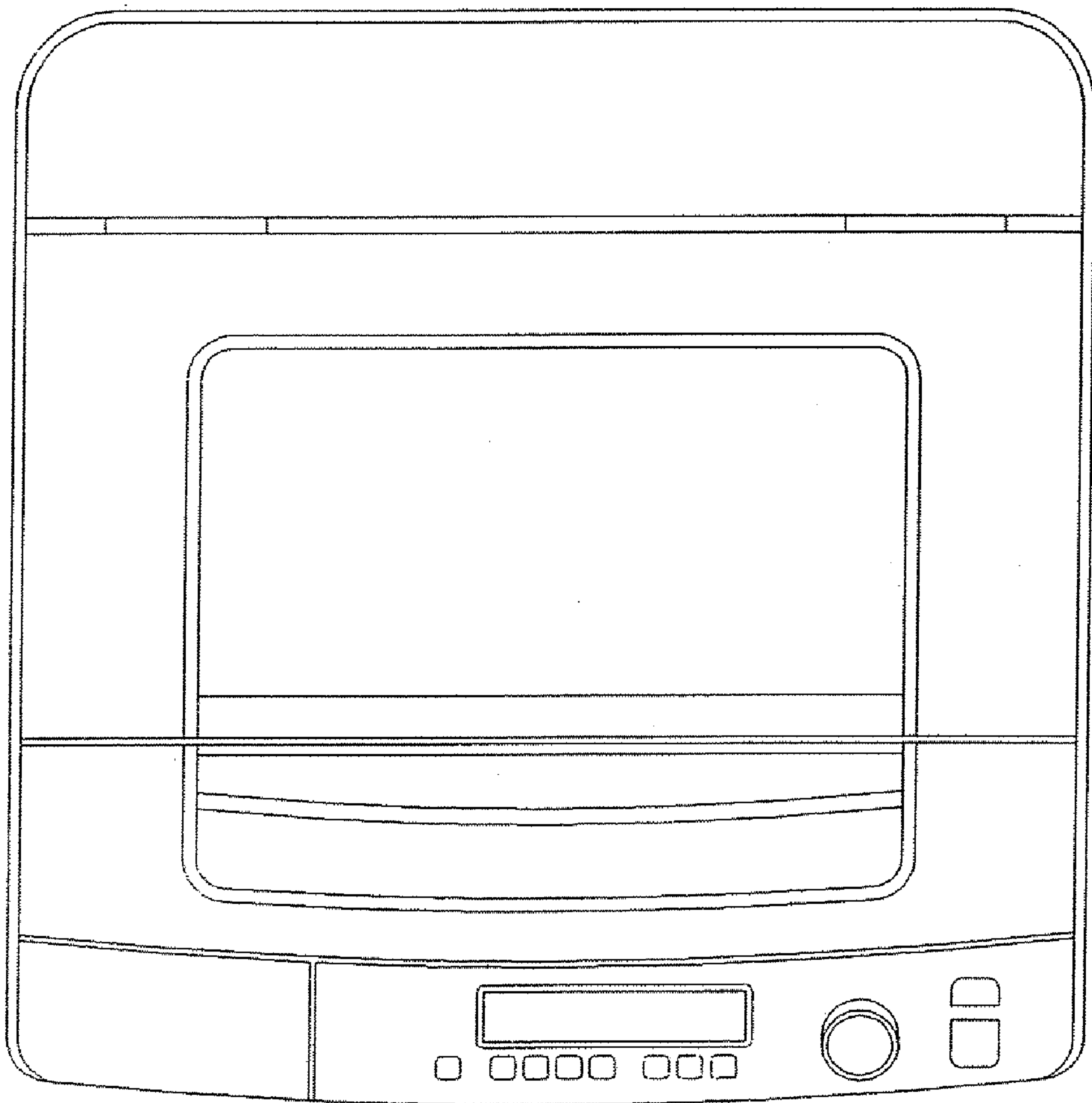
