FIG. 1 is a perspective view of a waste can cover configured according to the present invention;

FIG. 2 is a downward perspective view of the waste can cover of FIG. 1 rotated forty-five degrees;

FIG. 3 is an upward perspective view of the waste can cover of FIG. 1 rotated forty-five degrees;

FIG. 4 is a top view of the waste can cover of FIG. 1;

FIG. 5 is a bottom view of the waste can cover of FIG. 1;

FIG. 6 is a downward perspective view of a waste can cover configured according to the present invention;

FIG. 7 is an upward perspective view of the waste can cover of FIG. 6;

FIG. 8 is a top view of the waste can cover of FIG. 6; and,

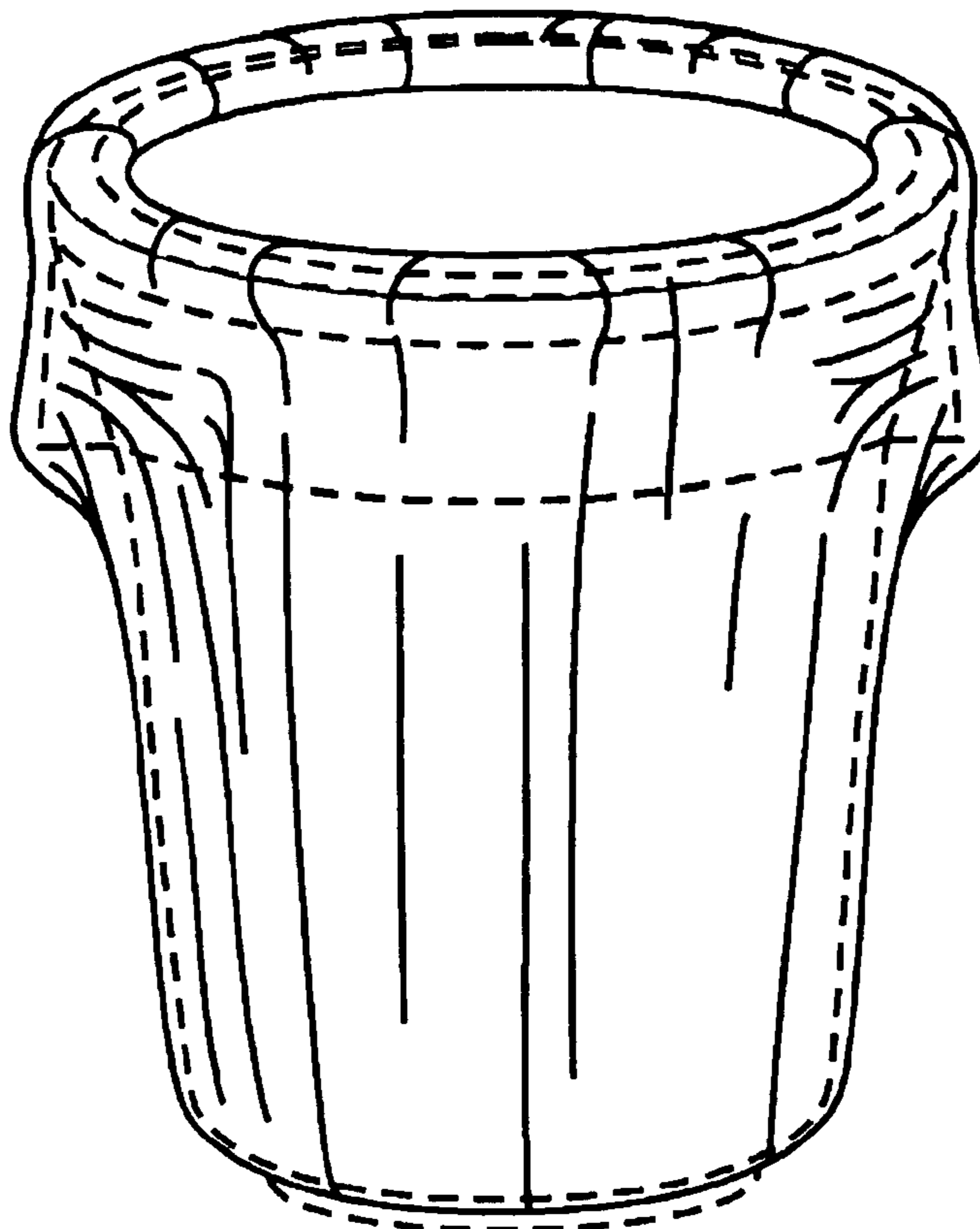
FIG. 9 is a bottom view of the waste can cover of FIG. 6.

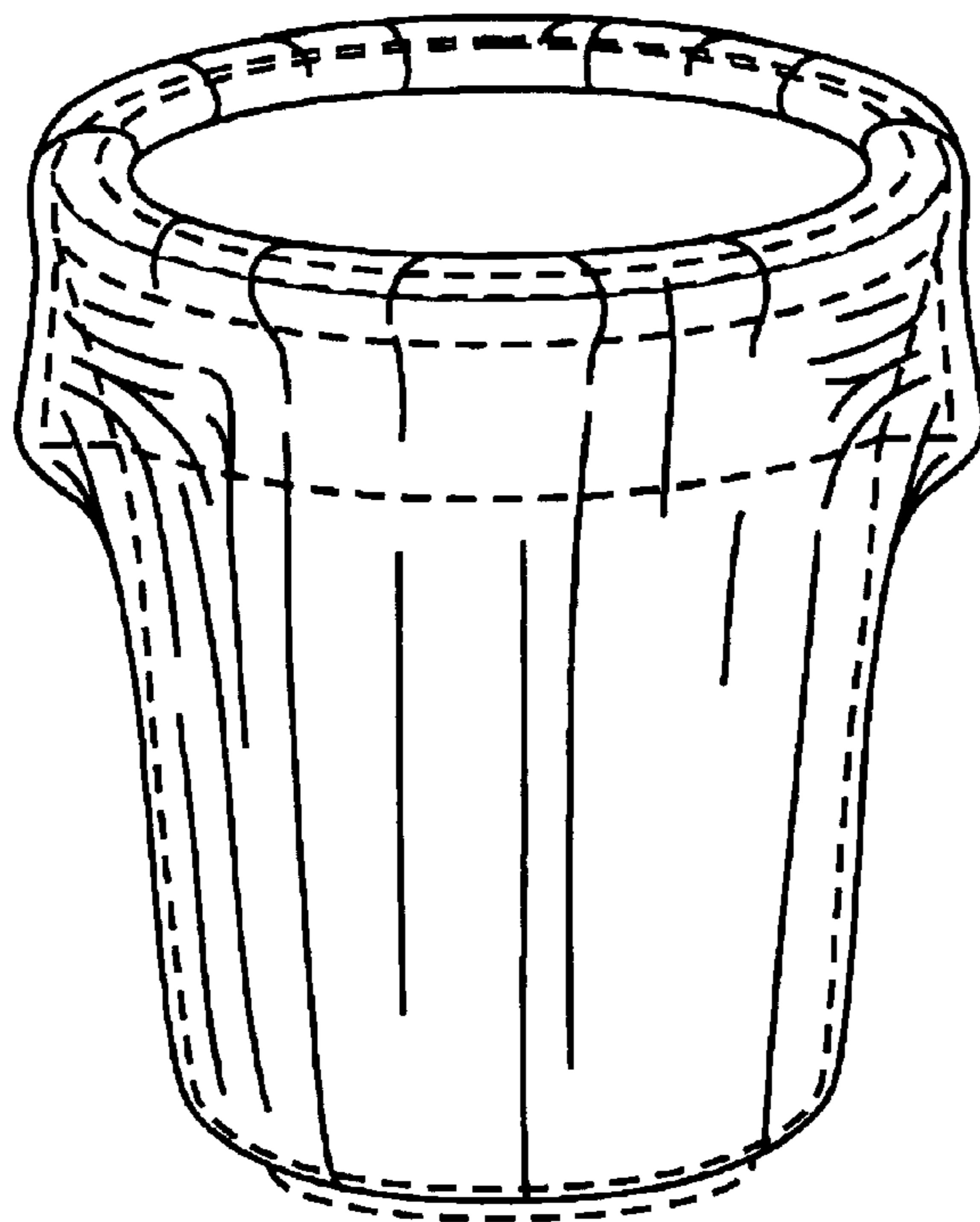

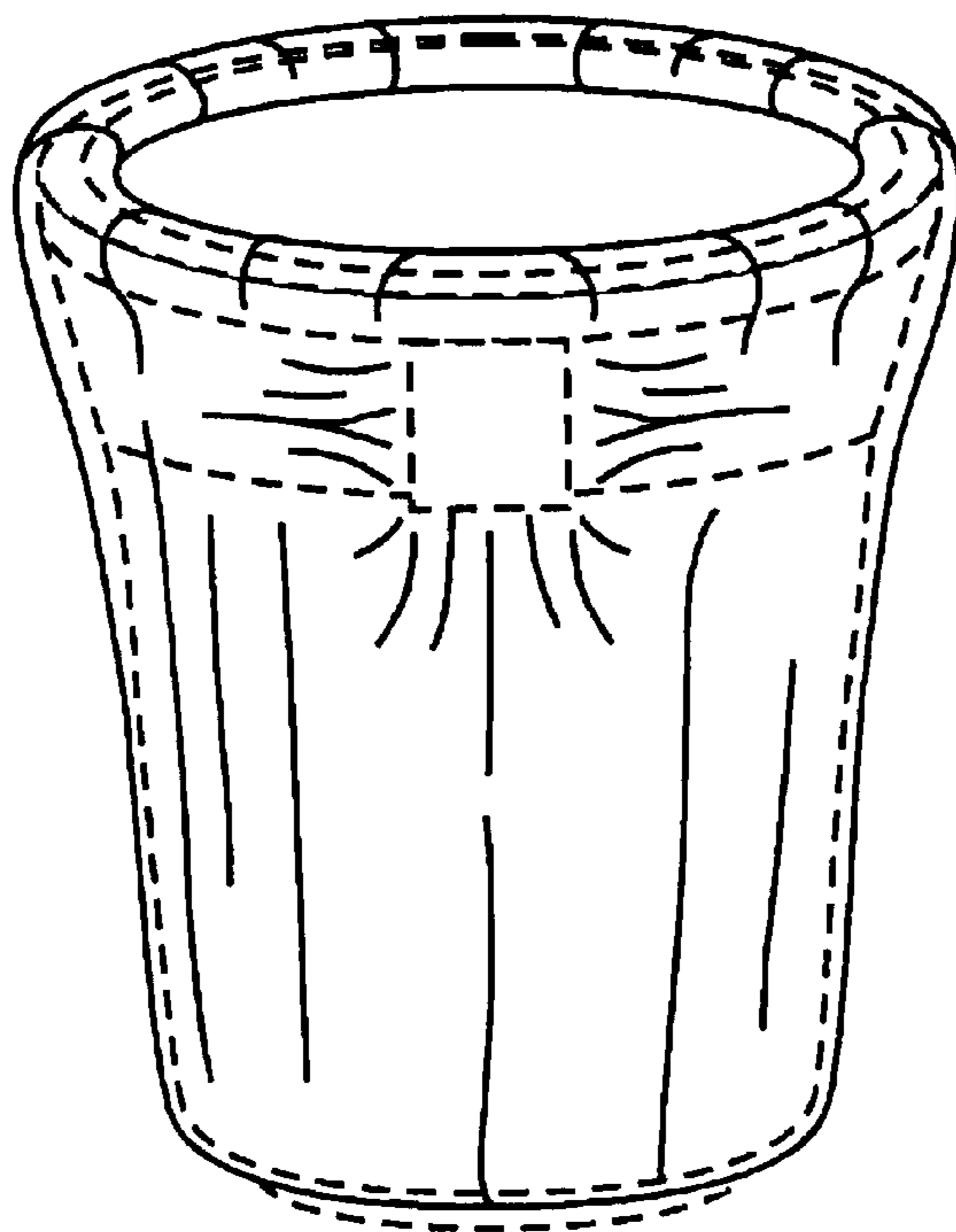
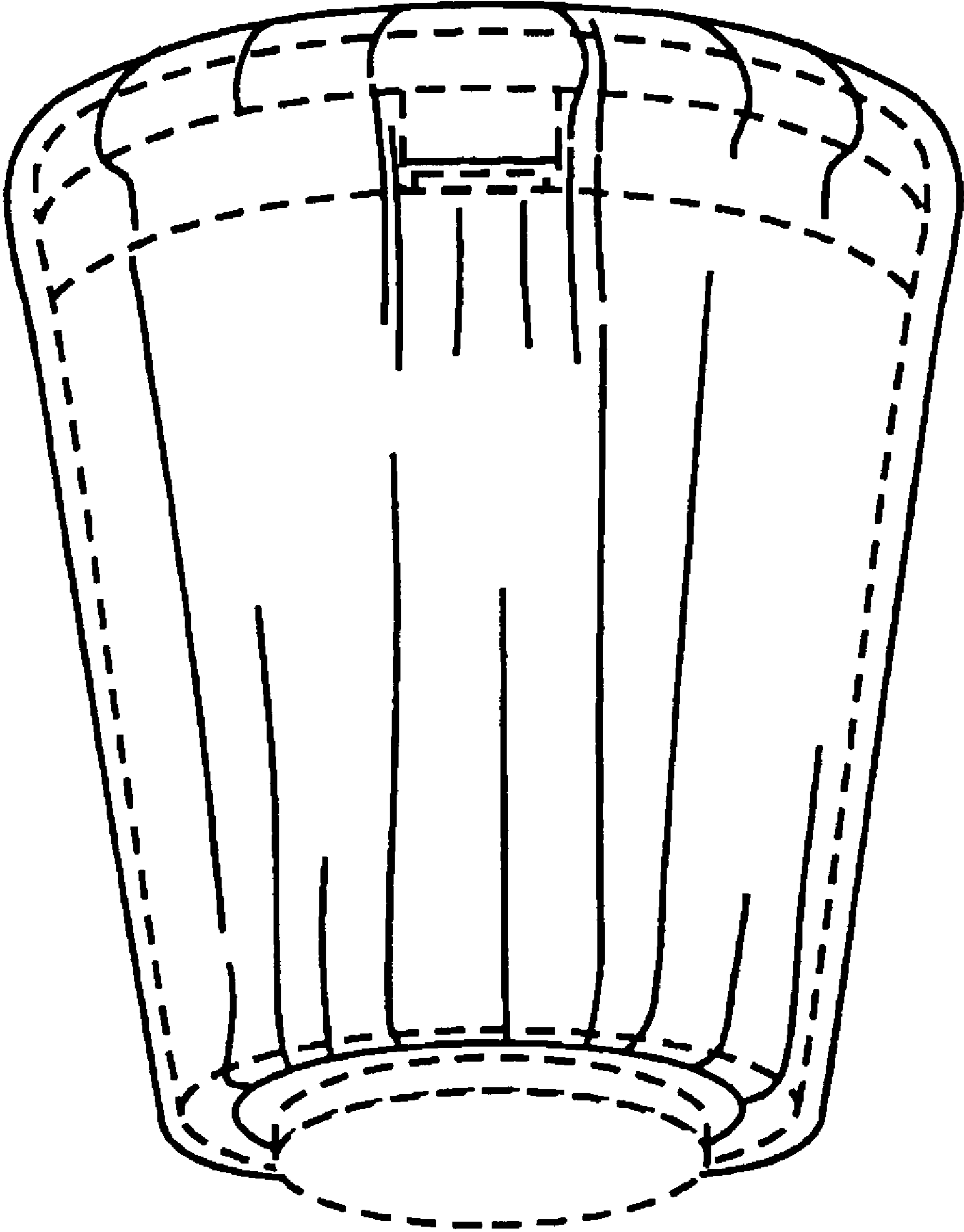

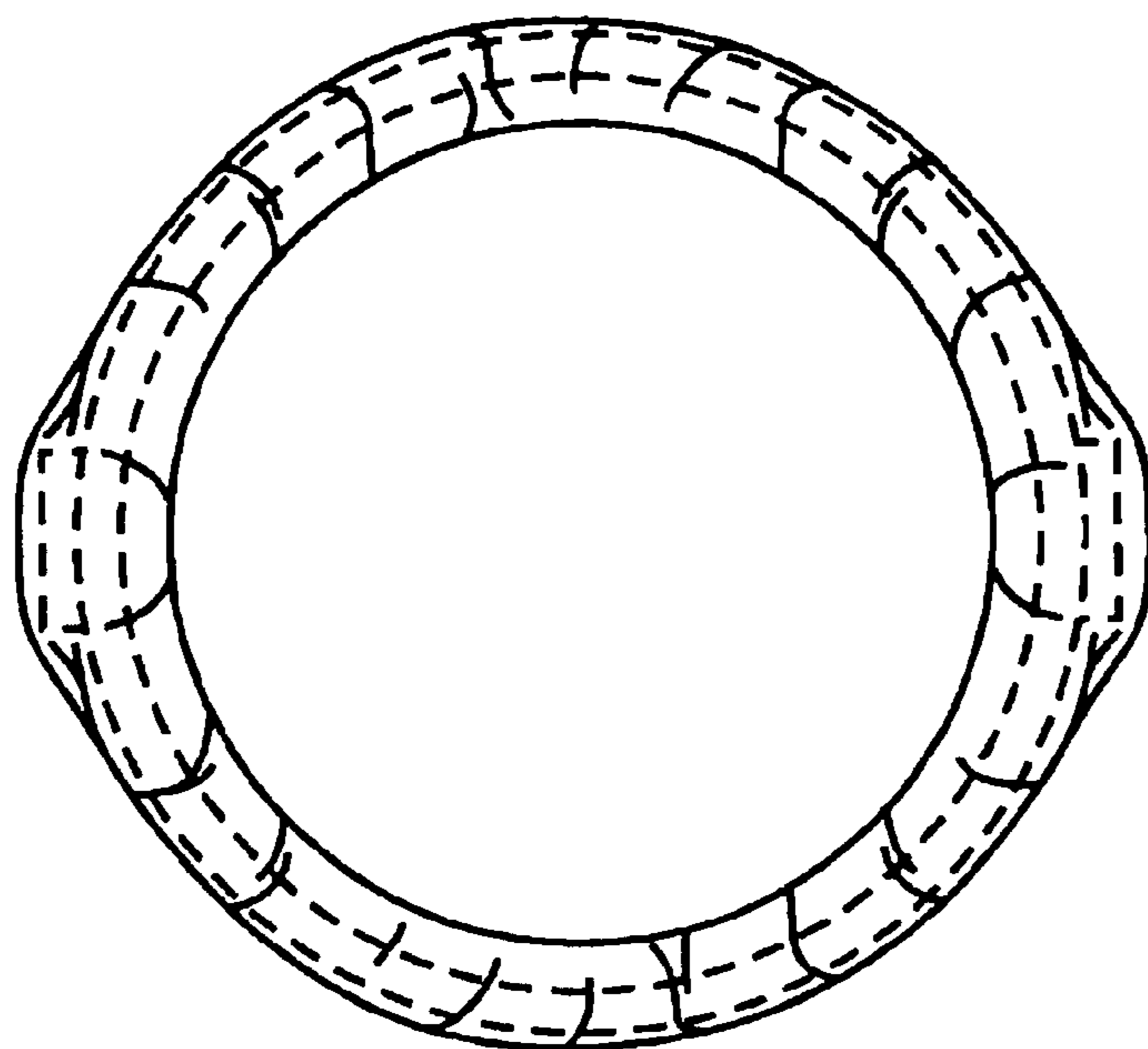

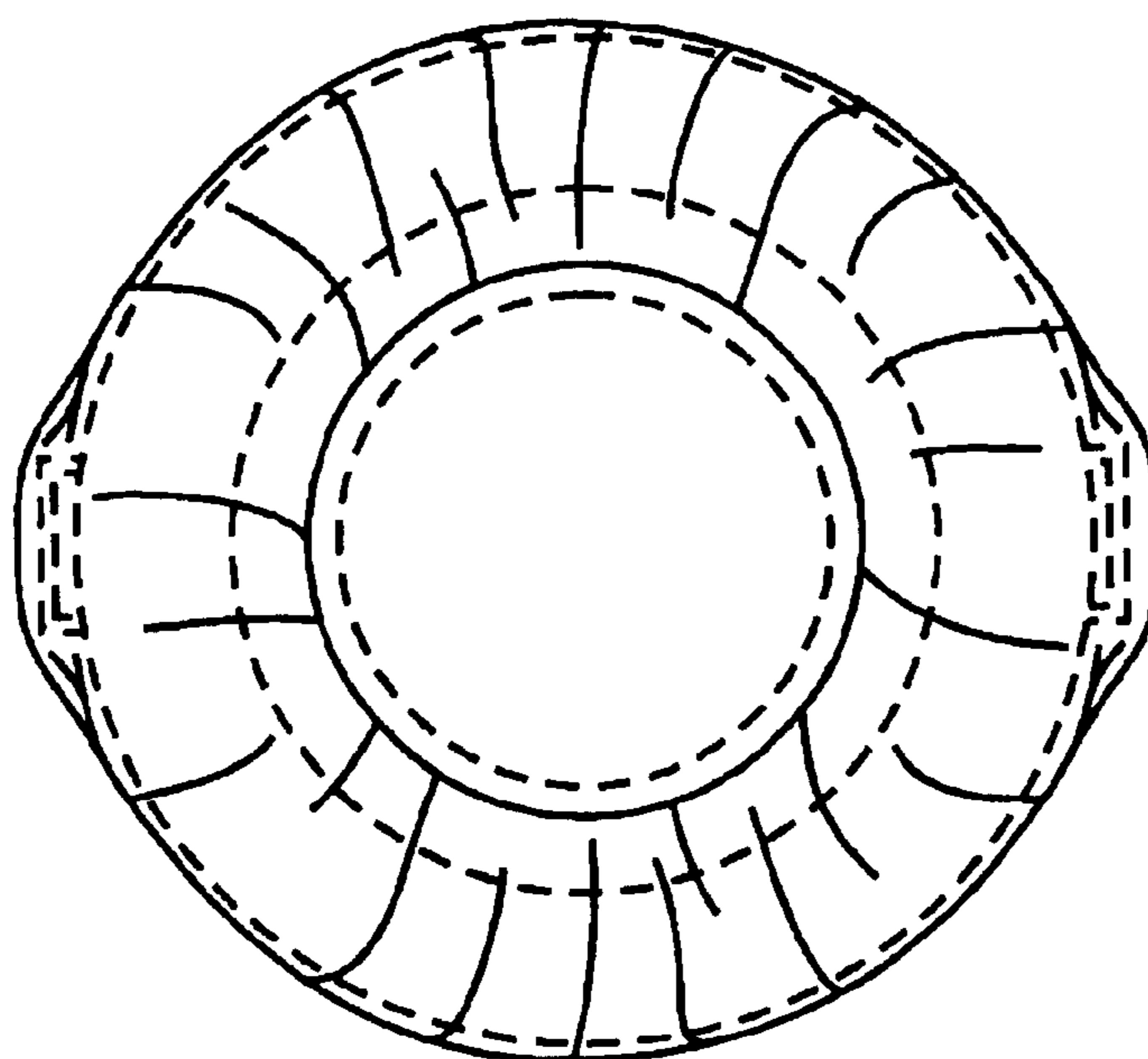

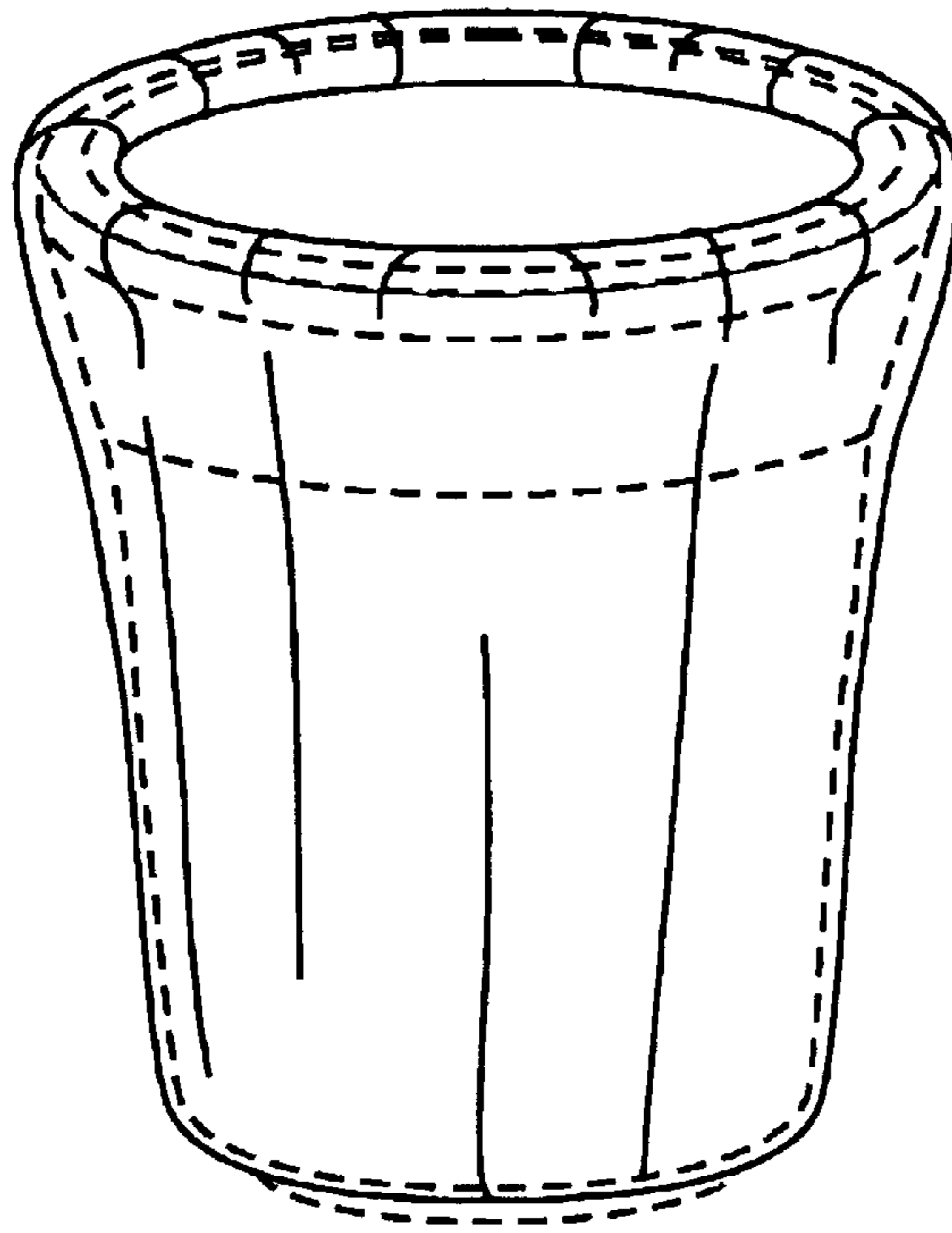

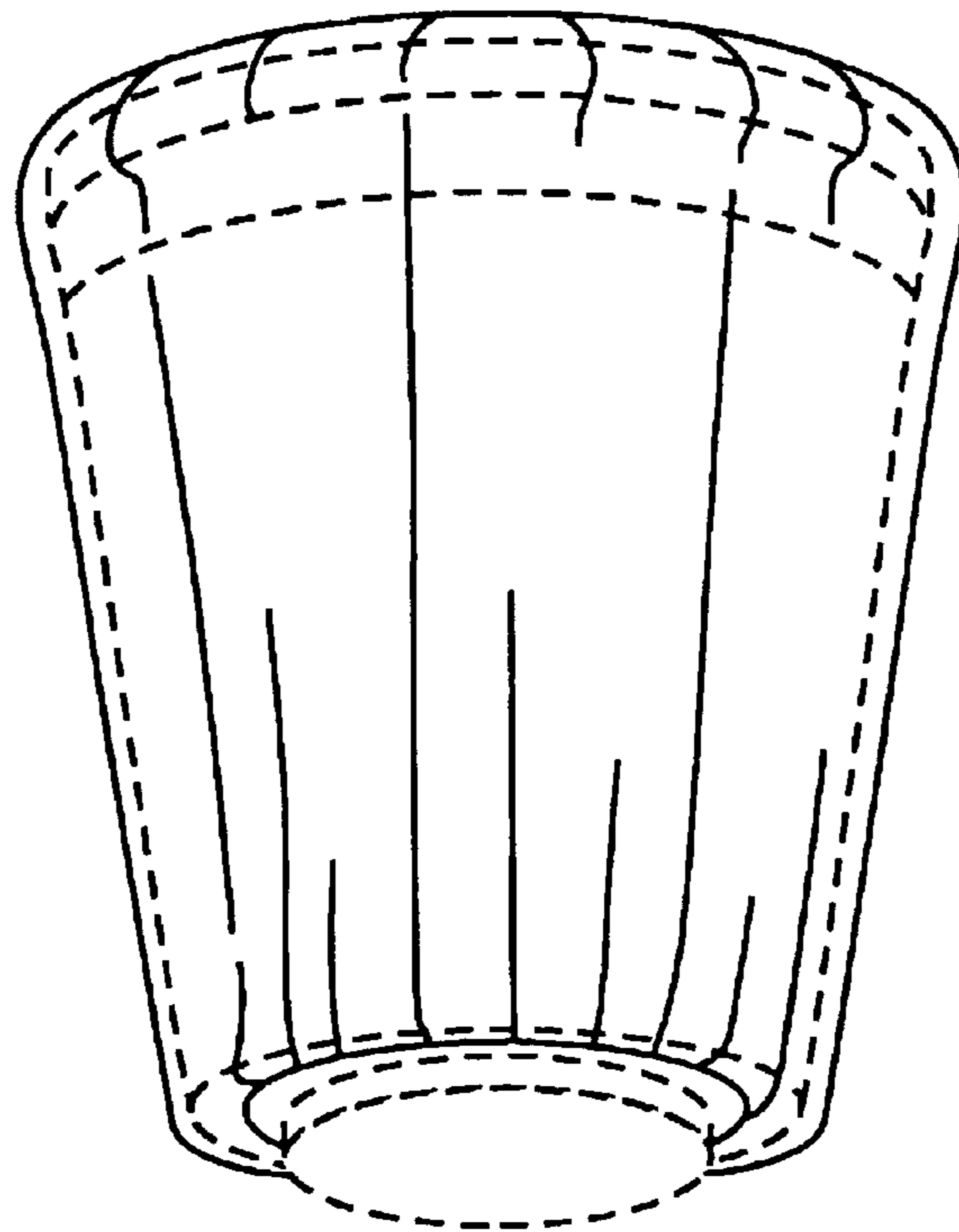

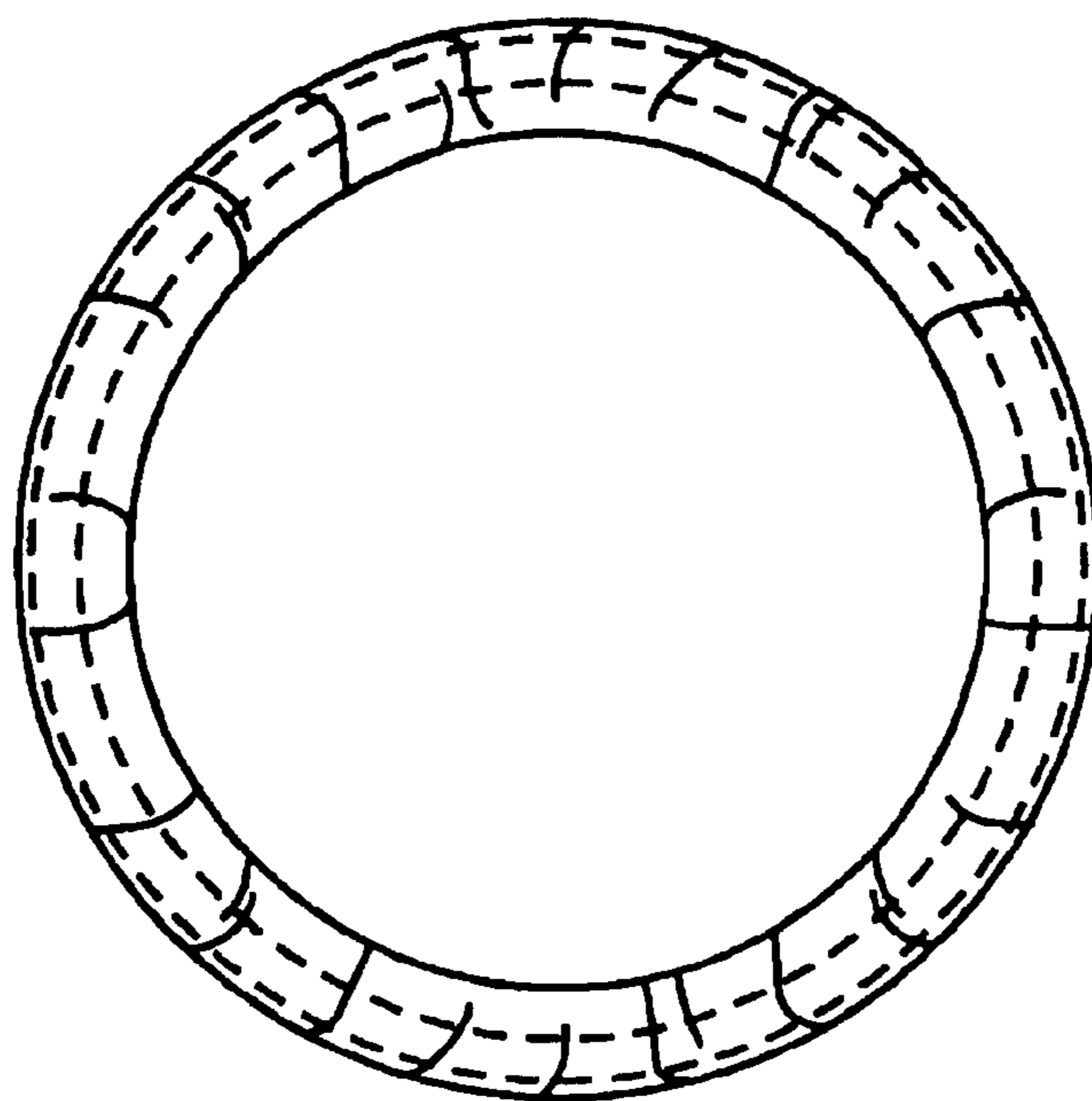

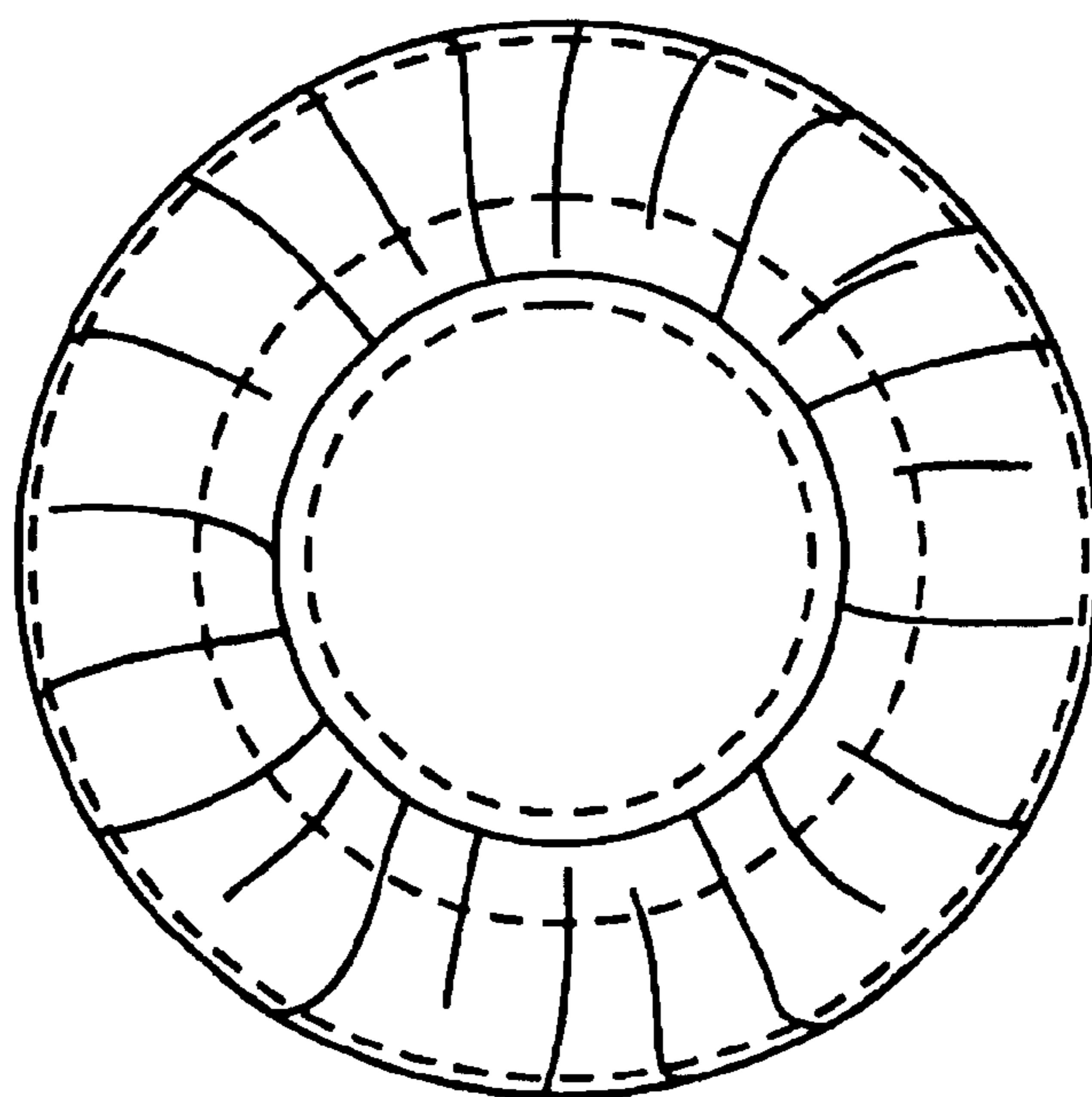
