(57) **CLAIM**

The ornamental design for a handbag, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a handbag showing my new design;

FIG. 2 is a front view of the handbag shown in FIG. 1;

FIG. 3 is a rear view of the handbag shown in FIG. 1;

FIG. 4 is a right side view of the handbag shown in FIG. 1;

FIG. 5 is a left side view of the handbag shown in FIG. 1;

FIG. 6 is a top view of the handbag shown in FIG. 1;

FIG. 7 is a bottom view of the handbag shown in FIG. 1;

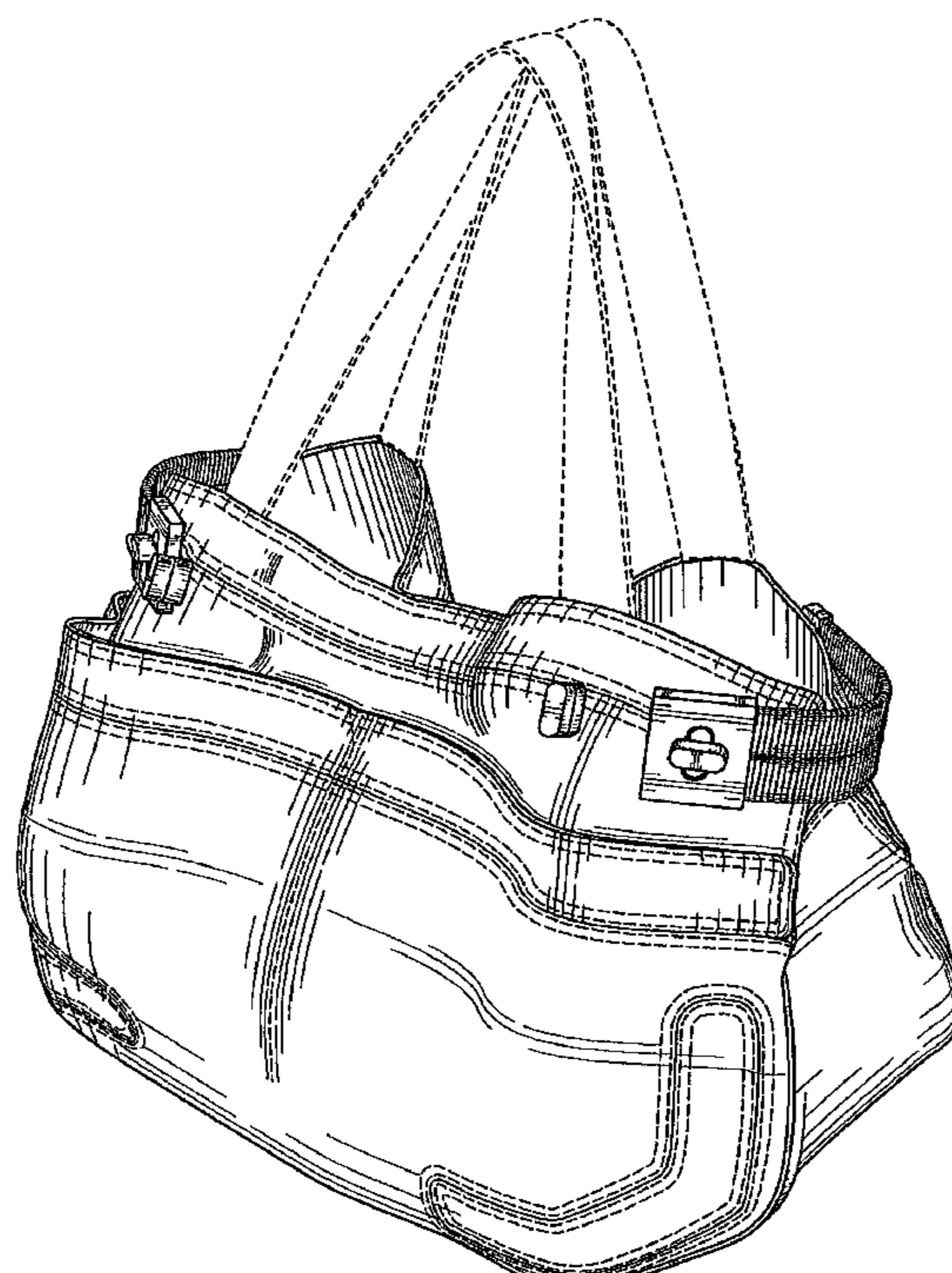
FIG. 8 is a front perspective view of the handbag with the closure mechanism shown in a second position; and,

FIG. 9 is a front view of the handbag.

The broken line showing of the body of the handbag and handles is for illustrative purposes only and forms no part of the claimed design.

The dotted lines shown in FIGS. 1-7, other than those representing the body of the handbag and handles, are understood to represent stitching.

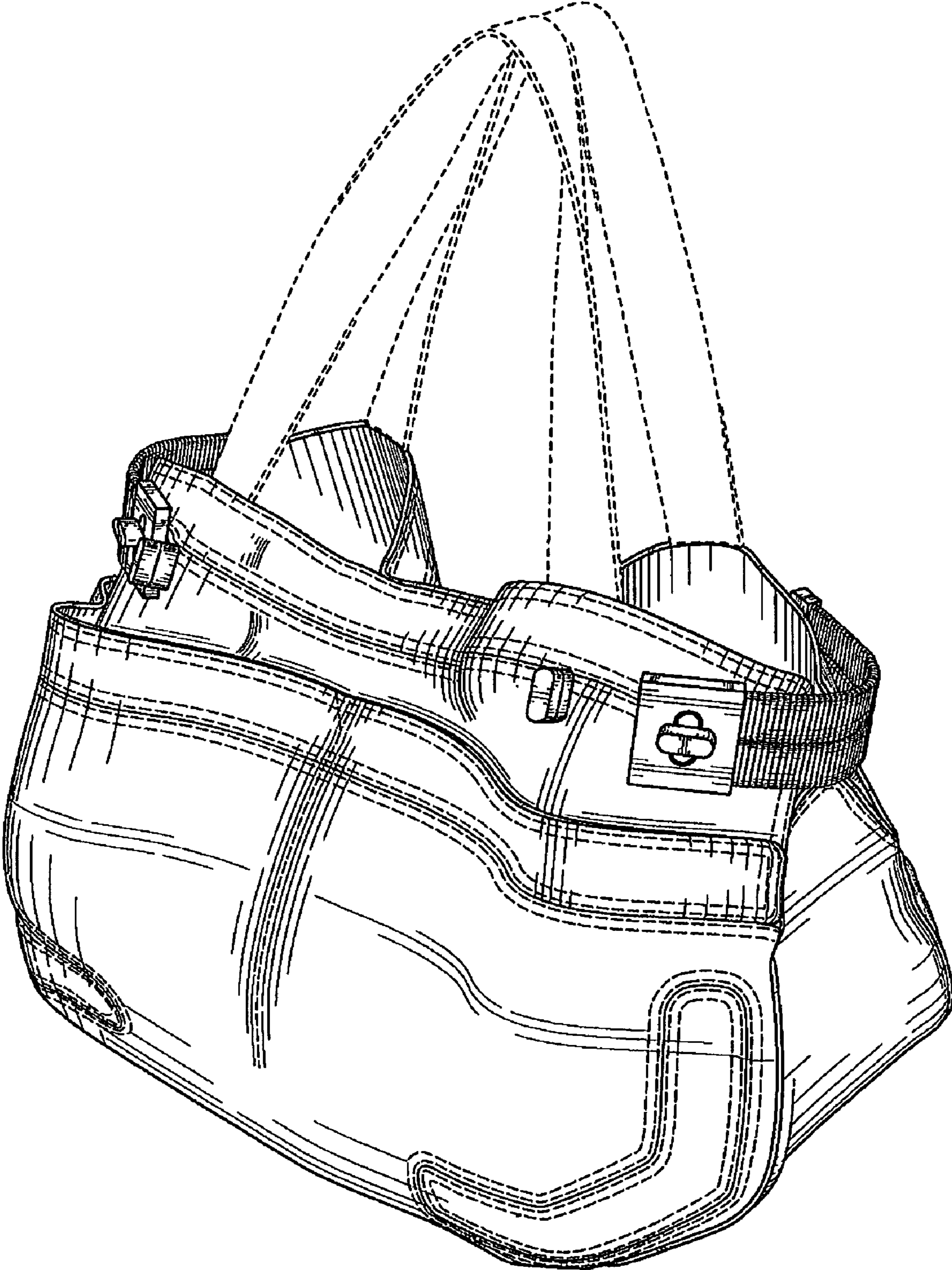

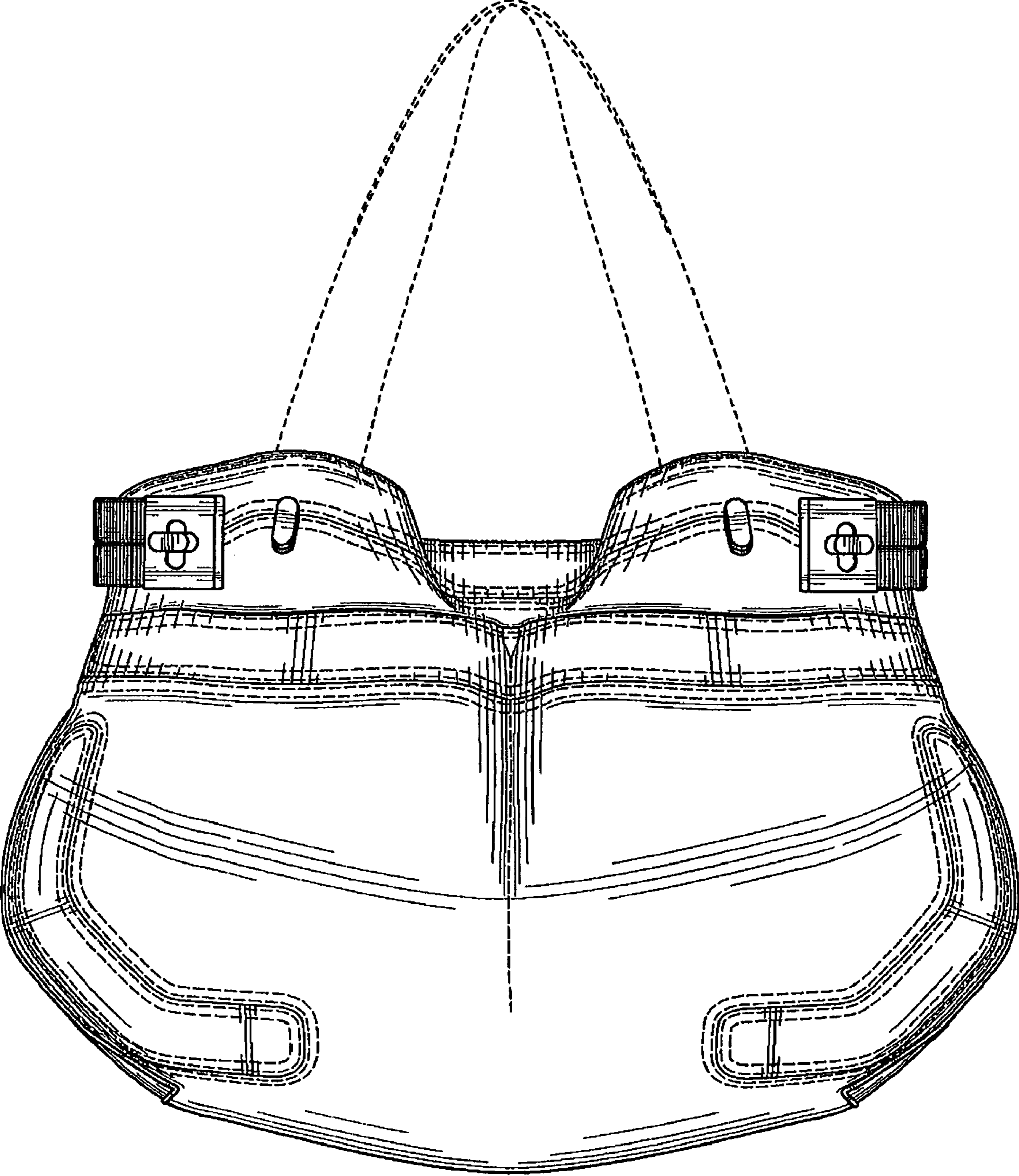

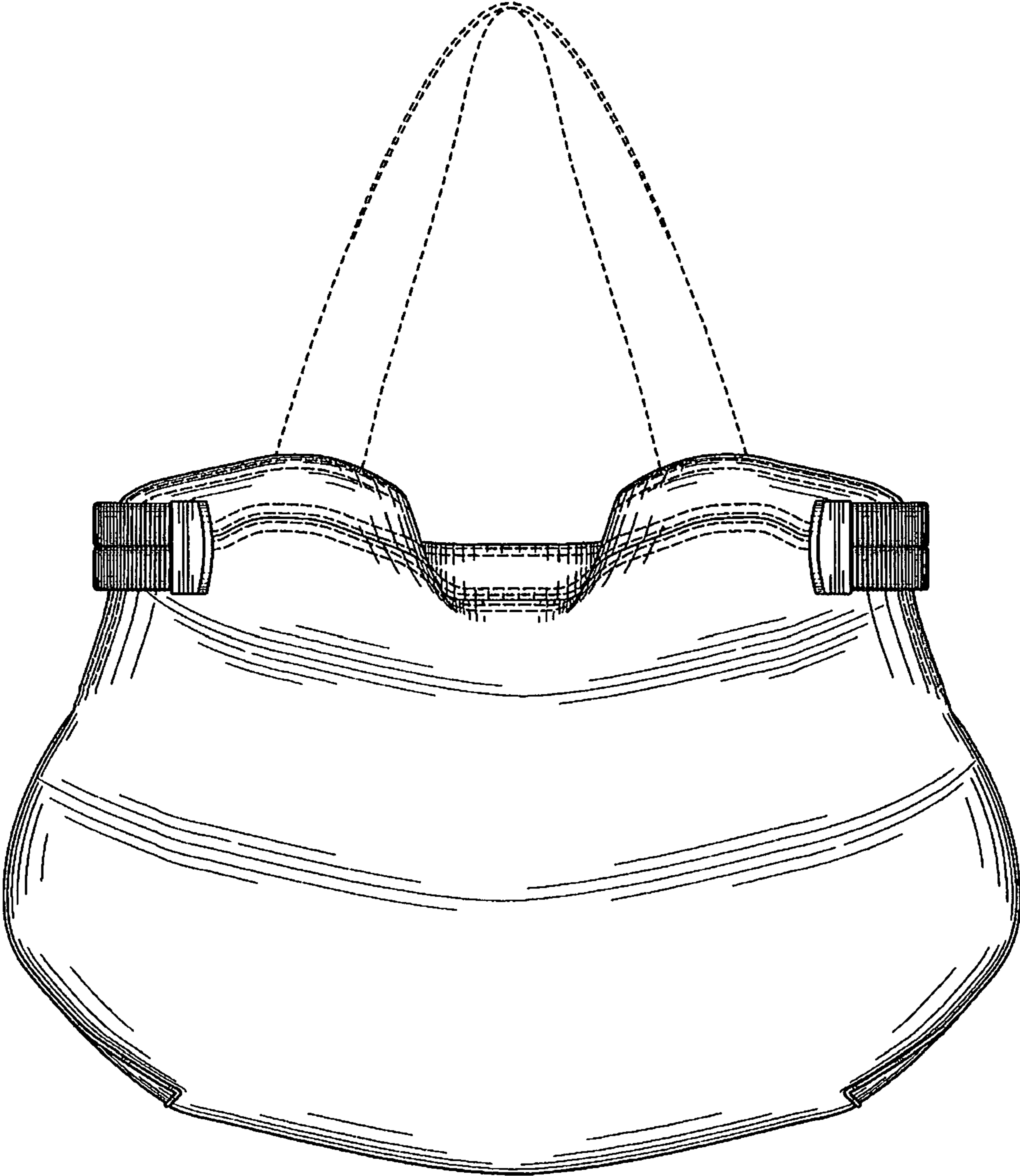

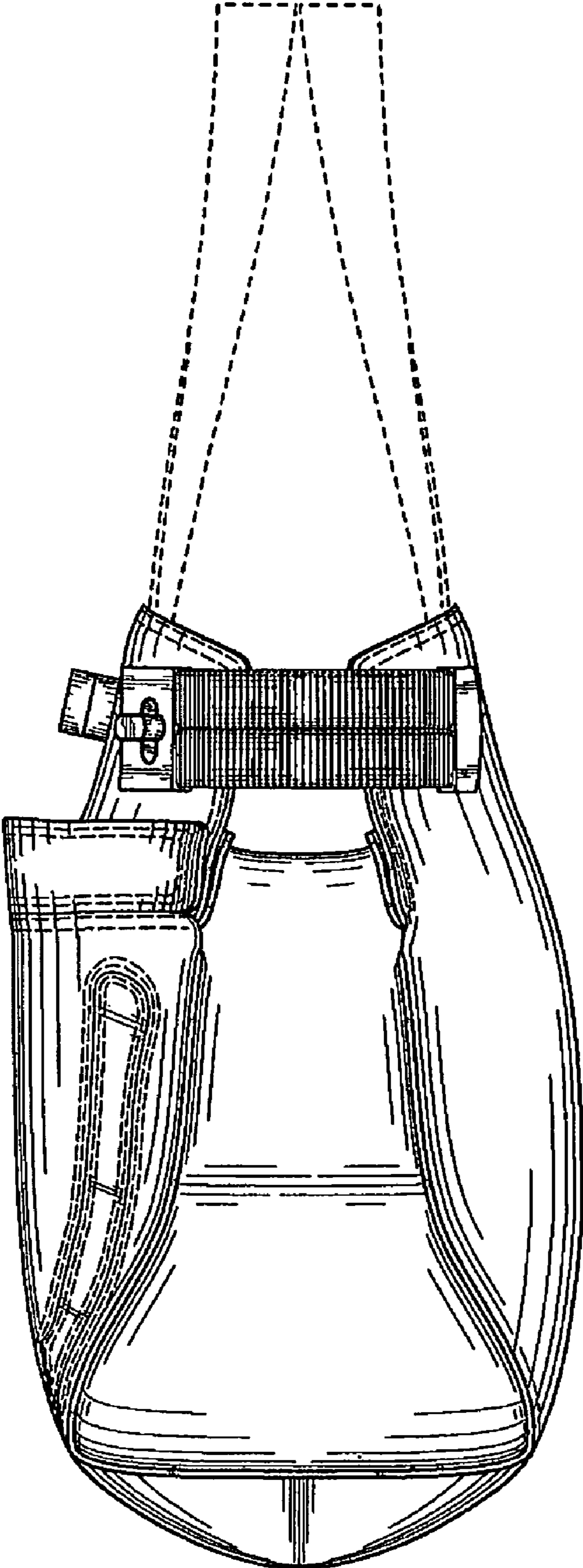

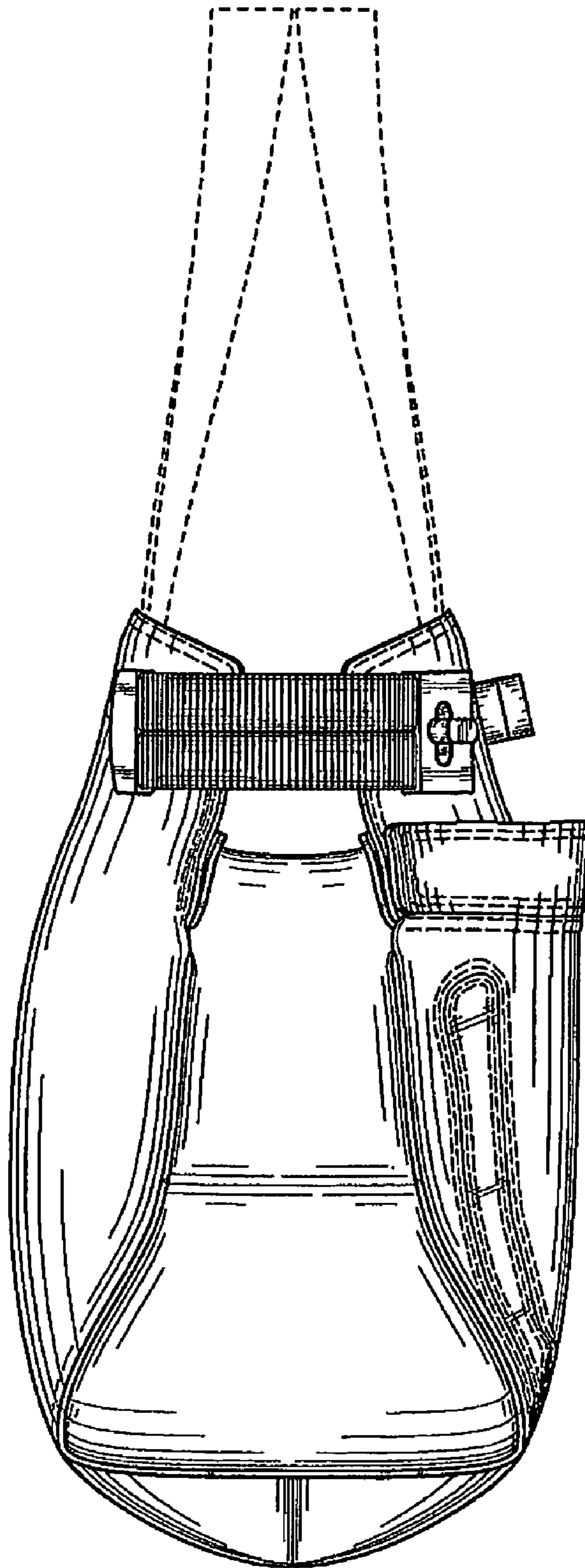

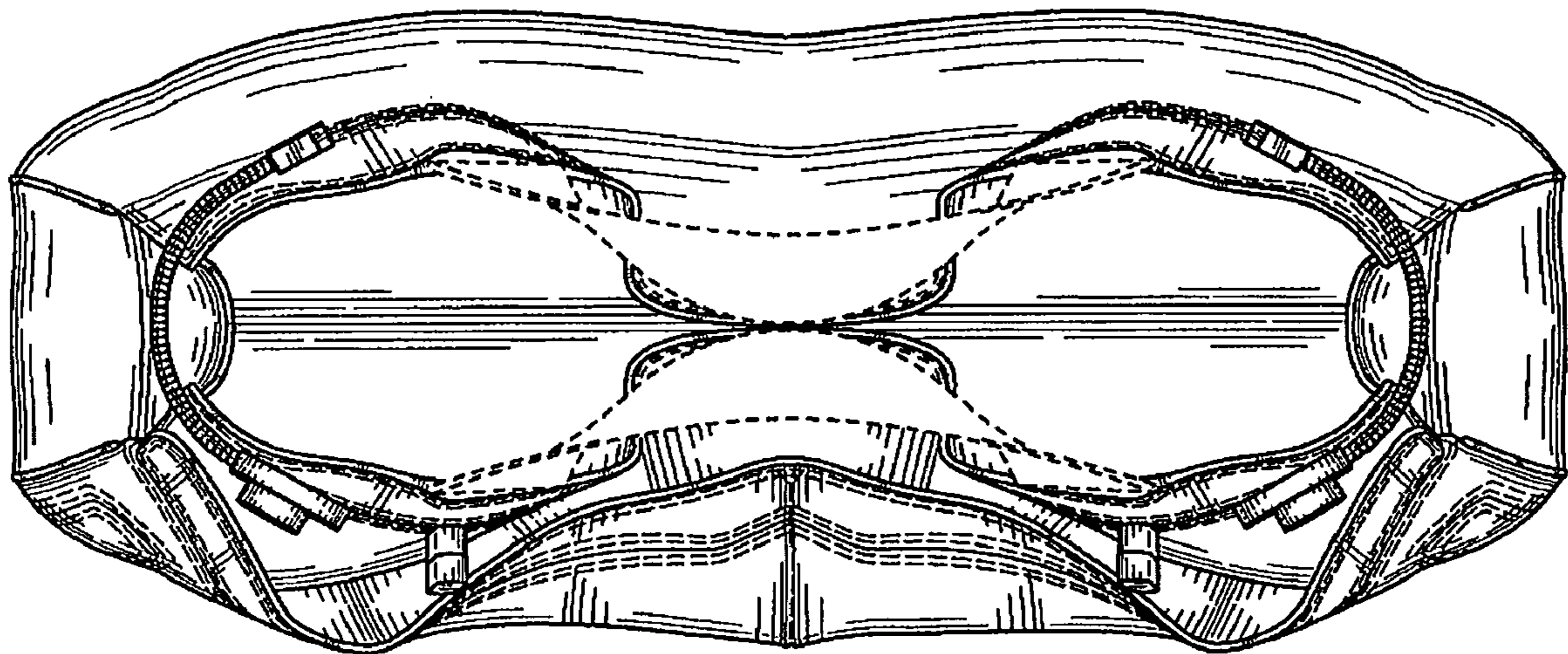

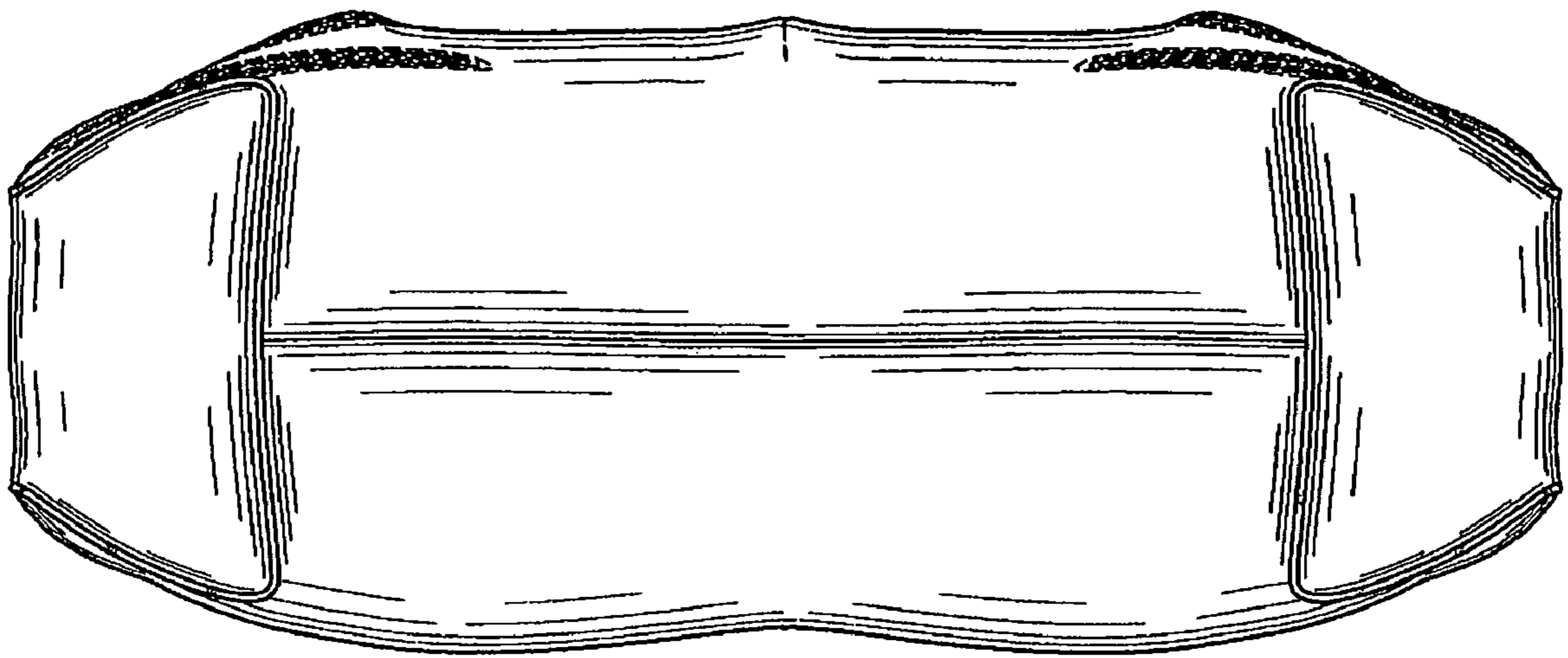

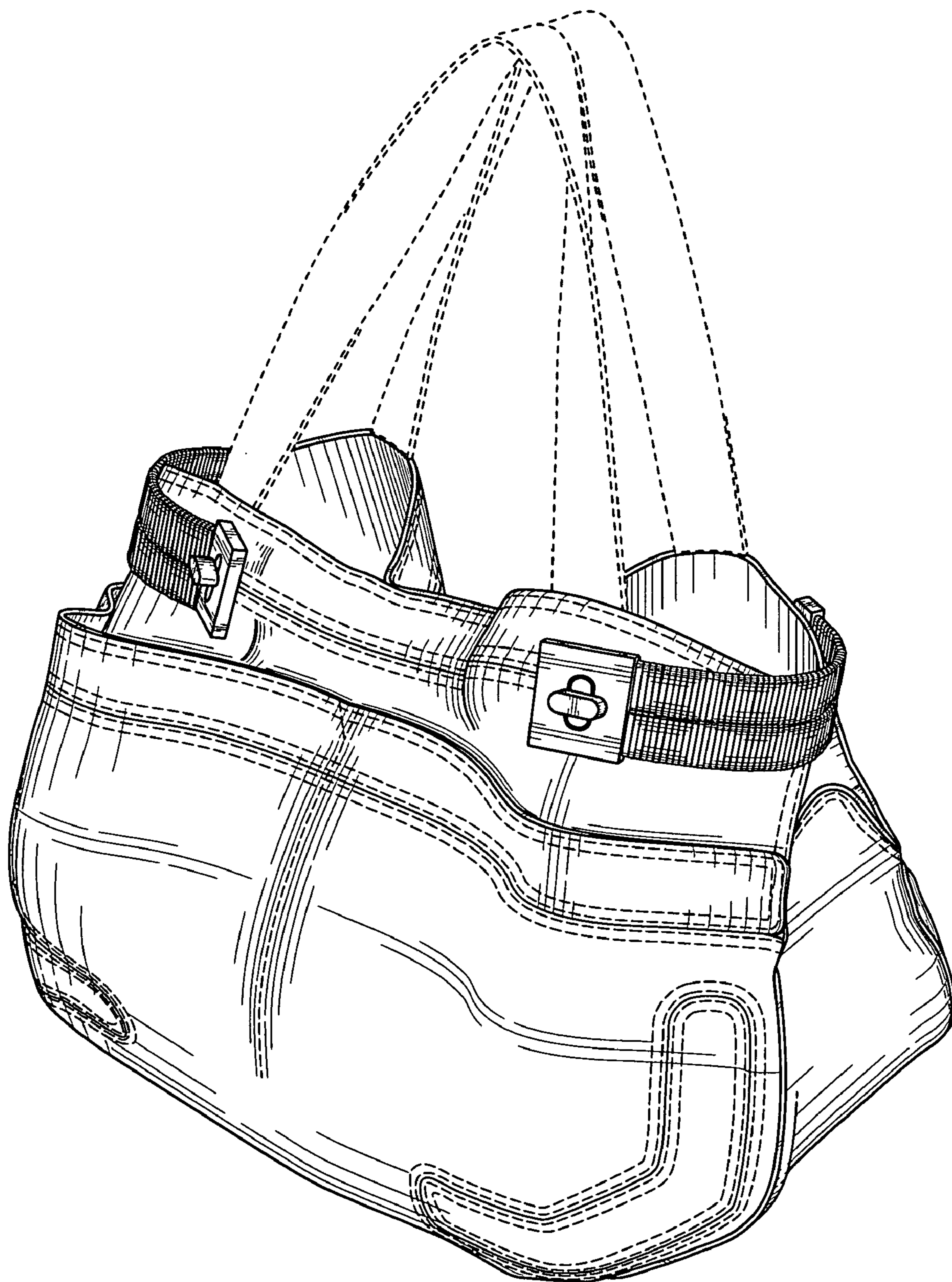

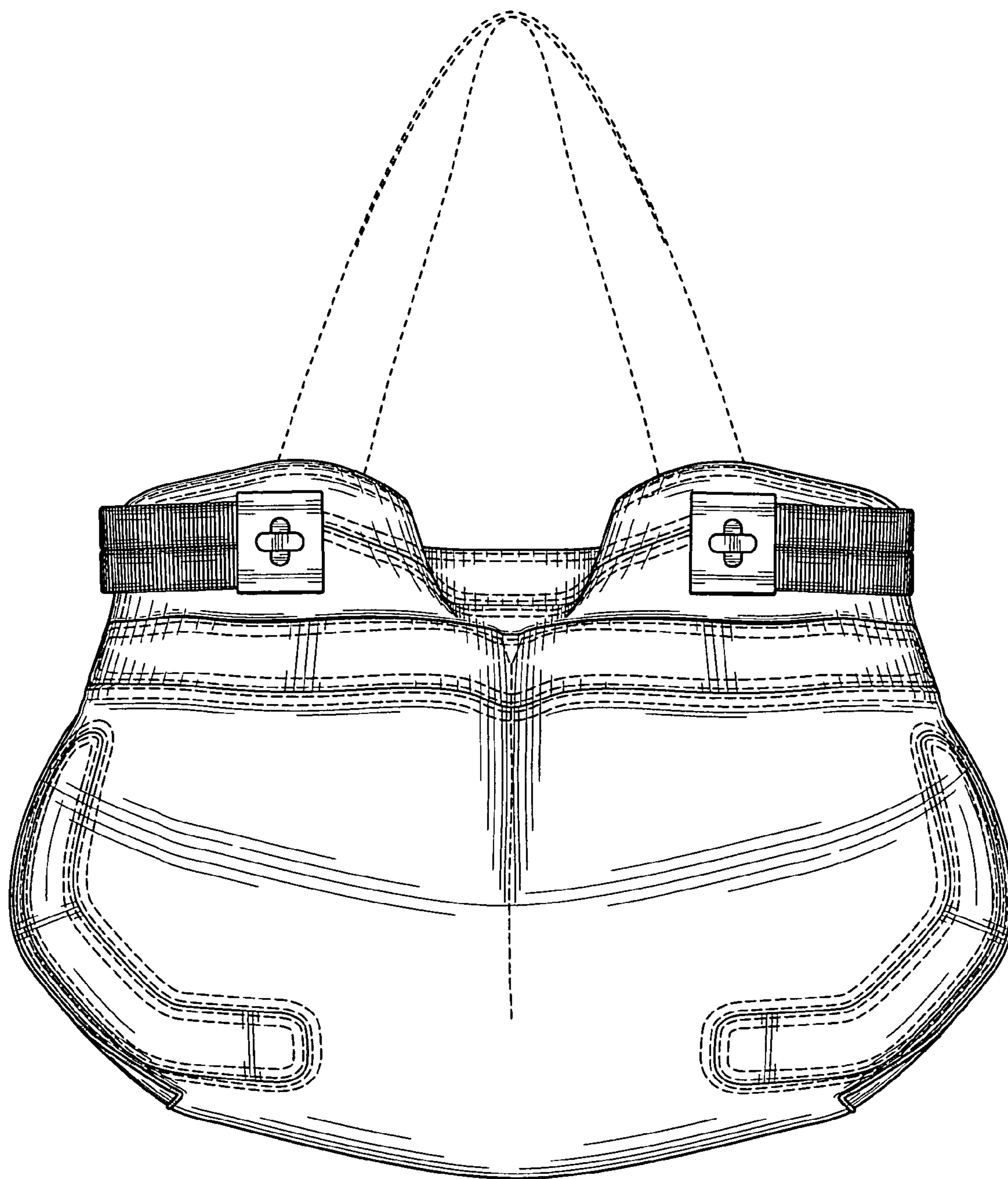
