(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a bottom, front, and right side perspective view of a first embodiment of my bottle;

FIG. 2 is a front elevational view thereof, the rear elevational view being identical;

FIG. 3 is a right side elevational view thereof, the left side elevational view being identical;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a bottom, front, and right side perspective view of a second embodiment of my bottle, the only difference being that the bottle is transparent;

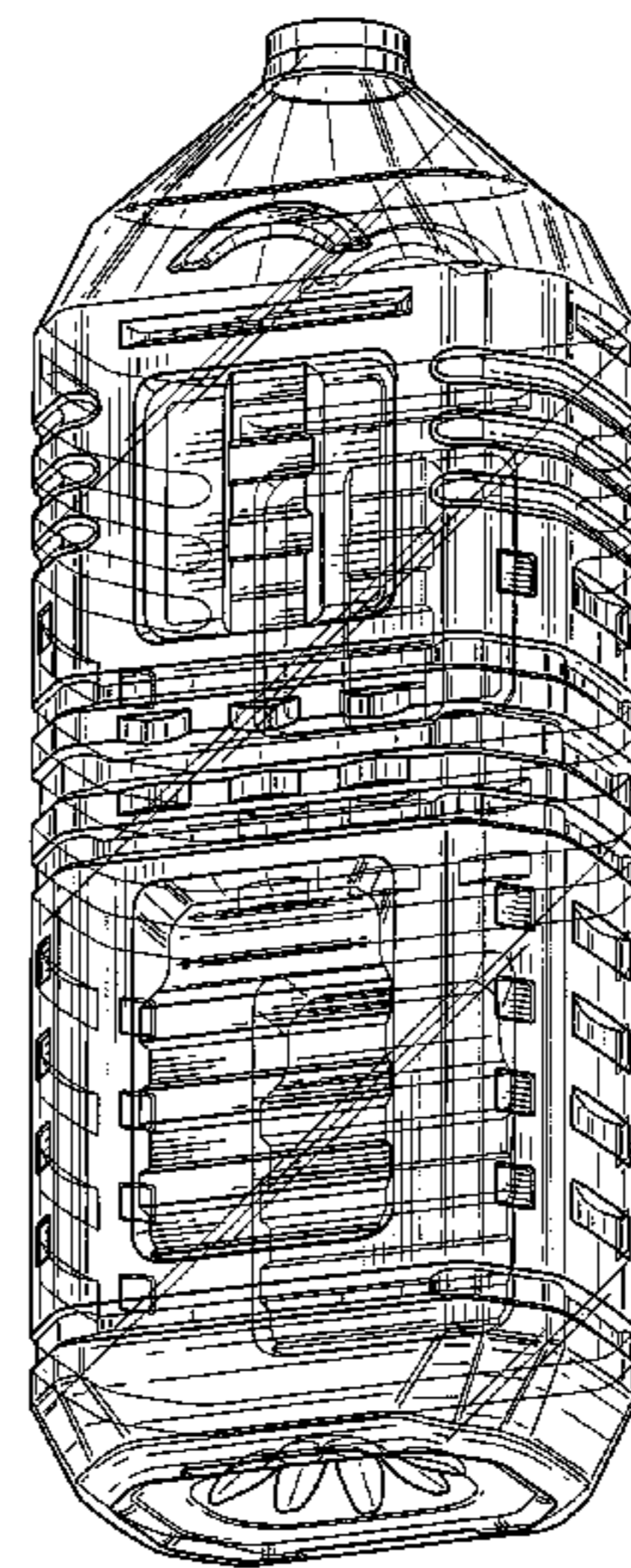
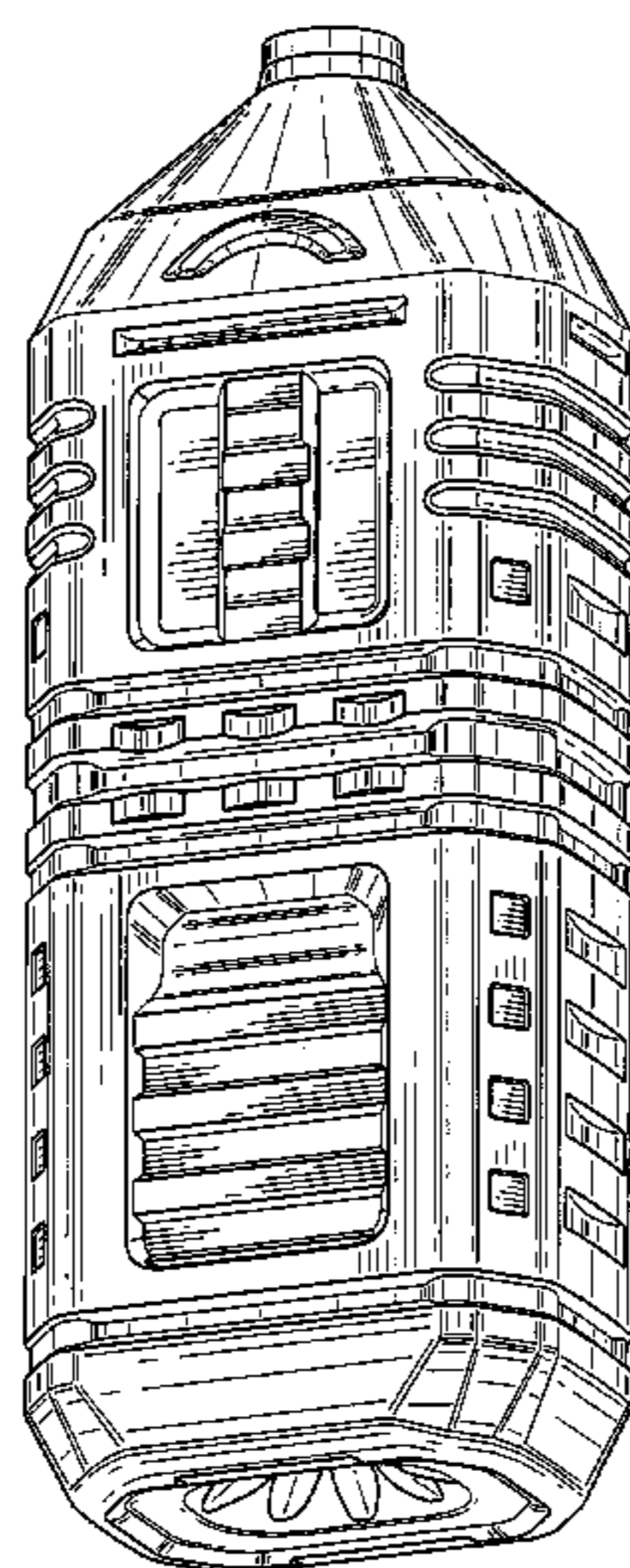
FIG. 7 is a front elevational view thereof, the rear elevational view being identical;

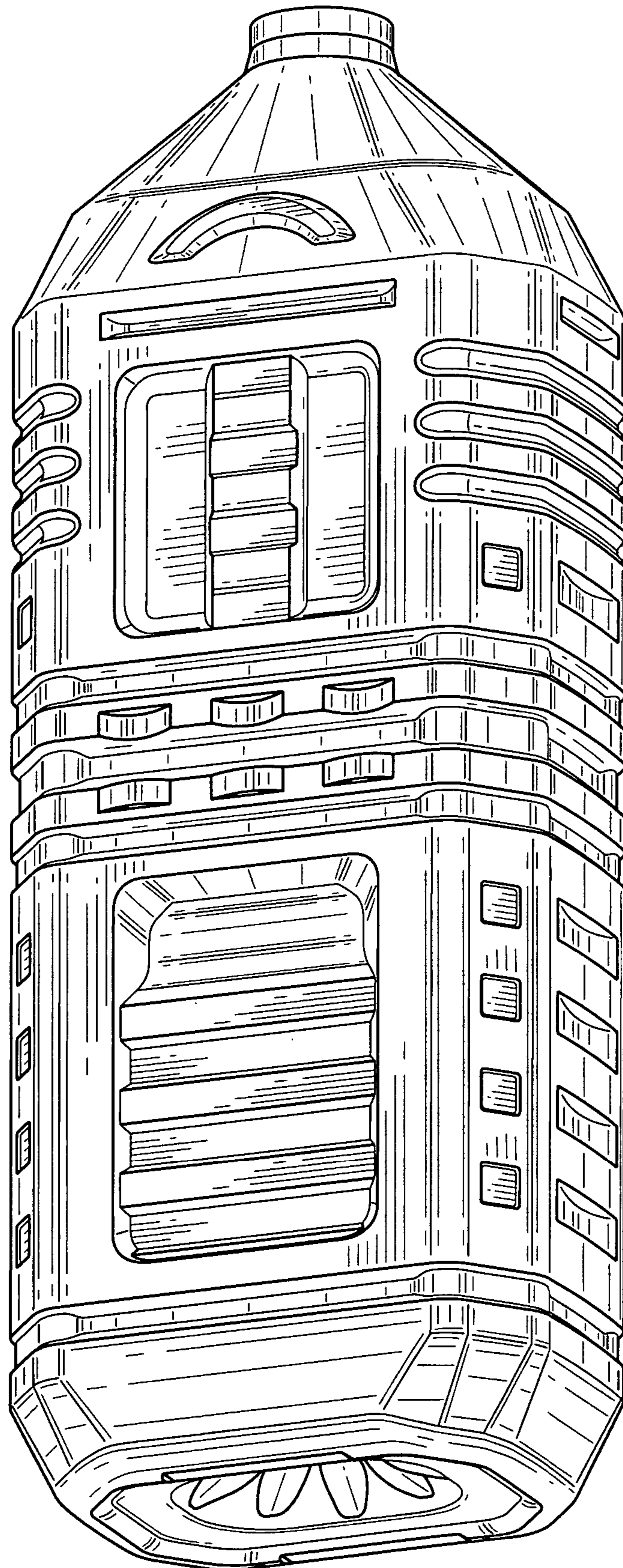

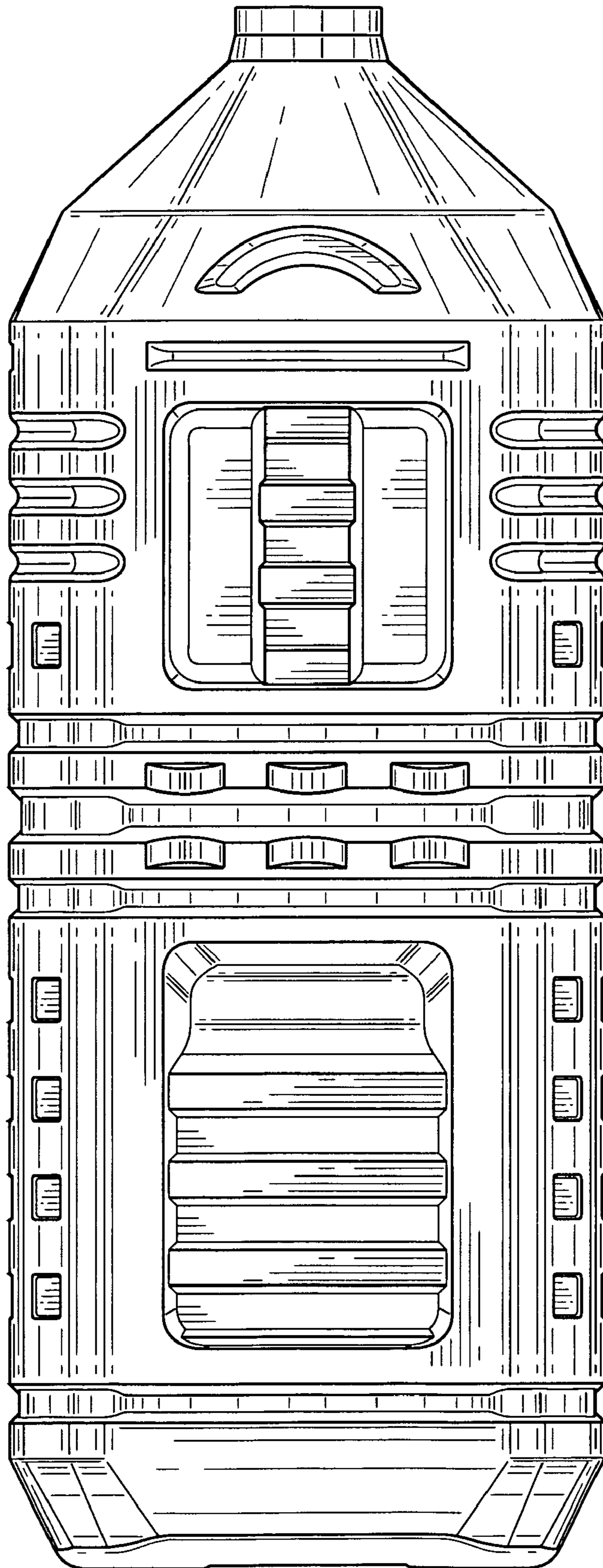

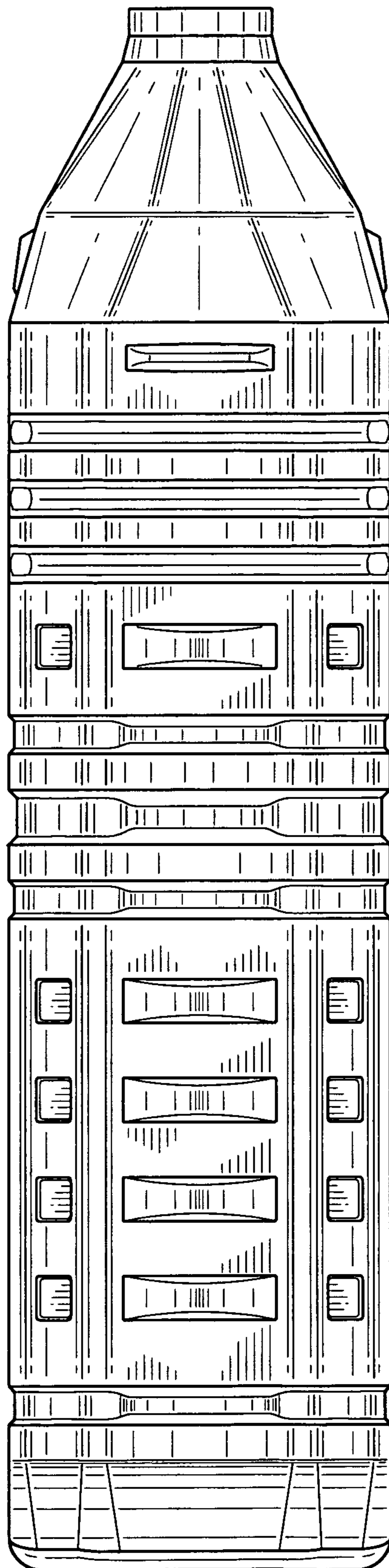

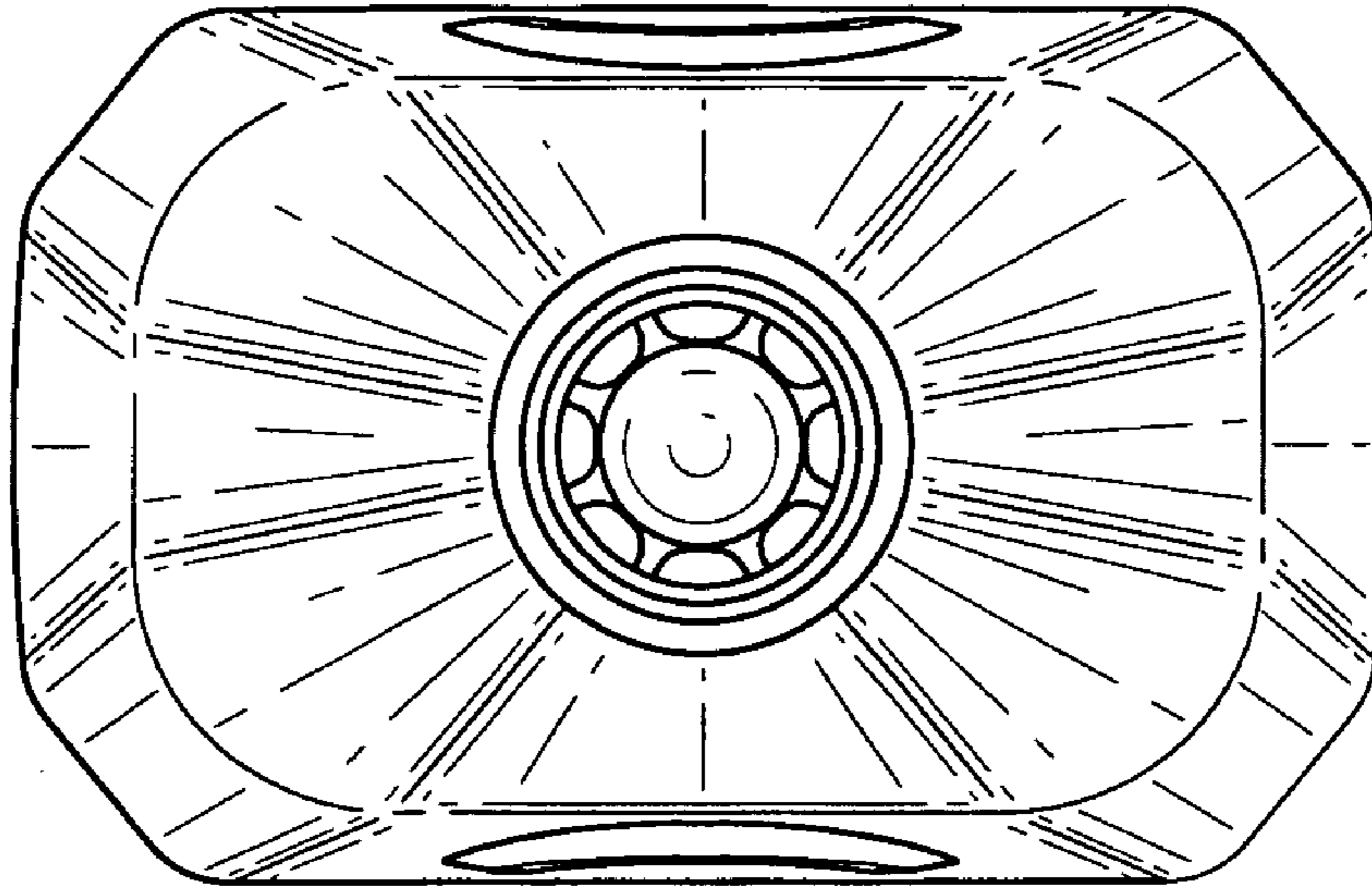

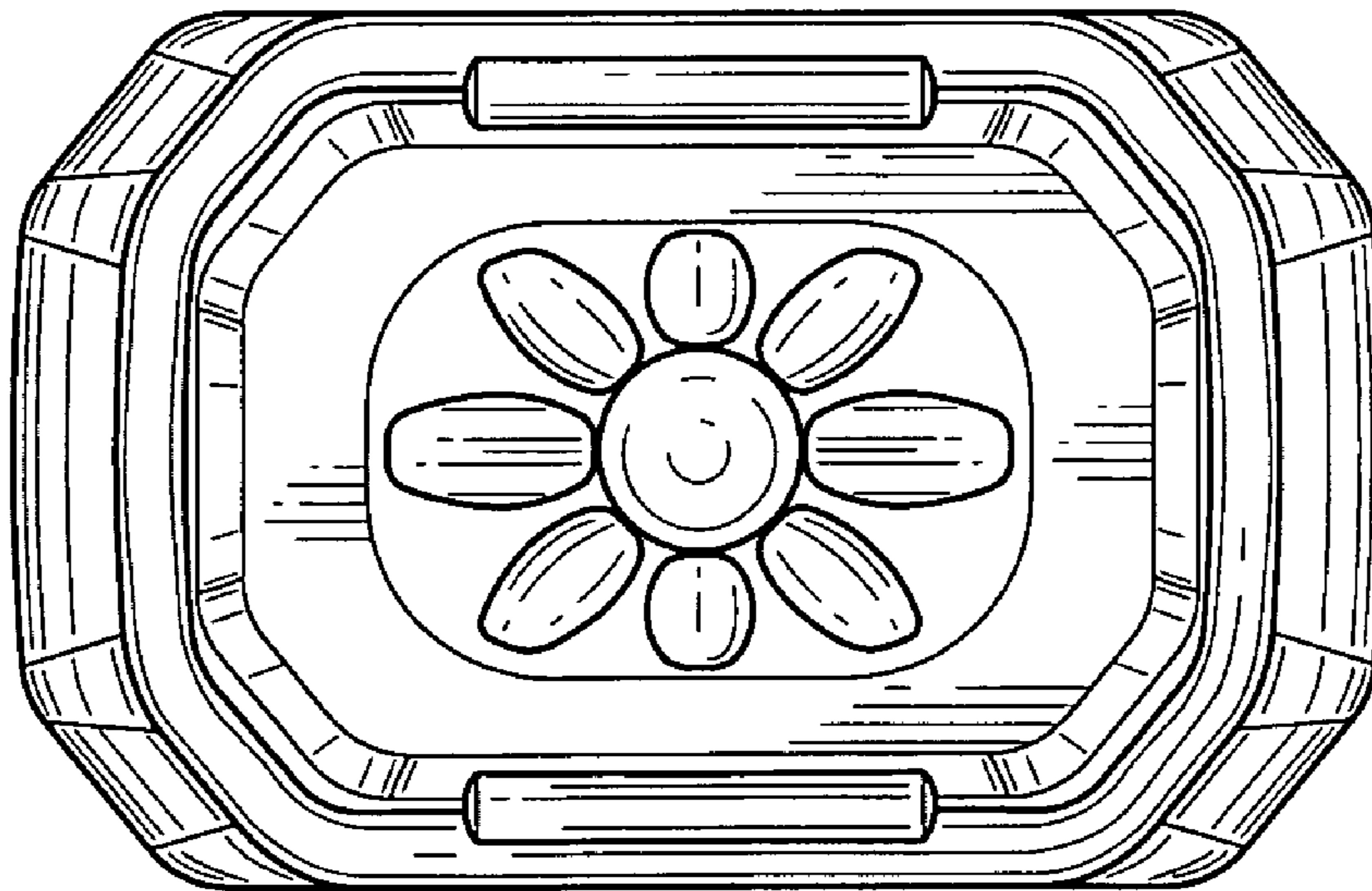

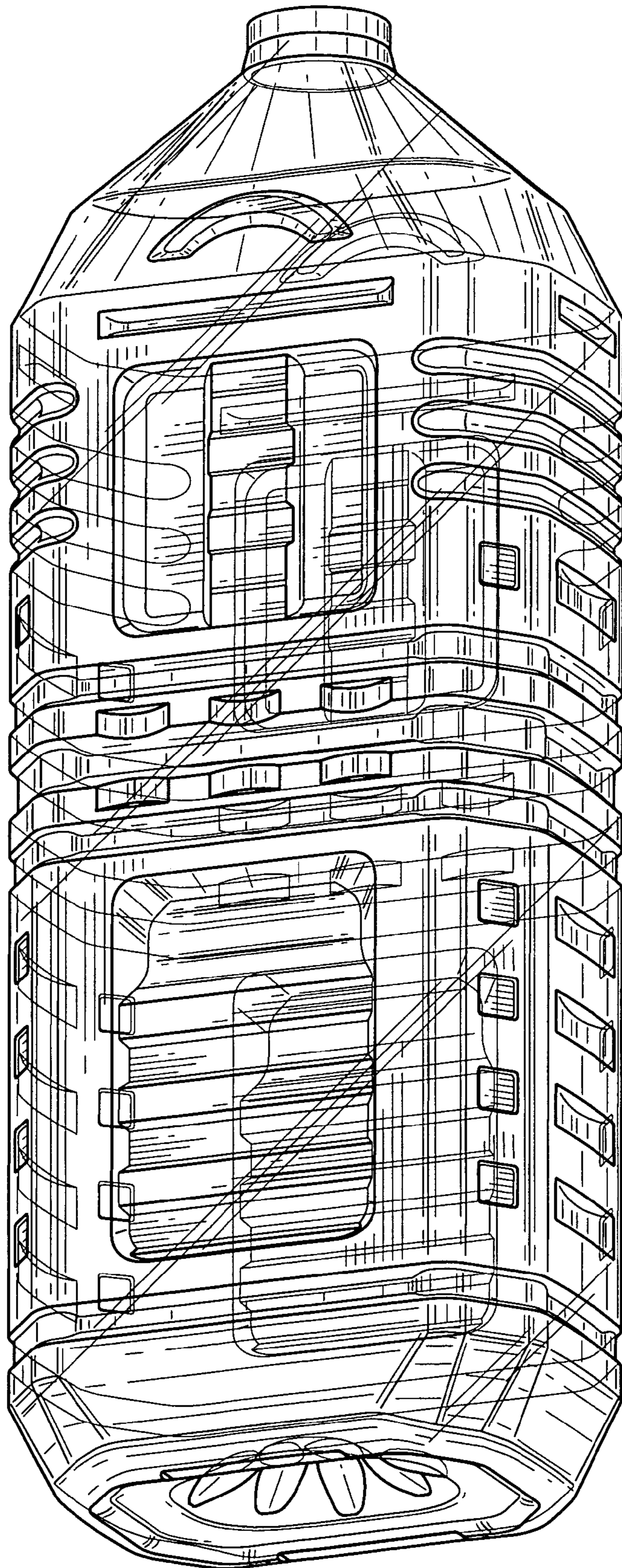

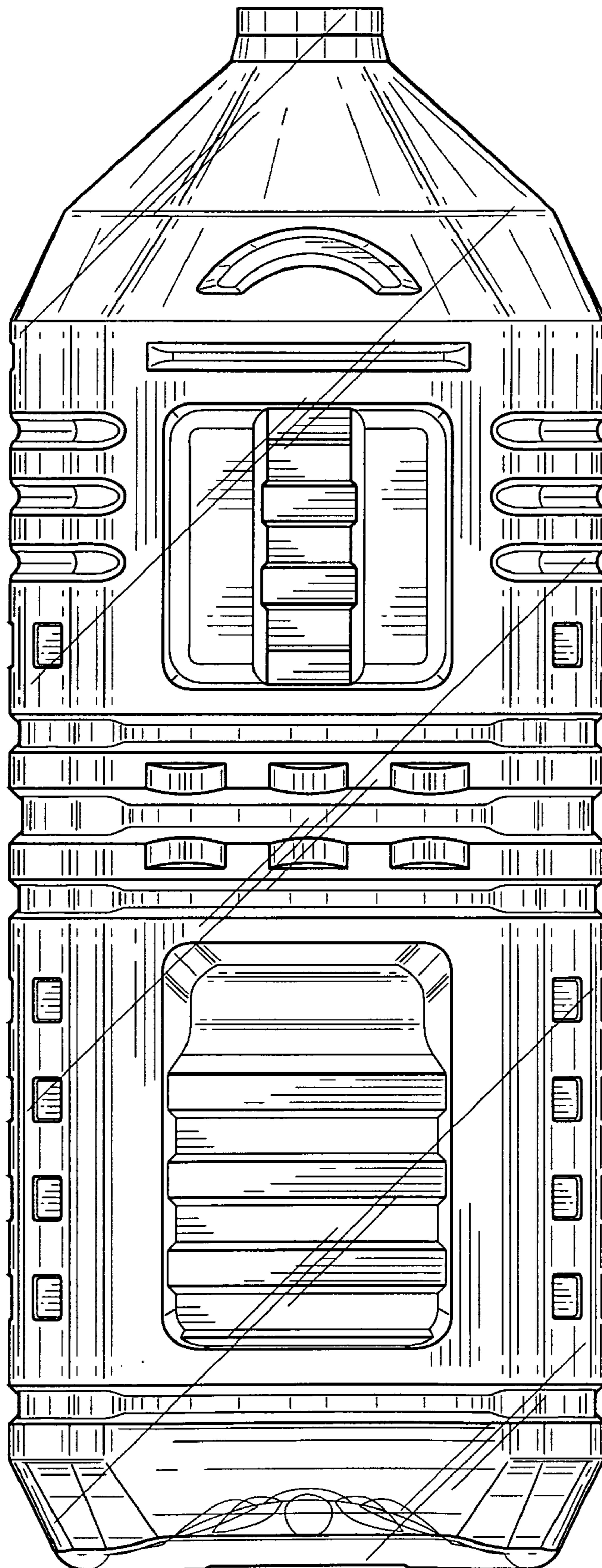

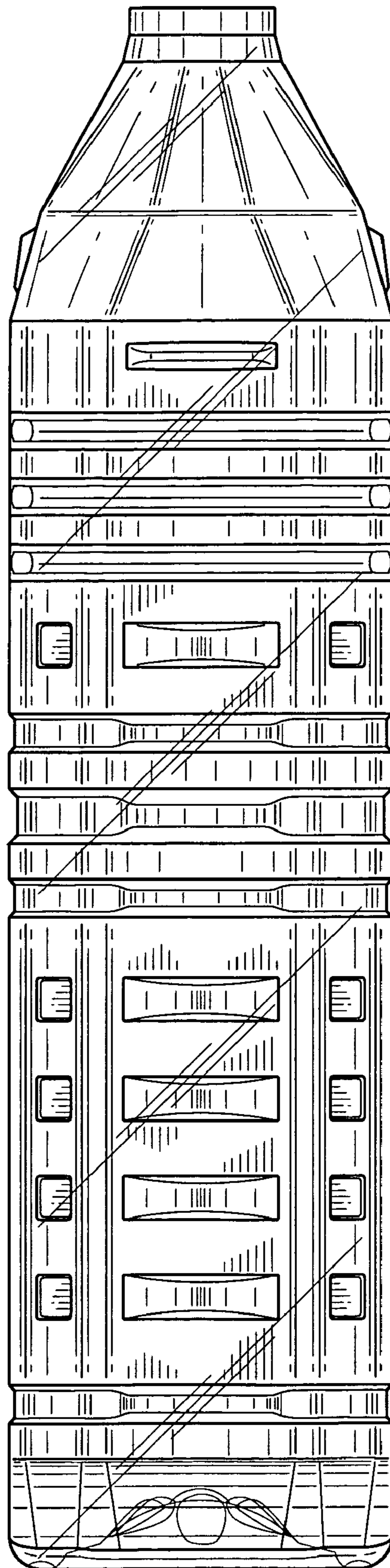

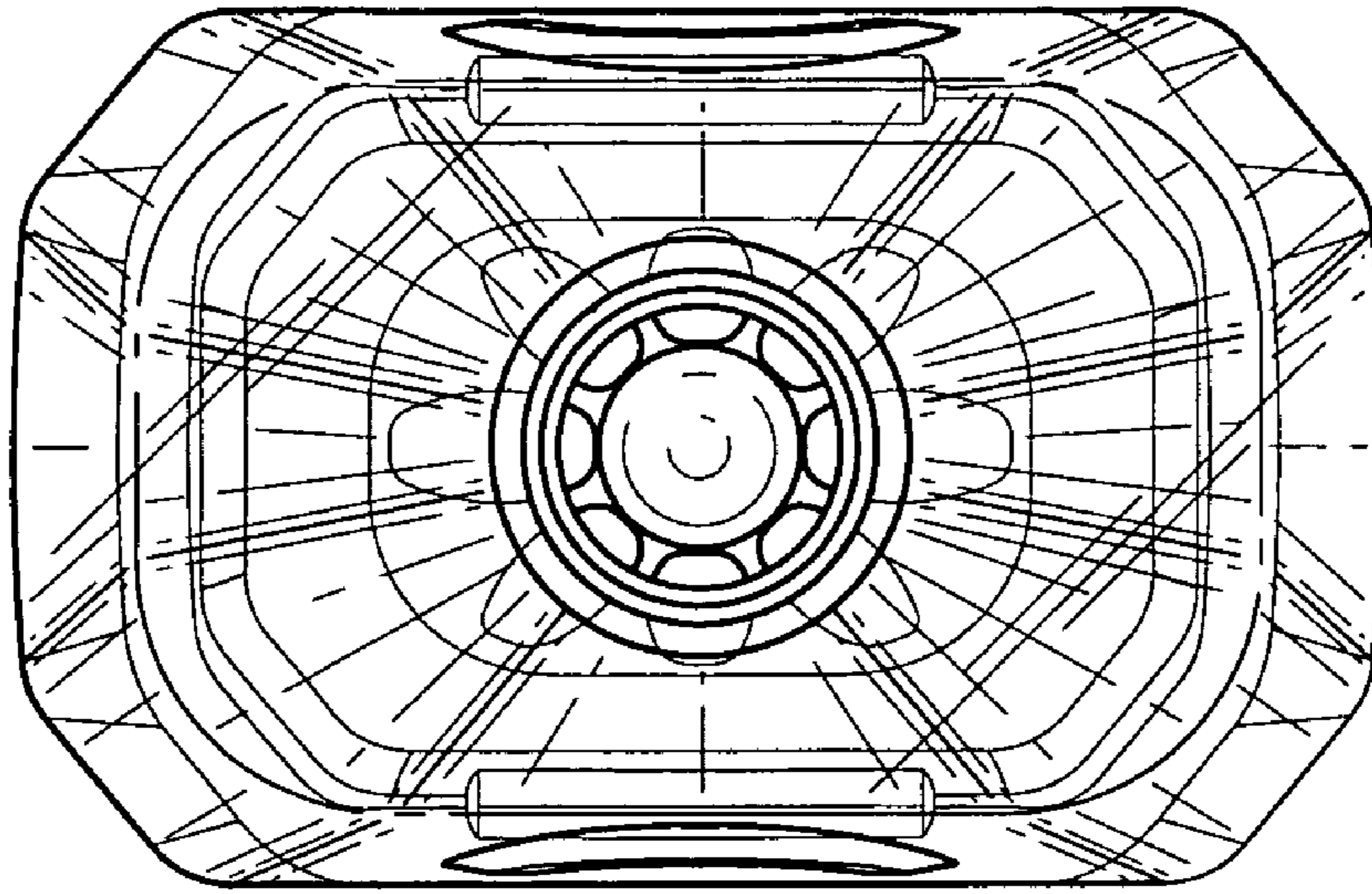

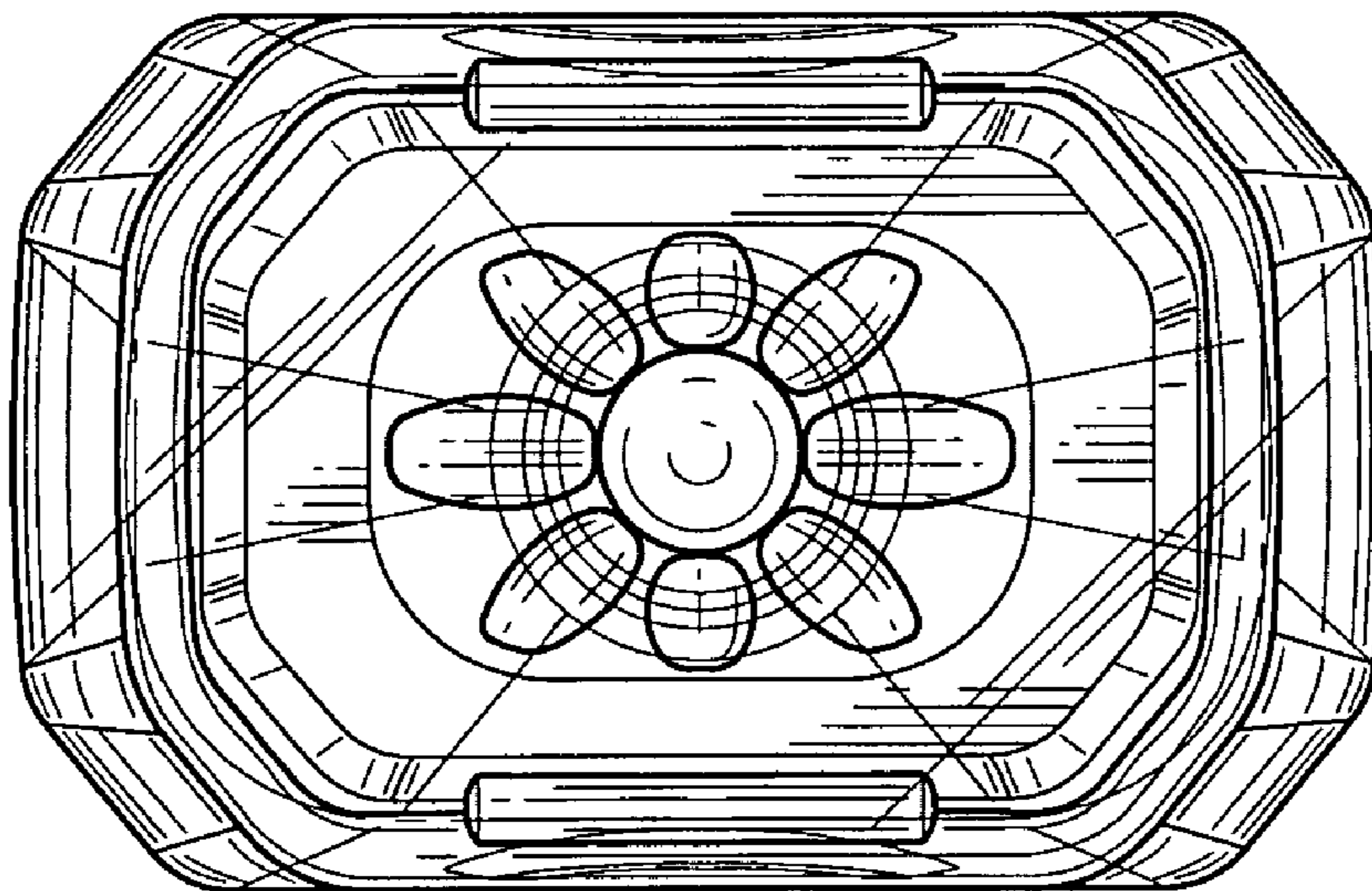
