FIG. 3 is a front view of the automobile wheel of FIG. 1 (wherein the automobile wheel is shown without a tire mounted thereon).

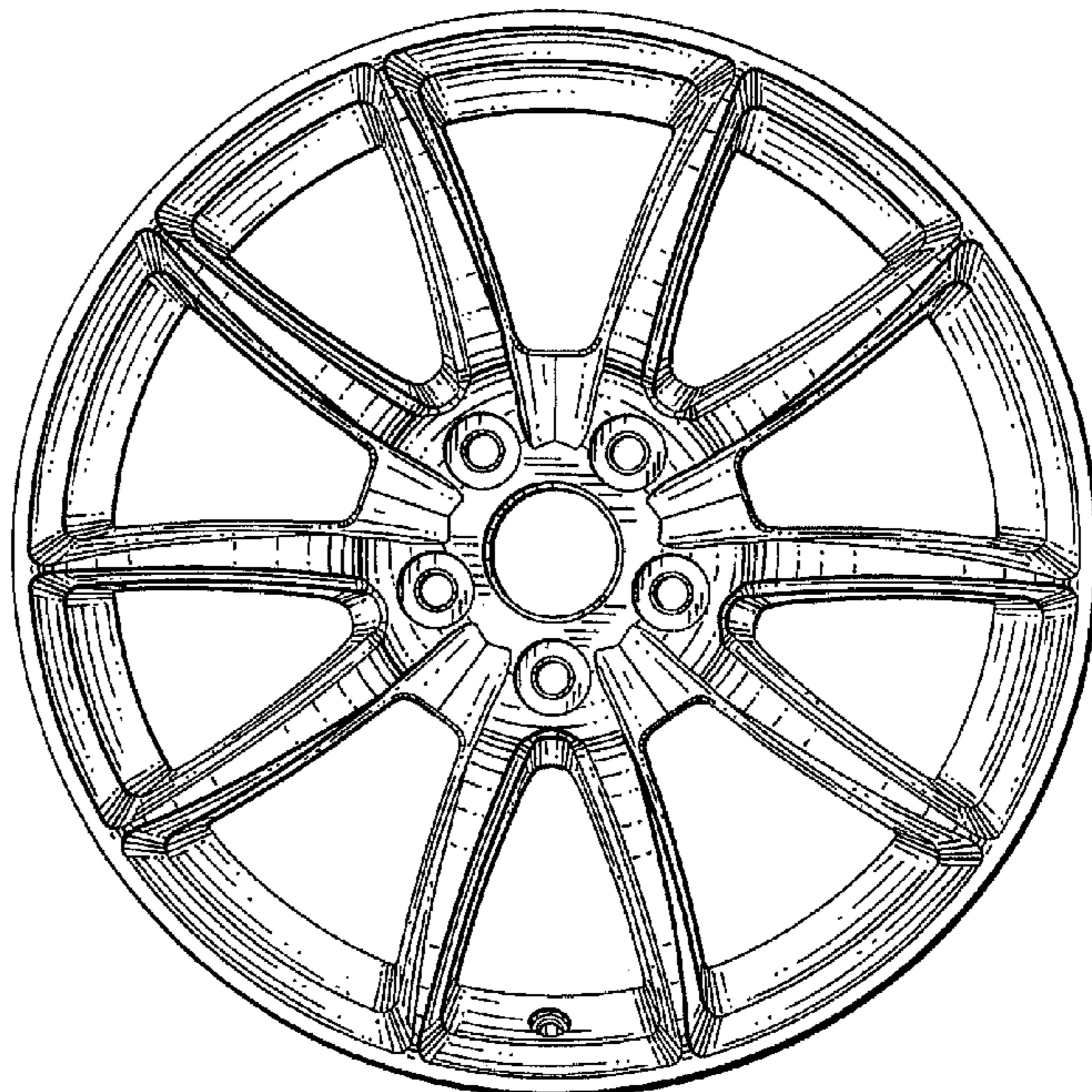
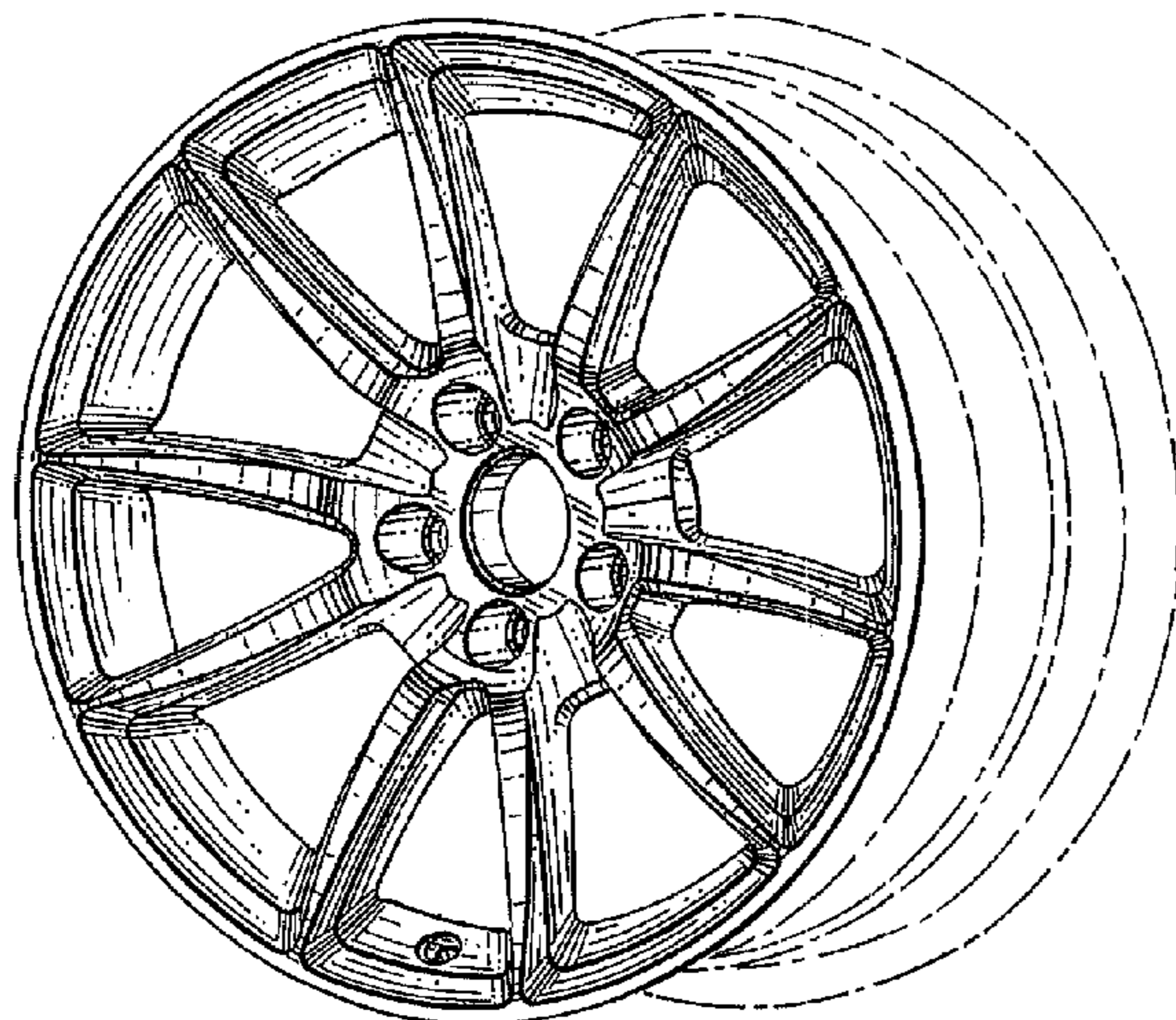

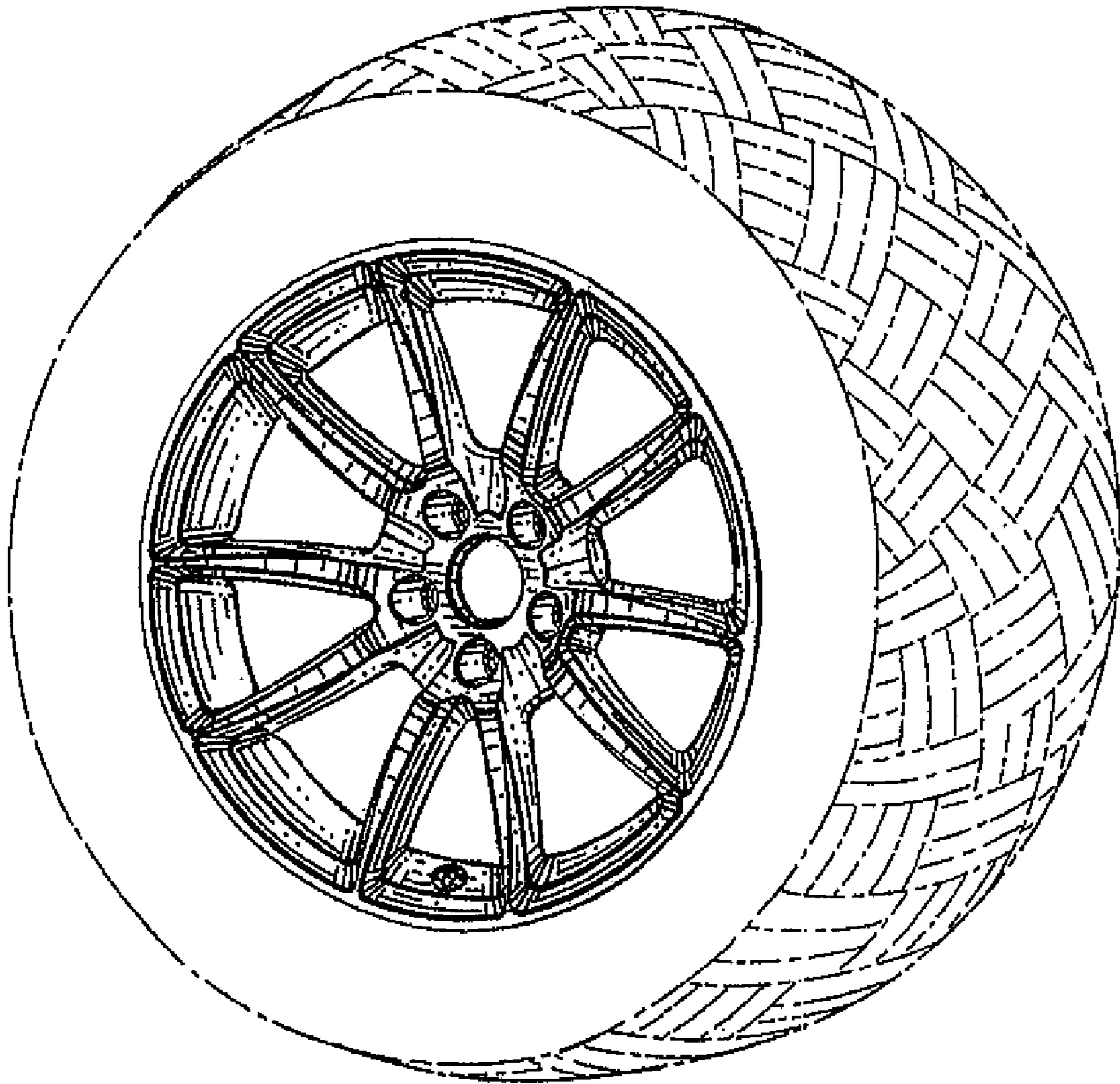

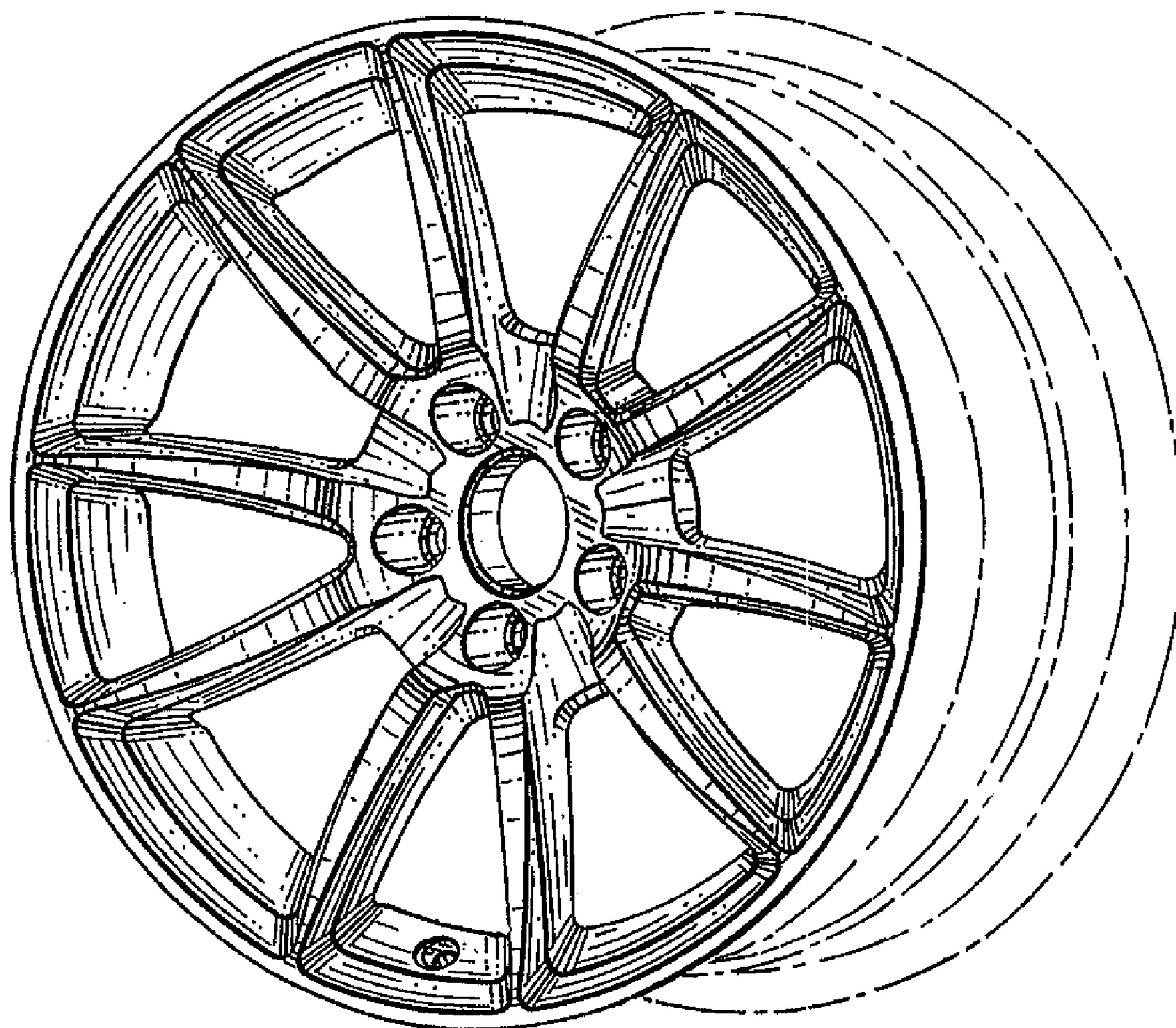

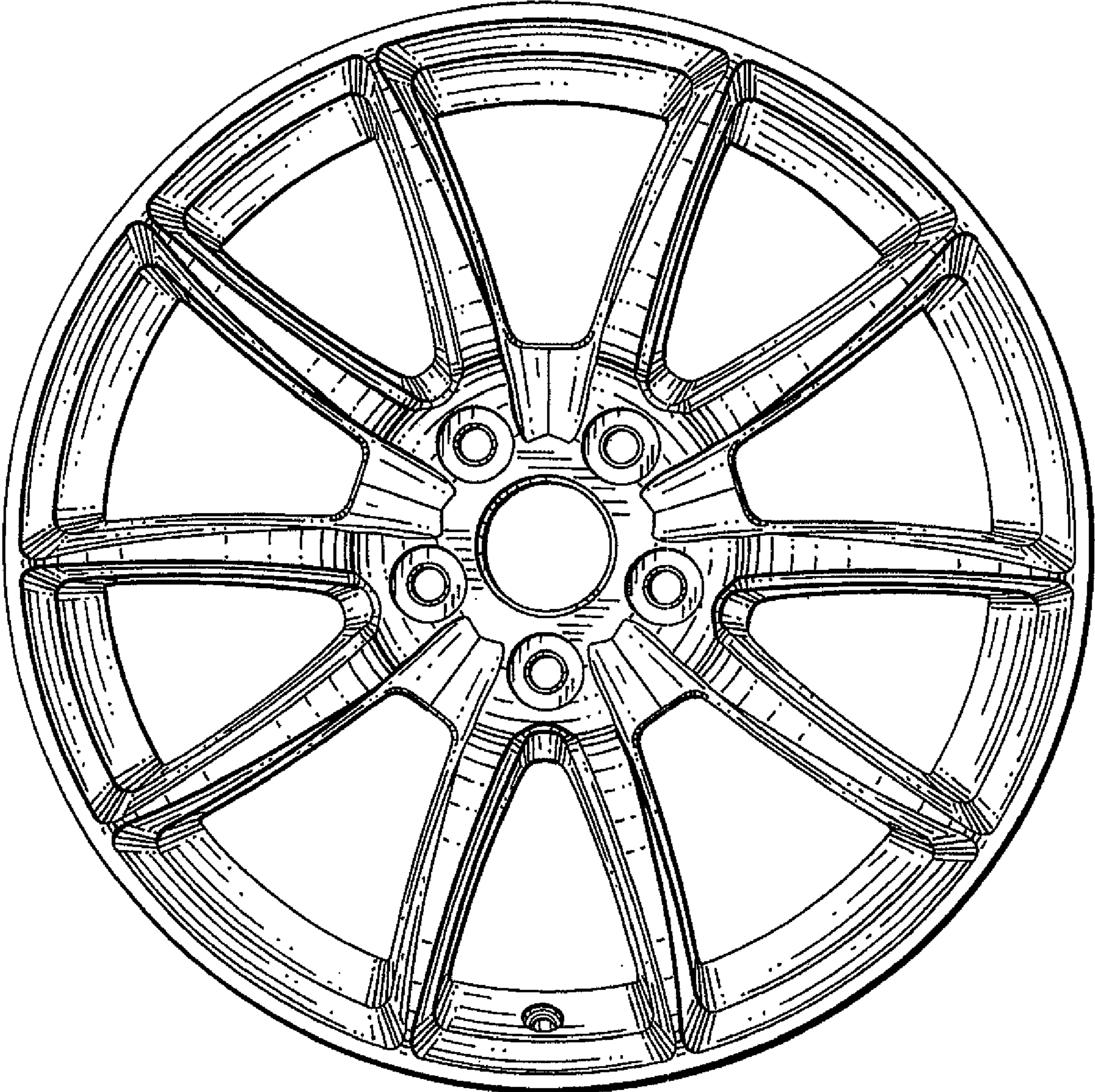
