The ornamental design for a utility vehicle, as shown and described.

**DESCRIPTION**

FIG. 1 is a rear view of a utility vehicle showing our new design;

FIG. 2 is a right side view of the utility vehicle in accordance with the design;

FIG. 3 is a left side view of the utility vehicle in accordance with the design;

FIG. 4 is a front view of the utility vehicle in accordance with the design;

FIG. 5 is a front perspective view of the utility vehicle in accordance with the invention; and,

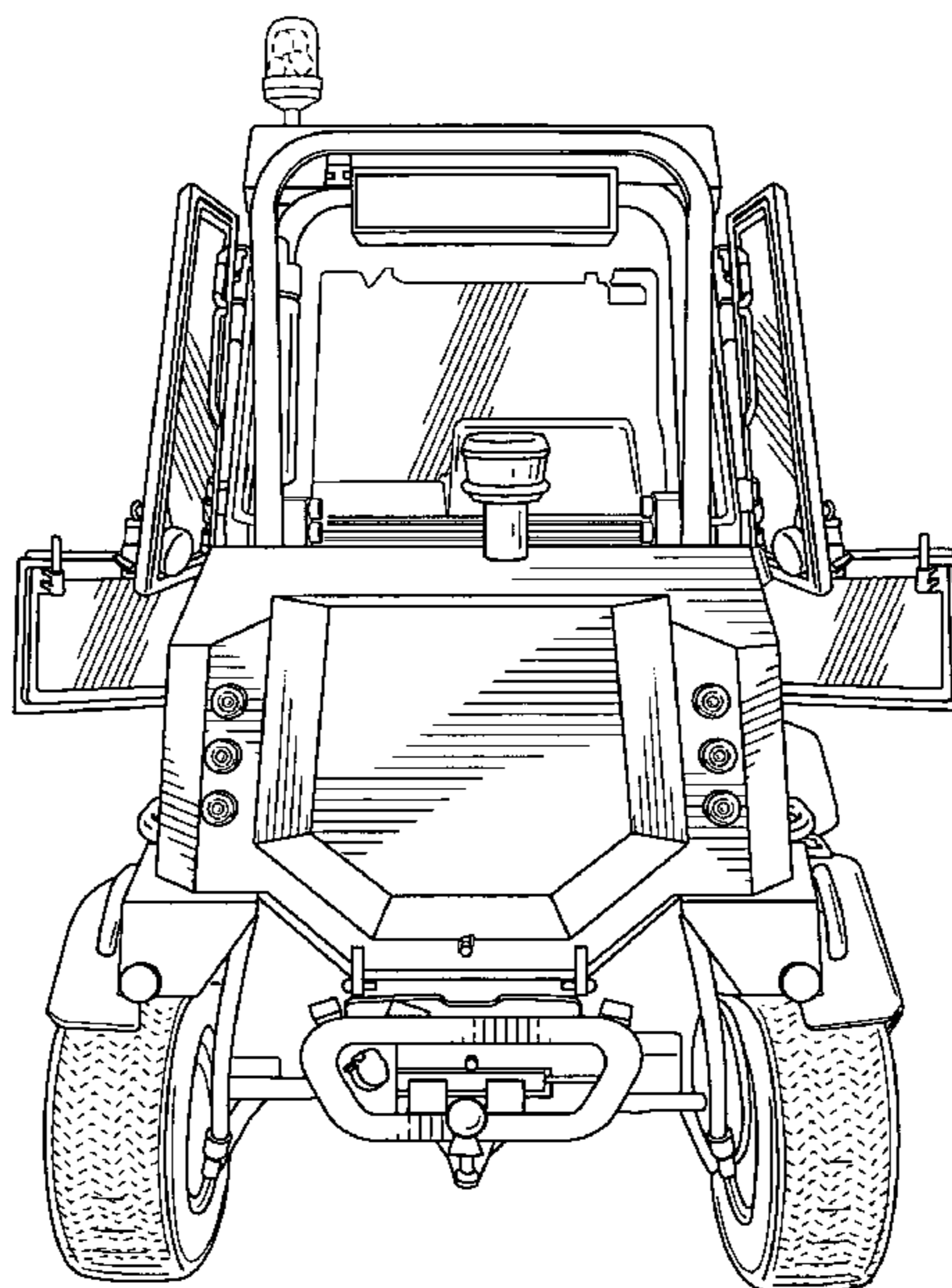
FIG. 6 is a front left perspective of the utility vehicle in accordance with the design.

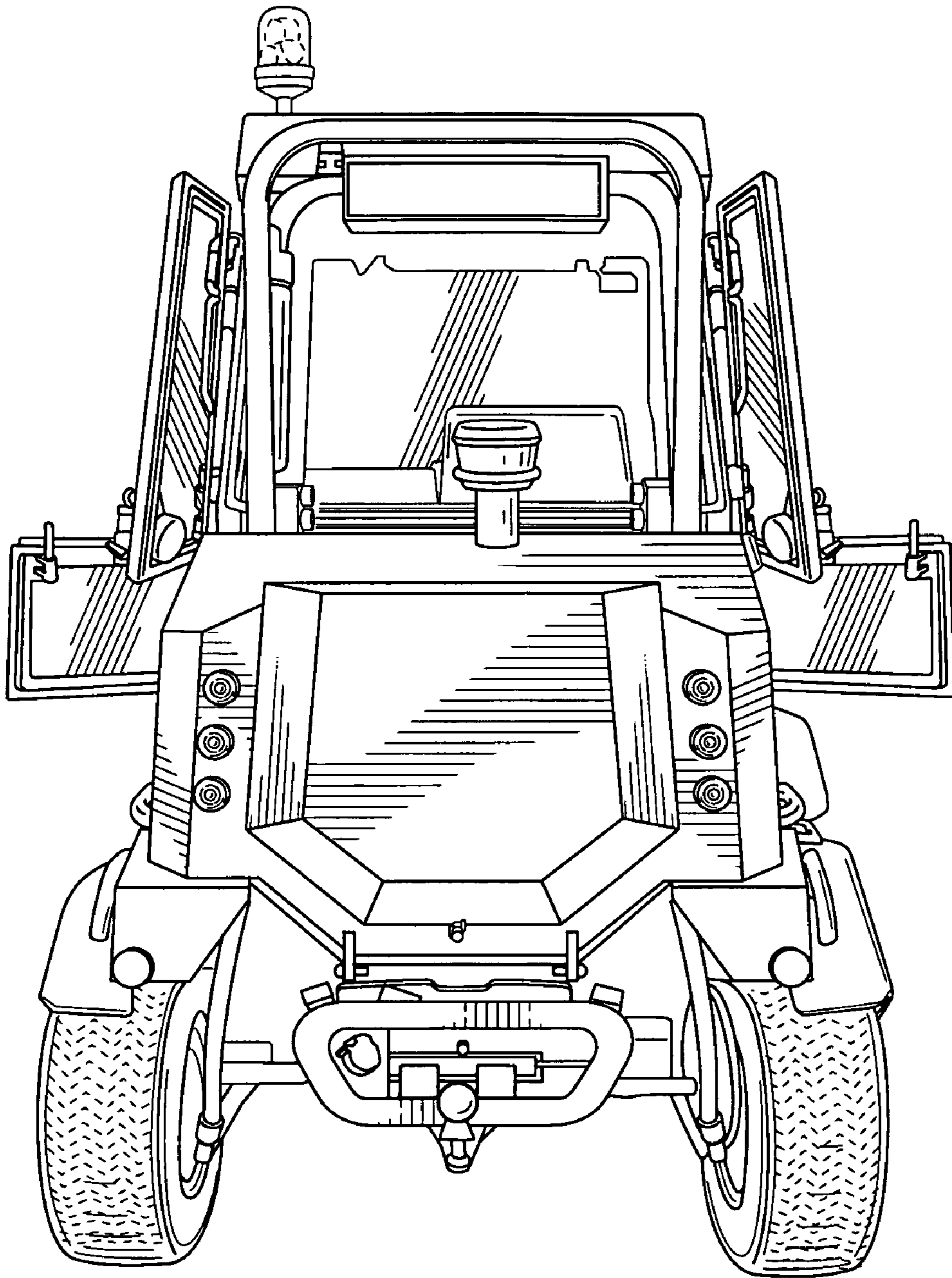
Applicants disclaim the top and bottom of the utility vehicle not shown in the drawing as forming no part of the claimed design.

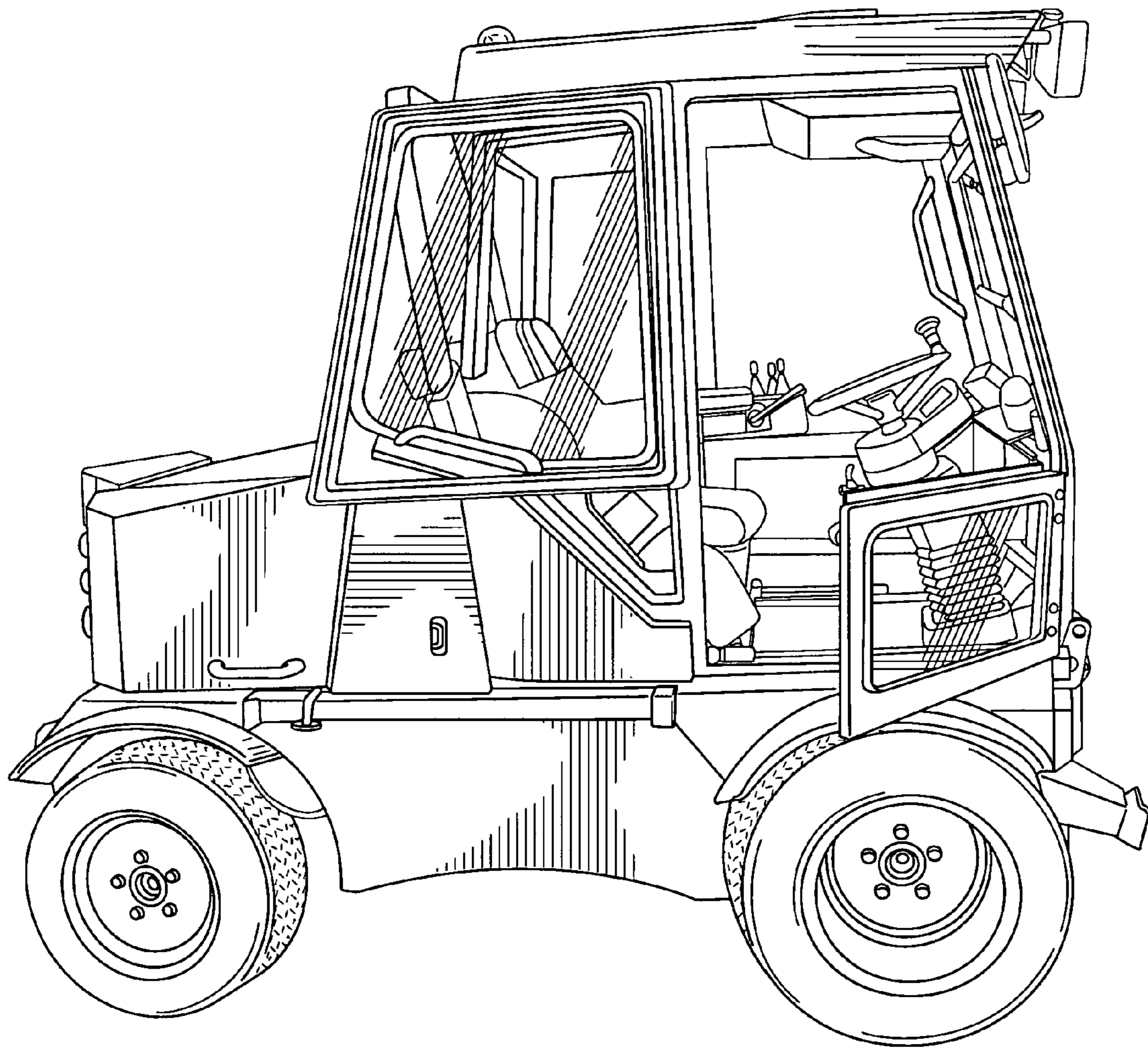

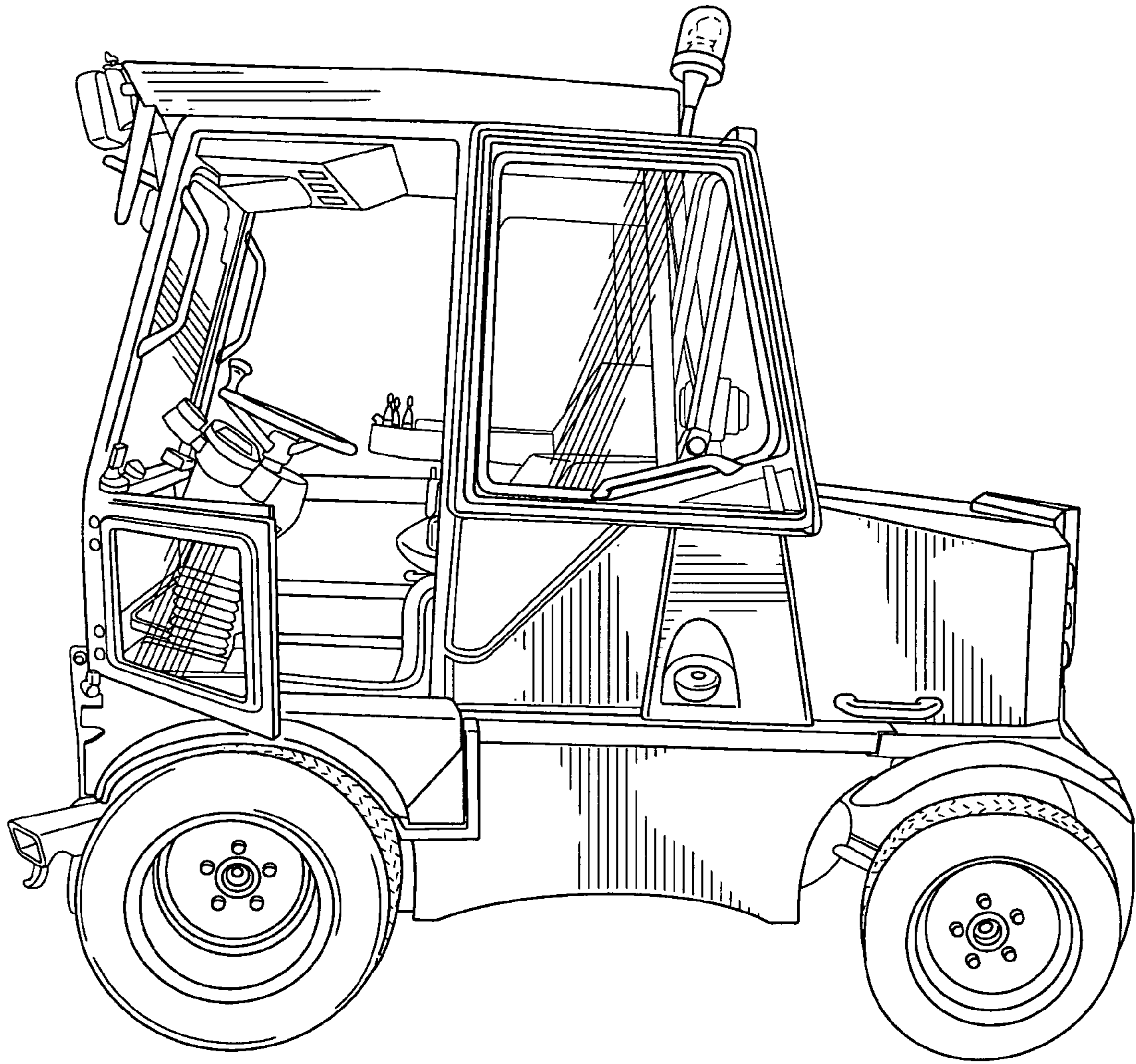
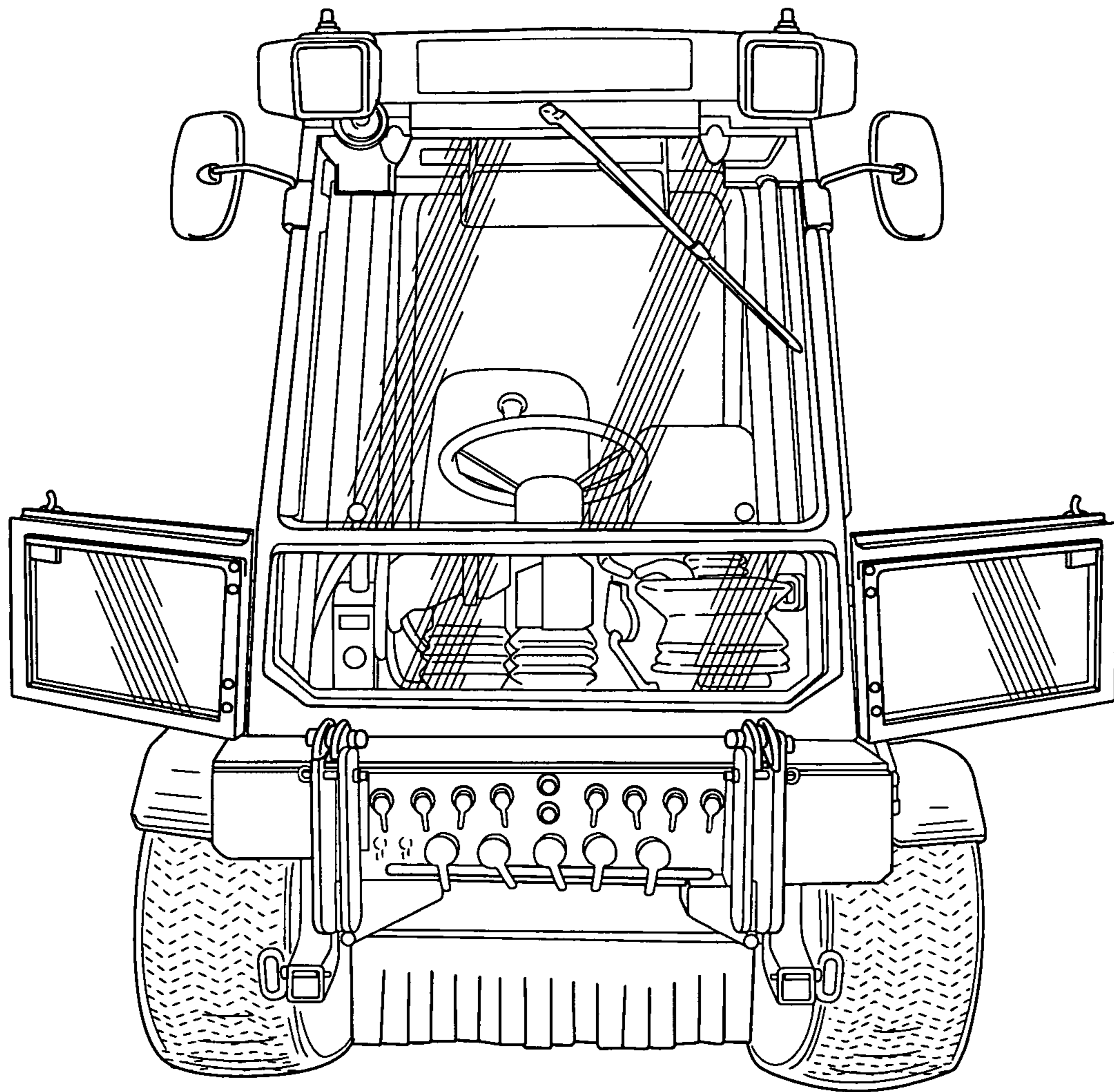
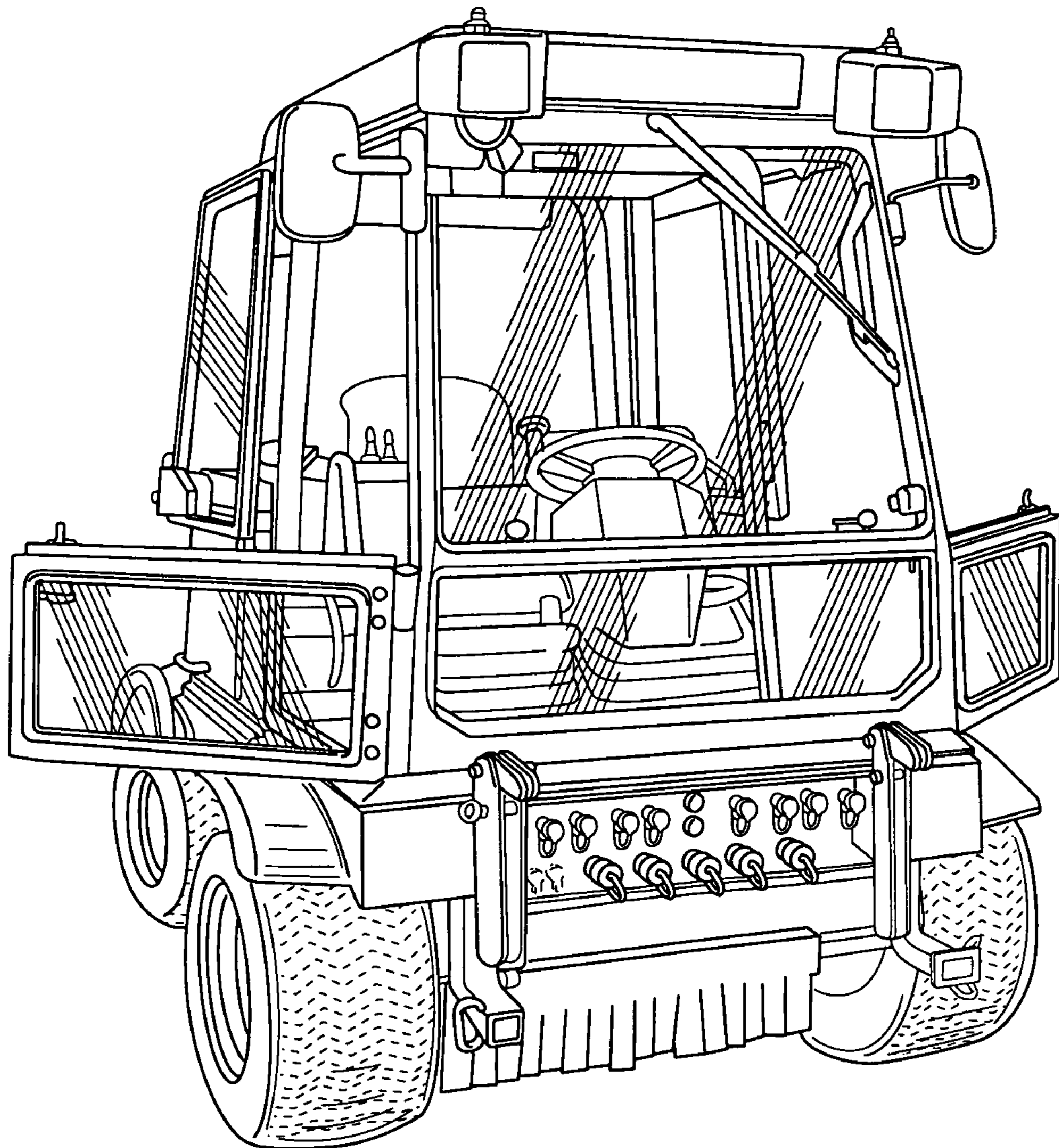

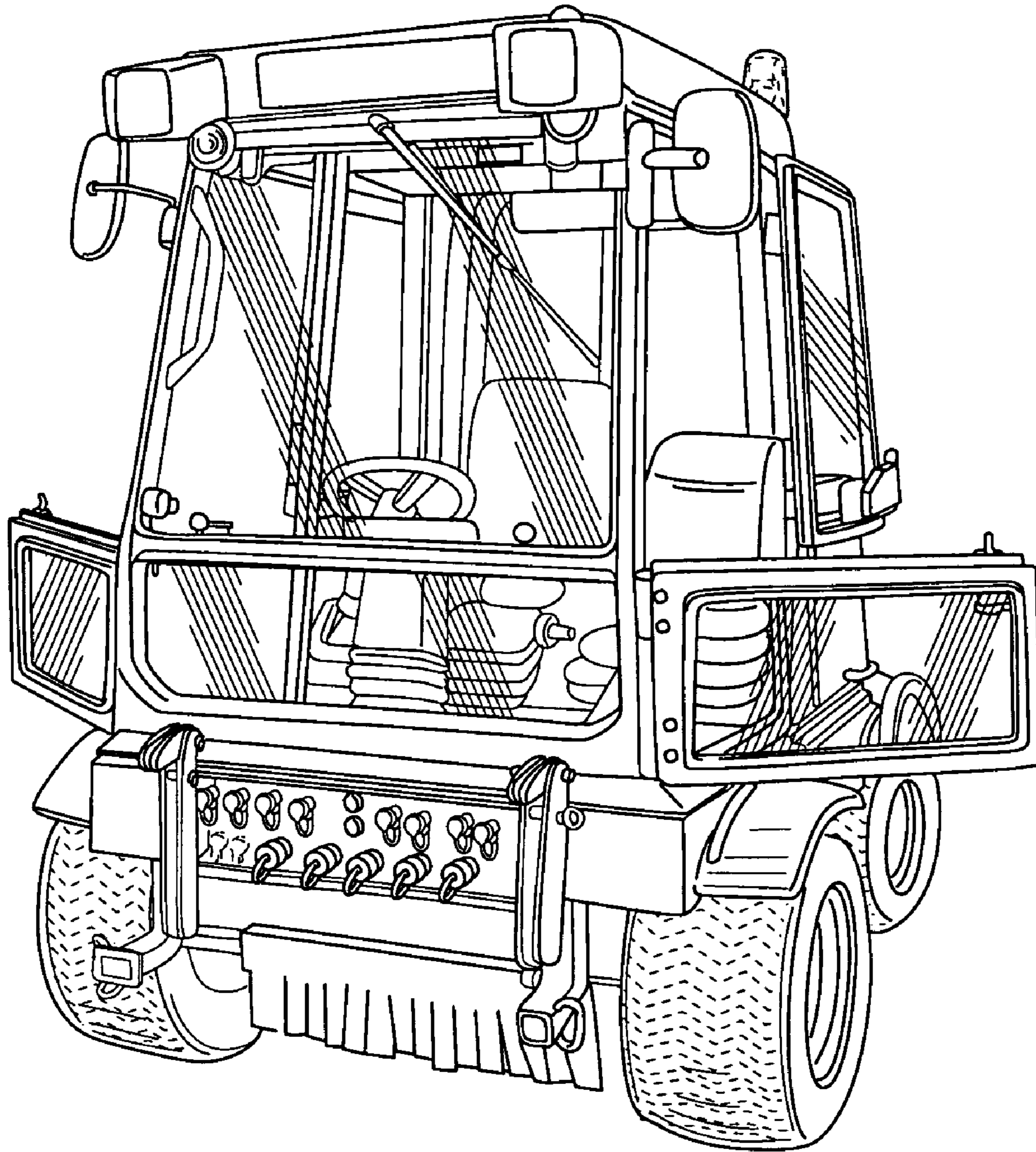
