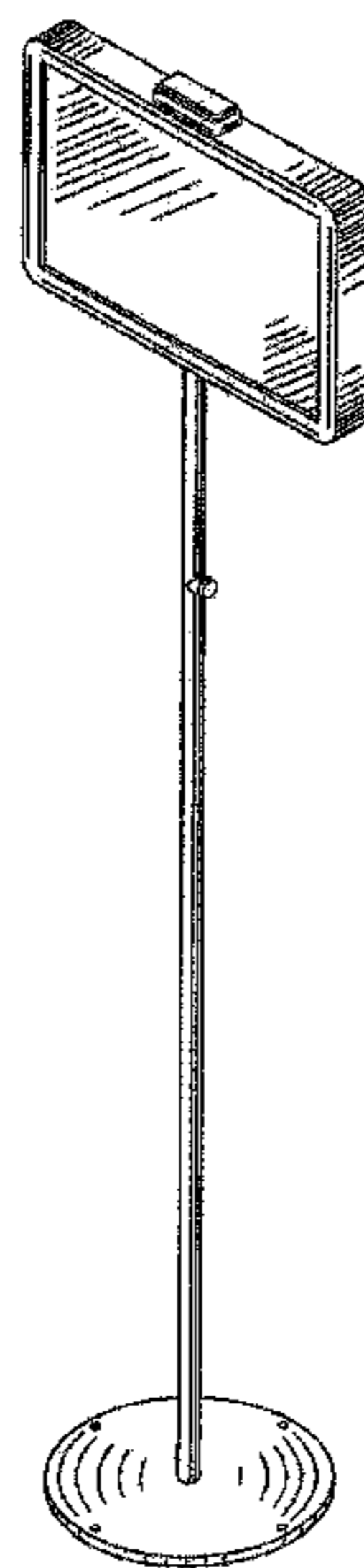
(57) **CLAIM**

I claim the ornamental design for a combined vendor advertising intercom and display, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a combined vendor advertising intercom and display showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is an enlarged bottom plan view thereof; and,
FIG. 7 is an enlarged top plan thereof.

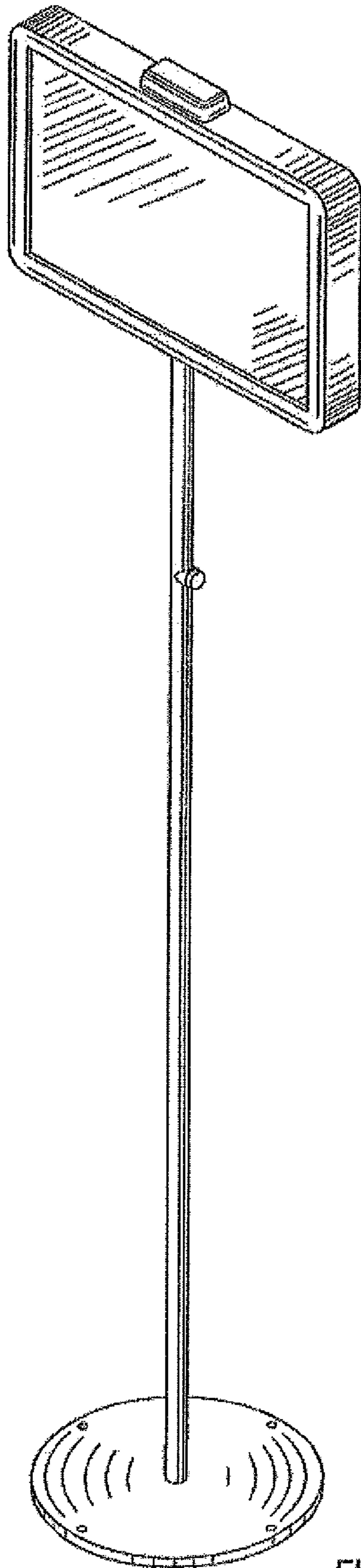

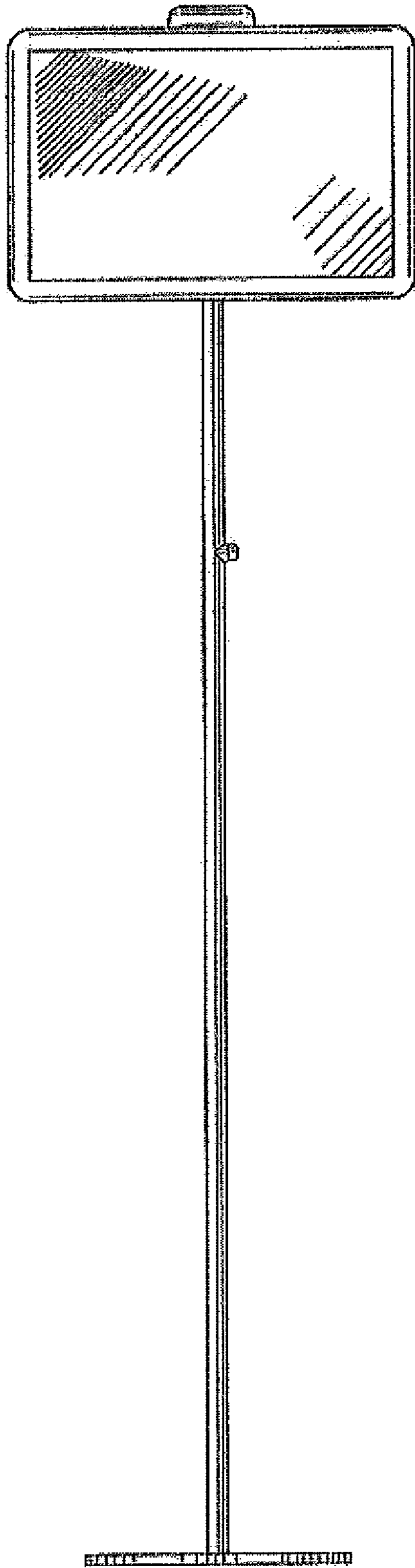

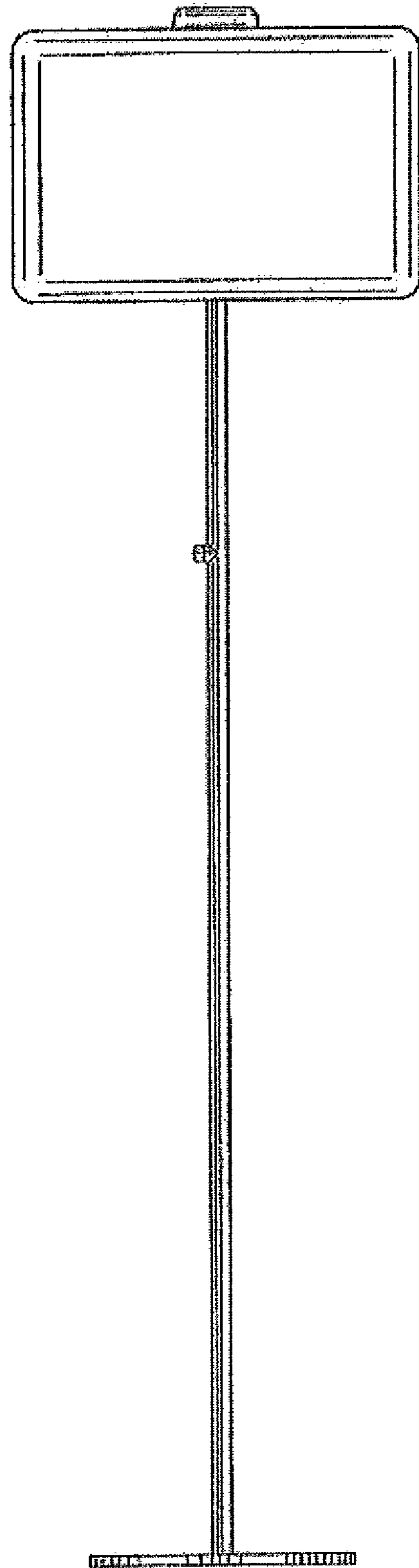

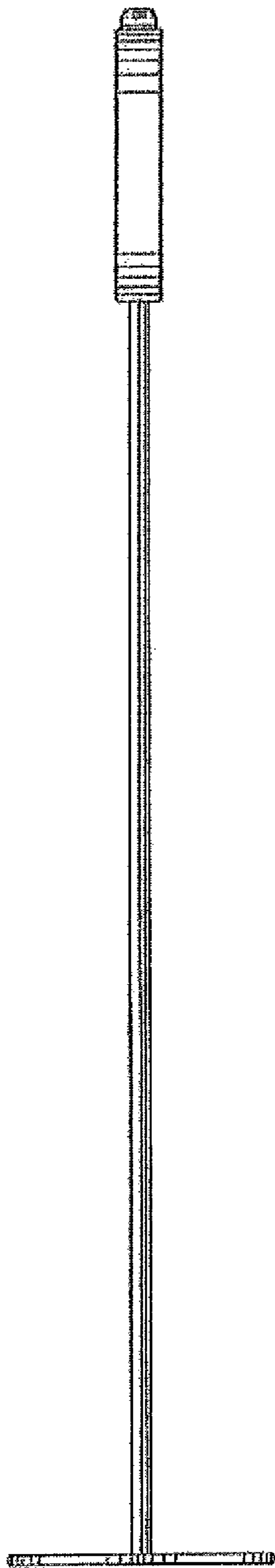

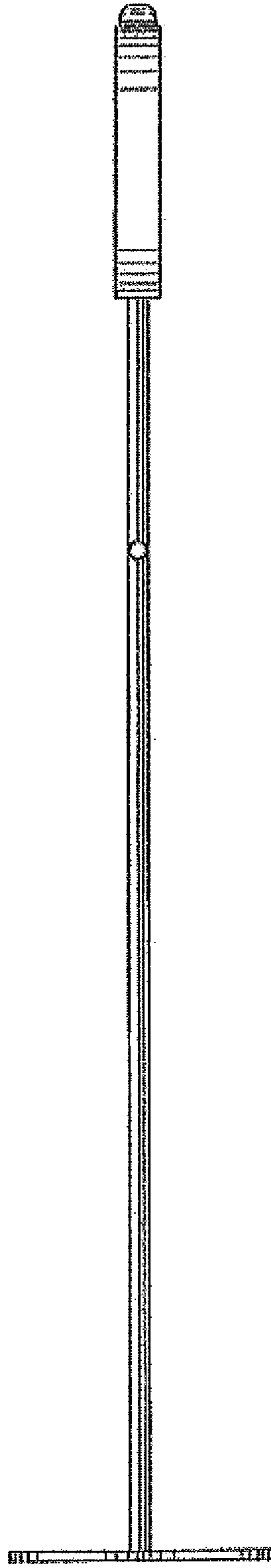

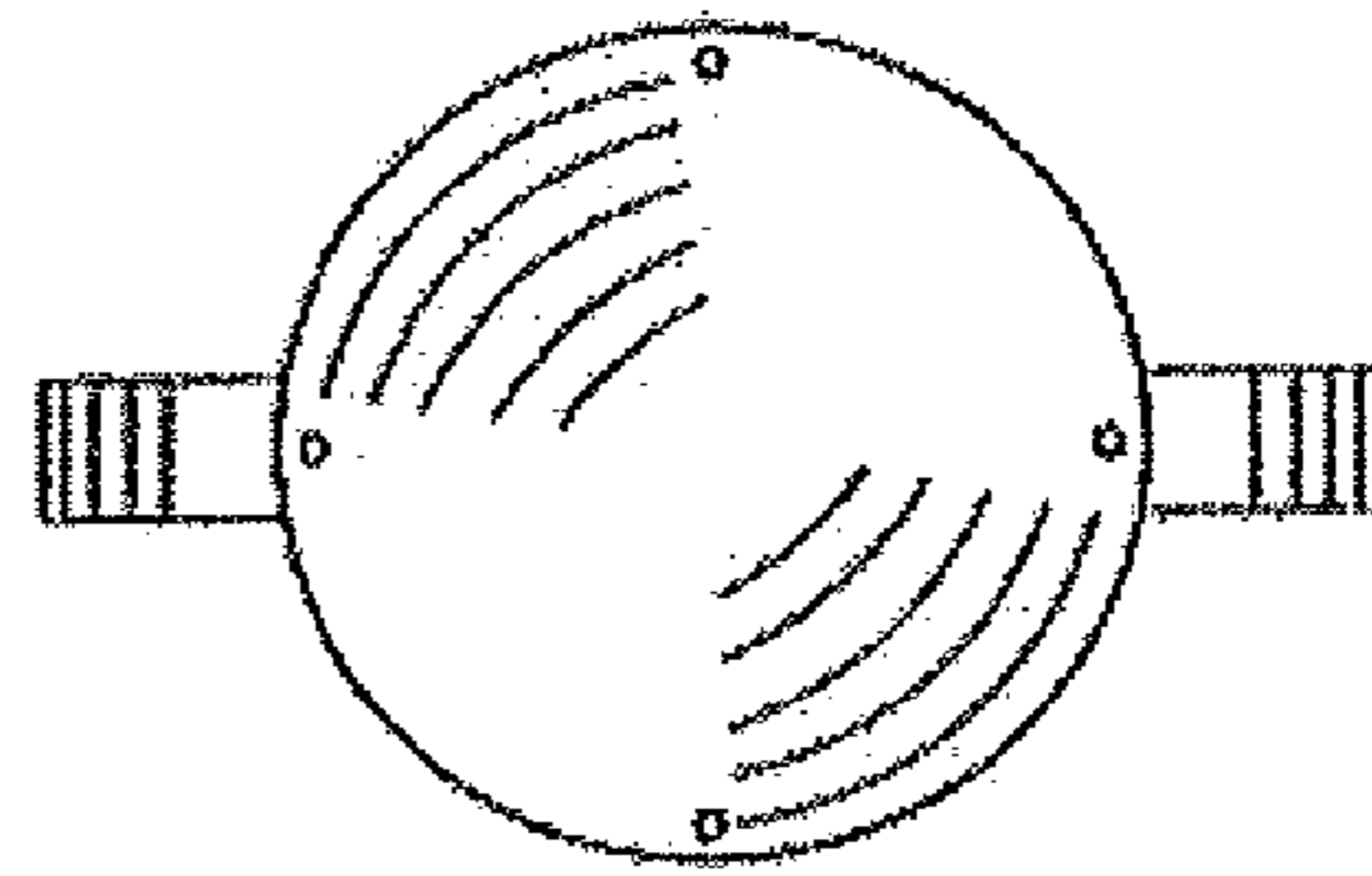

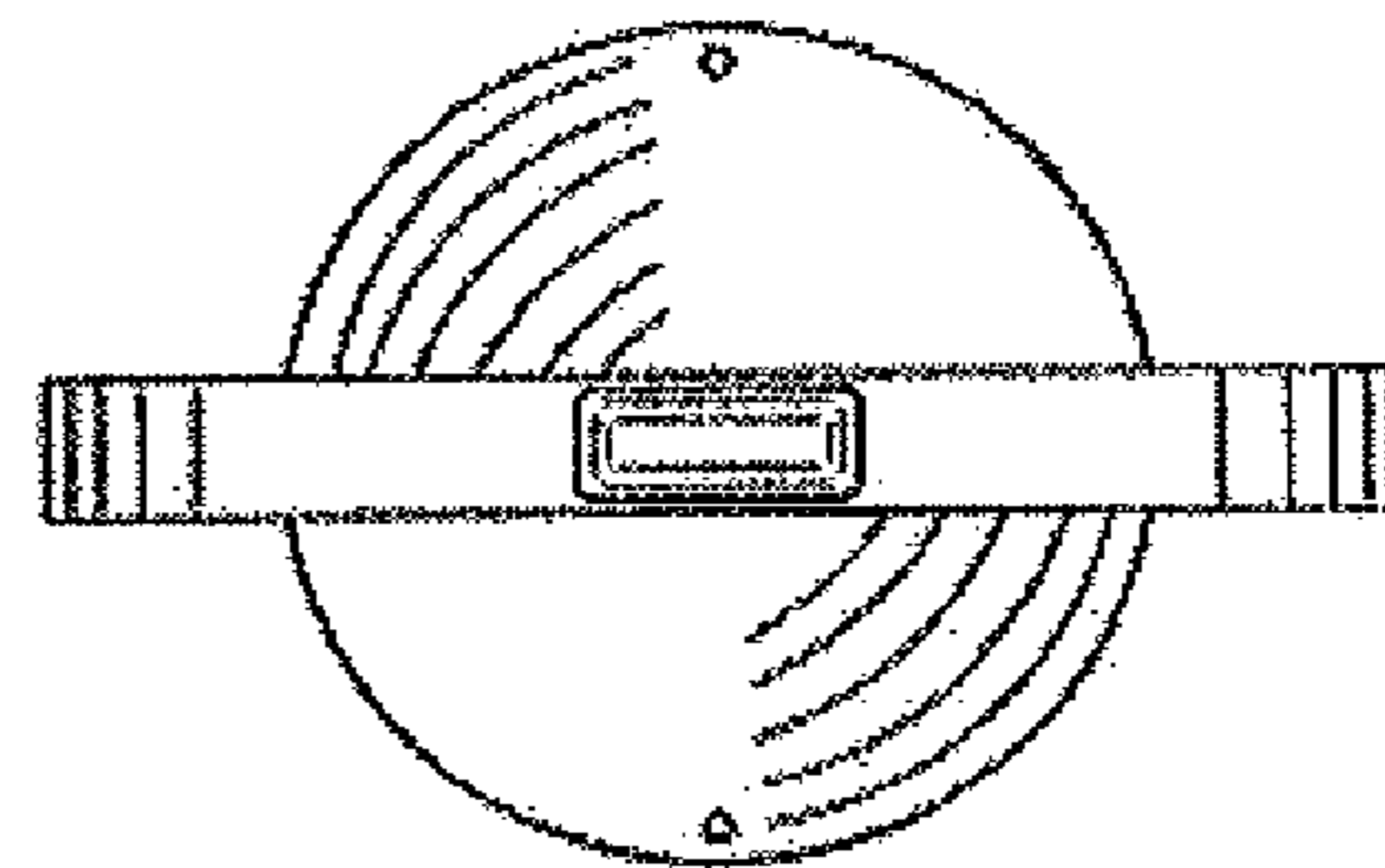
