DESCRIPTION

FIG. 6 is a bottom plan view thereof;

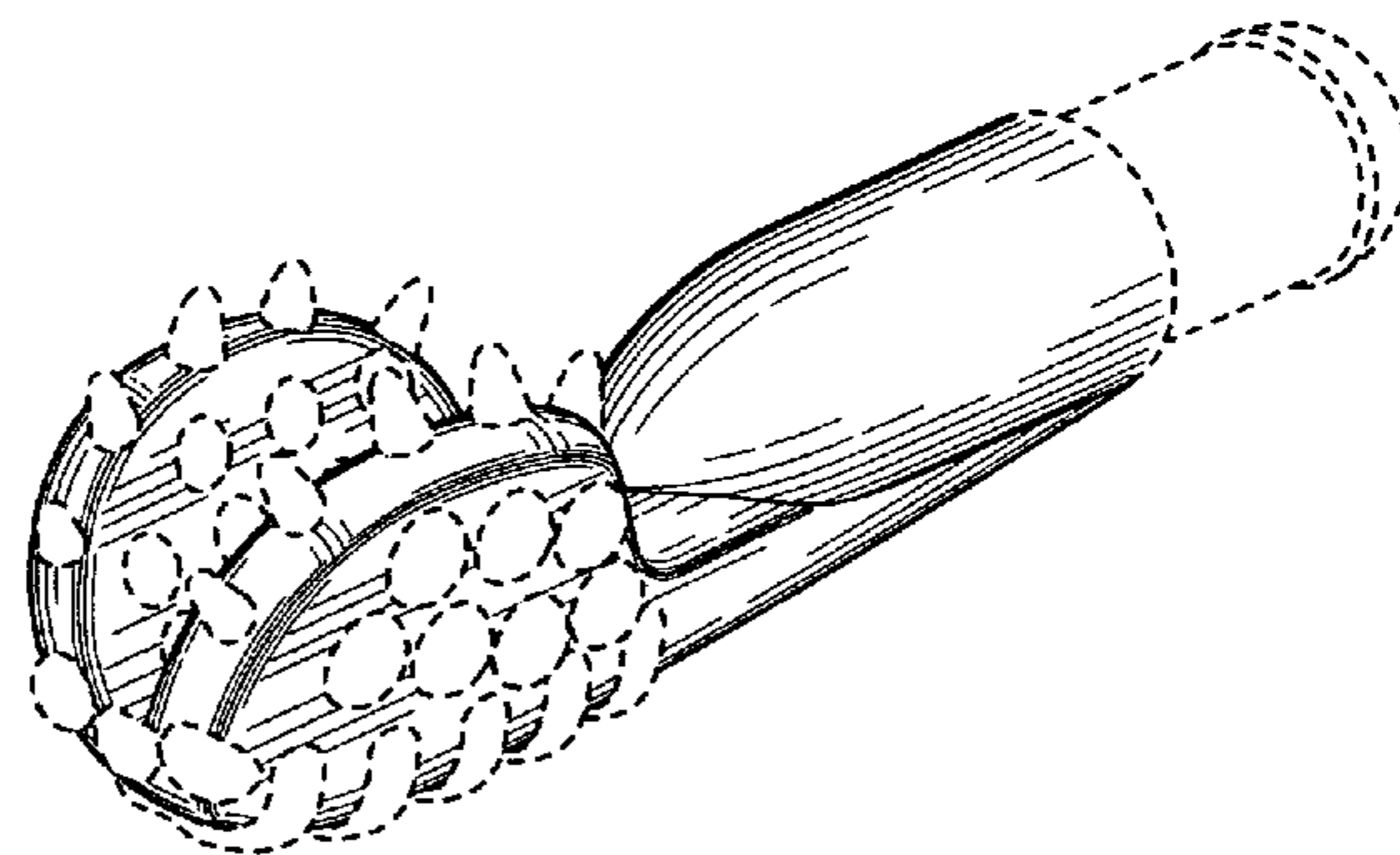
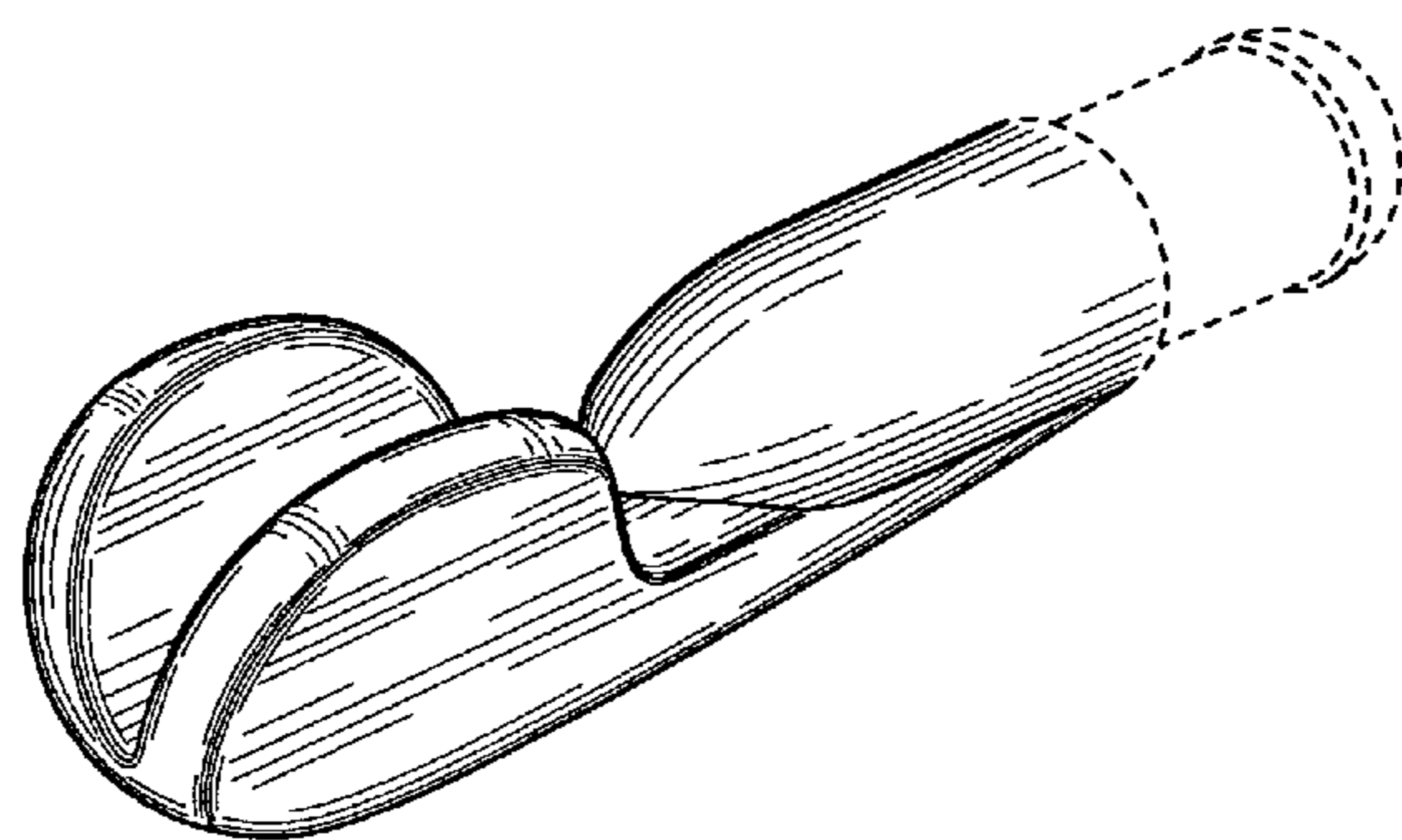
FIG. 7 is another top and side perspective view thereof with broken lines used to illustrate structural environment that forms no part of the claim;

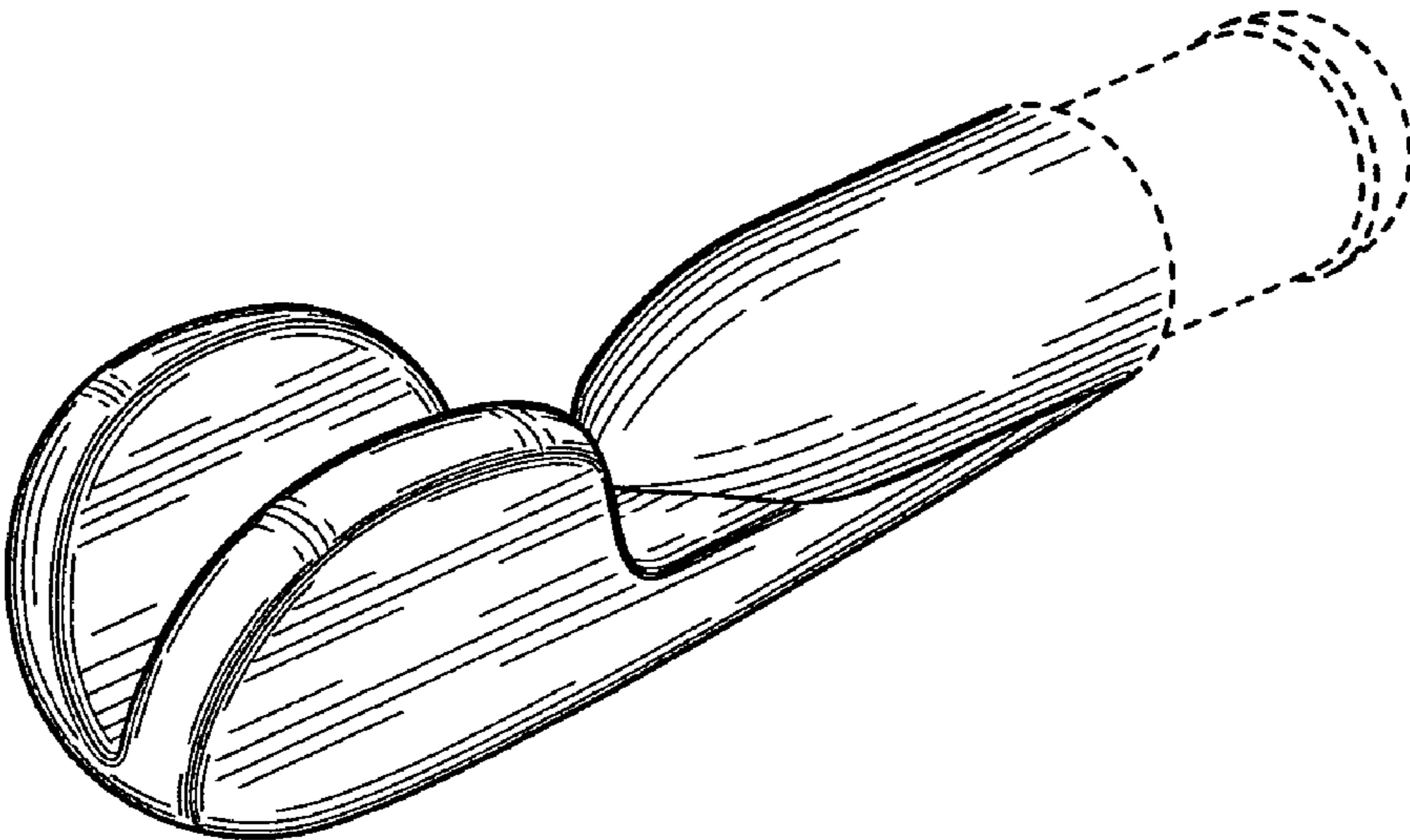

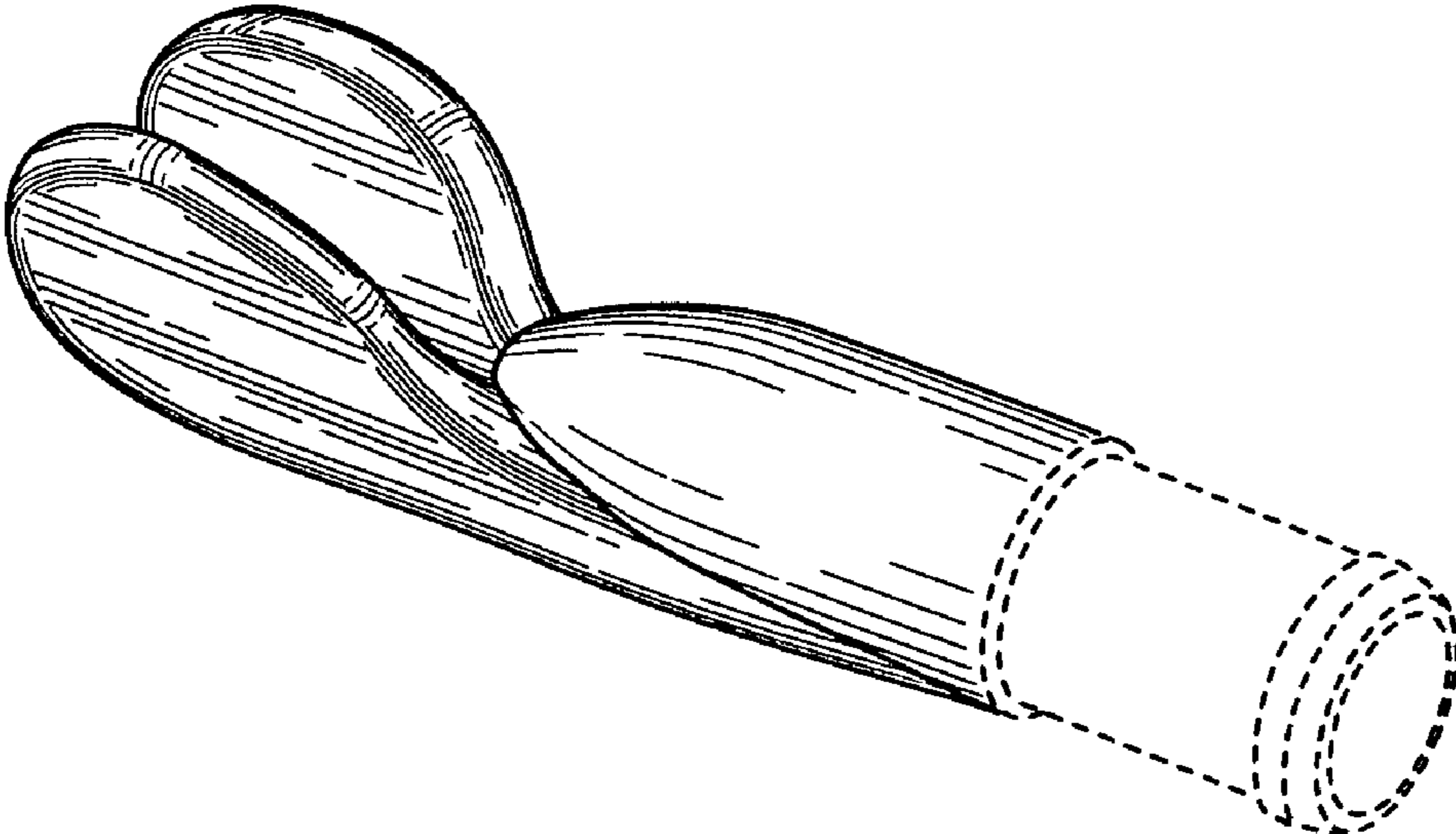

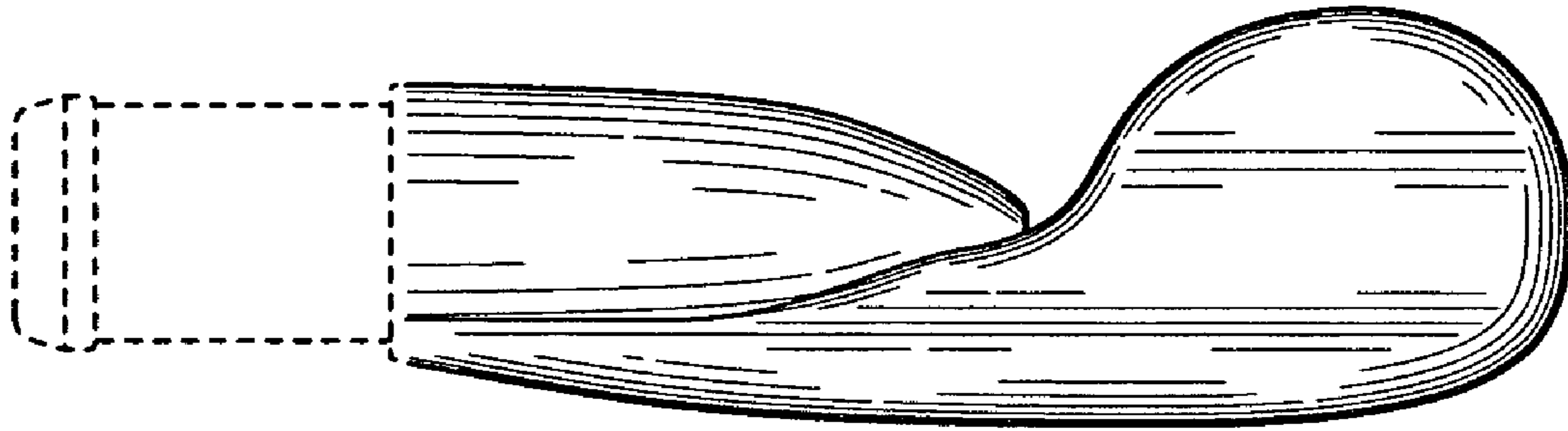

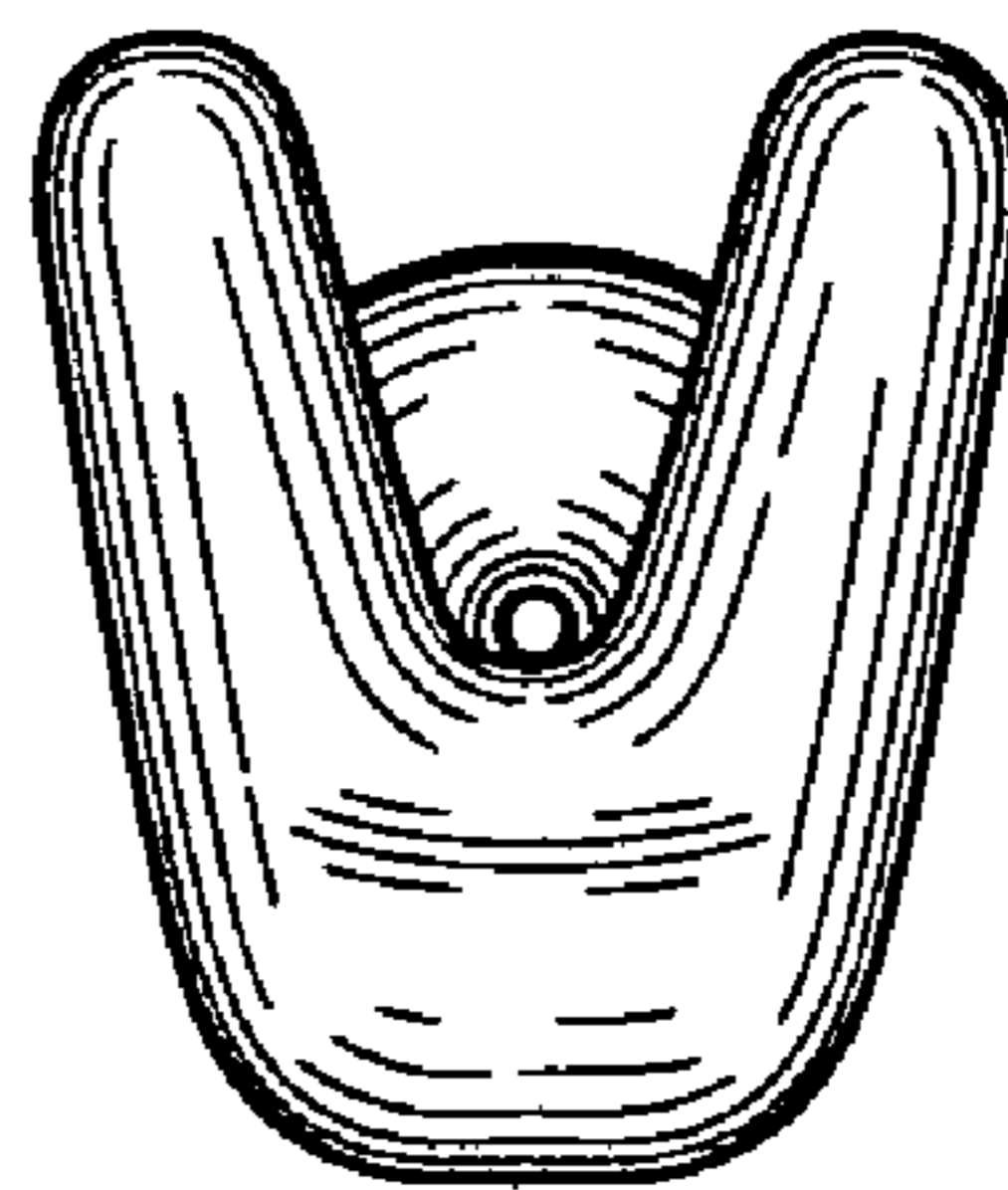

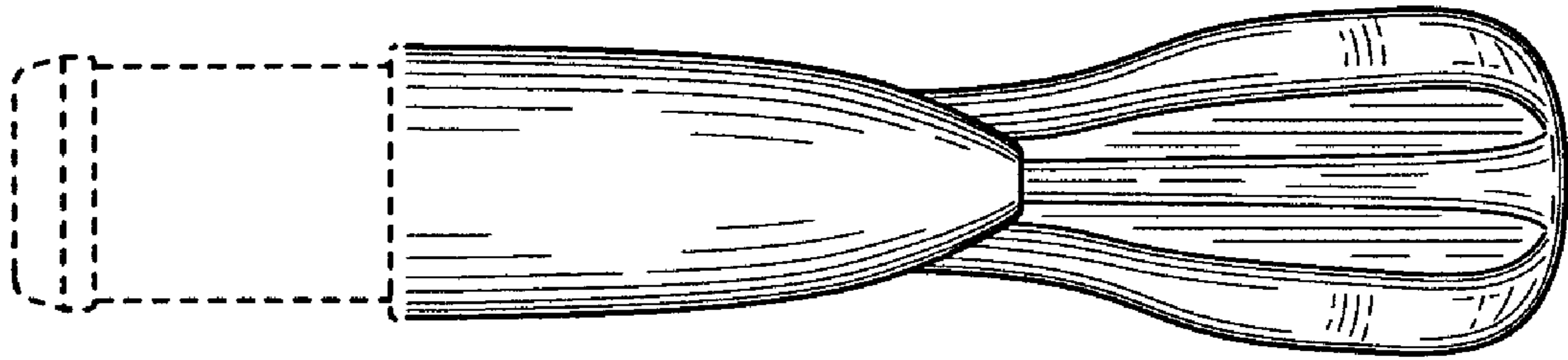

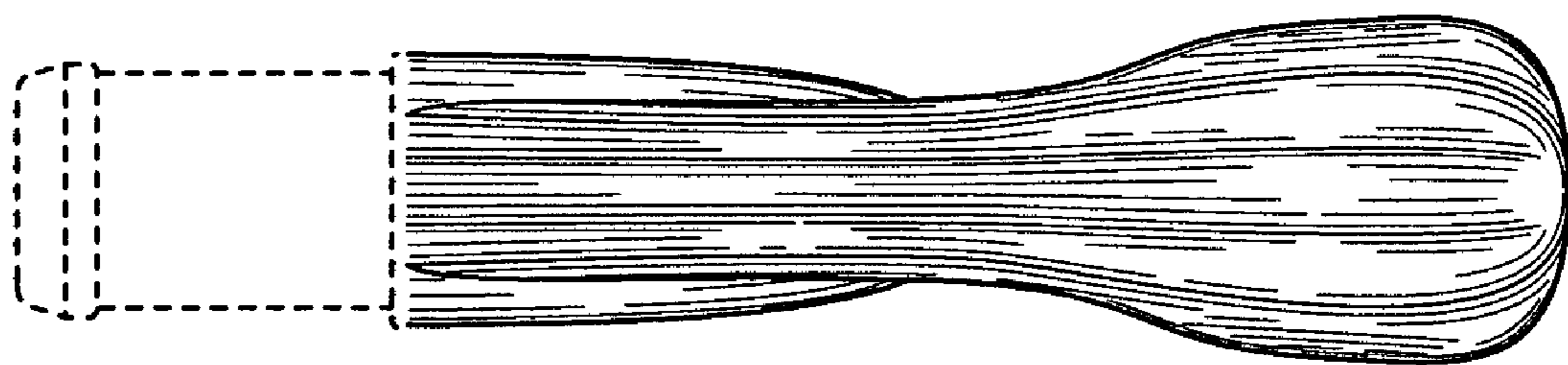

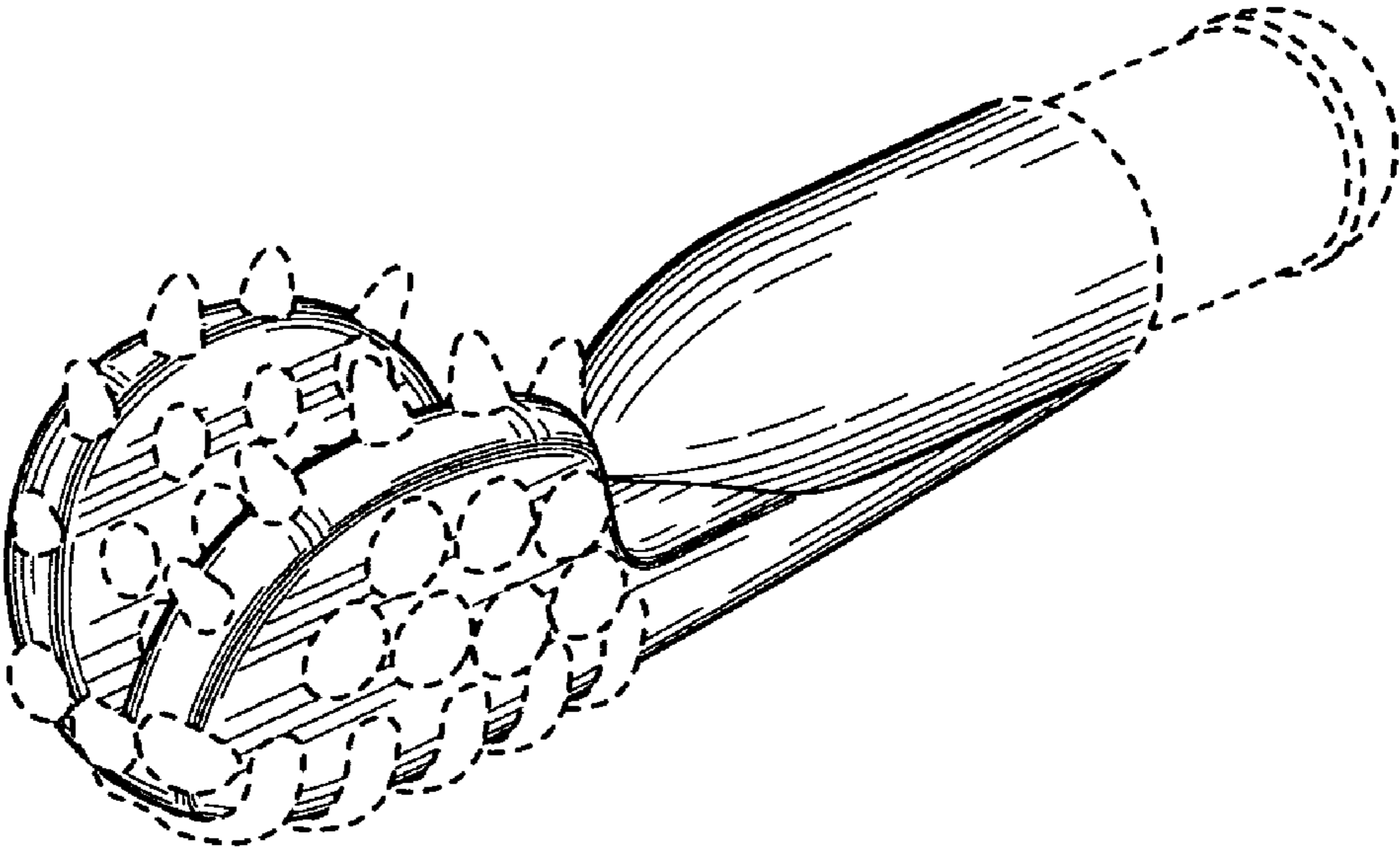

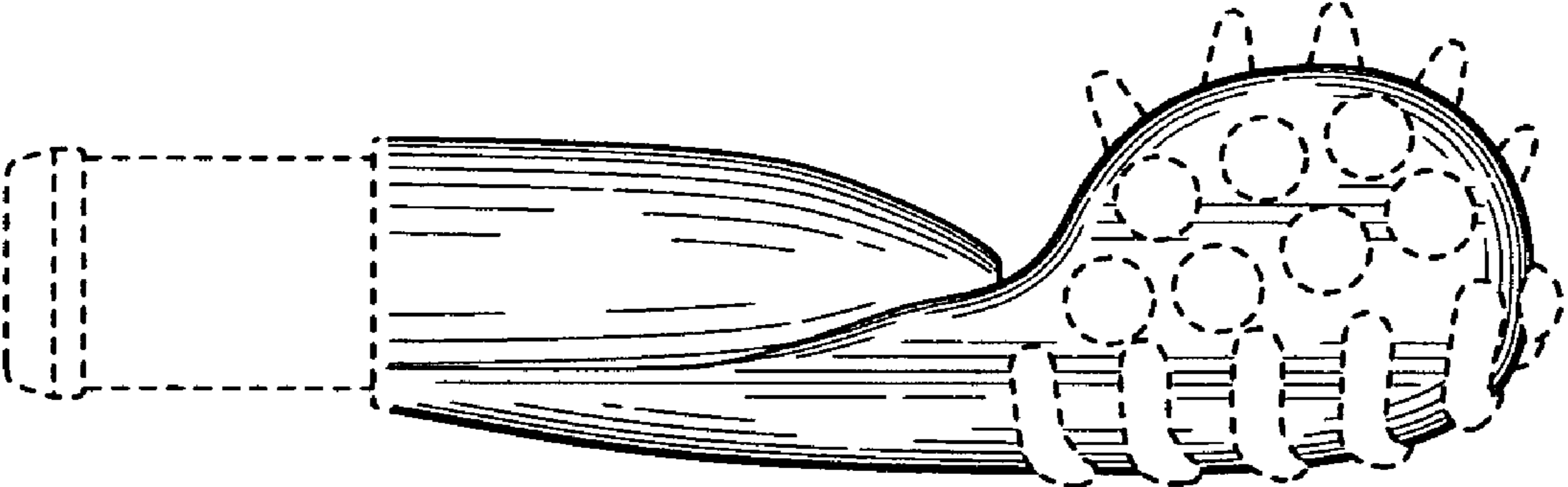

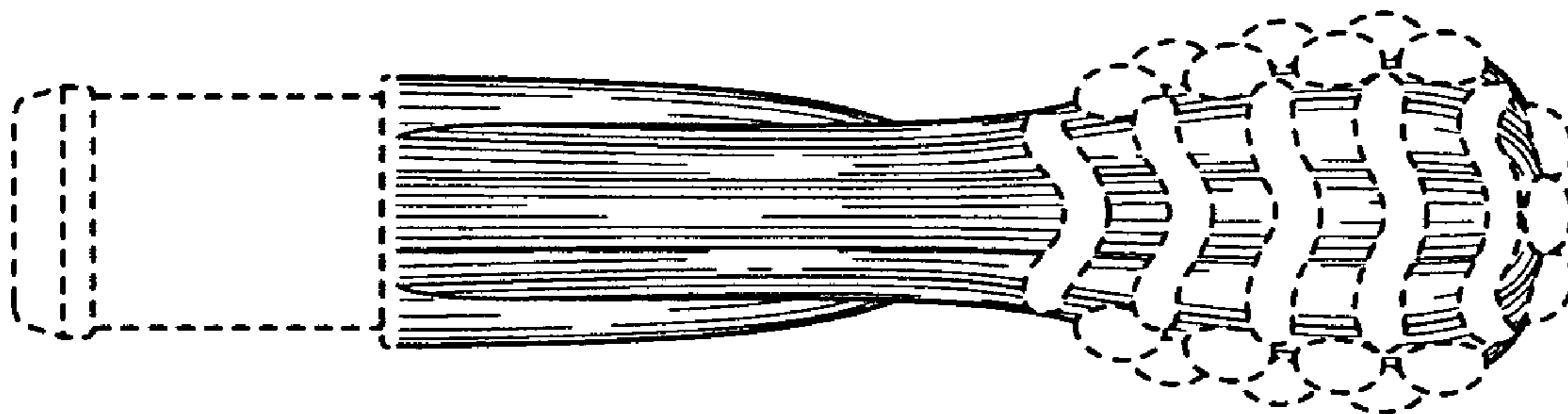
