(57) **CLAIM**

The ornamental design for a pedicure sink, as shown and  
described.

**DESCRIPTION**

FIG. 1 is a perspective view of a pedicure sink including our  
new design as implemented in conjunction with a pedicure  
tub, whereby the dashed lines of the pedicure tub form no part  
of the claimed design;

FIG. 2 is a perspective view of the pedicure sink showing our  
new design, whereby the dashed plumbing lines form no part  
of the claimed design;

FIG. 3 is a front elevational view of the pedicure sink;  
whereby the dashed plumbing lines form no part of the  
claimed design;

FIG. 4 is a rear elevational view of the pedicure sink, whereby  
the dashed plumbing lines form no part of the claimed design;

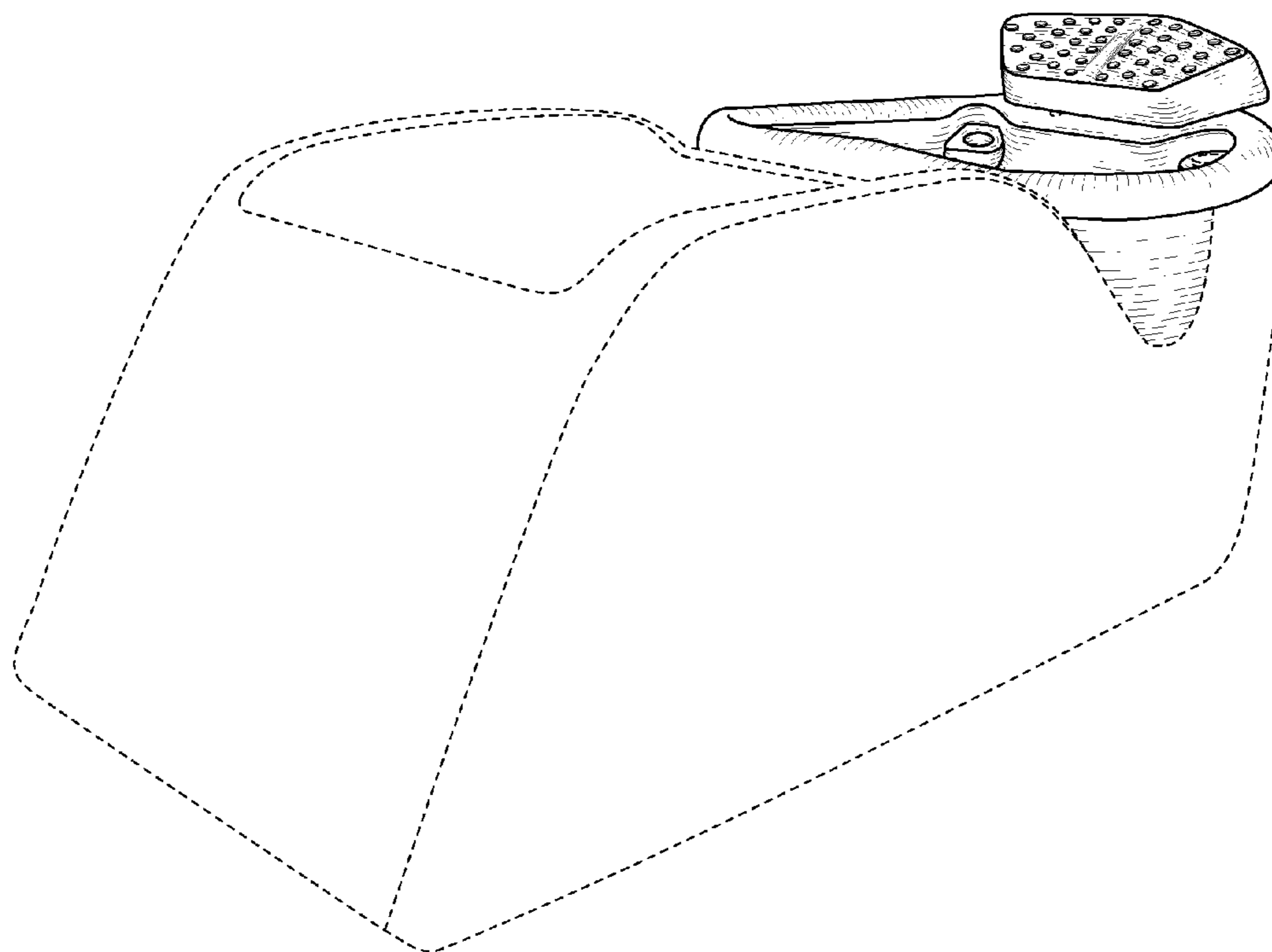
FIG. 5 is a right side elevational view of the pedicure sink;

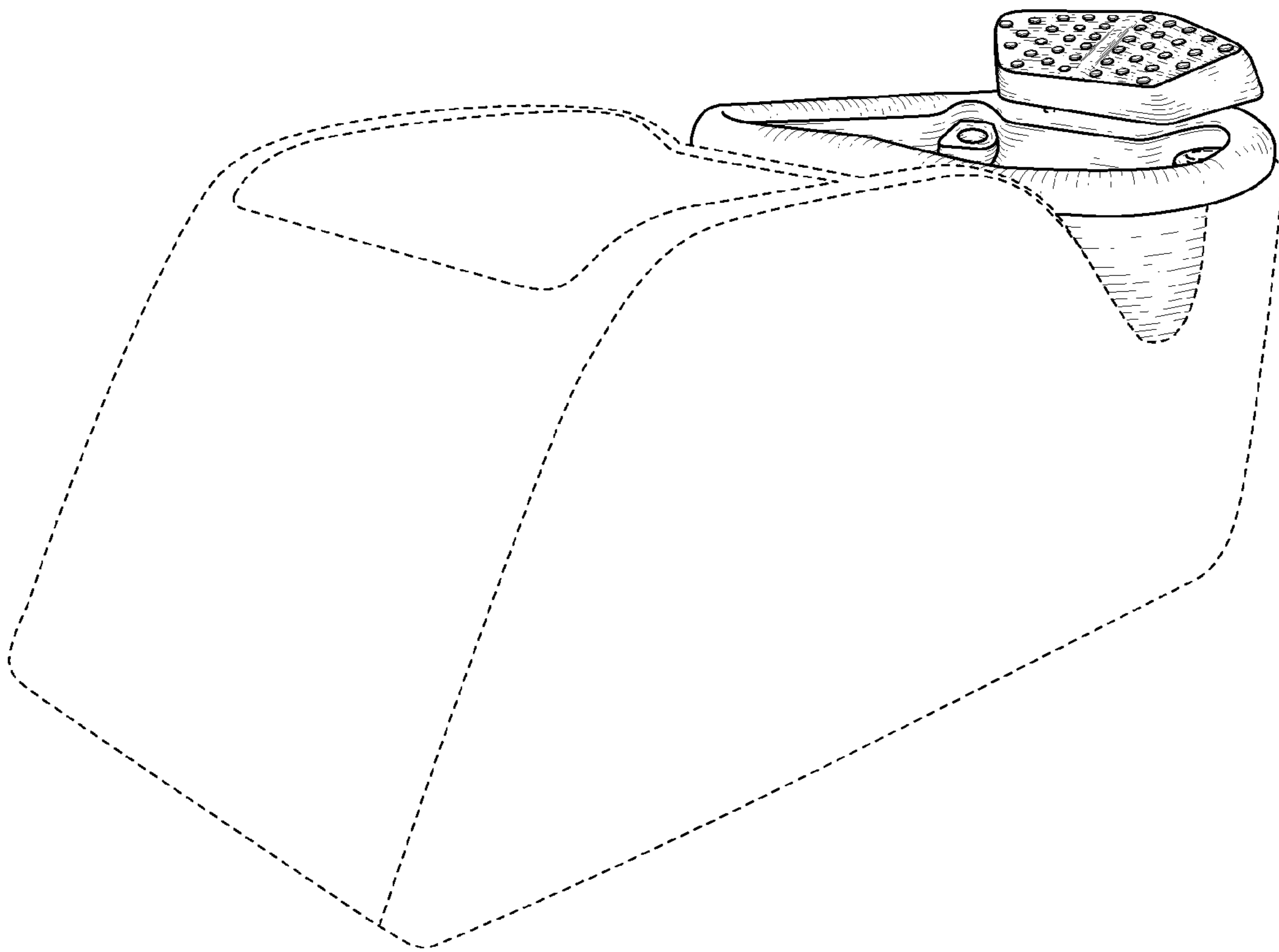
FIG. 6 is a left side elevational view of the pedicure sink;

lines form no part of the claimed design; and,

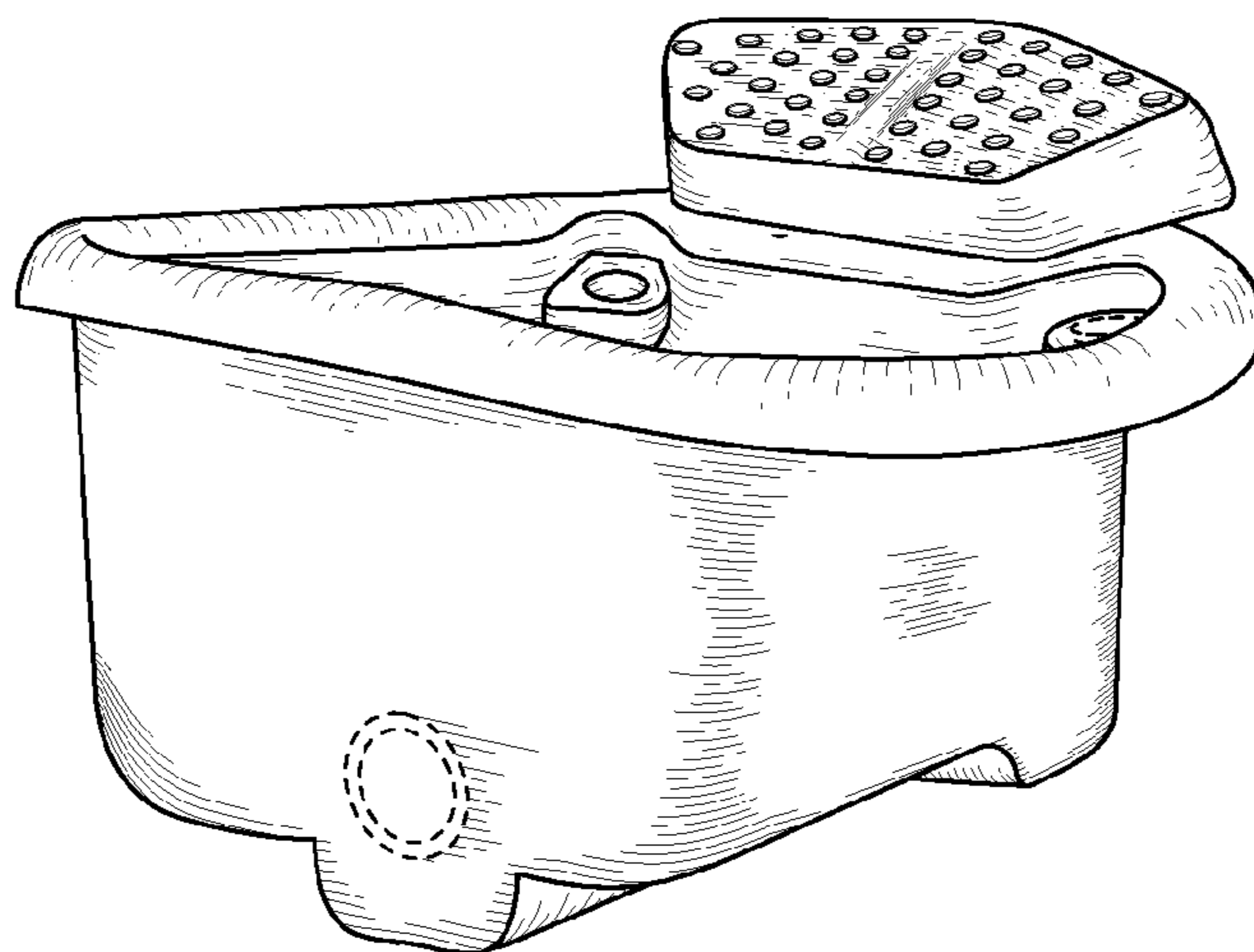
FIG. 8 is a bottom view of the pedicure sink, whereby the

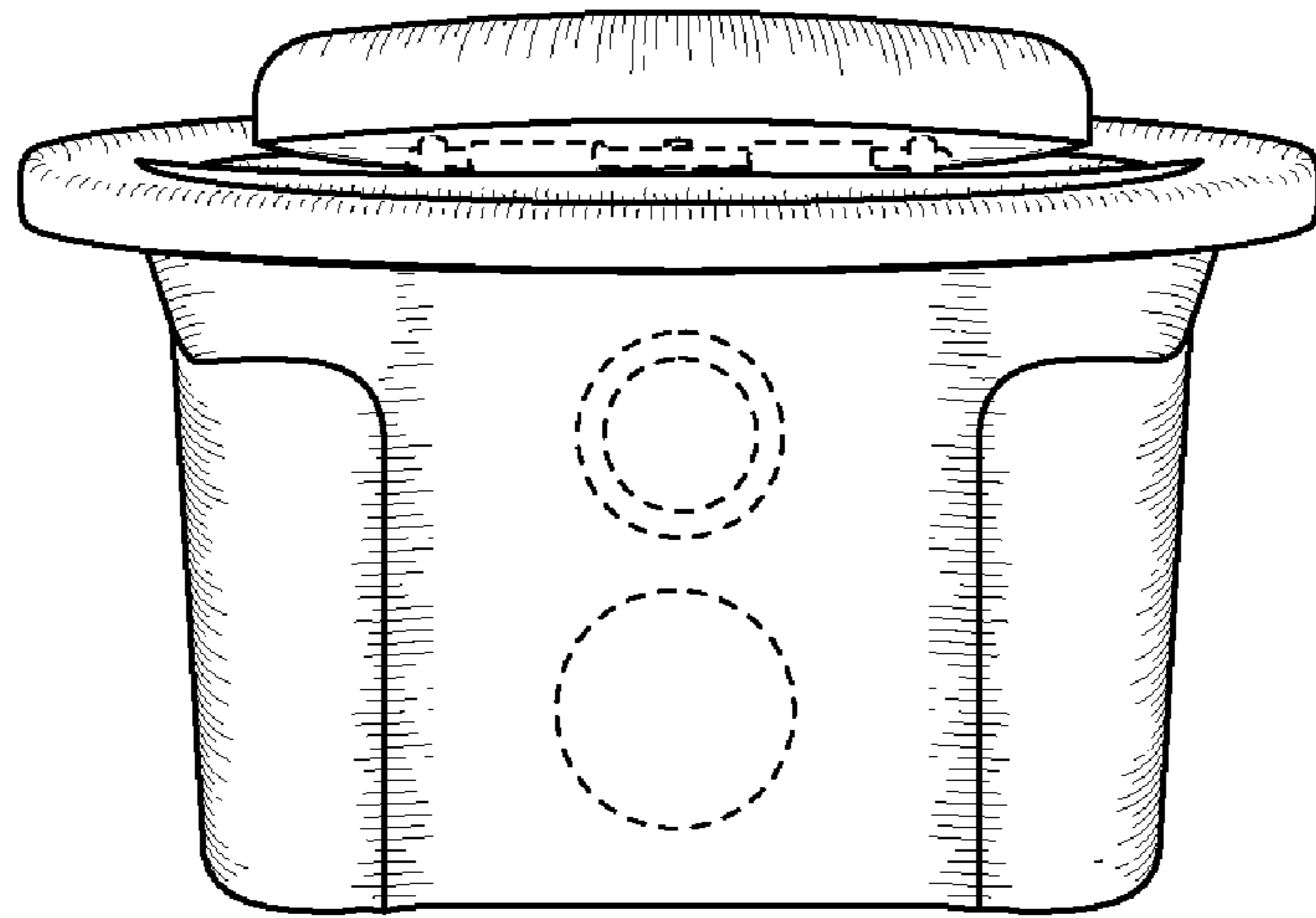




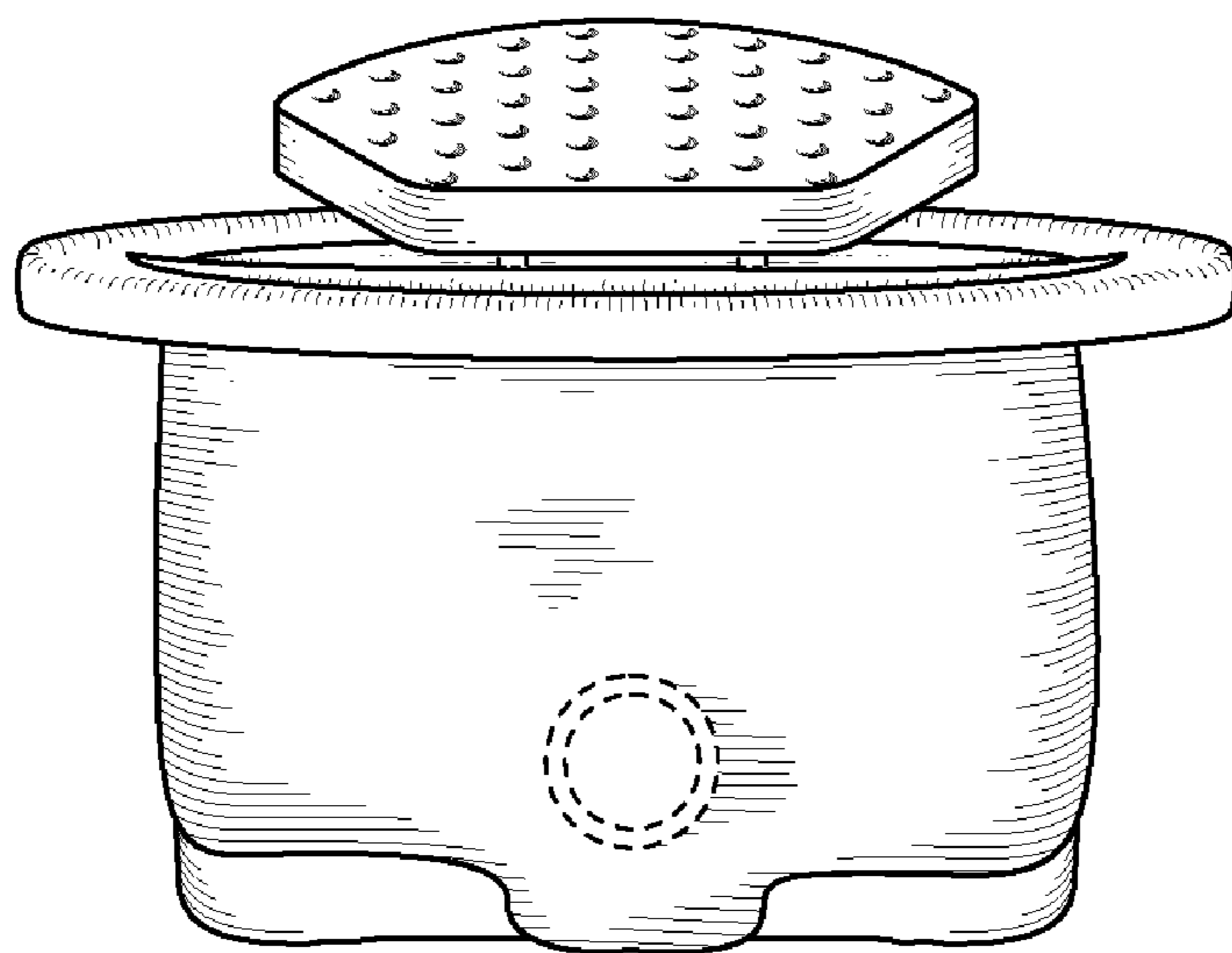

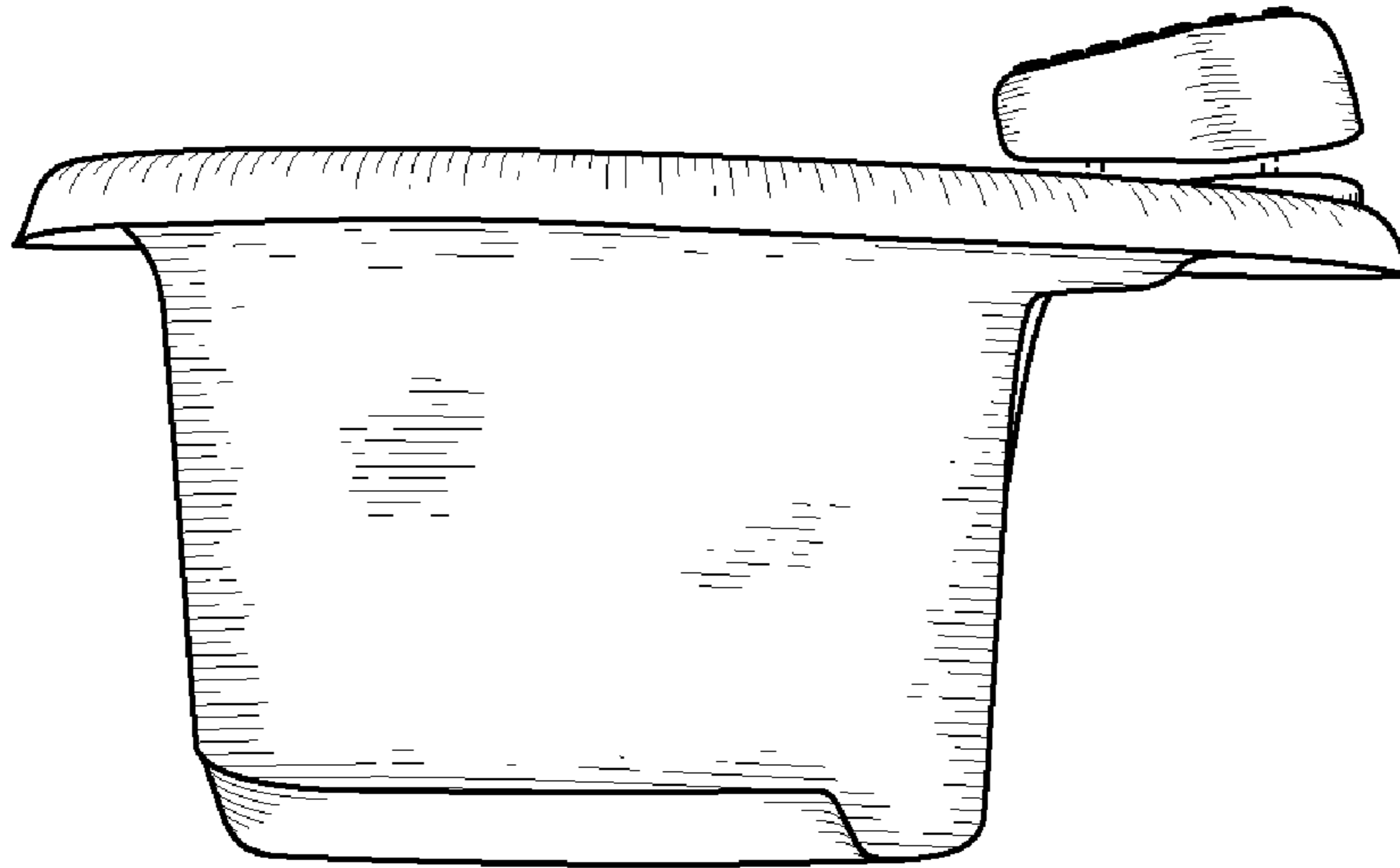

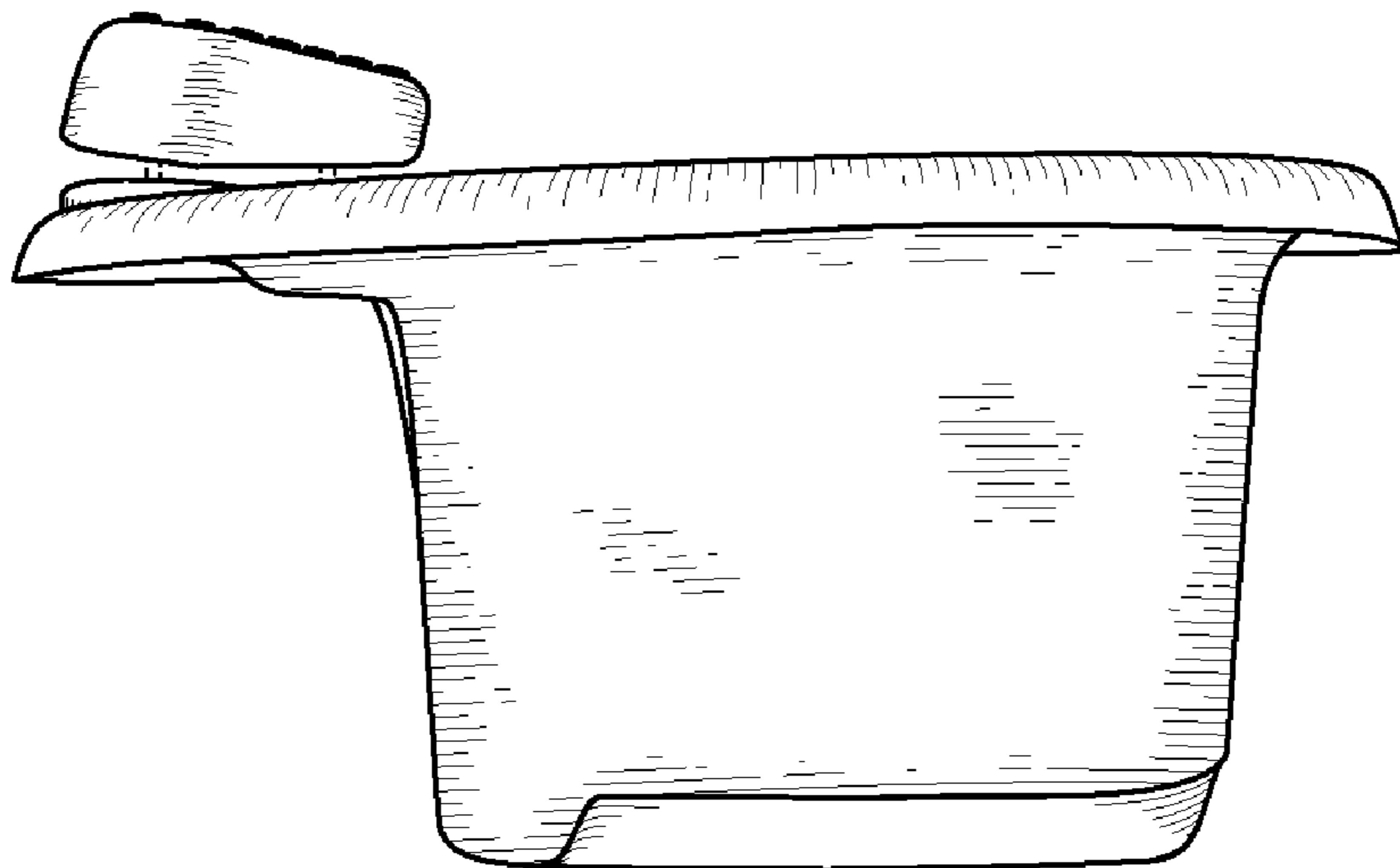

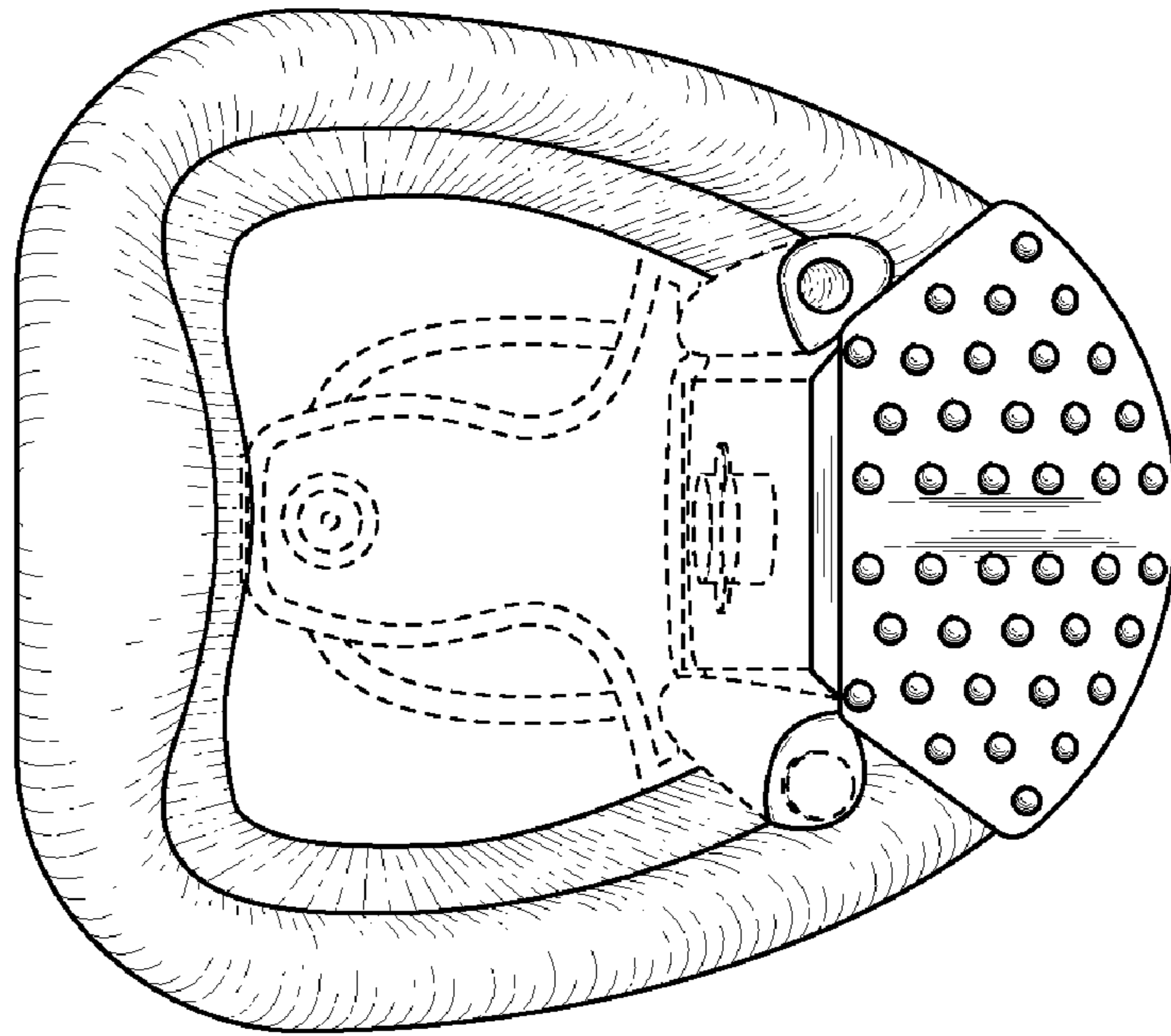

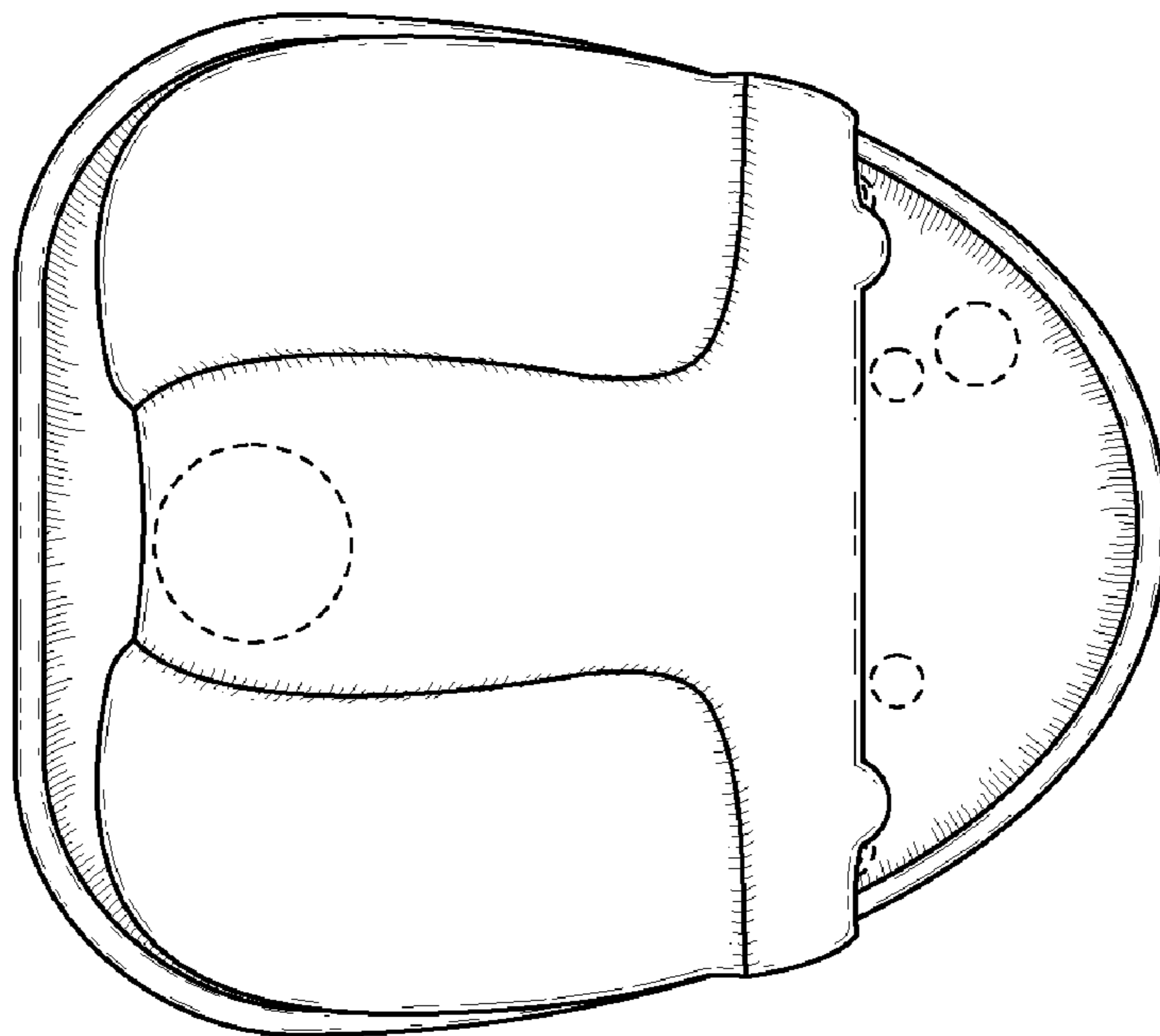
