FIG. 5 is a right side elevational view thereof;

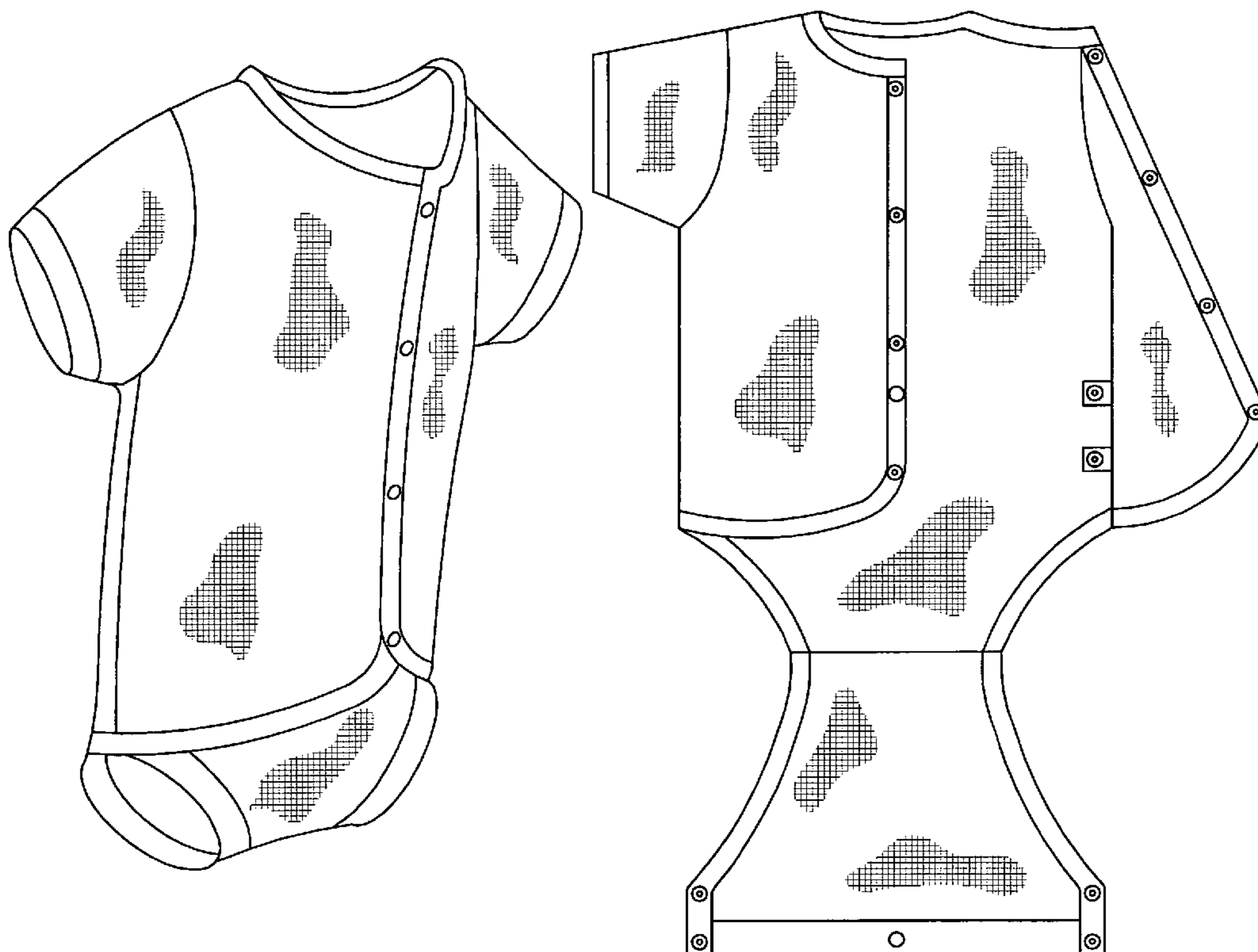
FIG. 6 is a top plan view thereof;

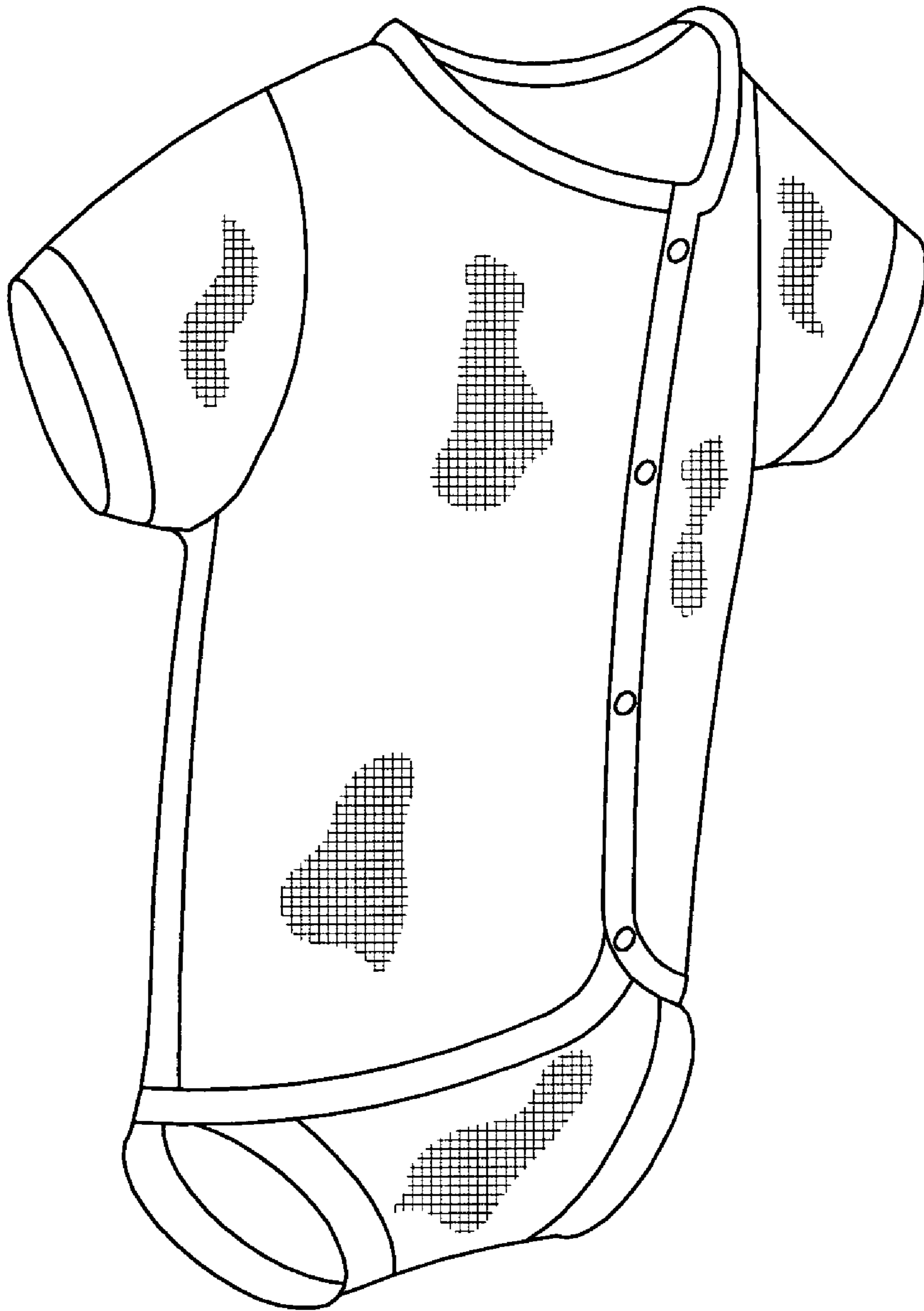
FIG. 7 is a bottom plan view thereof;

FIG. 8 is a front view thereof, with the upper body portion, partially open; and,

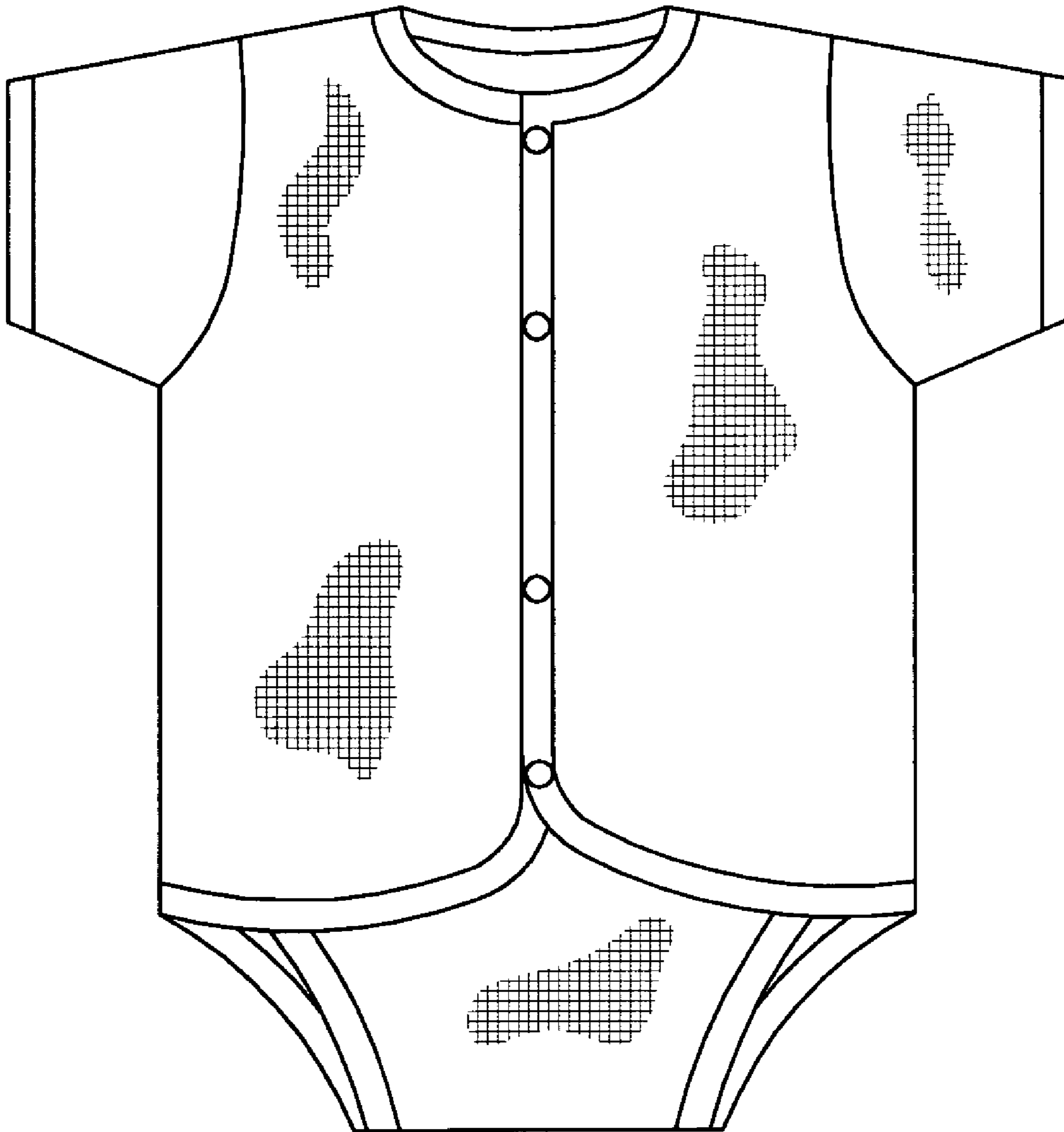
FIG. 9 is a front view thereof, with the upper body portion, partially open, and the lower body portion is folded to an open position.

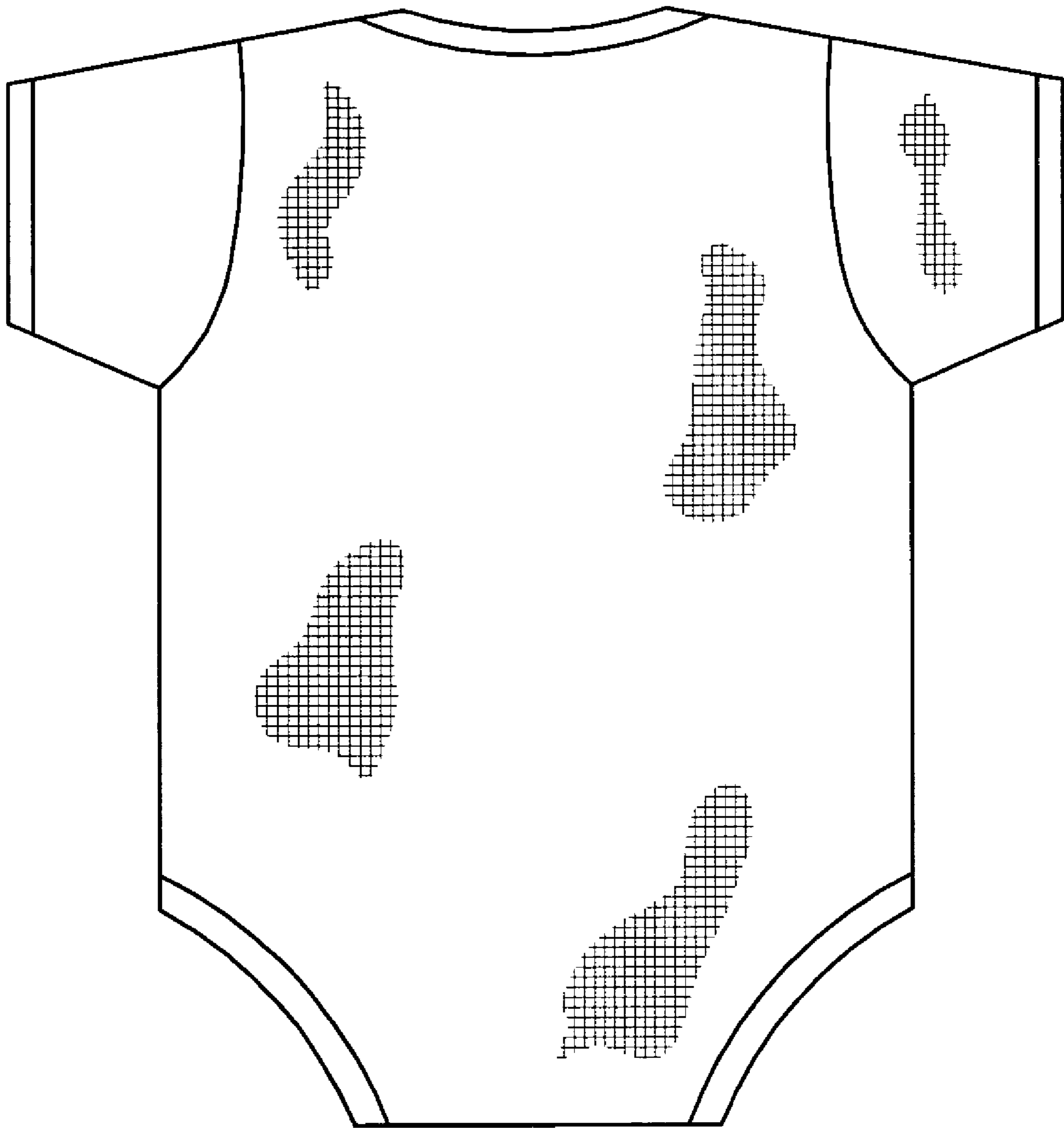




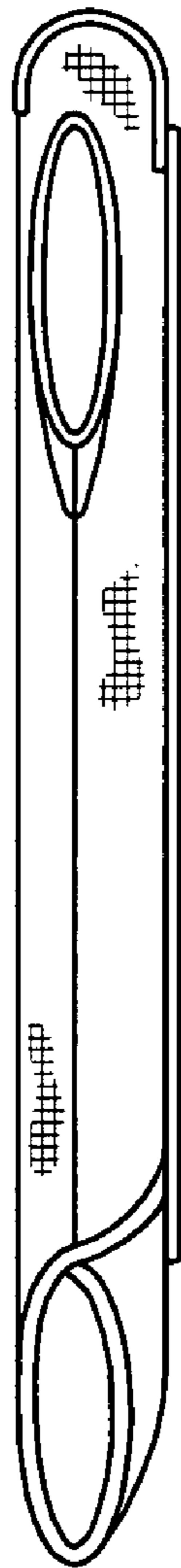

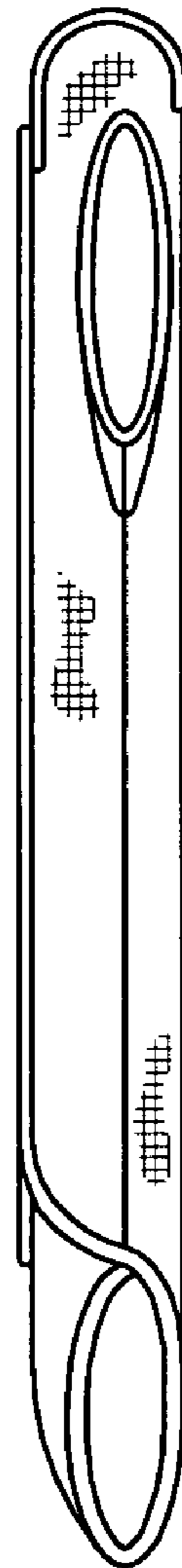

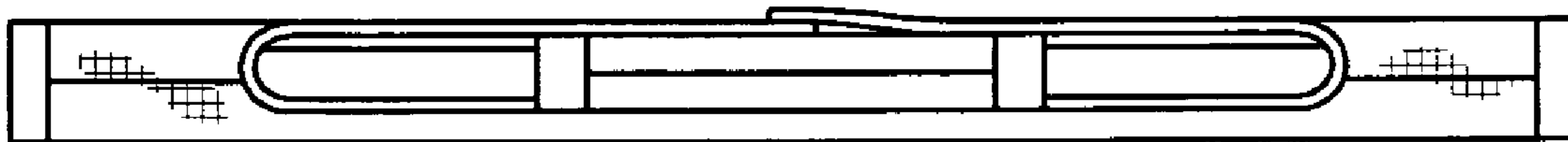

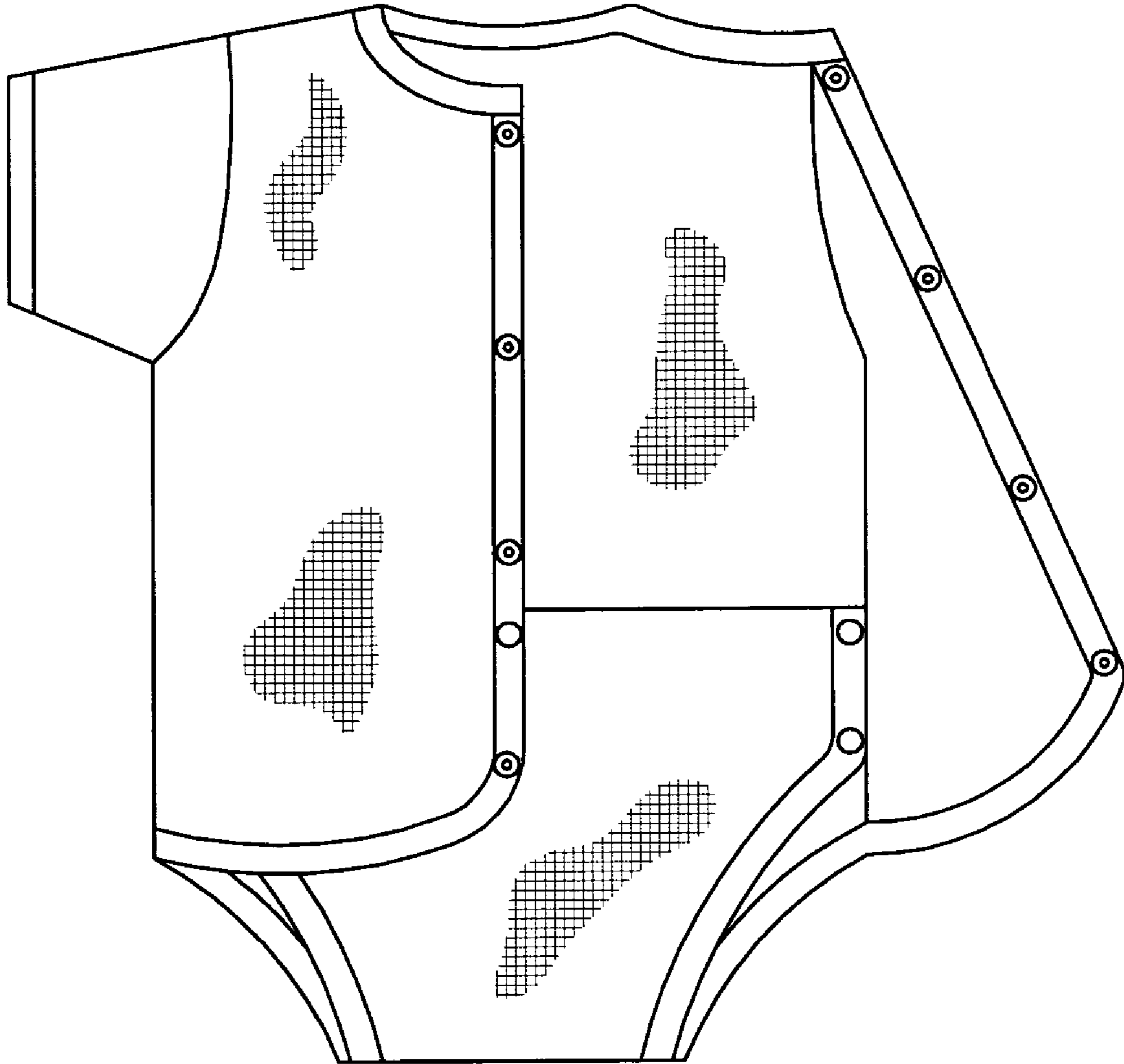

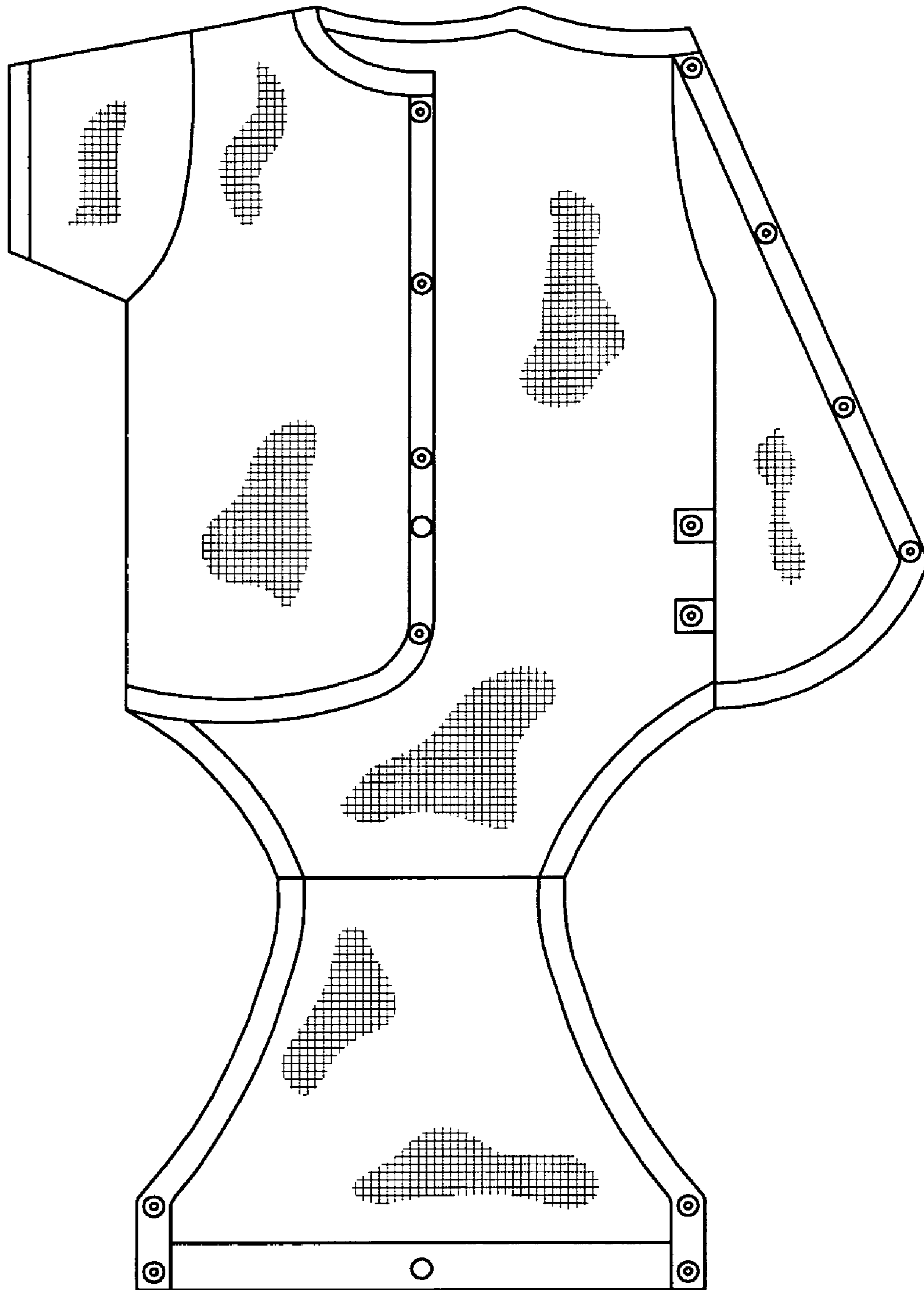
