FIG. 3 is a back view of the laptop sleeve.

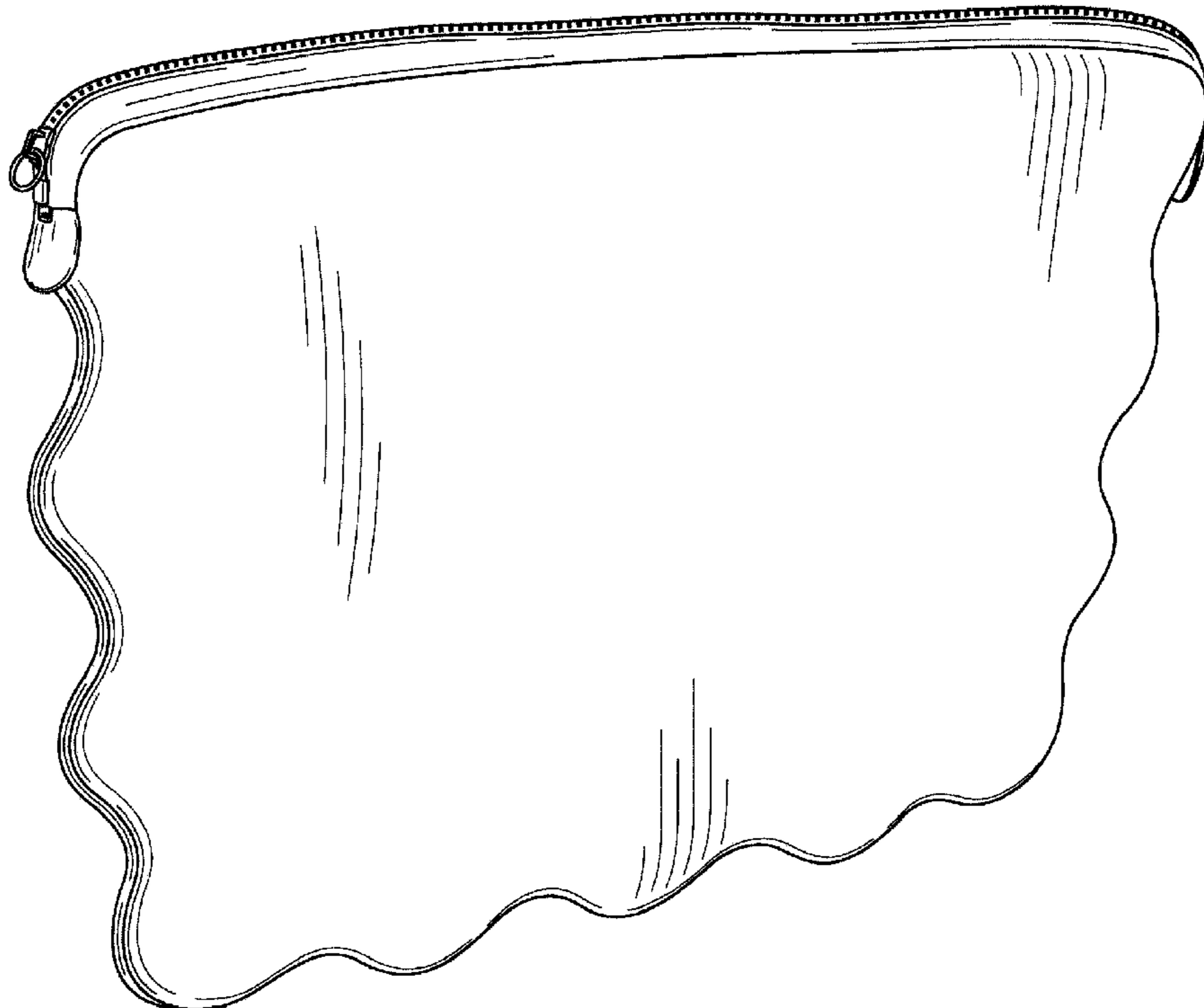
FIG. 4 is a left view of the laptop sleeve.

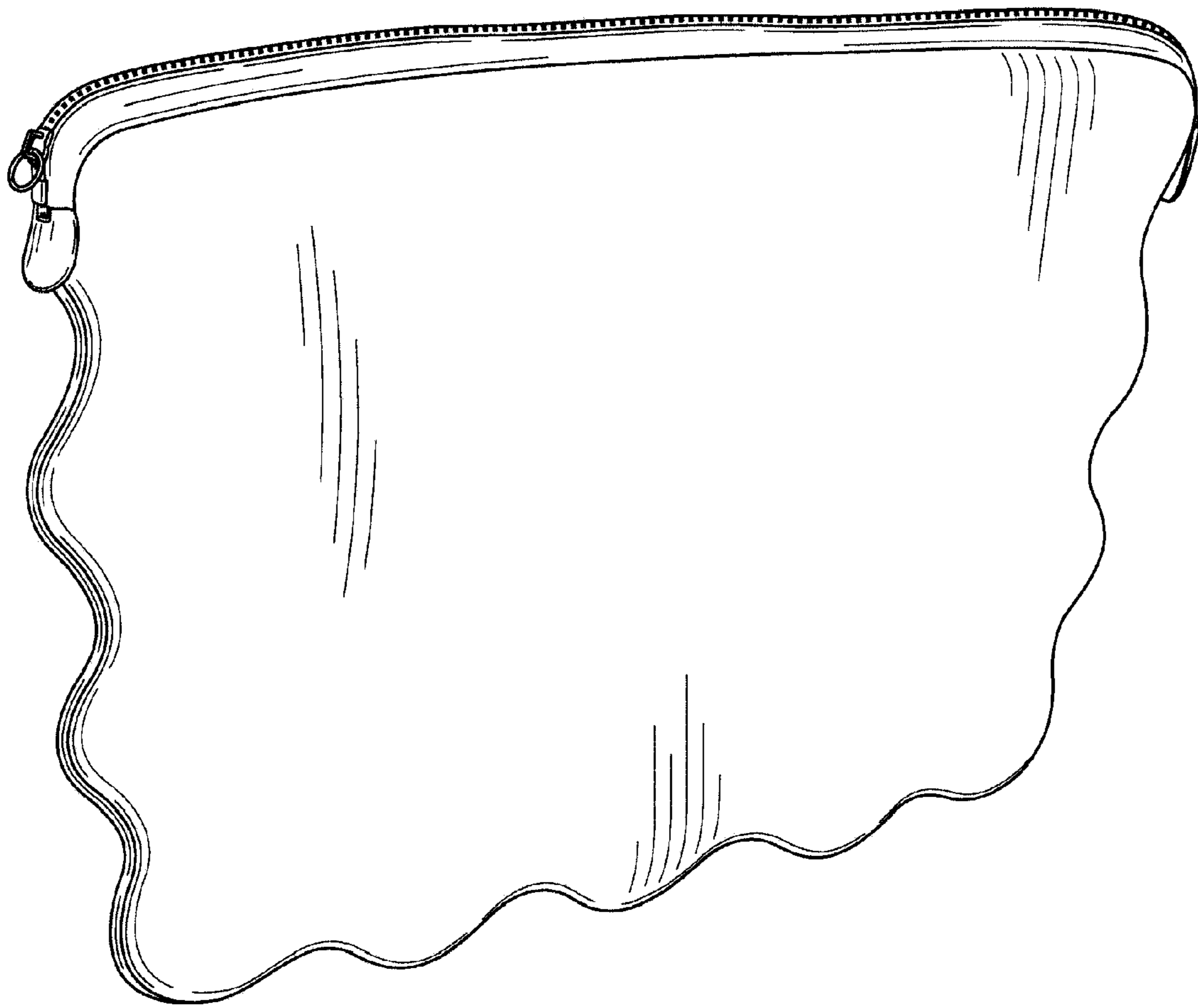

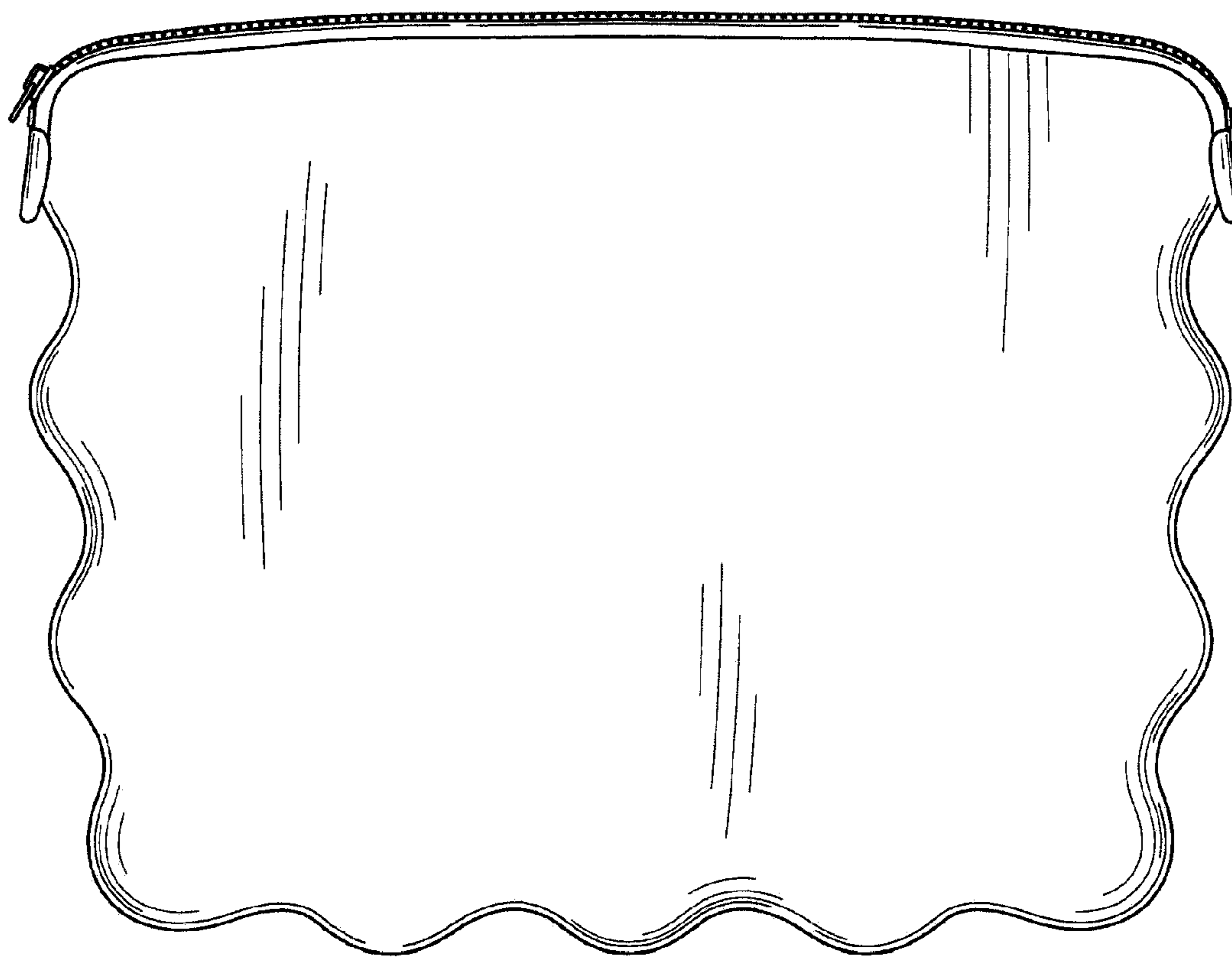

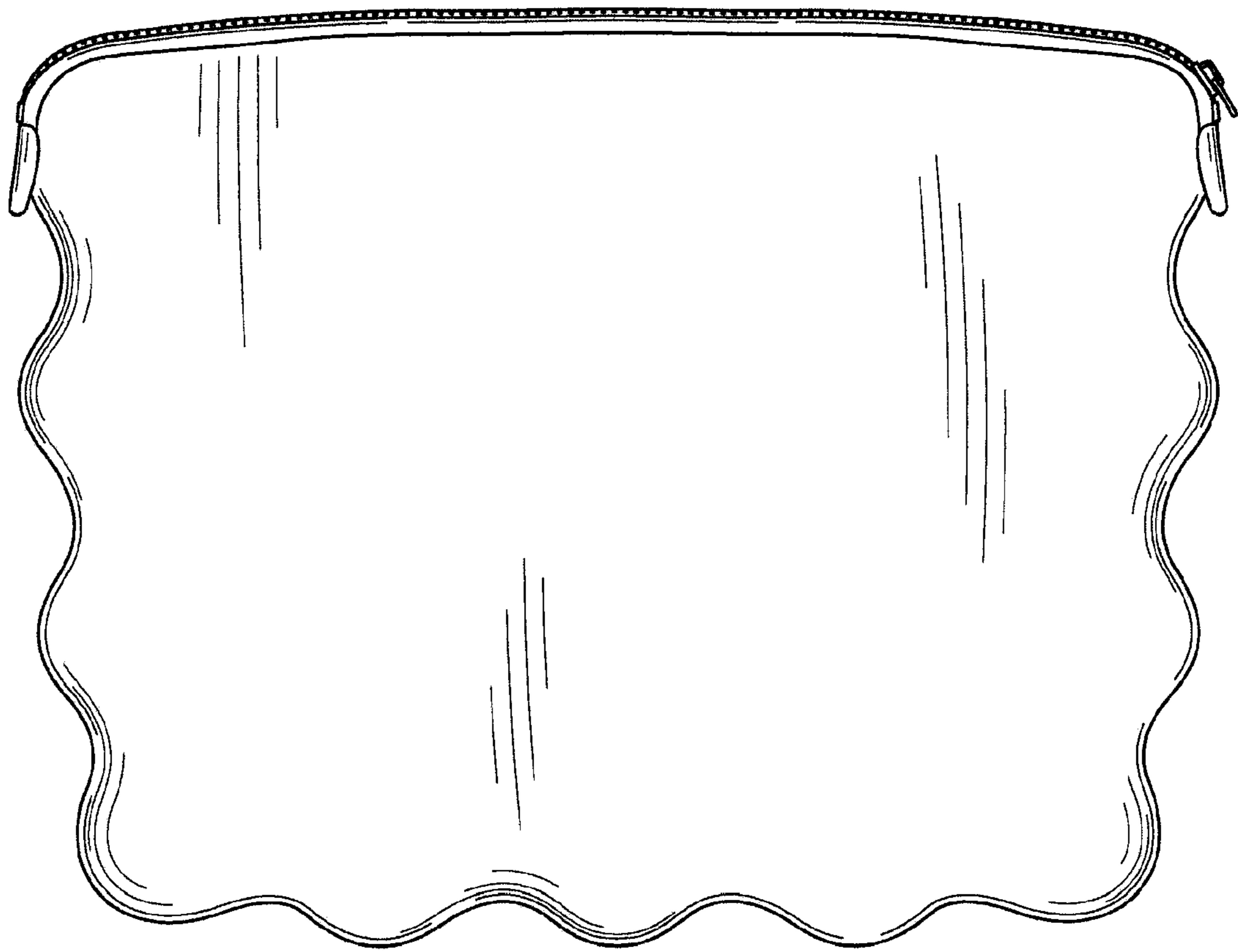

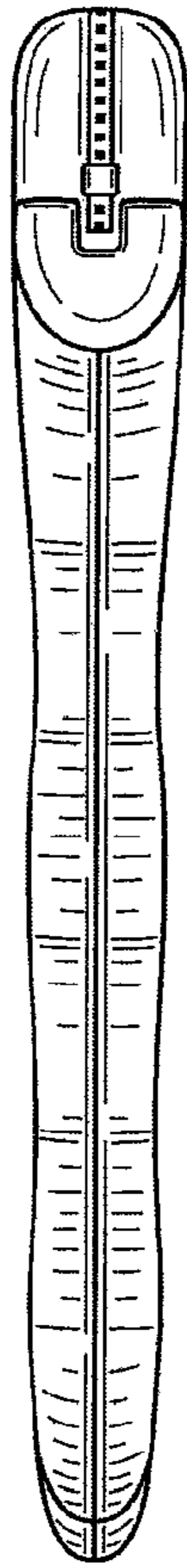

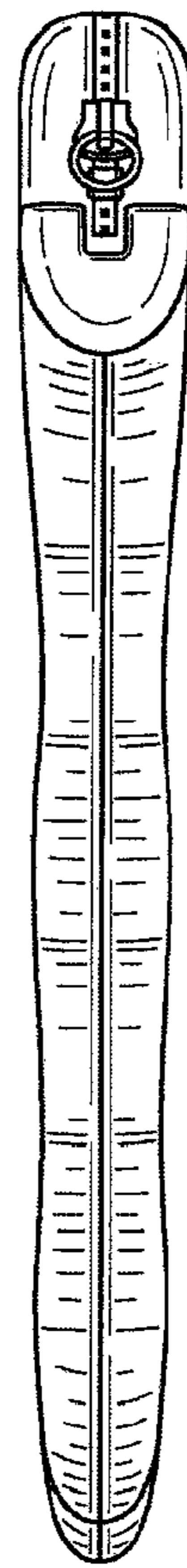

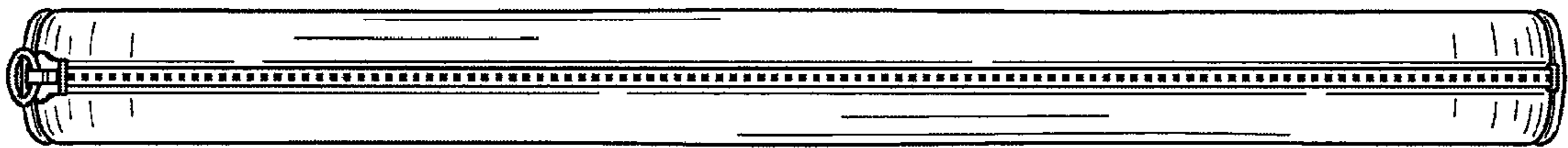

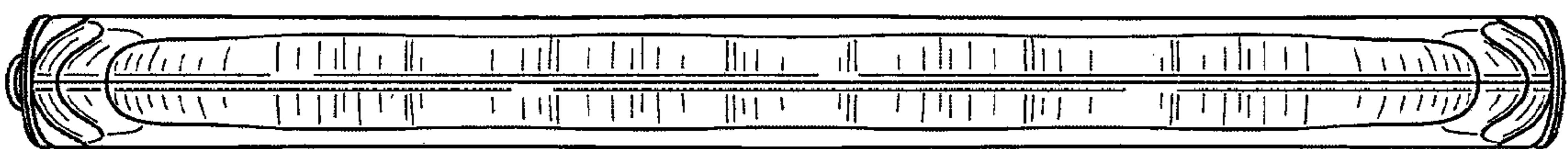
