(57) **CLAIM**

The ornamental design for a replacement head for an electric toothbrush, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the replacement head for an electric toothbrush embodying the new design;

FIG. 2 is a right side view thereof;

FIG. 3 is a left side view thereof;

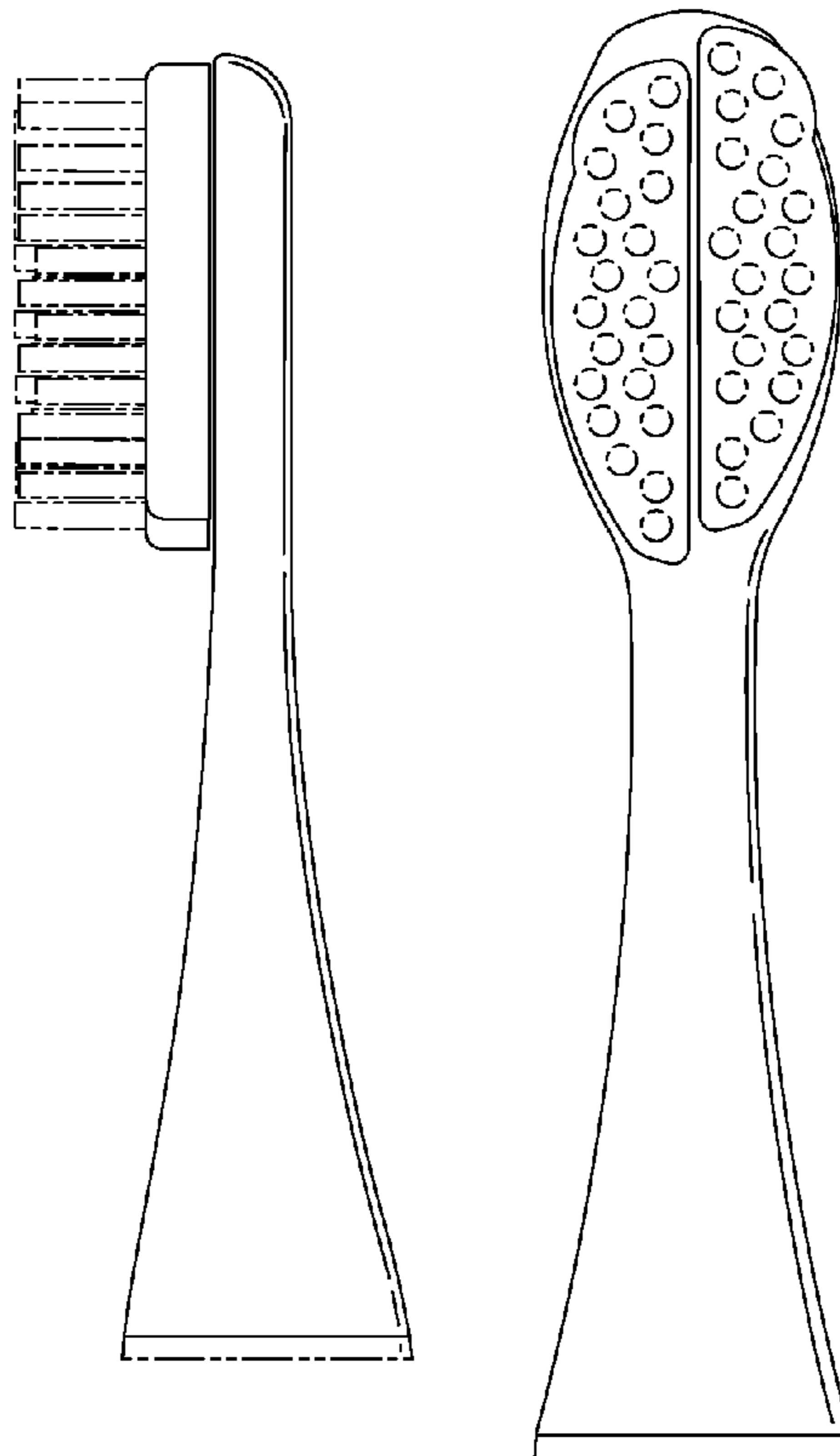
FIG. 4 is a top view thereof;

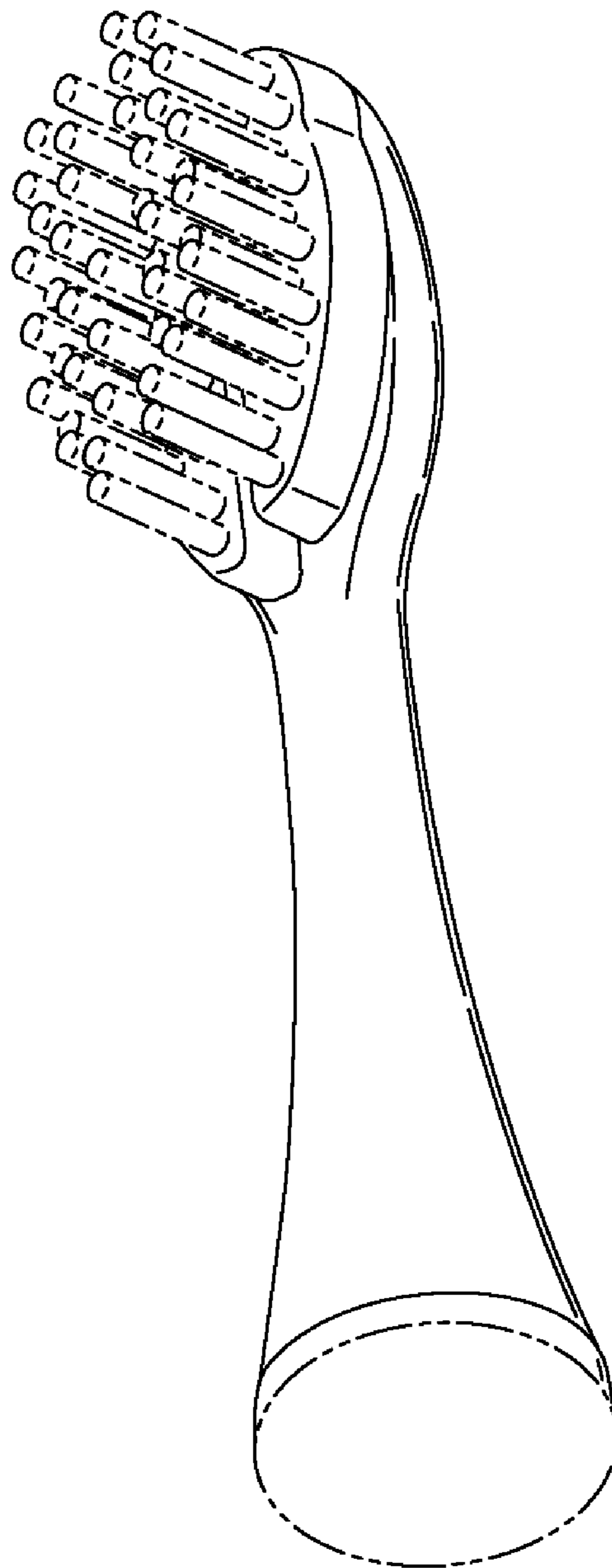

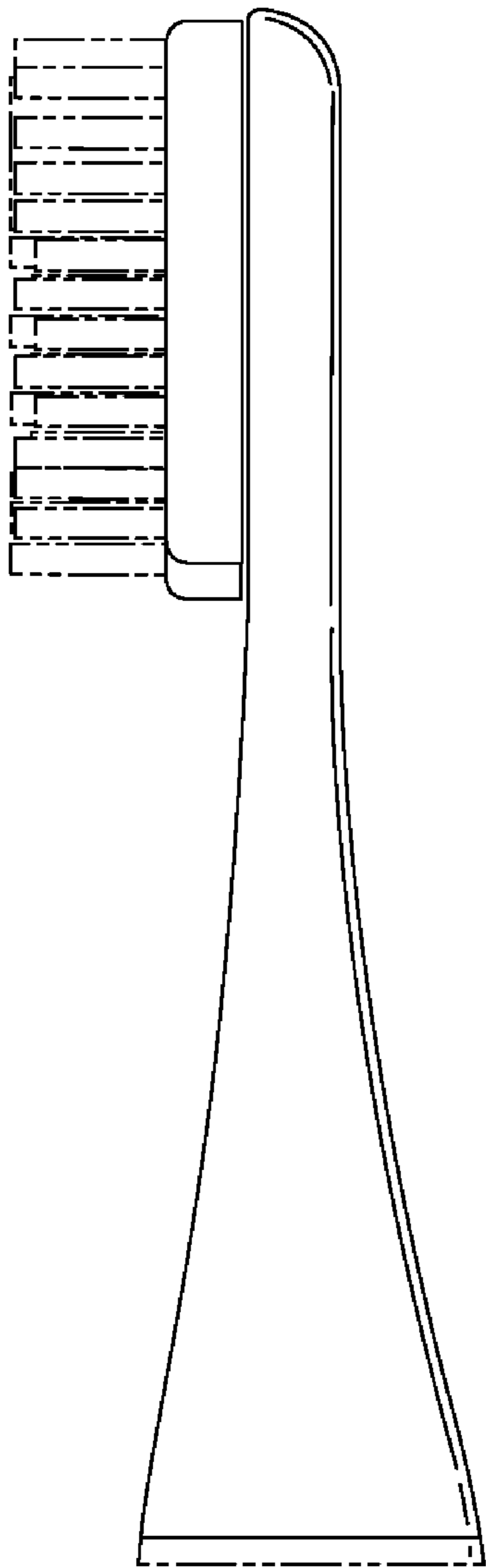

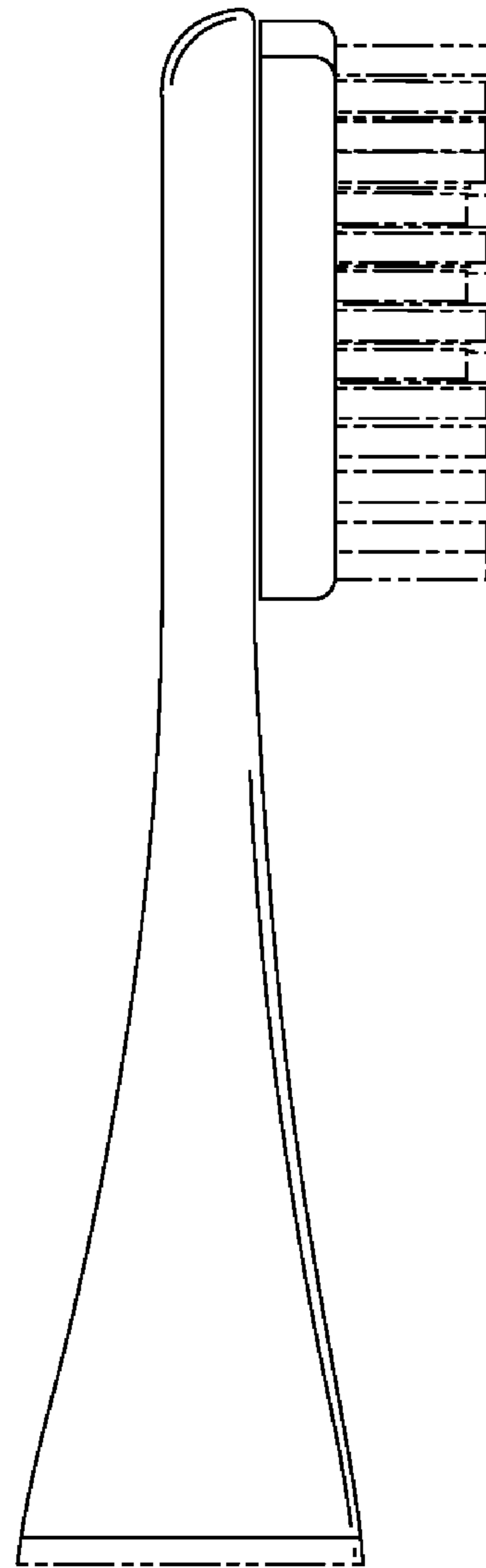

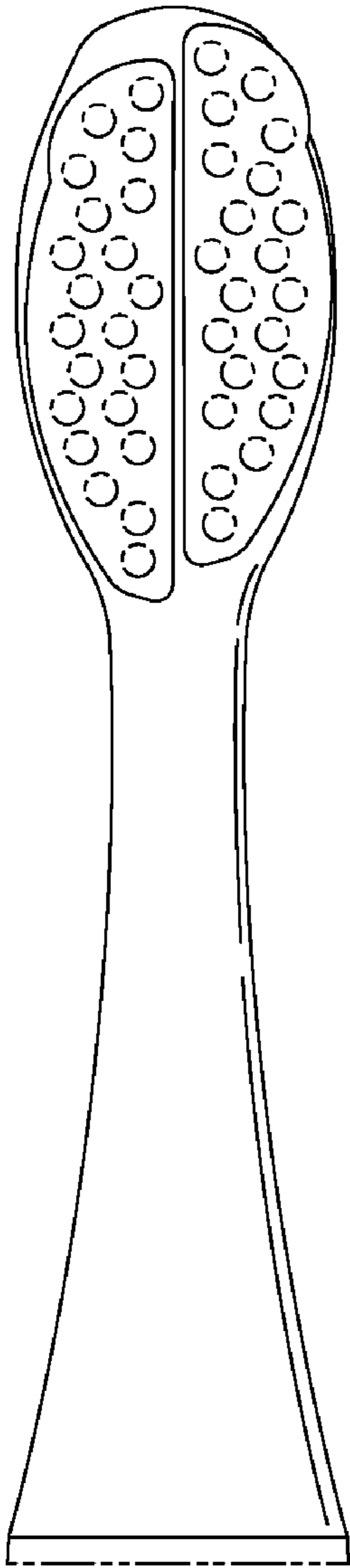

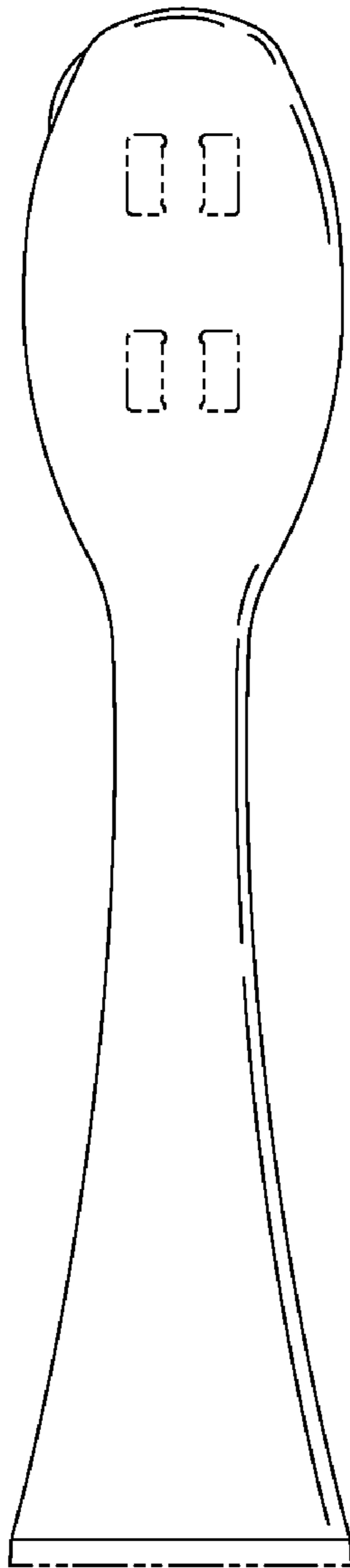

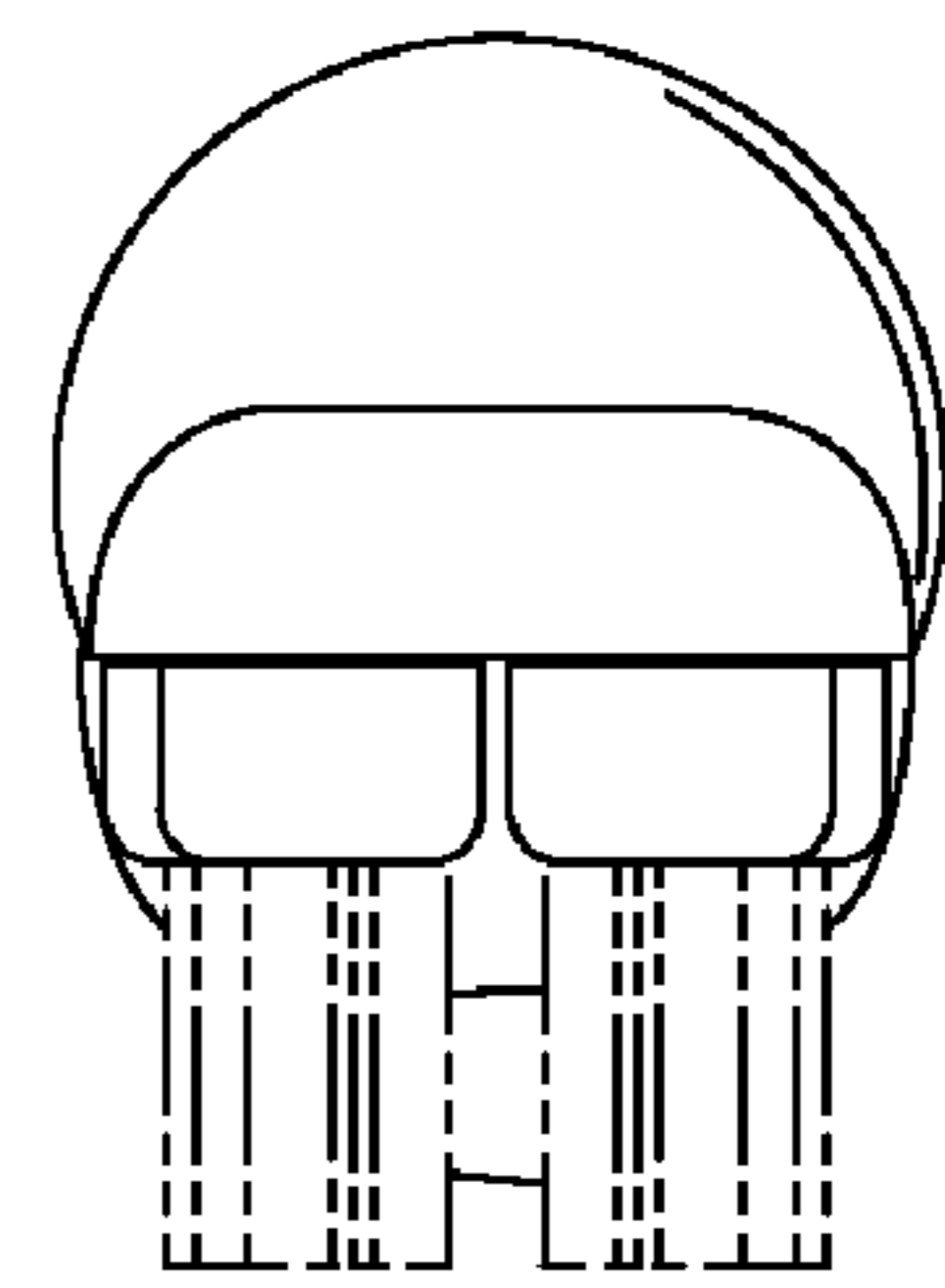
