(57) **CLAIM**

We claim the ornamental design for the portion of a horizontal and vertical cable holder, as shown and described.

DESCRIPTION

FIG. 1 is a front top right perspective view of a portion of a horizontal and vertical cable holder according to our design;

FIG. 2 is a front elevation view of the design shown in FIG. 1;

FIG. 3 is a back elevation view of the design shown in FIG. 1;

FIG. 4 is a left side elevation view of the design shown in FIG. 1;

FIG. 5 is a right side elevation view of the design shown in FIG. 1;

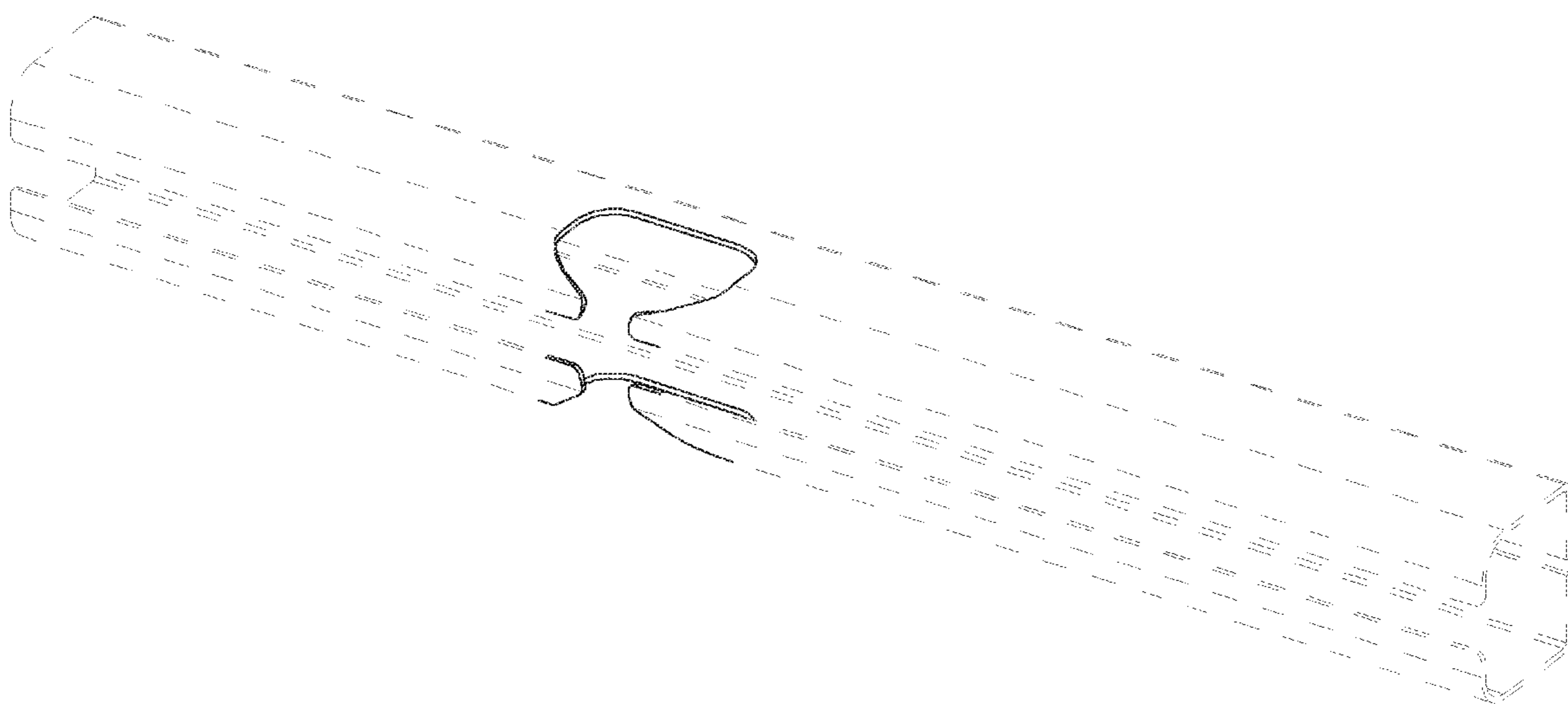
FIG. 6 is a top view of the design shown in FIG. 1;

FIG. 7 is a bottom plan view of the design shown in FIG. 1; and,

FIG. 8 is a perspective view of the design of FIG. 1 showing the design within a structure drawn in broken line which is included to illustrate the design in a position of use. The broken line structure forms no part of the claimed design.

The broken lines in the drawings depict parts of the portion of a horizontal and vertical cable holder that are not part of the claim. The broken lines and the structures and features they depict form no part of the claimed design.

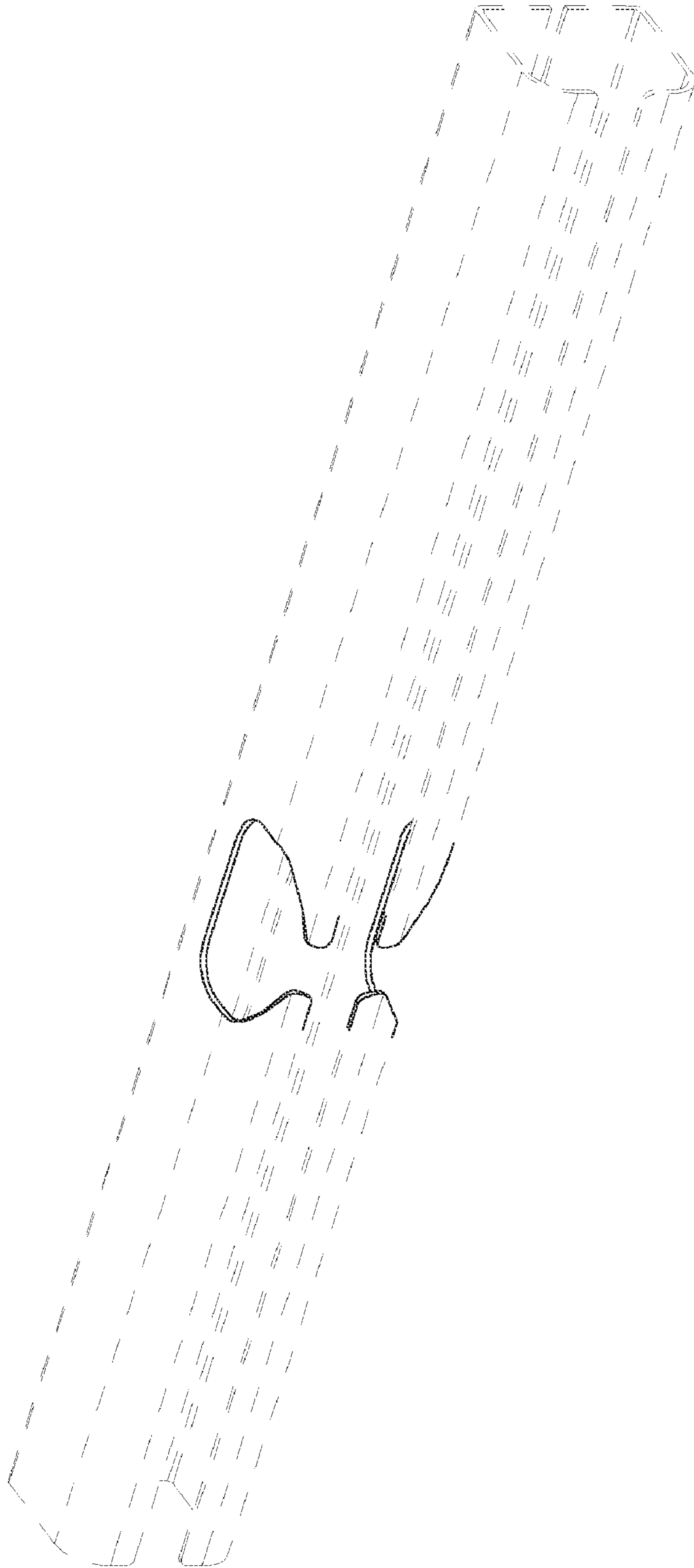

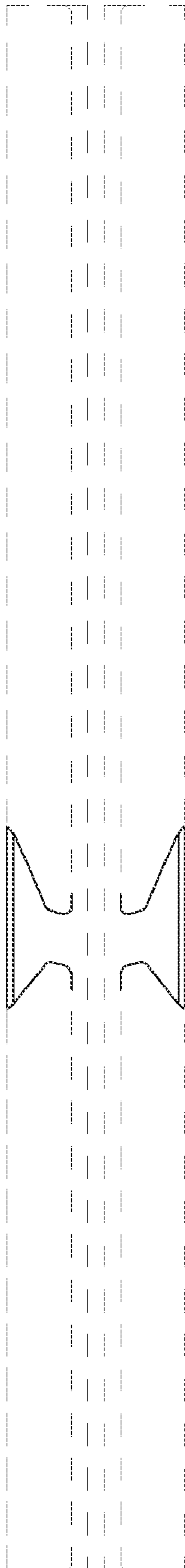

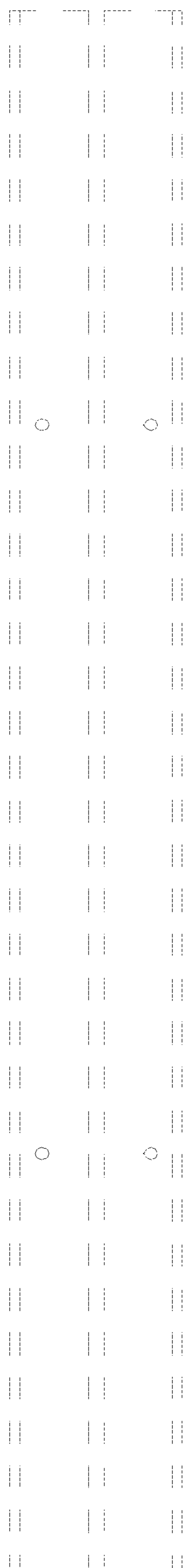

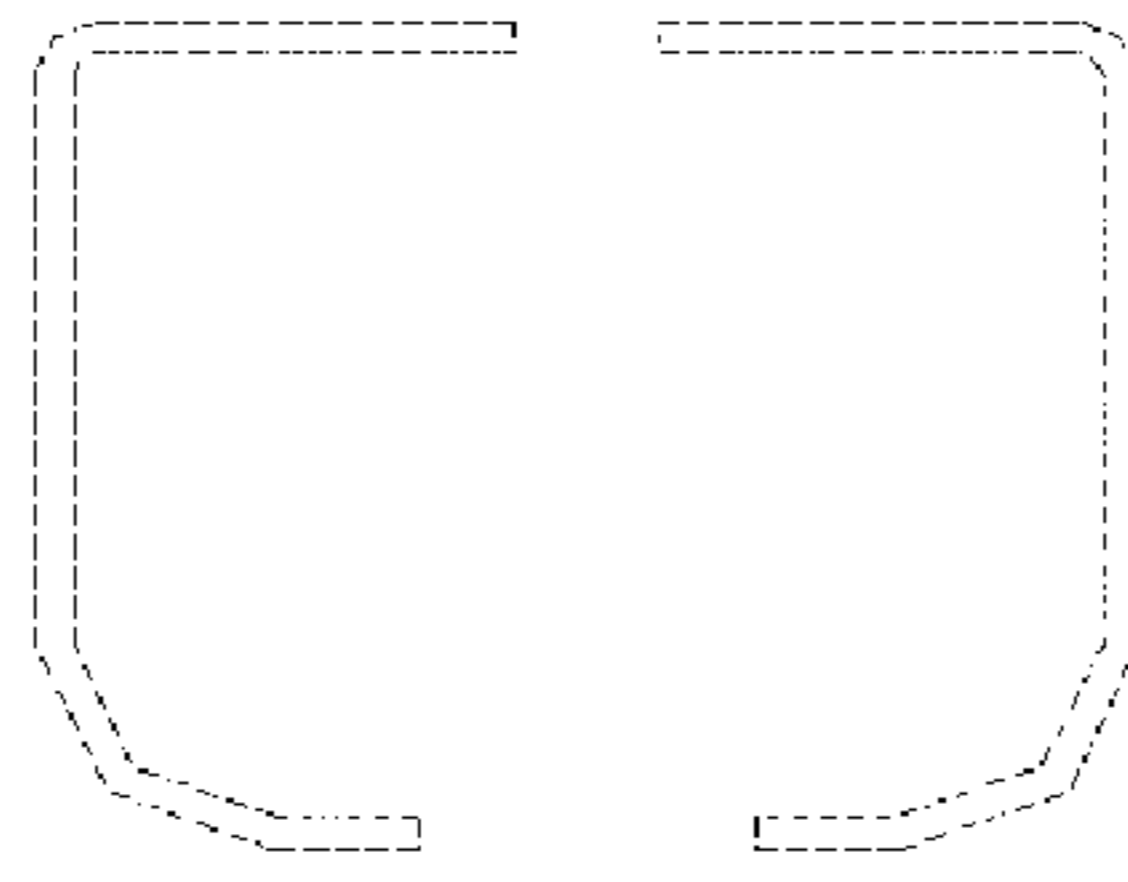

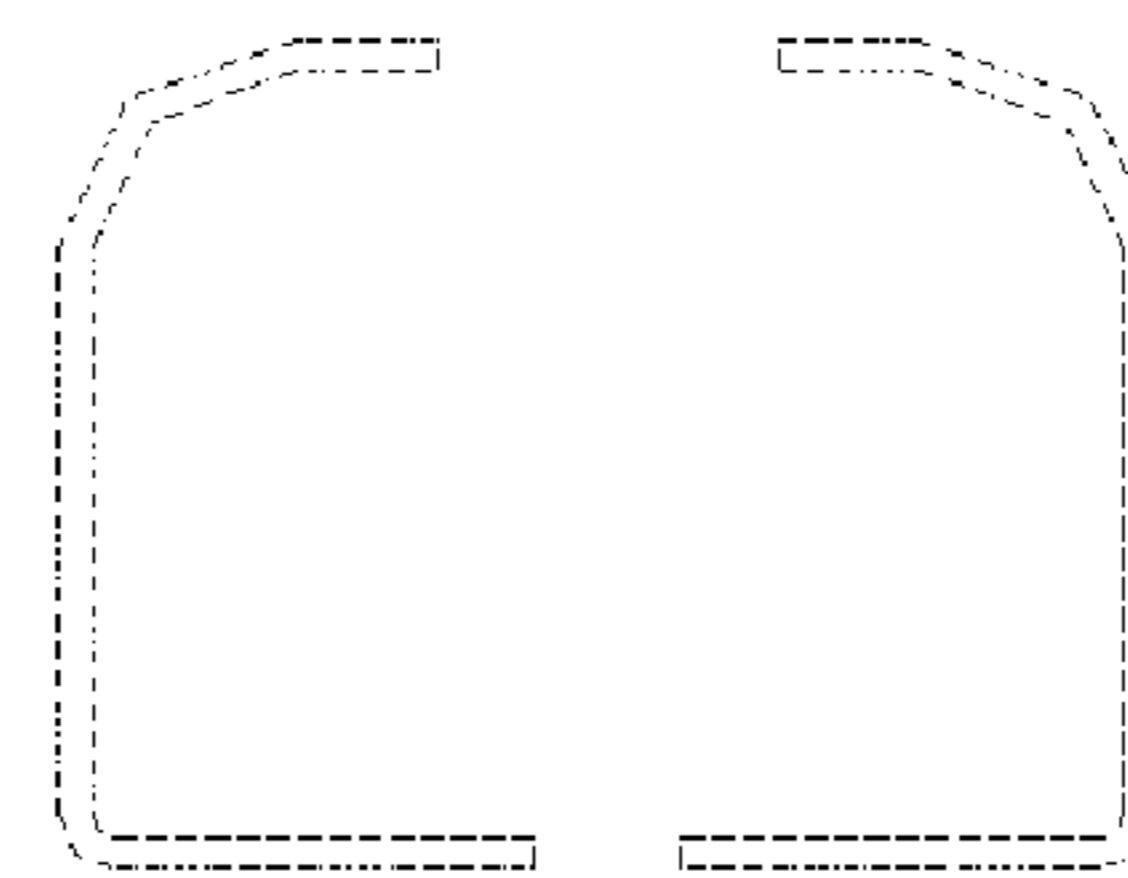

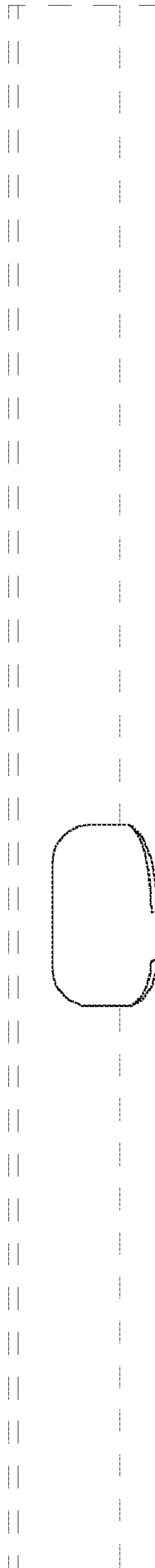

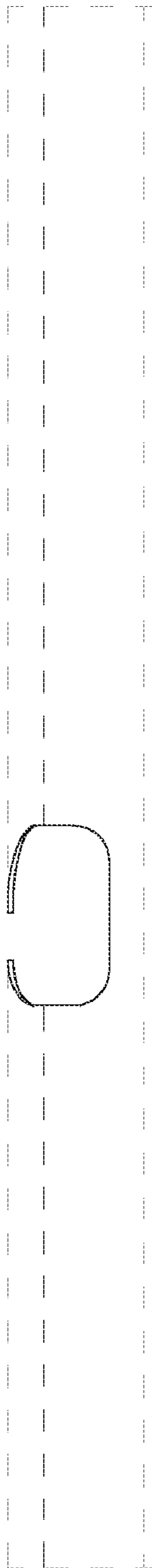

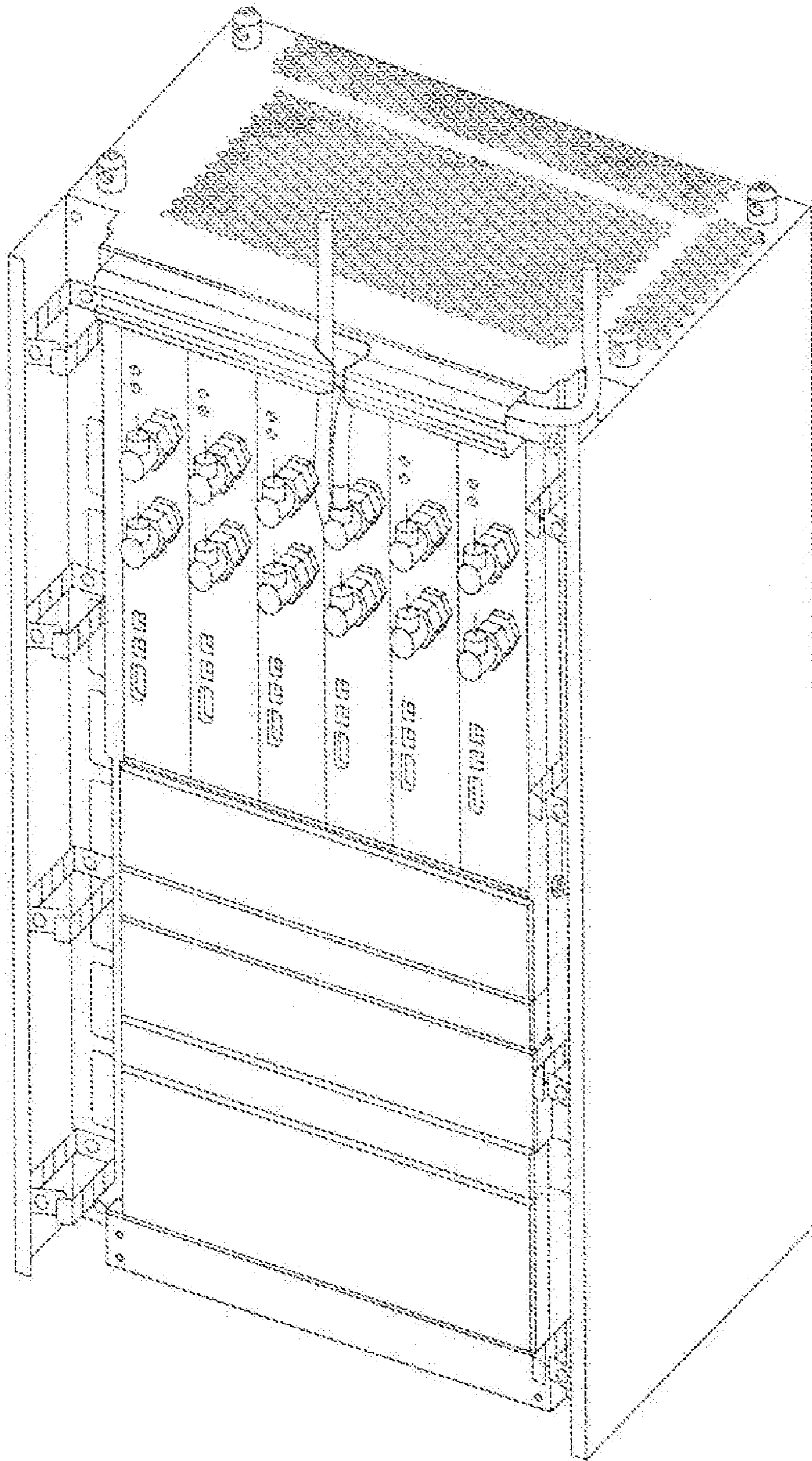
