The ornamental design for a dip-tube positioner, as shown and described.

DESCRIPTION

FIG. 1 is a bottom perspective view of a dip-tube positioner showing my new design;

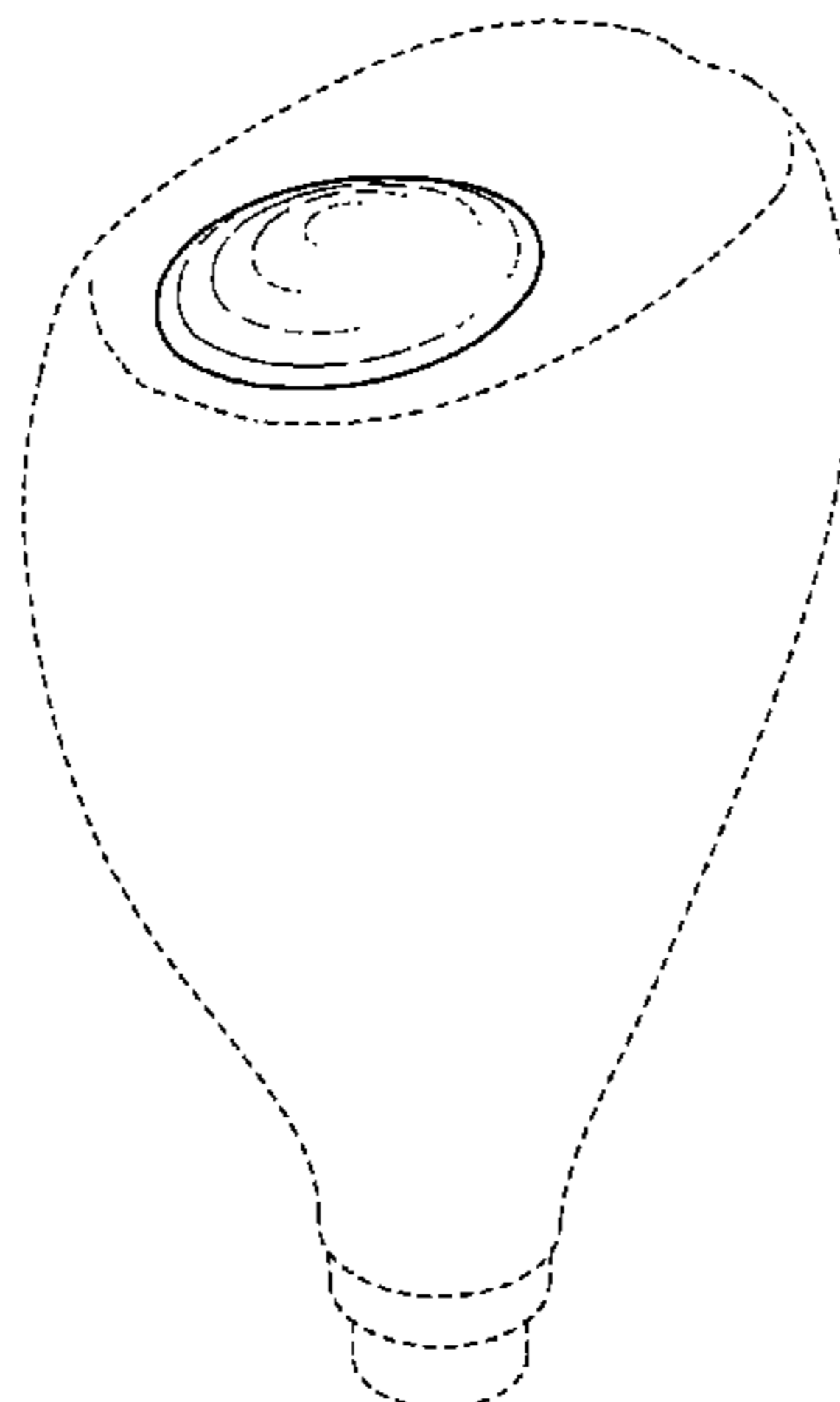
FIG. 2 is a bottom planar view thereof;

FIG. 3 is a cross-sectional view taken along lines 3—3 in FIG. 2; and

FIG. 4 is a cross-sectional view taken along lines 4—4 in FIG. 2.

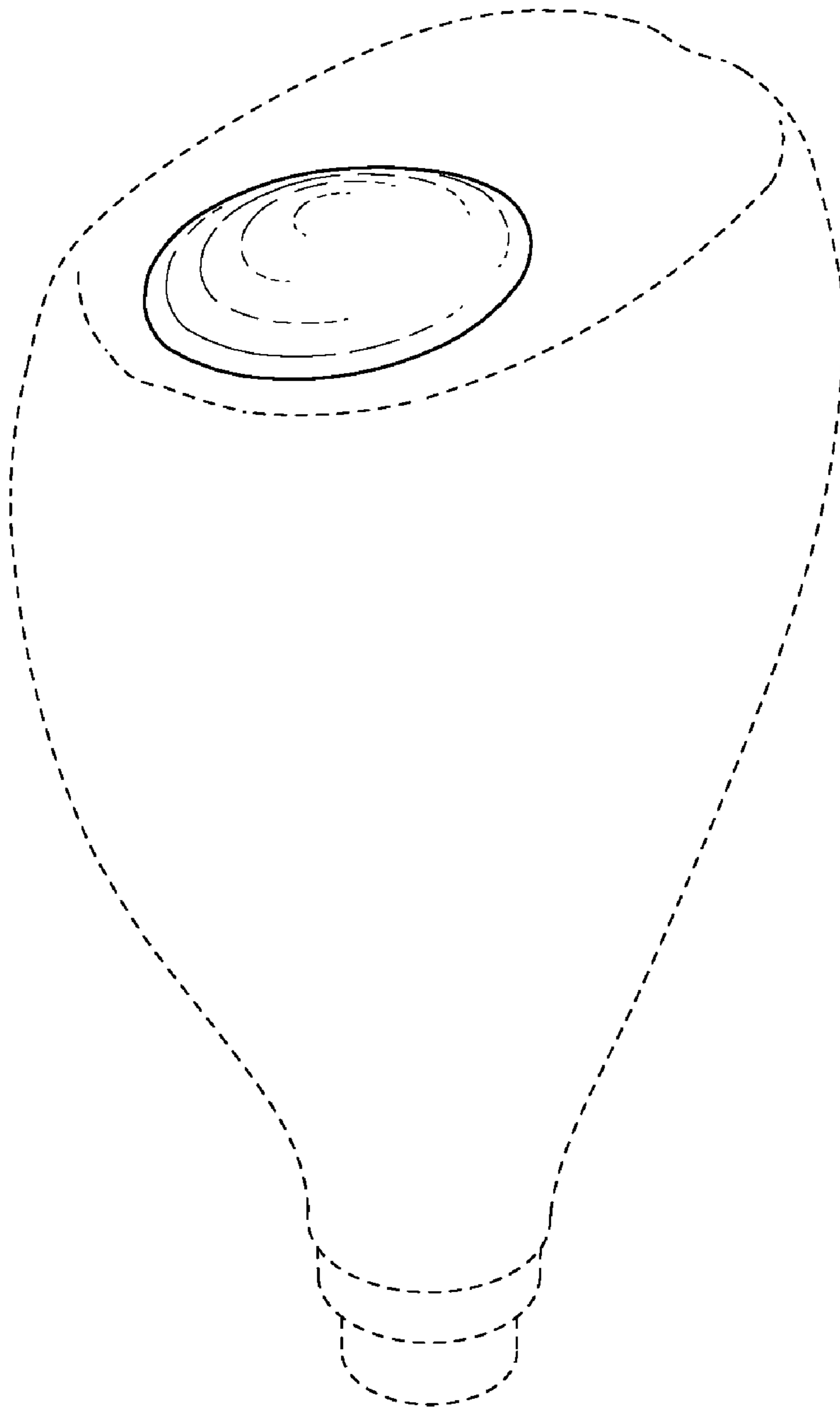

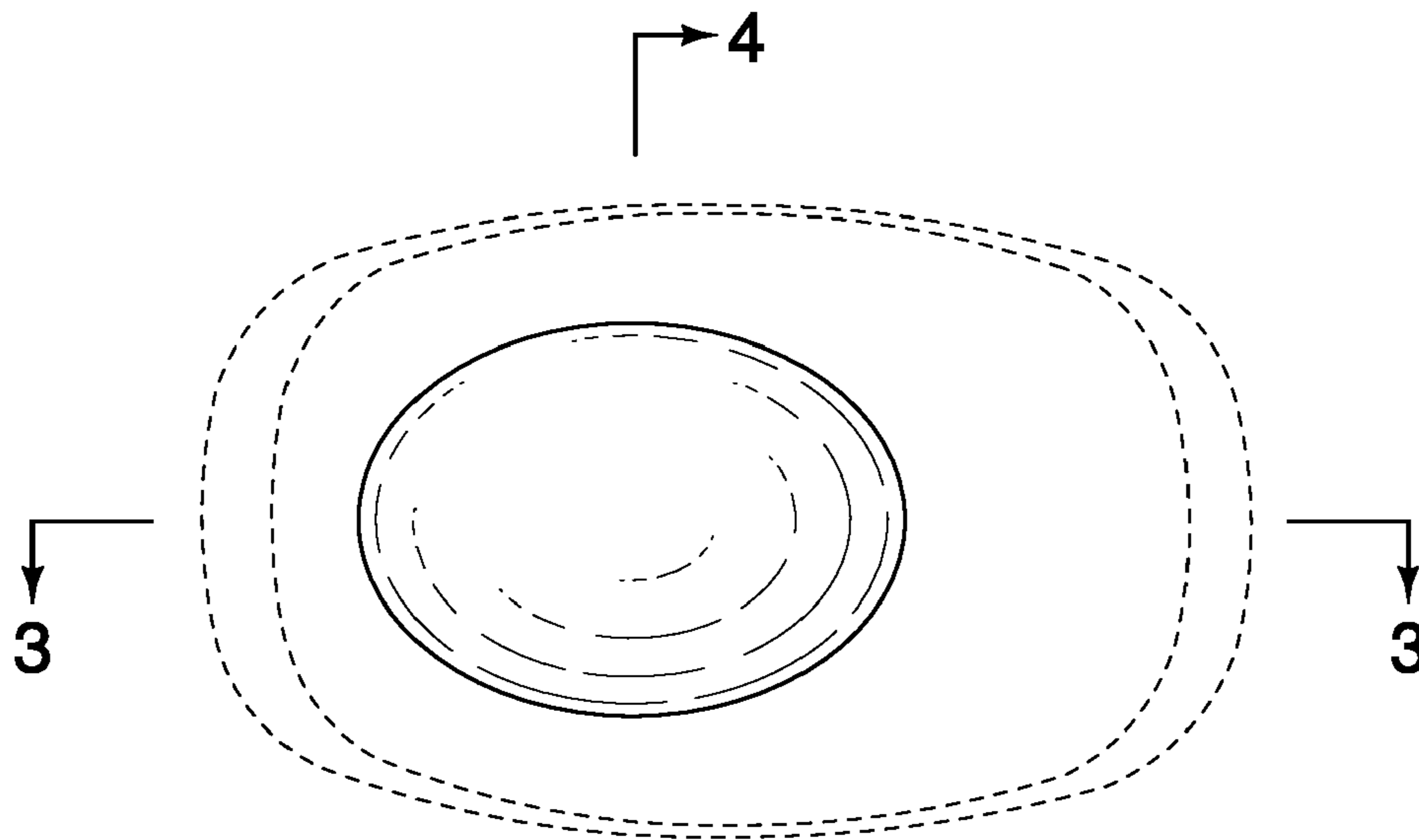

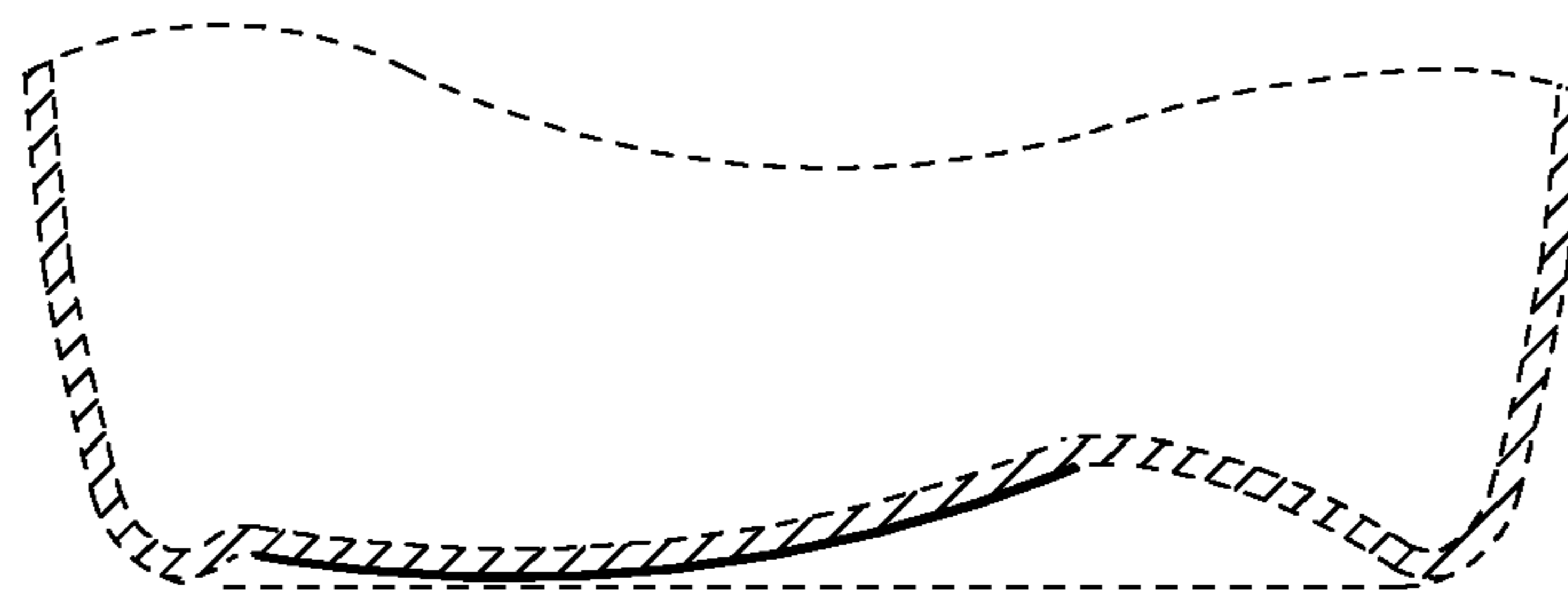

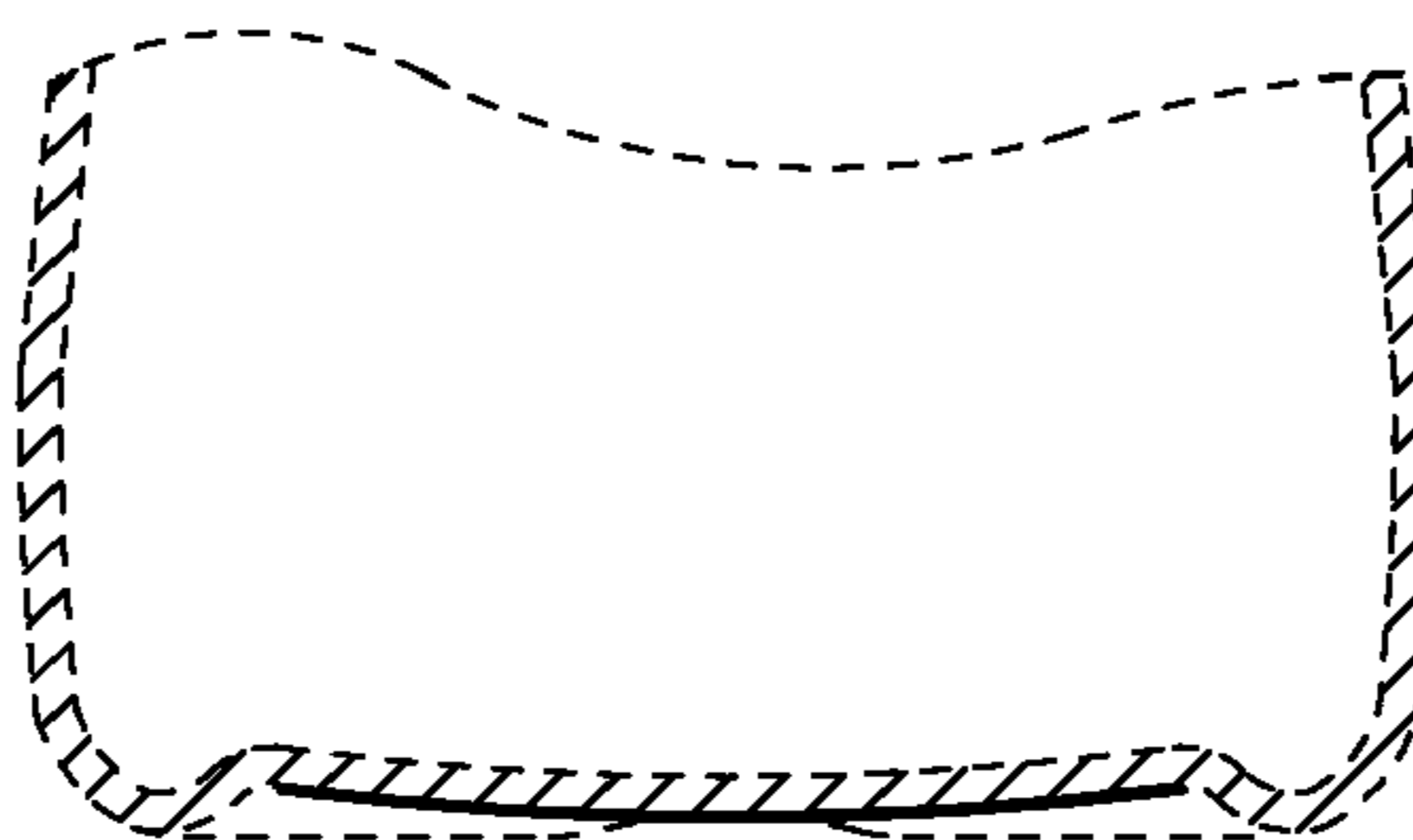
