FIG. 1 is a perspective view of a decorative ornament showing my new design.

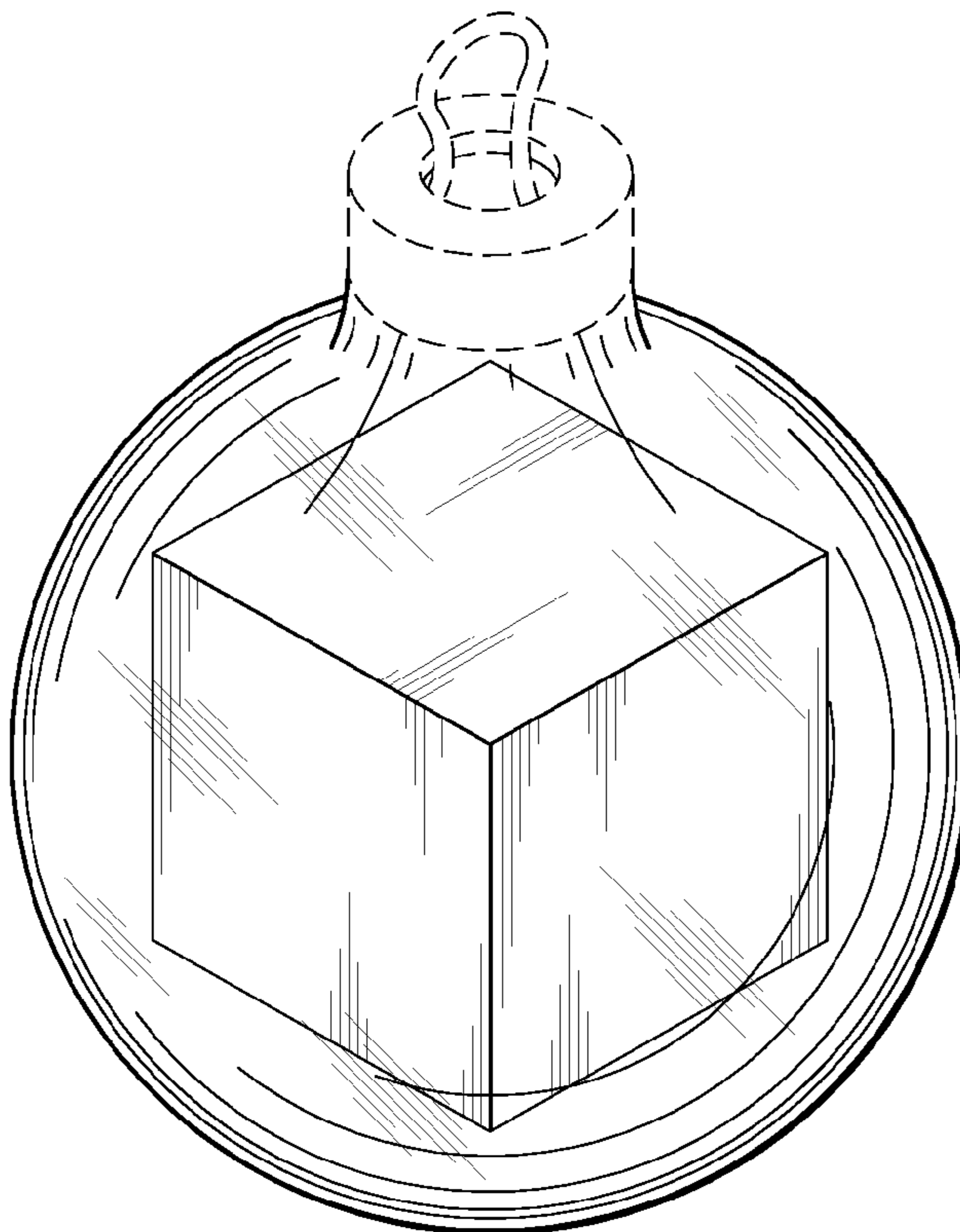
FIG. 2 is a front view thereof, with the left side view, right side view and rear view being identical thereof;

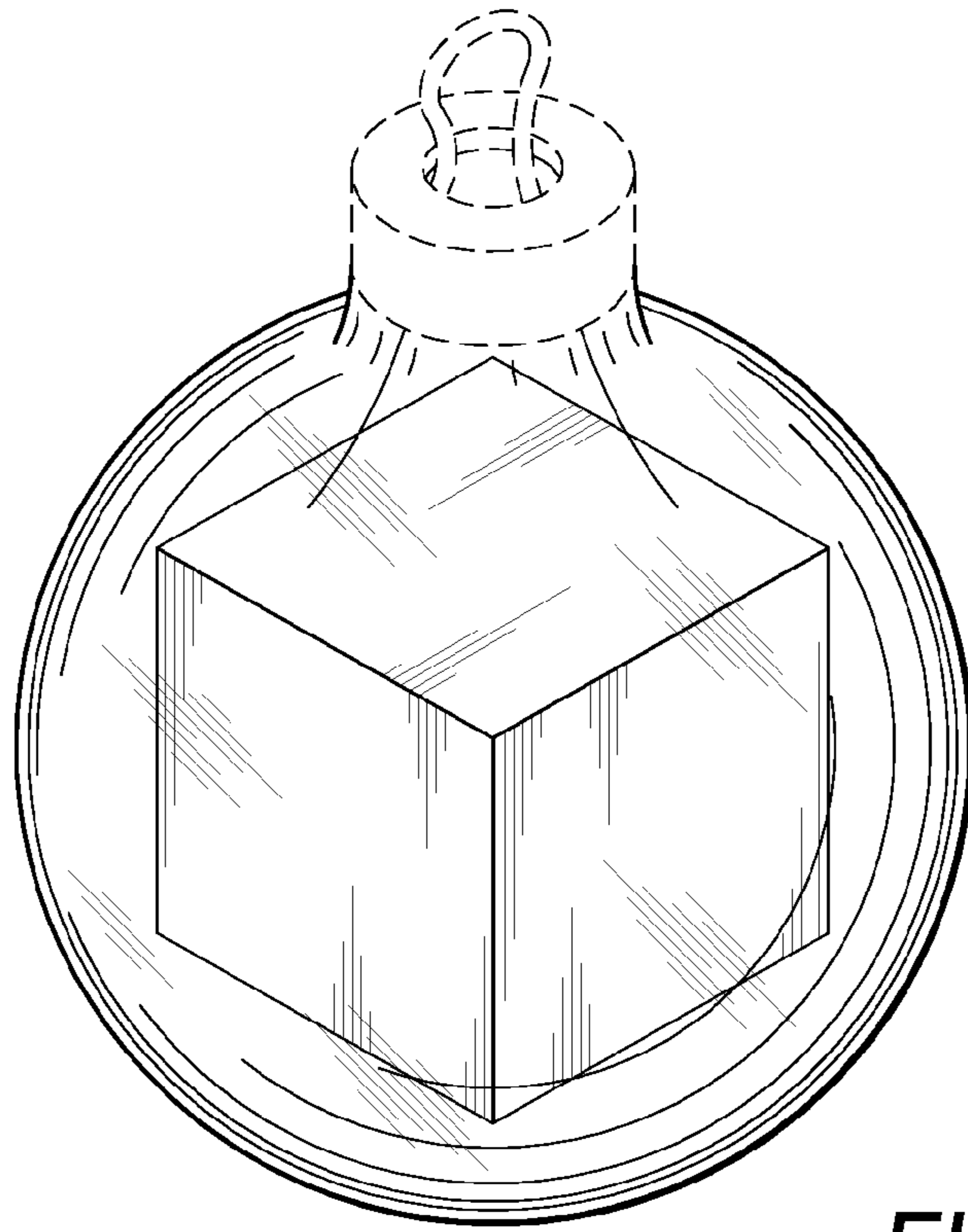

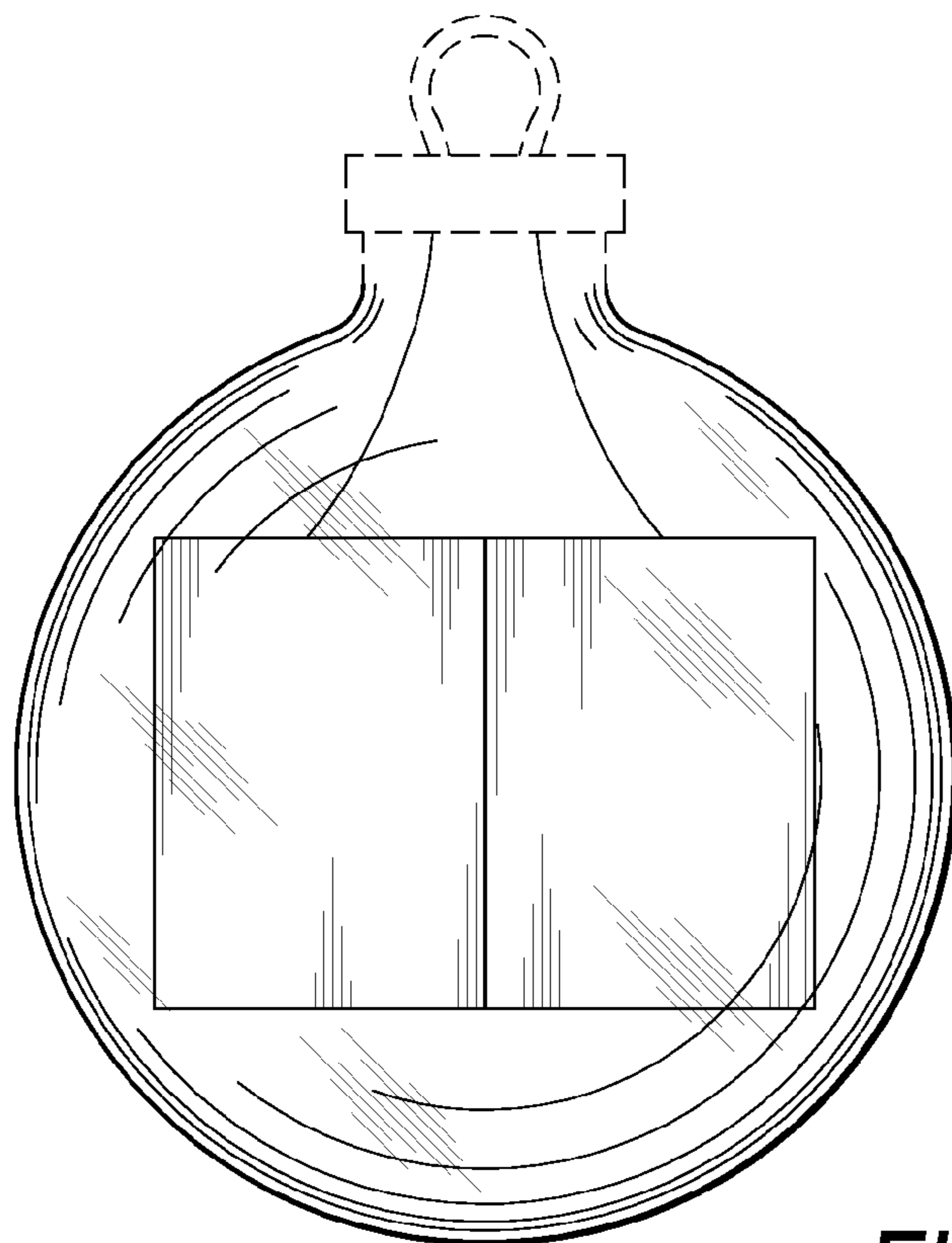

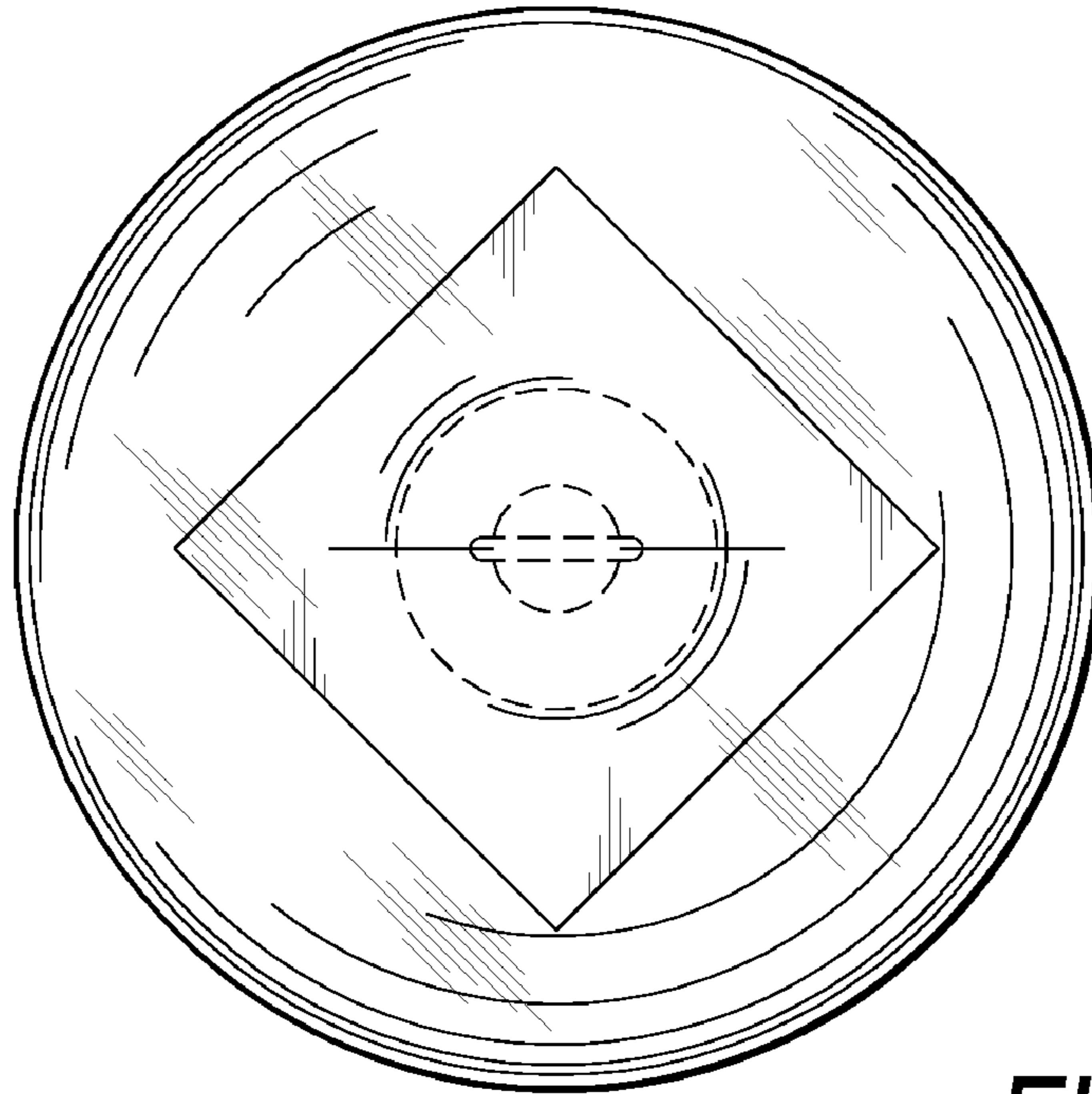

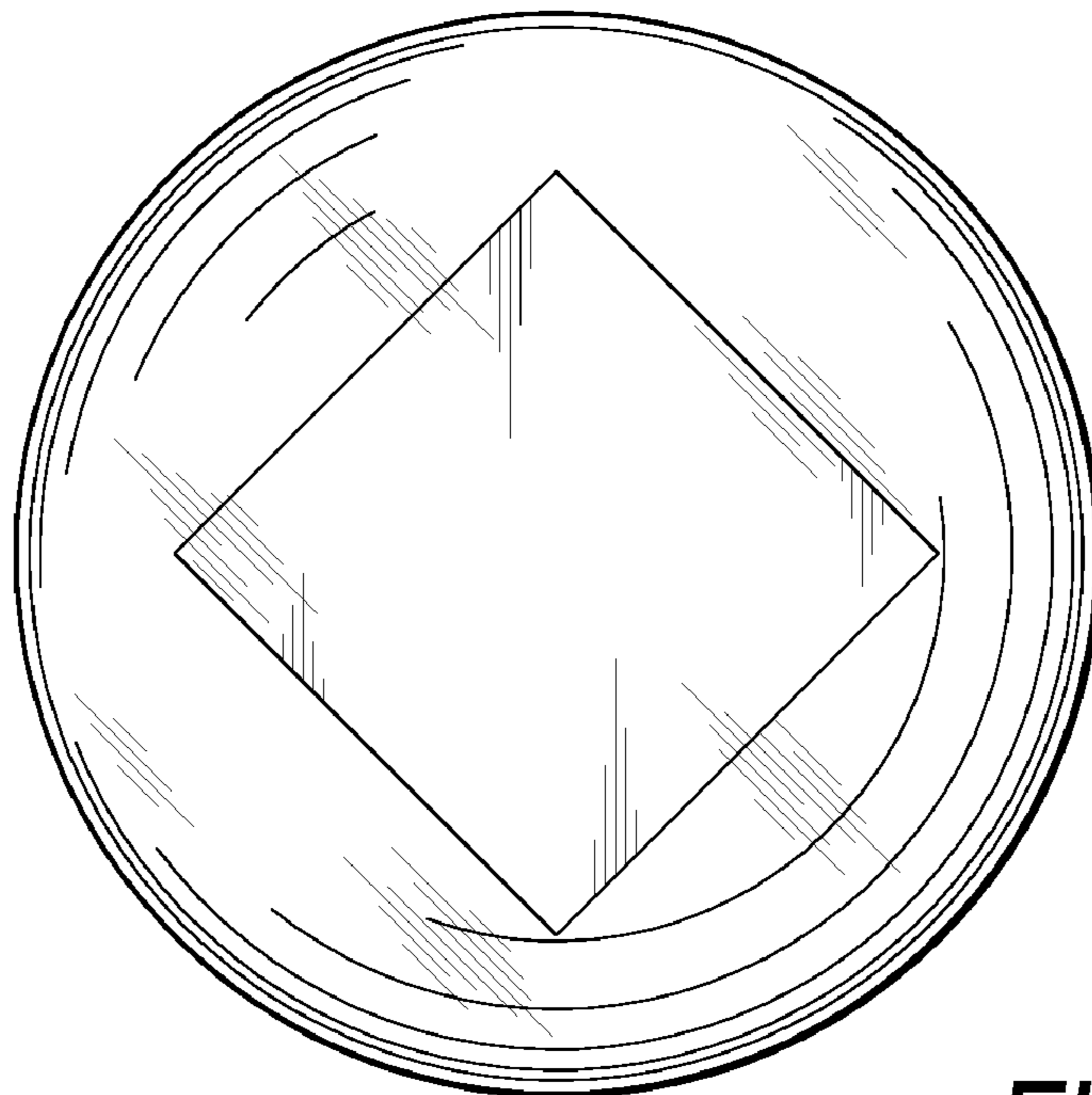
