(57) **CLAIM**

The ornamental design for a pair of vehicle mirrors, as shown and described.

DESCRIPTION

FIG. 1 is a first embodiment illustrating a front elevational view of a left vehicle mirror;

FIG. 2 is right elevational view of the left vehicle mirror;

FIG. 3 is a left elevational view of the left vehicle mirror;

FIG. 4 is a top plan view of the left vehicle mirror;

FIG. 5 is a bottom plan view of the left vehicle mirror;

FIG. 6 is a rear elevational view of the left vehicle mirror;

FIG. 7 is an alternative embodiment illustrating a front elevational view of a right vehicle mirror;

FIG. 8 is right elevational view of the right vehicle mirror;

FIG. 9 is a left elevational view of the right vehicle mirror;

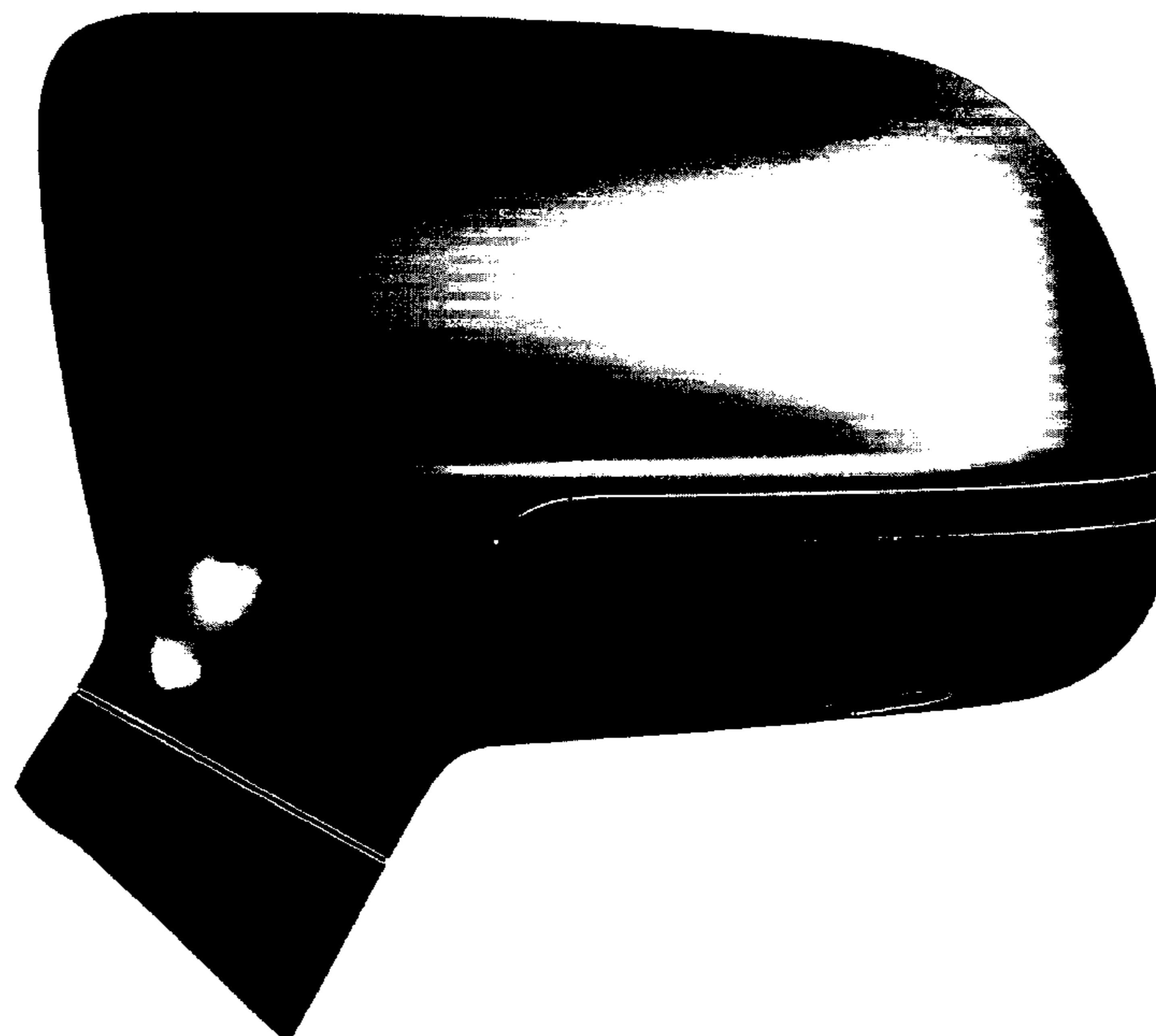
FIG. 10 is a top plan view of the right vehicle mirror;

FIG. 11 is a bottom plan view of the right vehicle mirror; and,

FIG. 12 is a rear elevational view of the right vehicle mirror.

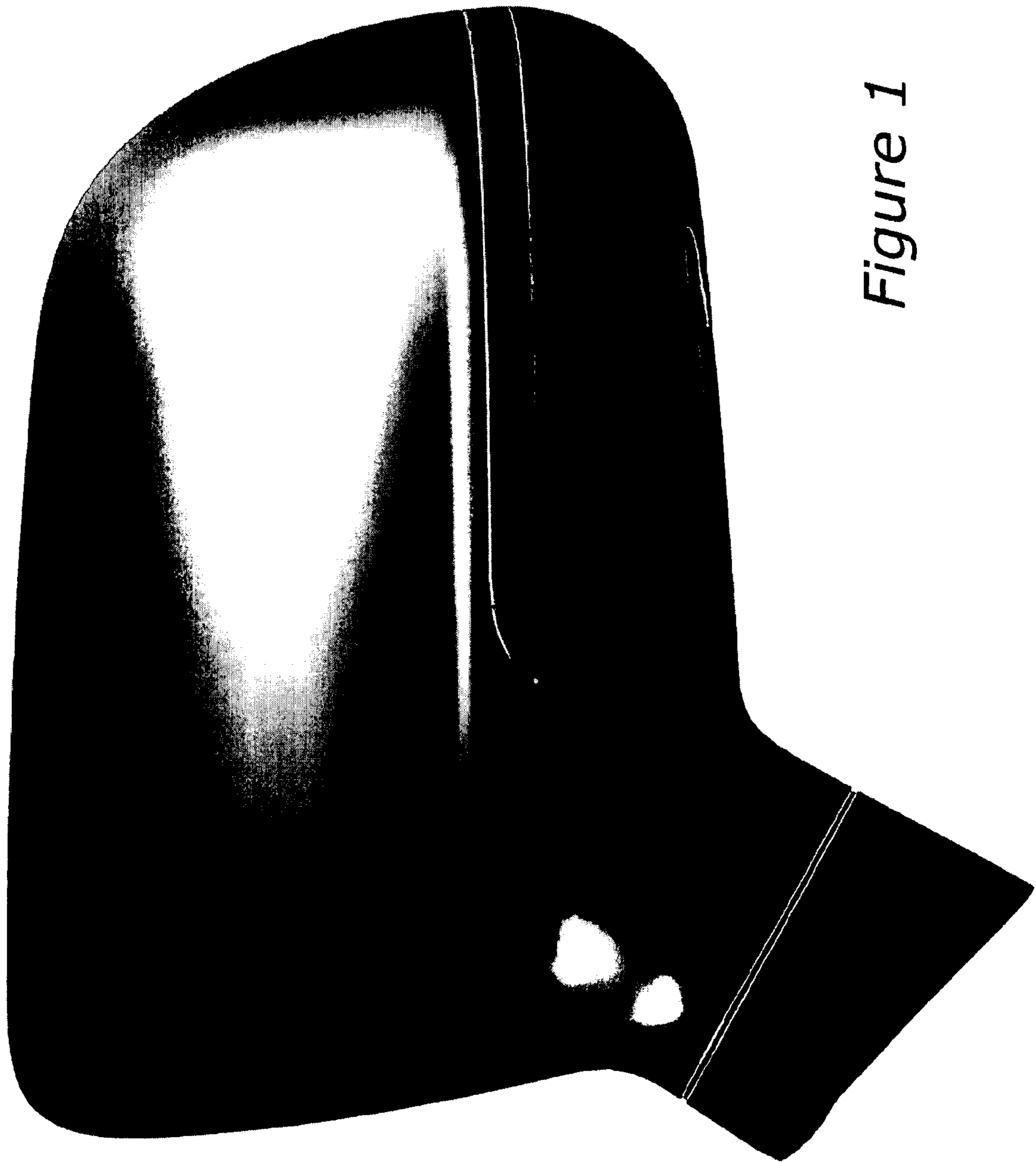

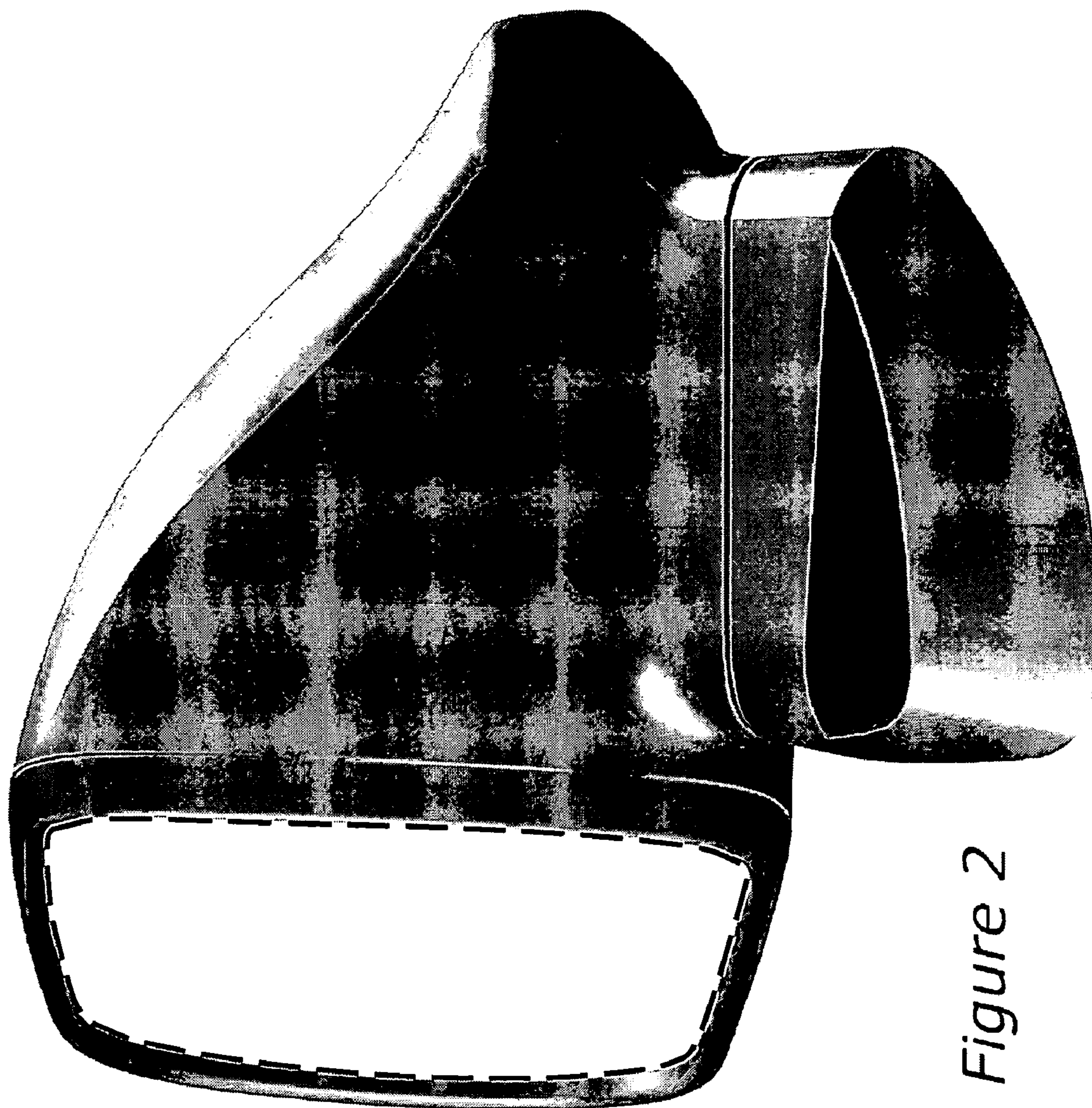

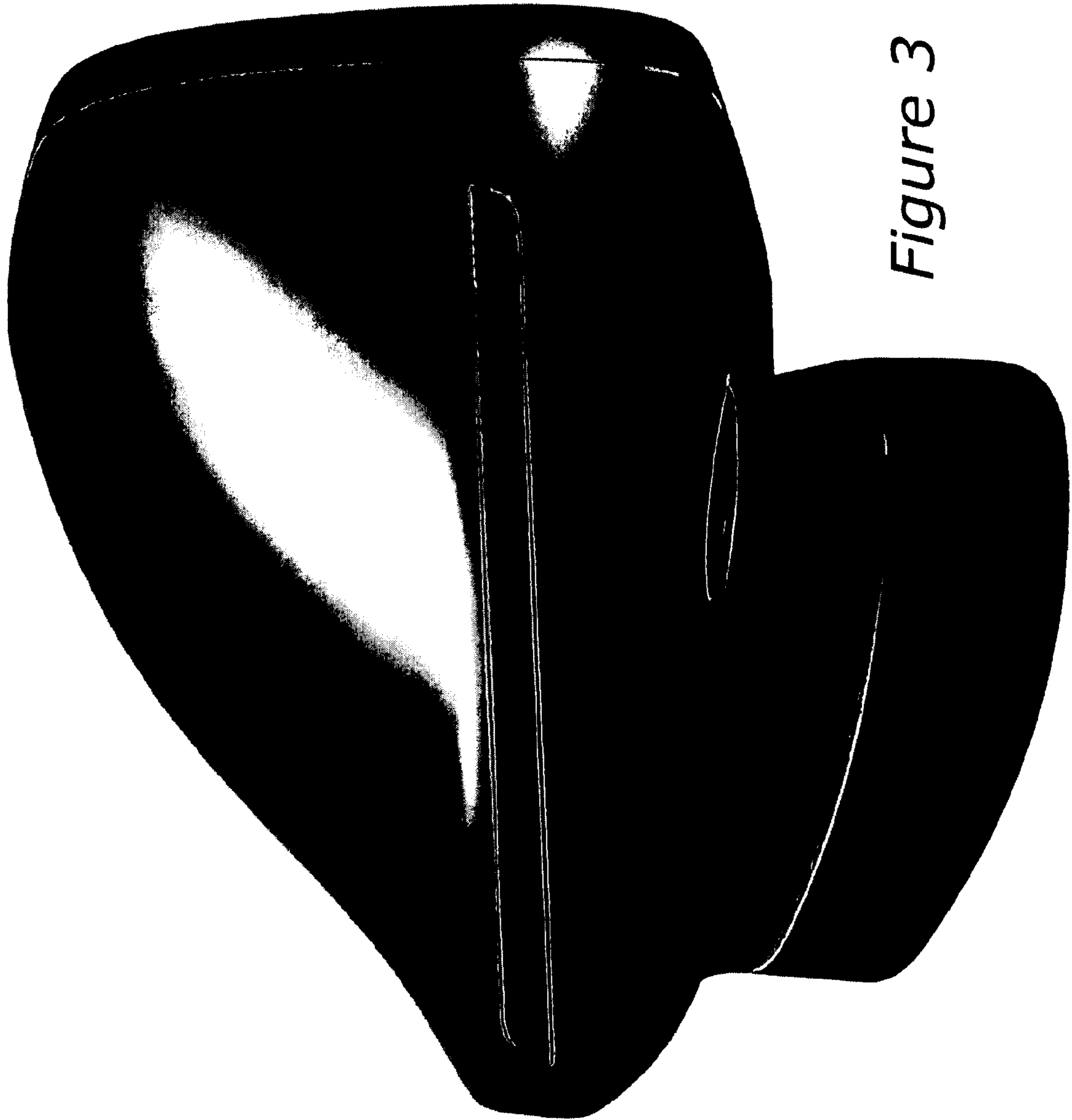

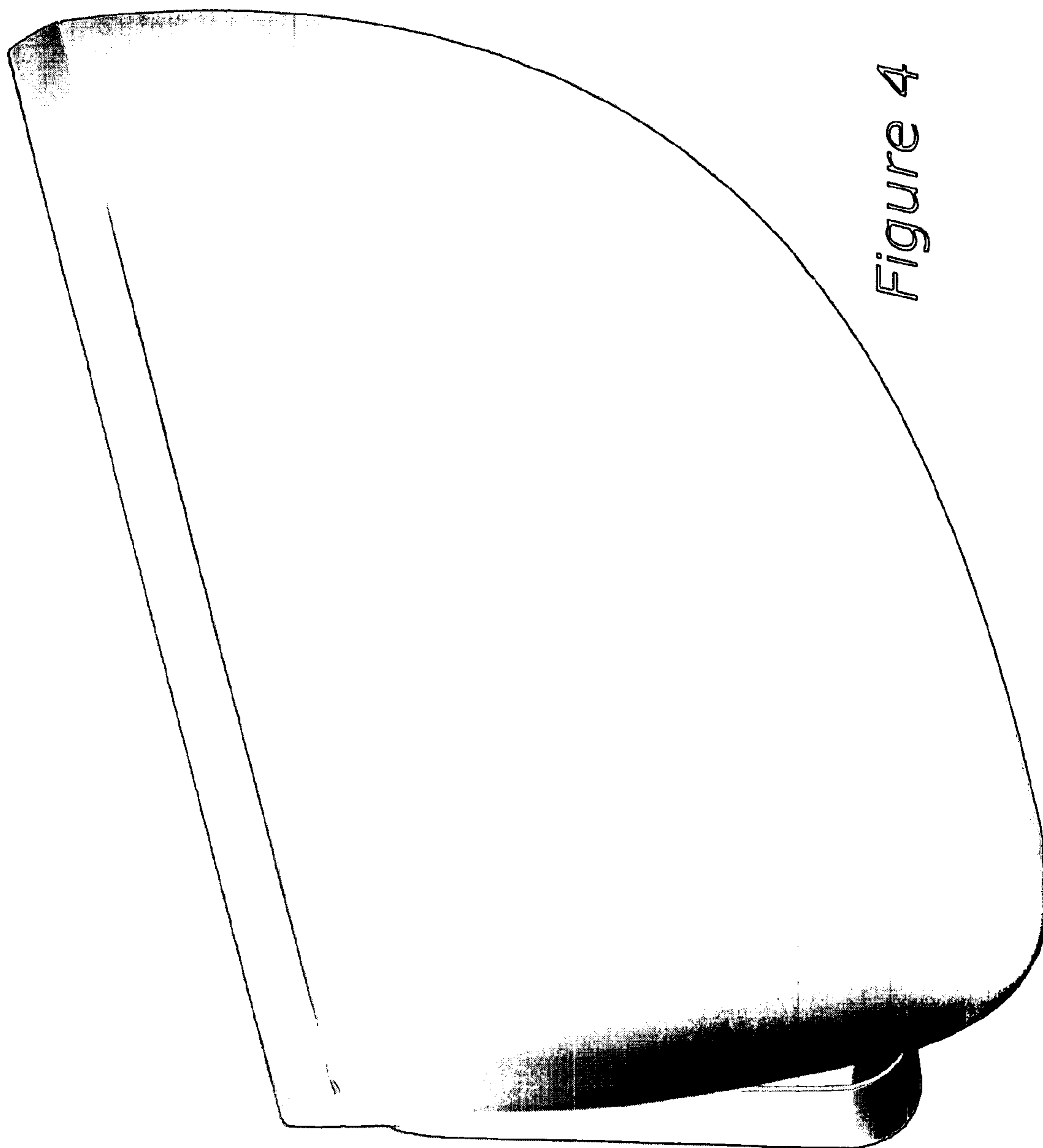

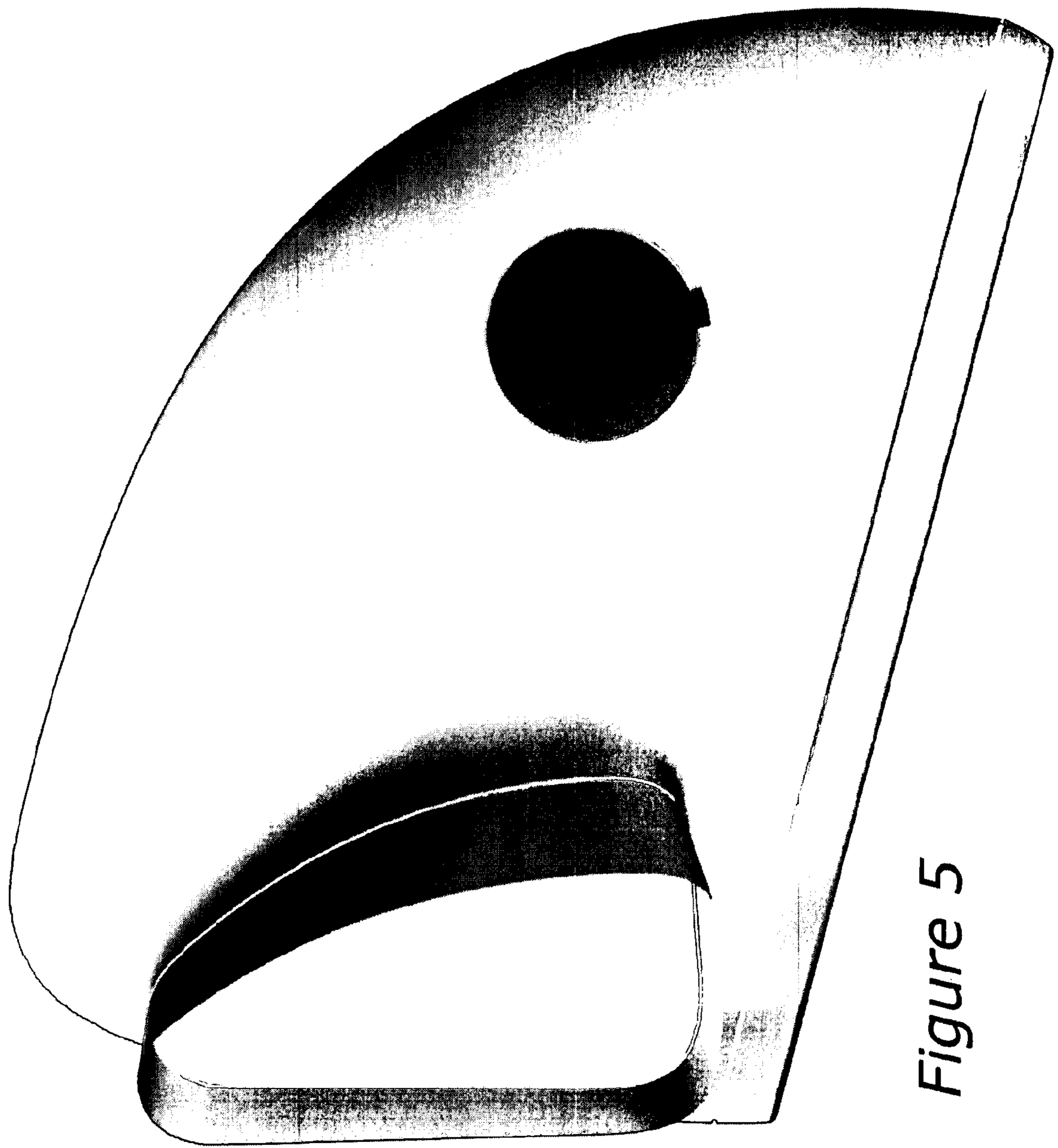

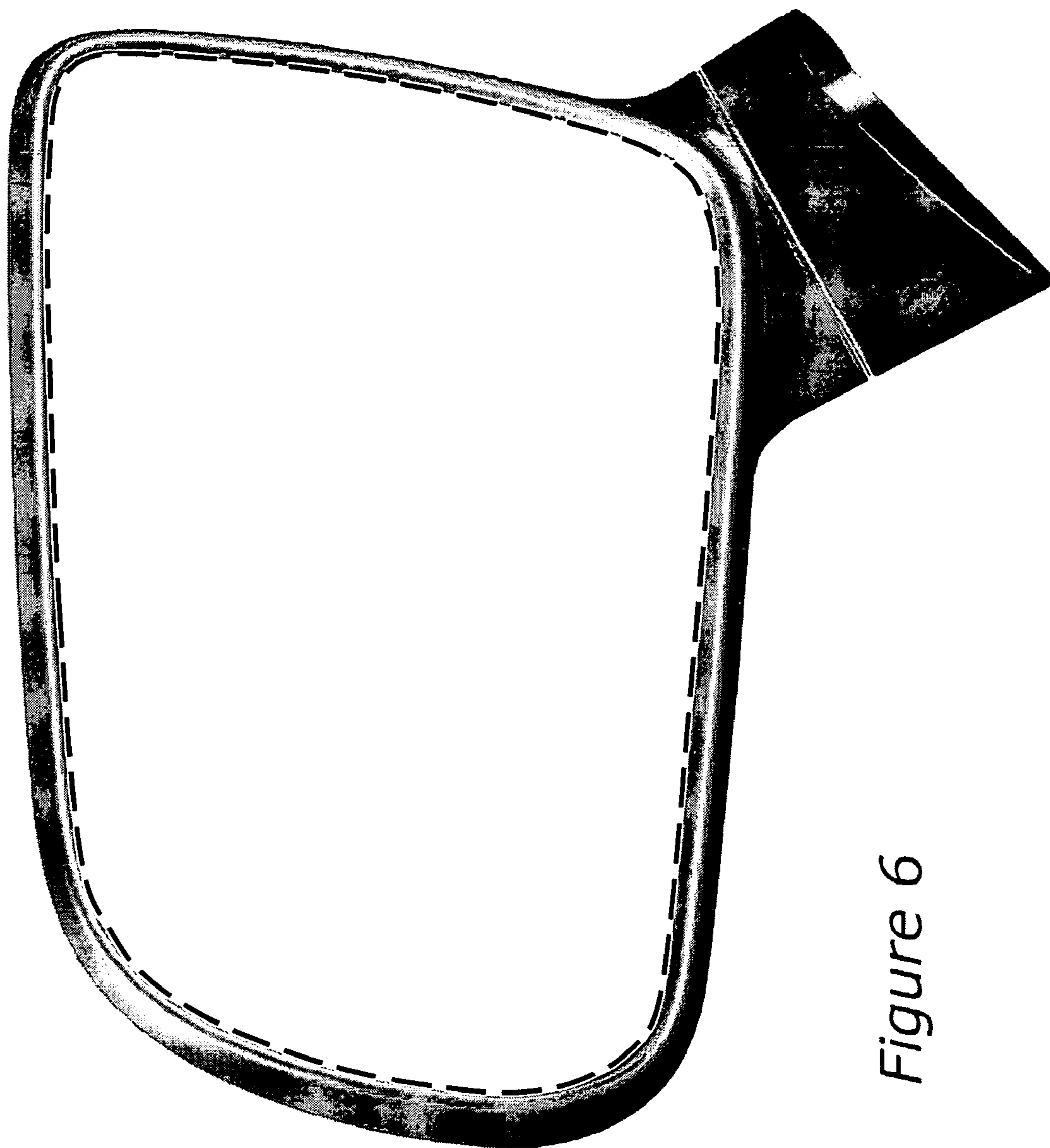

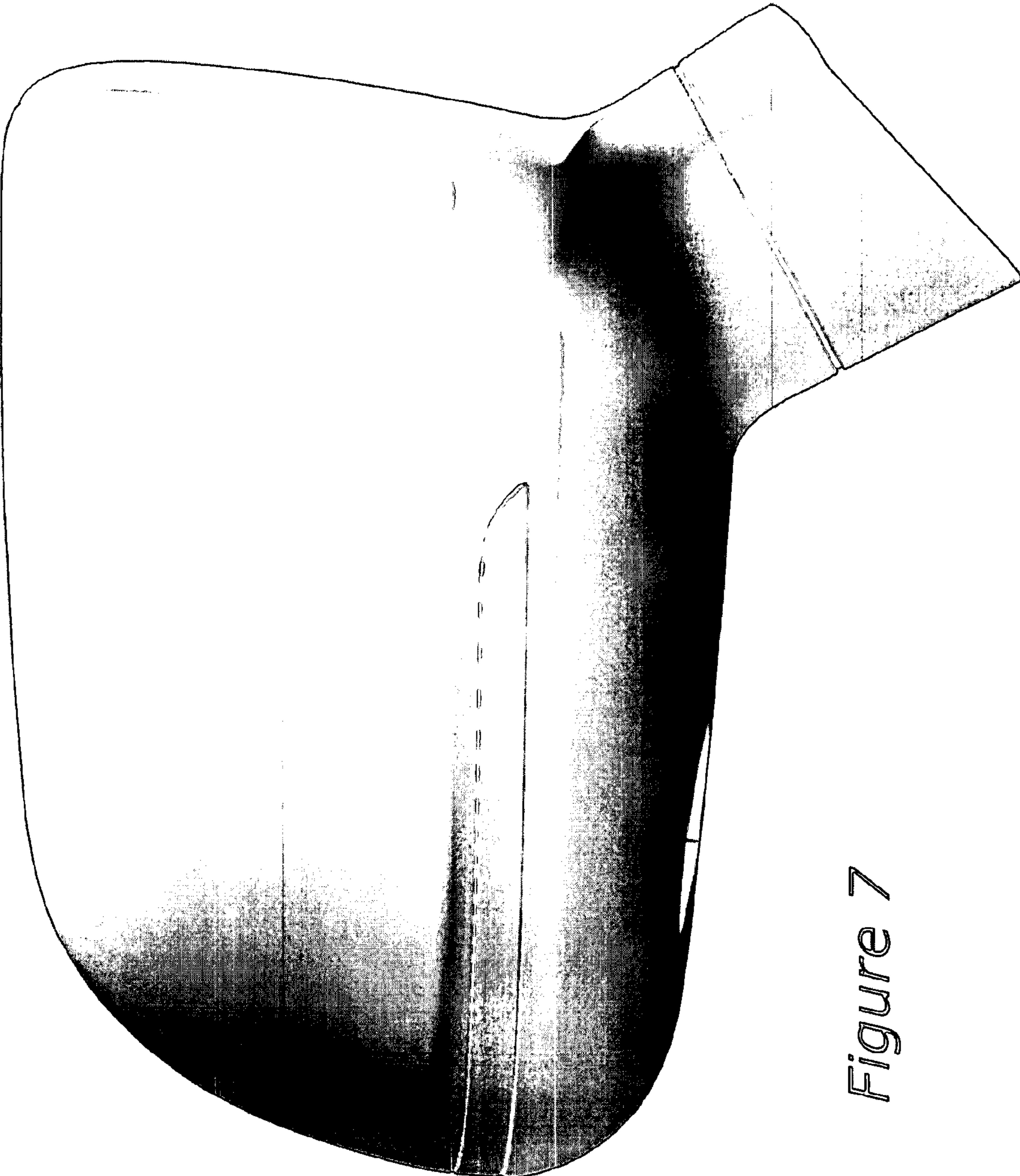

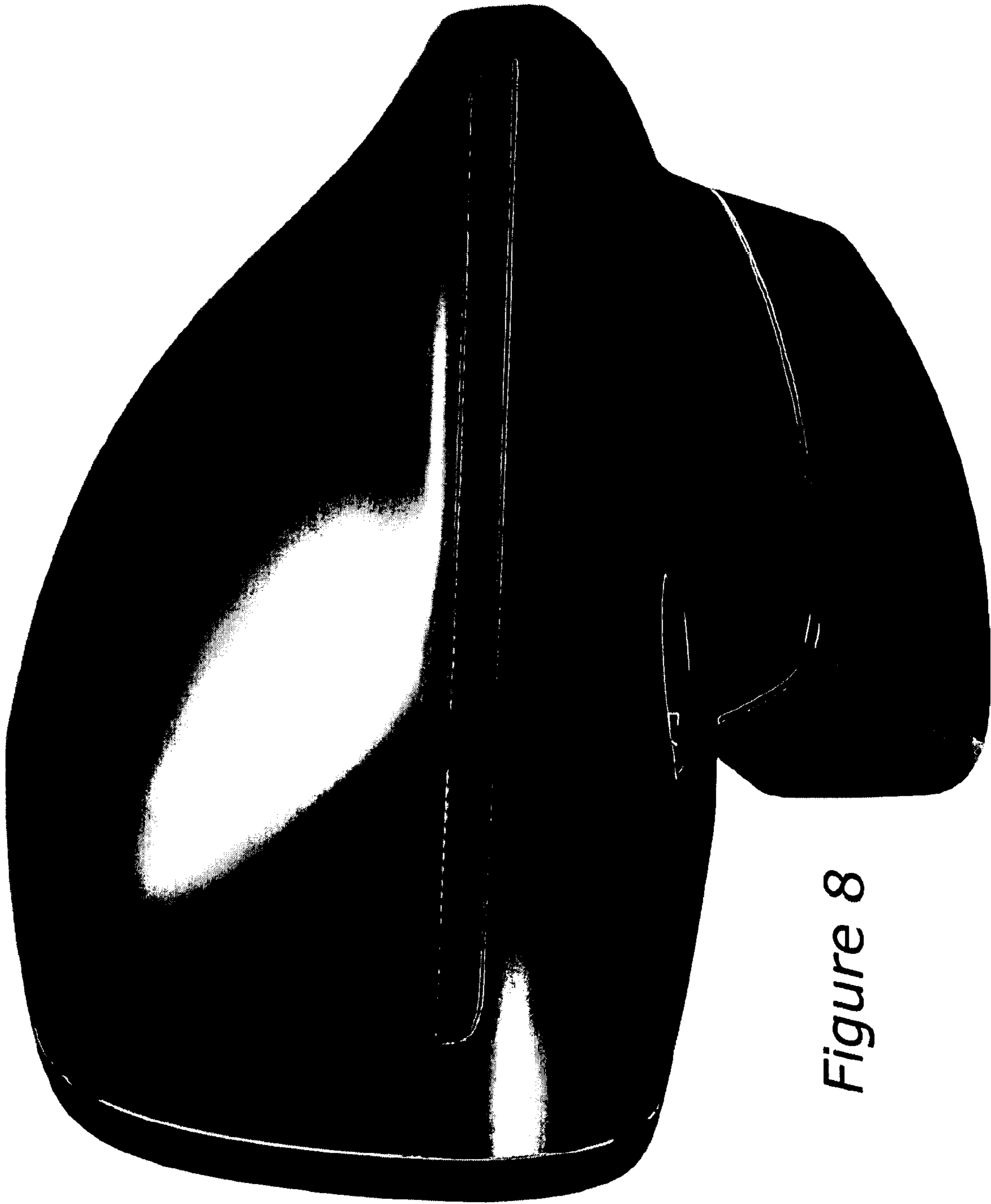

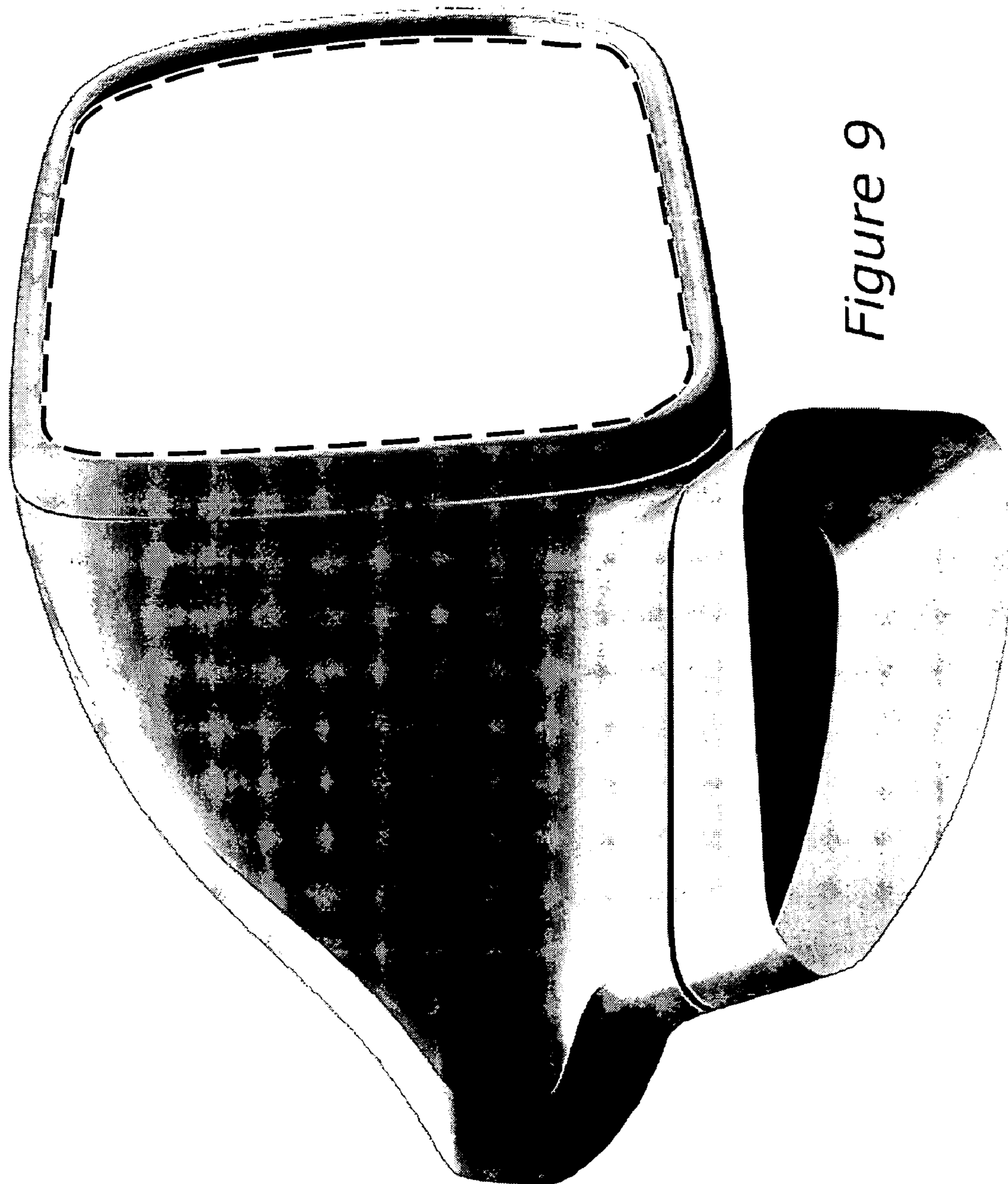

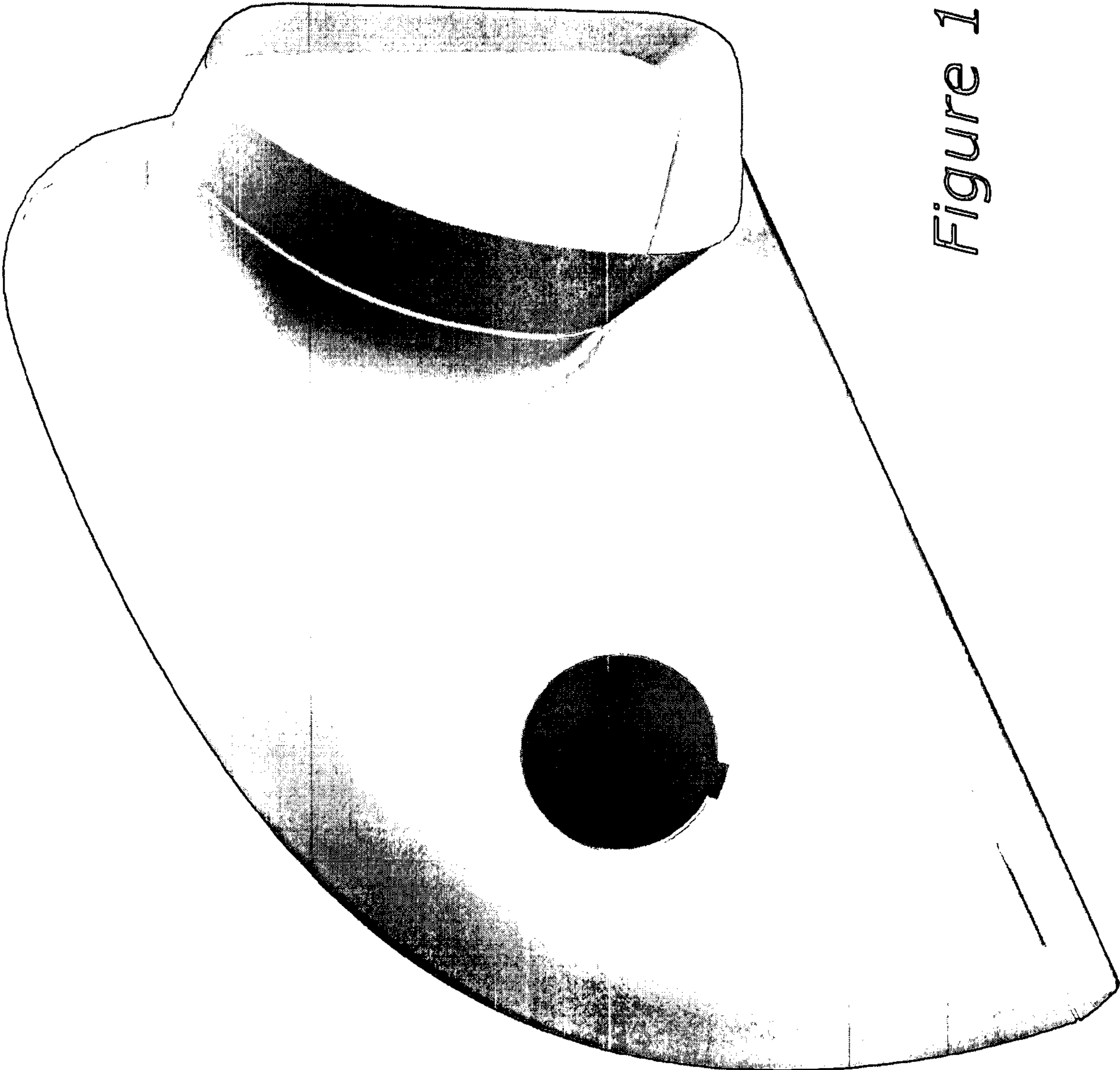

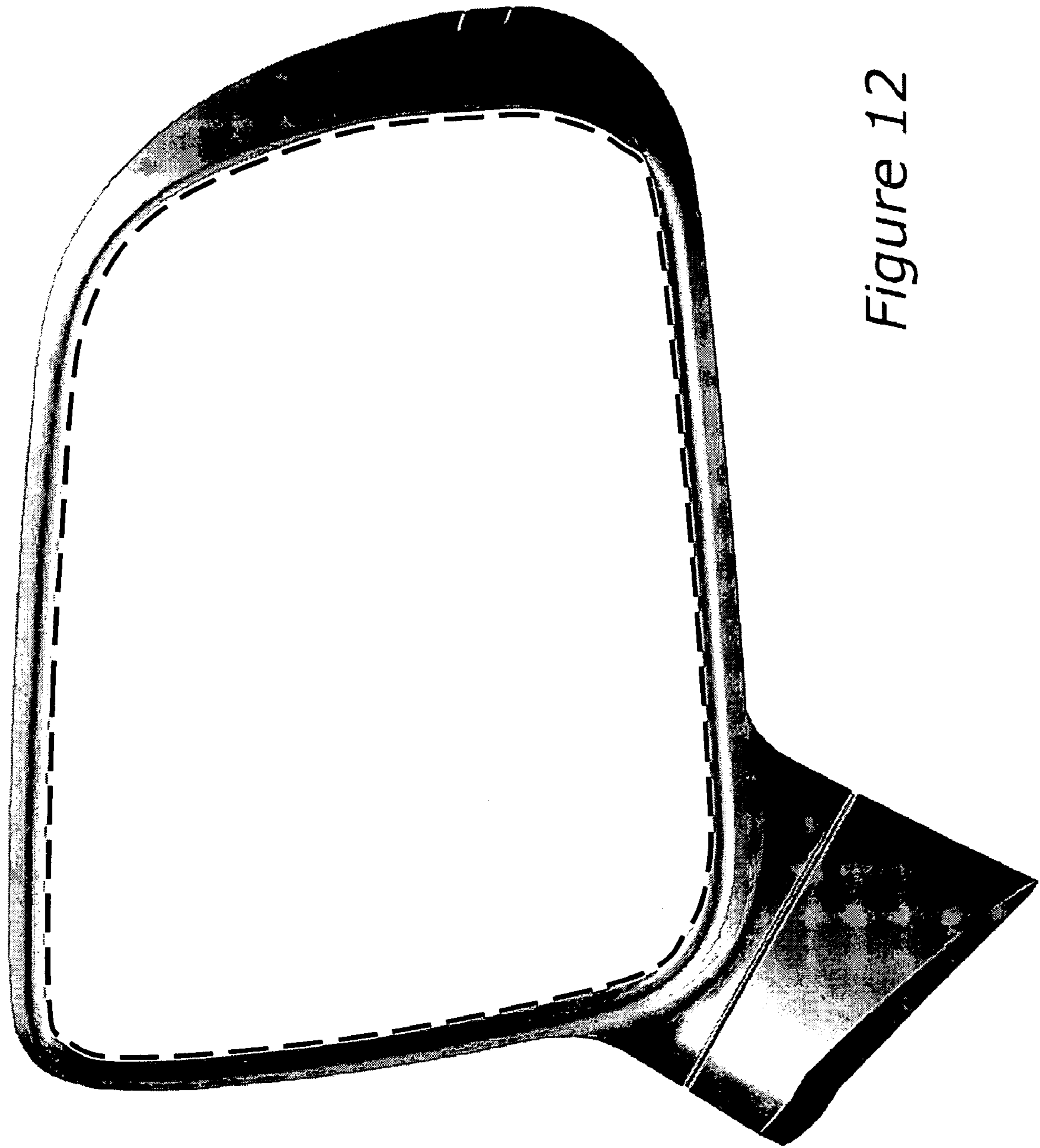
