DESCRIPTION

FIG. 1 is a front left perspective view of a ship cover showing my new design;

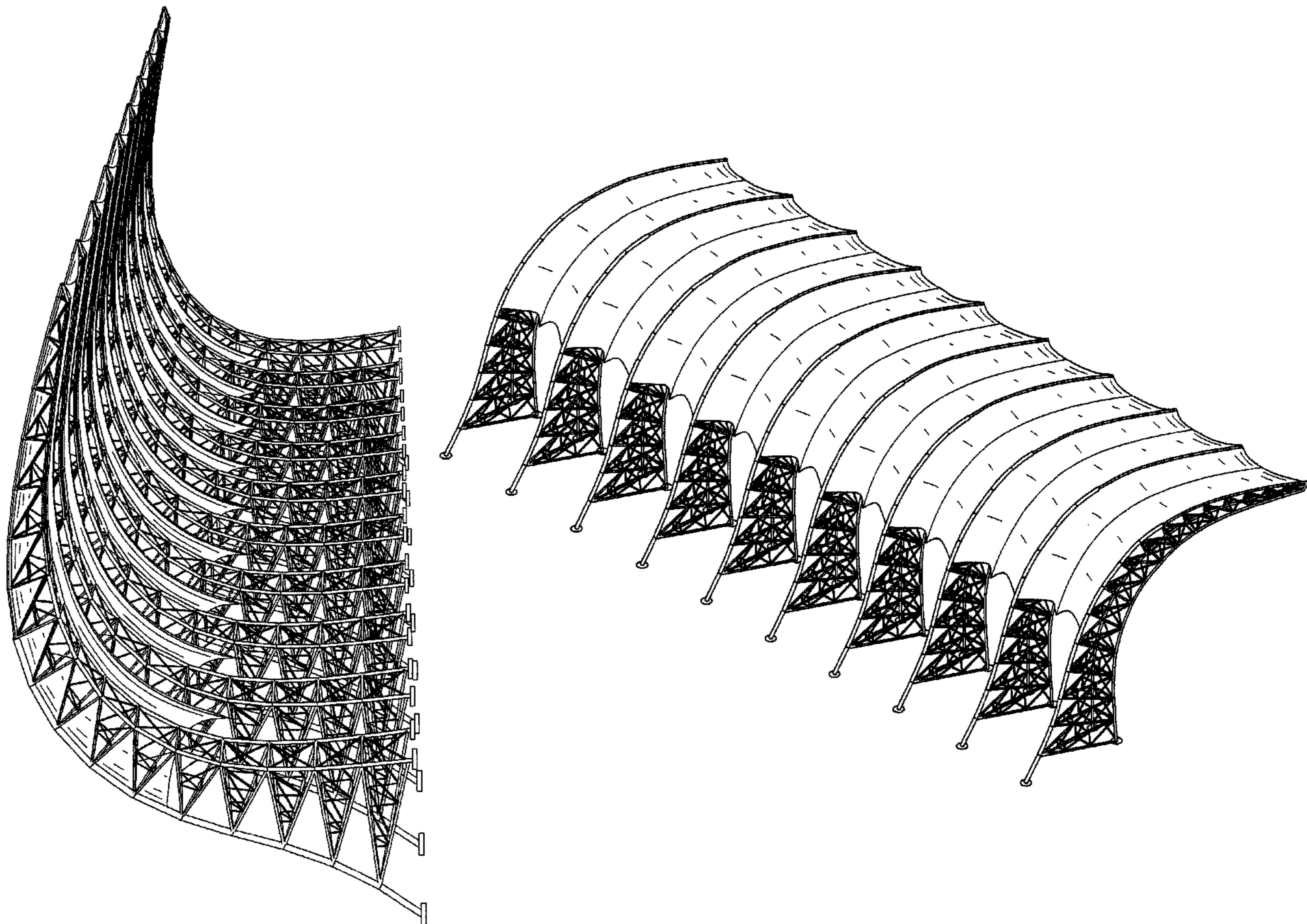
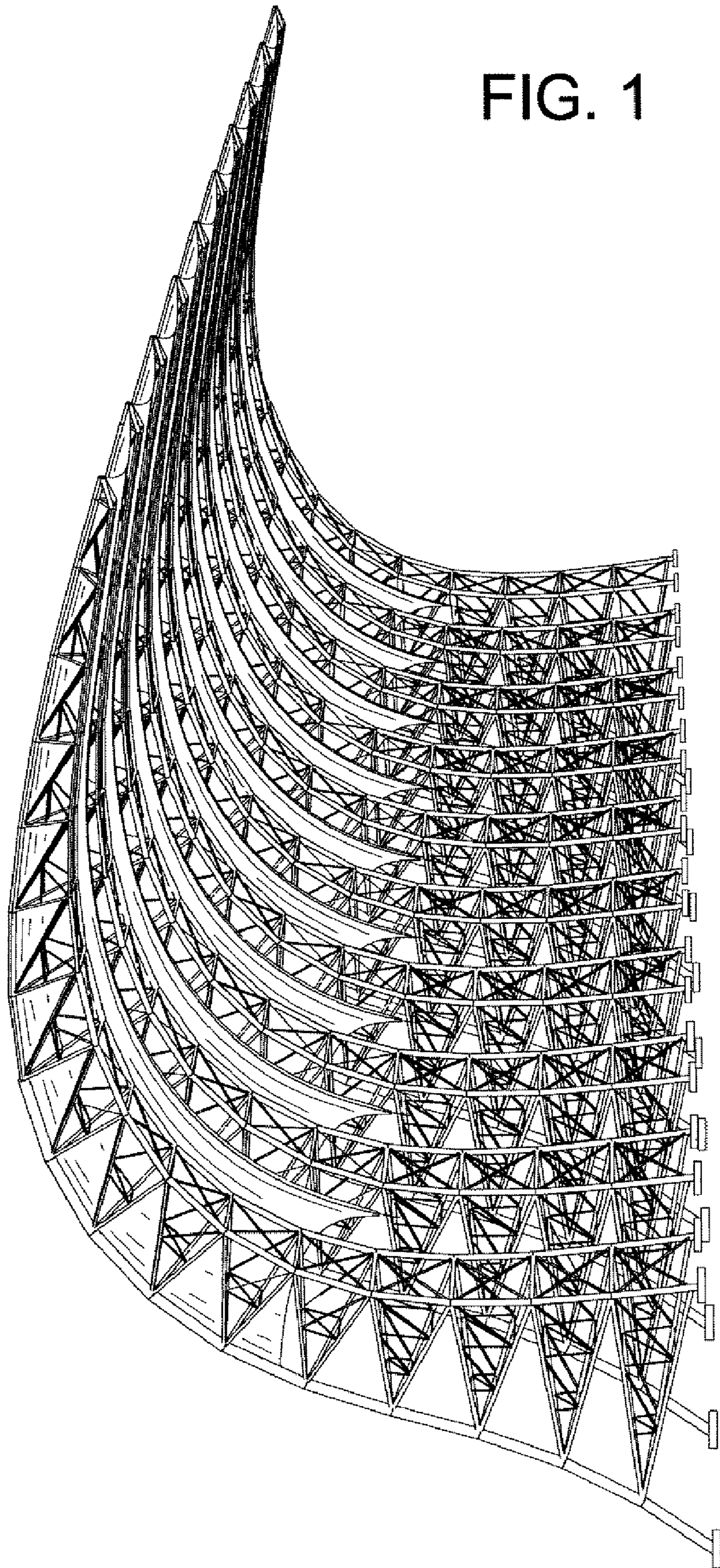

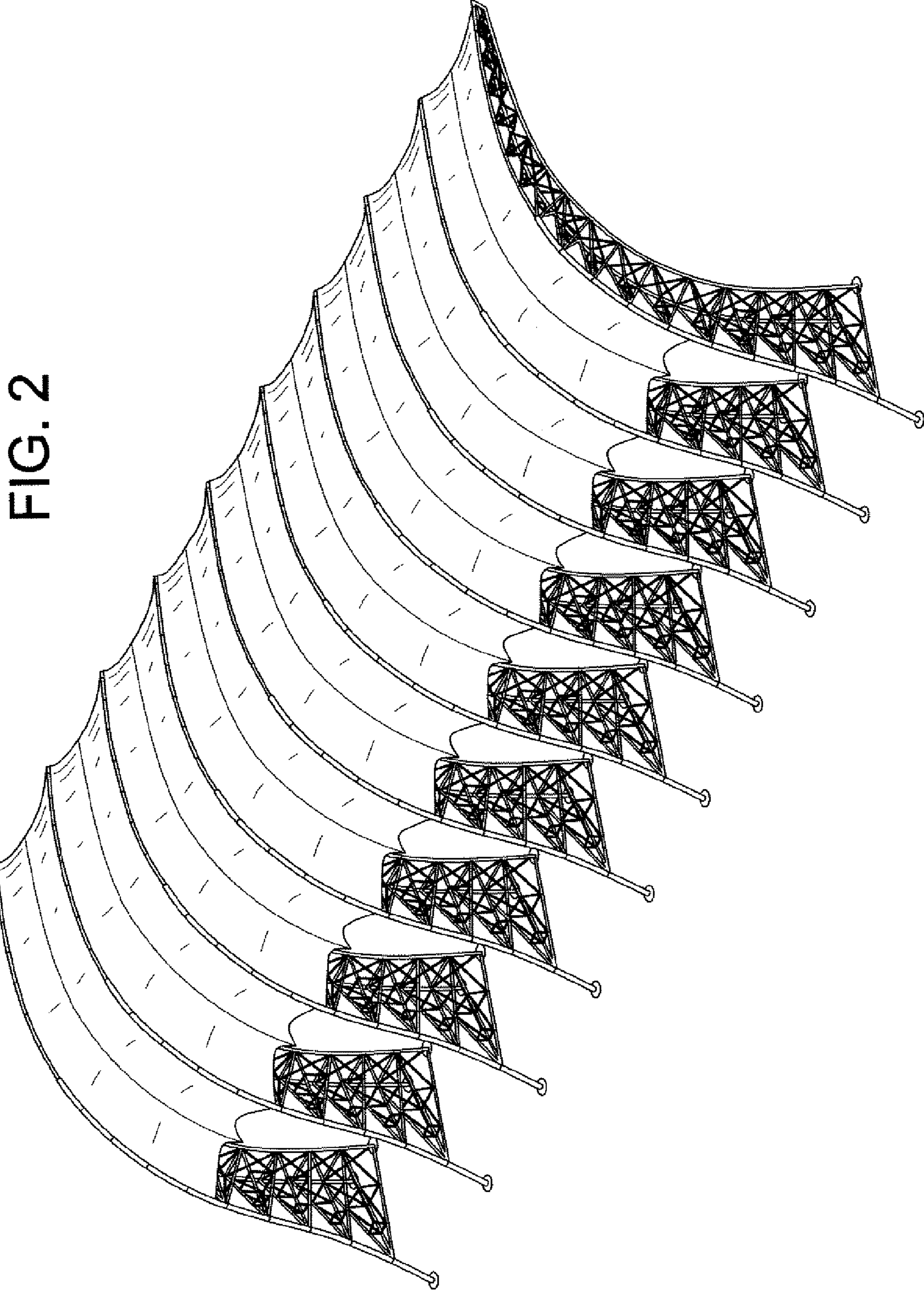

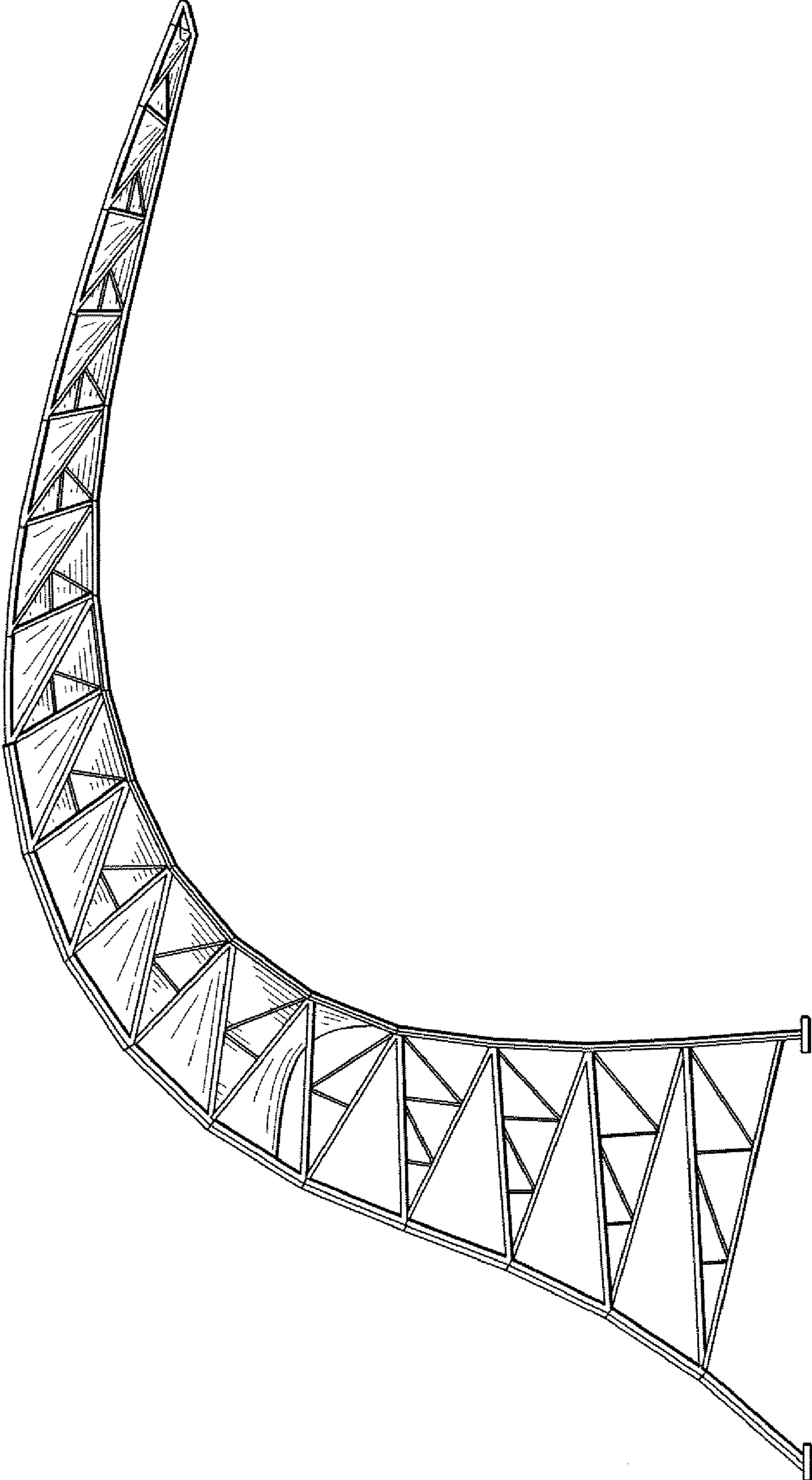

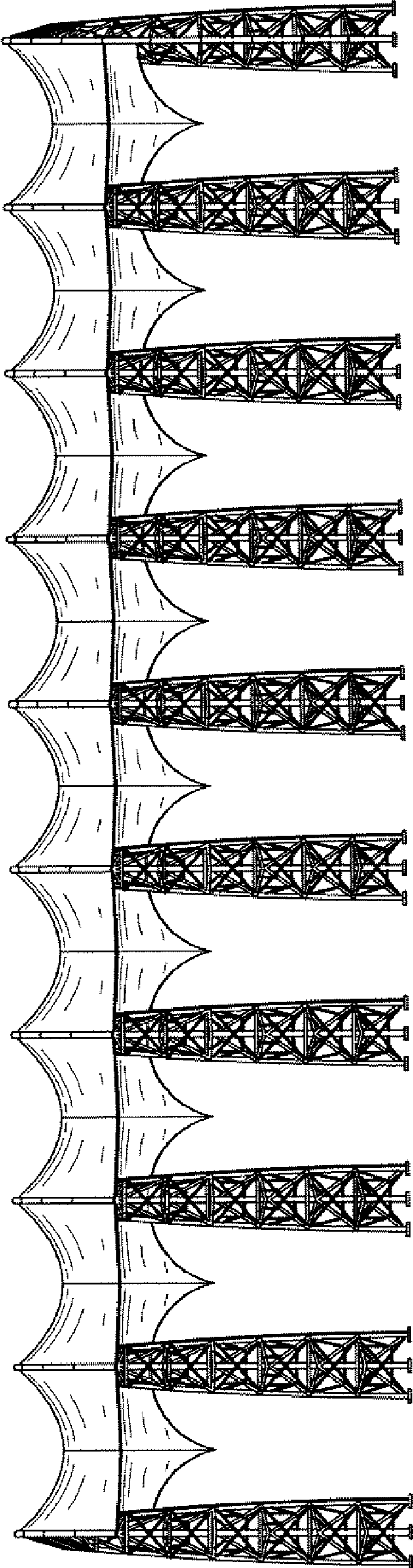

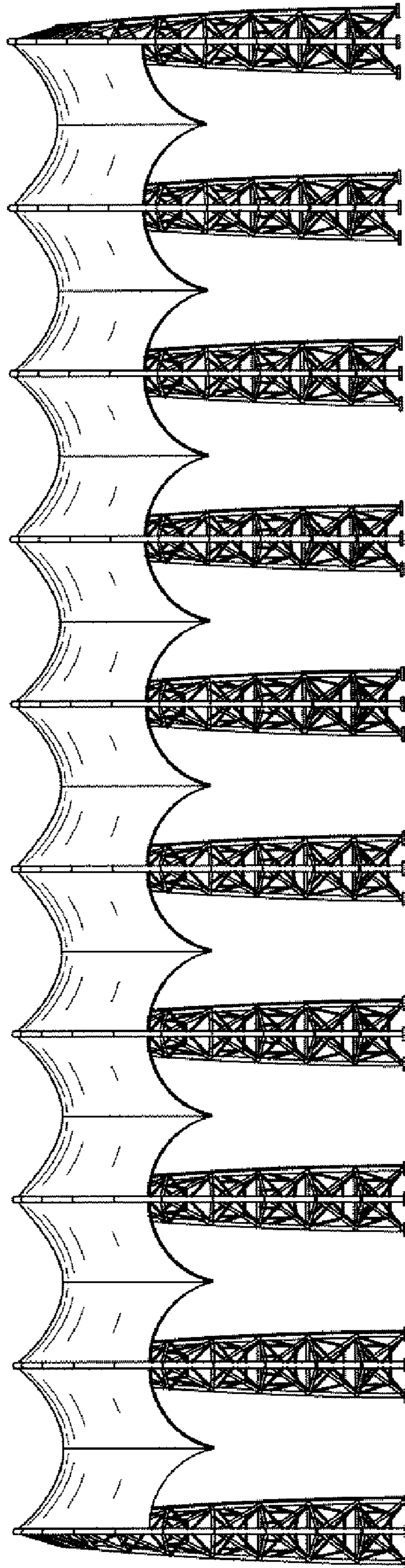

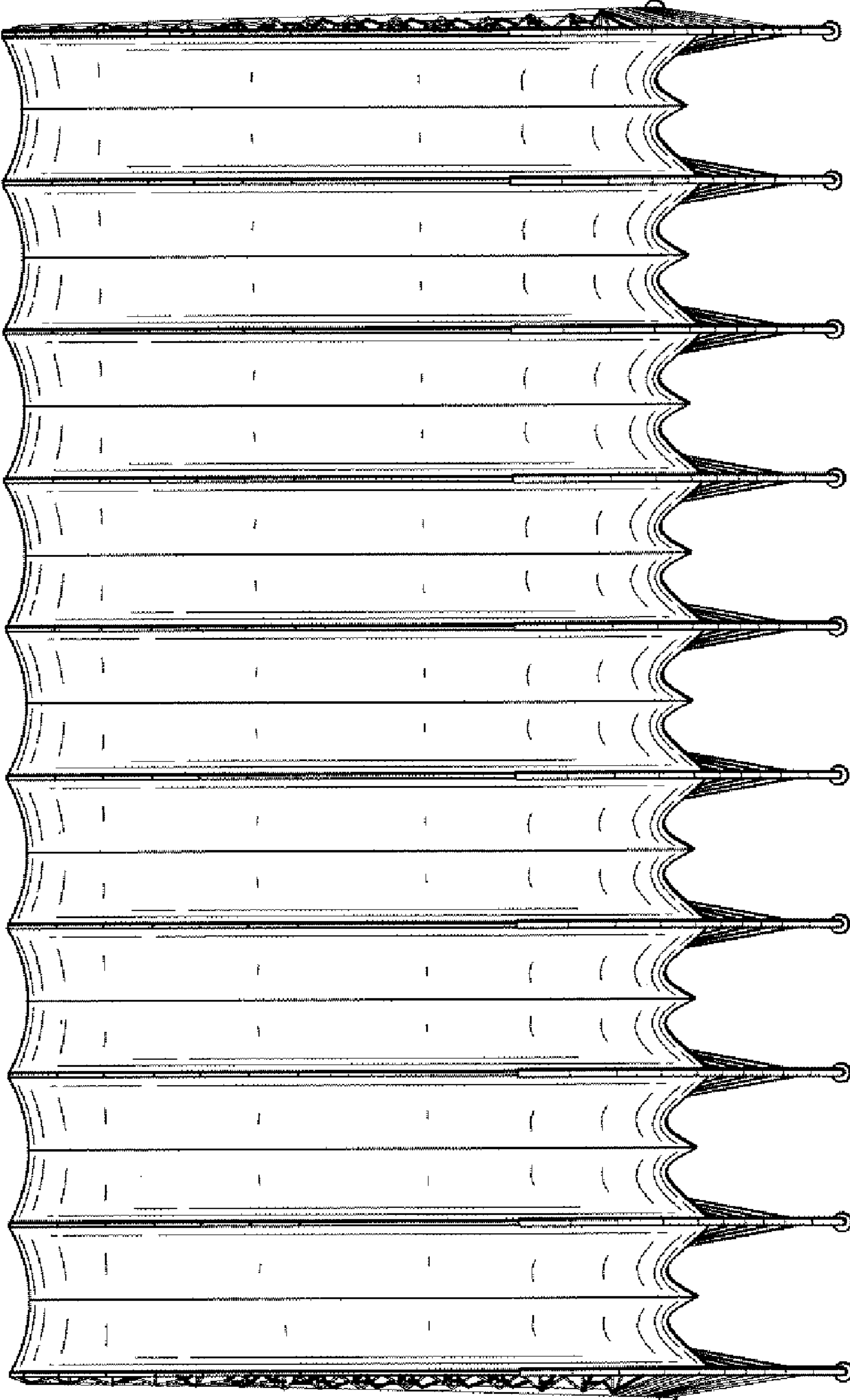
