**DESCRIPTION**

FIG. 1 is a front perspective view of a handset showing my new design;

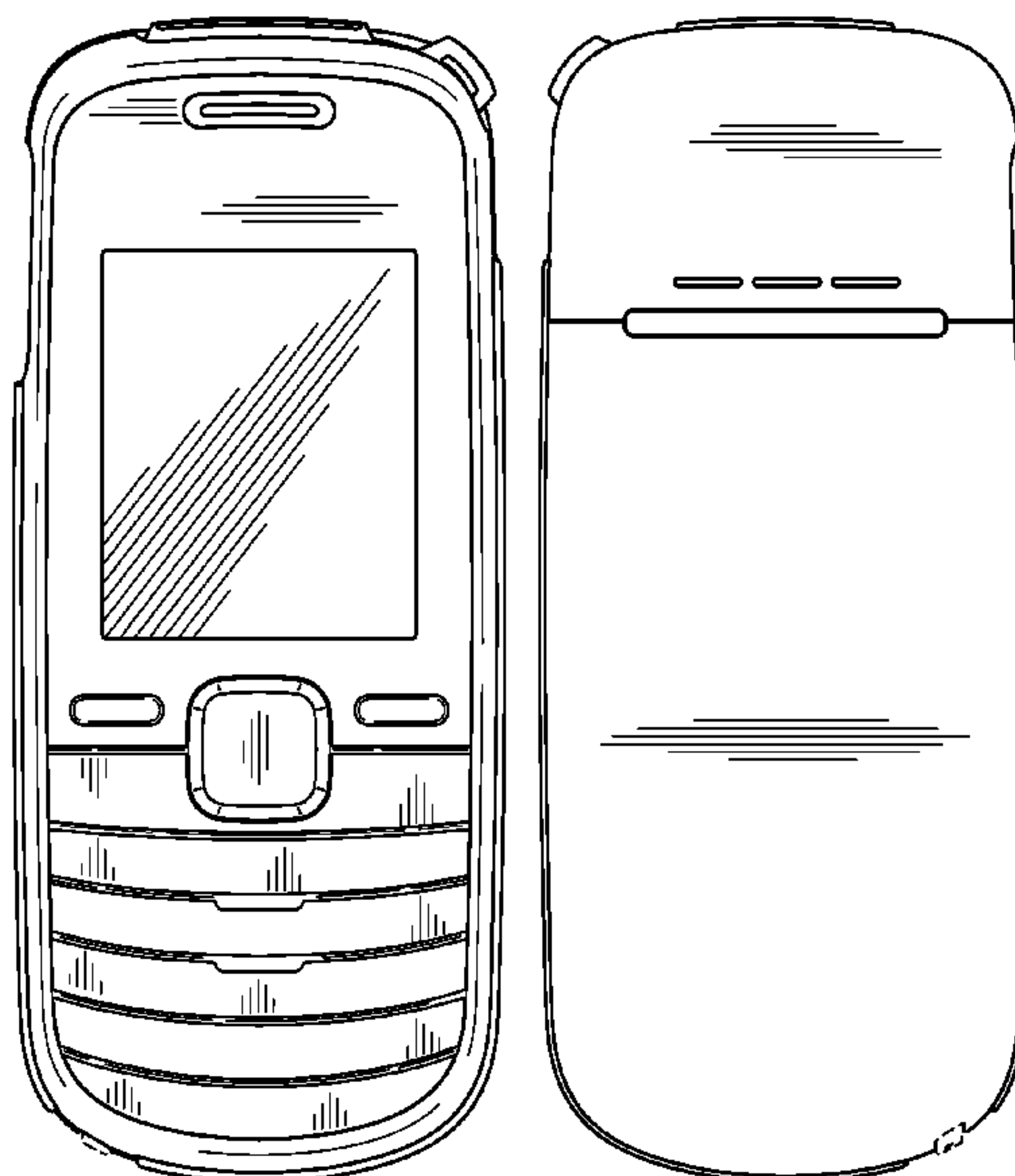

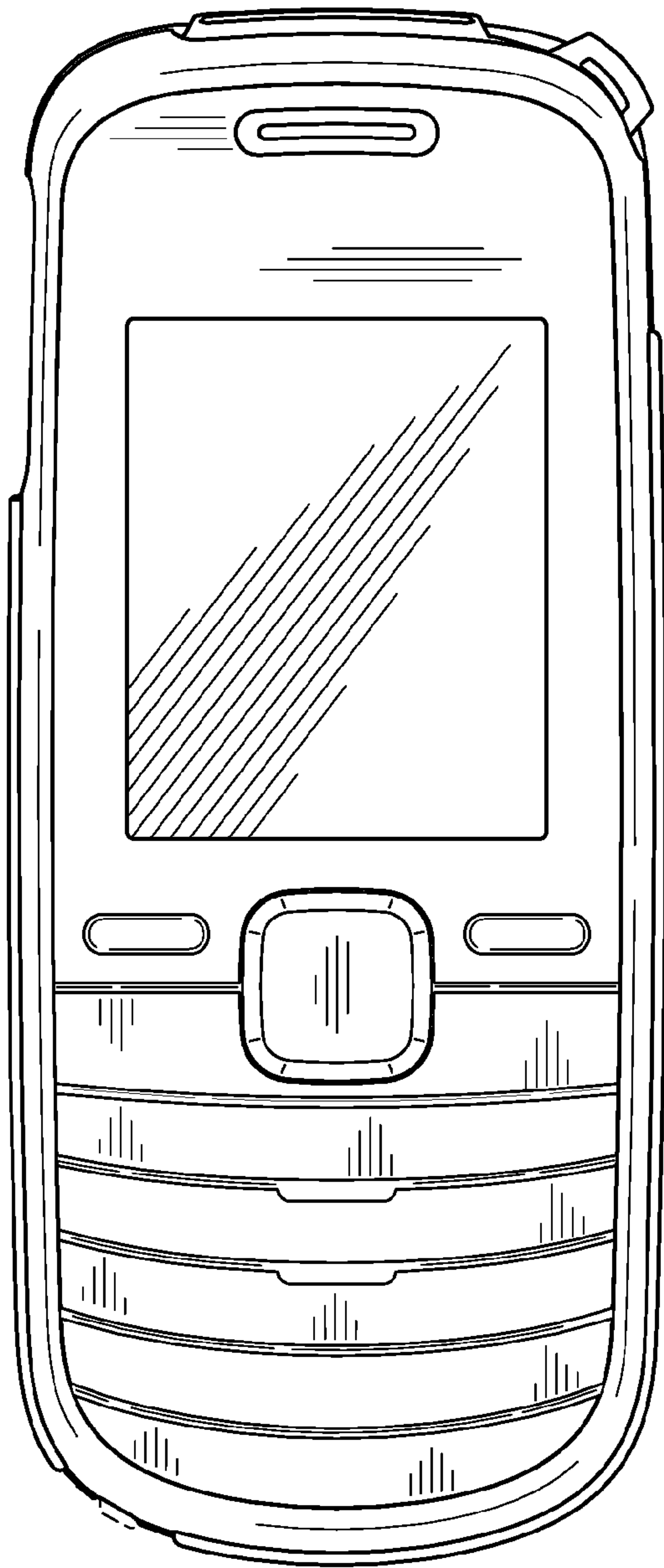

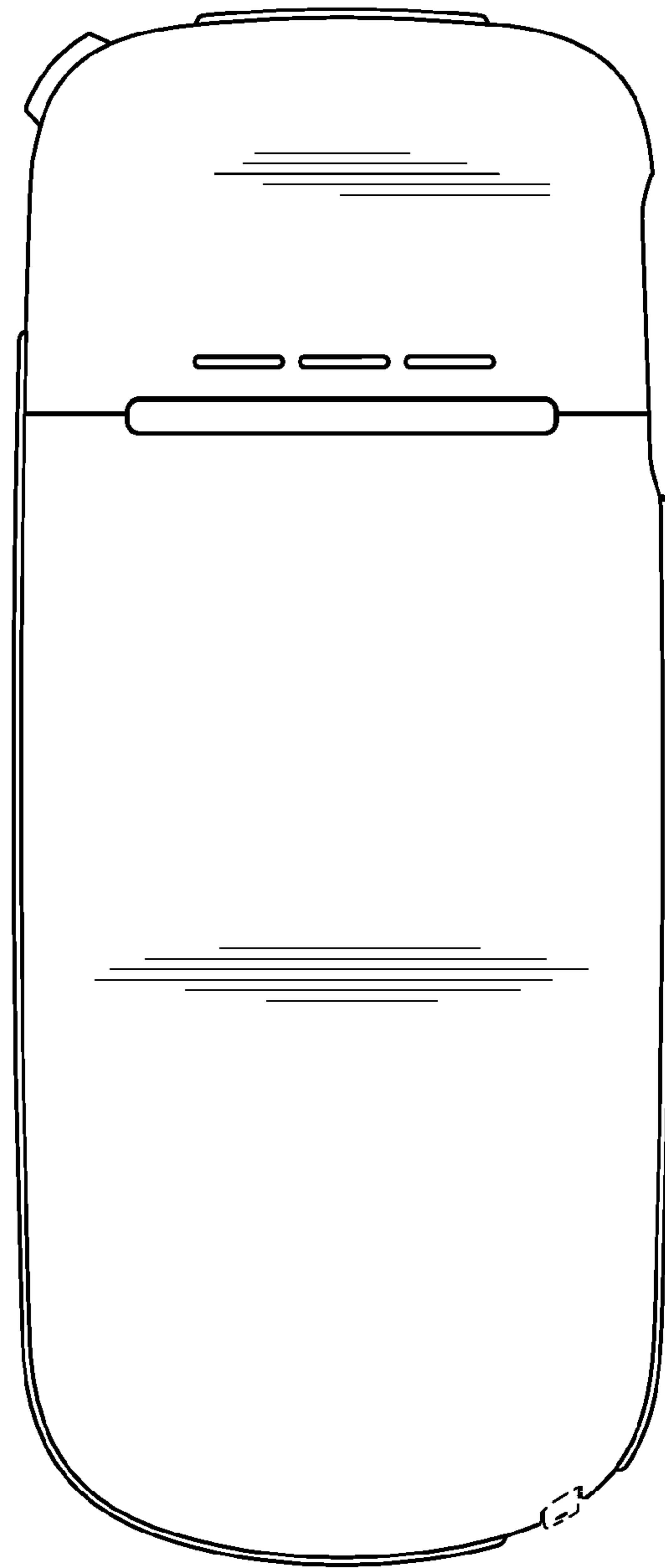

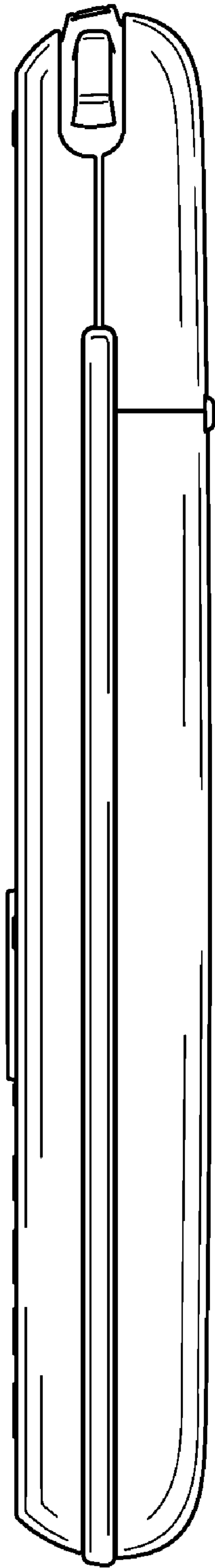

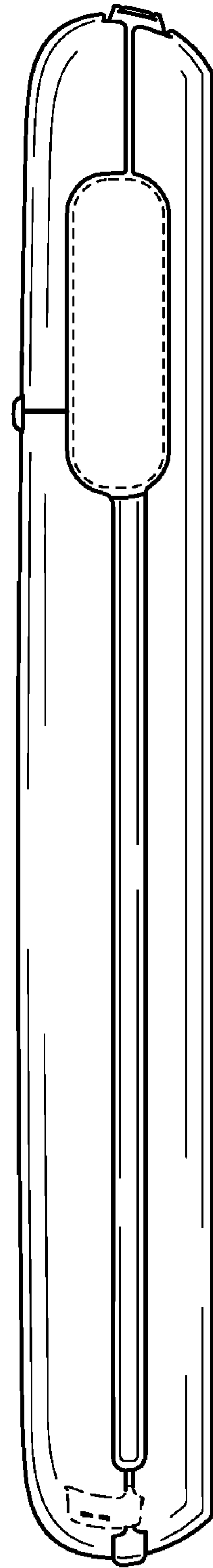
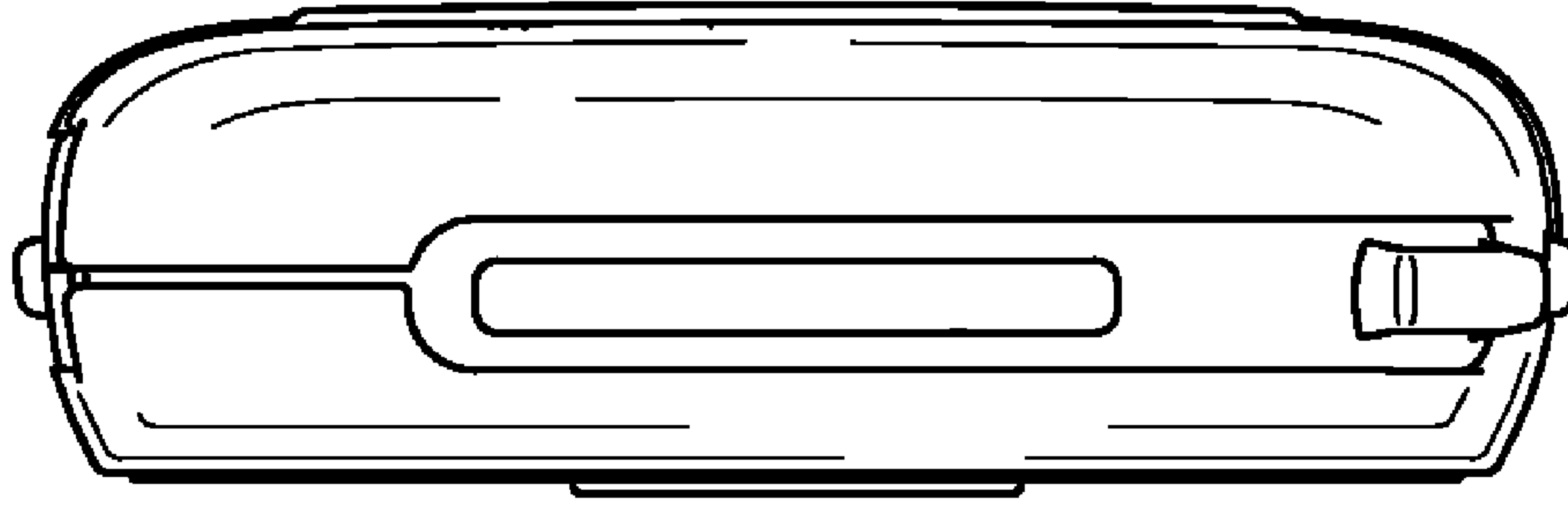
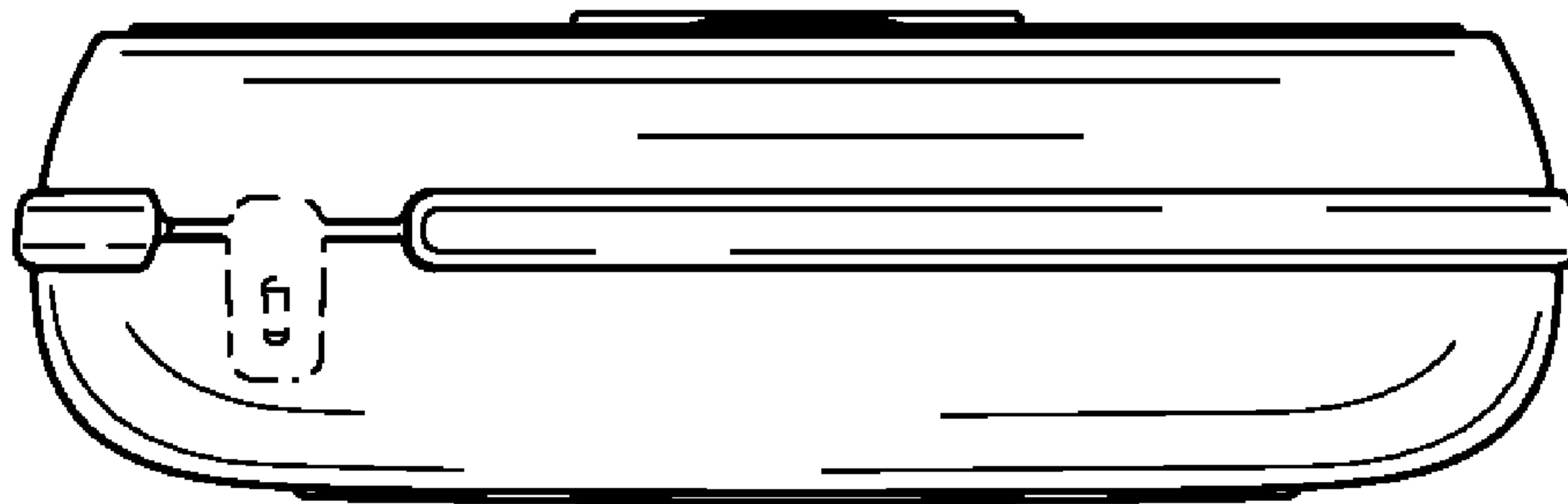
