The ornamental design for a sink with cabinet, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a sink with cabinet showing my new design;

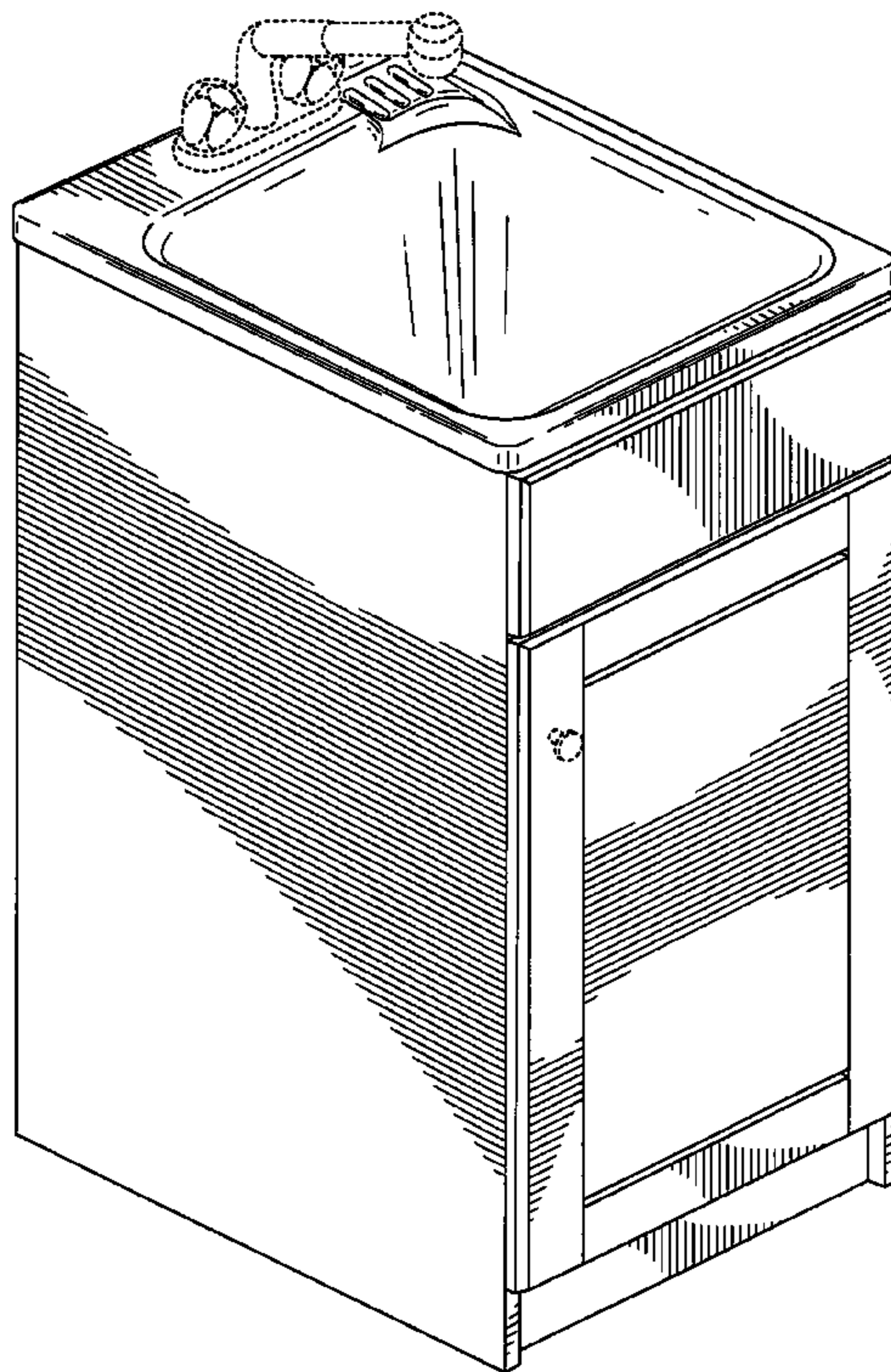
FIG. 2 is a left side elevational view thereof;

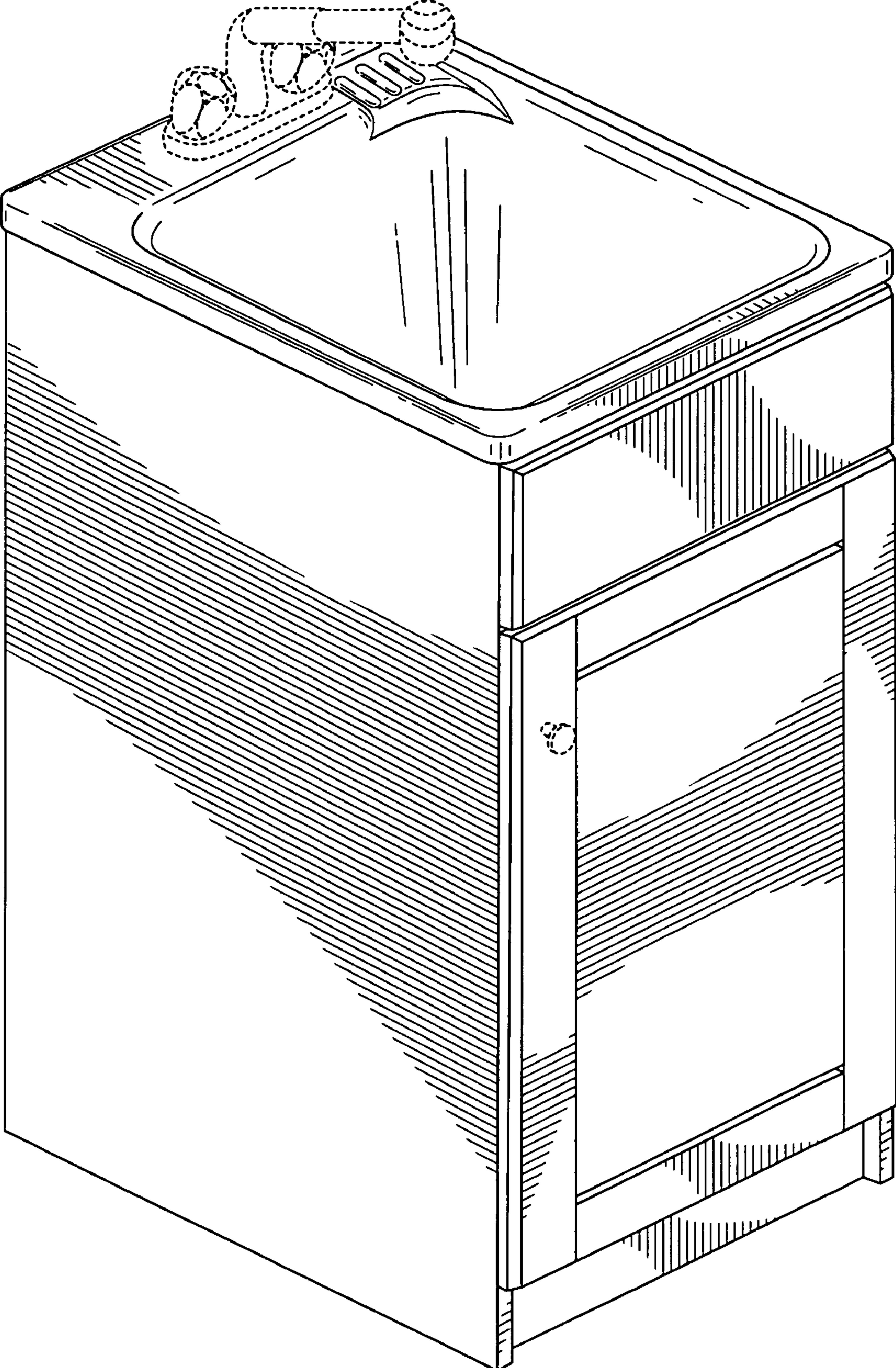

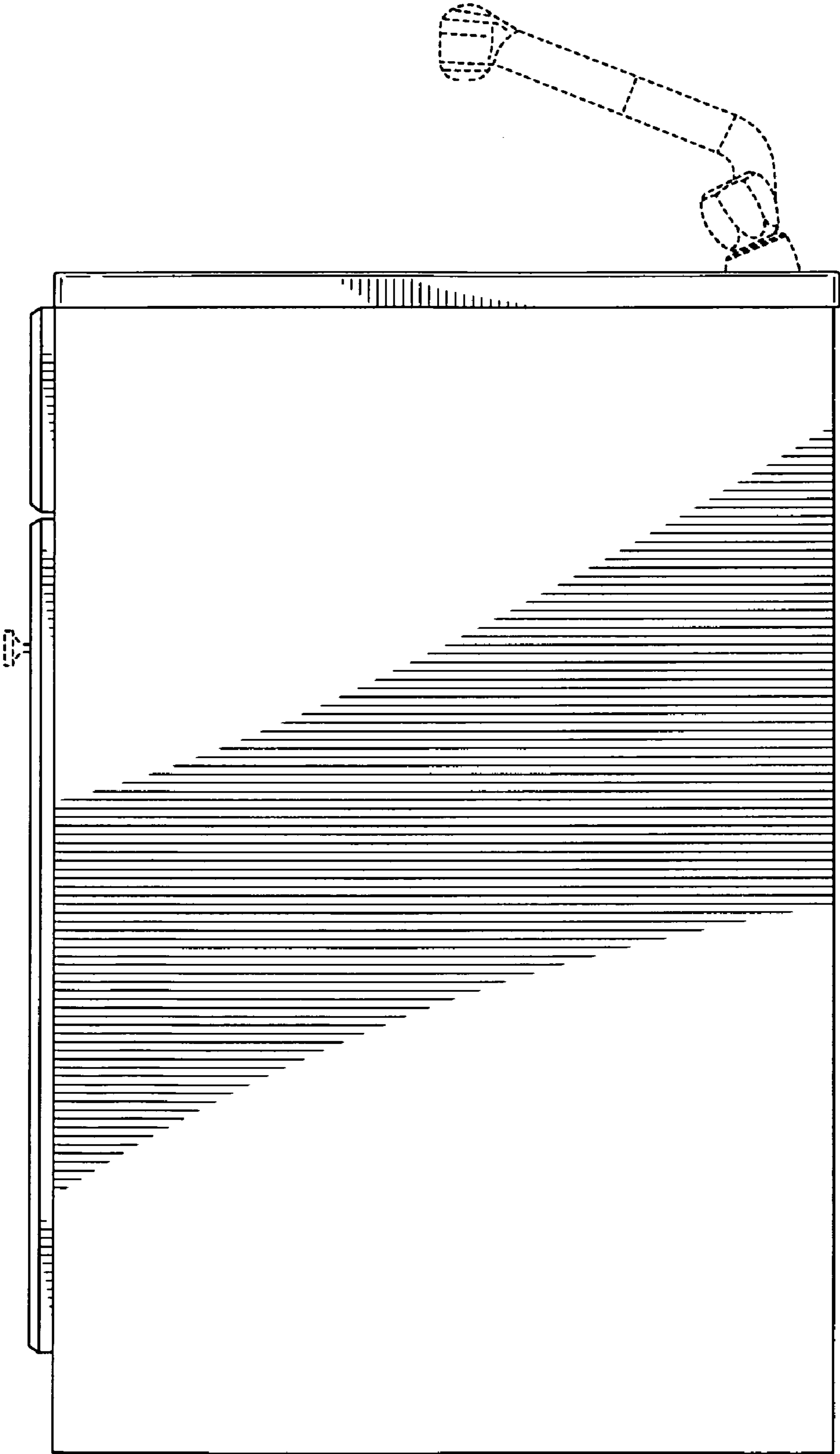

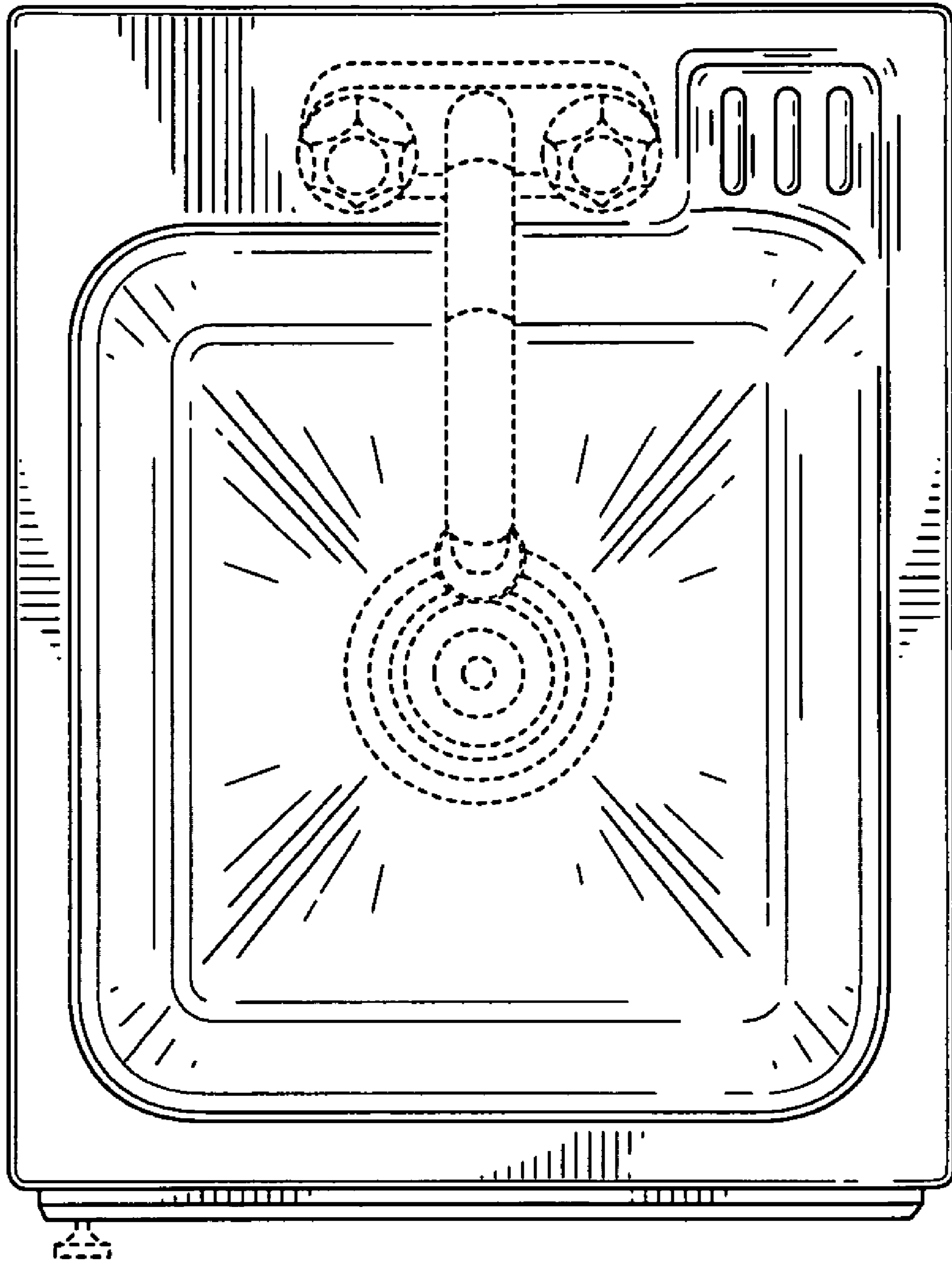

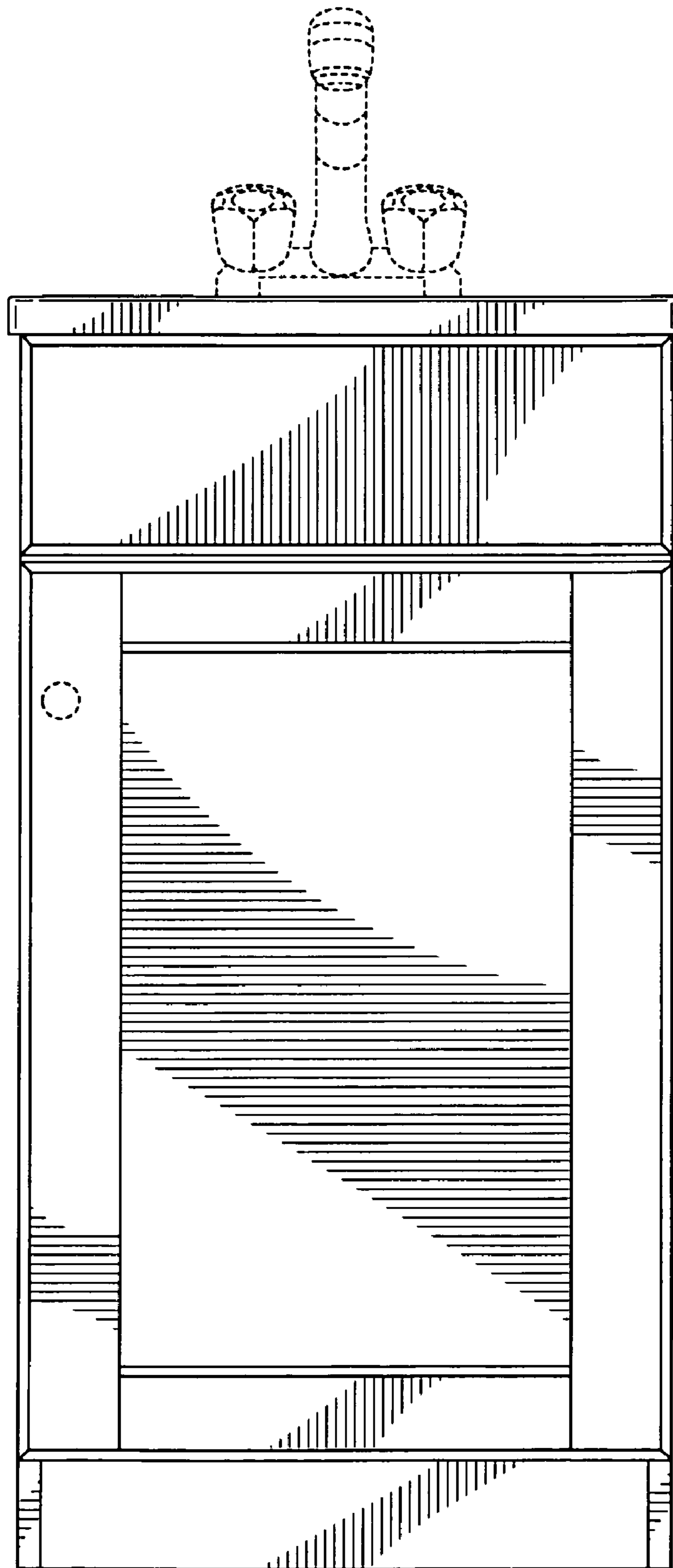
