FIG. 1 is a front perspective view of an insulated wall panel for two floor levels showing my new design;

FIG. 2 is a rear perspective view thereof;

FIG. 3 is an enlarged partial front perspective view, showing top and bottom portions of the wall panel;

FIG. 4 is an enlarged partial front perspective view, showing a middle portion of the wall panel;

FIG. 5 is top plan view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is a left side elevational view thereof;

FIG. 8 is a rear elevational view thereof;

FIG. 9 is a right elevational view thereof; and,

FIG. 10 is a front elevational view thereof.
















