(57) **CLAIM**

The ornamental design for an edible beverage container, as shown and described.

DESCRIPTION

FIG. 1 is a side elevational view of an edible beverage container in accordance with a first embodiment of the design, wherein each side of the first embodiment is the view shown in FIG. 1;

FIG. 2 is a top elevational view of the edible beverage container in accordance with the first embodiment of the design;

FIG. 3 is a perspective view of the edible beverage container in accordance with the first embodiment;

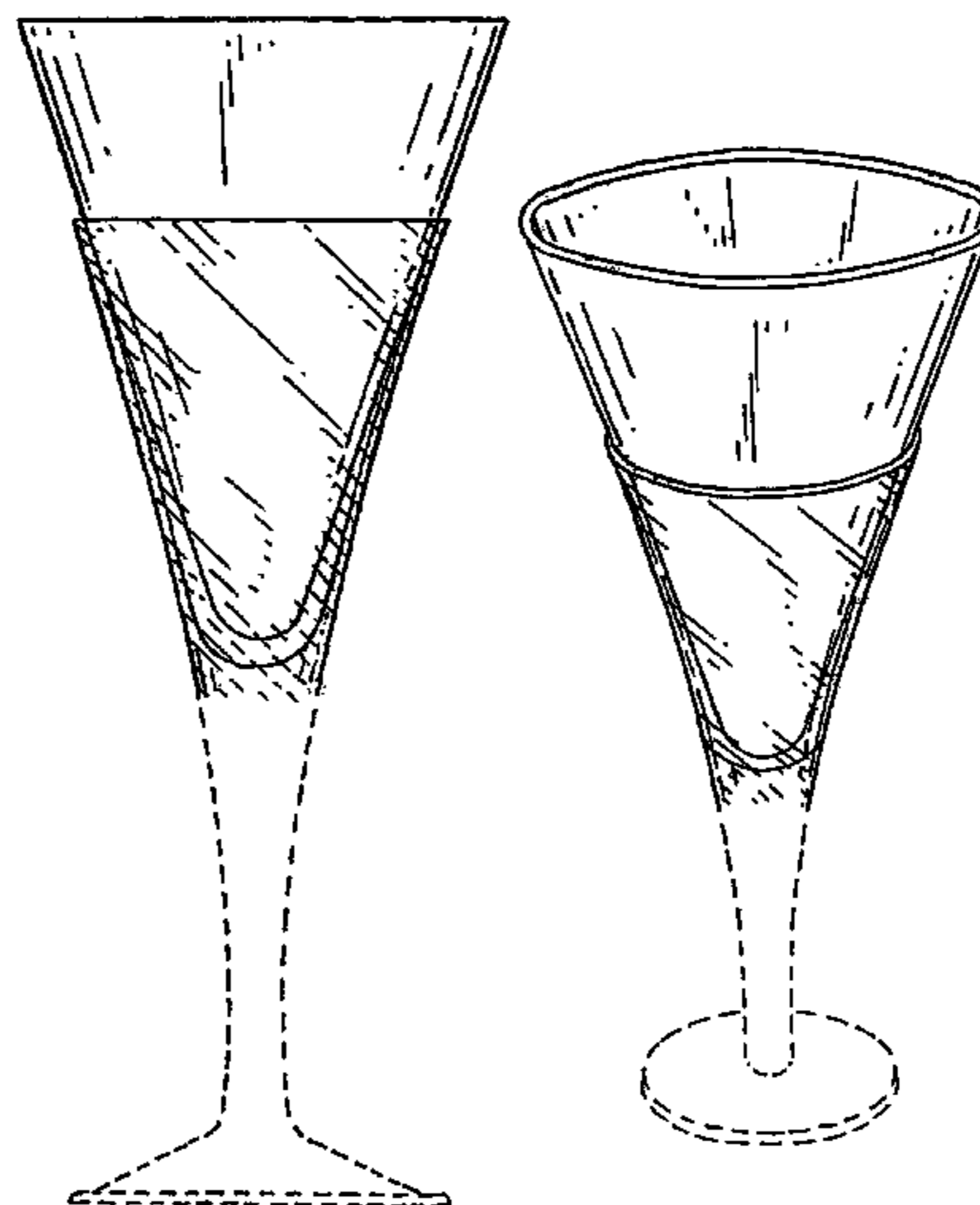
FIG. 4 is a side elevational view of the edible beverage container in accordance with a second embodiment of the design, wherein each side of the second embodiment is the view shown in FIG. 1;

FIG. 5 is a top elevational view of the edible beverage container in accordance with the second embodiment of the design; and,

FIG. 6 is a perspective view of the edible beverage container in accordance with the second embodiment.

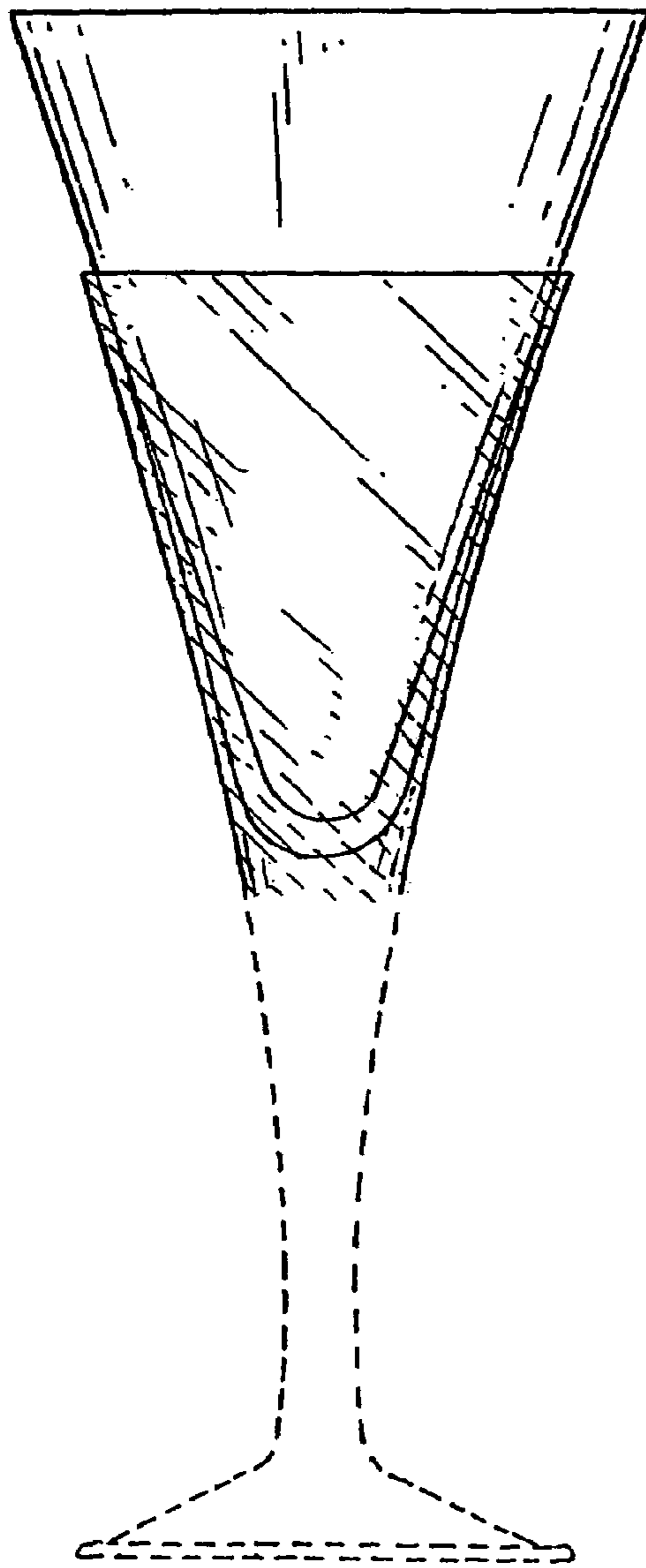

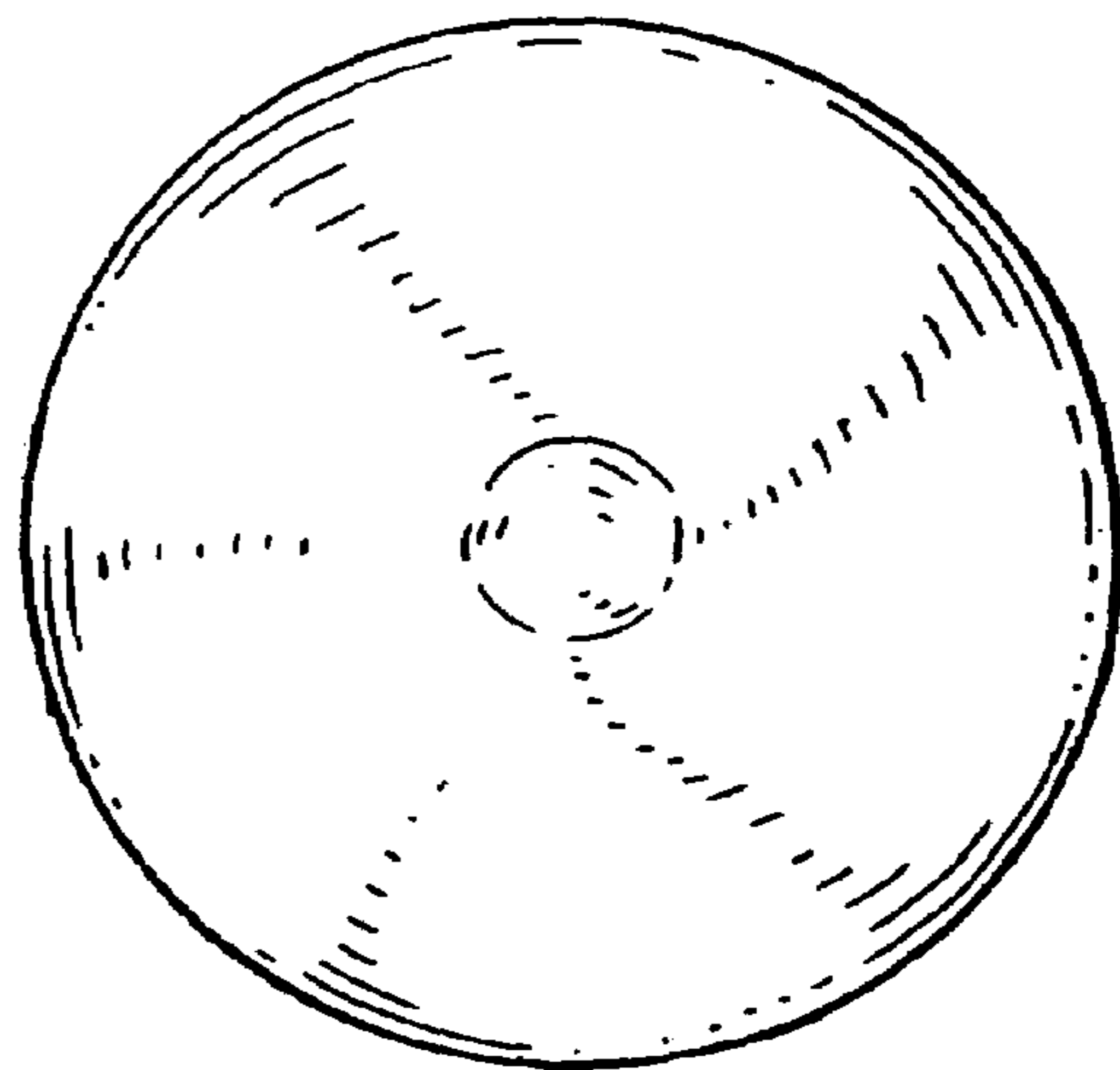

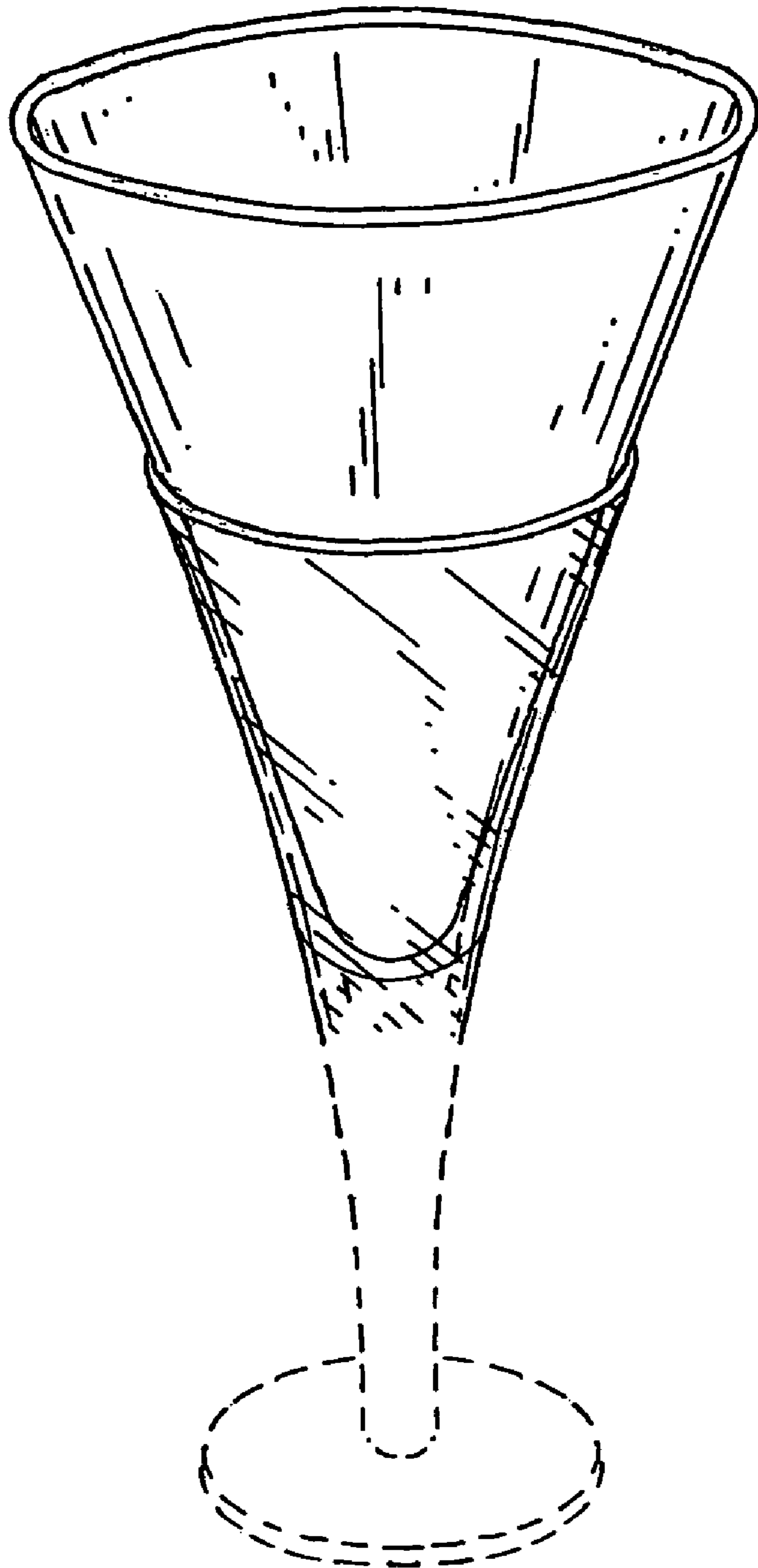

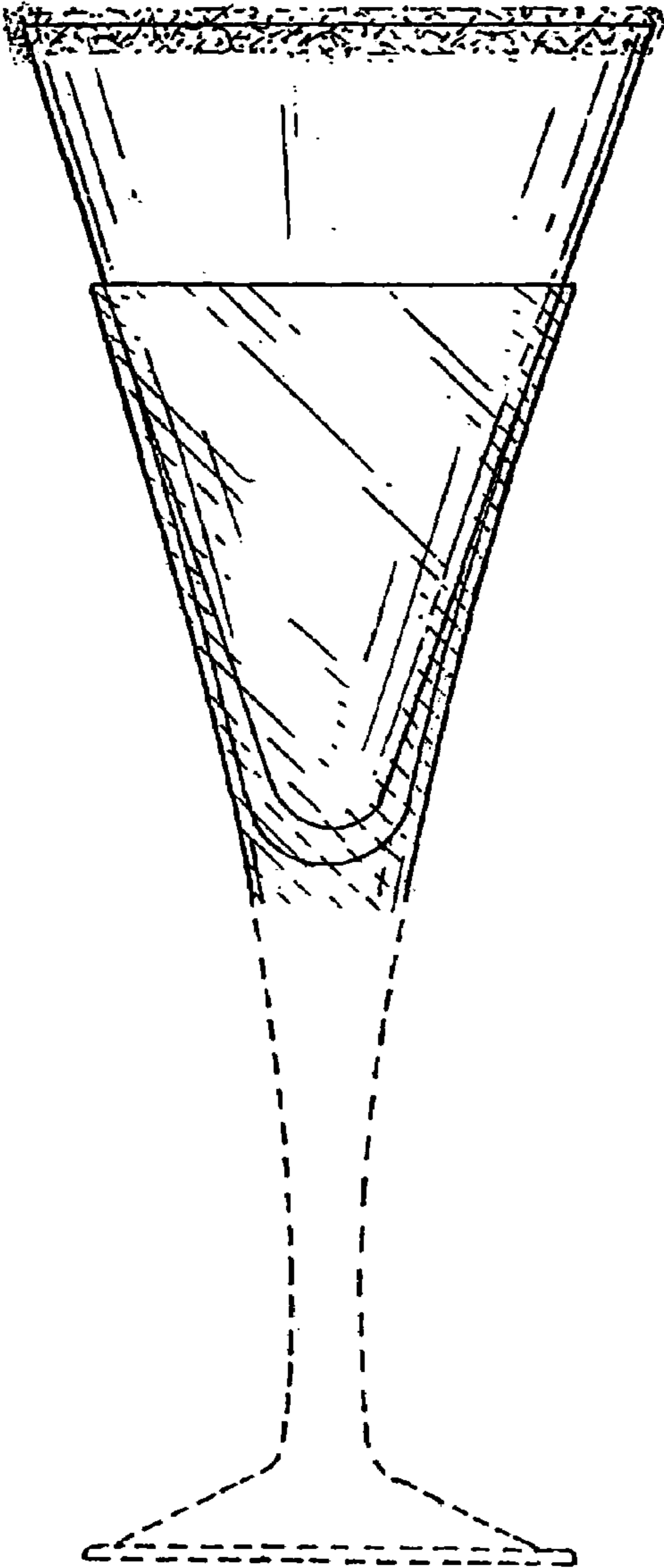

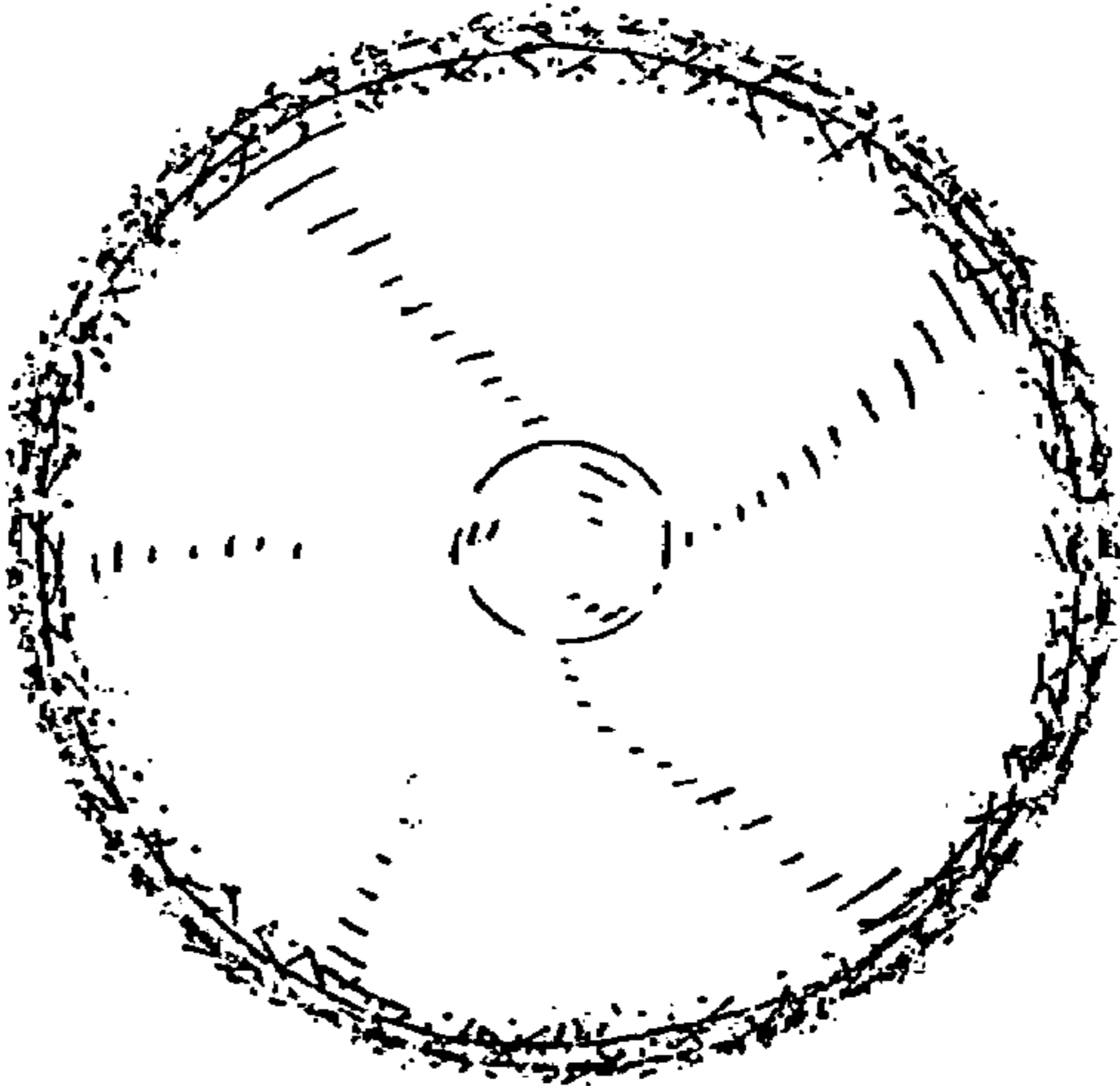

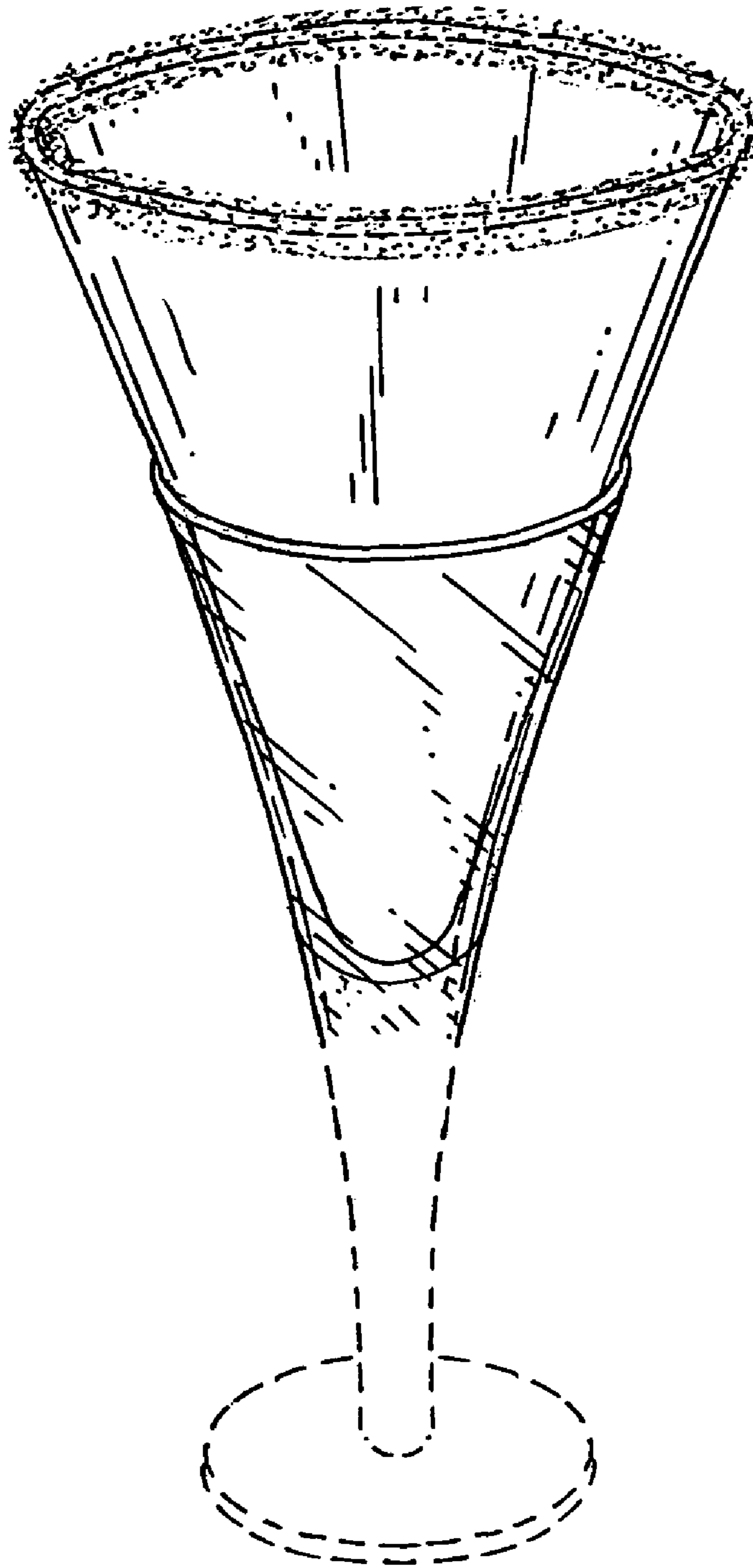
