FIG. 7 is a bottom plan view thereof; and,

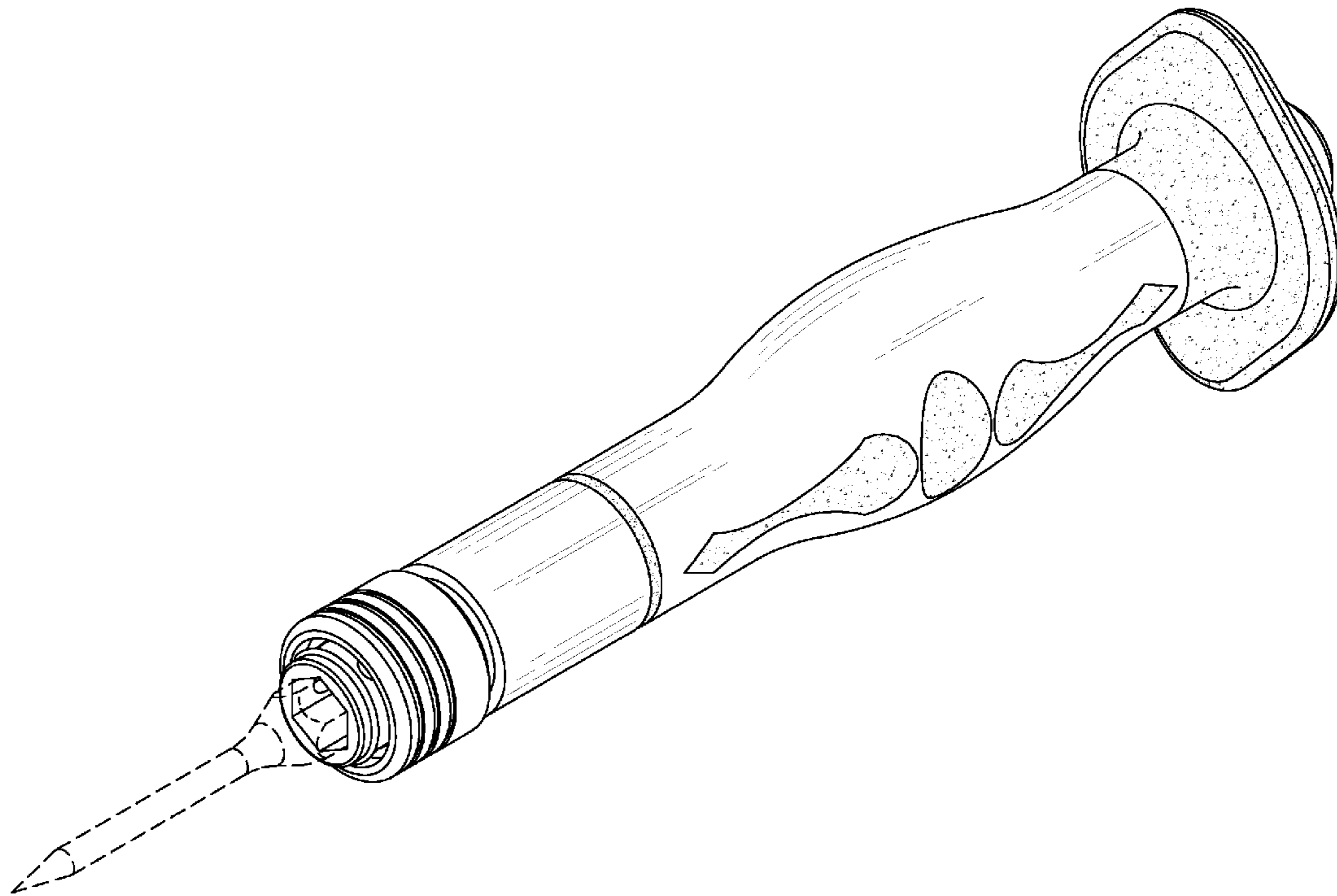
FIG. 8 is another perspective view of the chisel wherein the broken line showing of the bit is for environmental purposes only and forms no part of the claimed design.

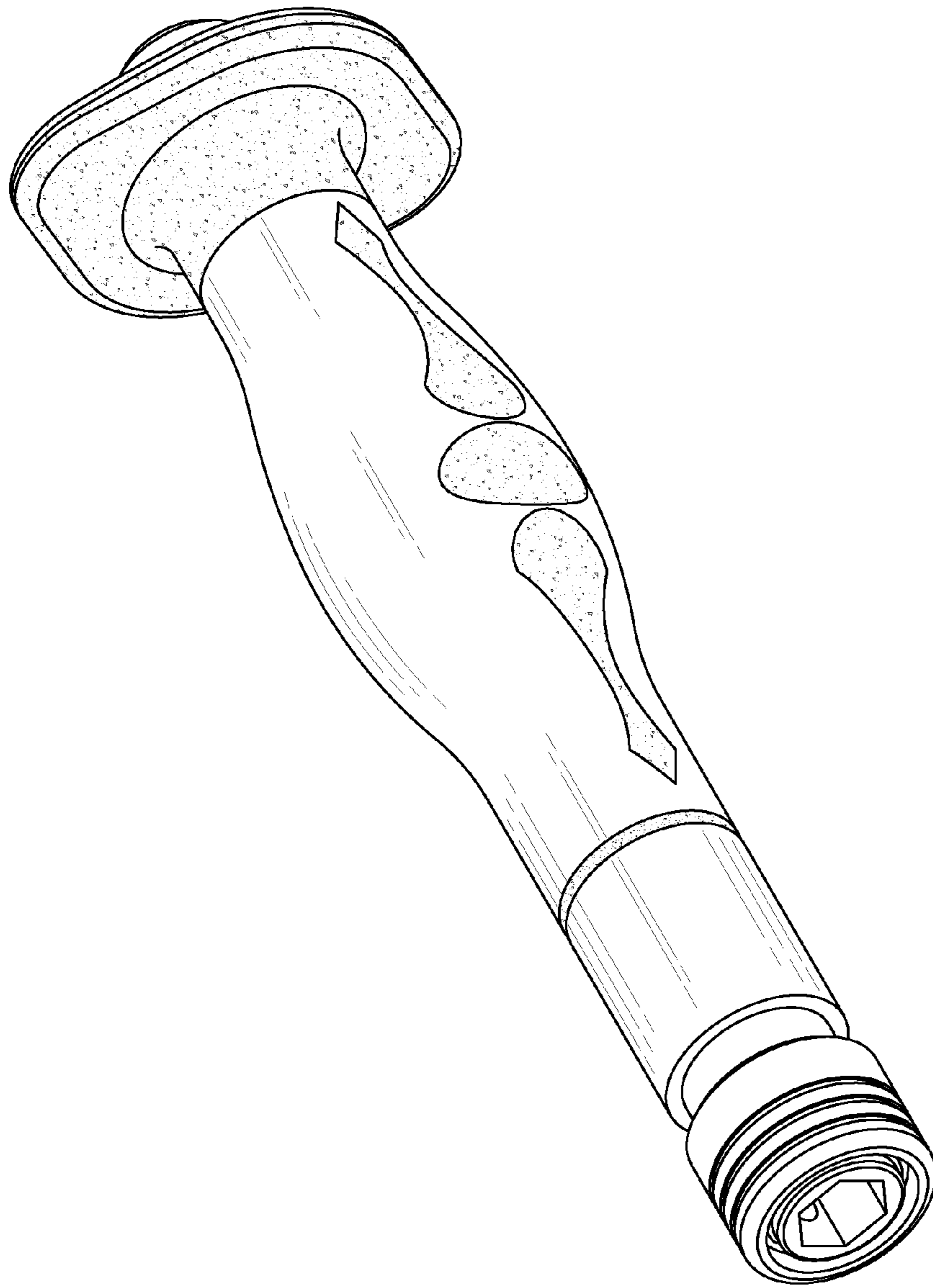

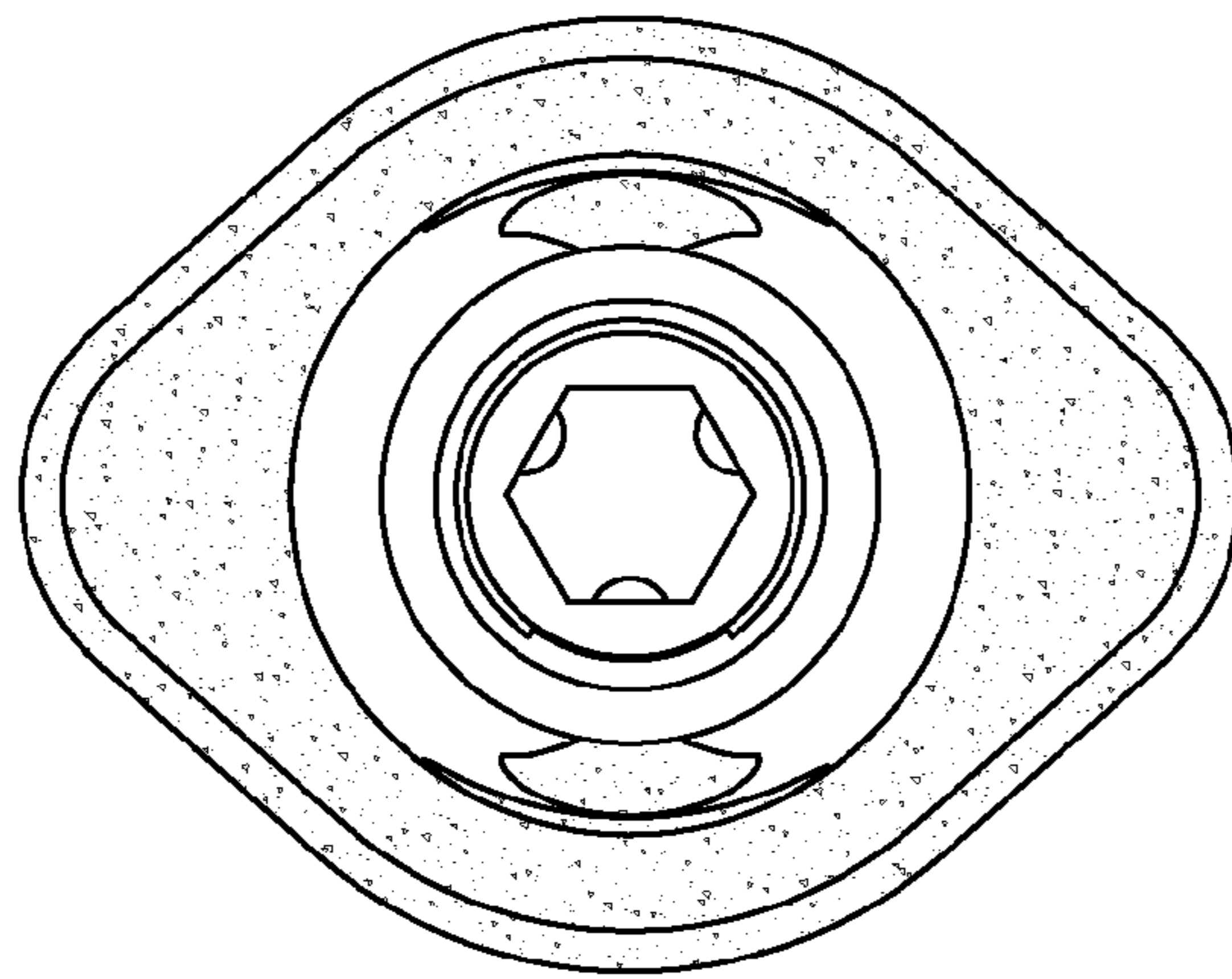

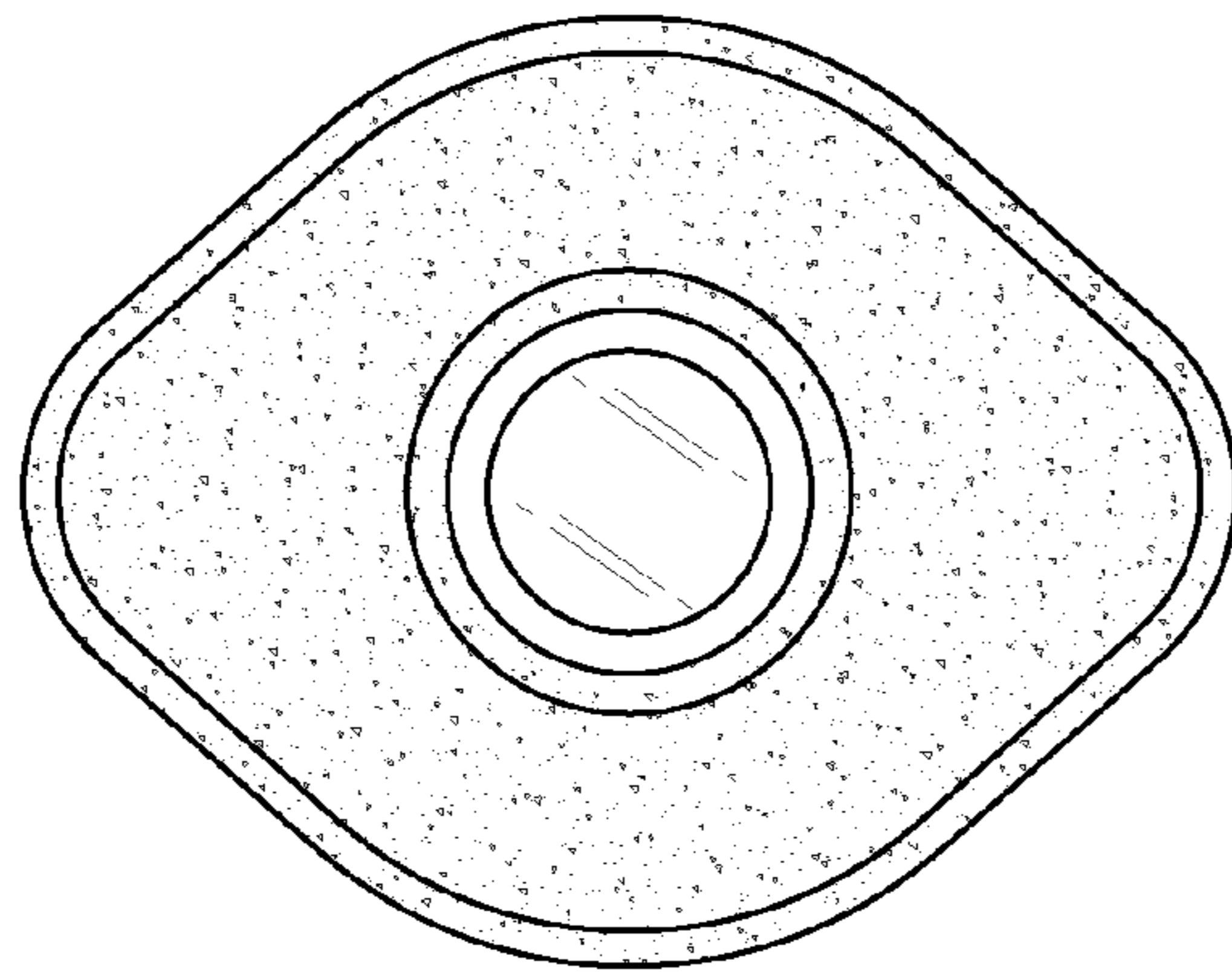

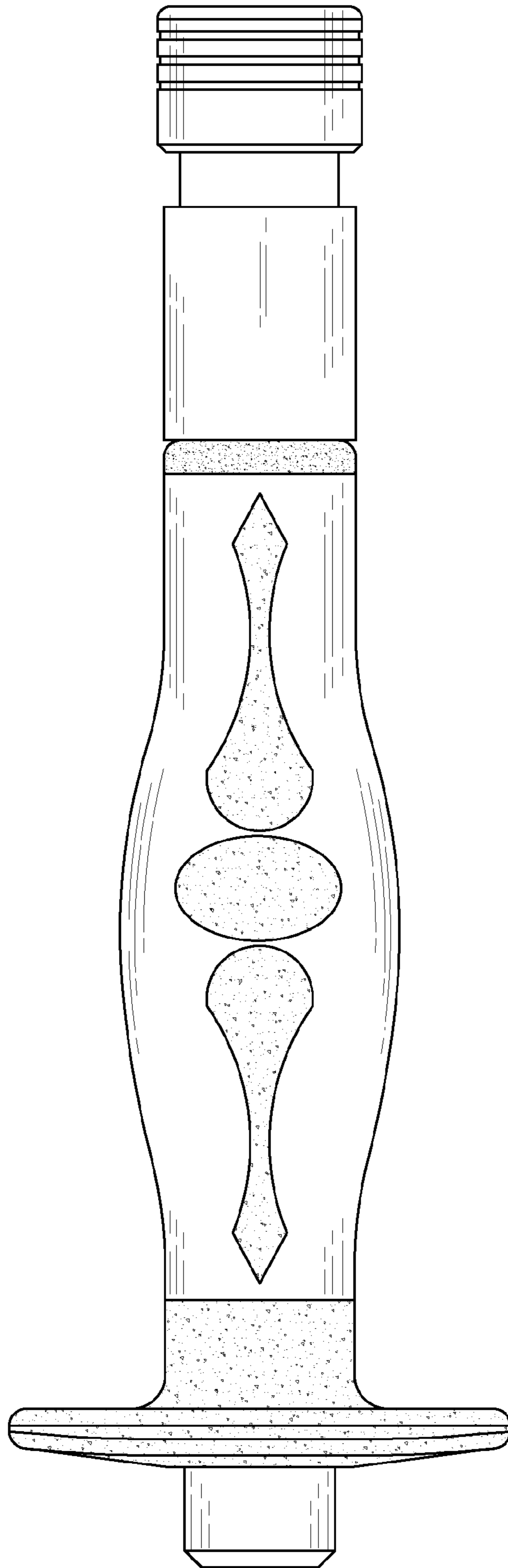

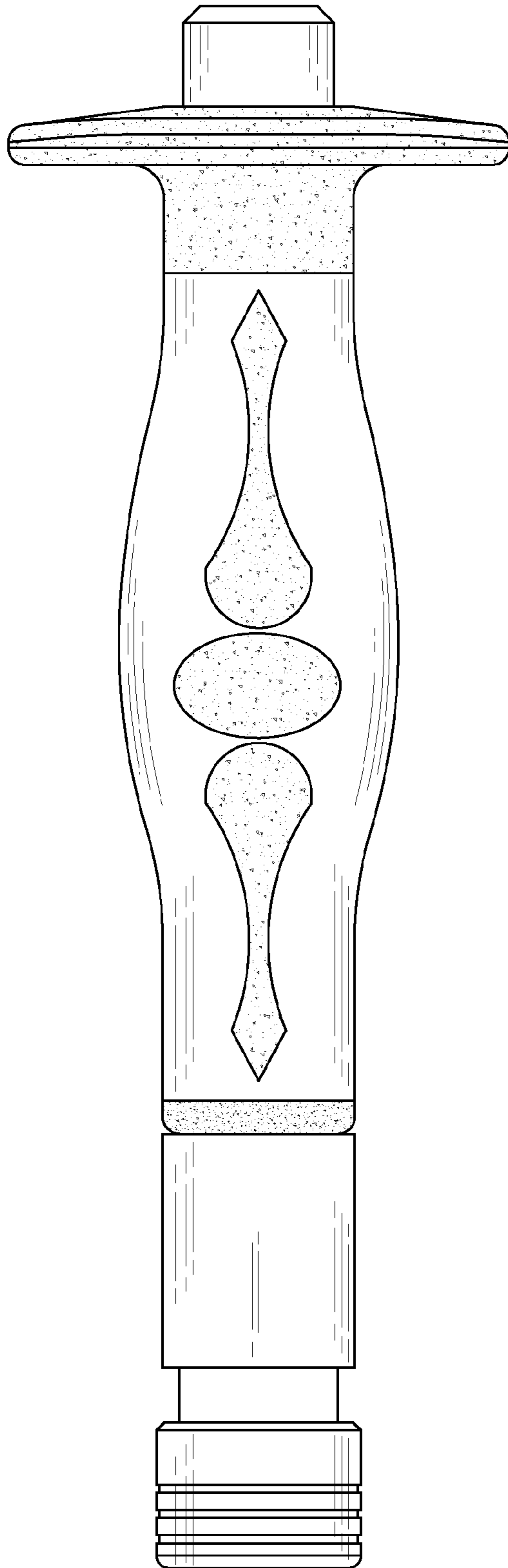

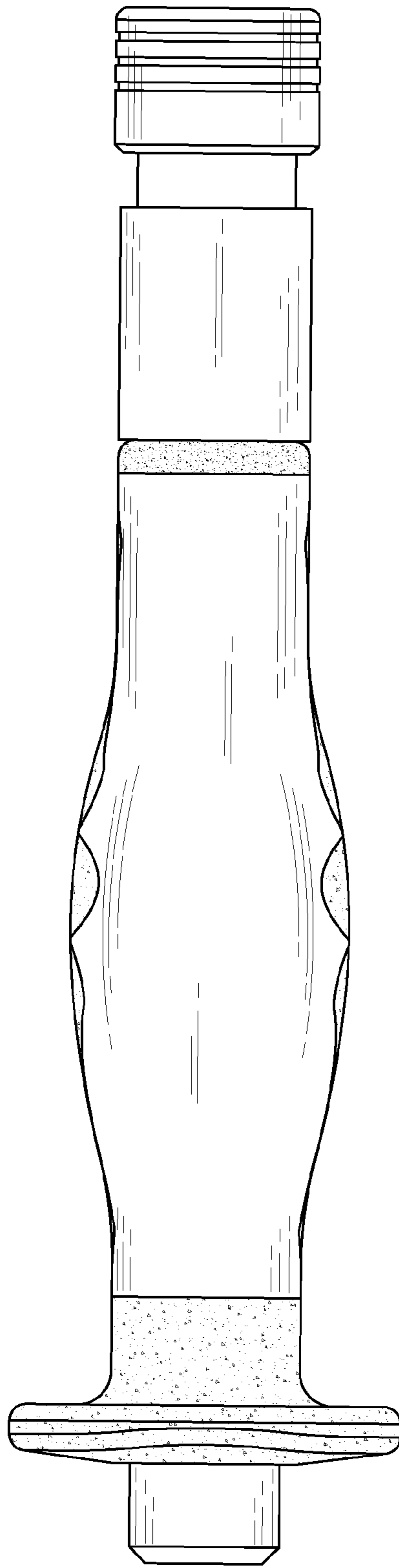

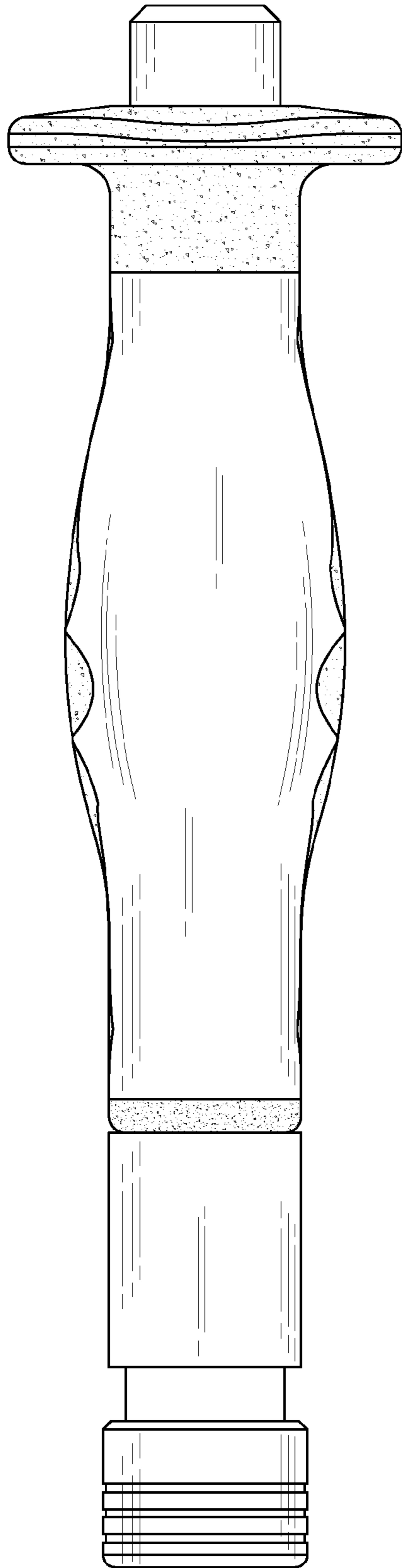

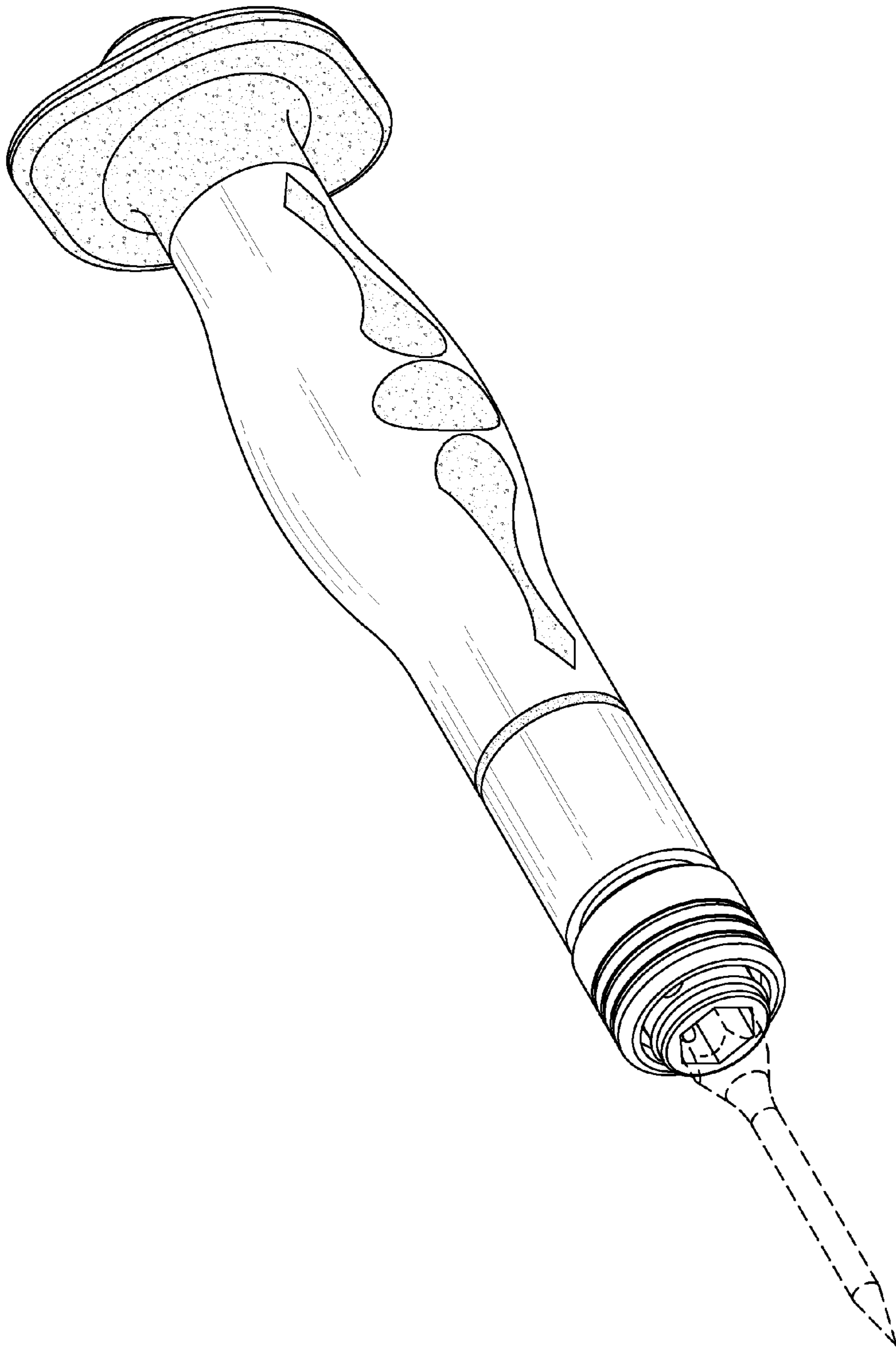
