The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, and right side perspective view of the bottle of the claimed design;

FIG. 2 is a bottom, front, and right side perspective view thereof;

FIG. 3 is a right side elevational view thereof;

FIG. 4 is a front elevational view thereof, the rear elevational view being identical except for the threads;

FIG. 5 is a left side elevational view thereof;

FIG. 6 is a top plan view thereof; and,

FIG. 7 is a bottom plan view thereof.

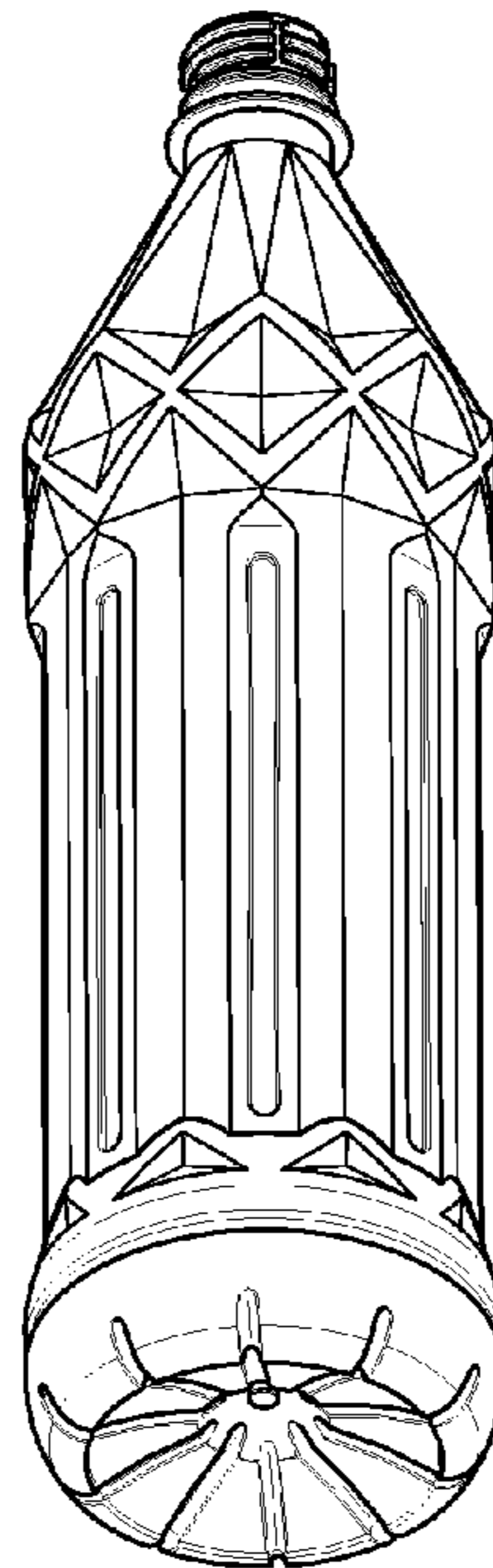
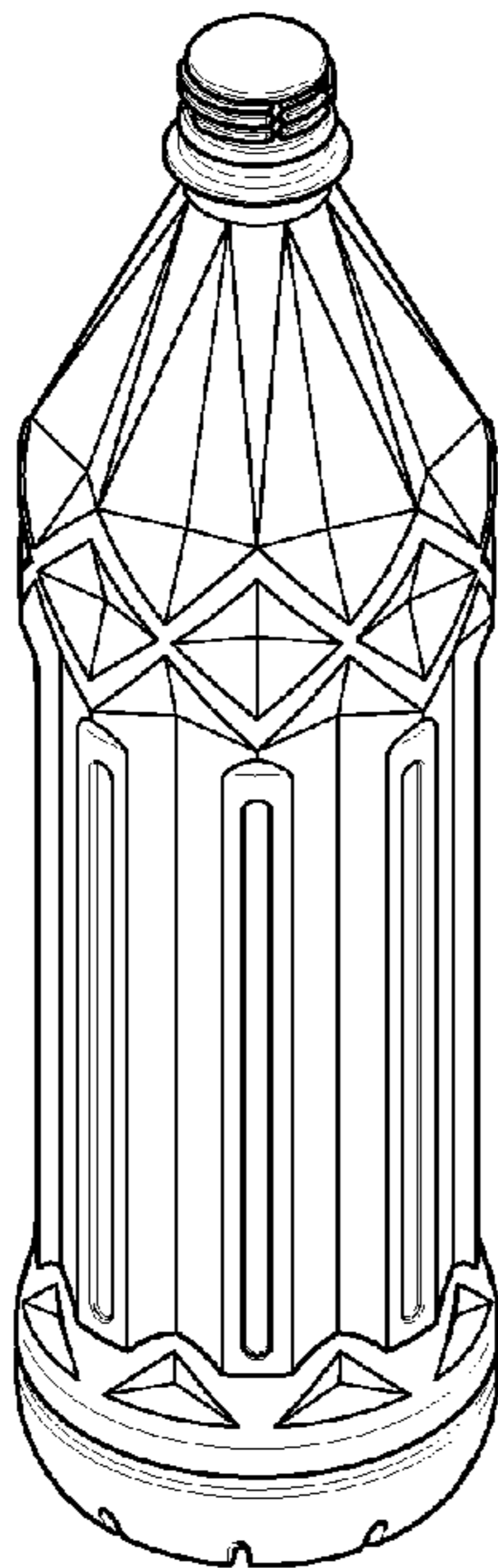

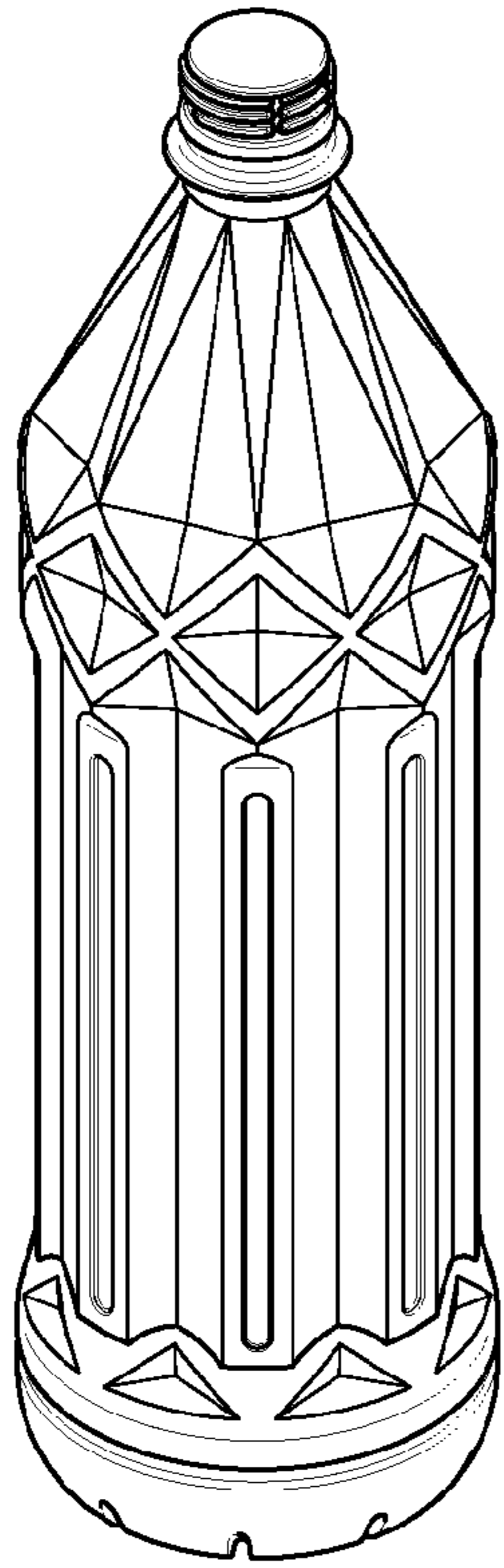

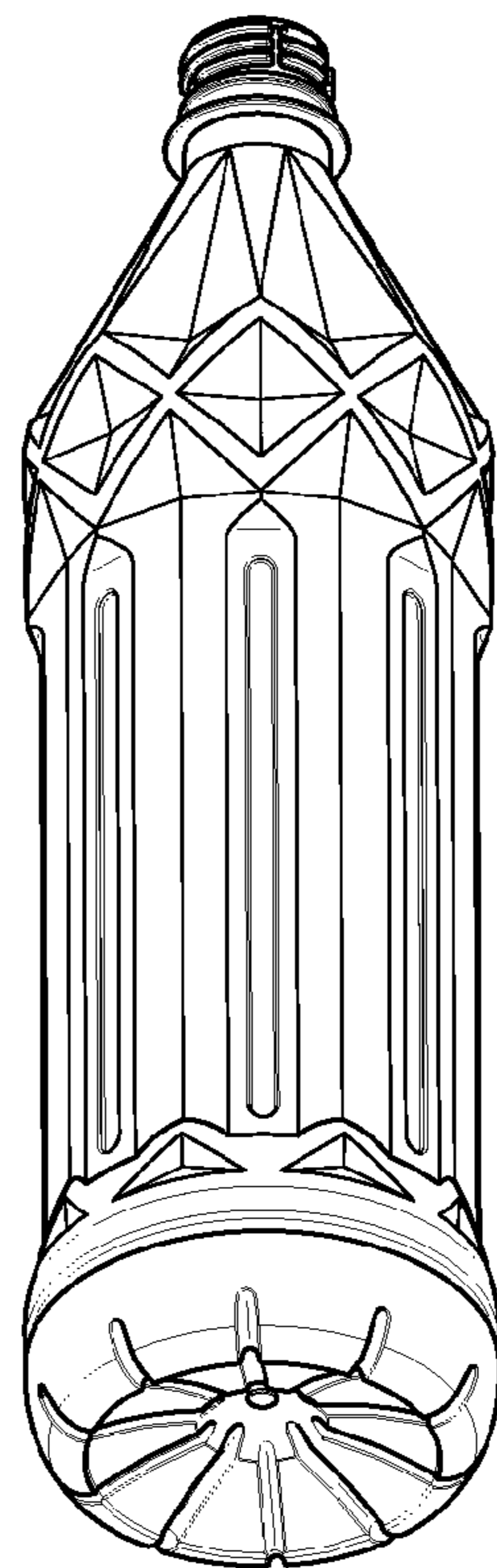

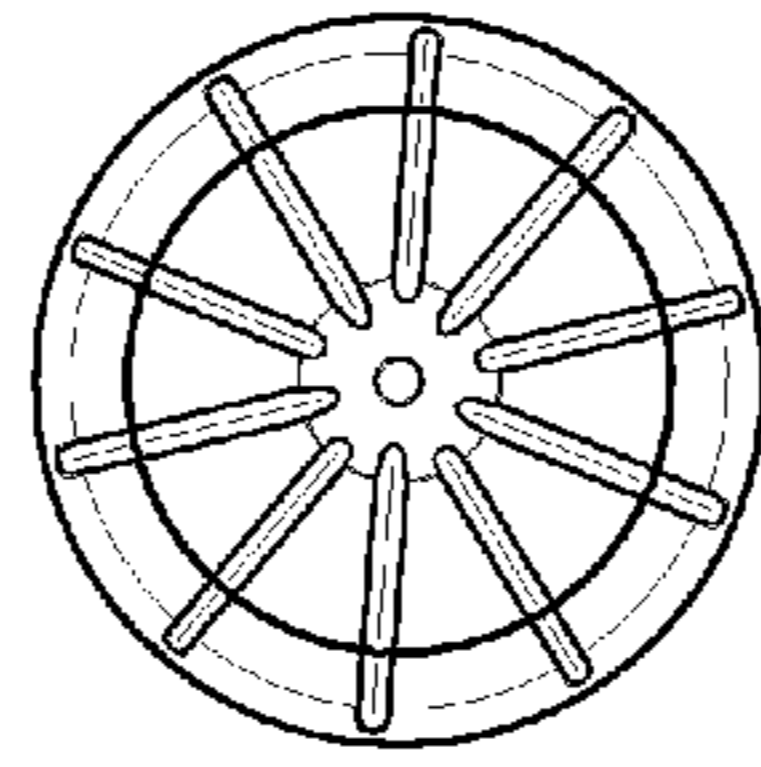

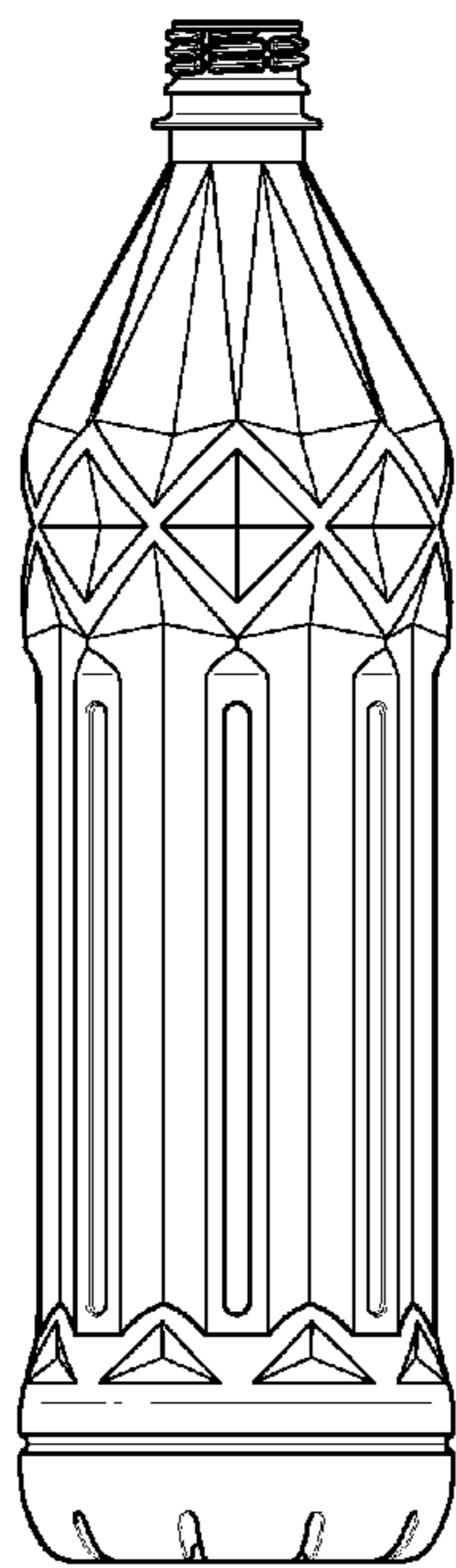

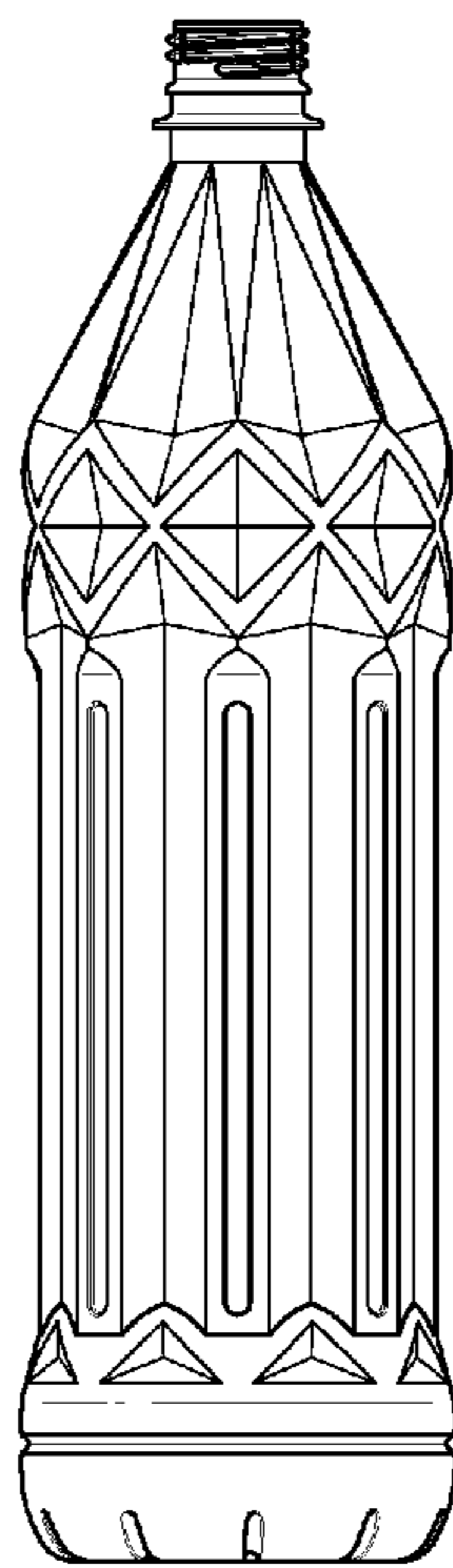

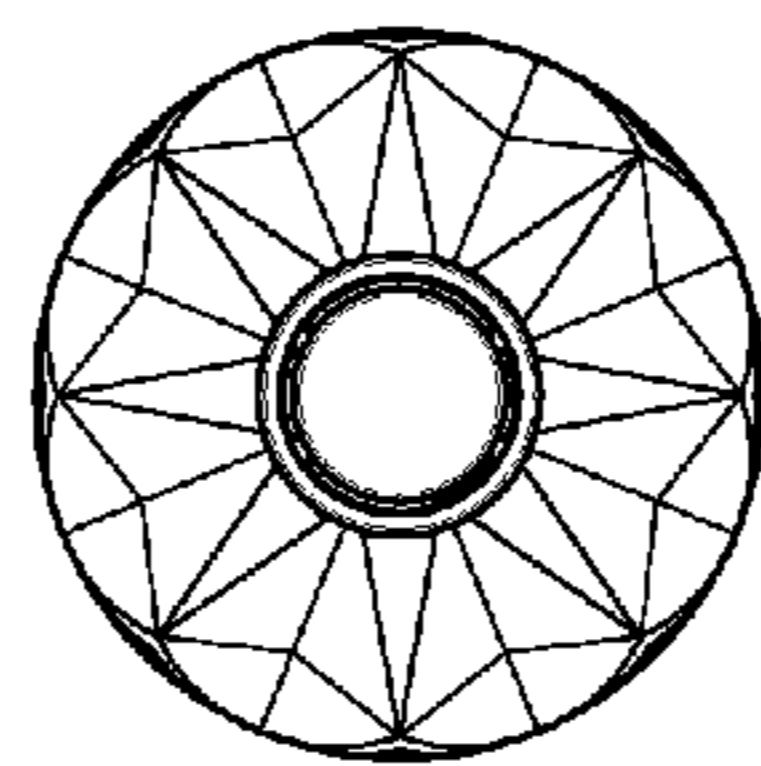
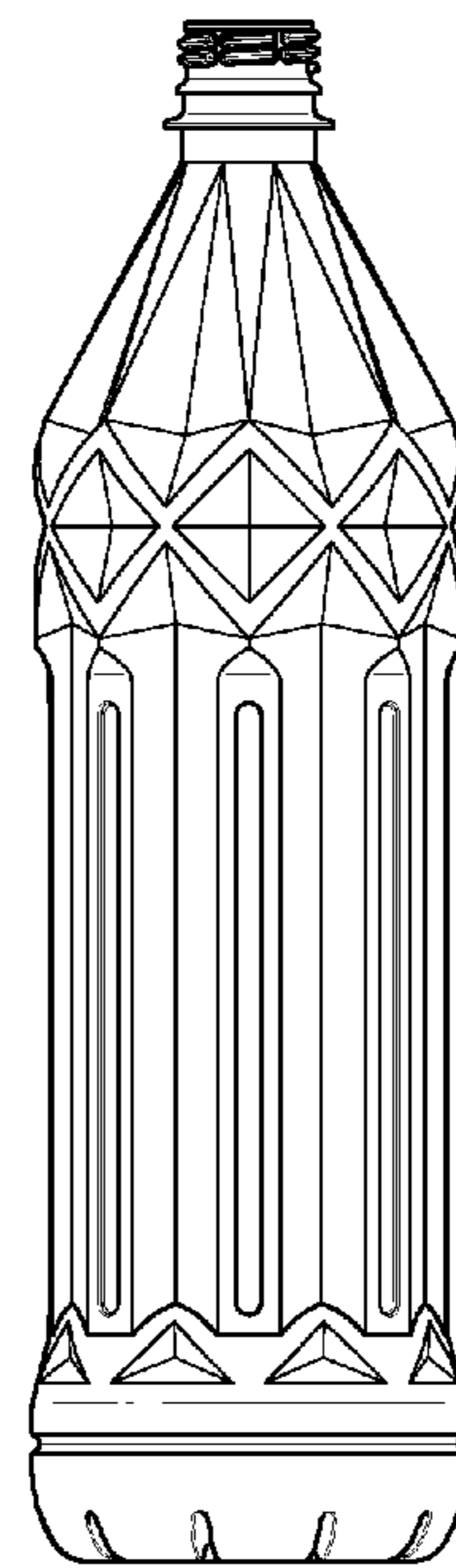
