FIG. 1 is a perspective view of a blister card showing my new design;

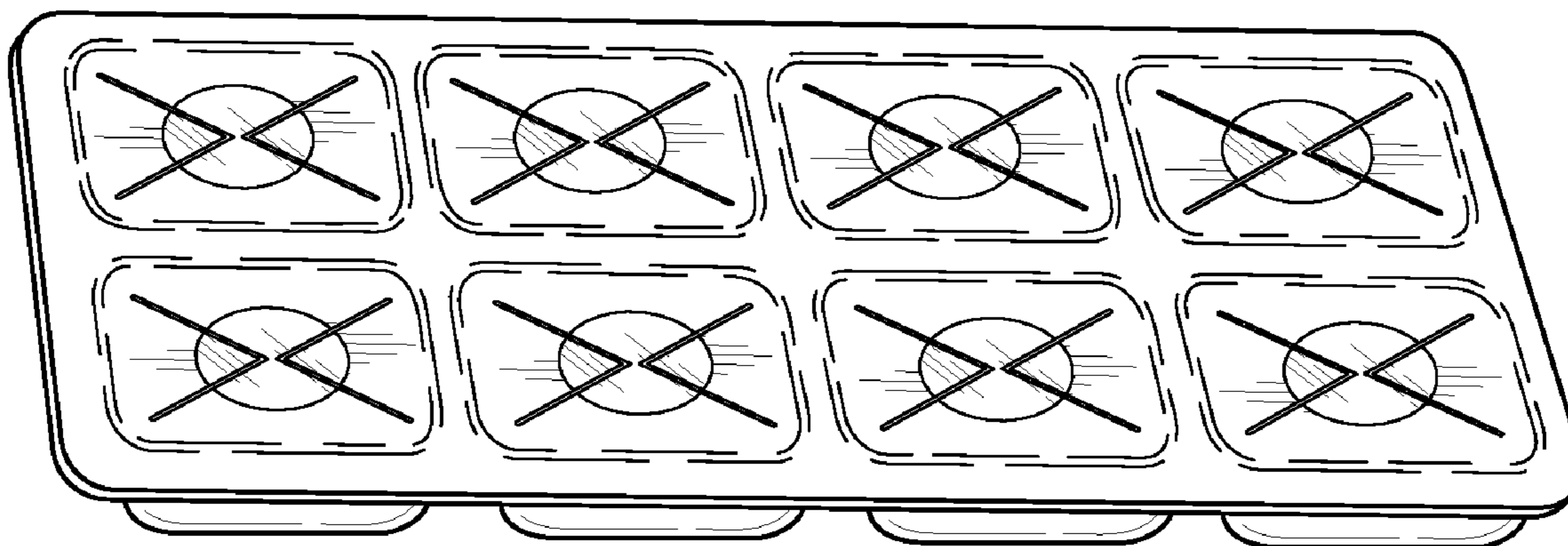
FIG. 2 is a side view thereof, the opposed side view being identical thereto;

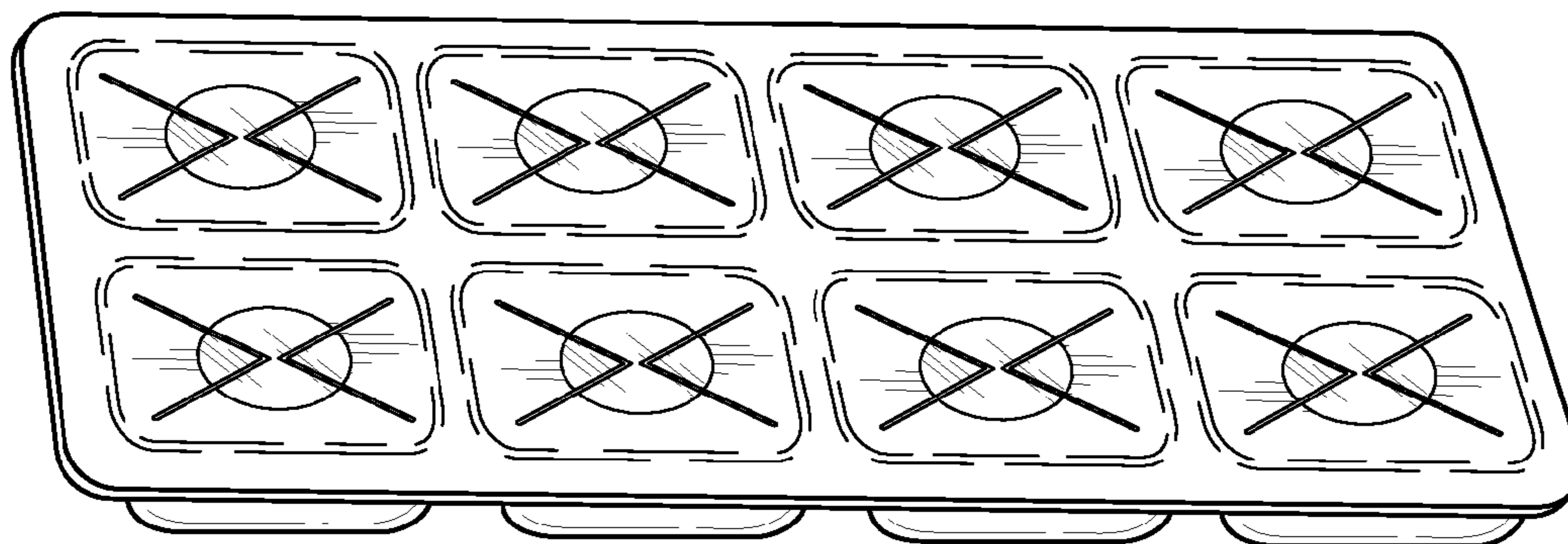

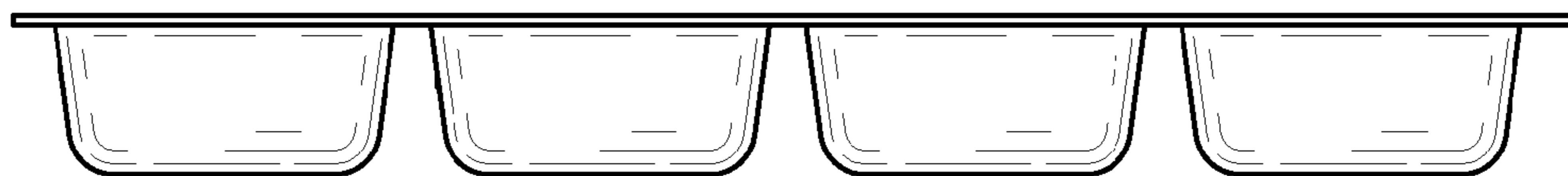

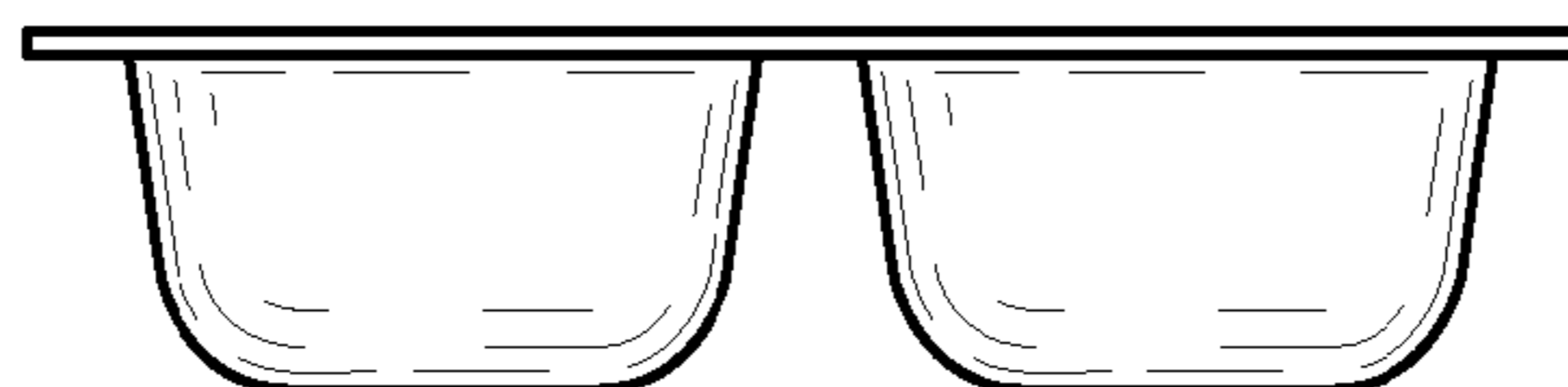

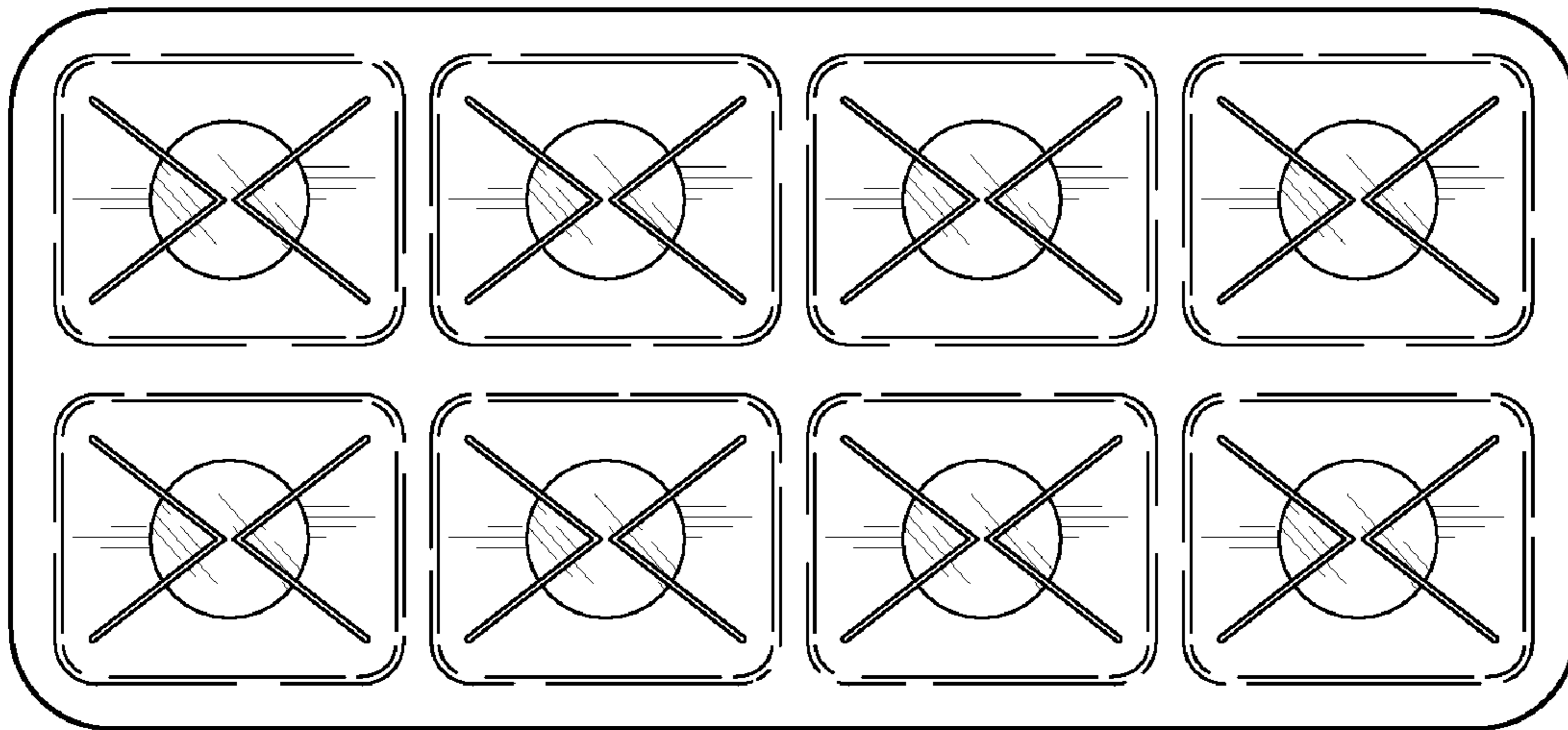

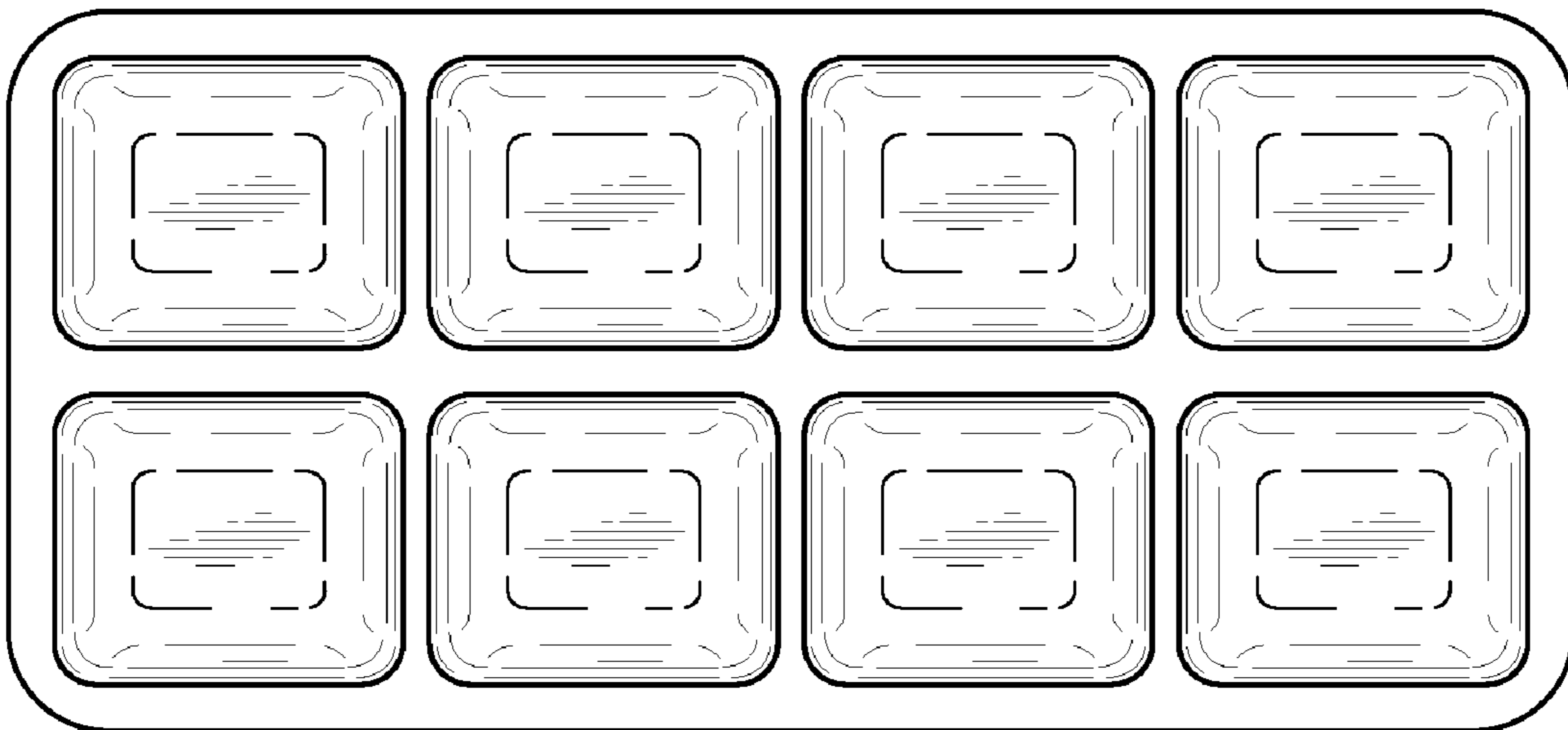
