FIG. 3 is a rear-side view of the rechargeable battery of FIG. 1.

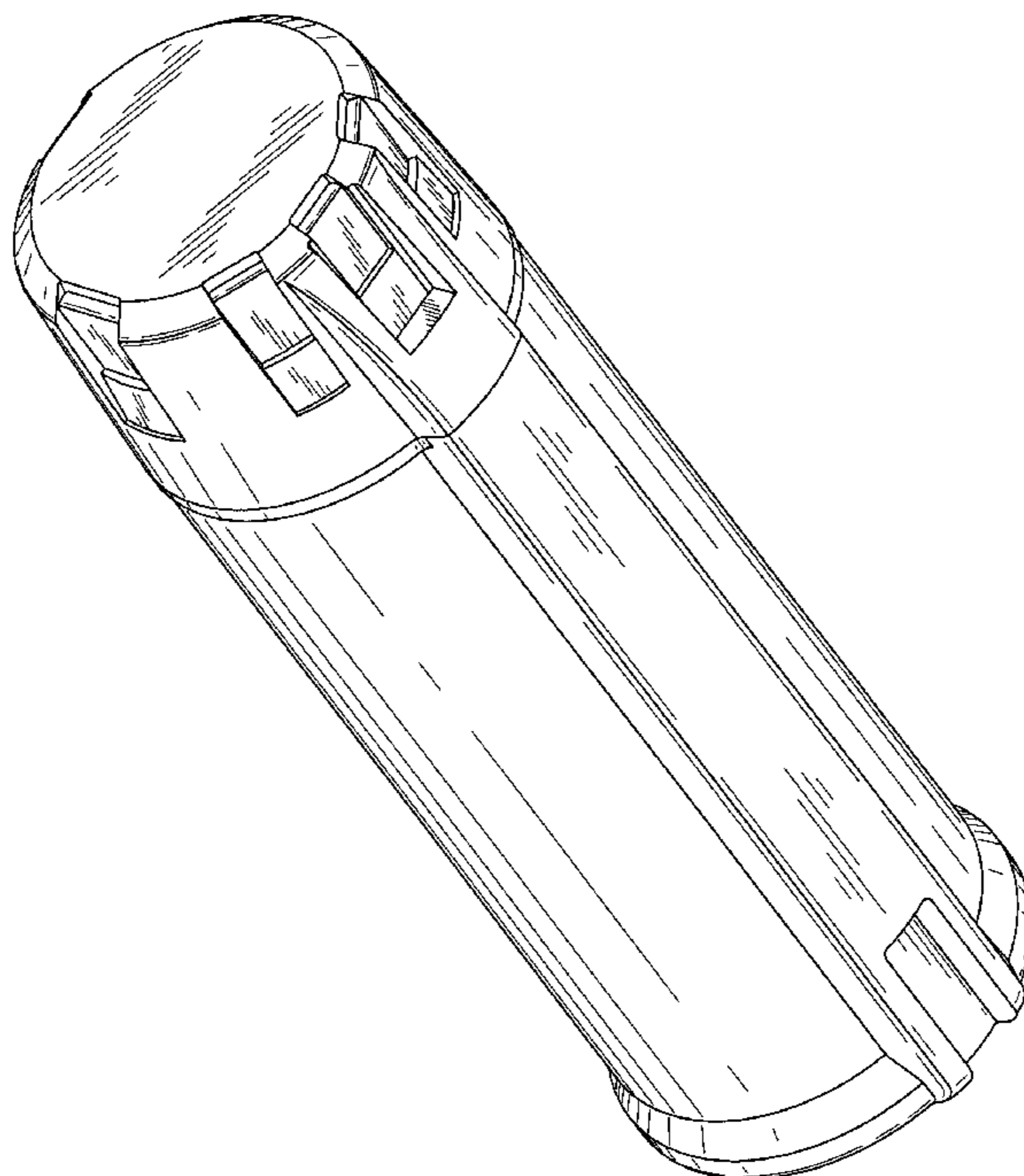
FIG. 4 is a right-side view of the rechargeable battery of FIG. 1.

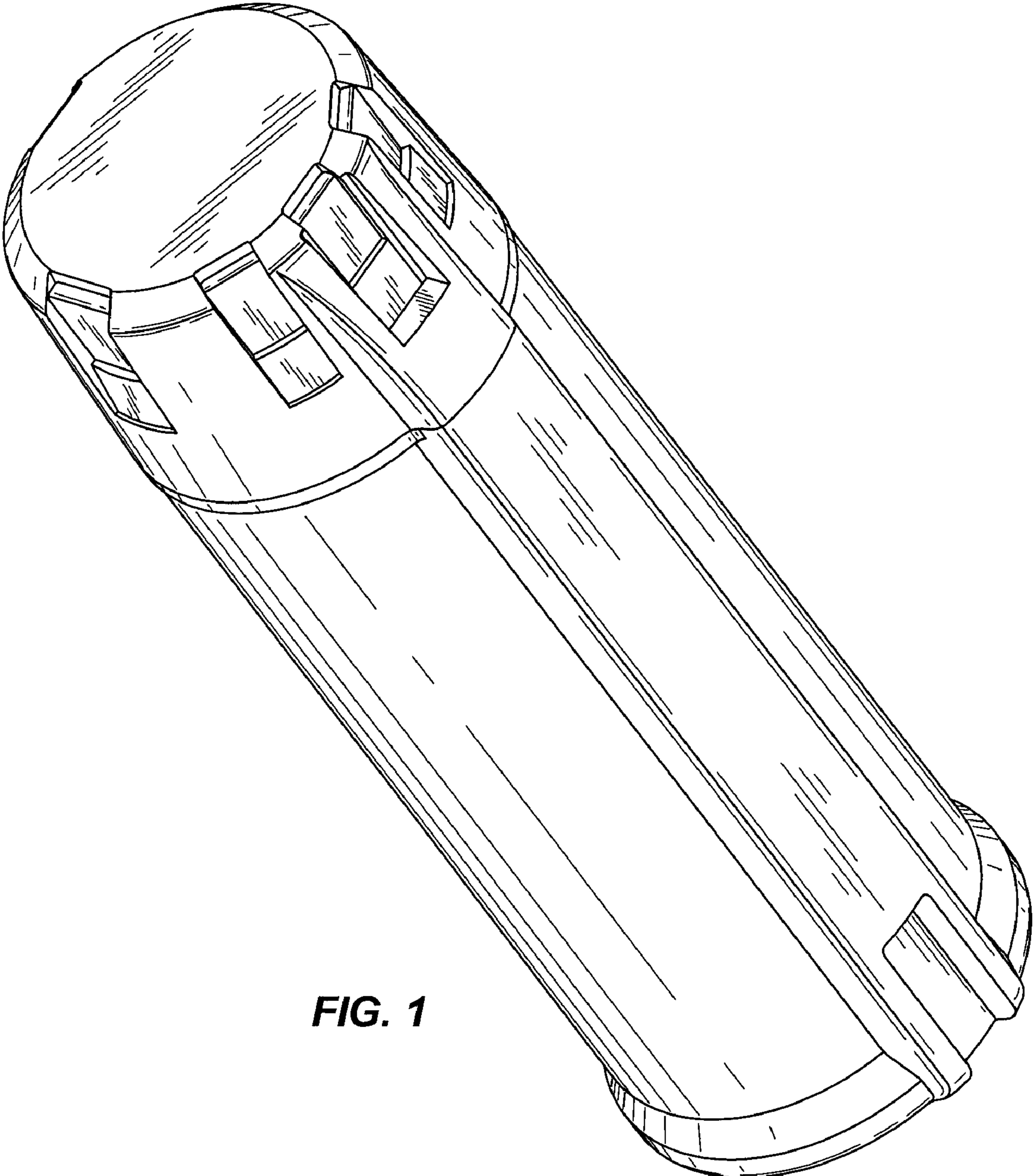

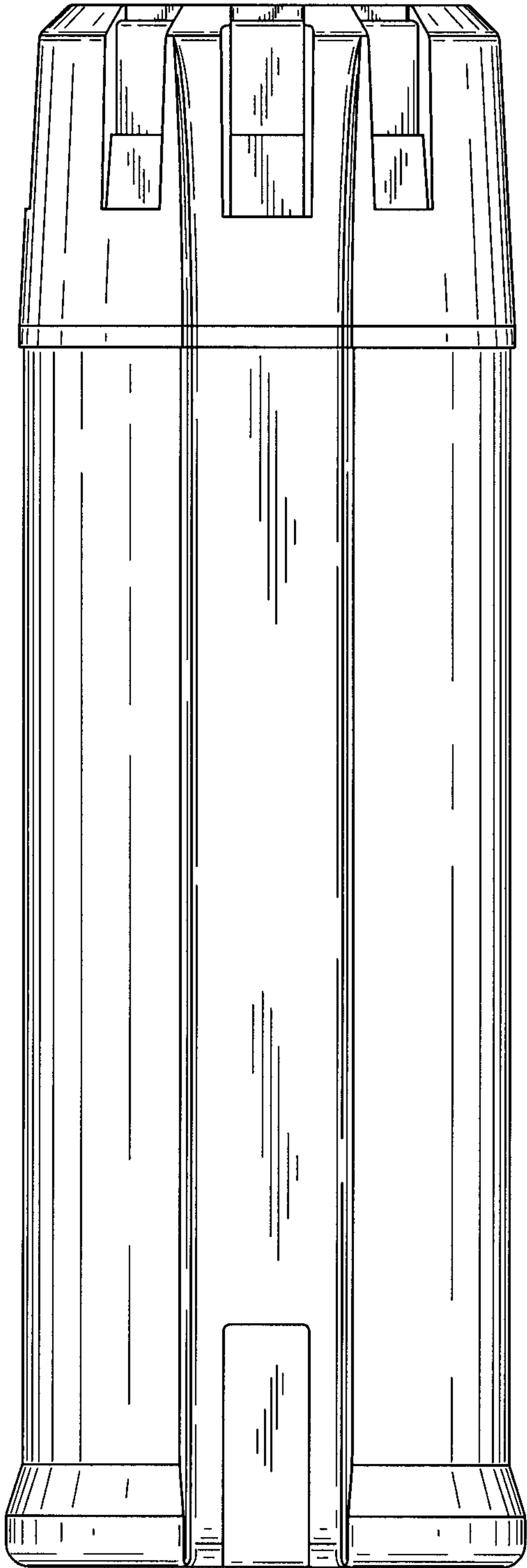

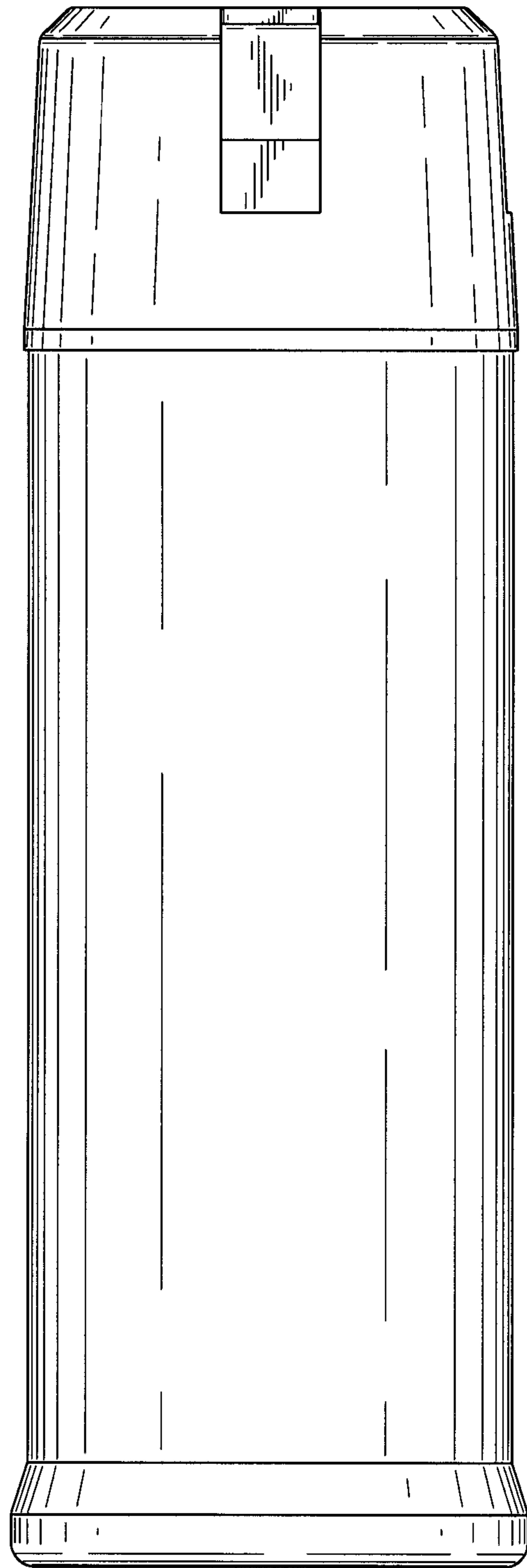

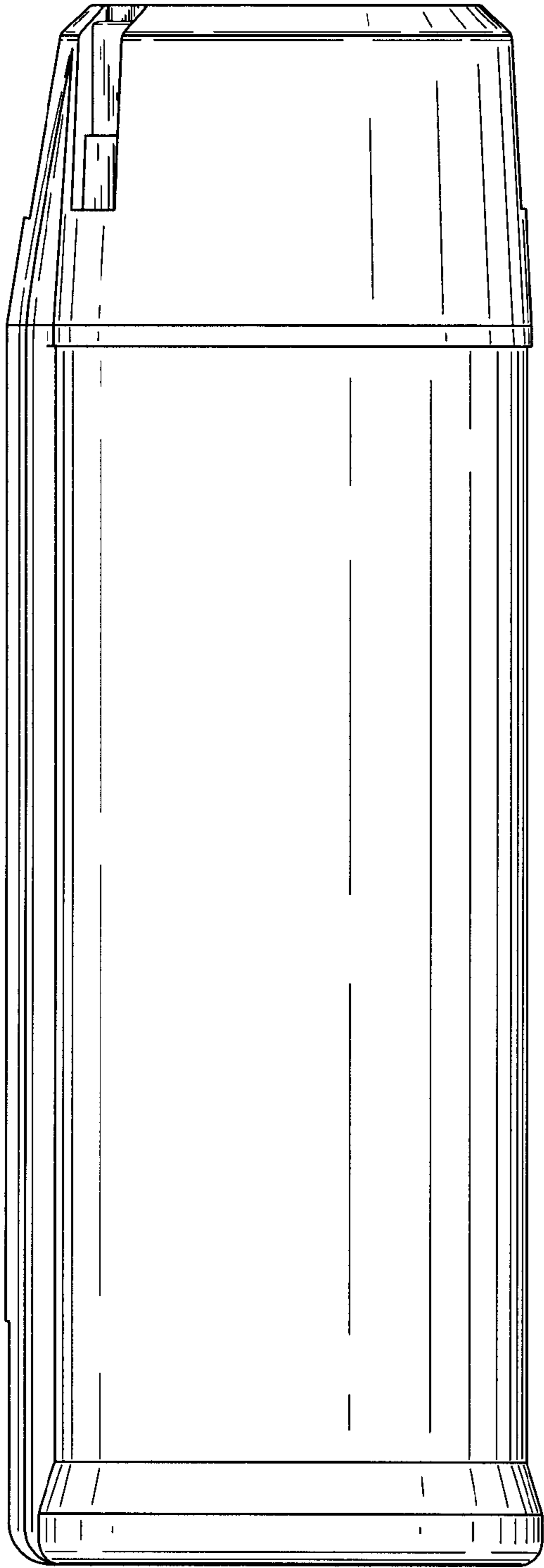

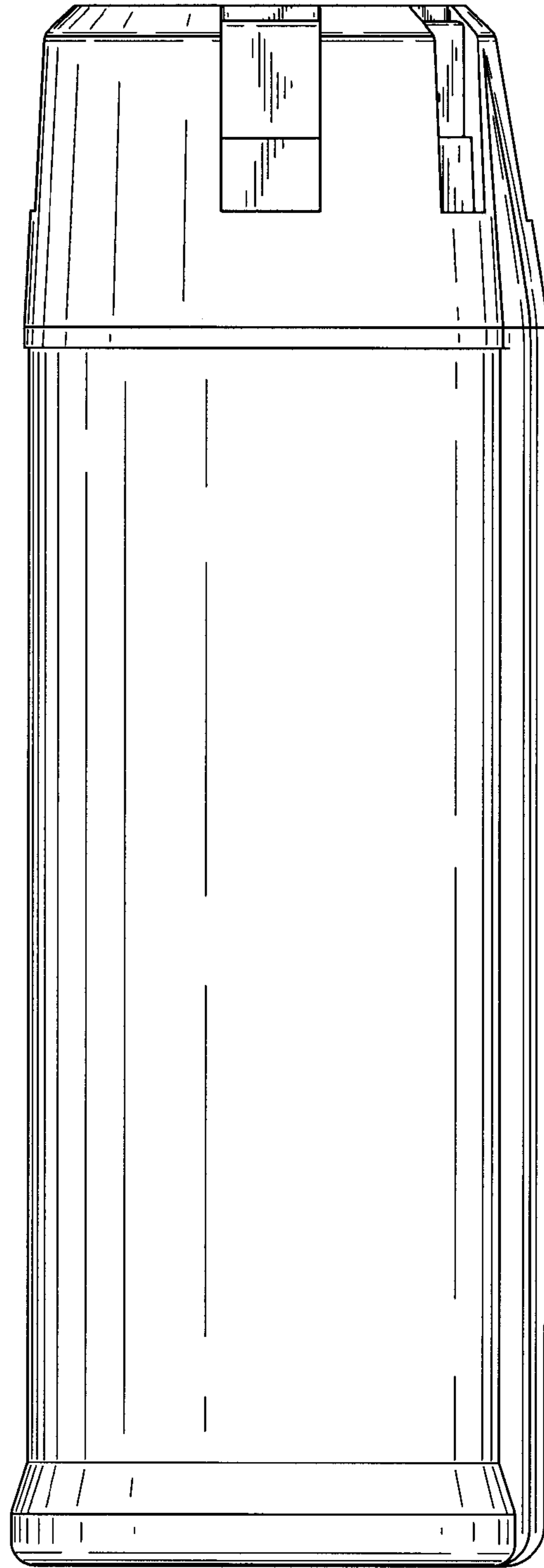

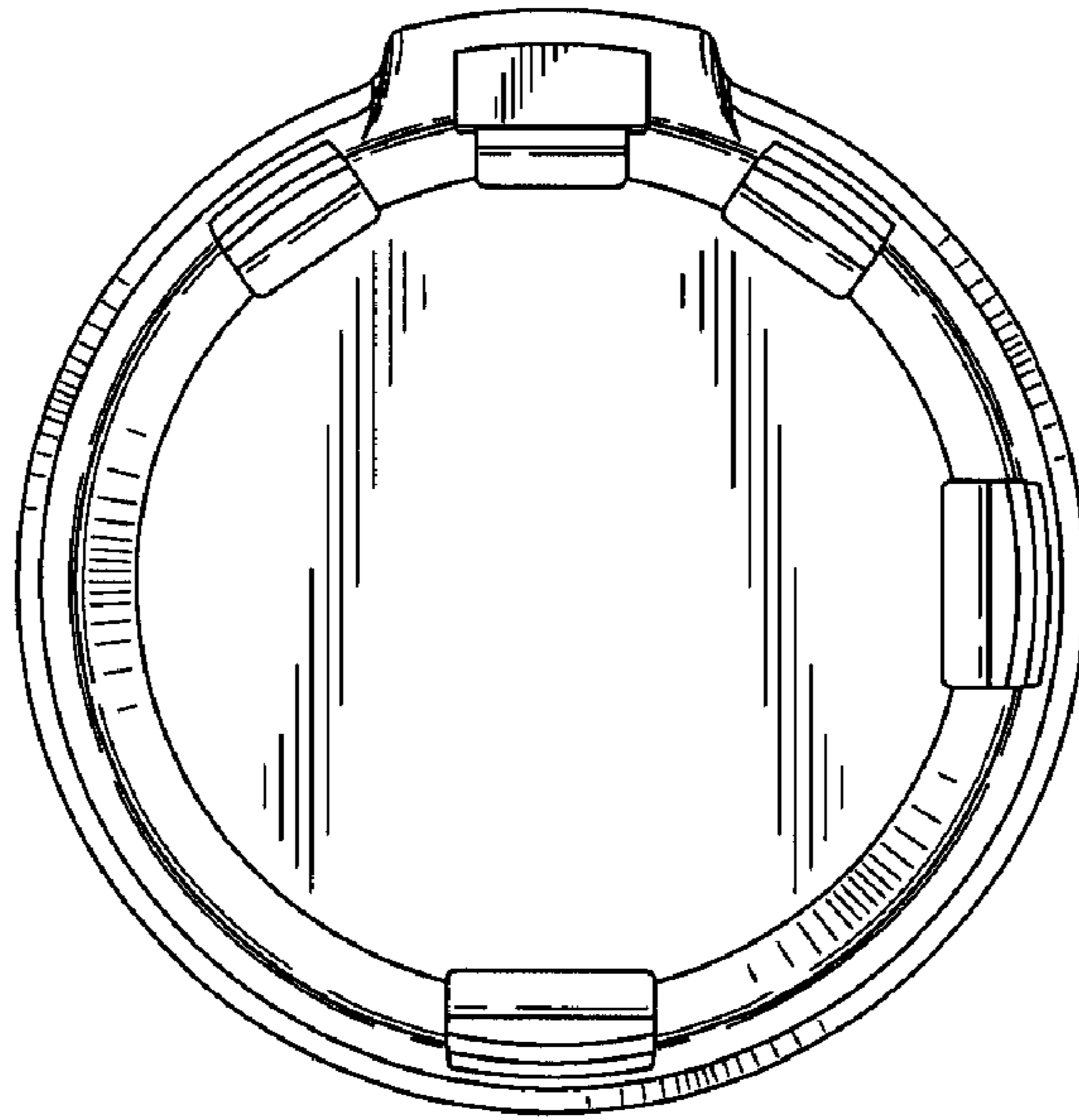

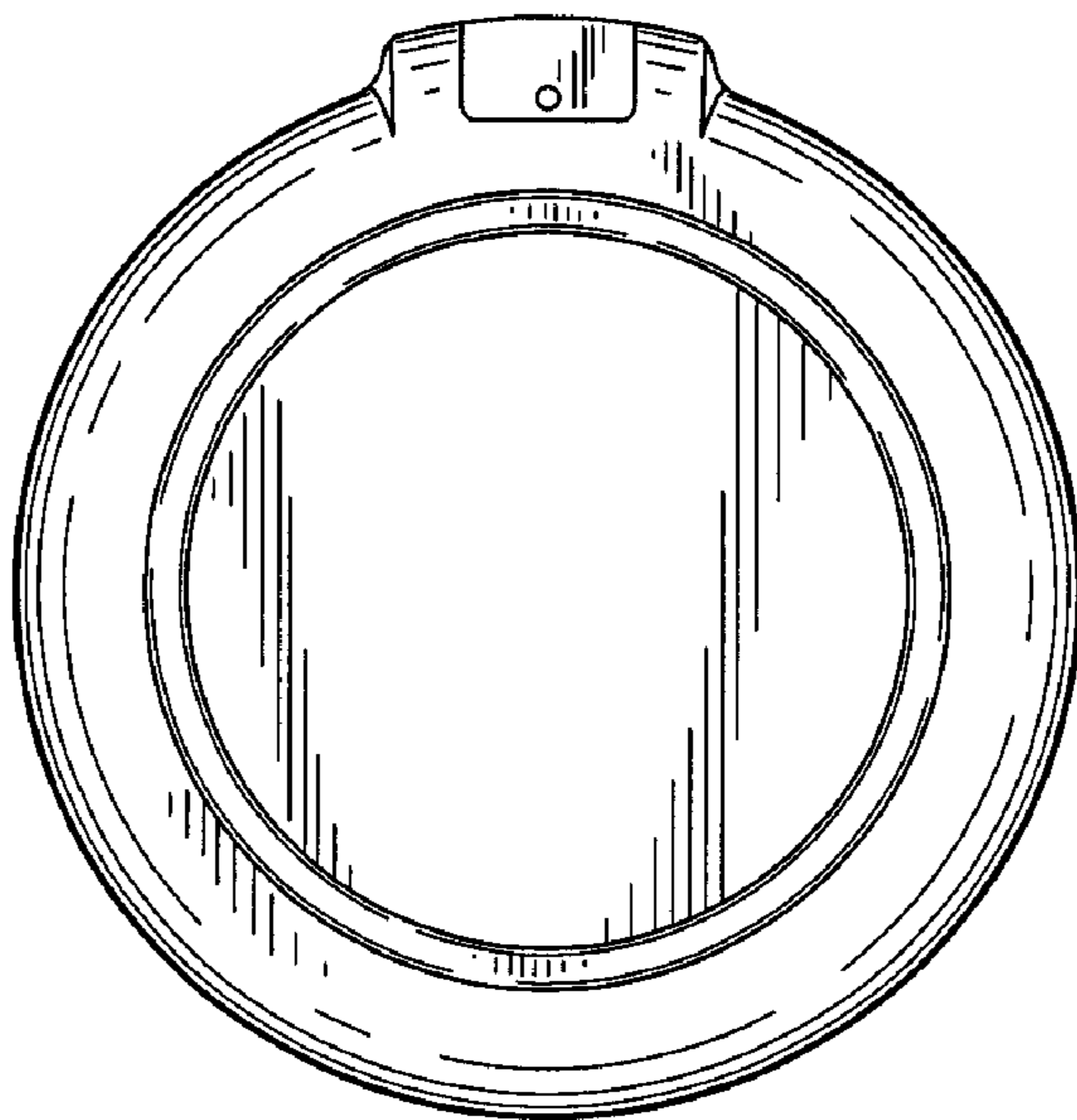
