The ornamental design for a graphic user interface for a display panel, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a first embodiment of a graphic user interface for a display panel showing our new design;

FIG. 2 is a front view of a second embodiment of the graphic user interface for the display panel showing our new design; and,
