The ornamental design for a magnifying pen, as shown and described.

DESCRIPTION

FIG. 1 is right side view of a magnifying pen showing my new design;

FIG. 2 is a top view of the magnifying pen of FIG. 1;

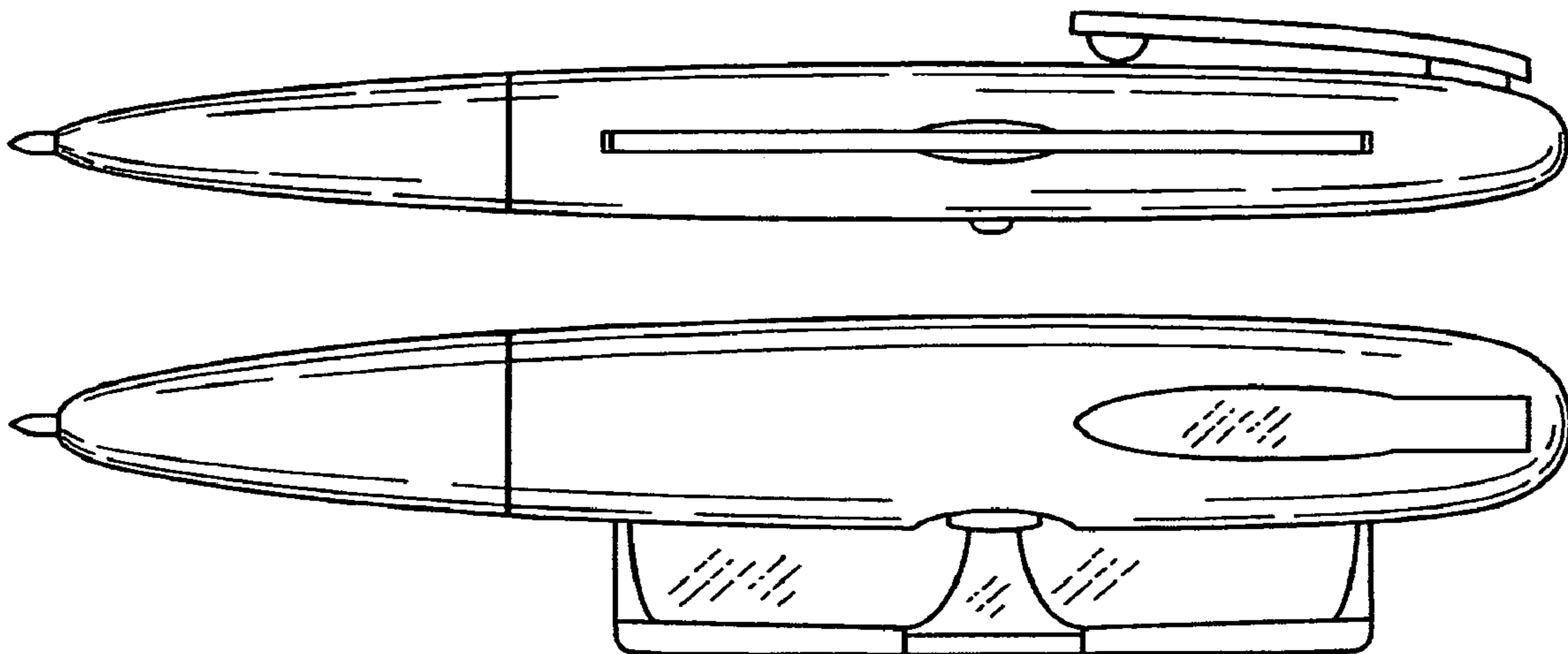
FIG. 3 is a top view of the magnifying pen of FIG. 1 with the magnifying glass extended;

FIG. 4 is a bottom view of the magnifying pen of FIG. 1 with the magnifying glass retracted;

FIG. 6 is a top right perspective view of the magnifying pen of FIG. 1 with the magnifying glass extended.

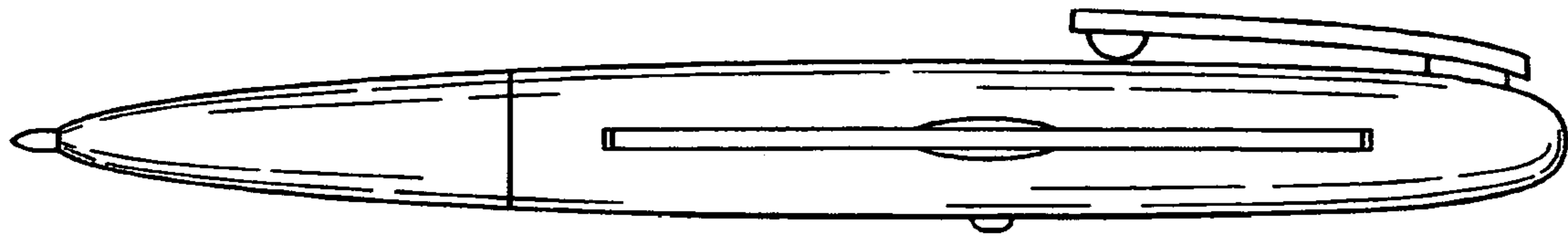

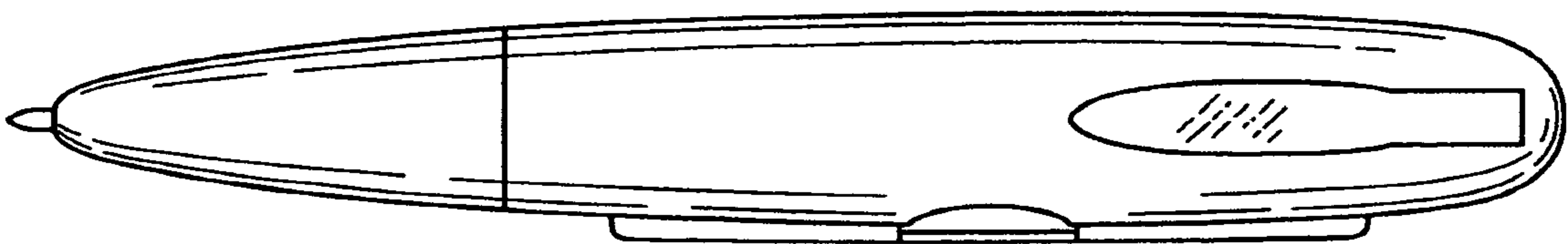

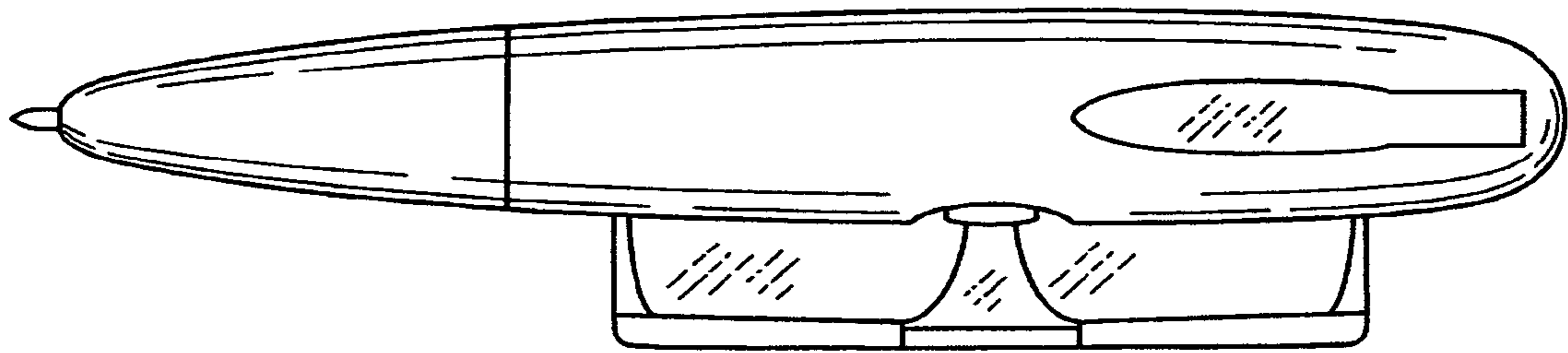

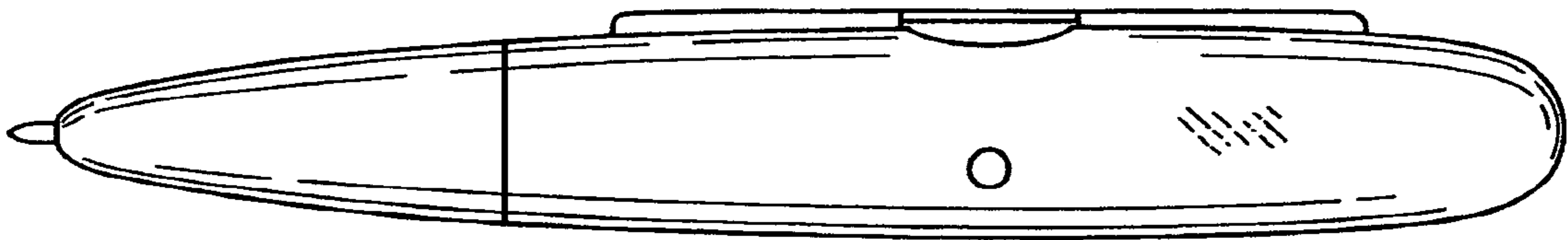

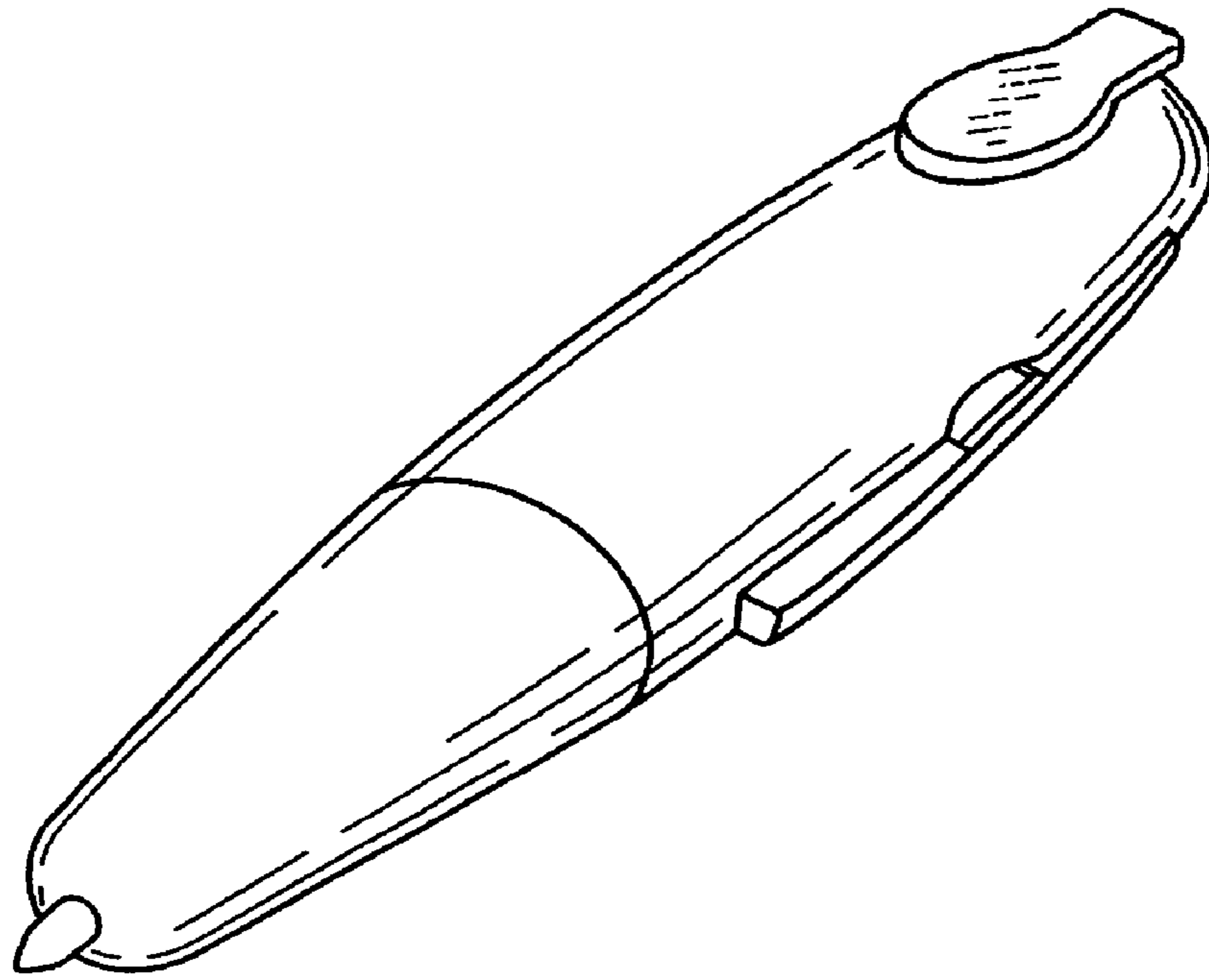

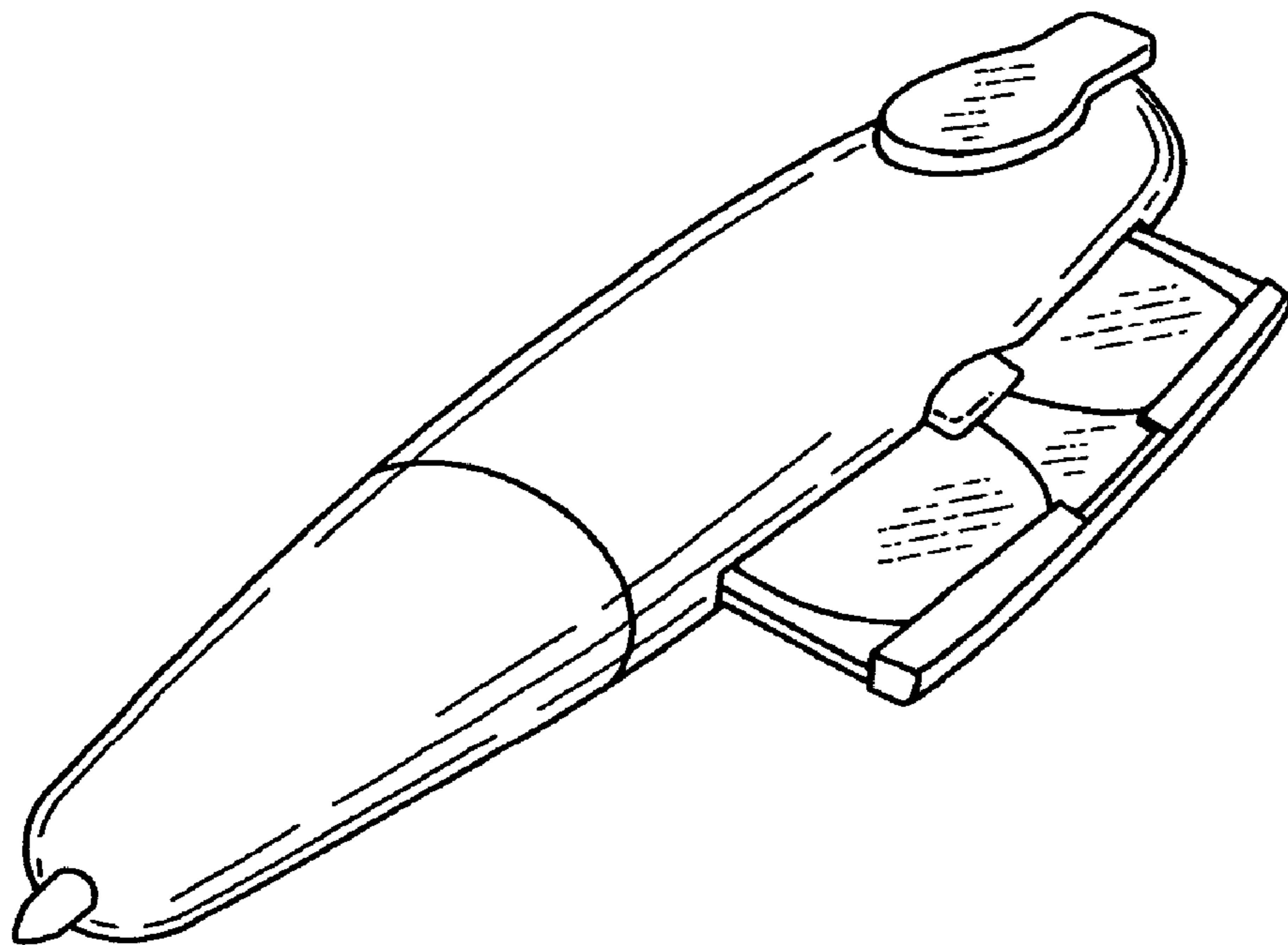
