FIG. 4 is a bottom perspective view thereof;

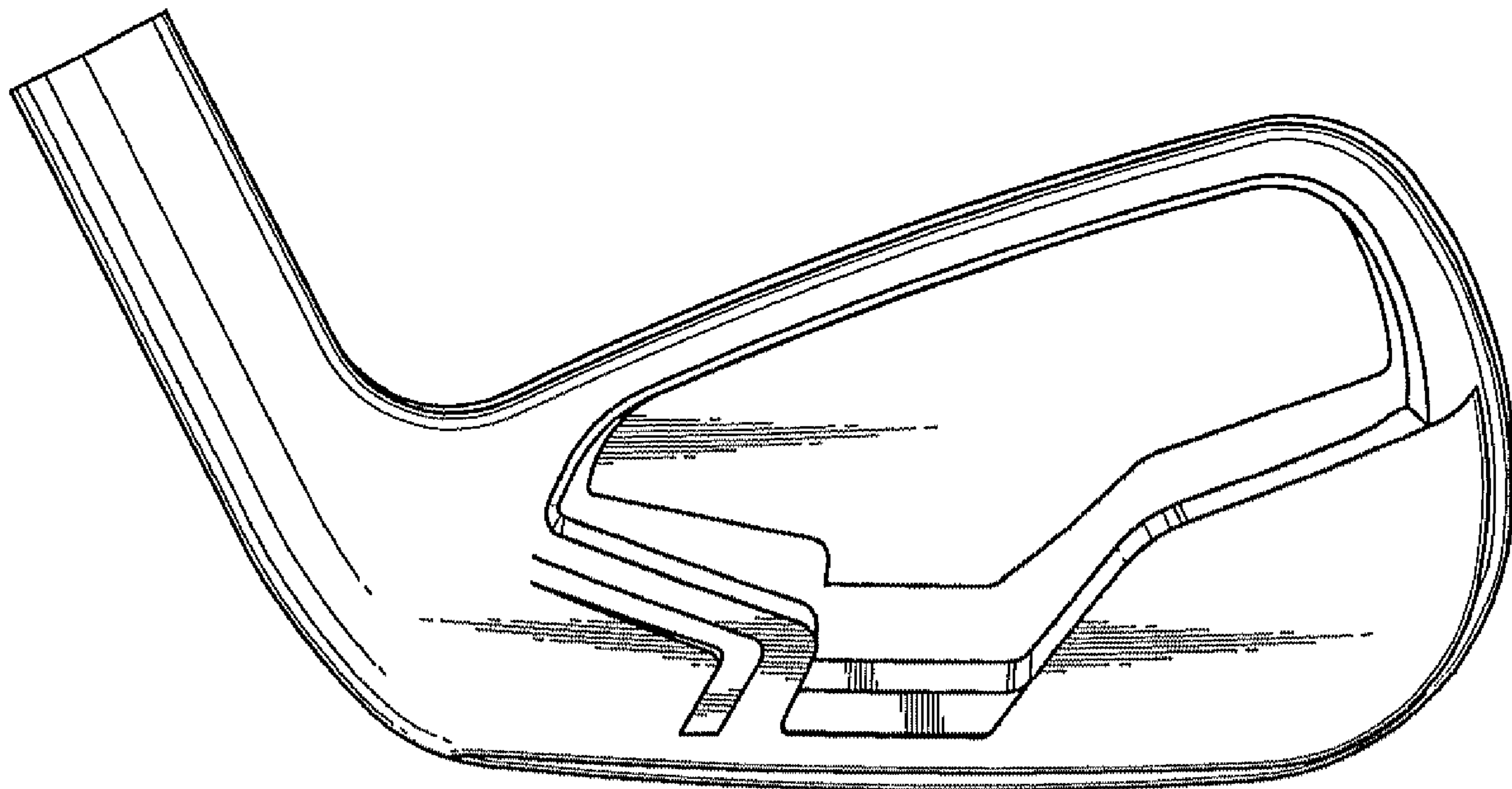
FIG. 5 is a heel side elevational view thereof;

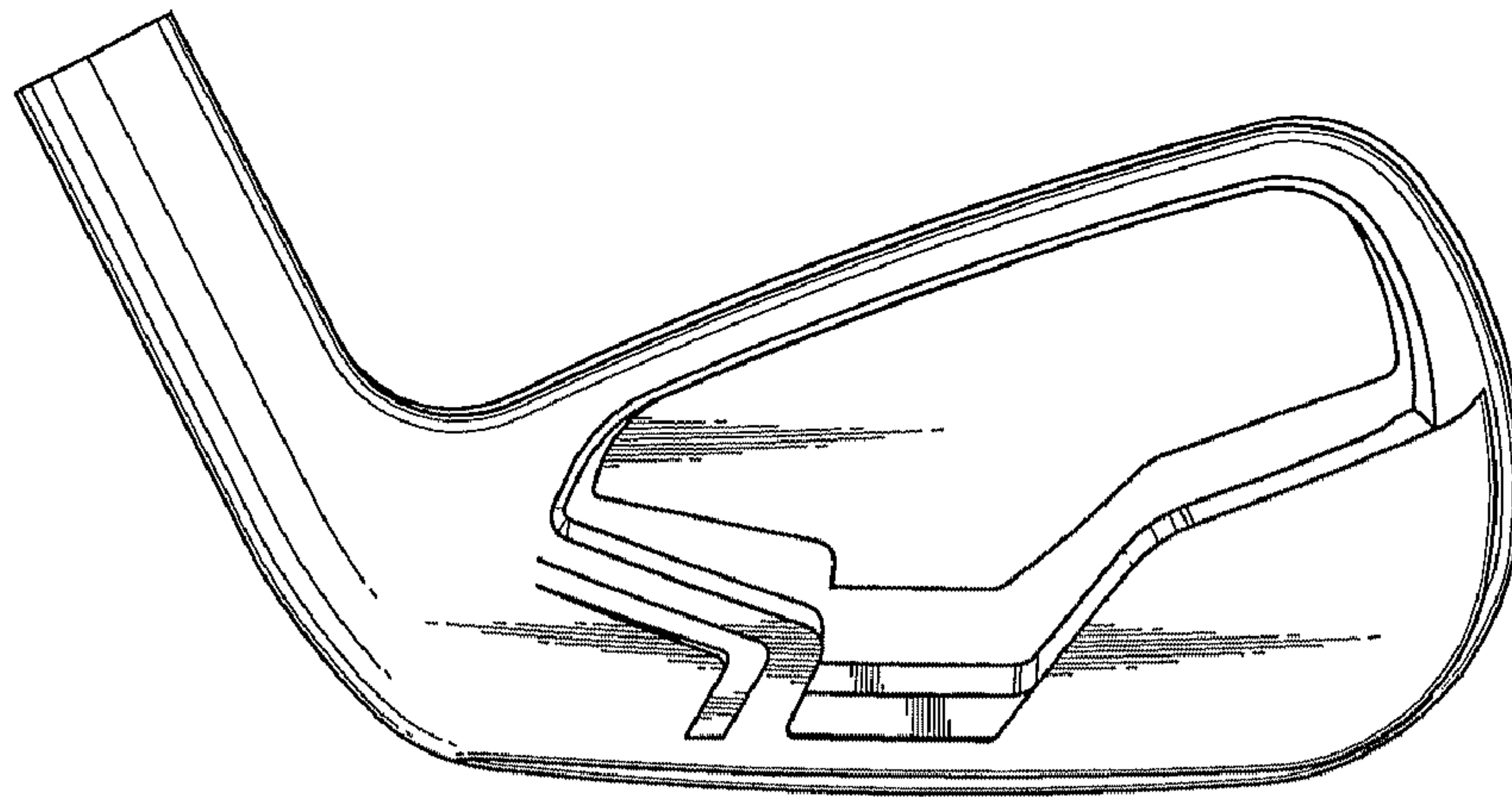

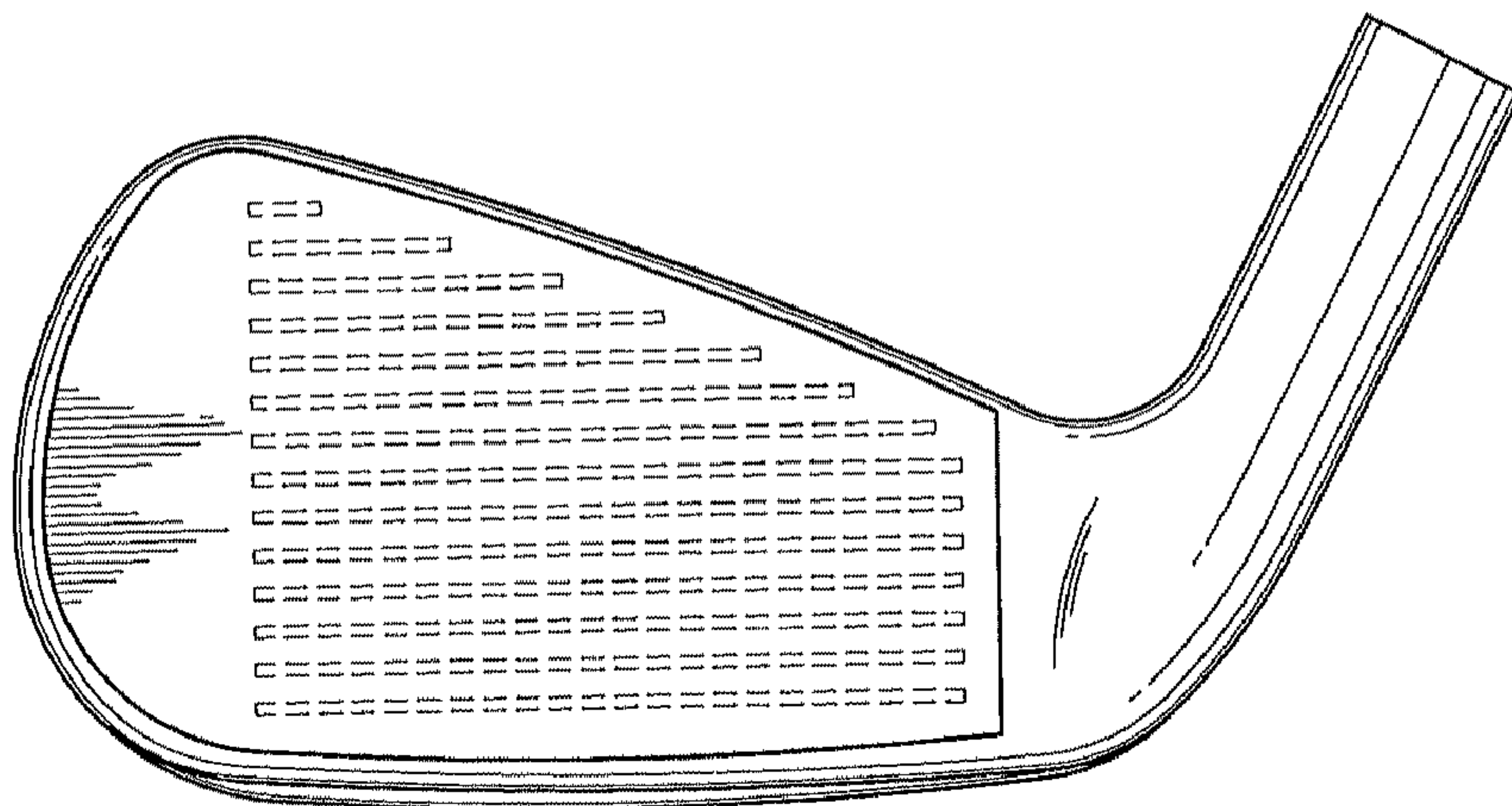

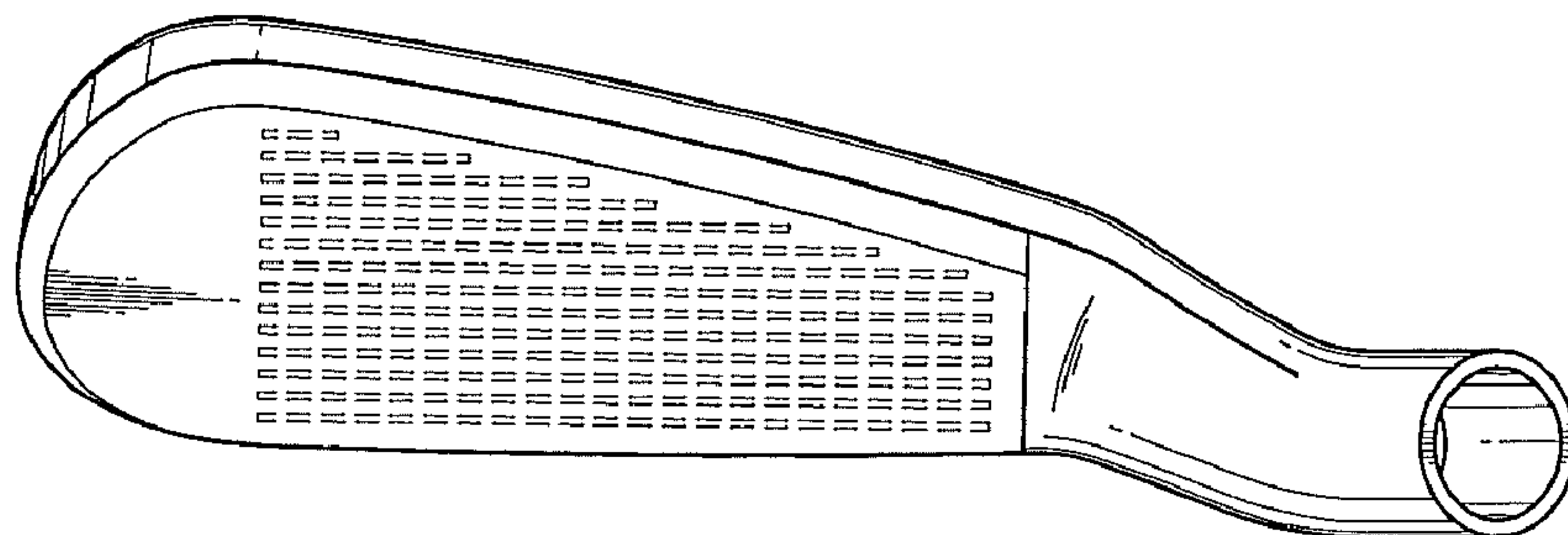

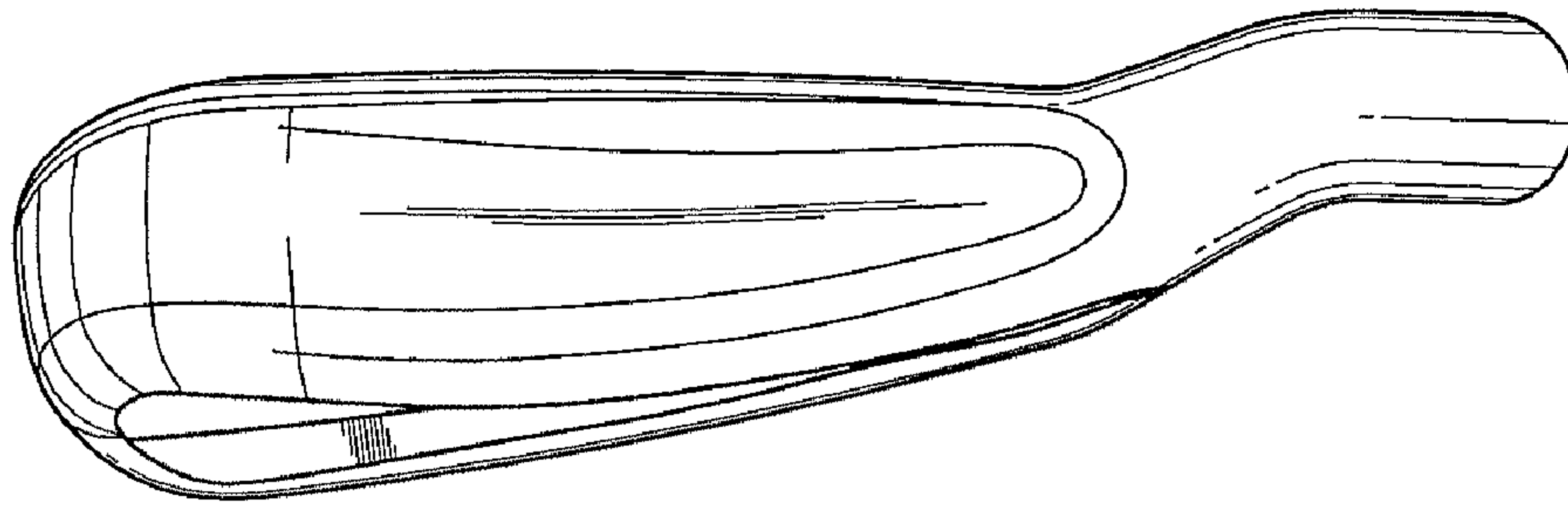

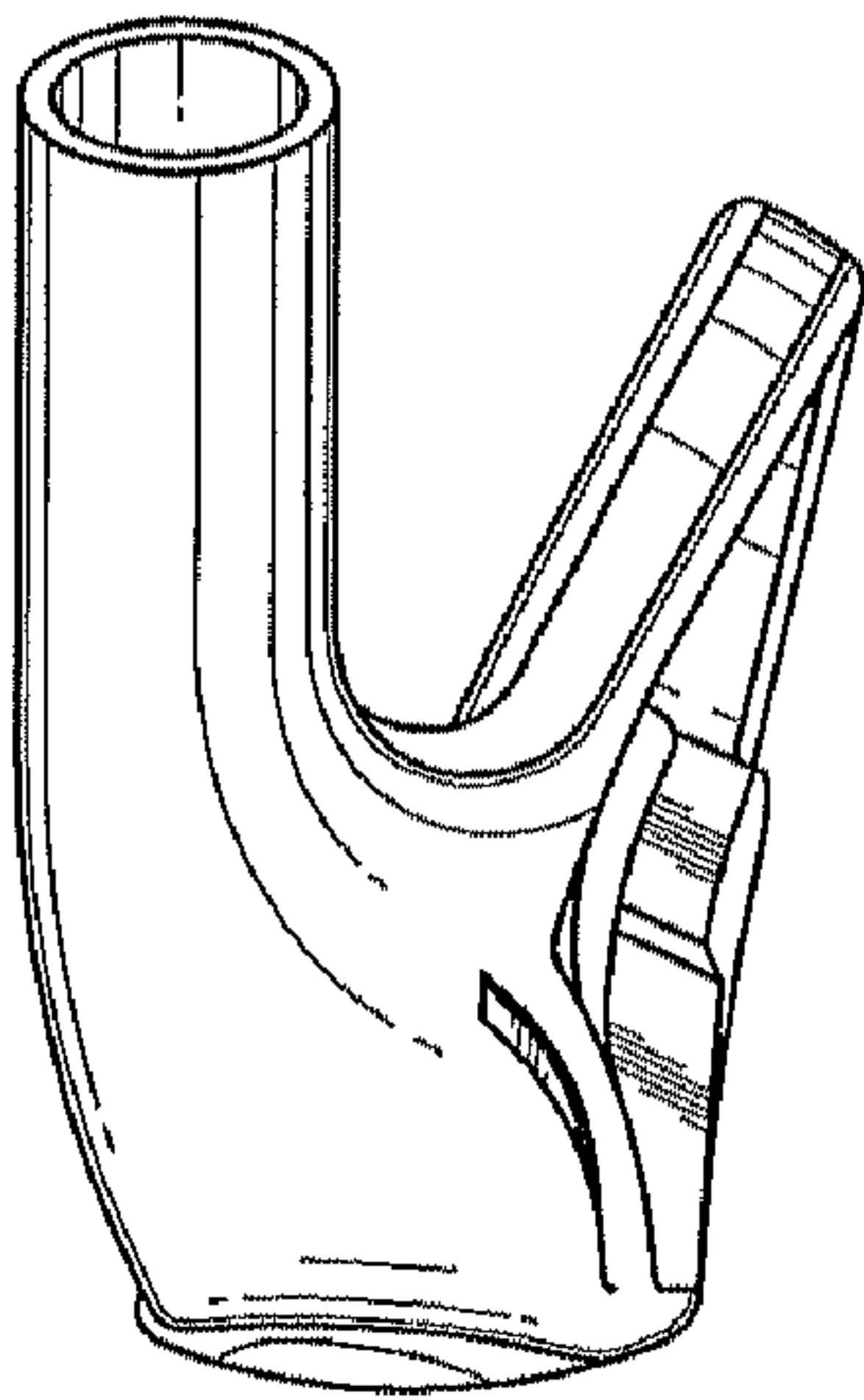

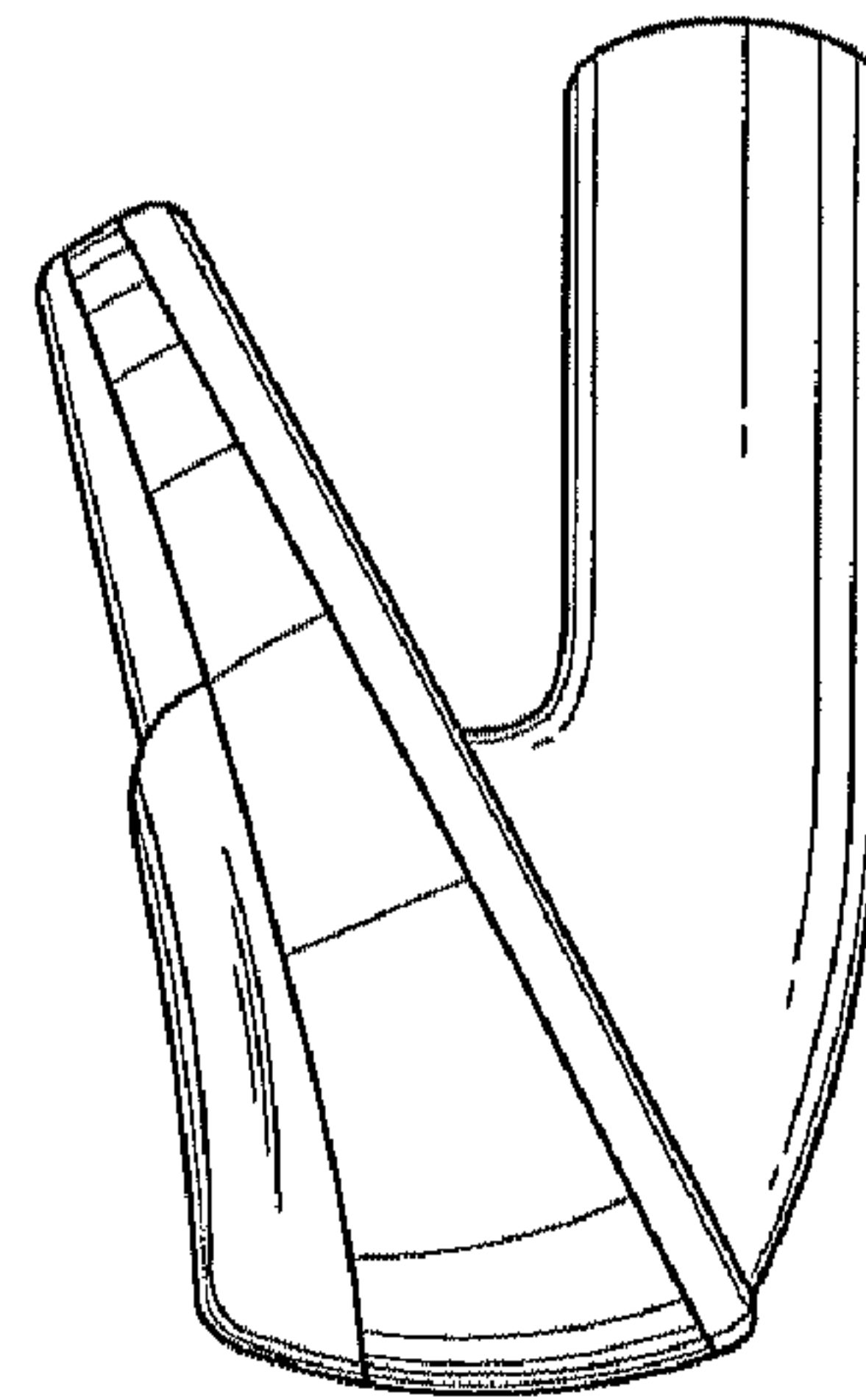

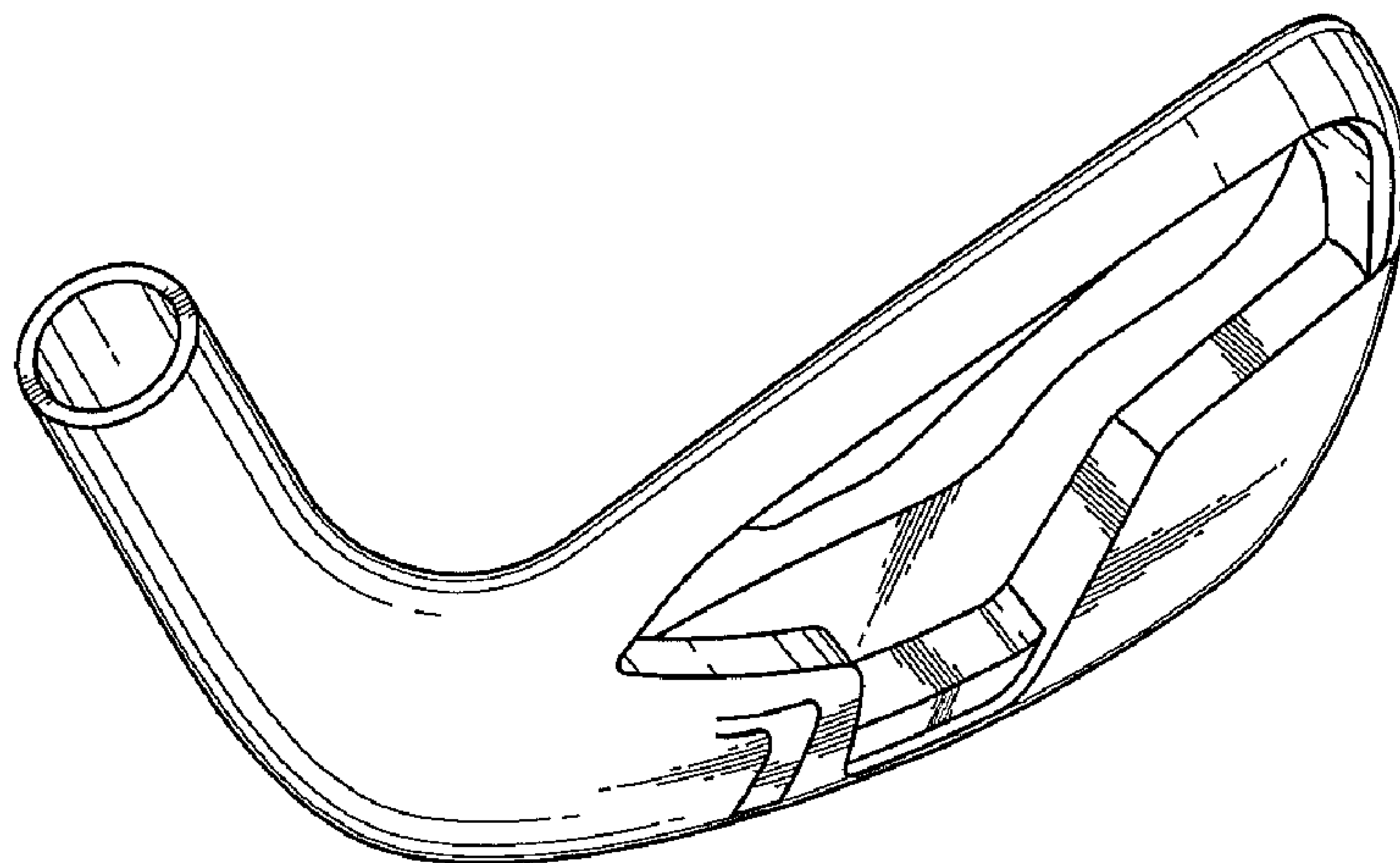
