FIG. 13 is a top view of an alternative embodiment thereof; and,

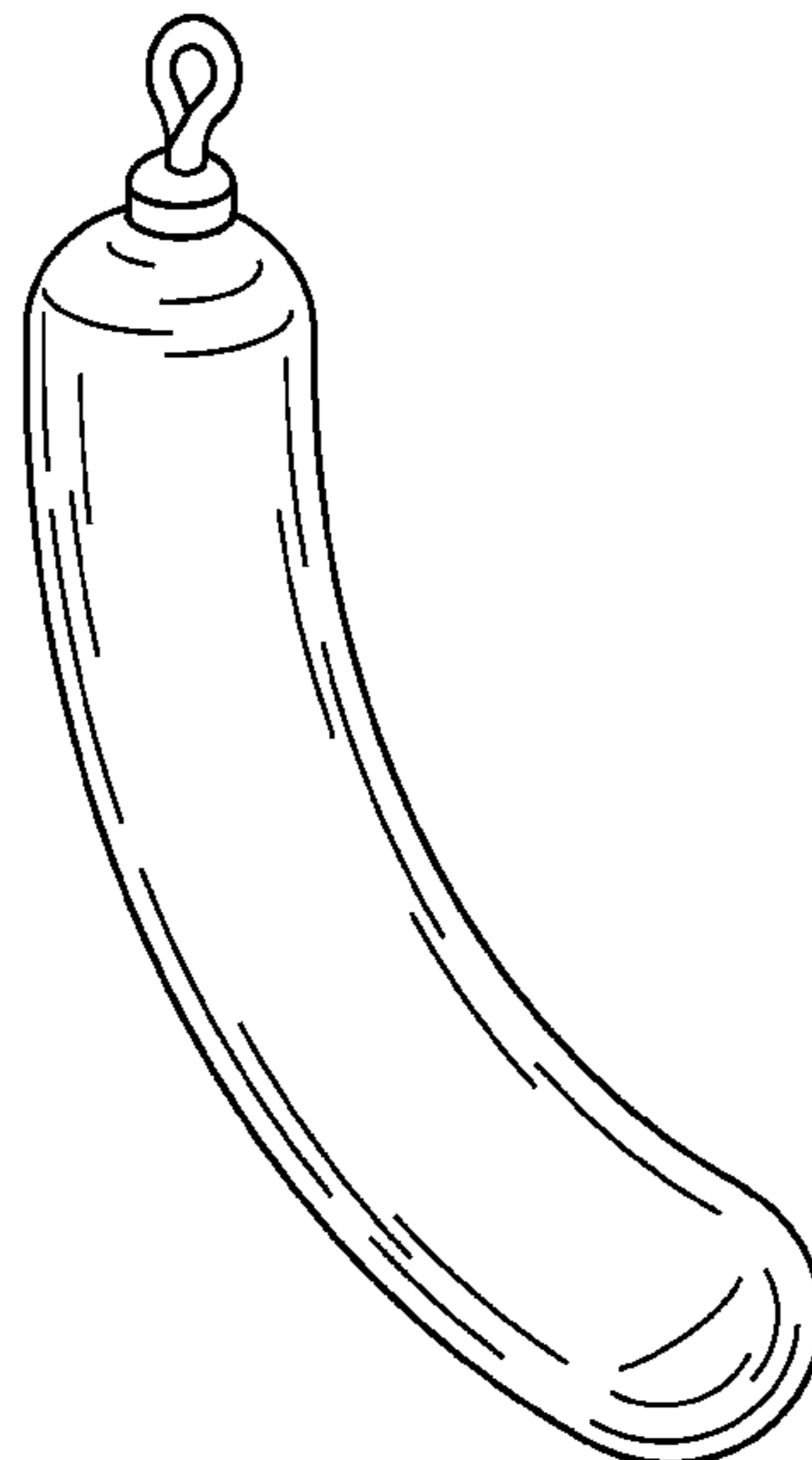
FIG. 14 is a bottom view of an alternative embodiment thereof.

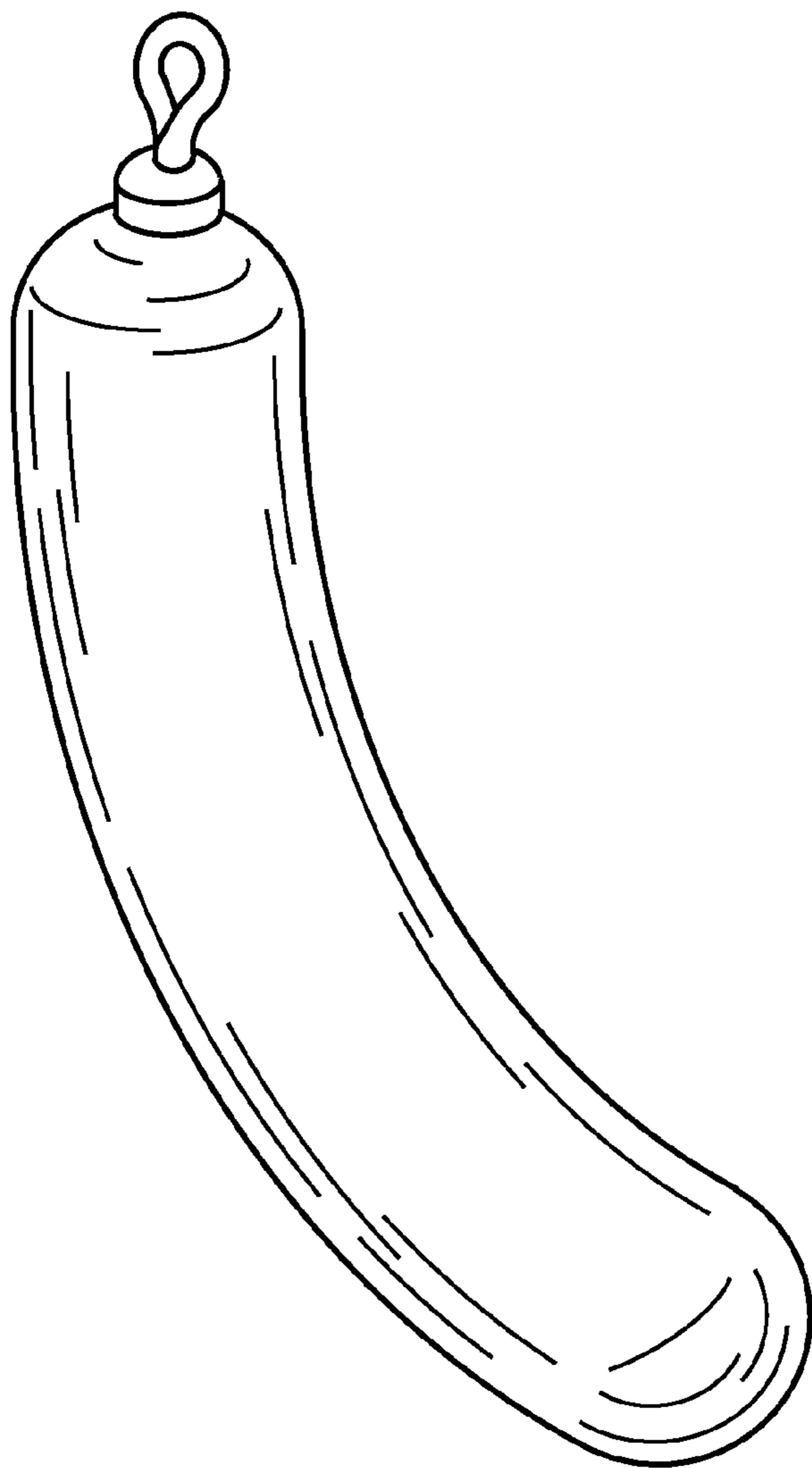

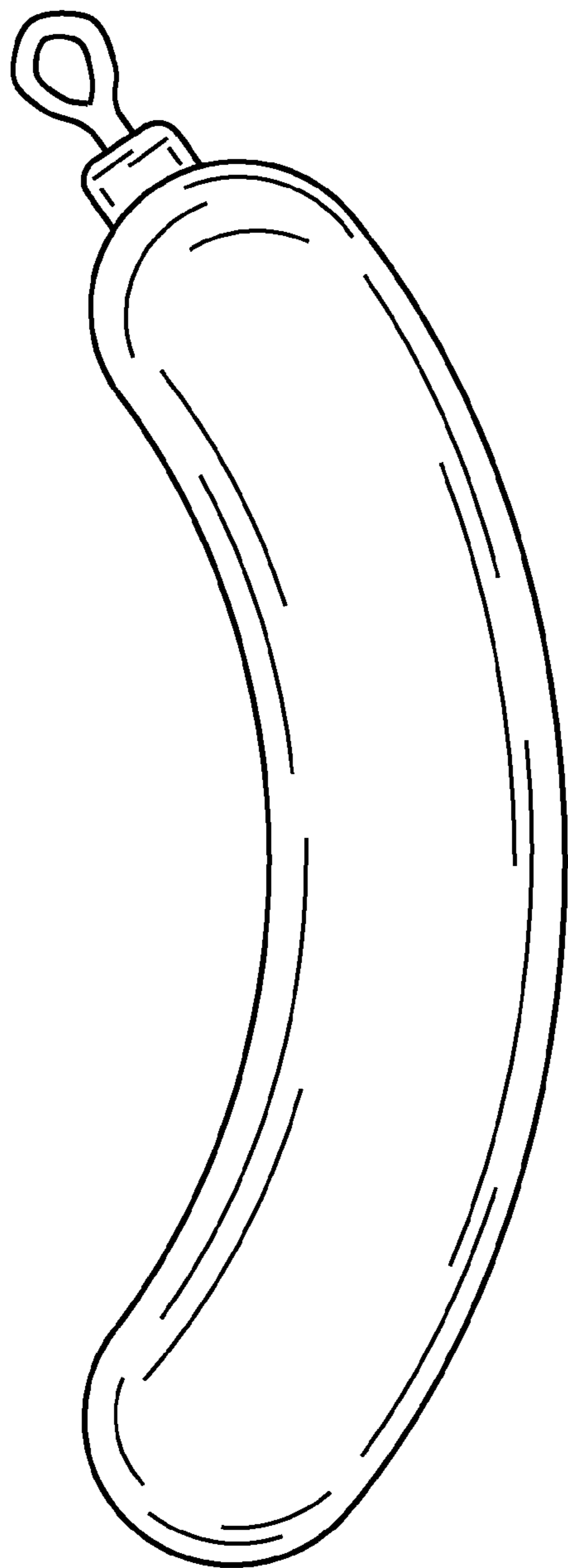




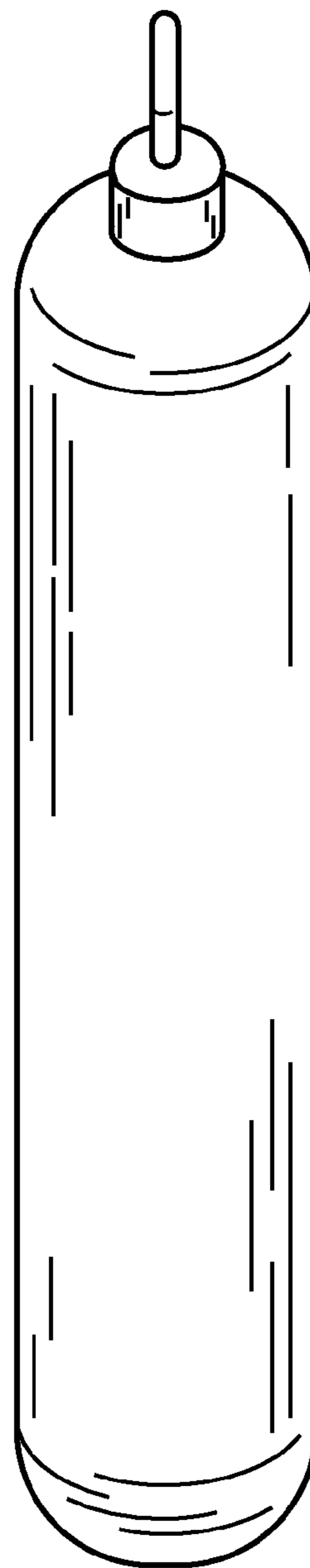

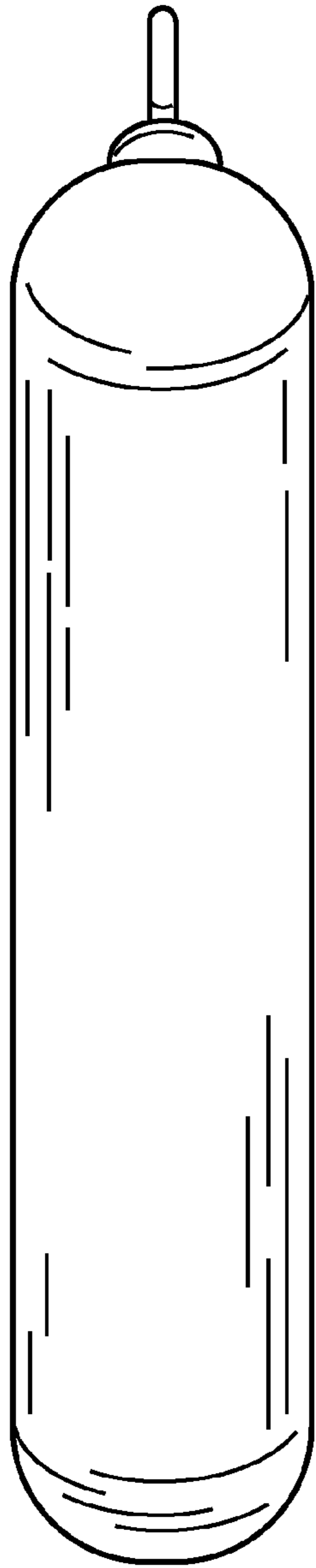

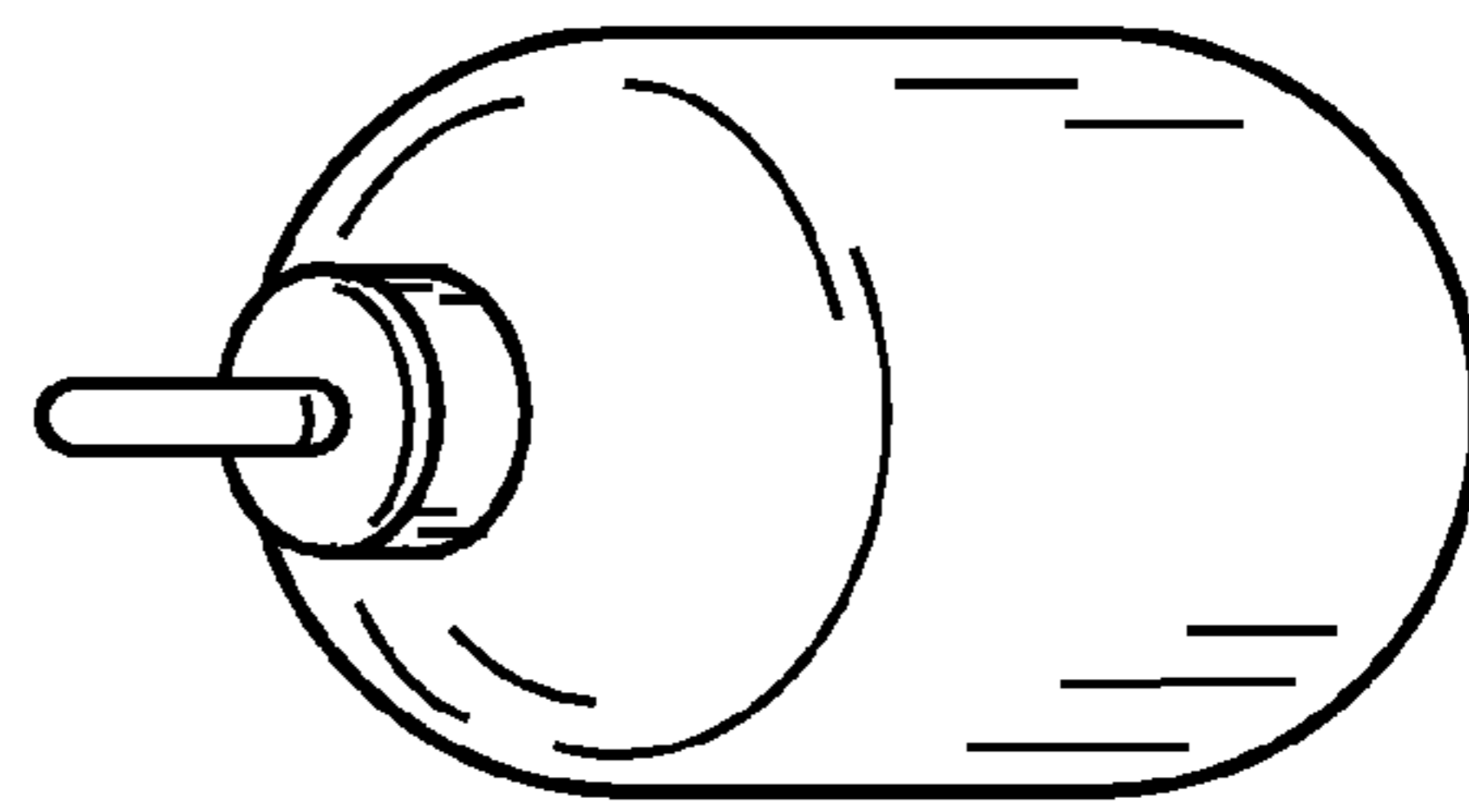

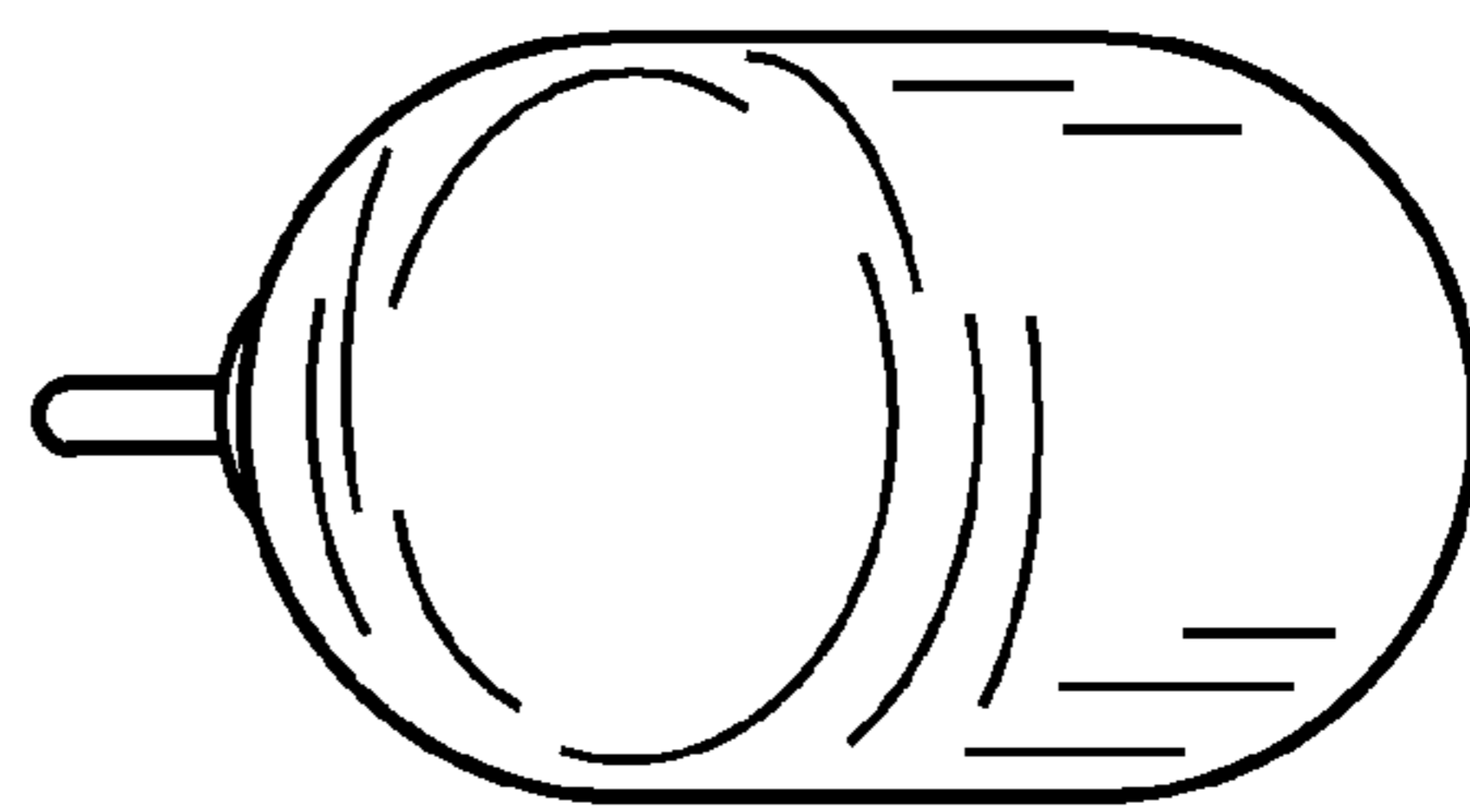

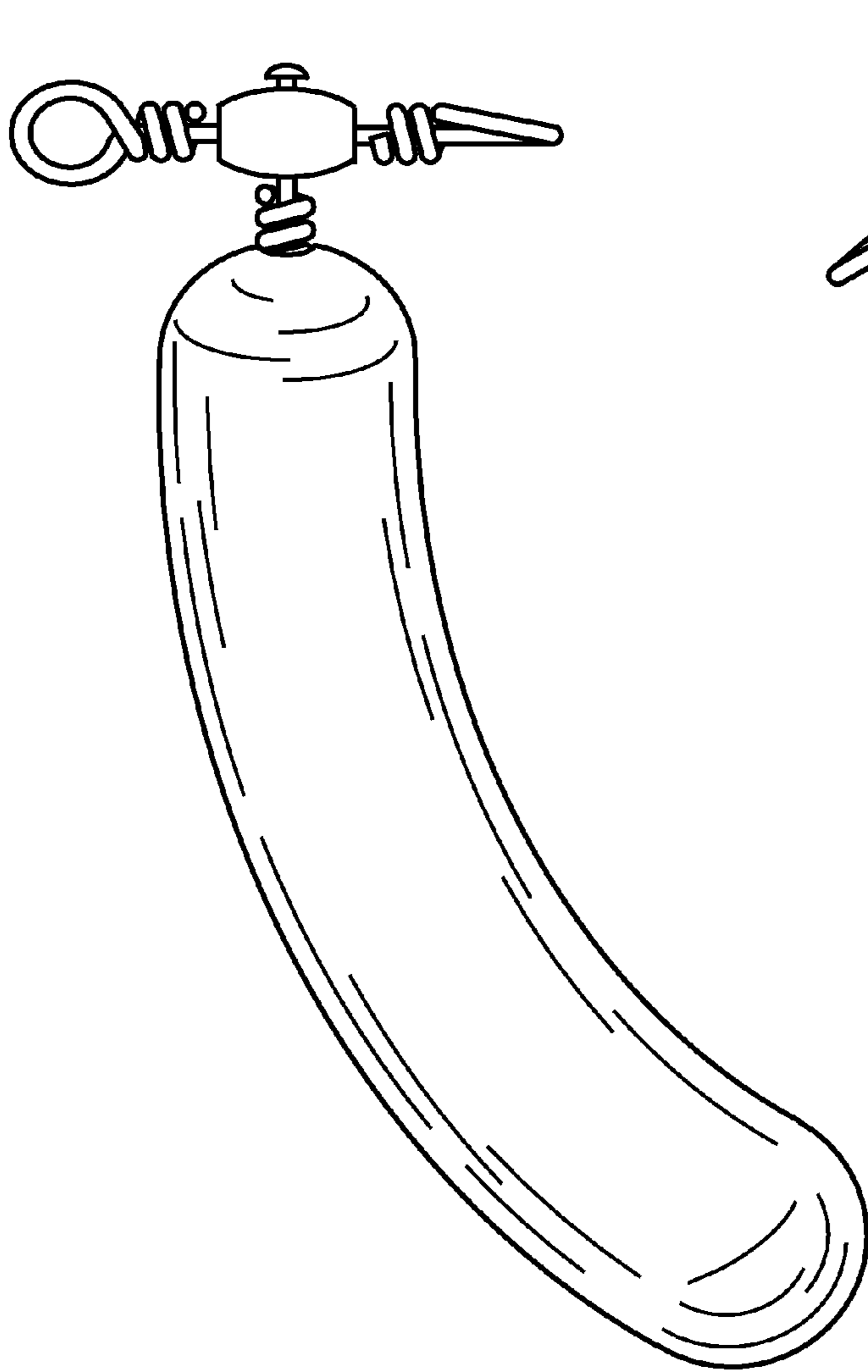

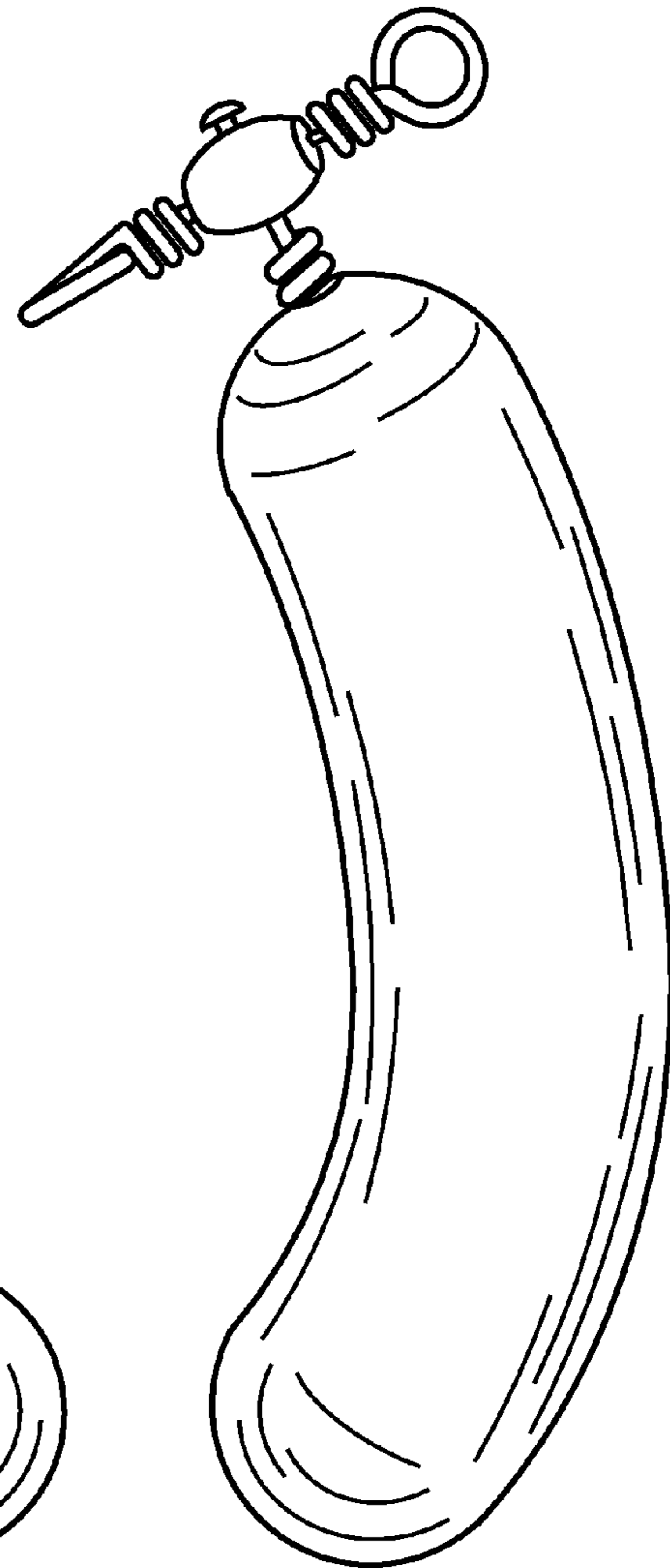
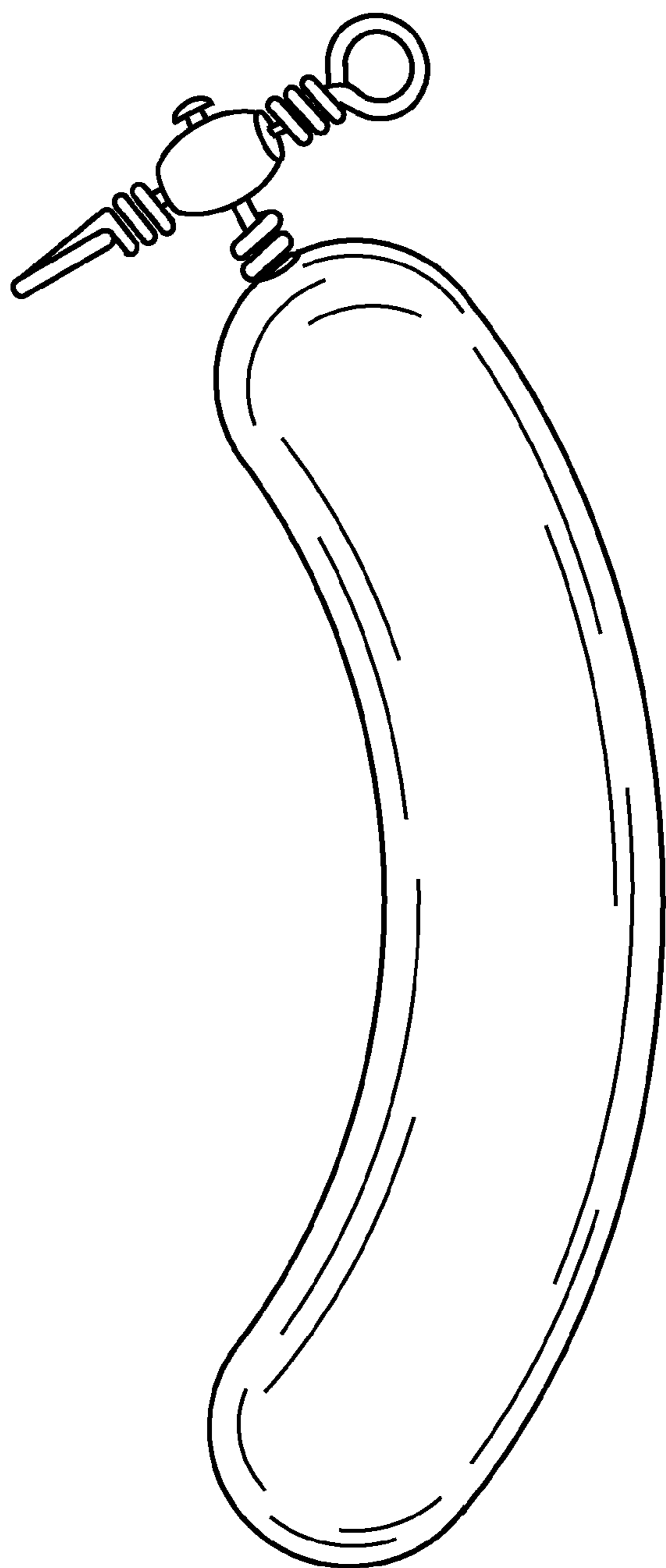
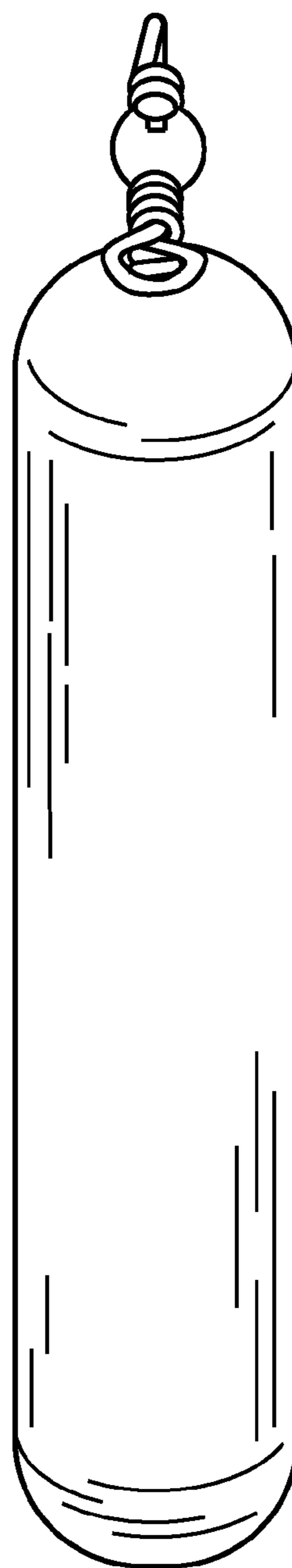

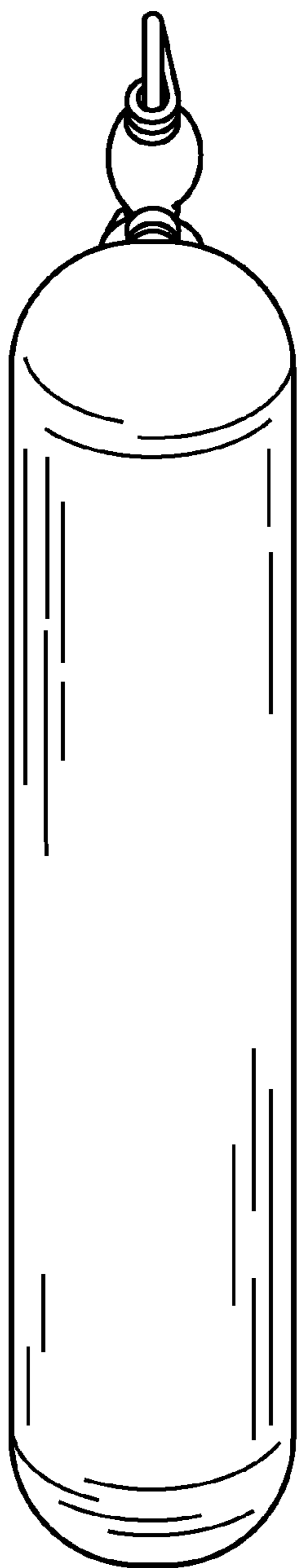

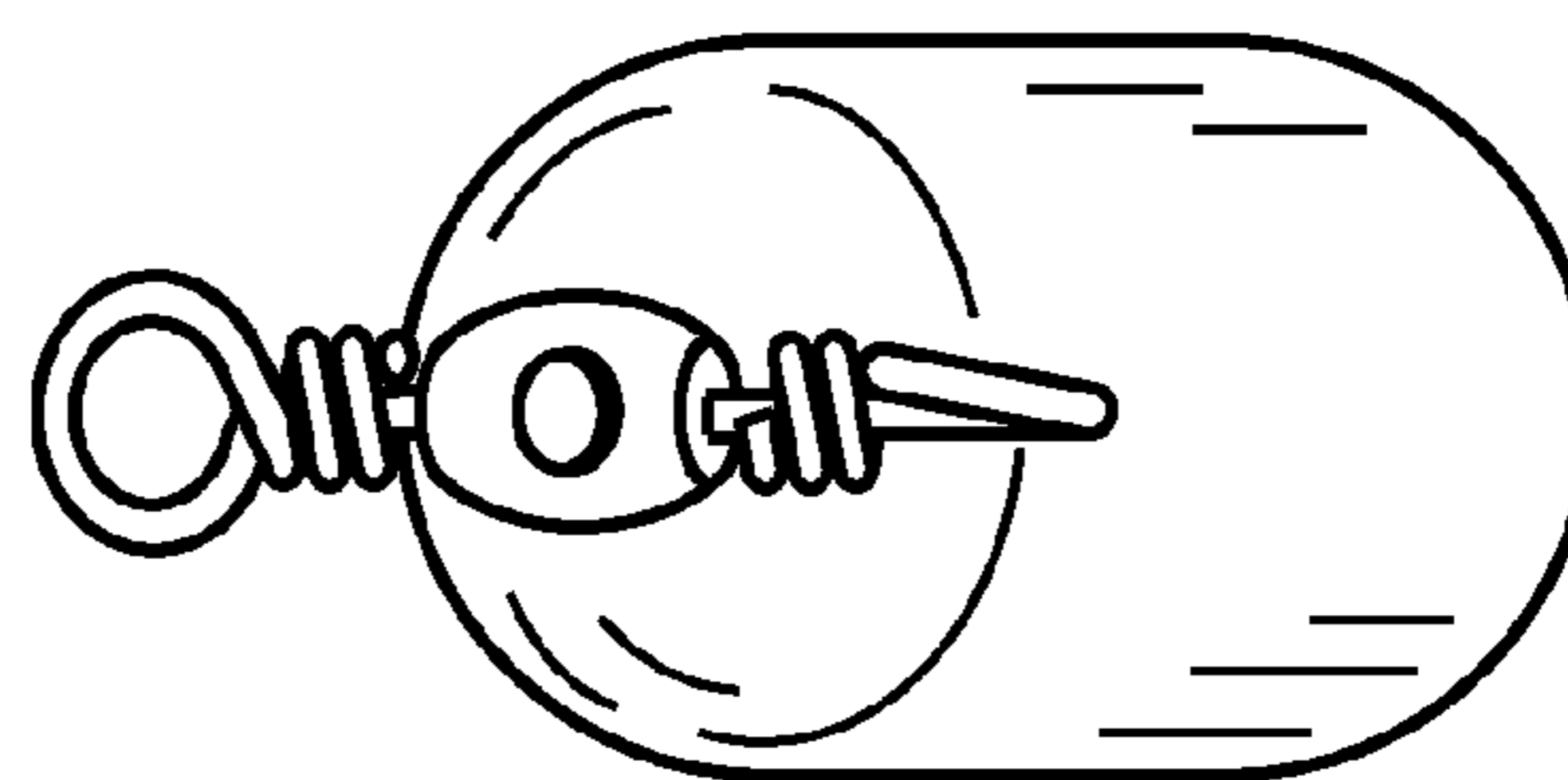

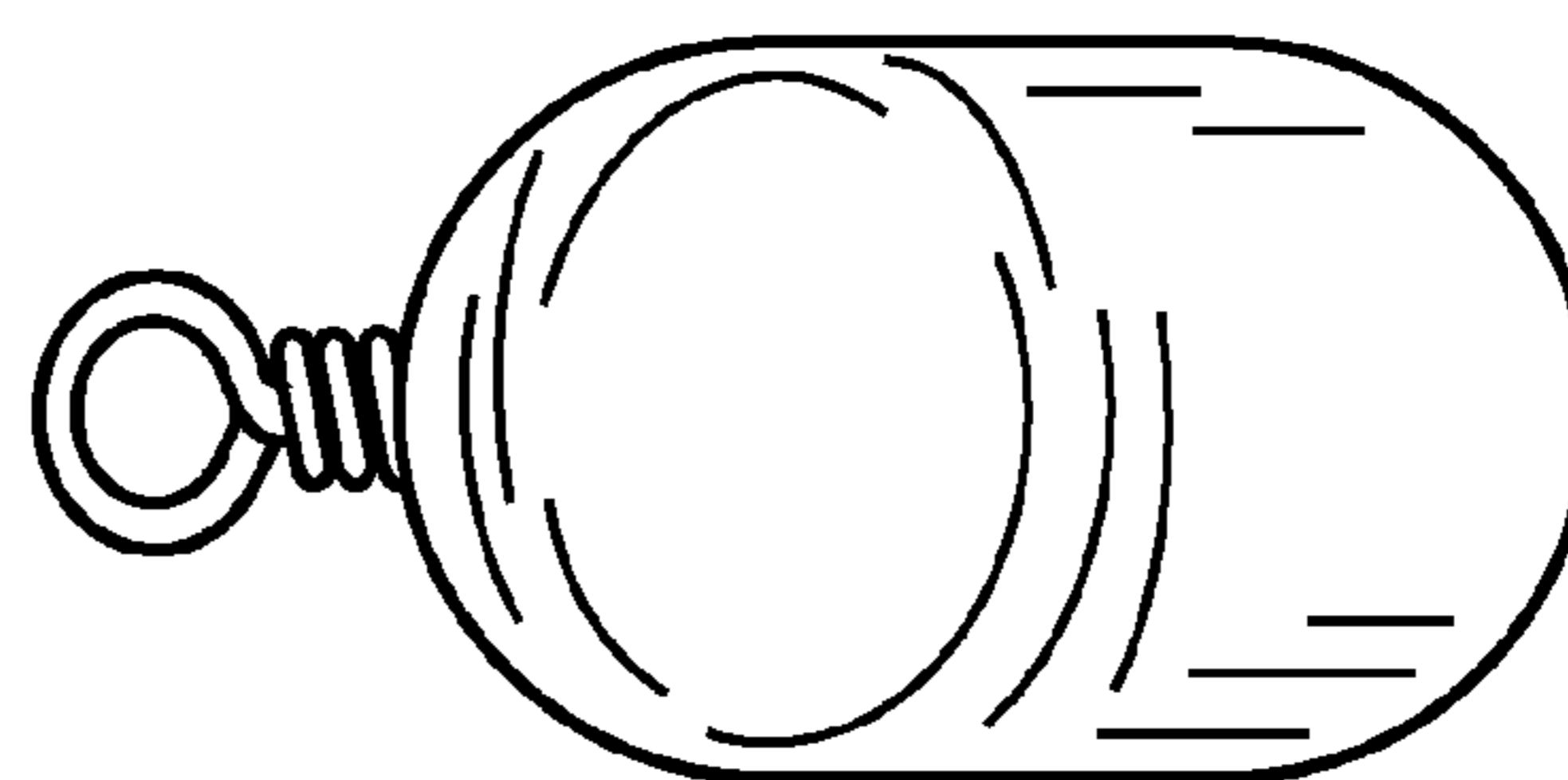
