DESCRIPTION

FIG. 1 is a perspective view of a massager according to the present invention;

FIG. 4 is a rear elevational view of the massager of FIG. 1;

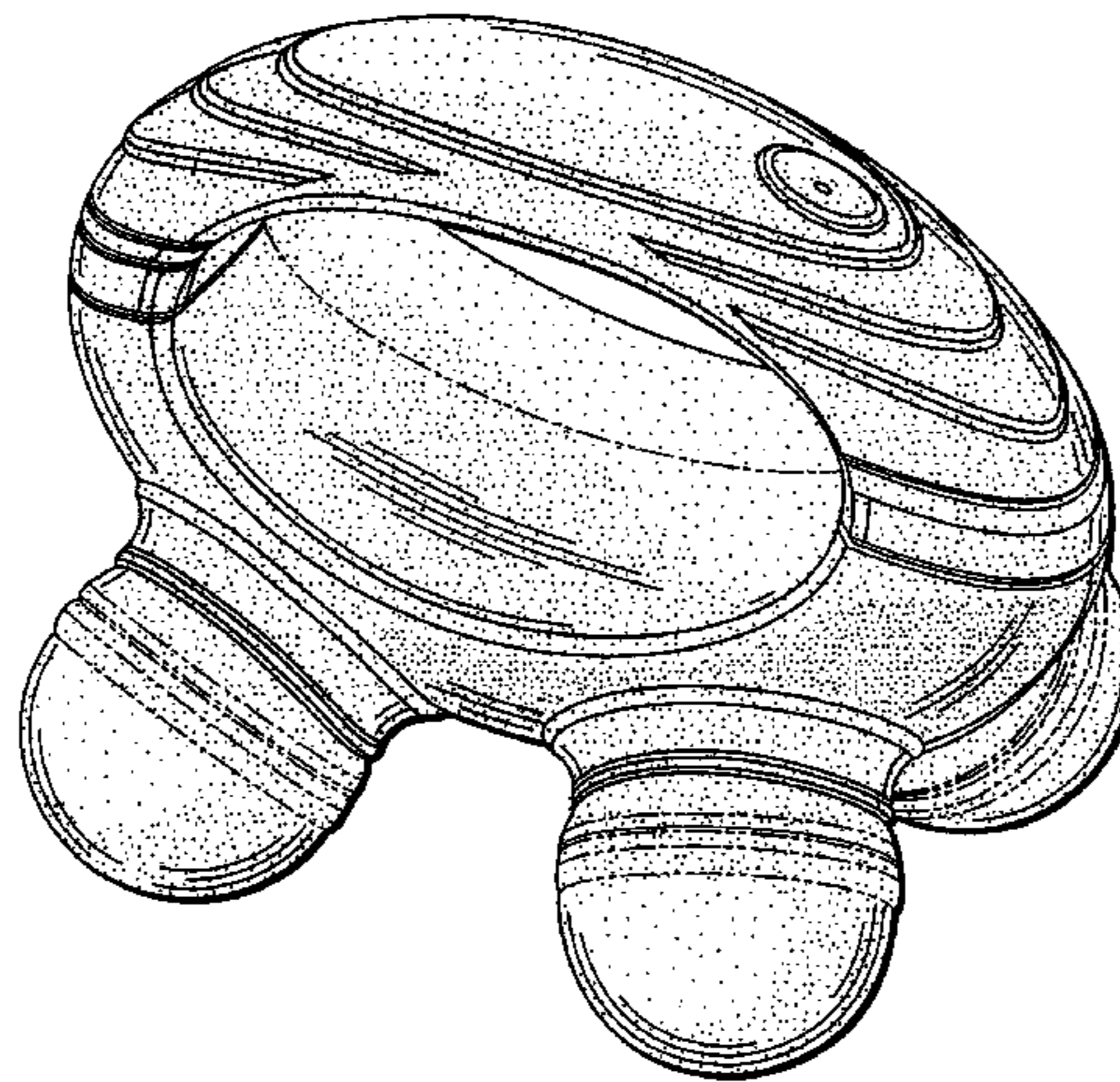
FIG. 5 is a front elevational view of the massager of FIG. 1;

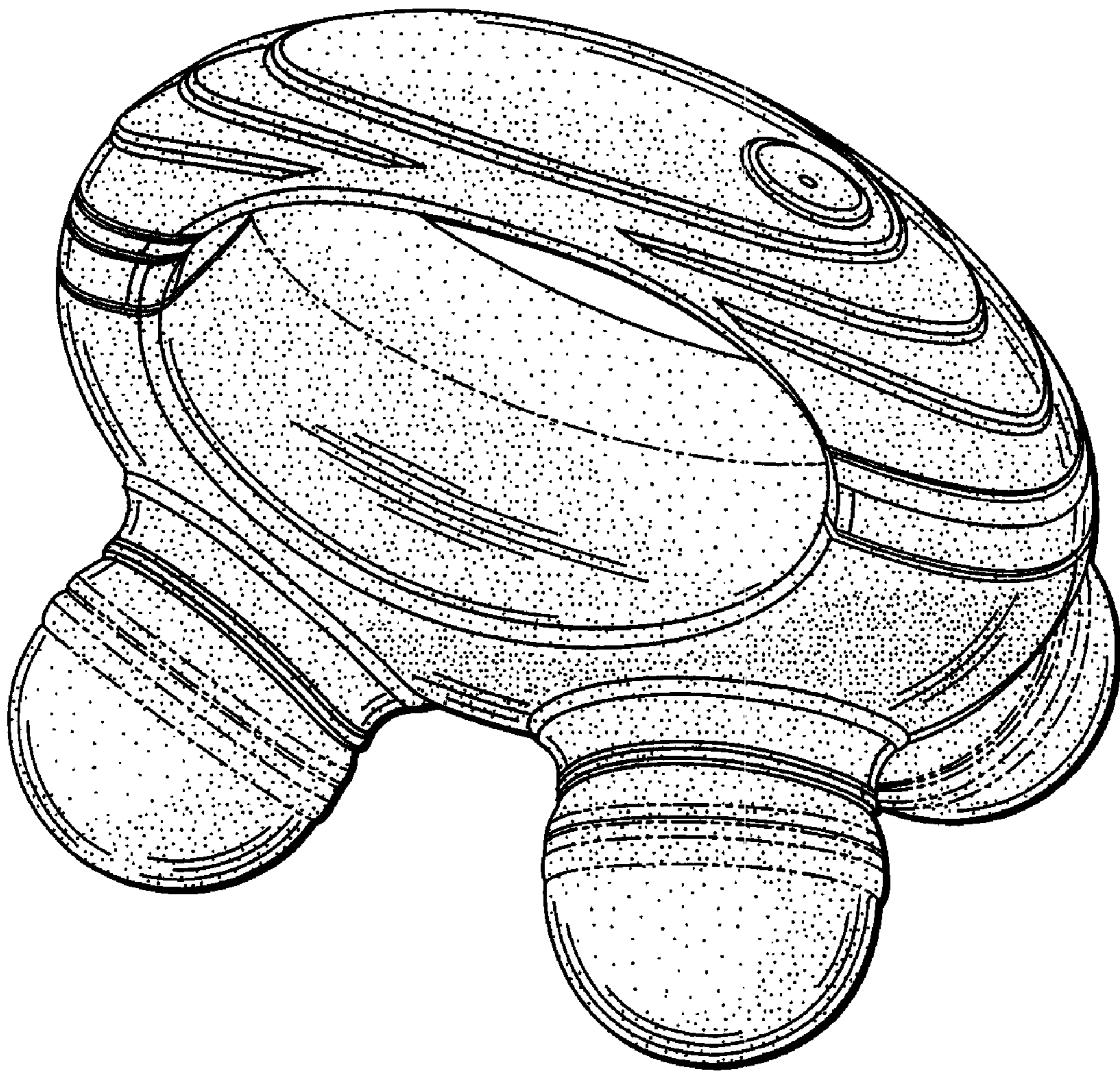

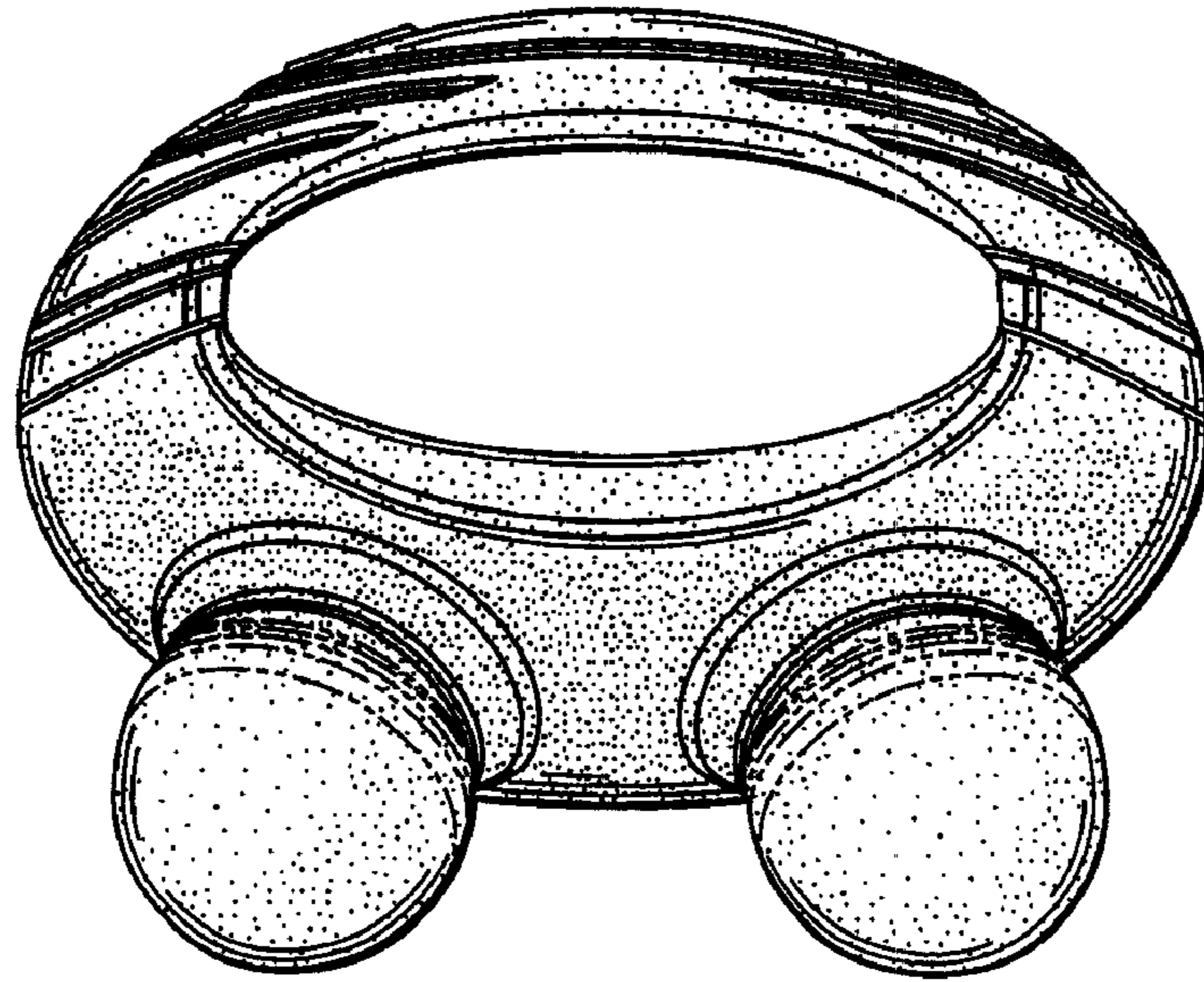

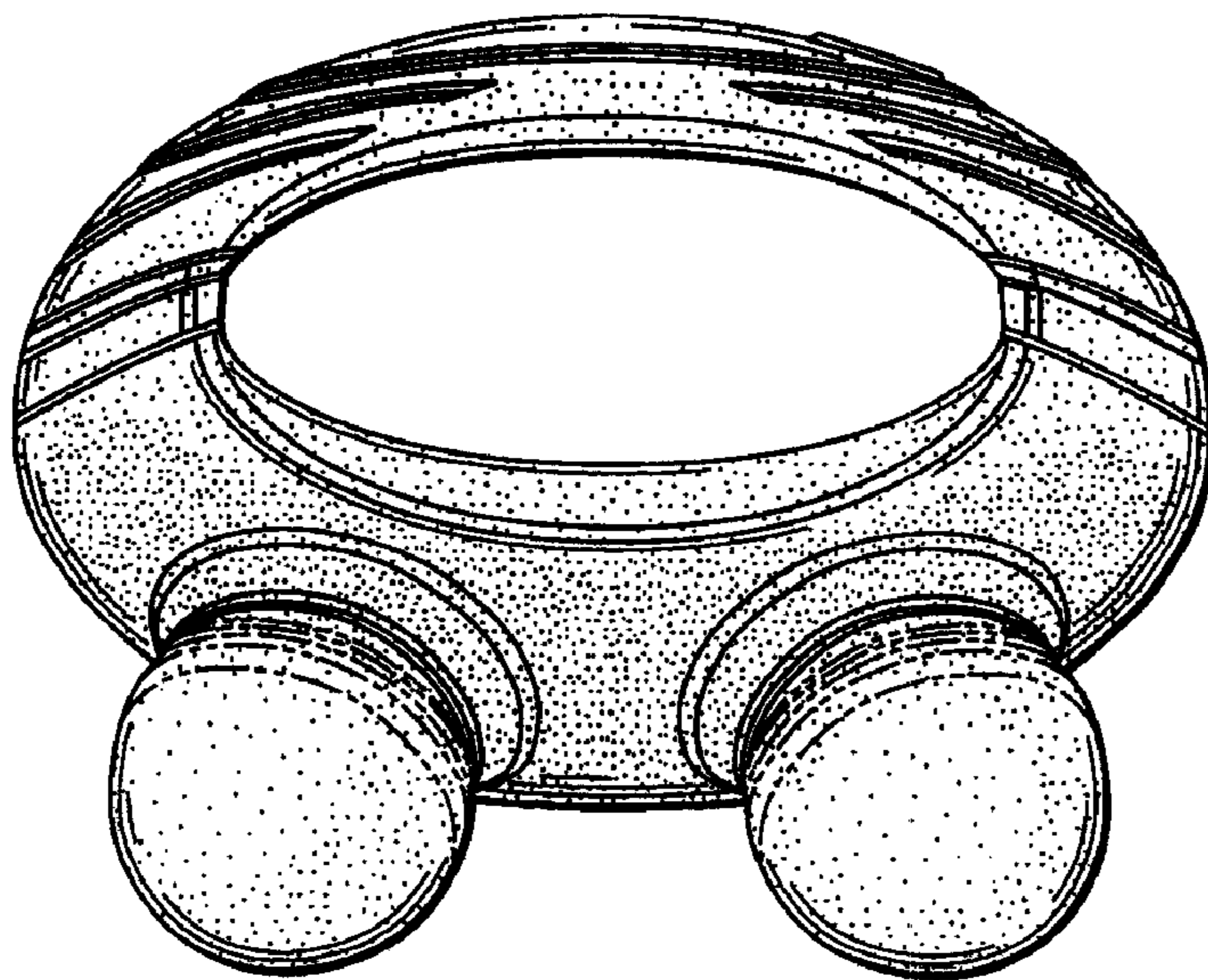

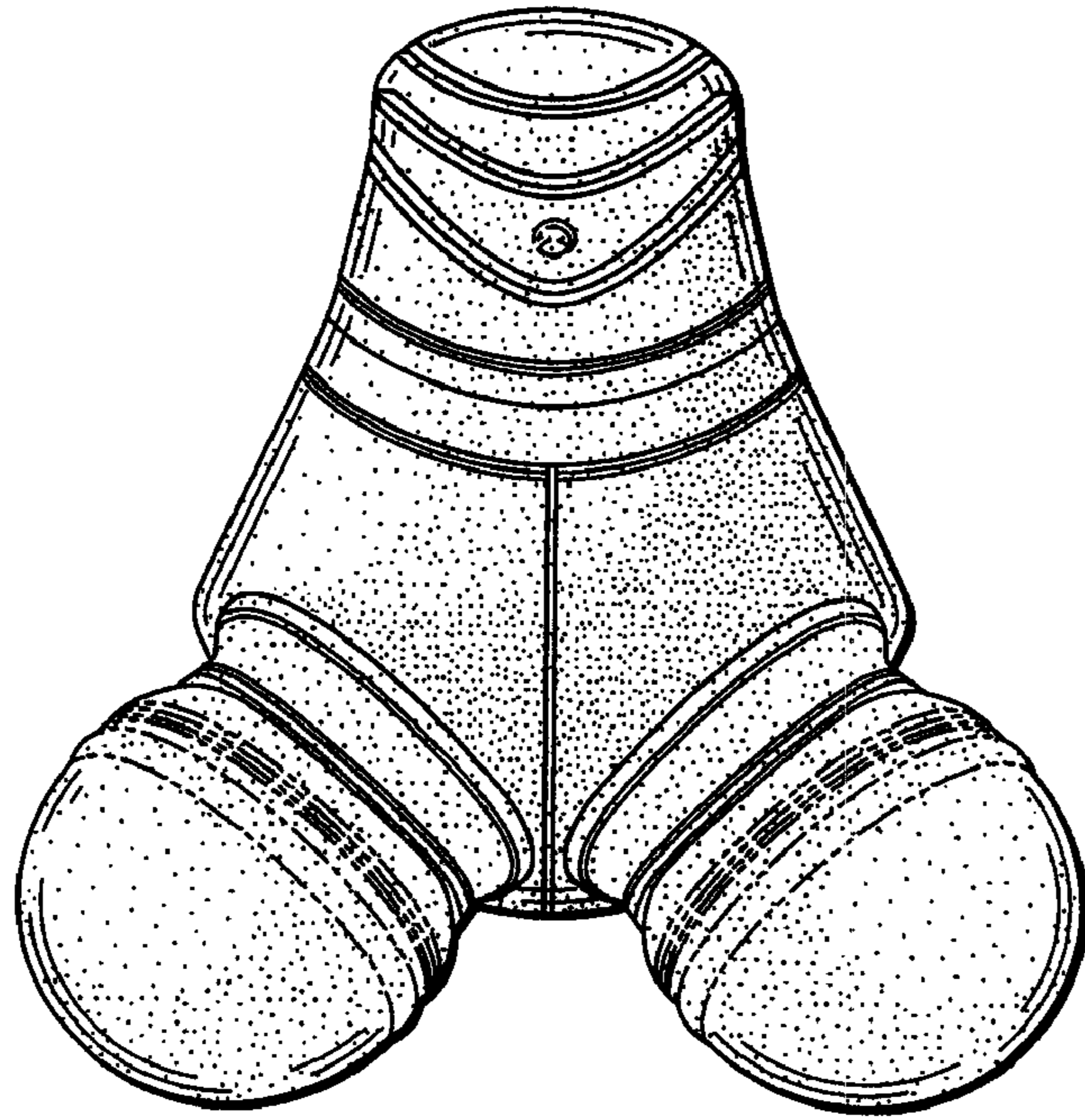

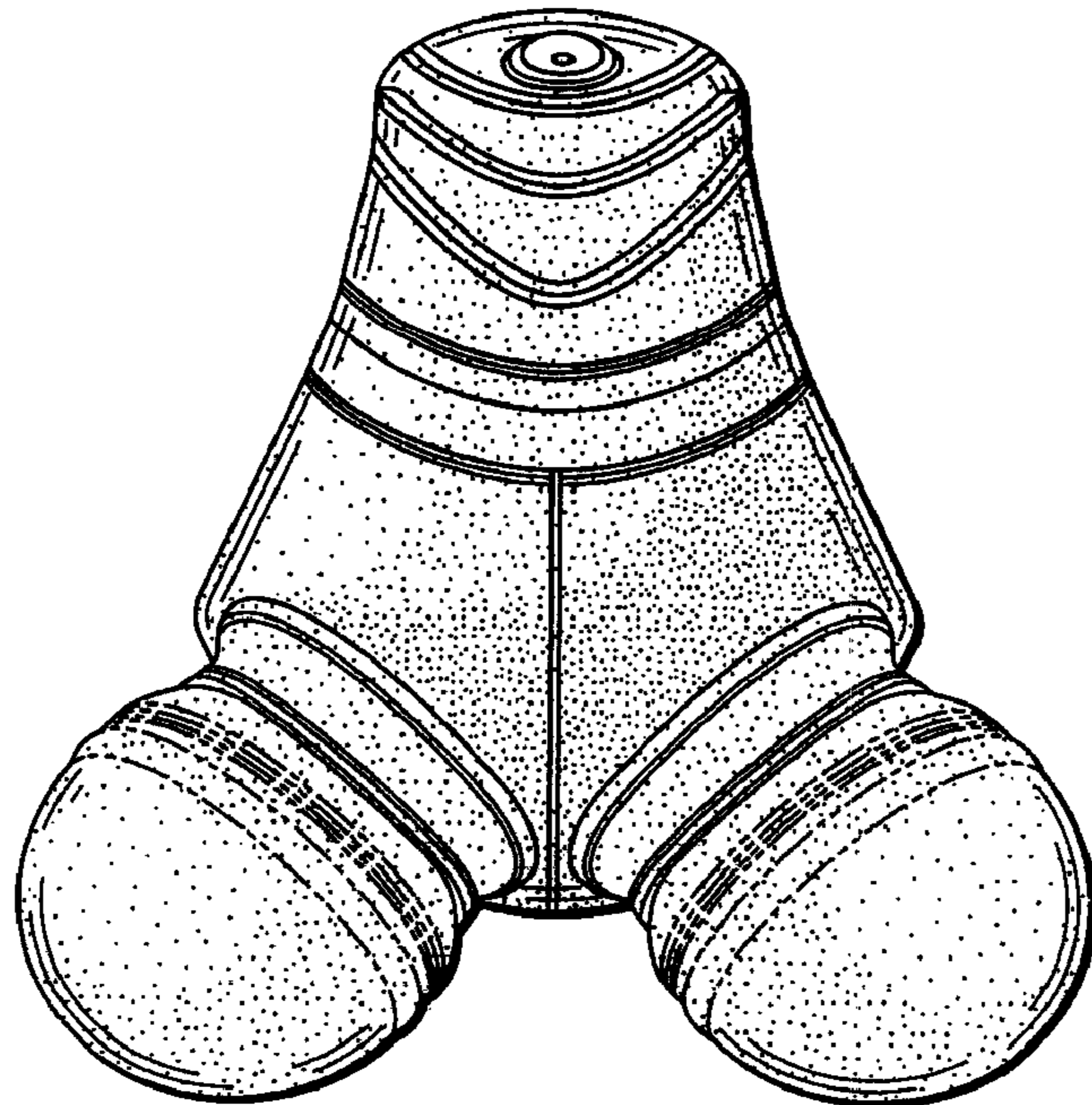

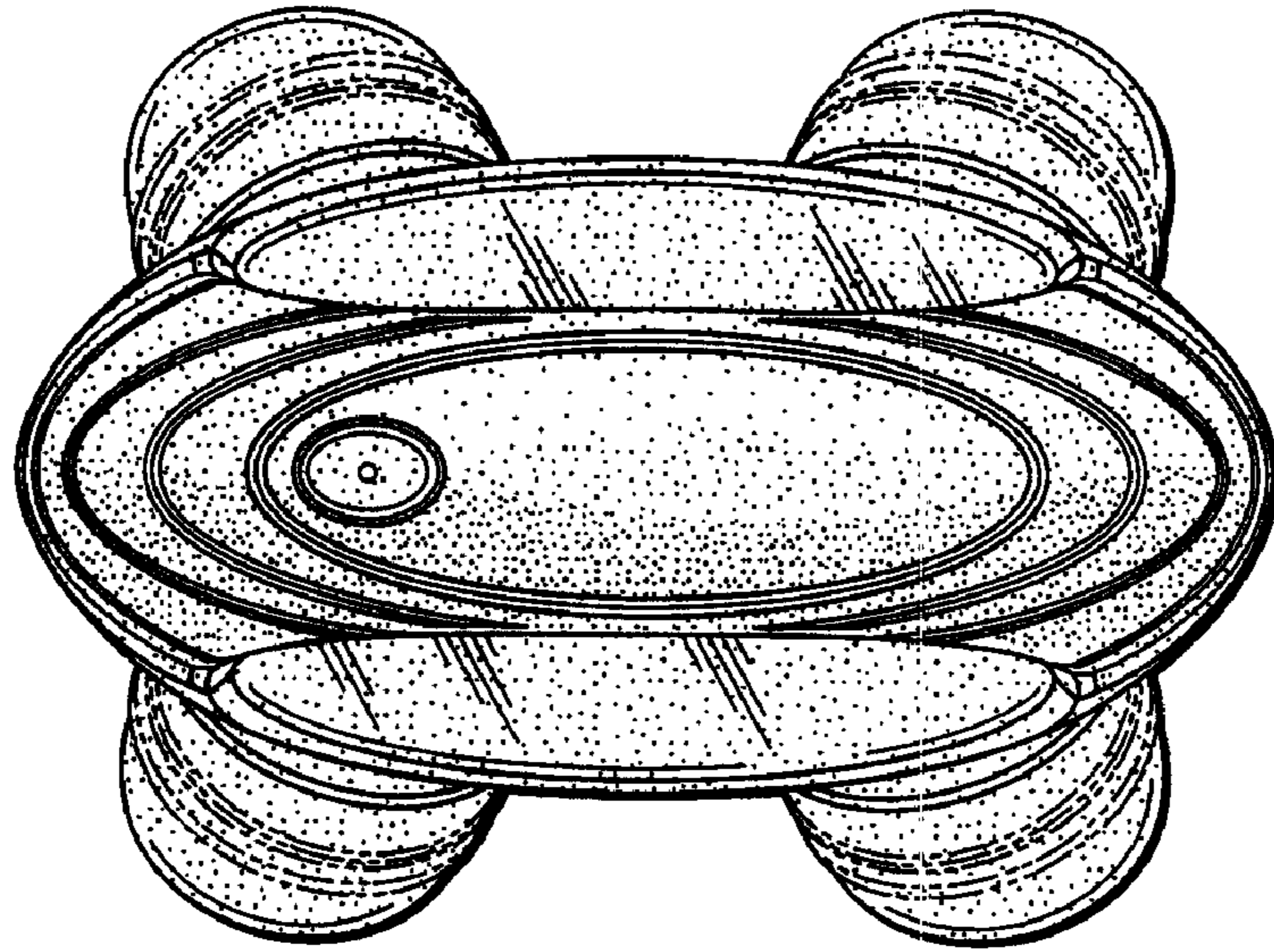

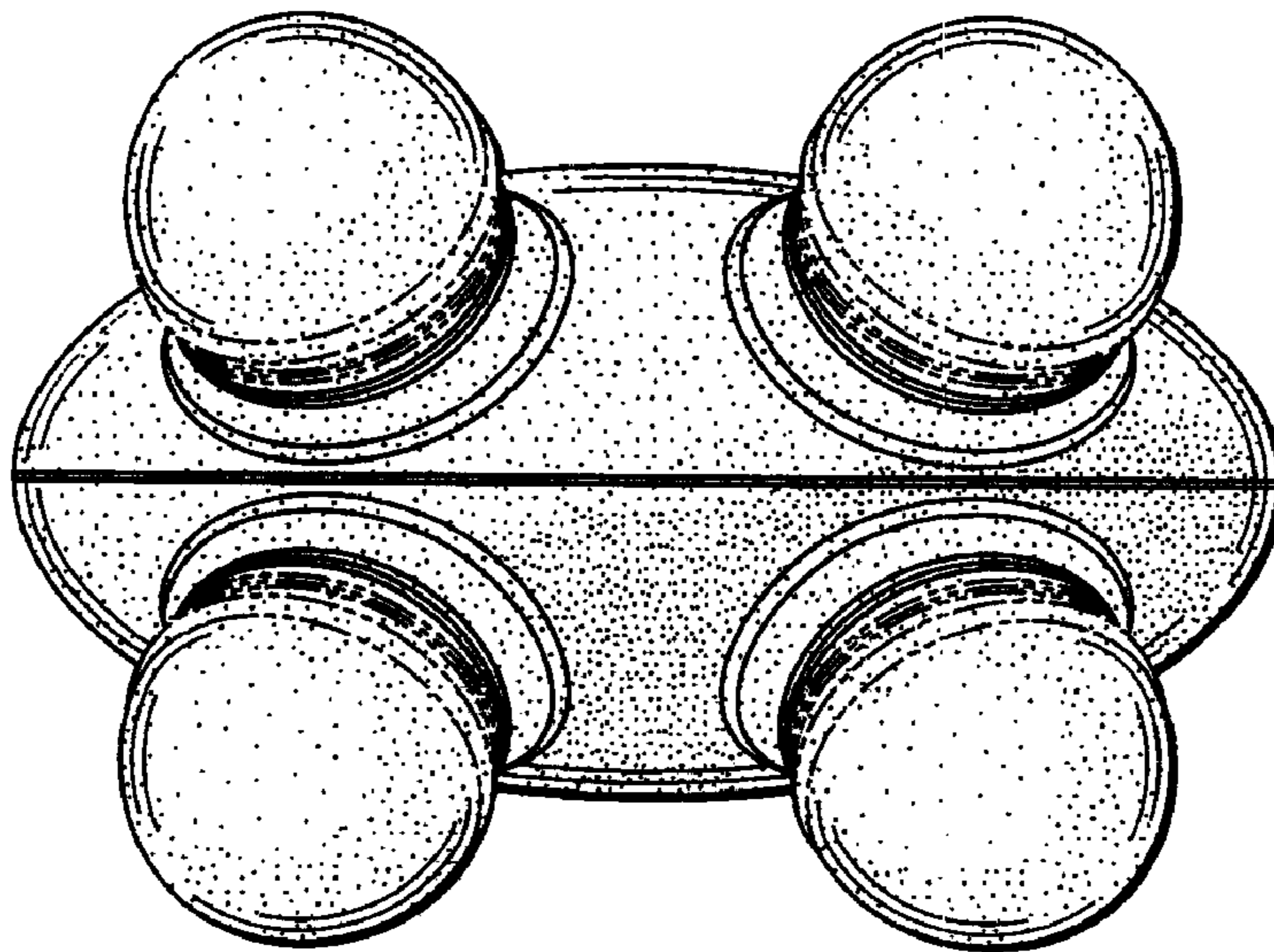
