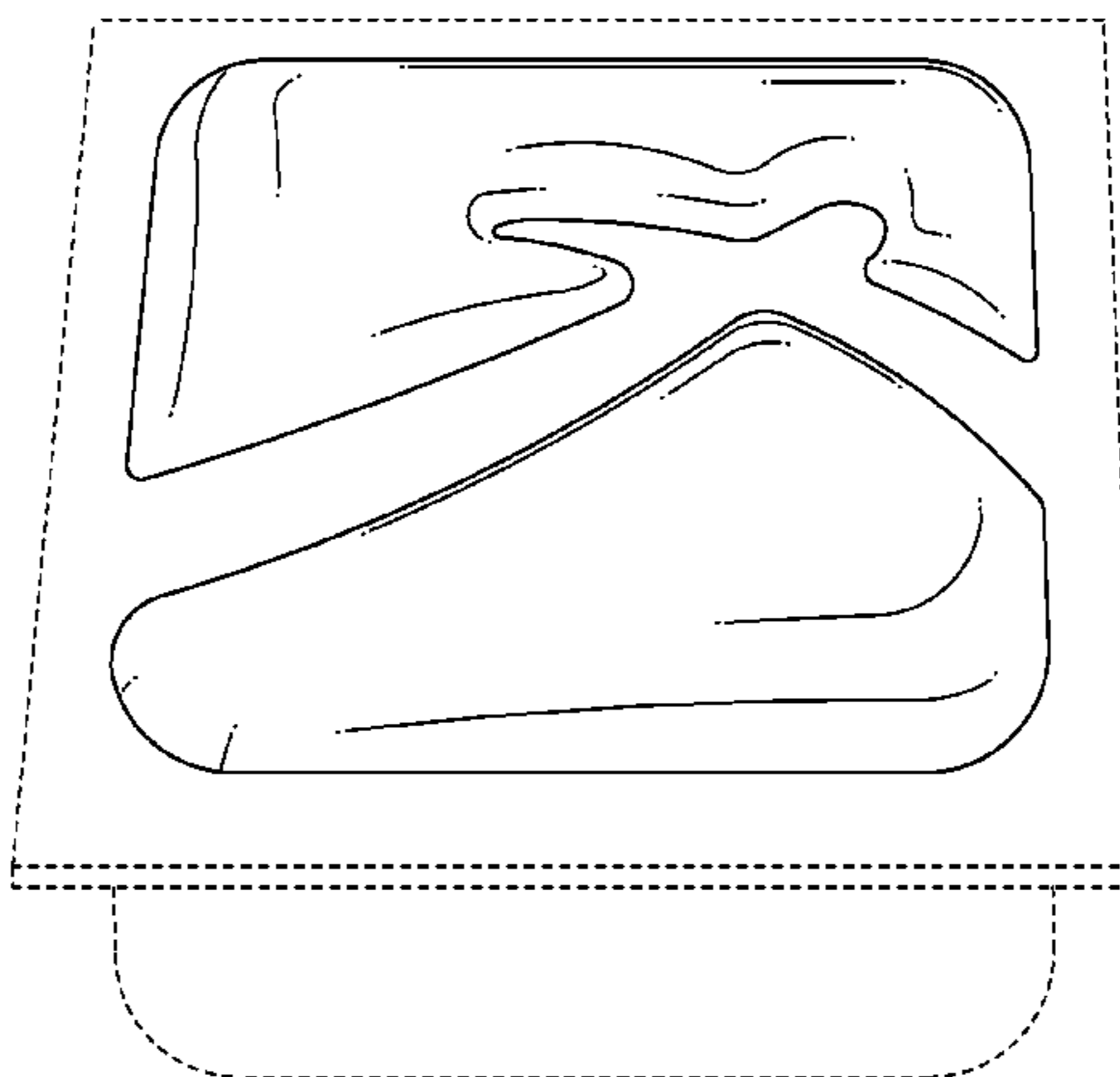


FIG. 16 is a top view of the indicia for laundry treatment product of FIG. 15.

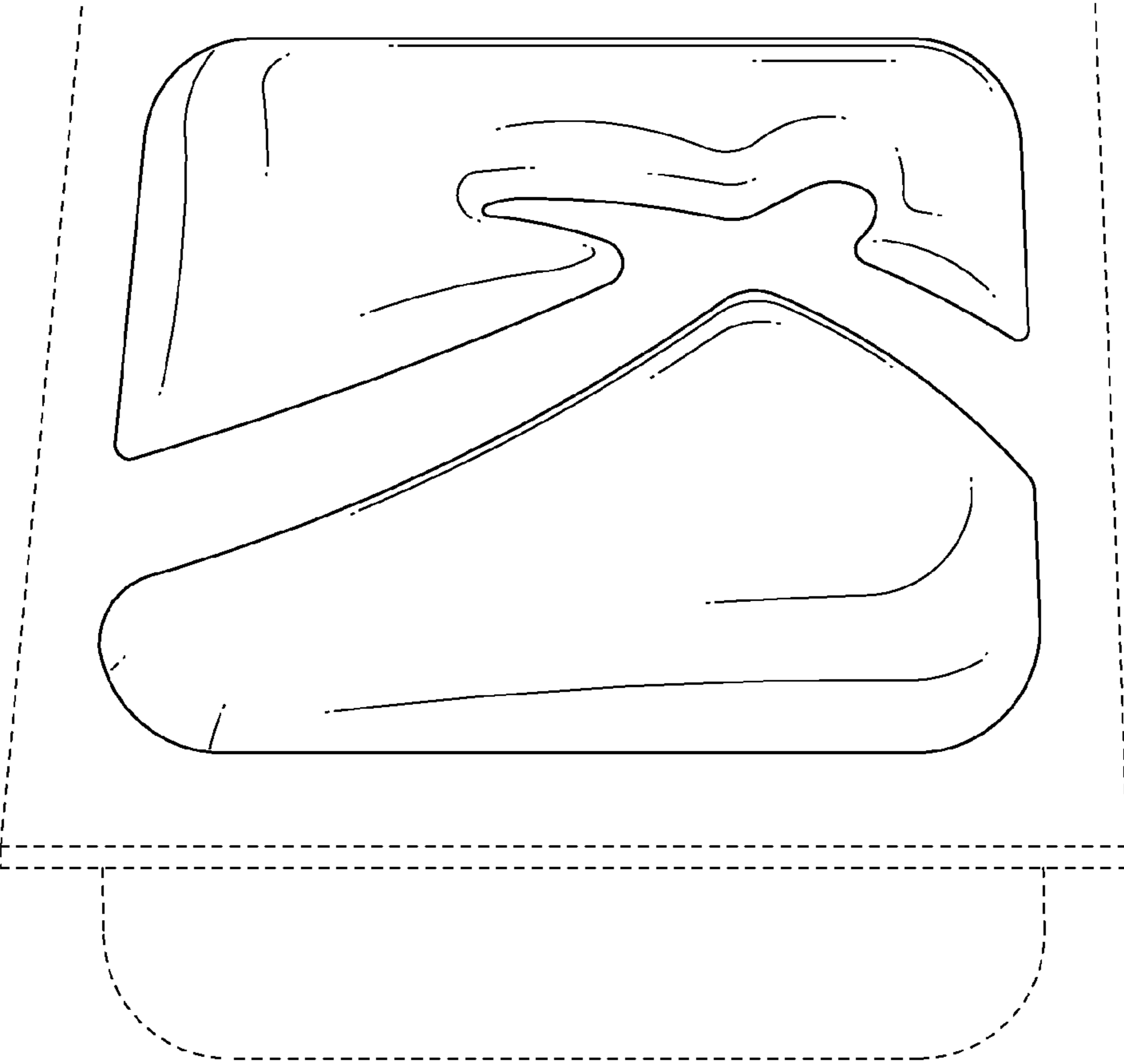

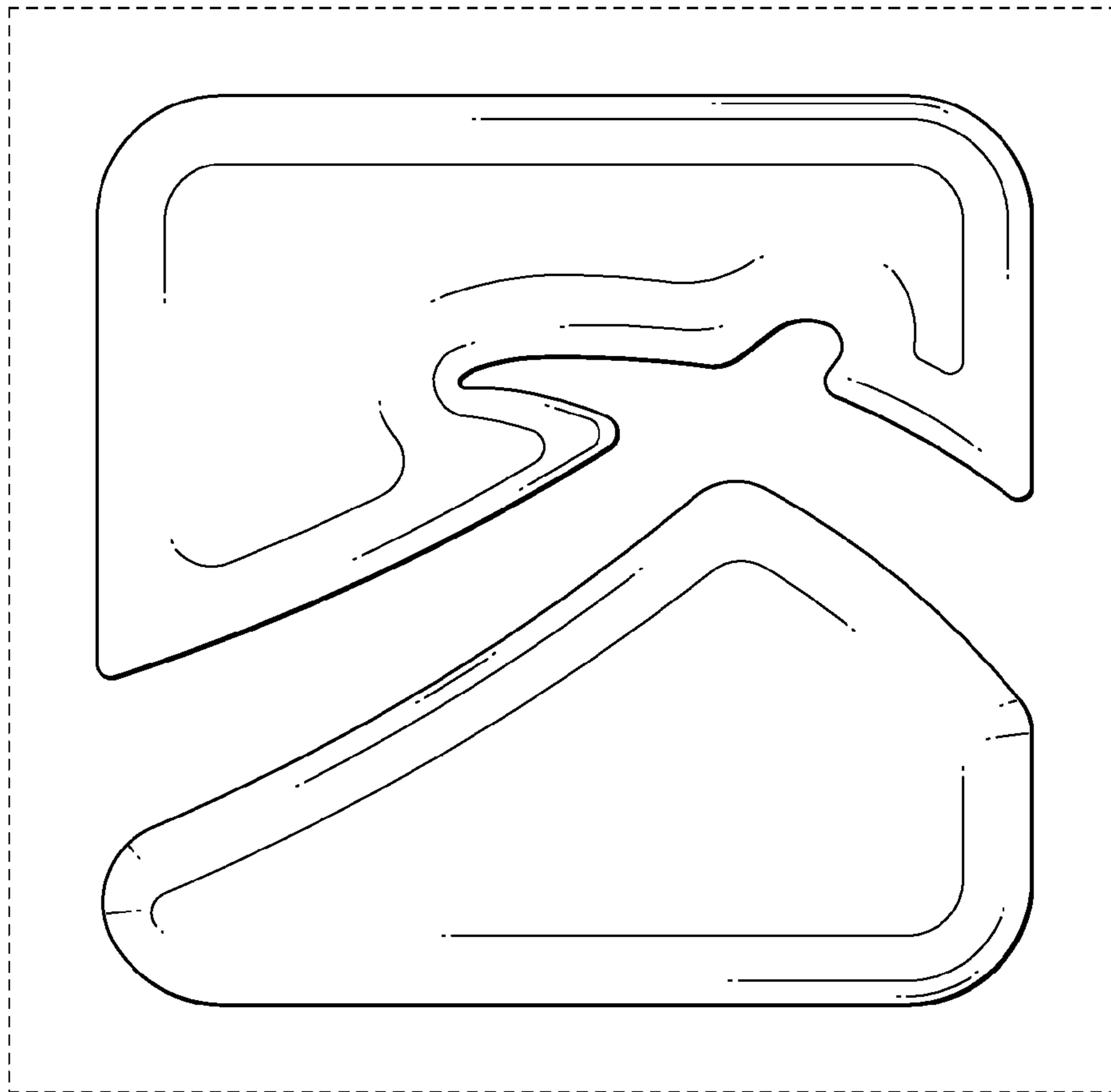

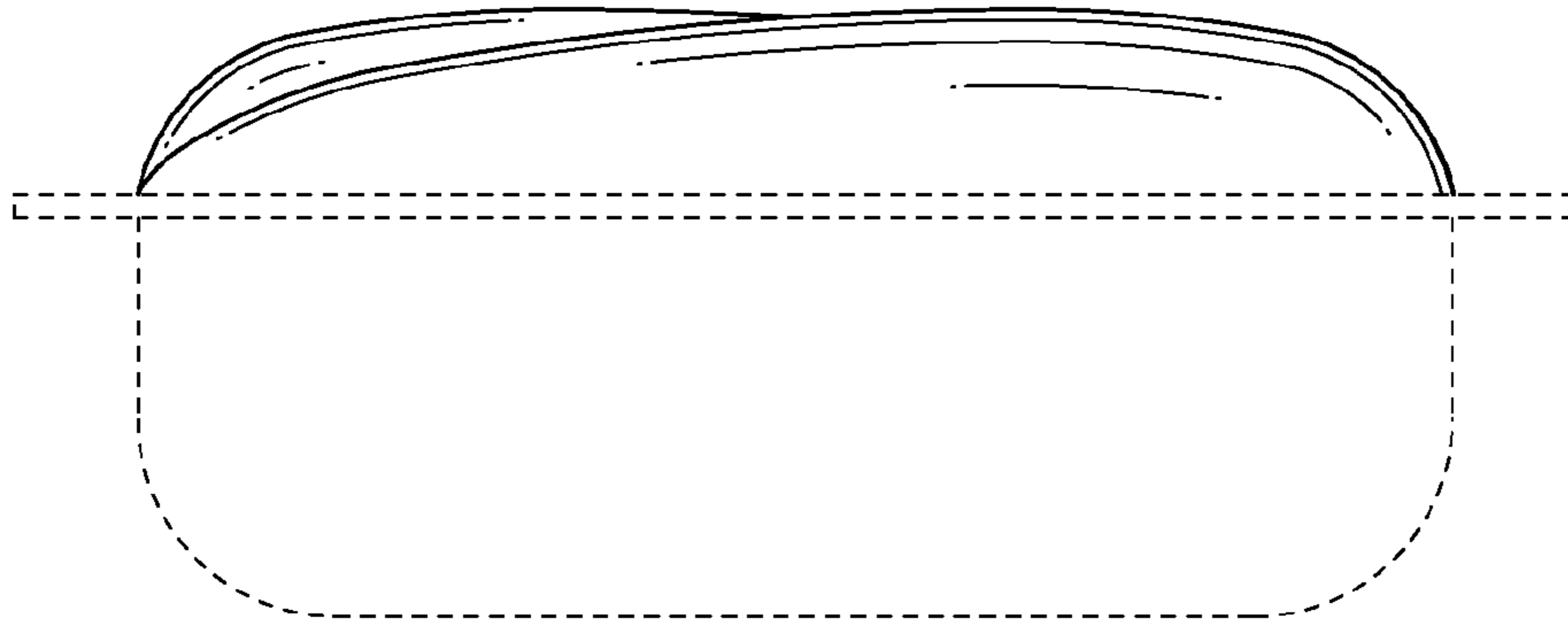

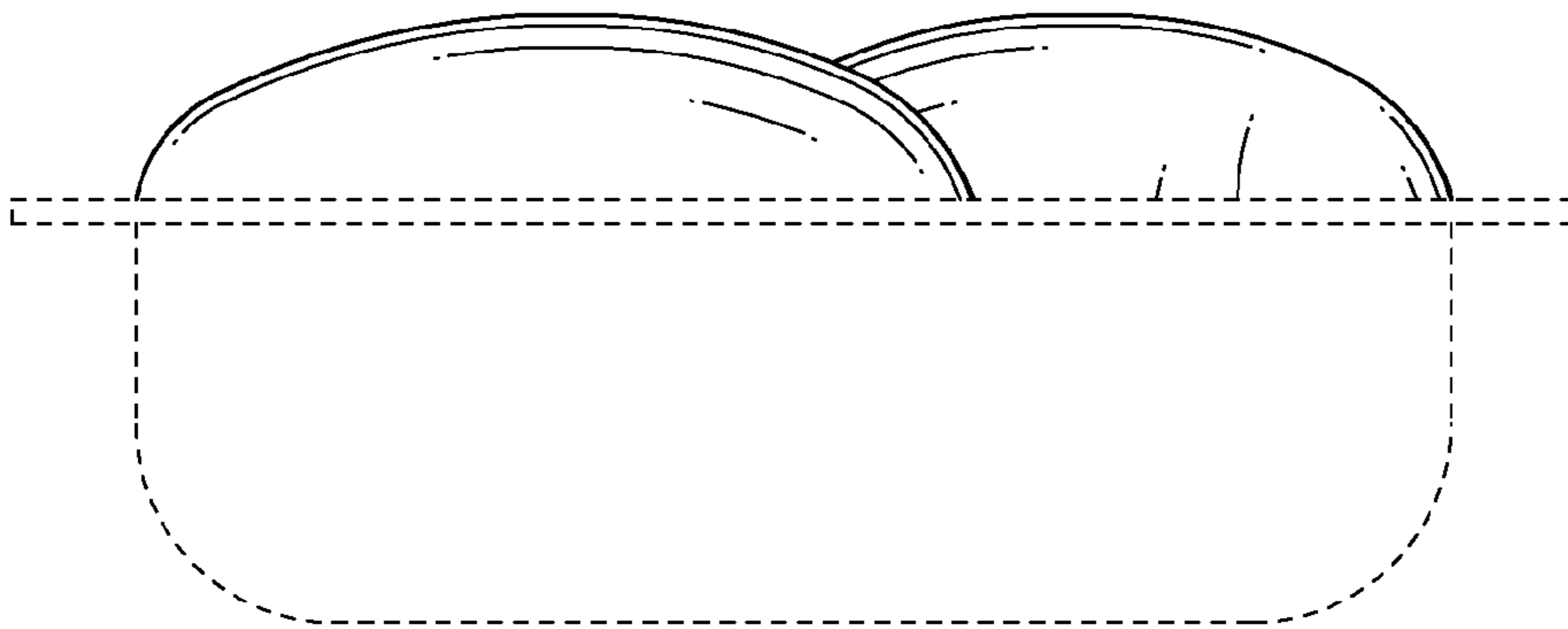

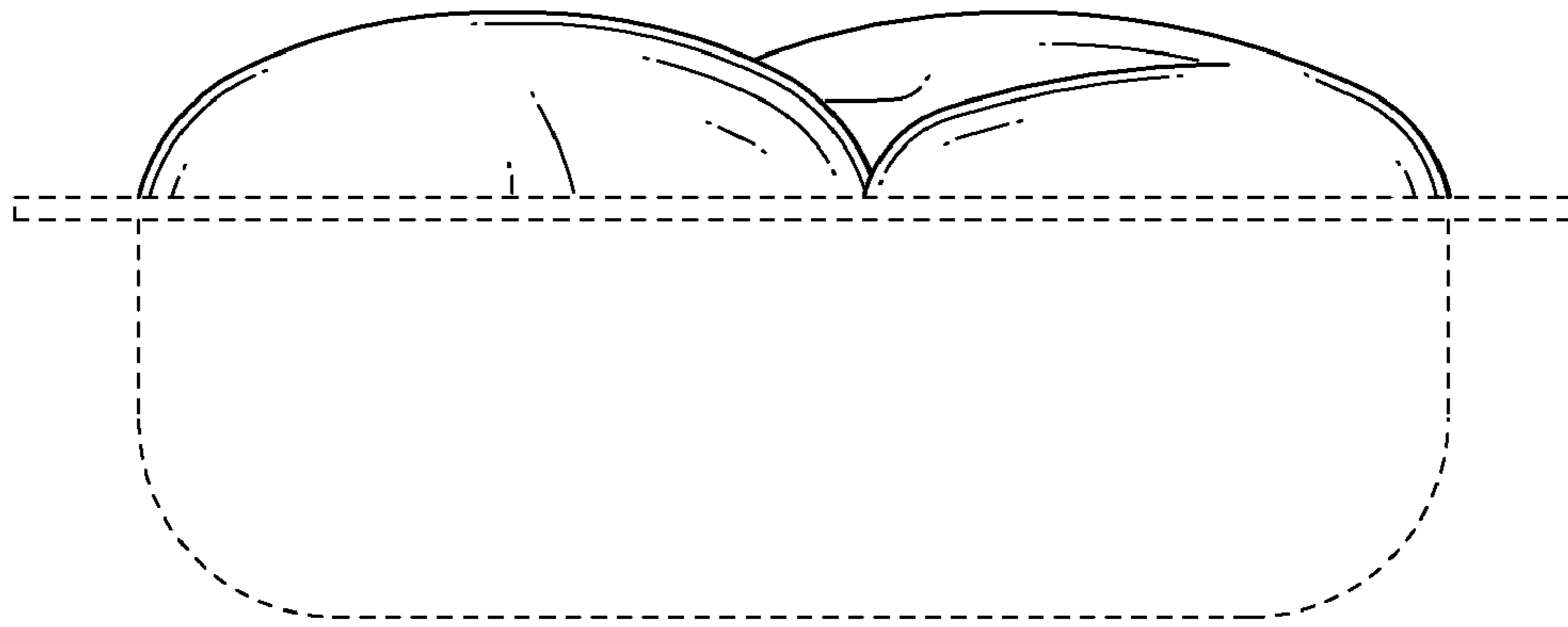

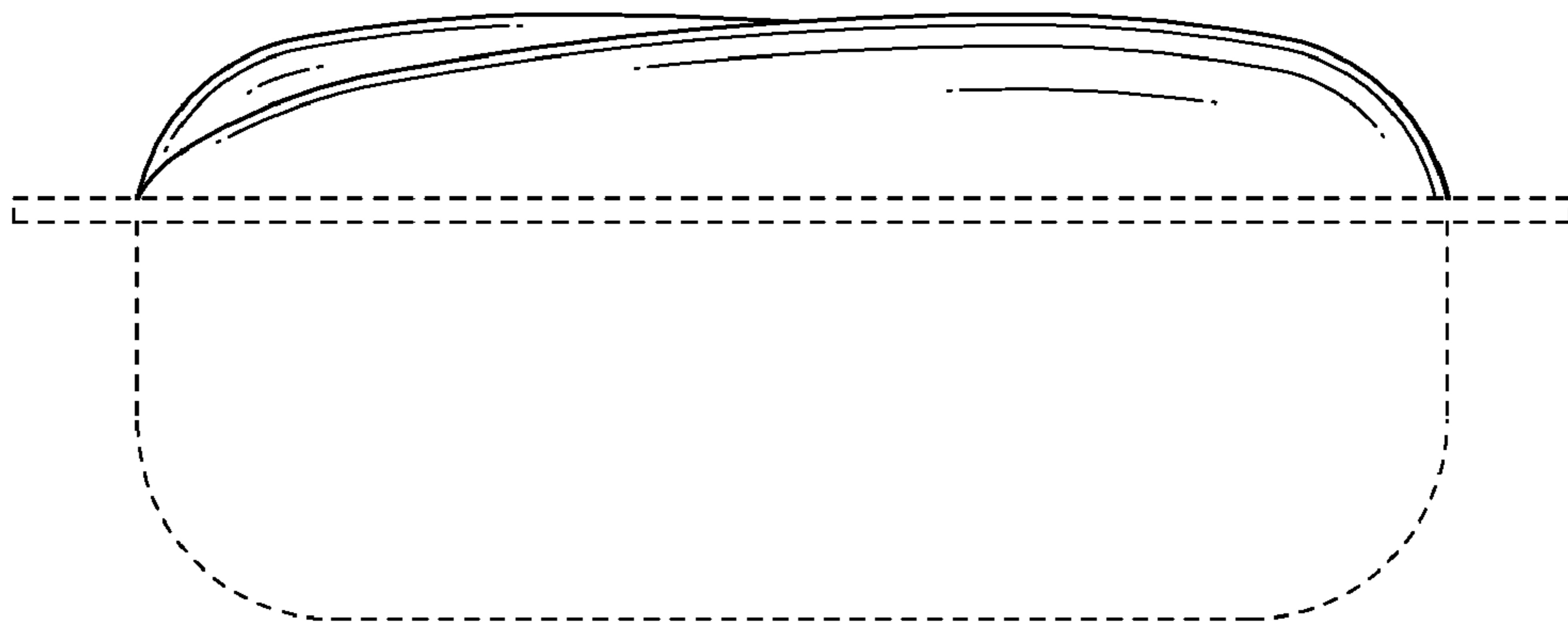

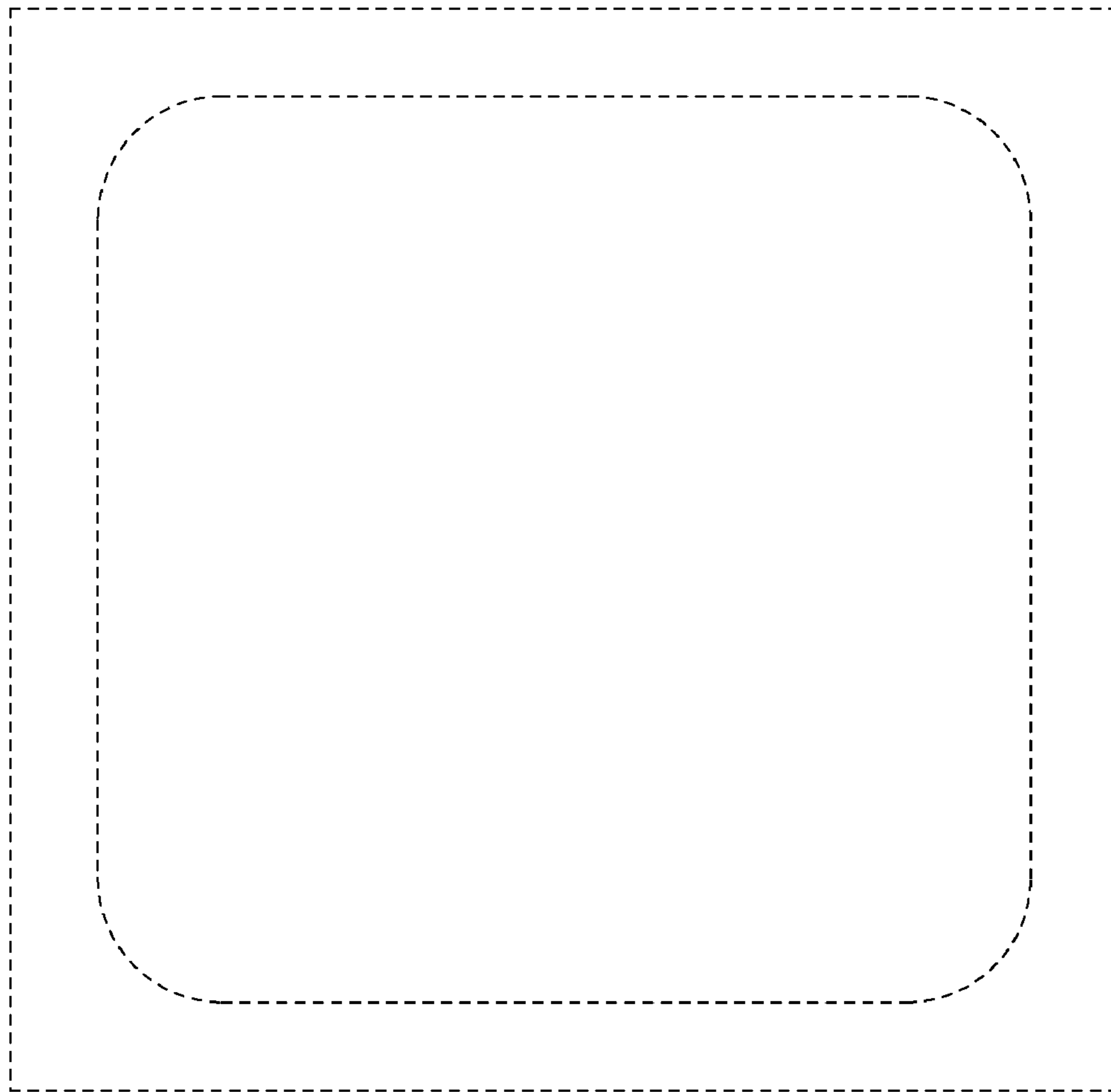

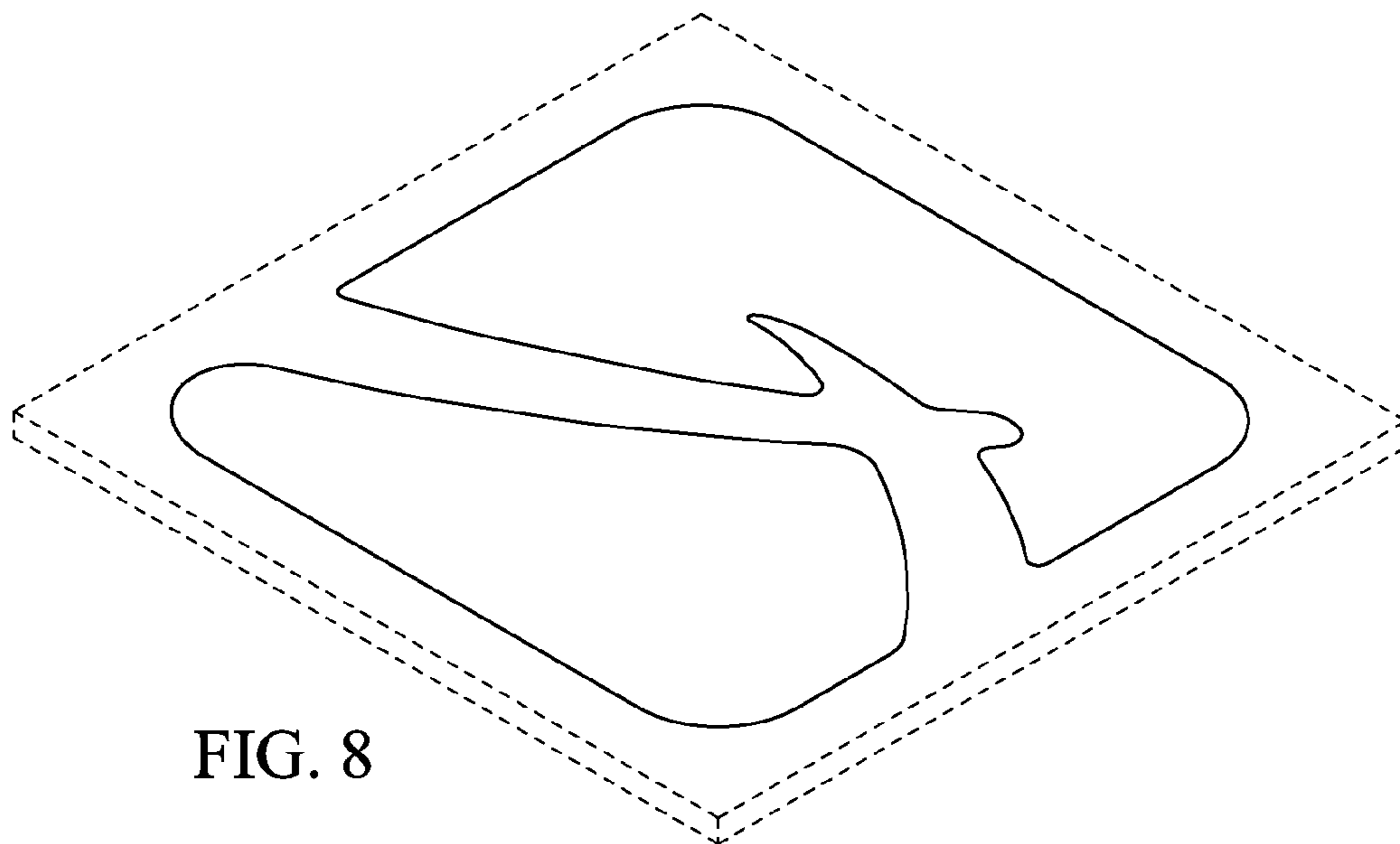

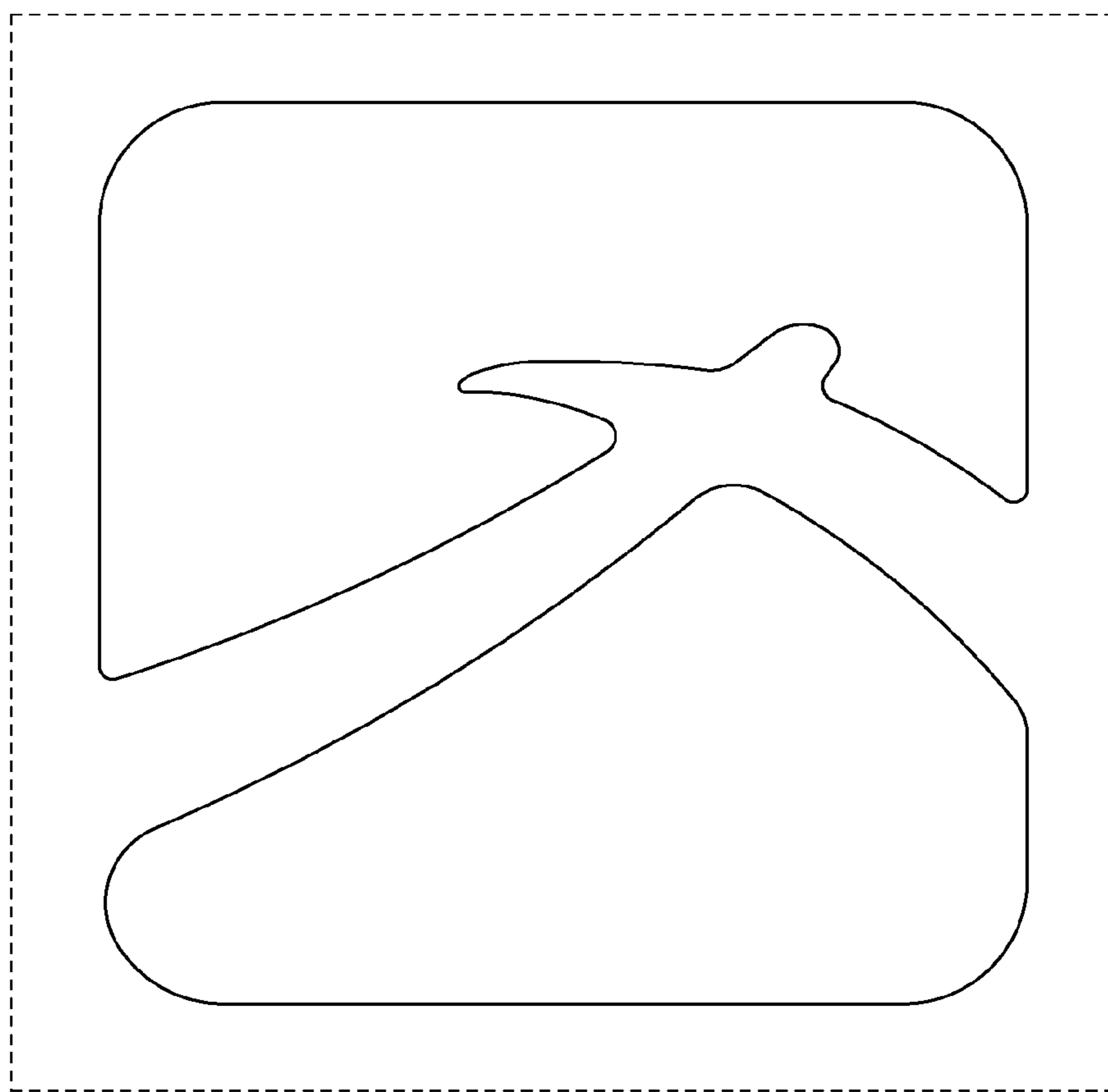

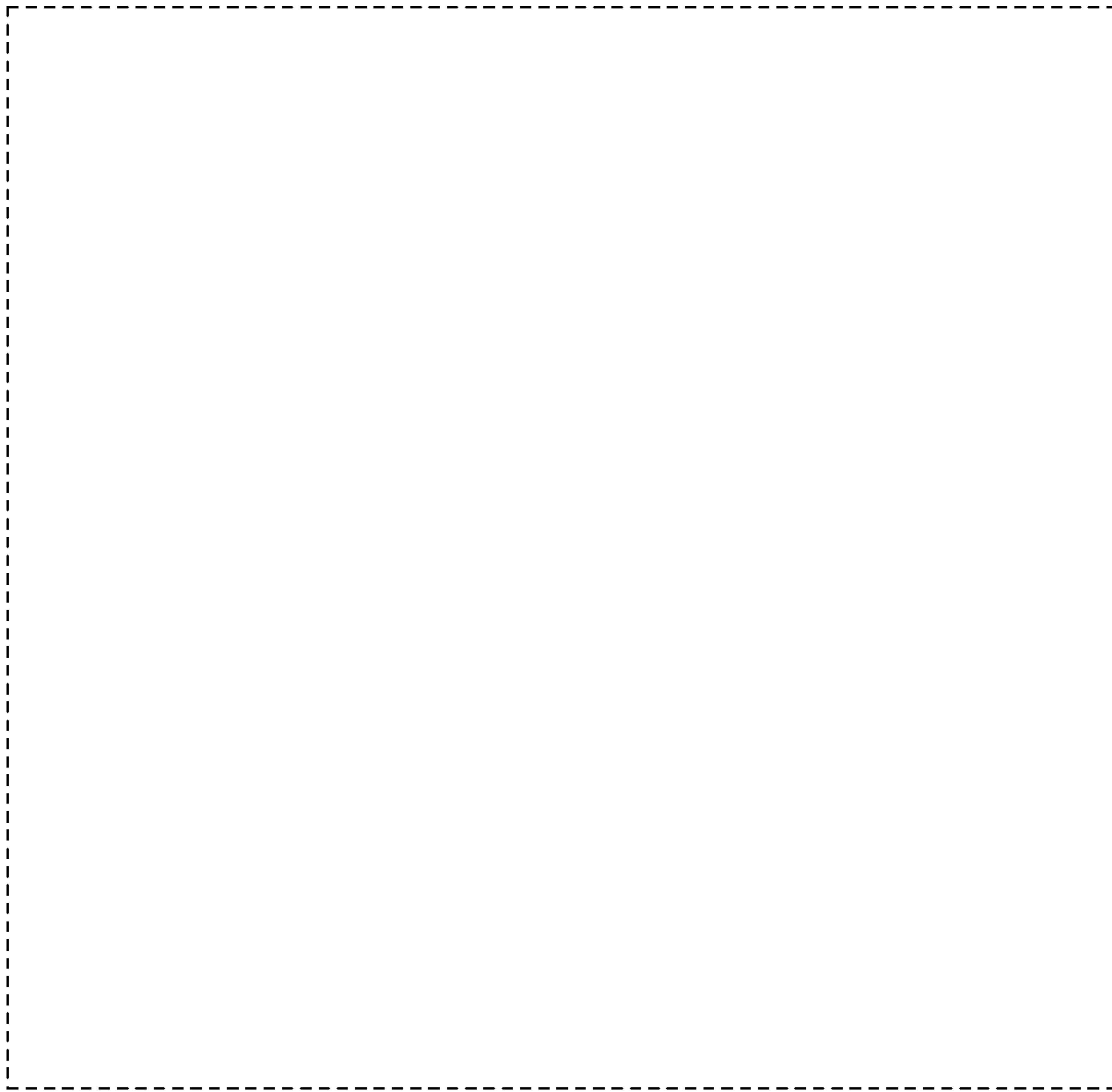

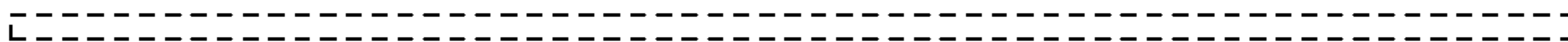

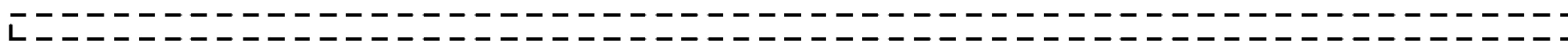

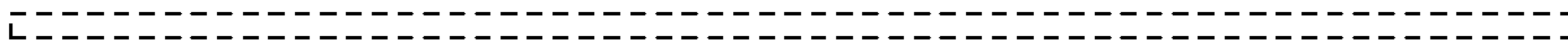

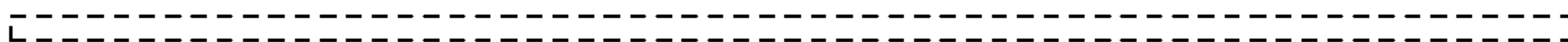

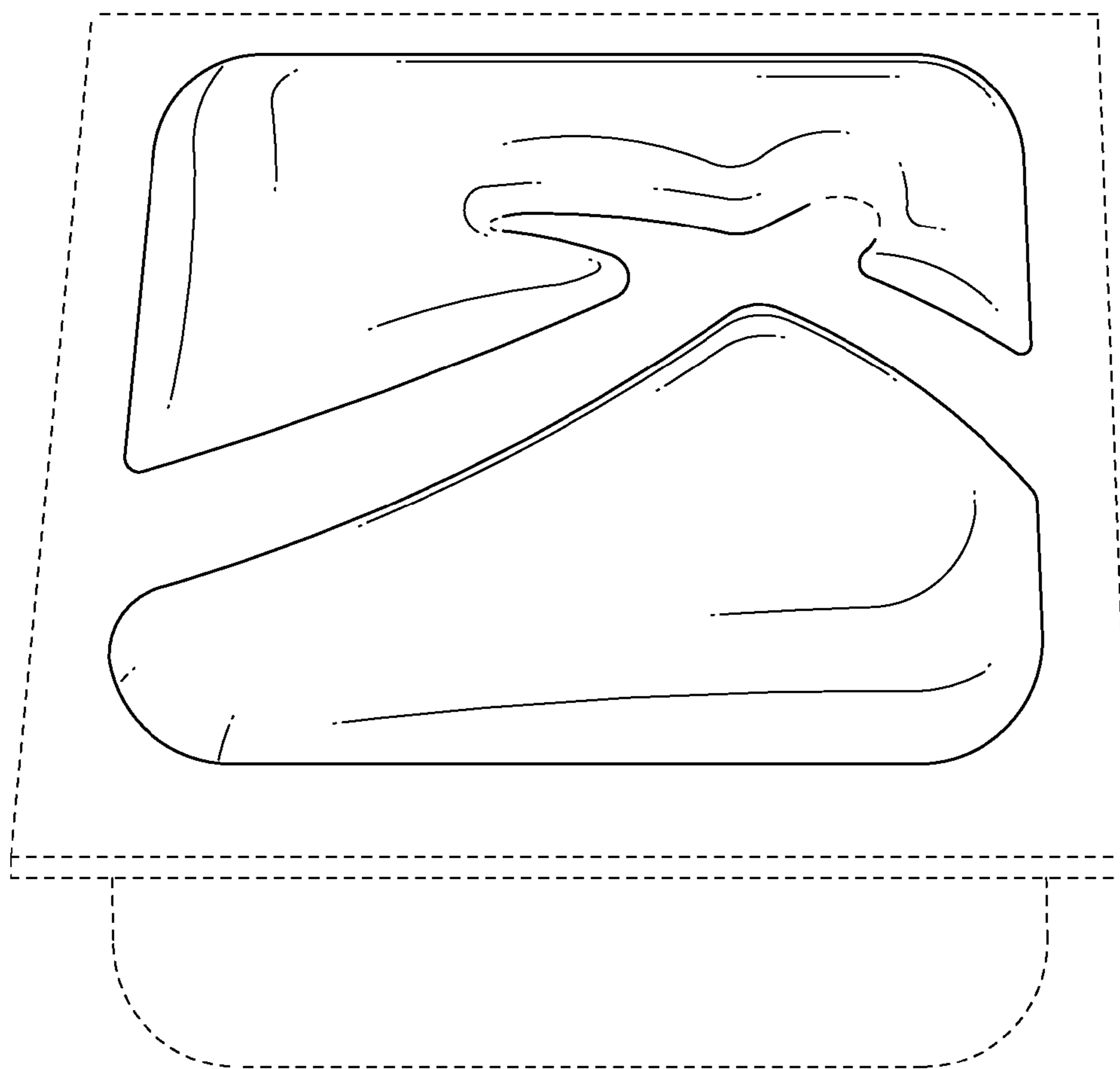

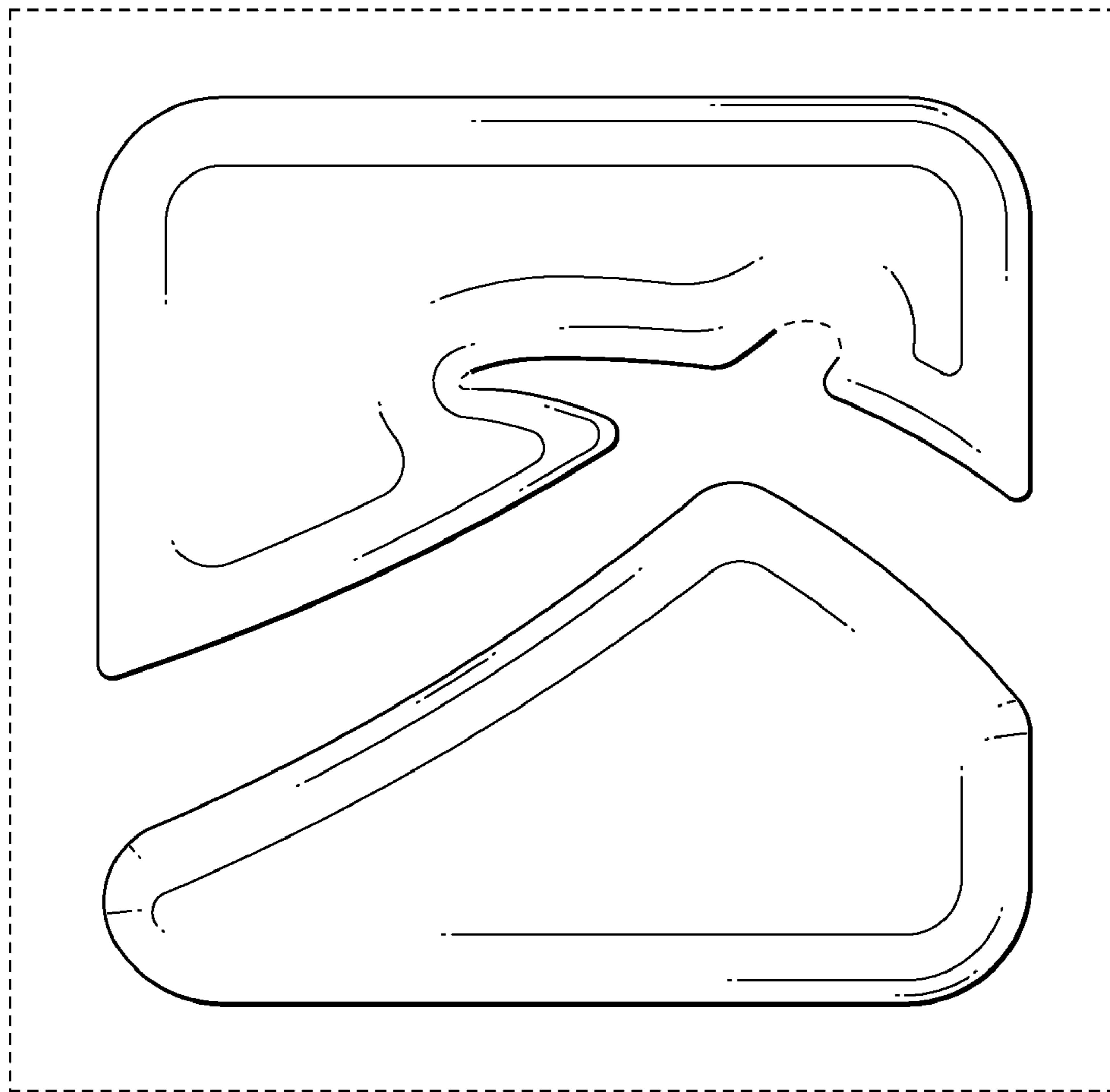

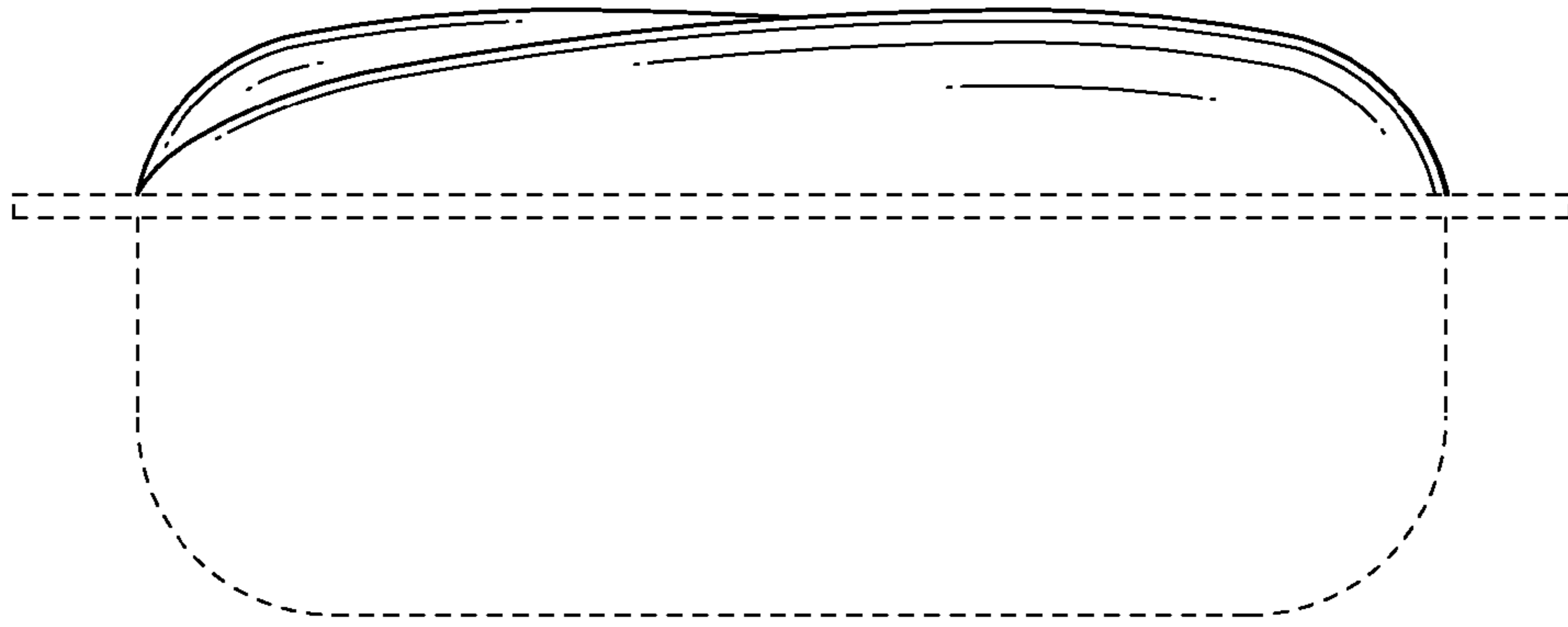

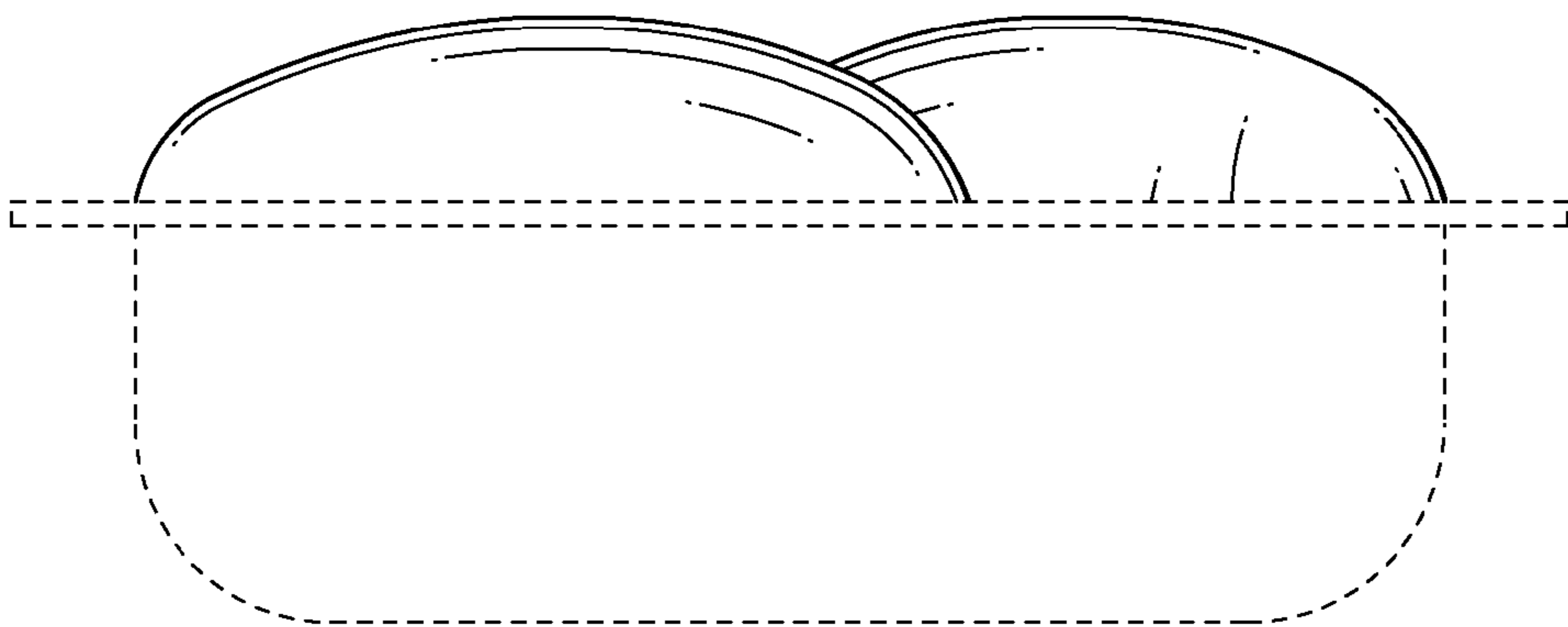

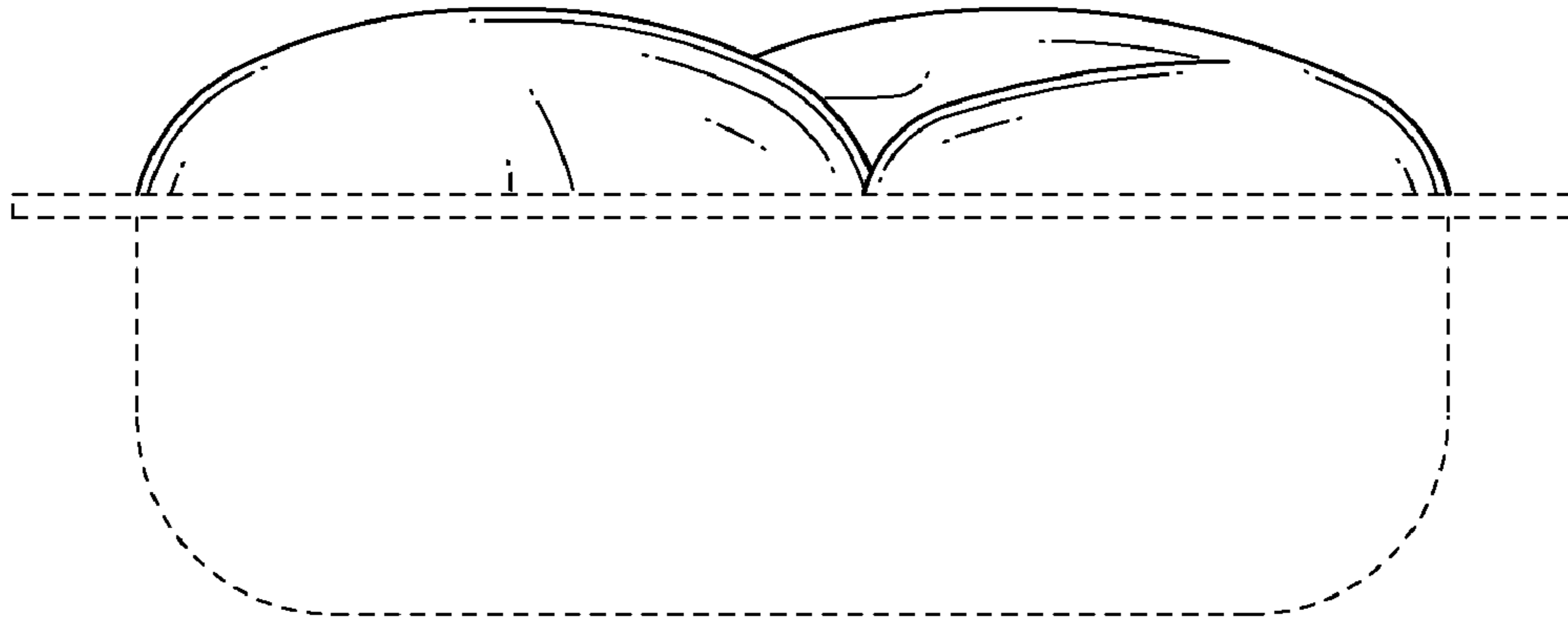

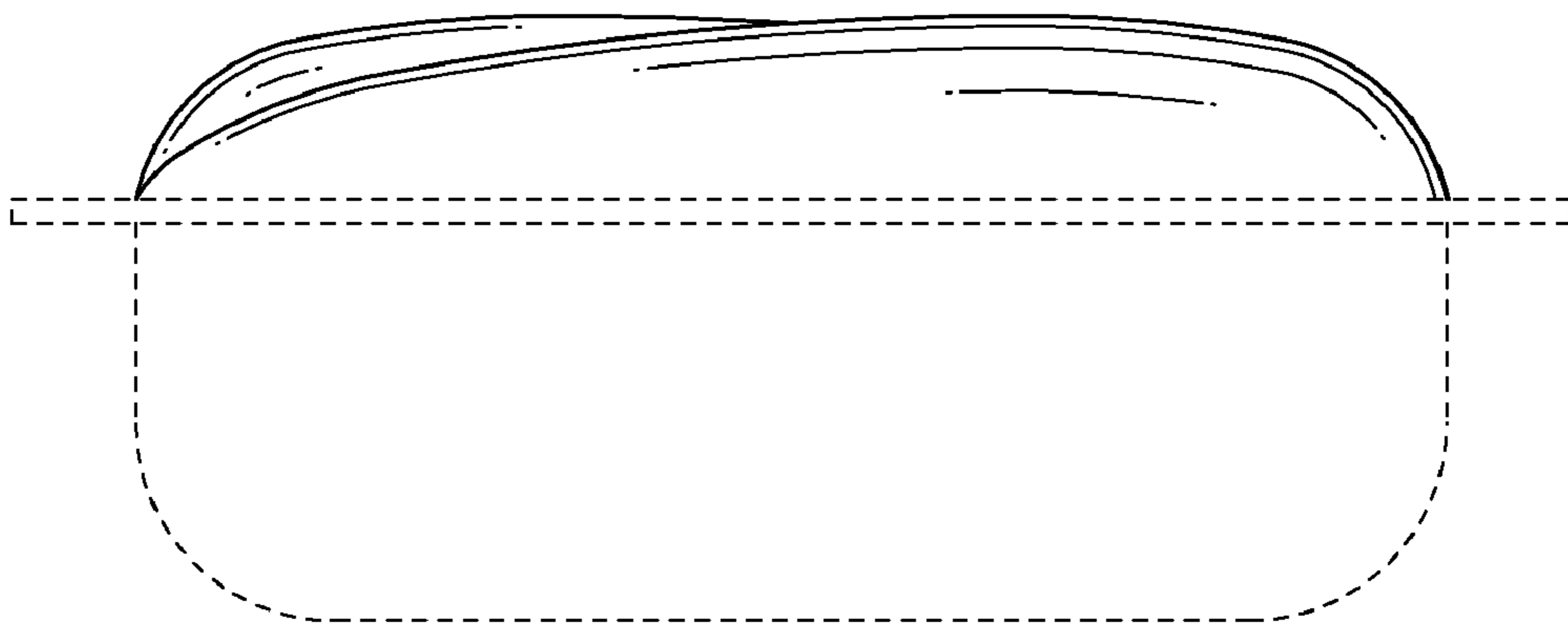

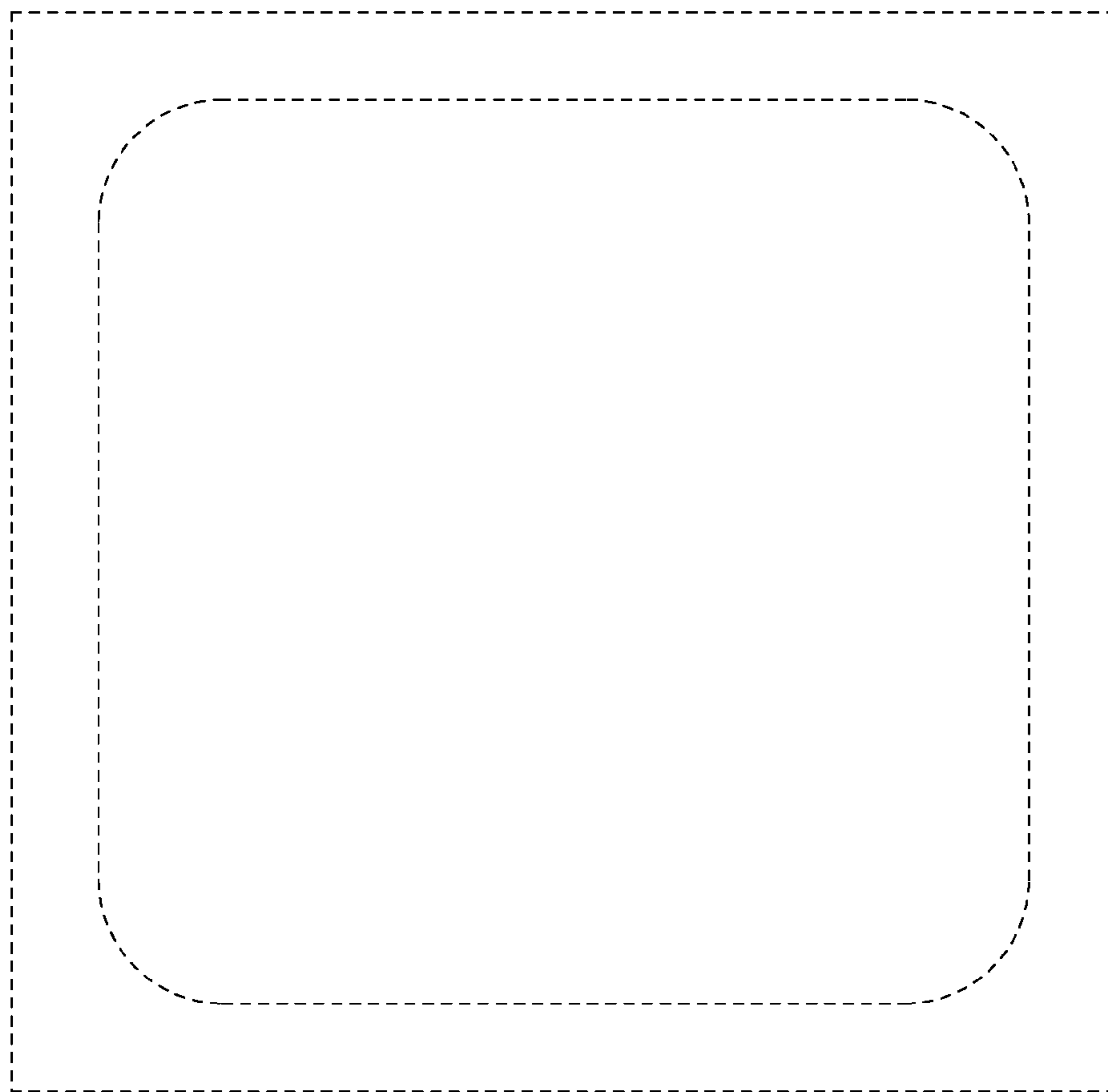

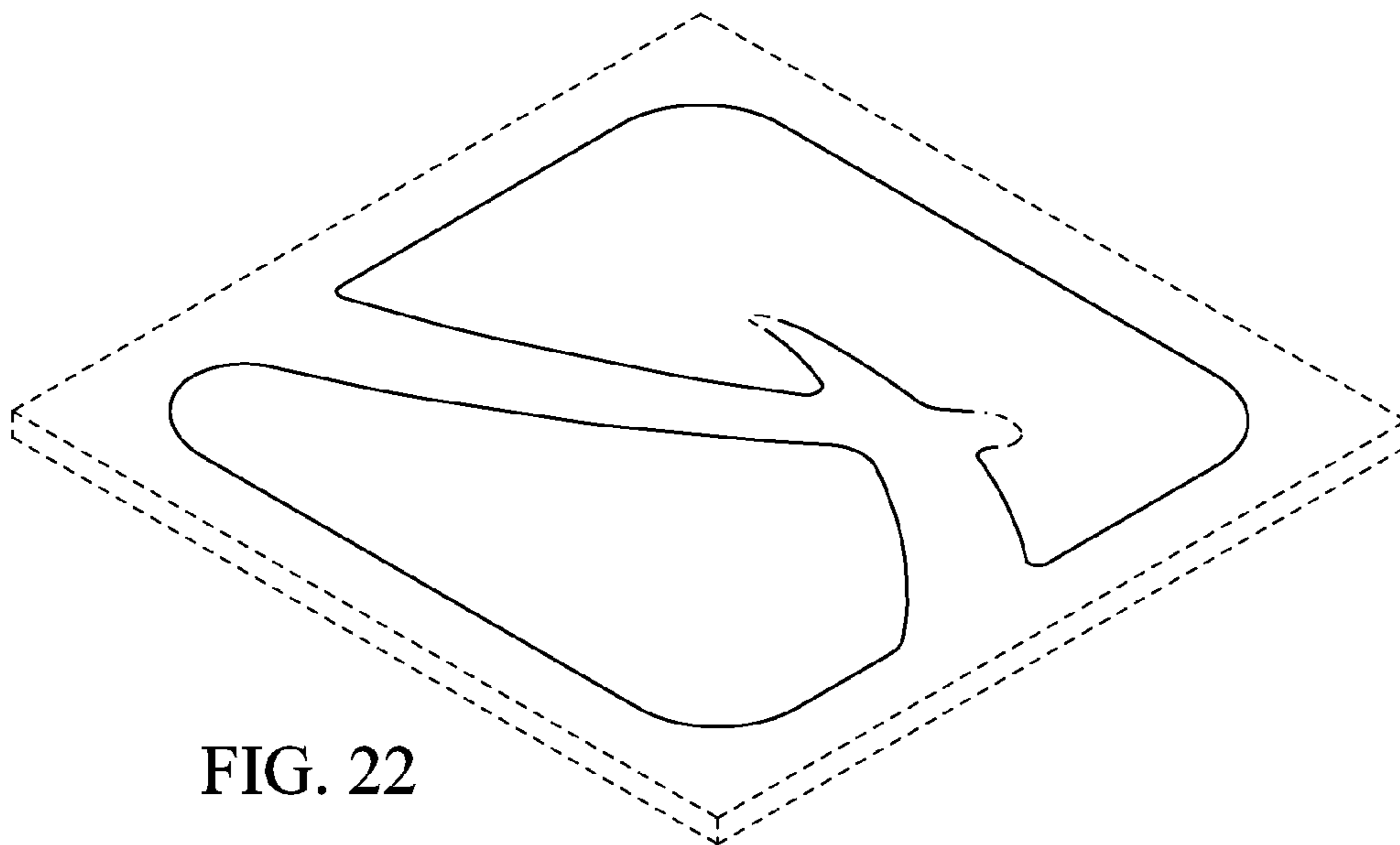

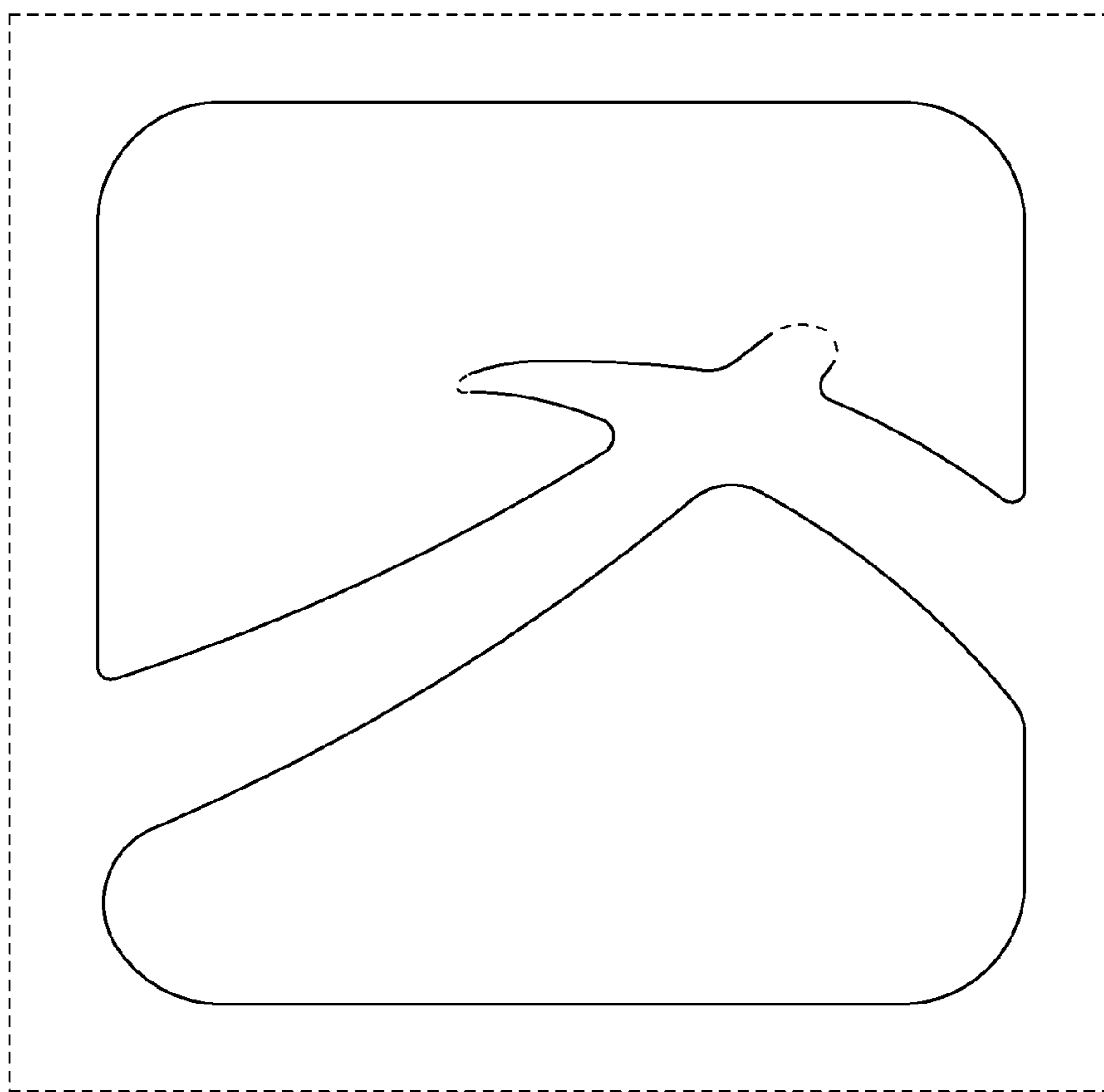

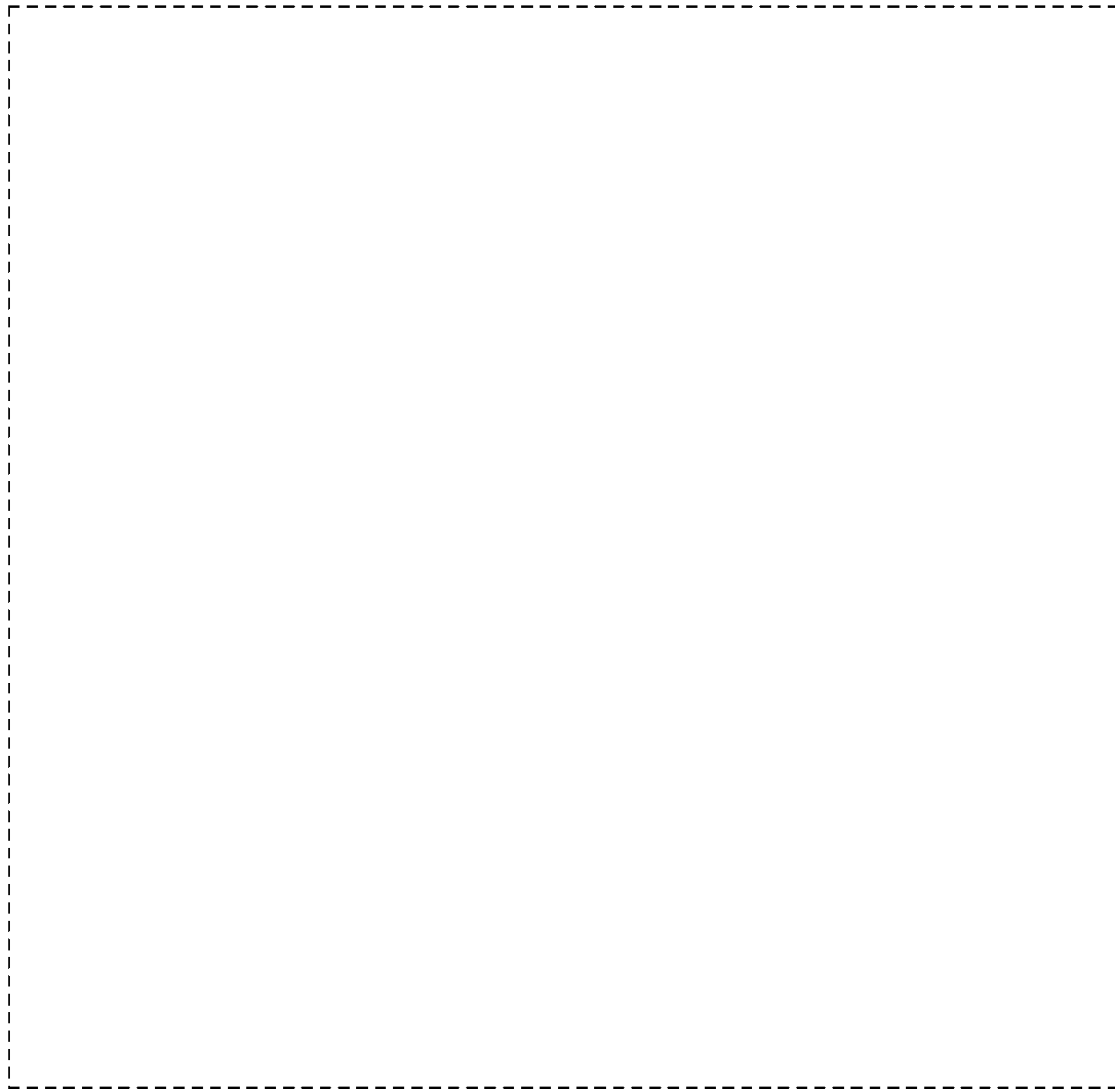

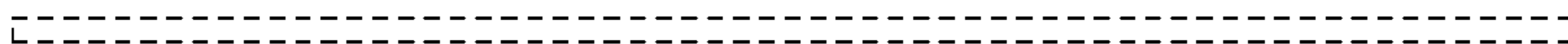

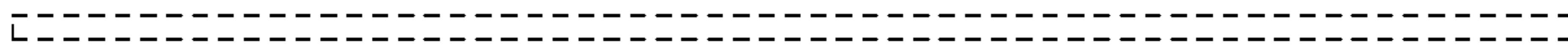

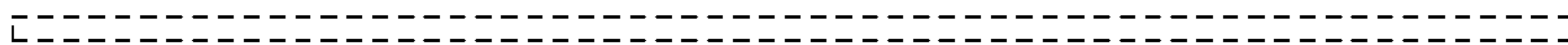

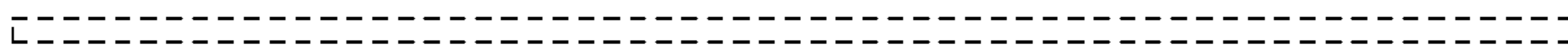
