FIG. 3 is a rear elevation view of the snack food product of the present invention;

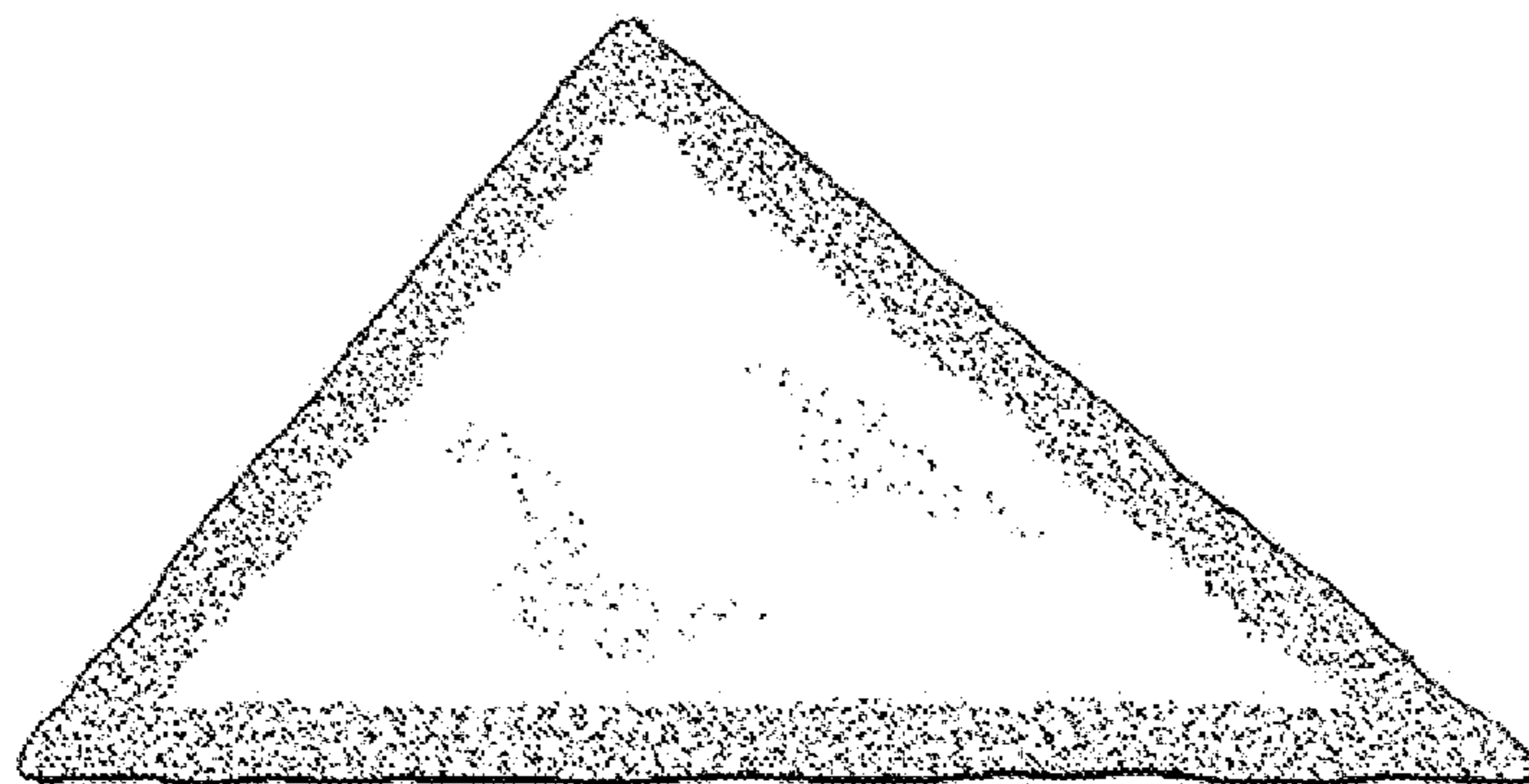
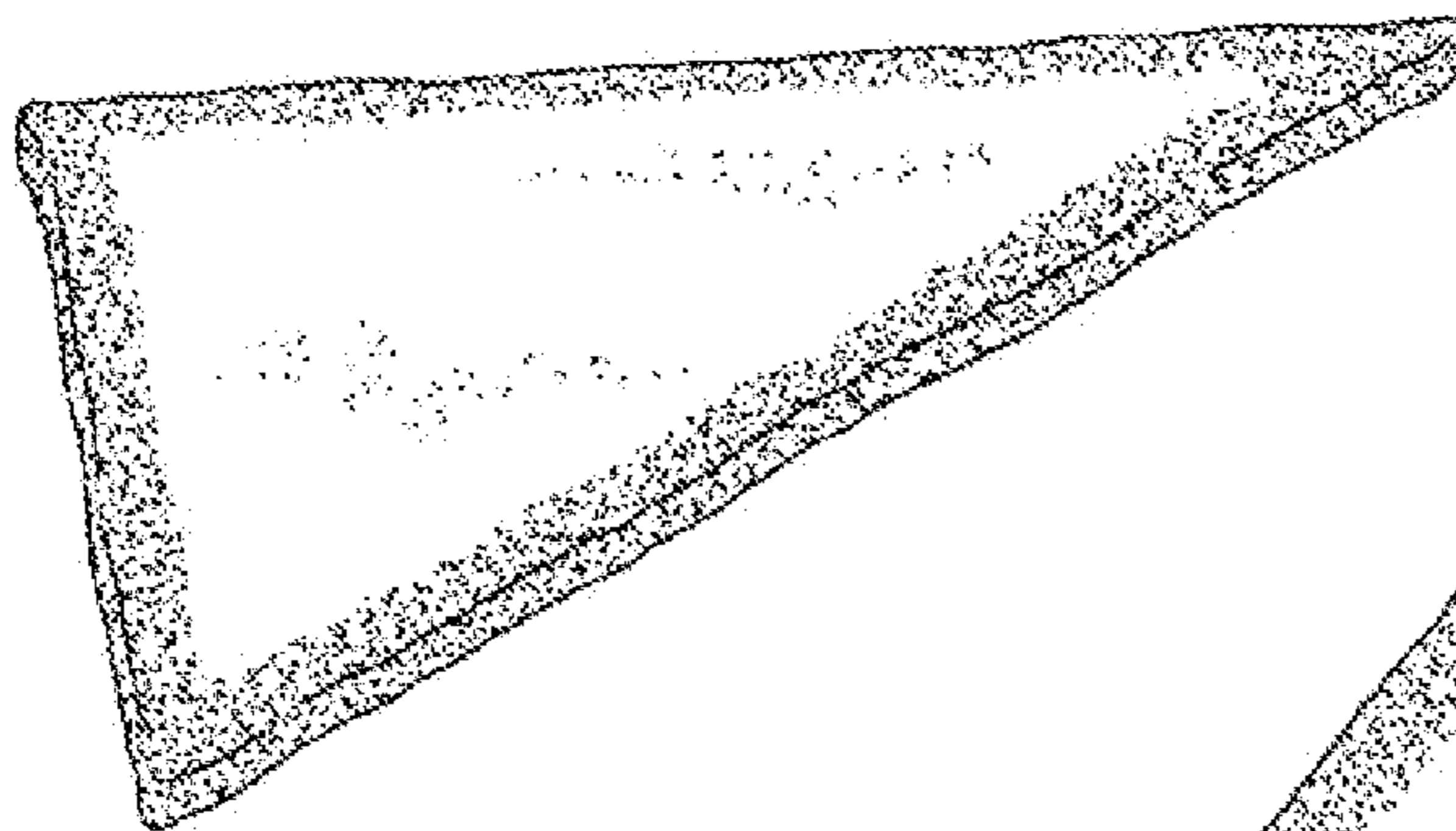
FIG. 4 is a front elevation view of the snack food product of the present invention;

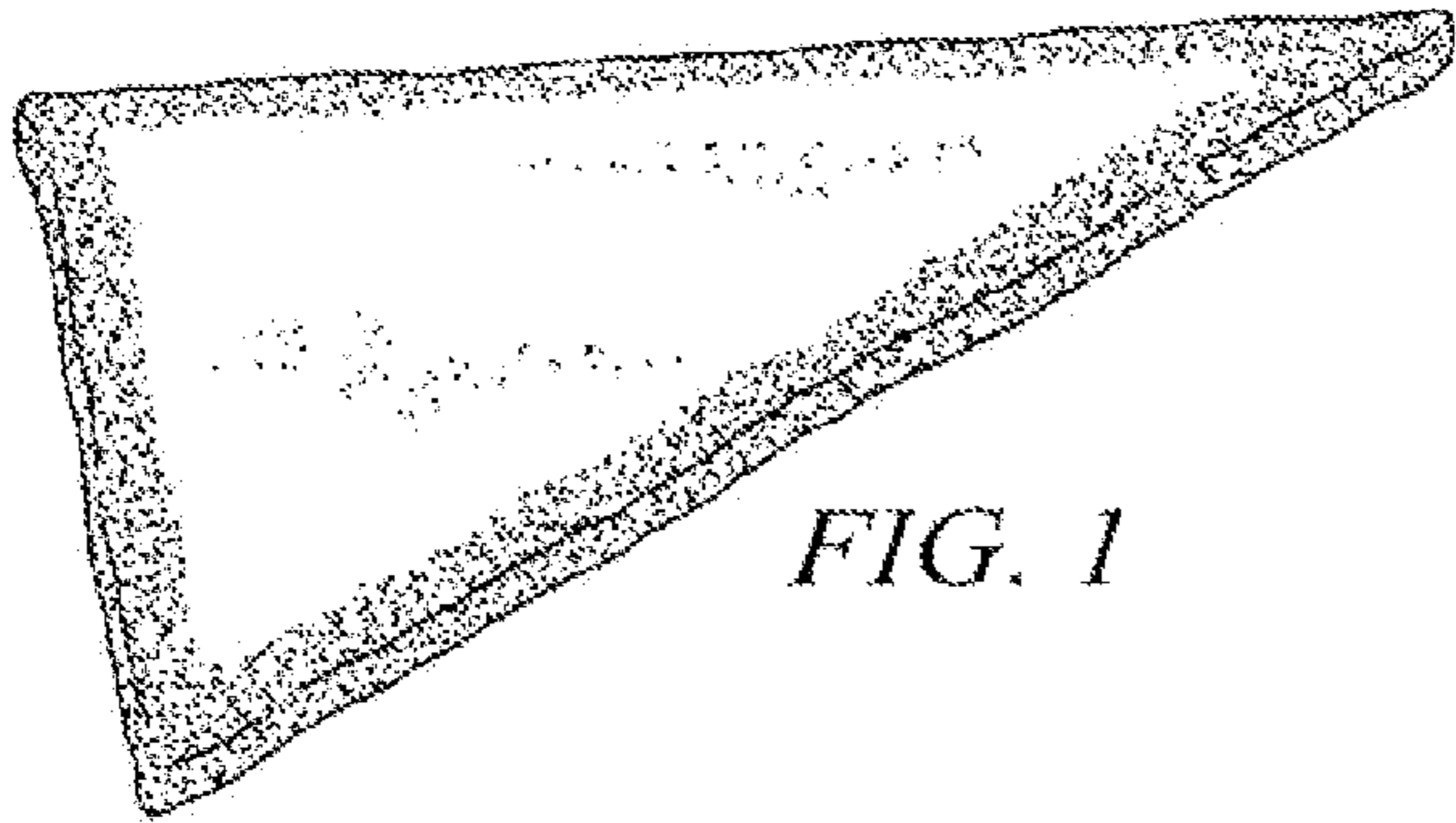

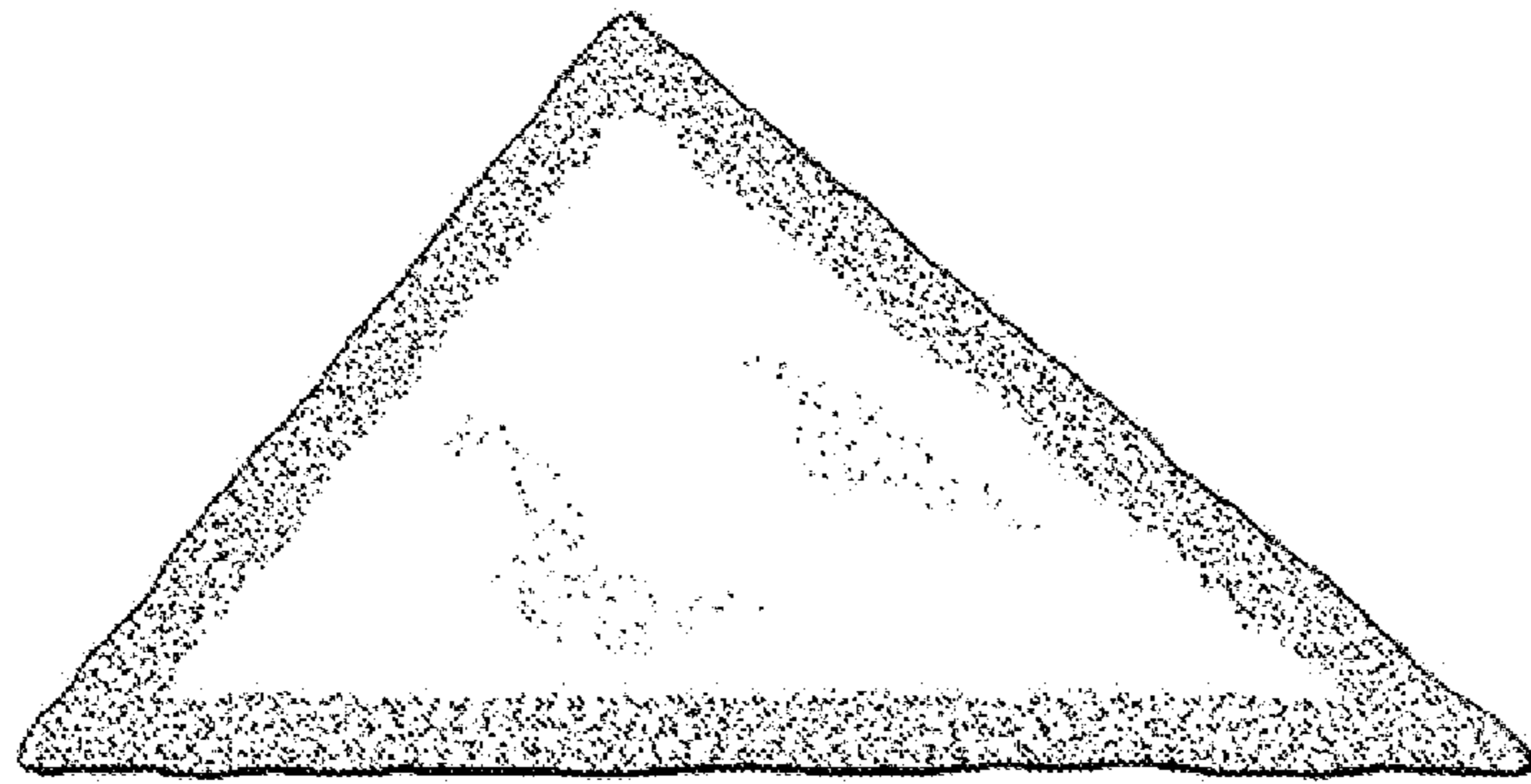

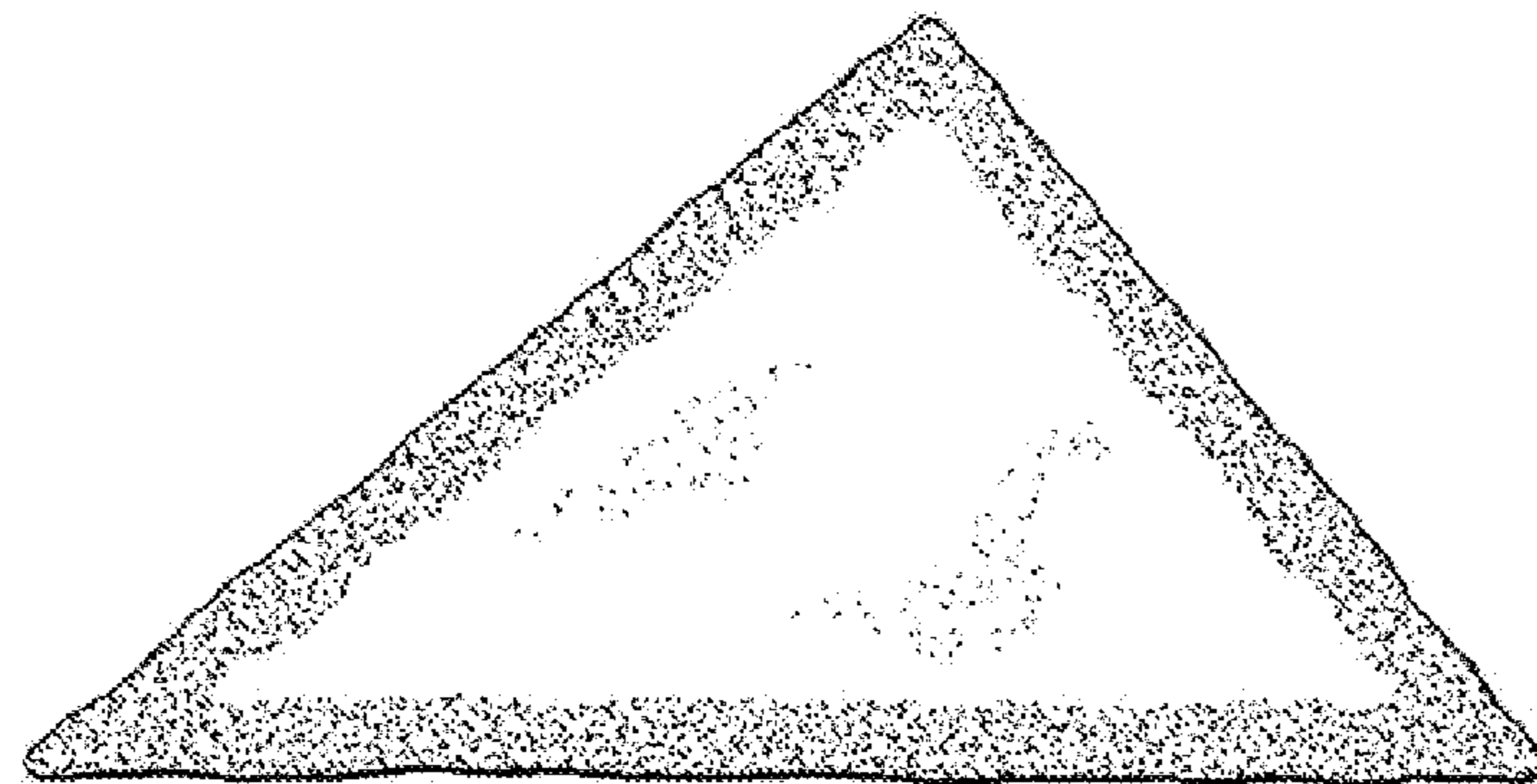
