(57) **CLAIM**

I claim the ornamental design for a knitted hat, as shown and
described.

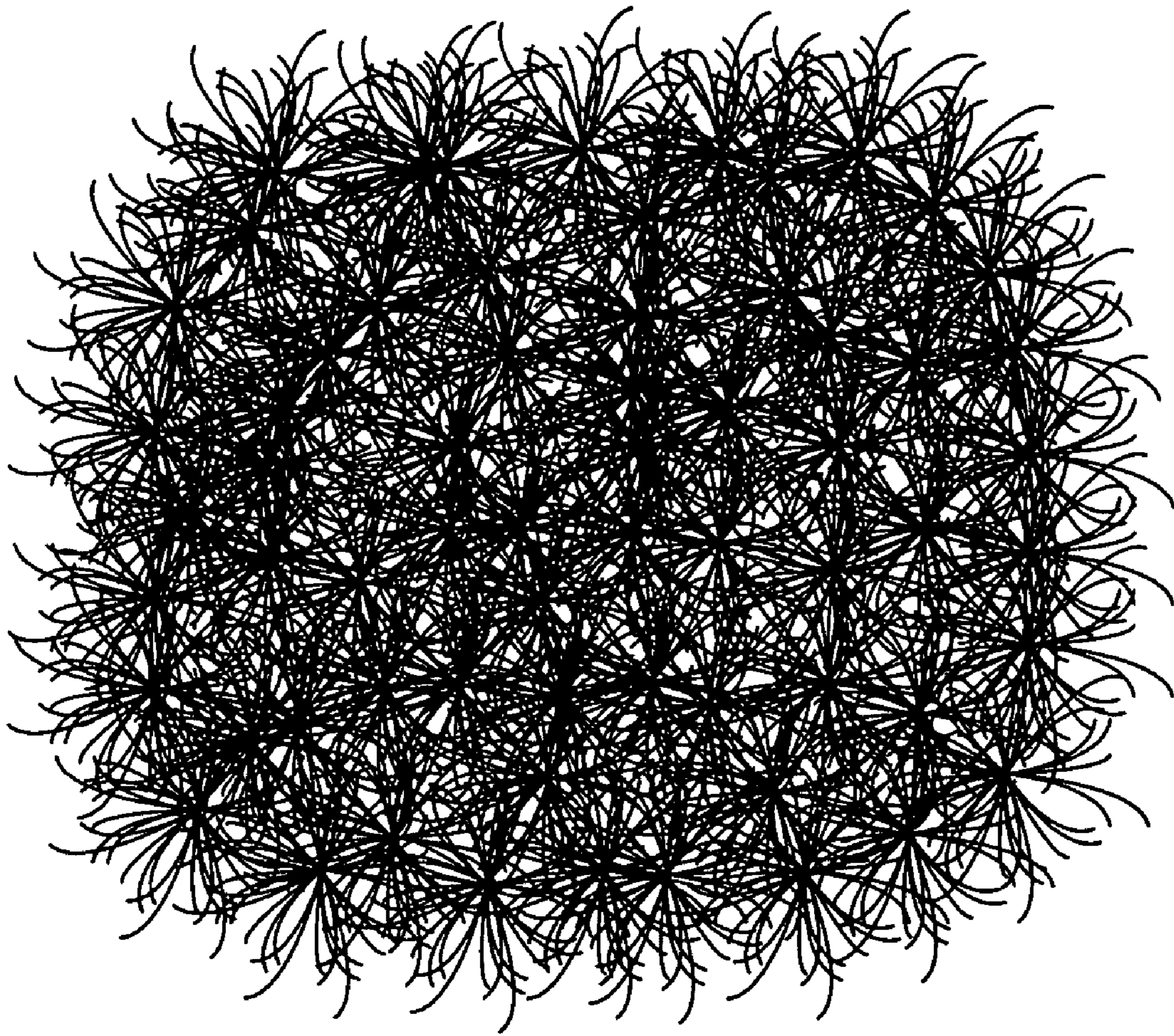

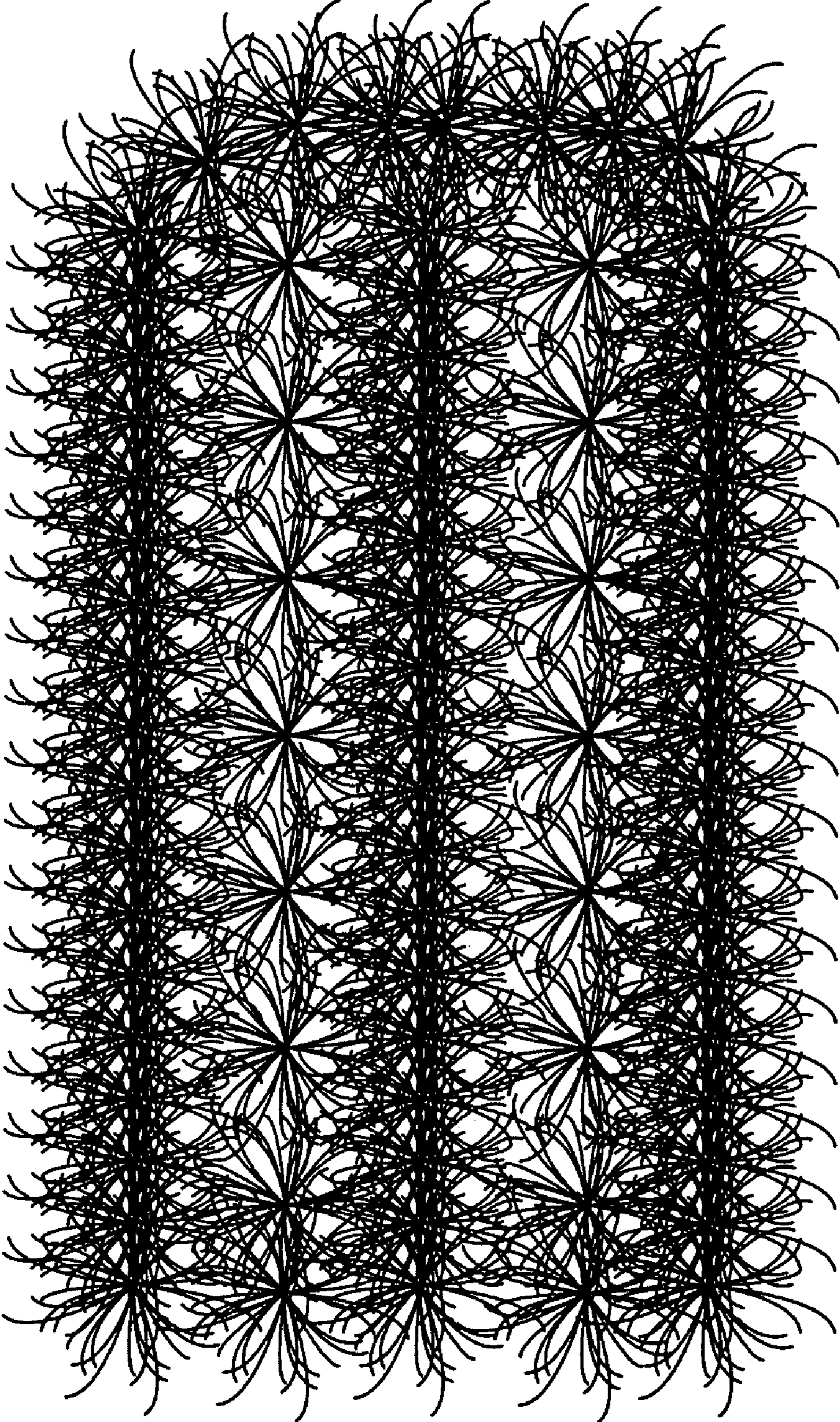
