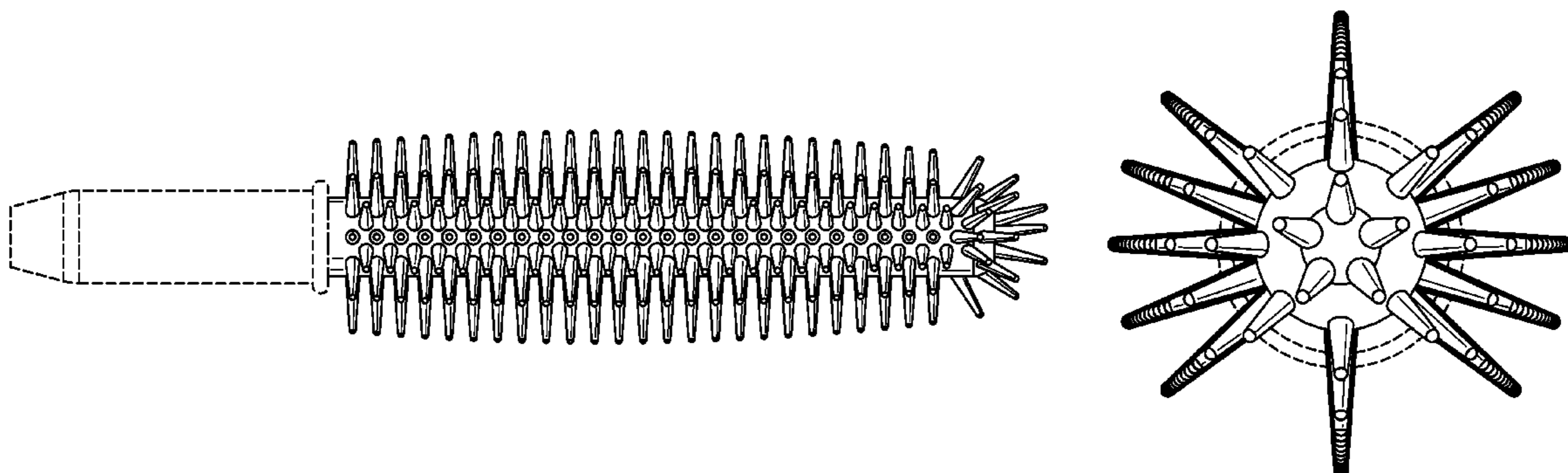
FIG. 1 is a front perspective view of a mascara brush showing my new design;

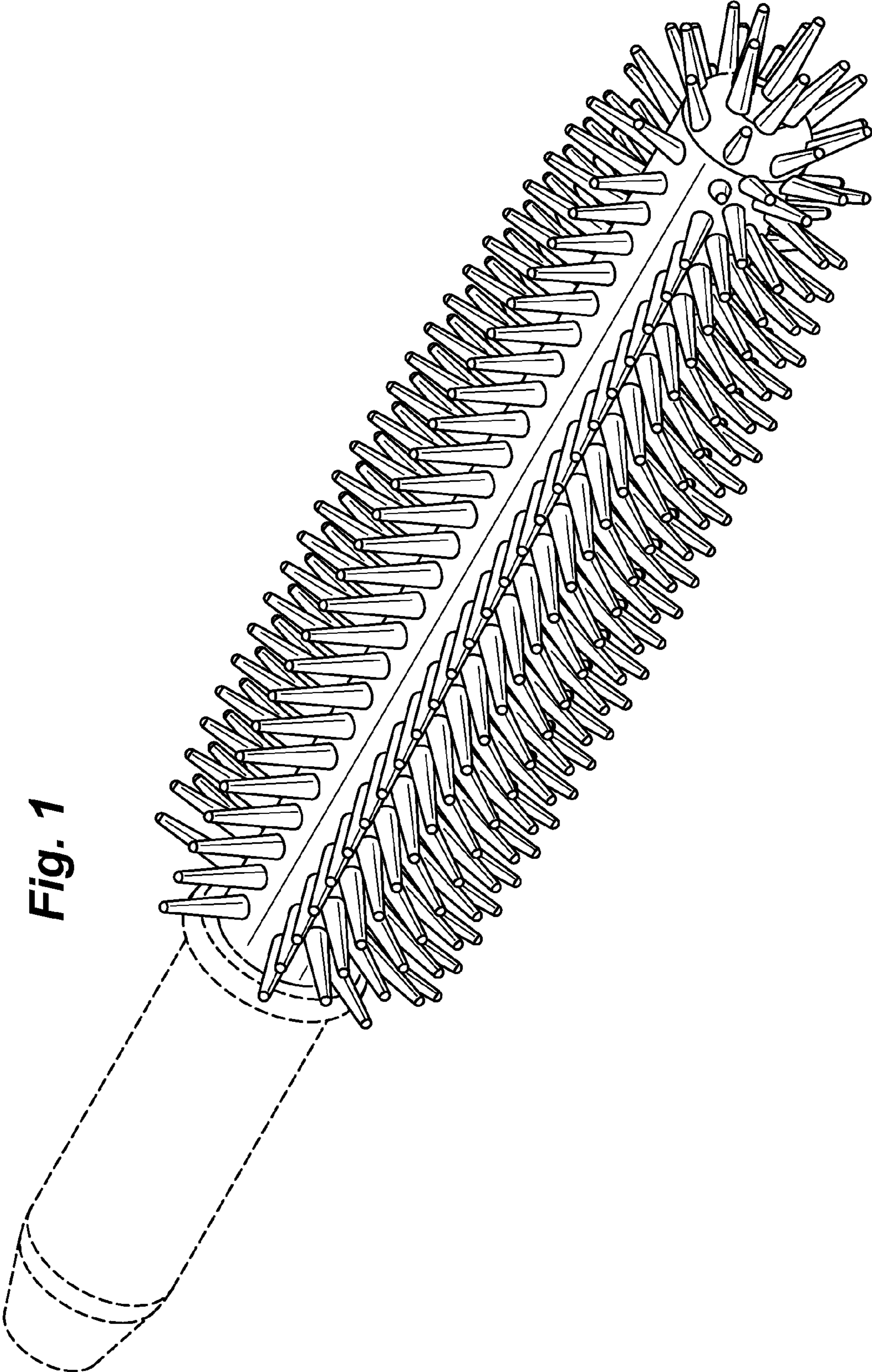

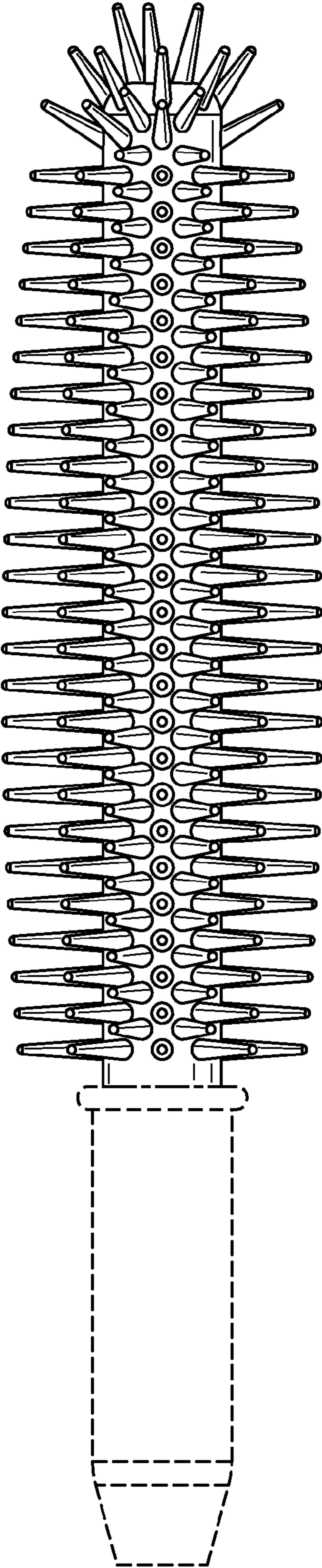

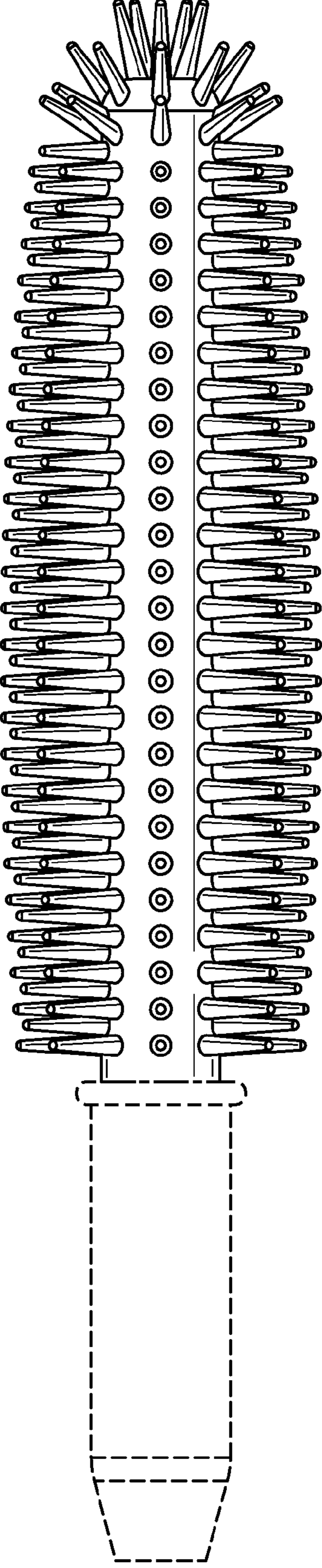

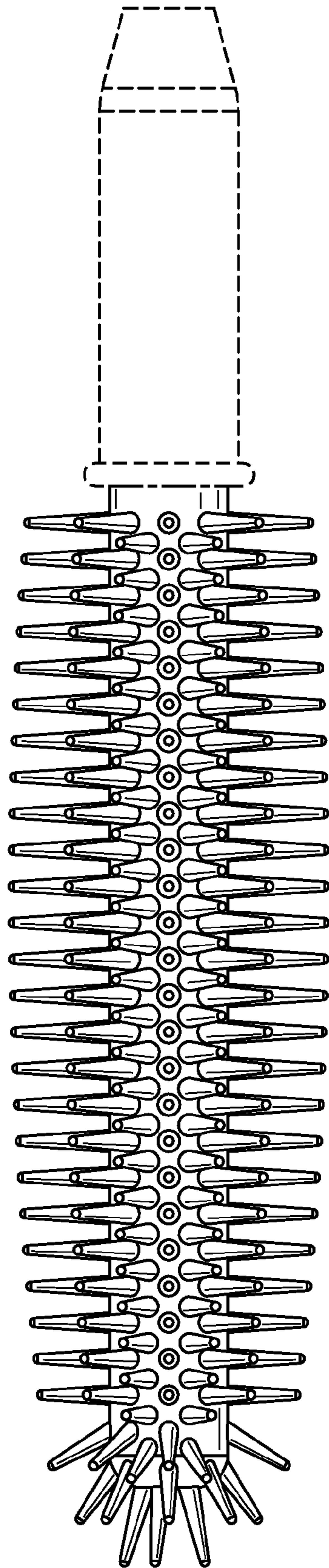

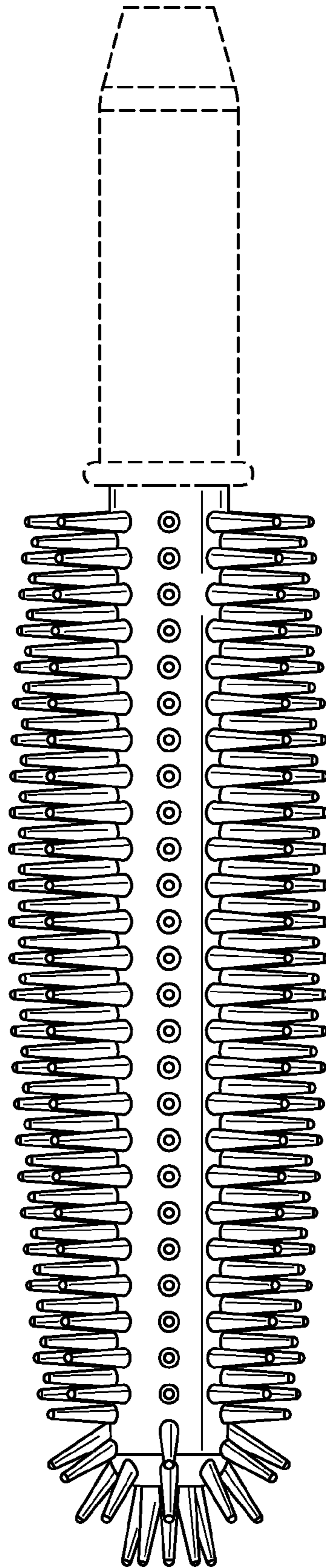

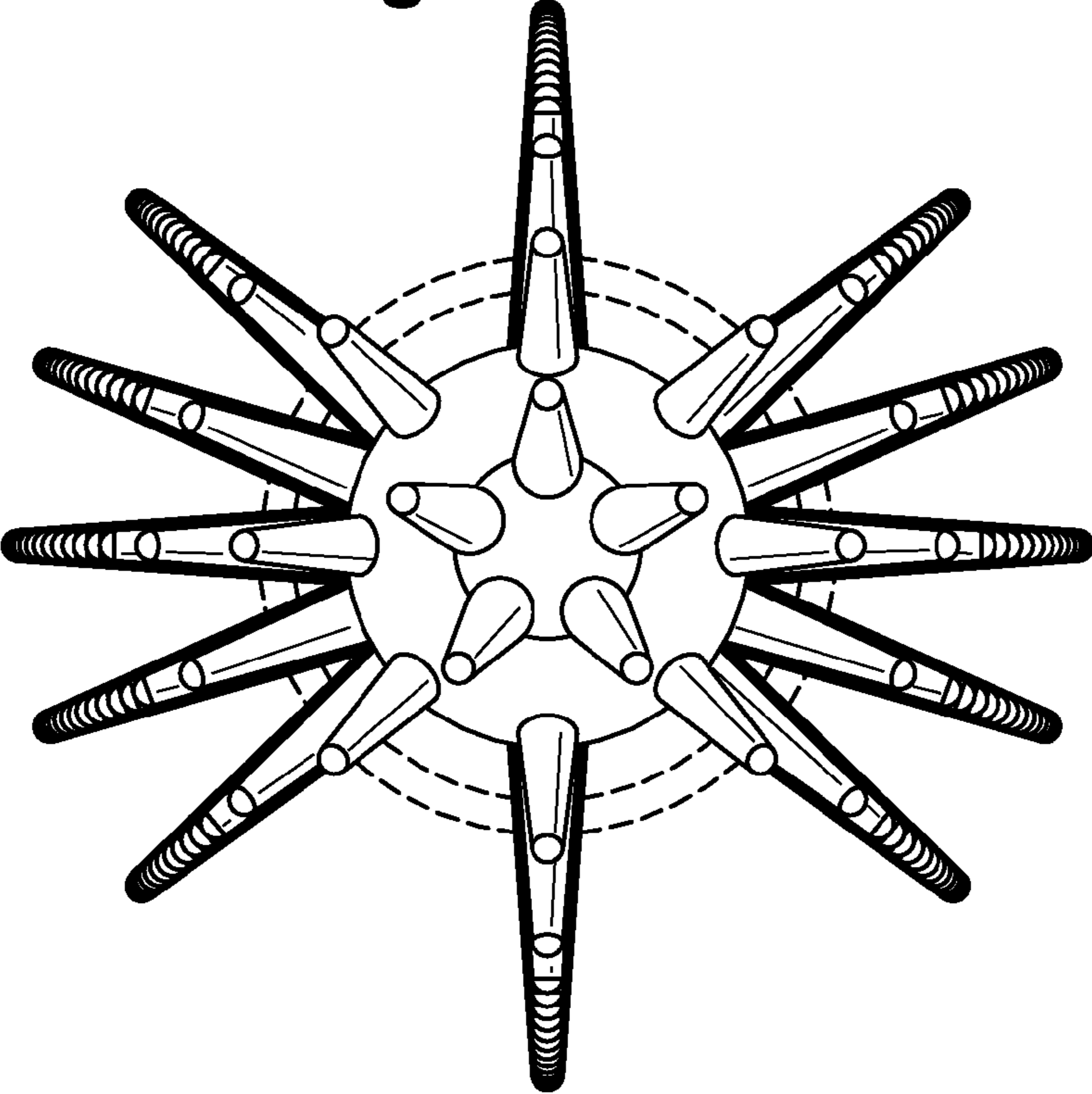
