(57) **CLAIM**

The ornamental design for a chair, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view from above and one side of the chair according to the invention, the chair having a seat and back rest unit mounted on a chair subframe;

FIG. 2 is a front view of the chair shown in FIG. 1;

FIG. 3 is a rear view of the chair;

FIG. 4 is a side view of the chair from one side;

FIG. 5 is a side view of the chair from the opposite side of that shown in FIG. 4;

FIG. 6 is a top view of the chair;

FIG. 7 is a bottom view of the chair;

FIG. 8 is a rear perspective view of the chair from above and the opposite side of that shown in FIG. 1;

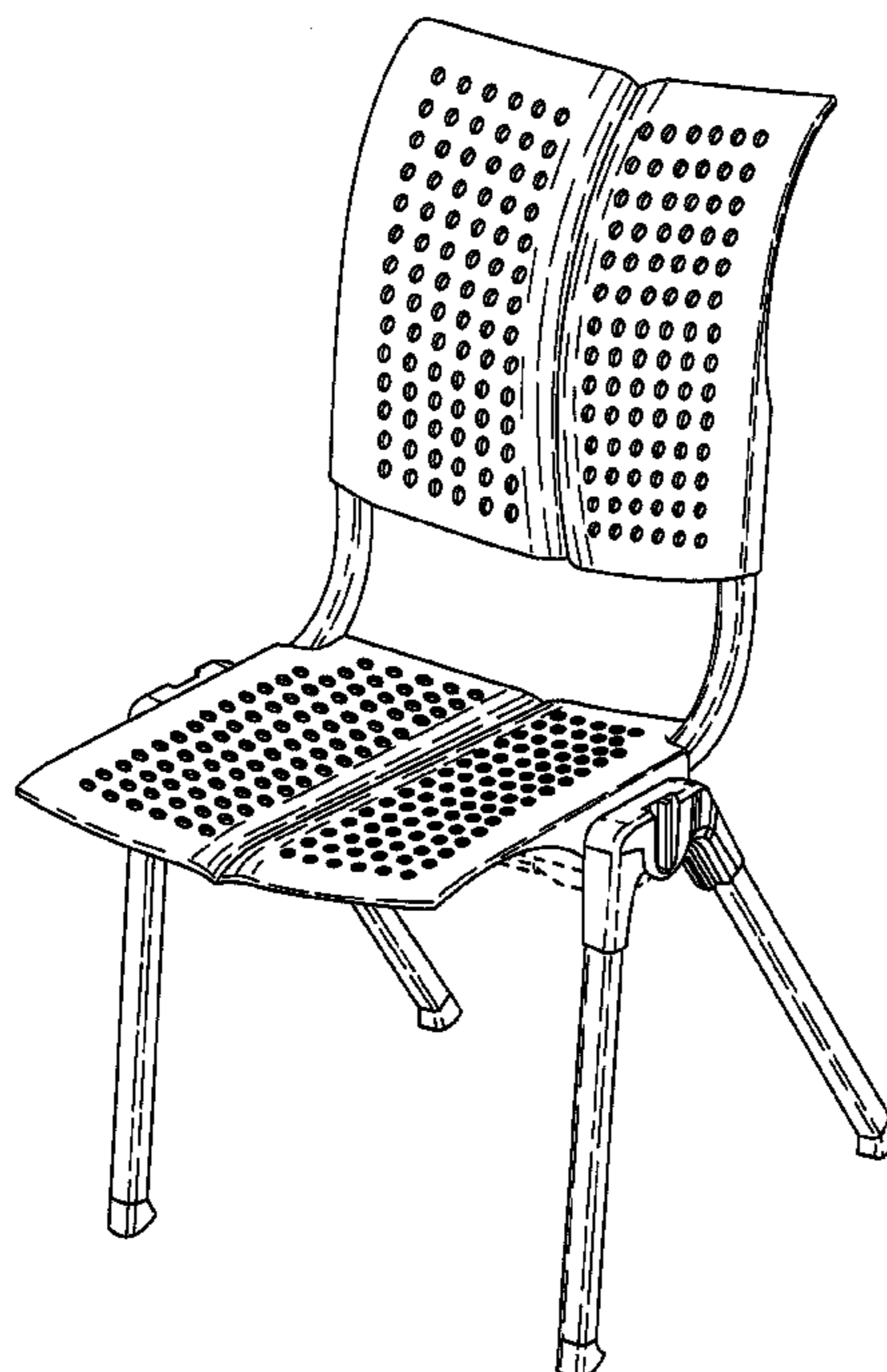
FIG. 9 is a rear perspective view of the chair from above and the same side as shown in FIG. 1;

FIG. 10 is a front perspective view of the chair from the opposite side of that shown in FIG. 1; and,

FIG. 11 is a rear perspective view of the chair from the same side as that shown in FIG. 1.

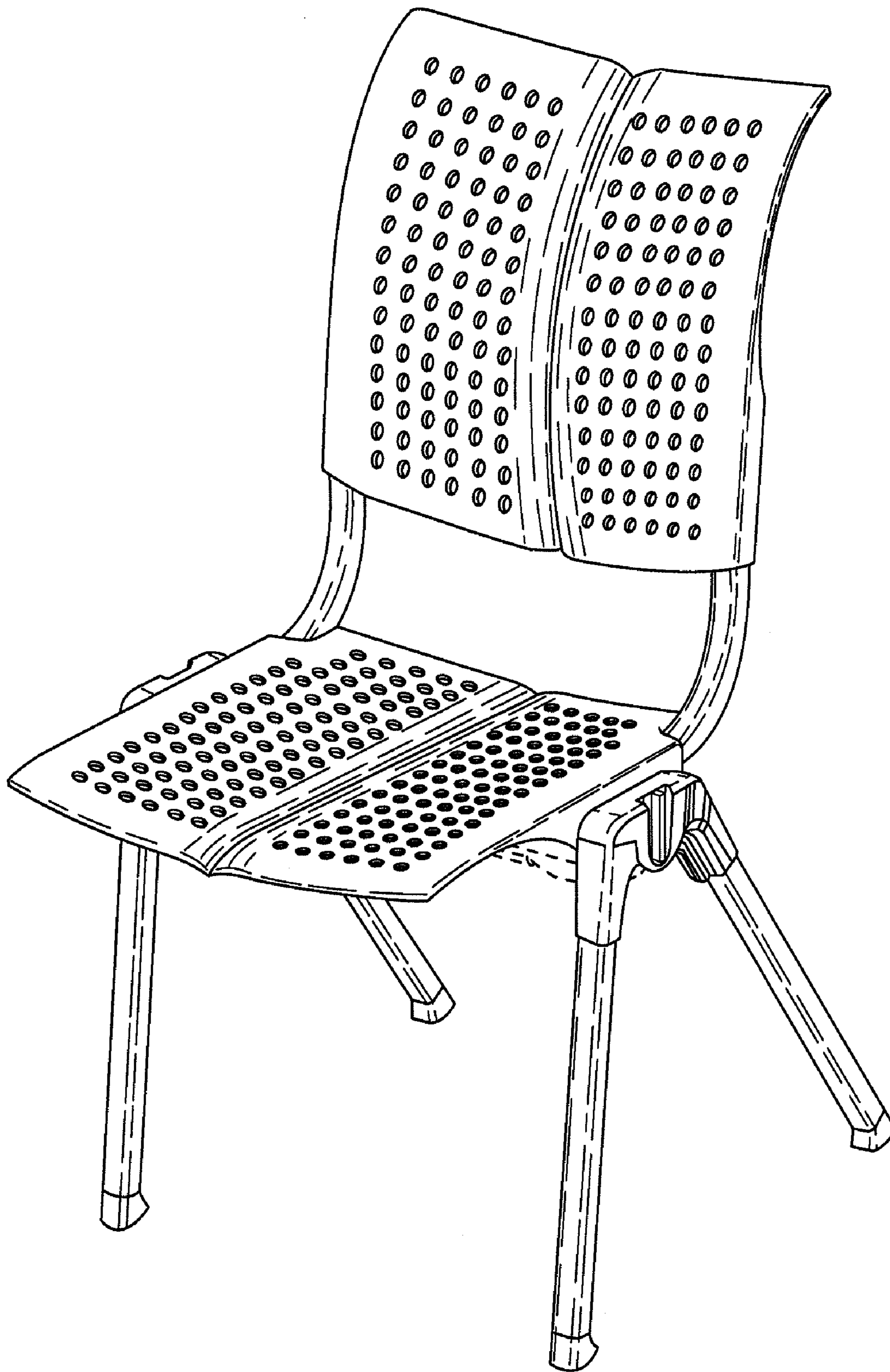

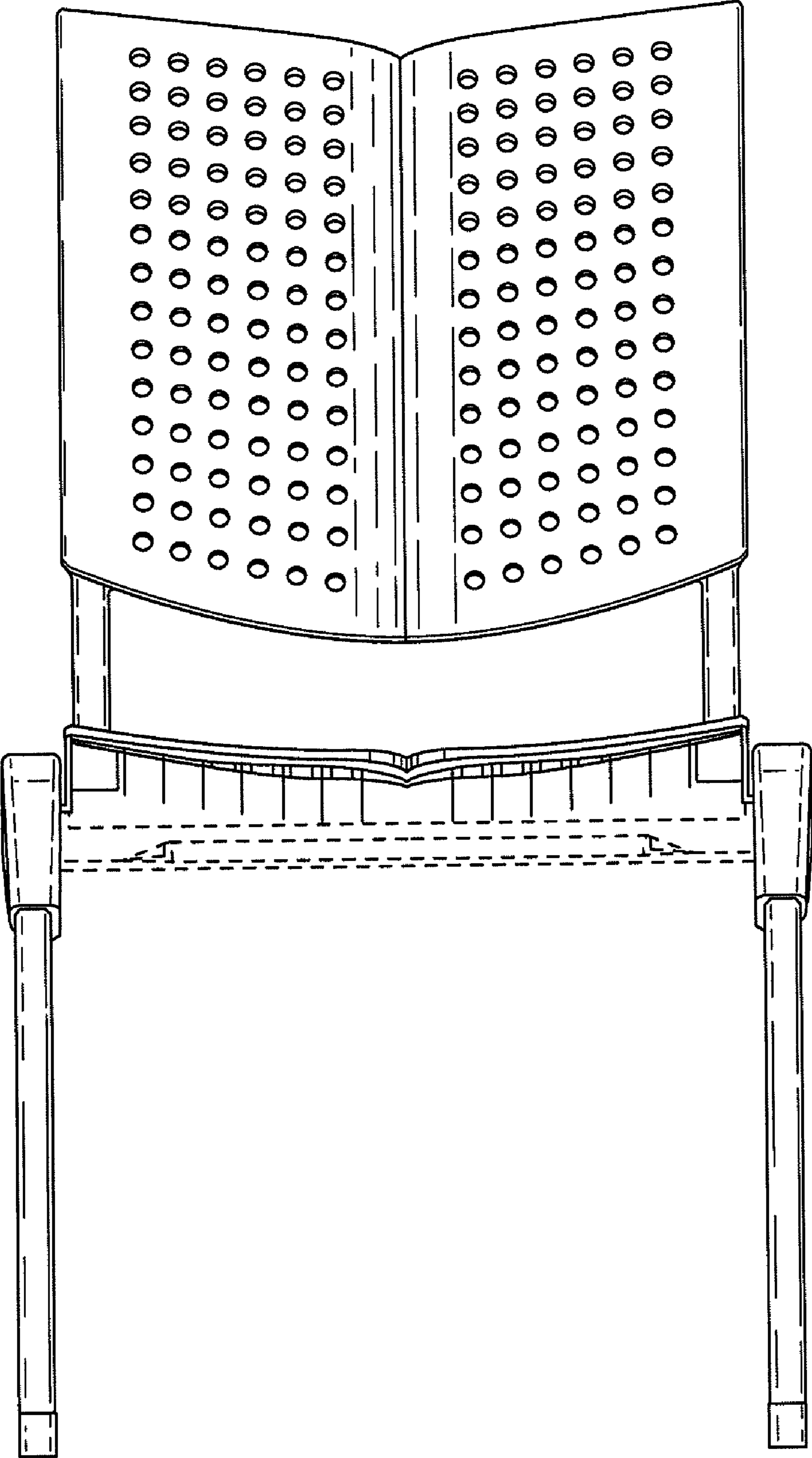

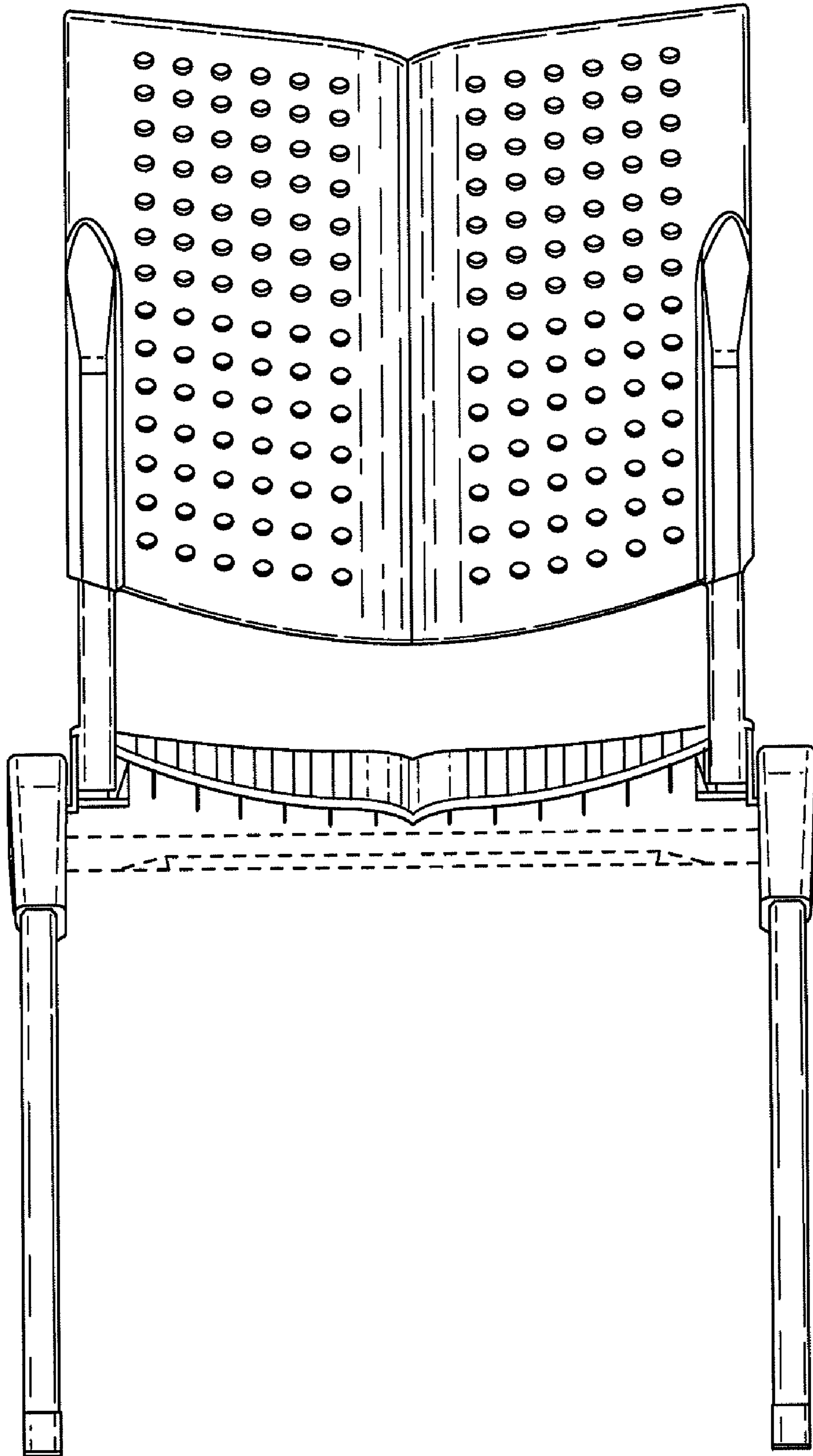

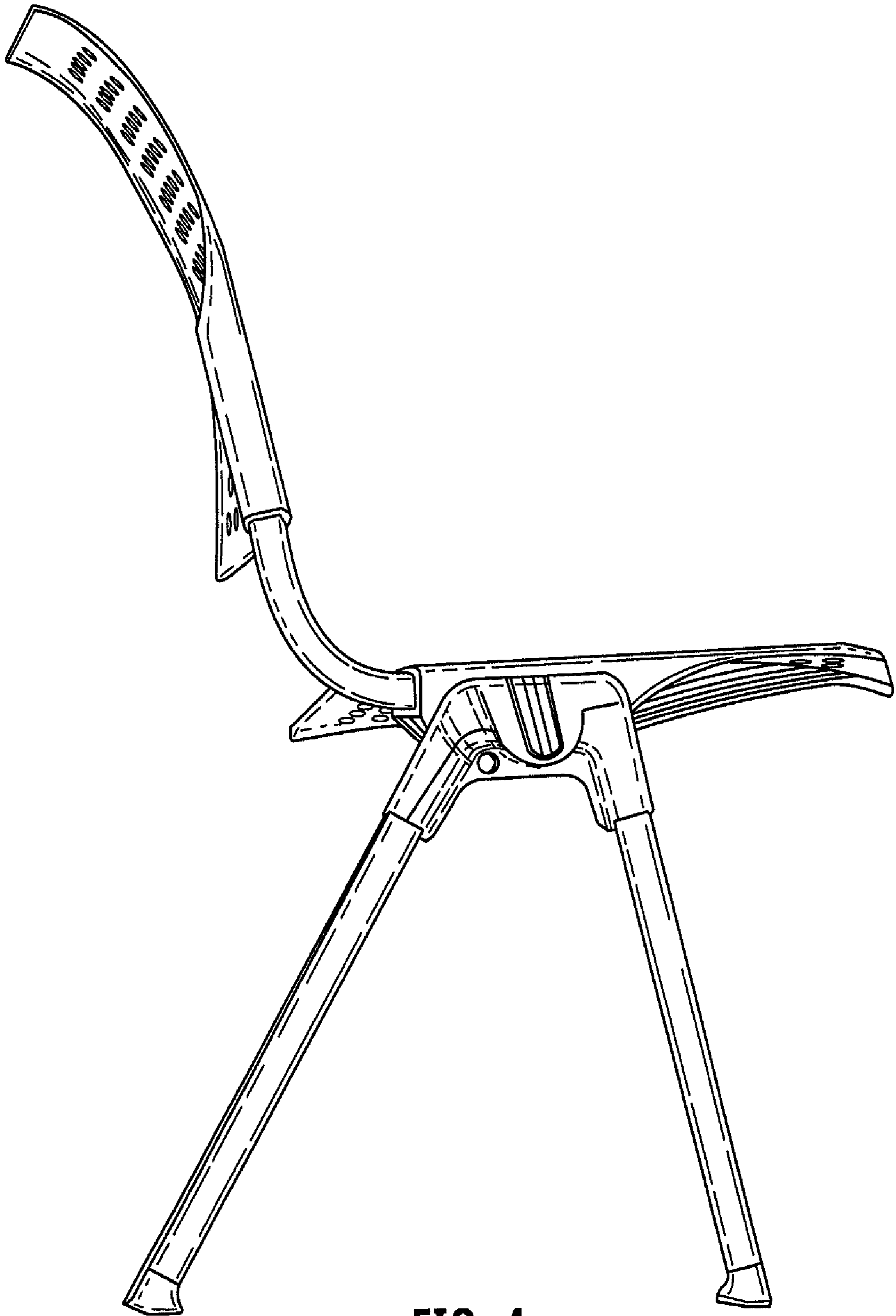

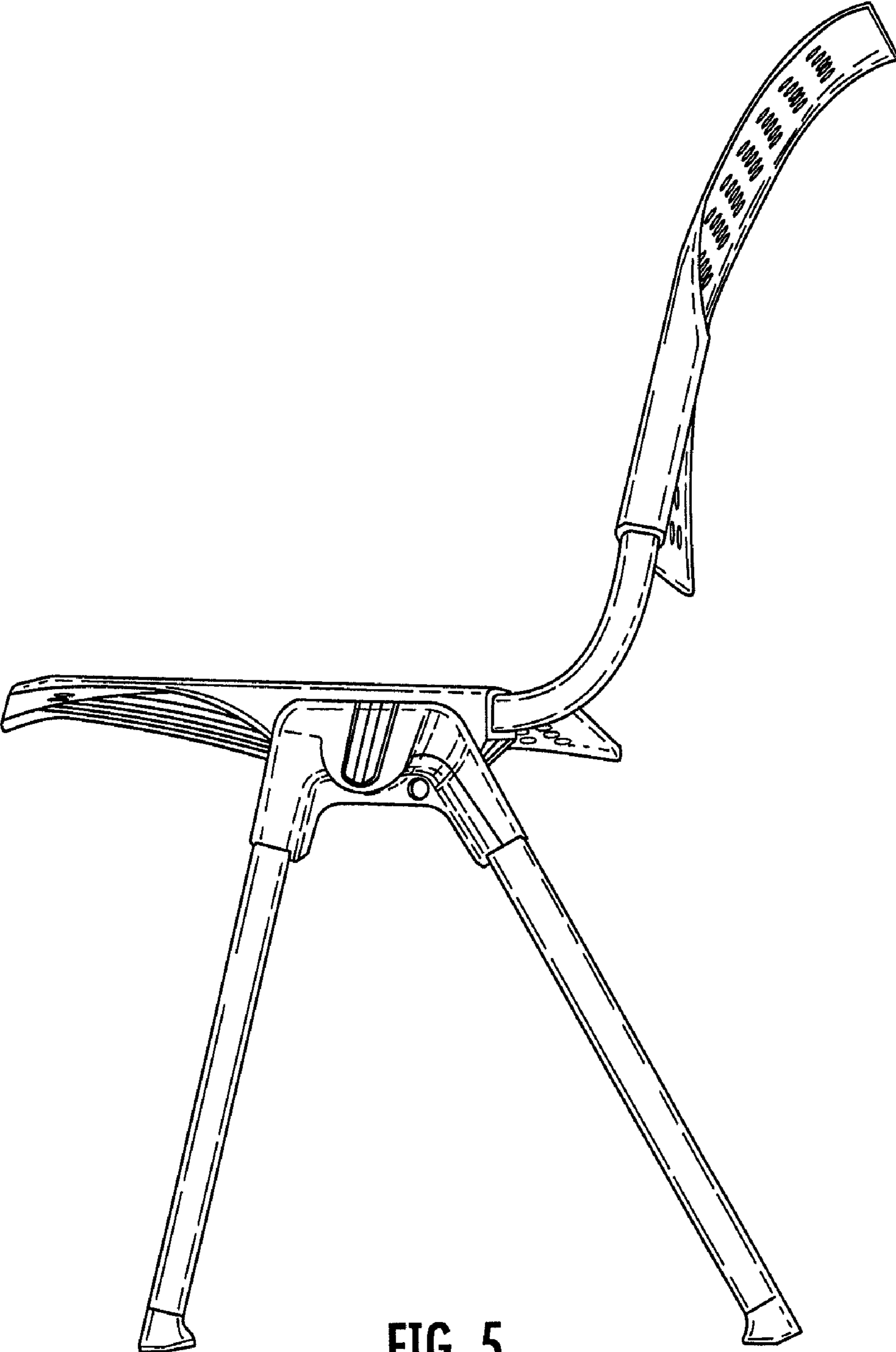

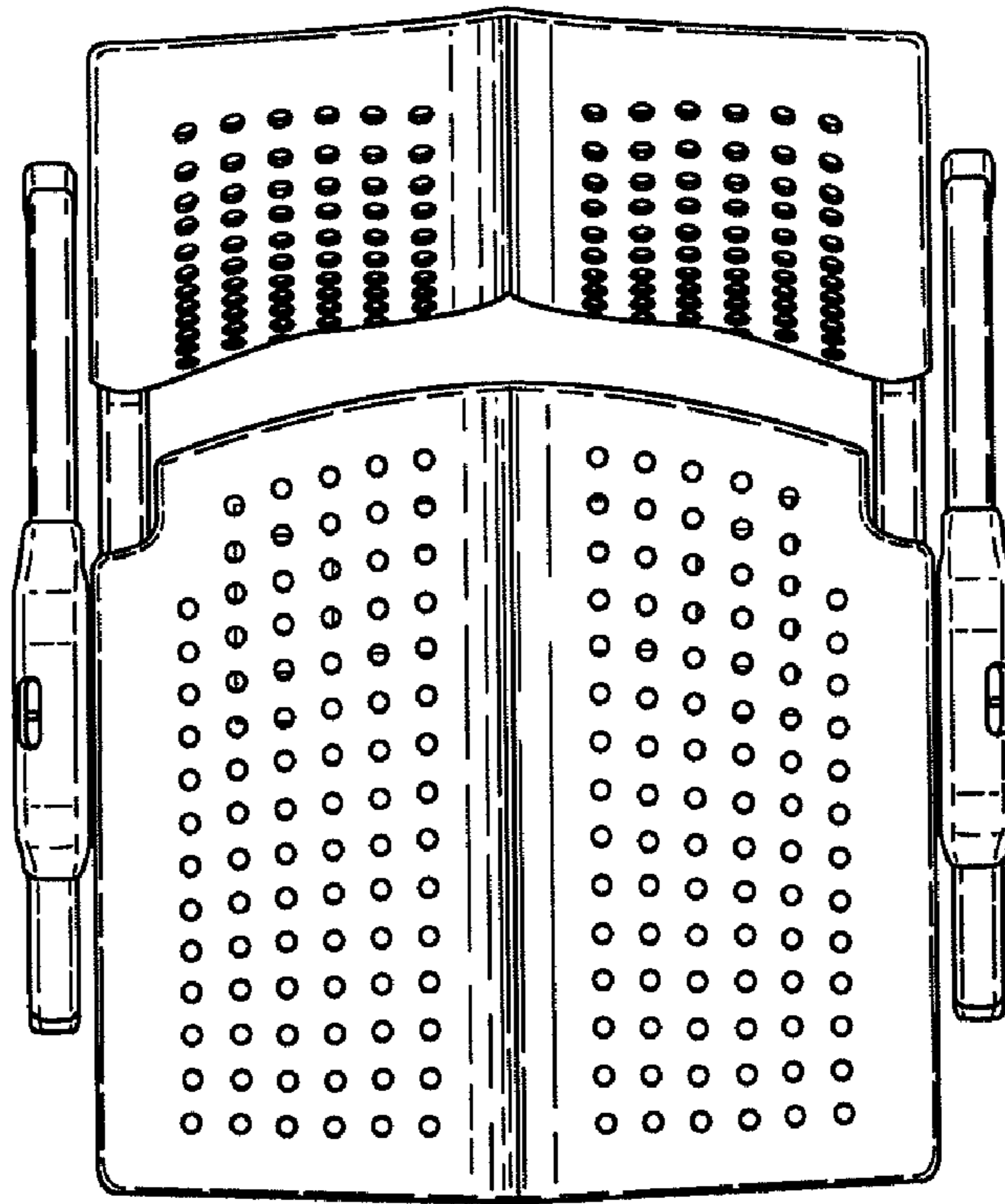

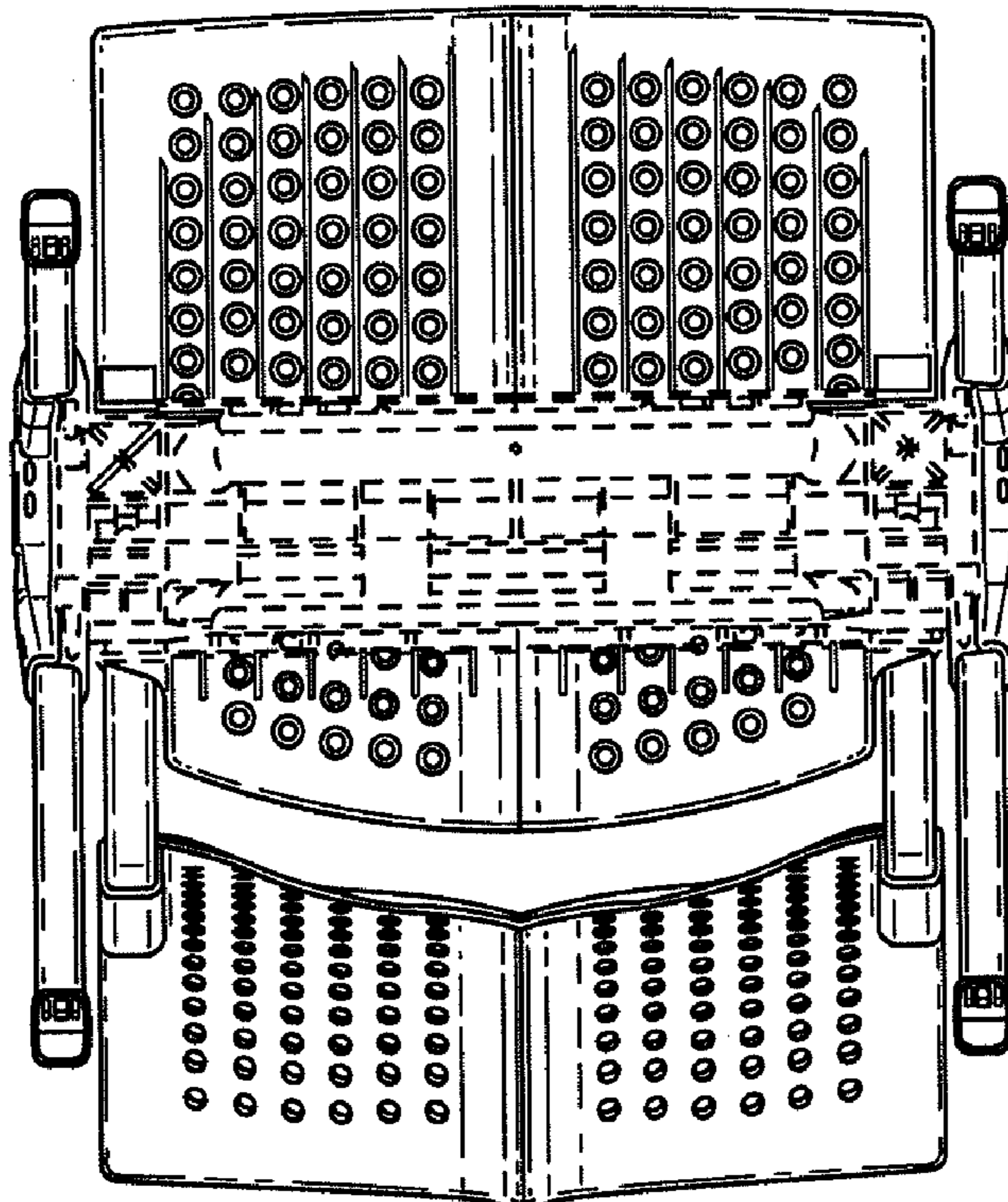

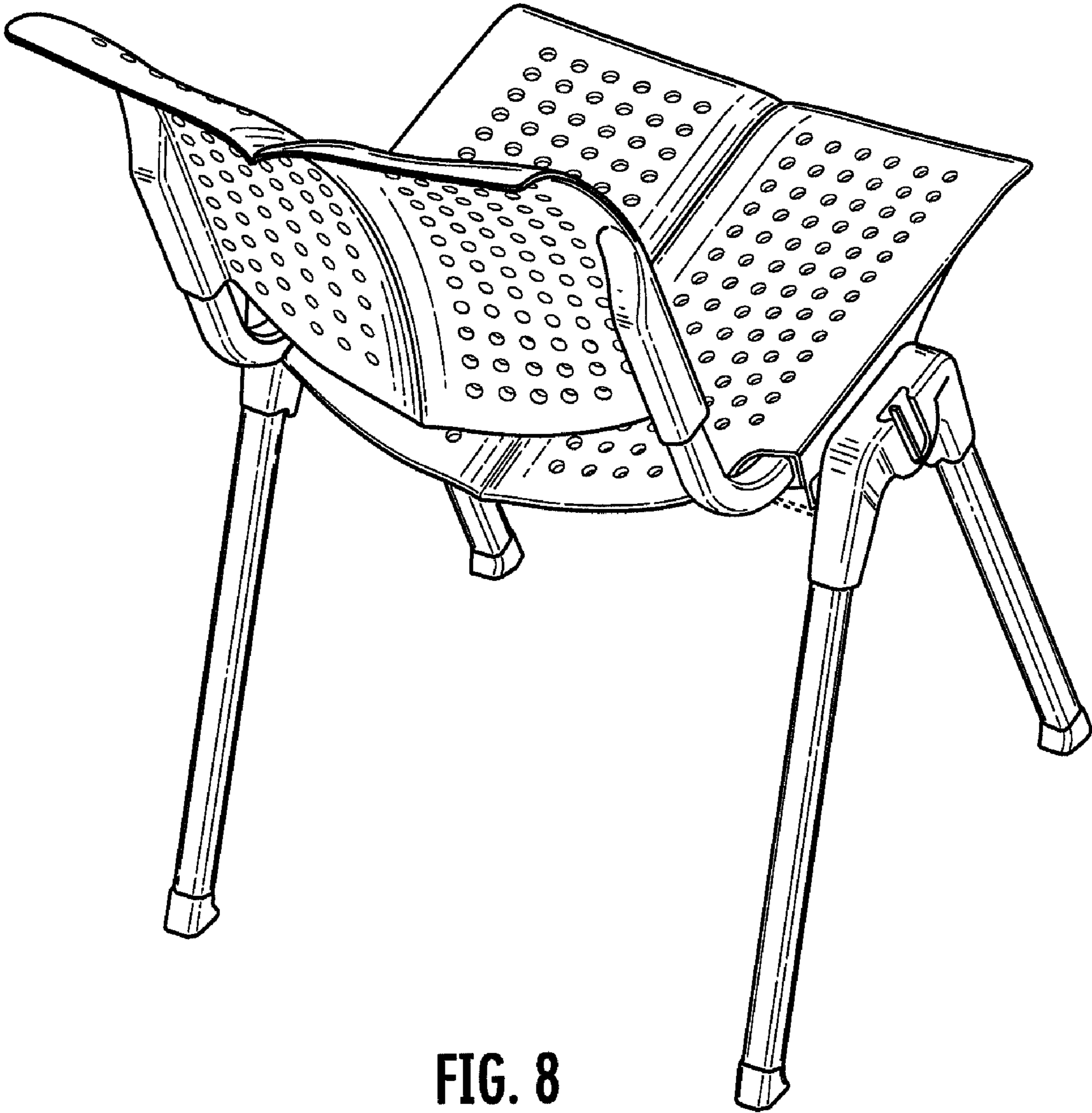

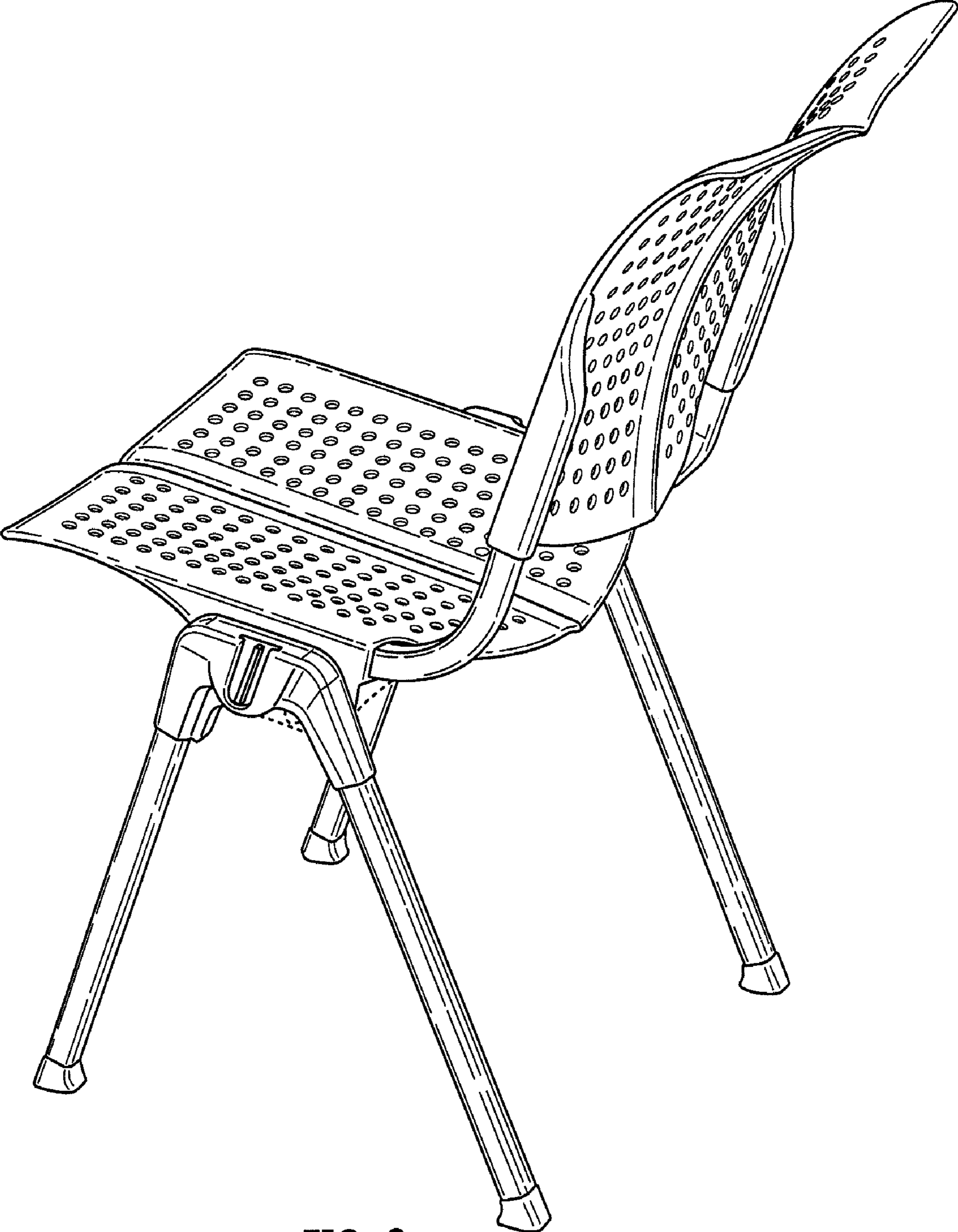

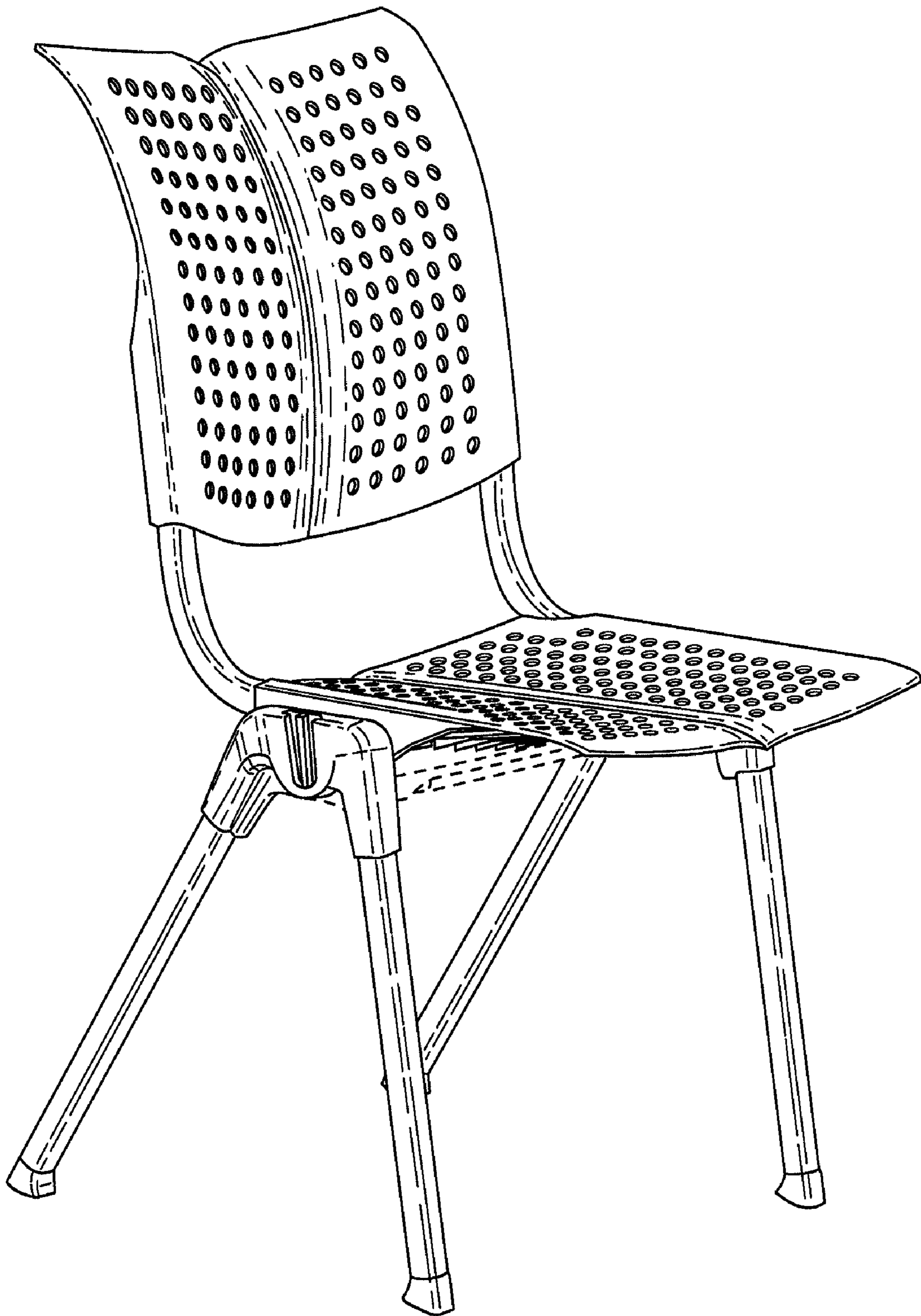

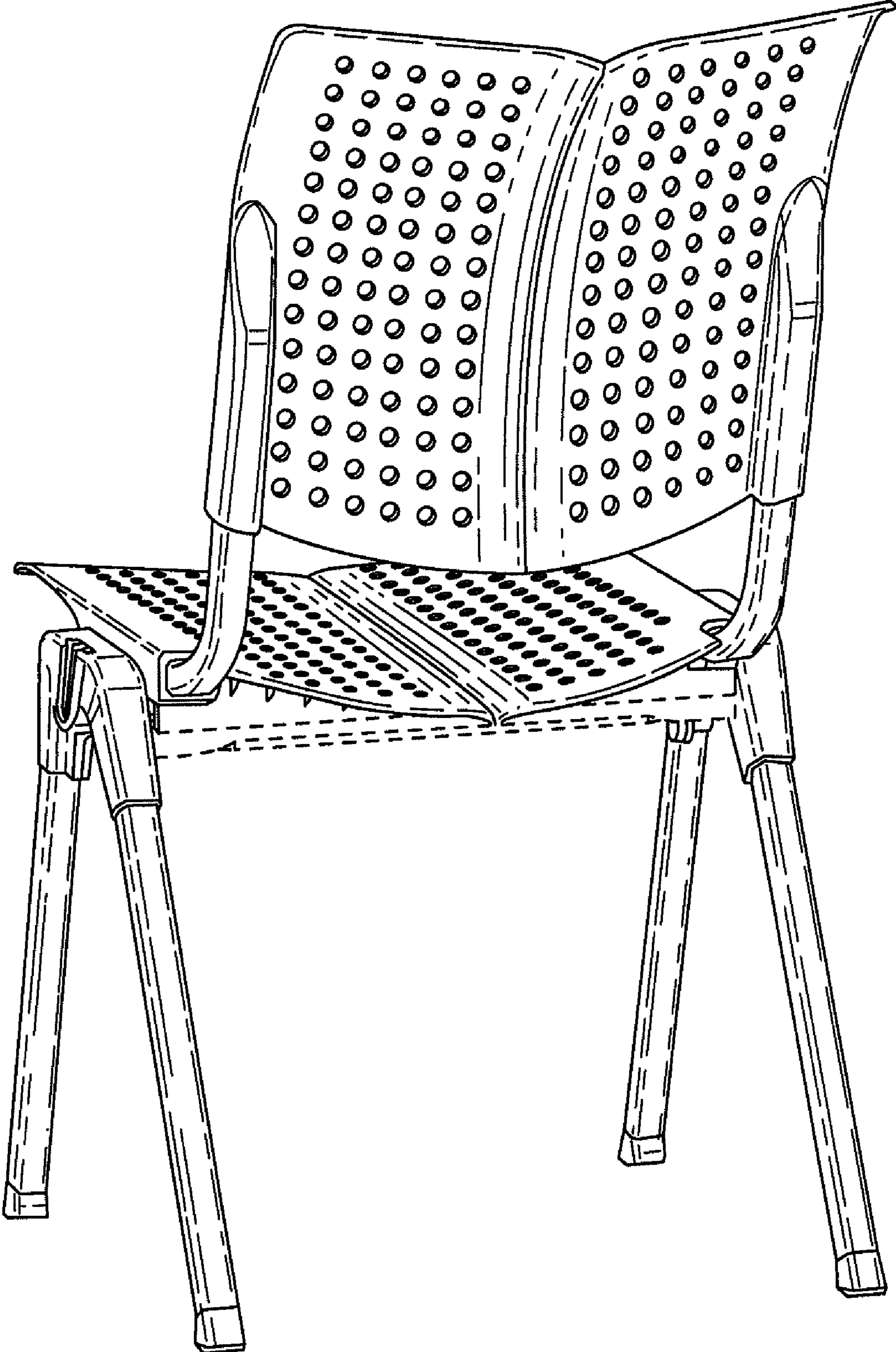
