(57) **CLAIM**

The ornamental design for a display apparatus for products or product images, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of a display apparatus for products or product images.

FIG. 2 is a front perspective view of the display apparatus of FIG. 1.

FIG. 3 is a left elevation view of the display apparatus of FIG. 1.

FIG. 4 is a right elevation view of the display apparatus of FIG. 1.

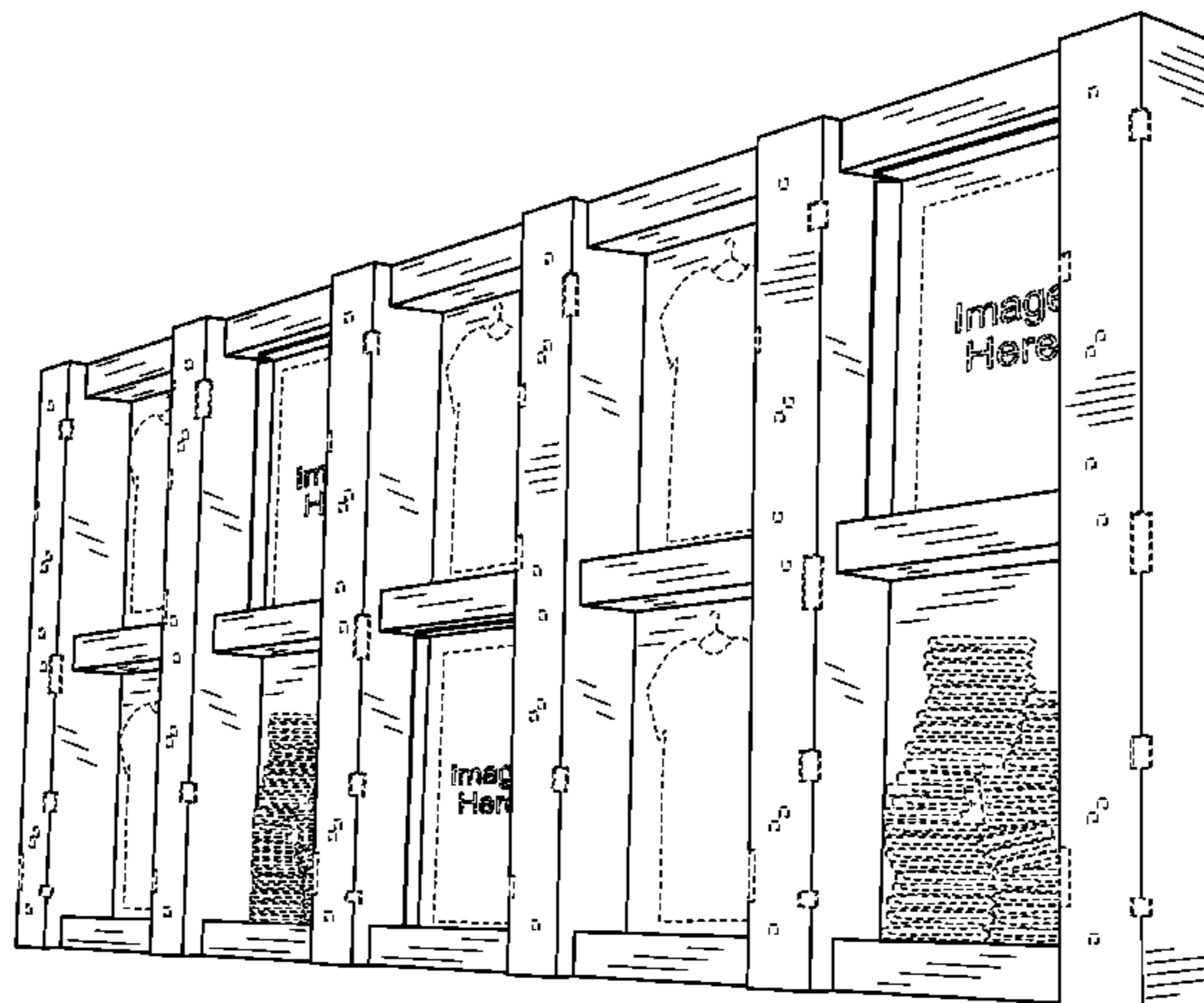
FIG. 5 is a top plan view of the display apparatus of FIG. 1.

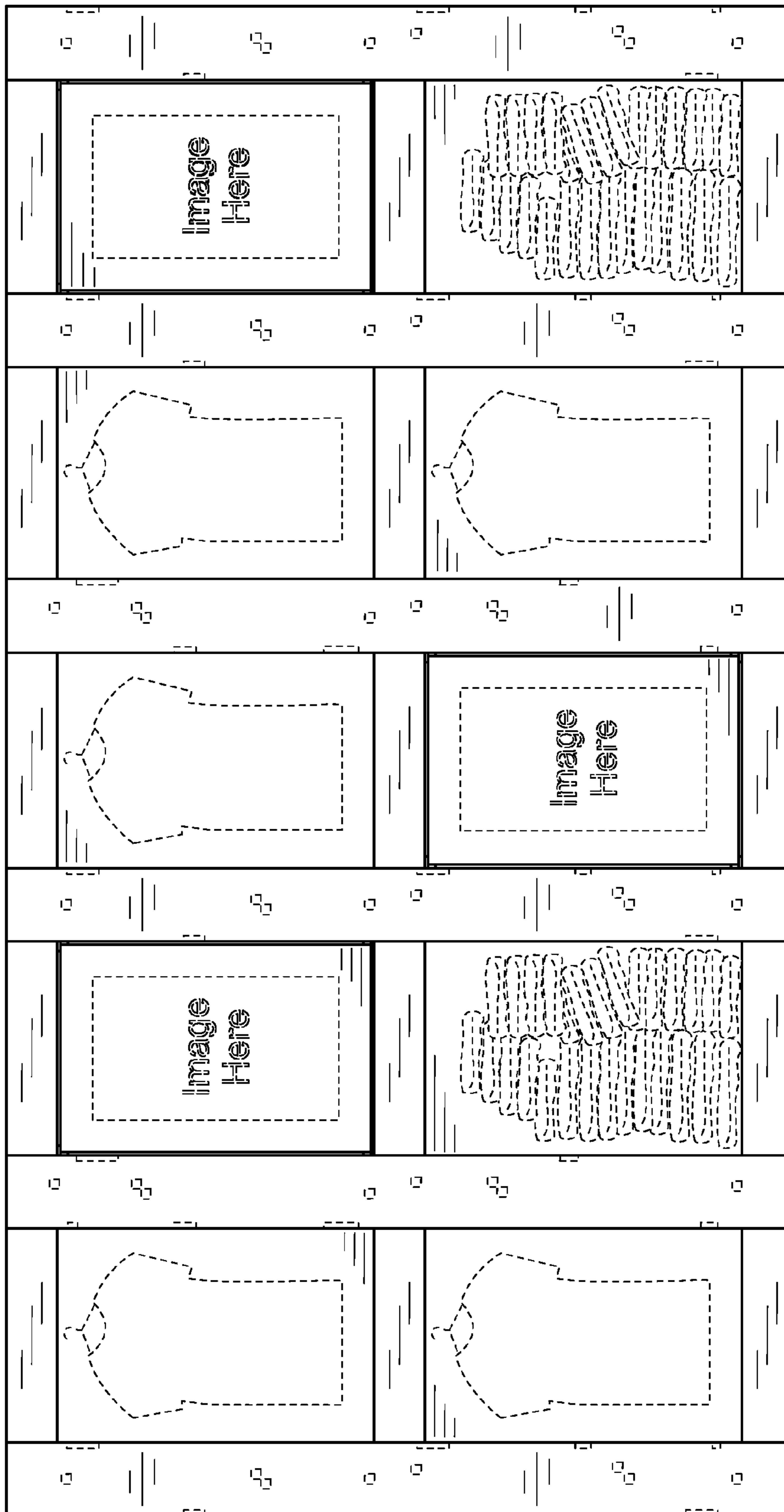
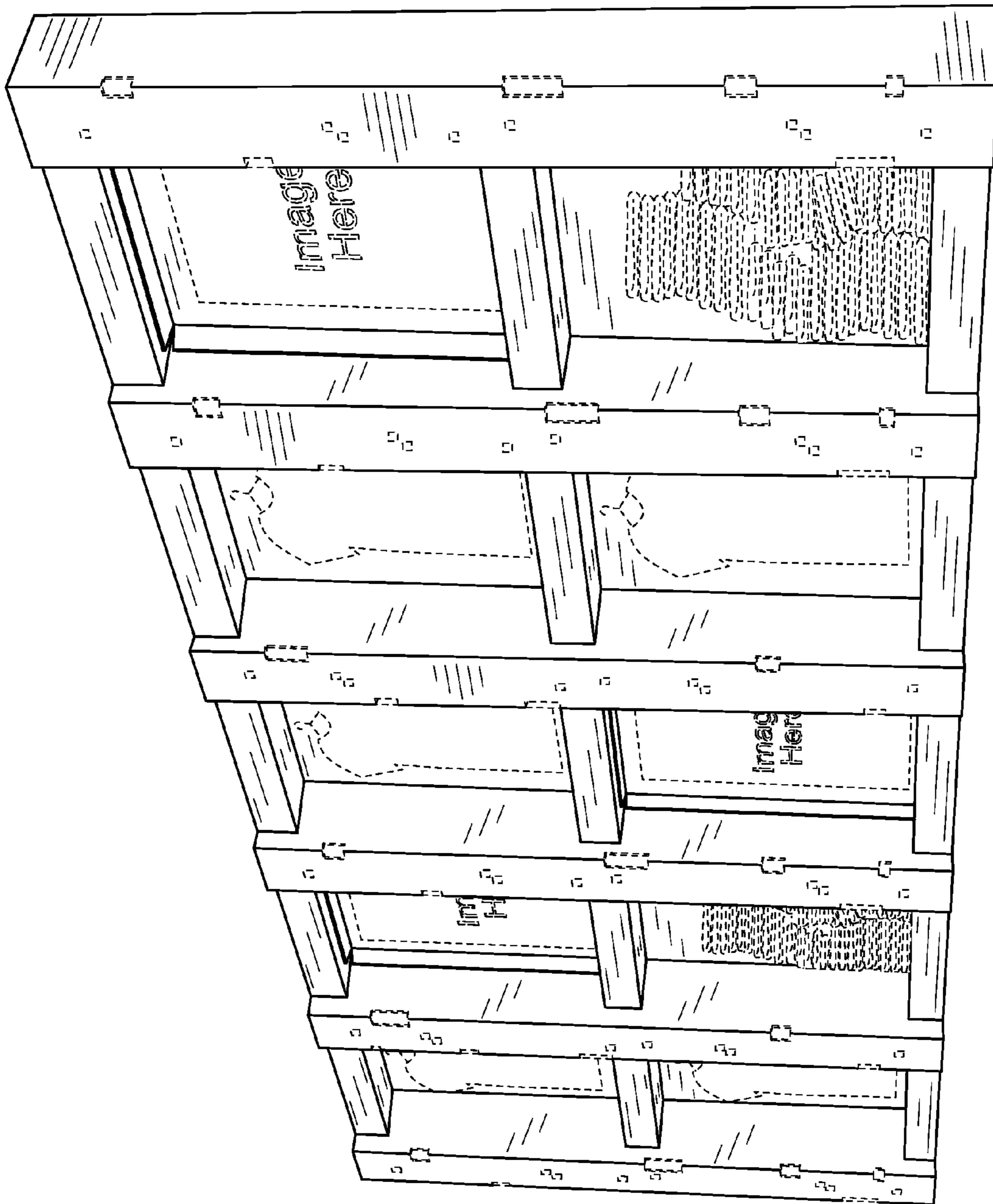

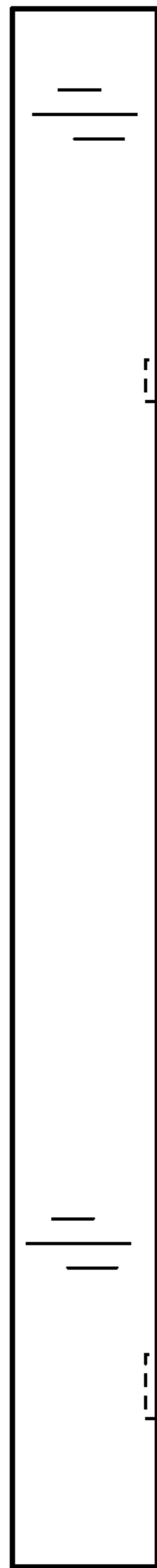

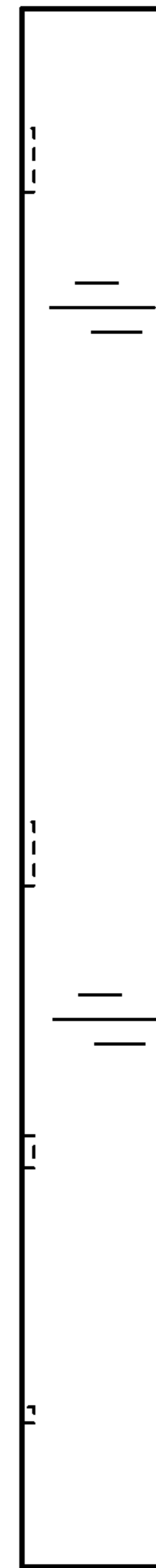

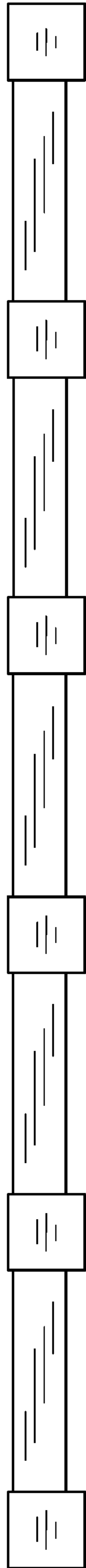

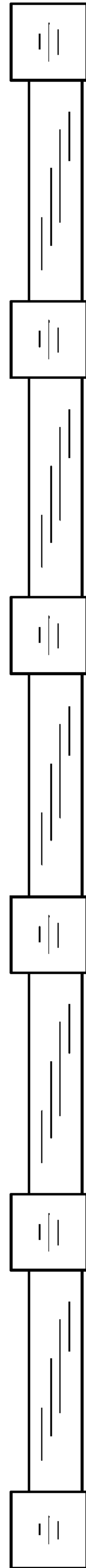

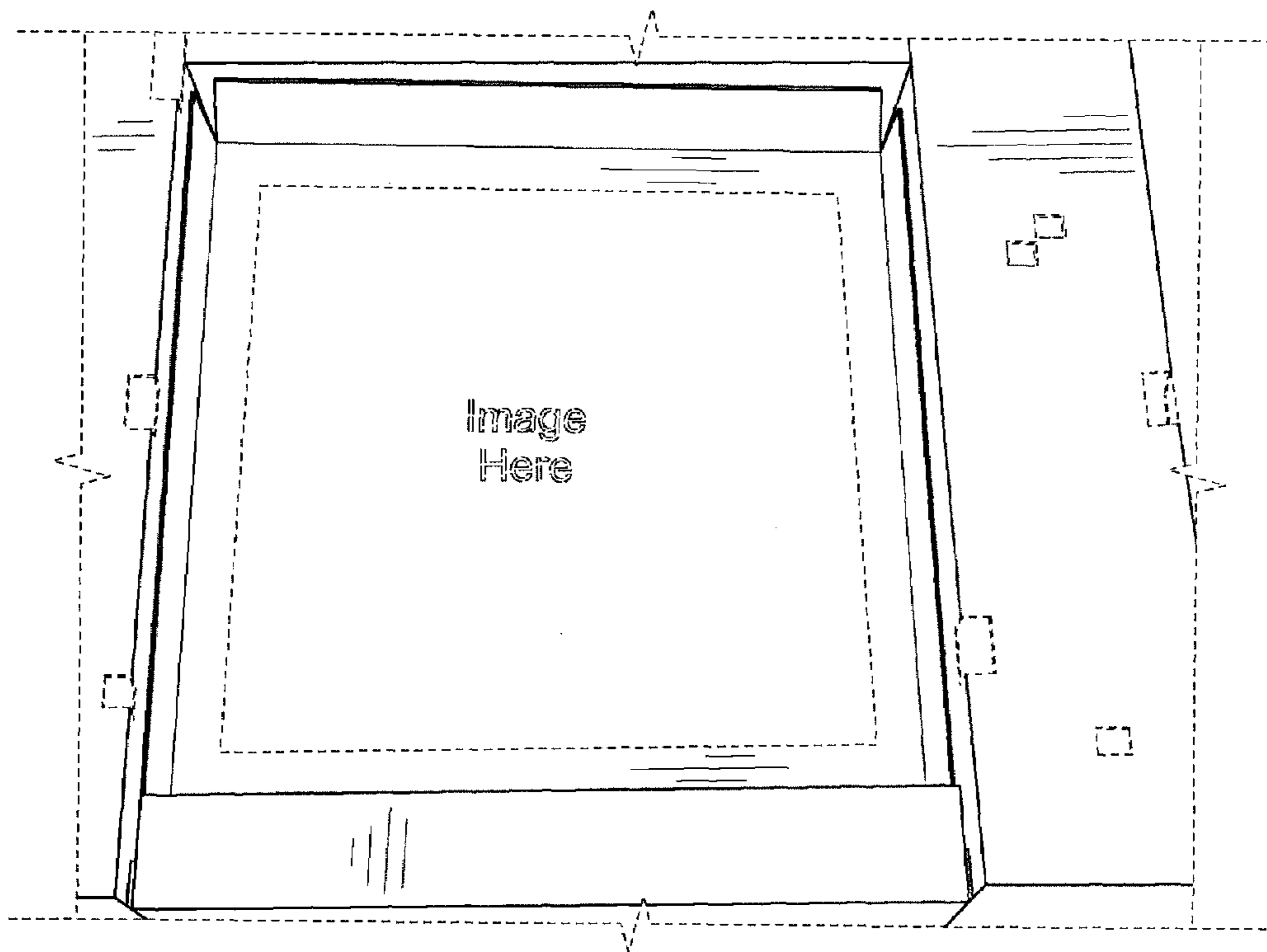
