(57) **CLAIM**

We claim the ornamental design for a bracket, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a bracket showing a first embodiment of our new design;

FIG. 2 is a top view thereof;

FIG. 3 is a front view thereof, wherein the back view is the same as the front view;

FIG. 4 is a first side view thereof, wherein the second side view is the same as the first side view;

FIG. 5 is a bottom view thereof;

FIG. 6 is a top perspective view of a bracket showing a second embodiment of our new design;

FIG. 7 is a top view thereof;

FIG. 8 is a front view thereof, wherein the back view is the same as the front view;

FIG. 9 is a first side view thereof, wherein the second side view is the same as the first side view; and,

FIG. 10 is a bottom view thereof.

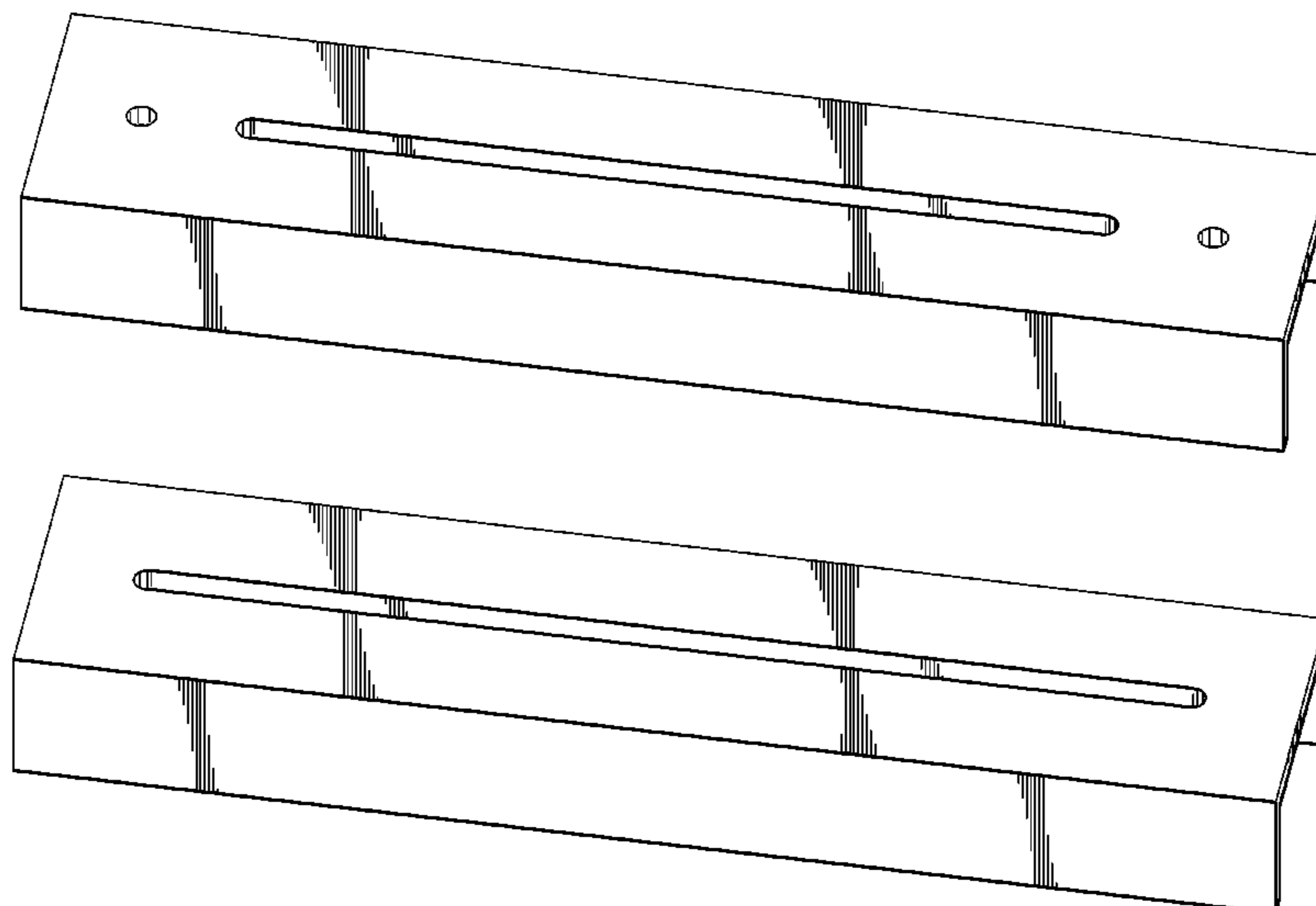

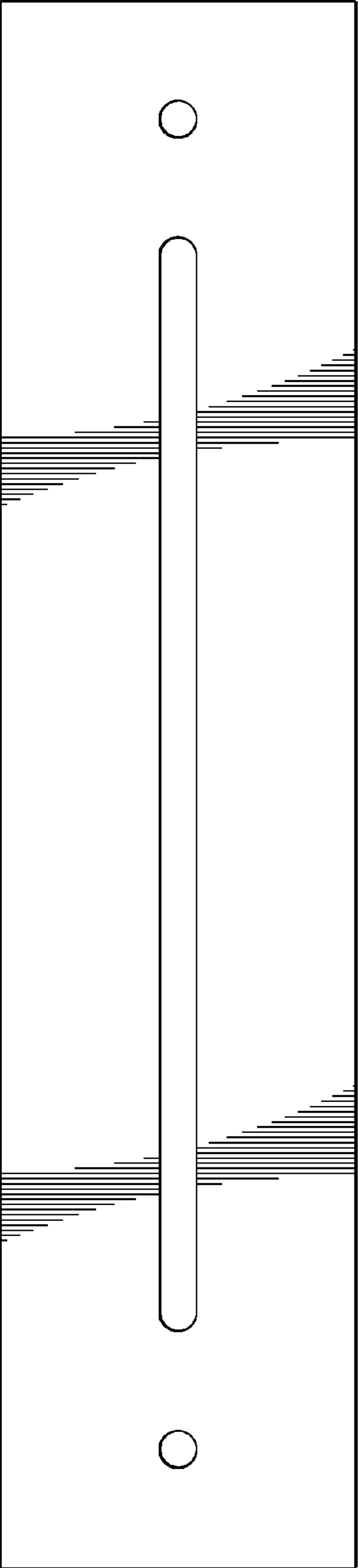

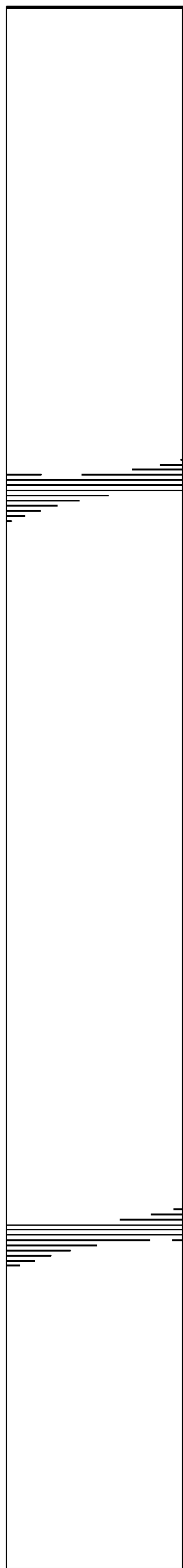

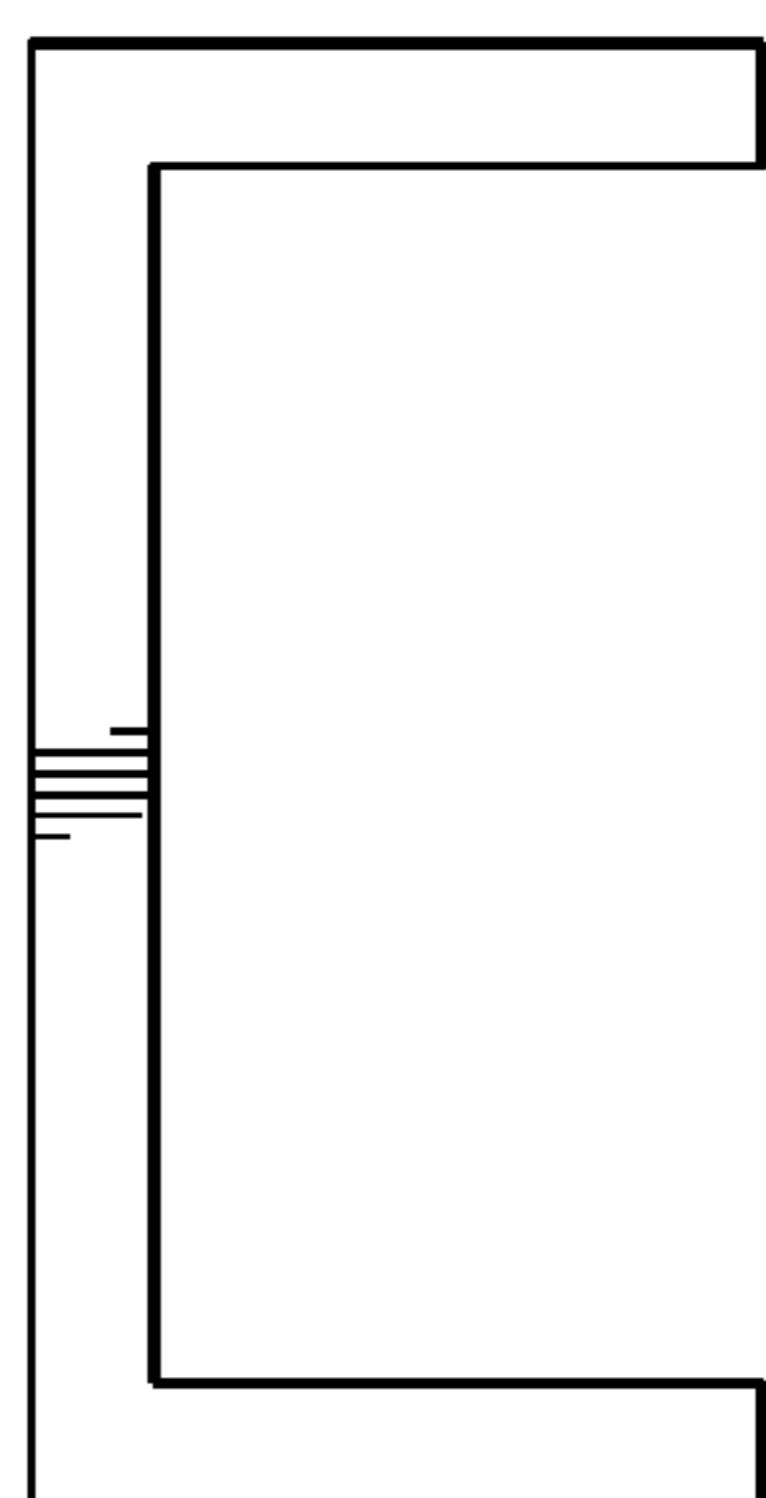

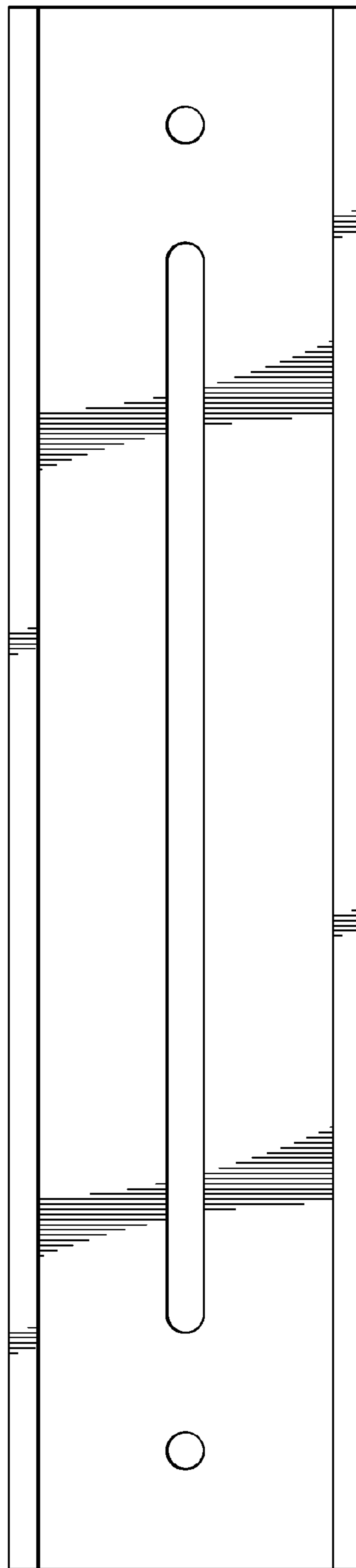

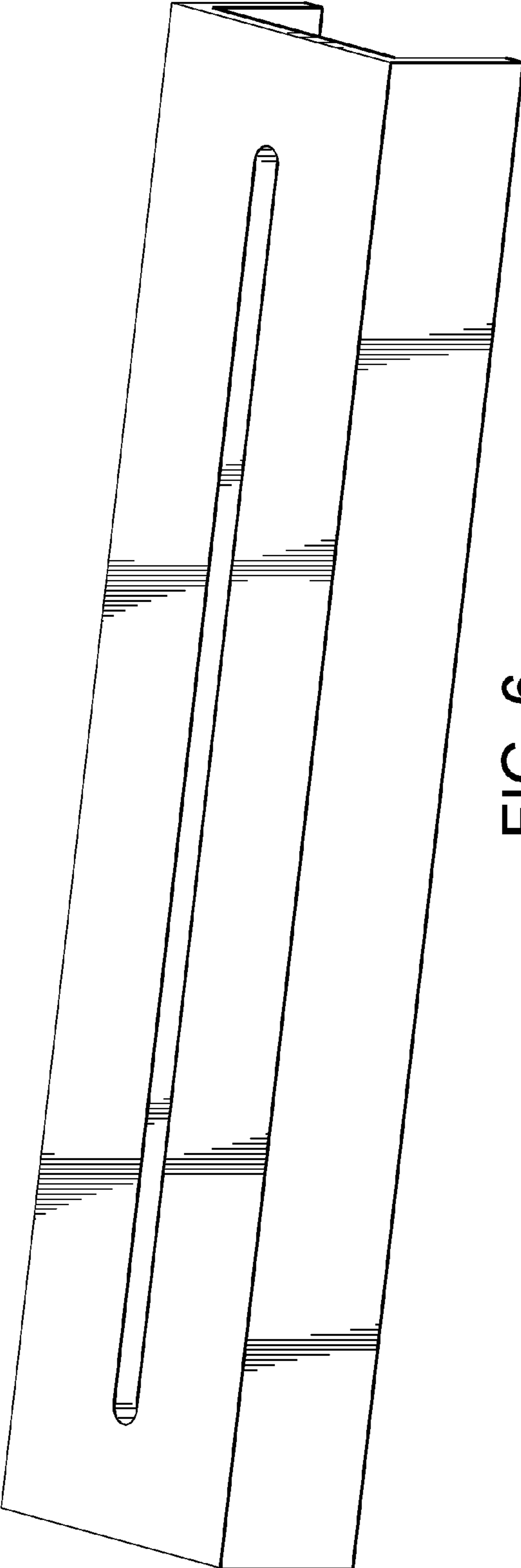

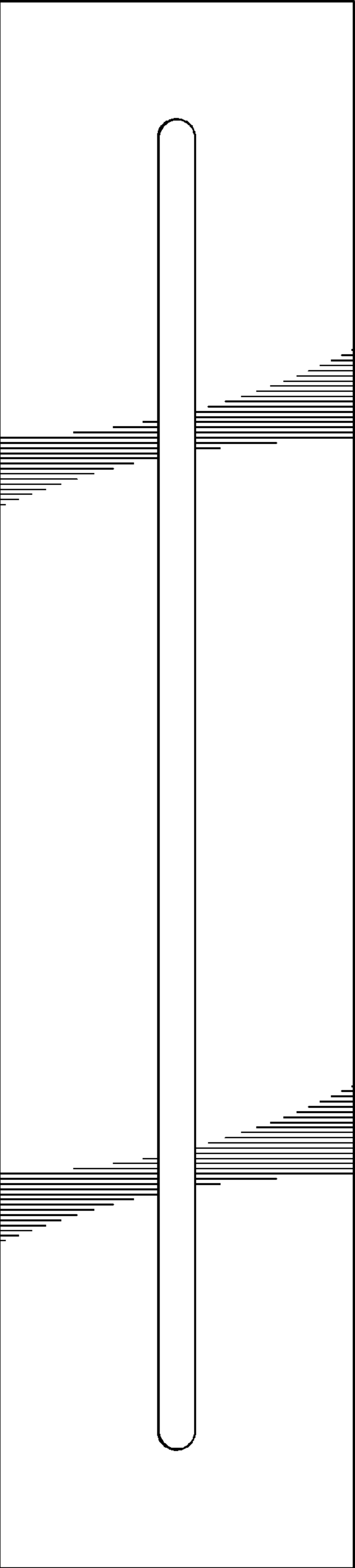

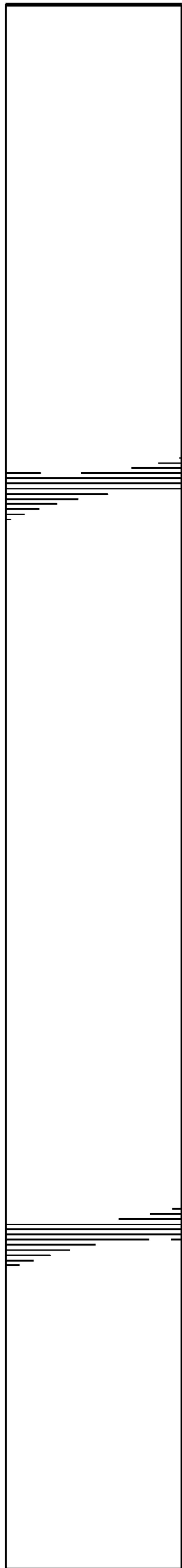

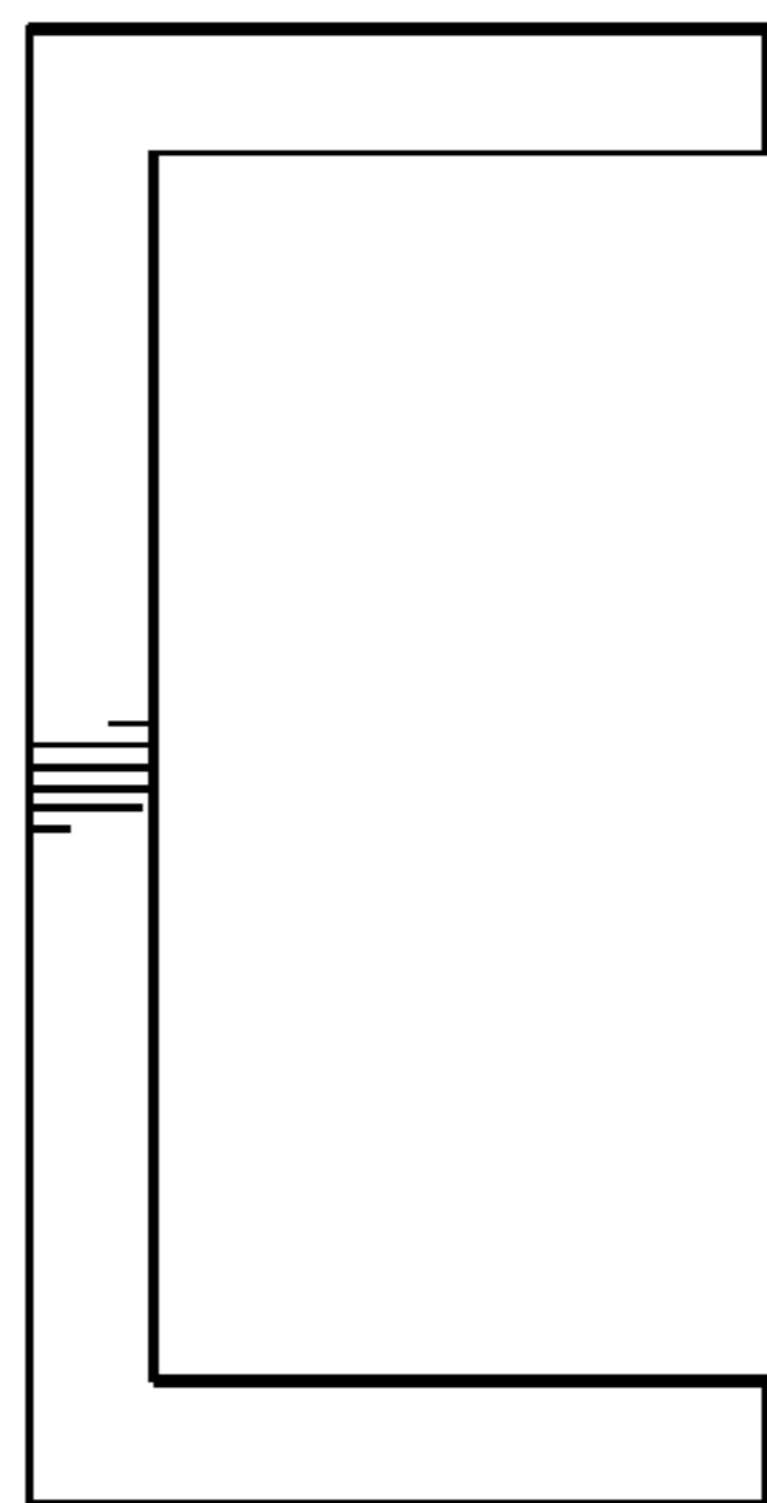

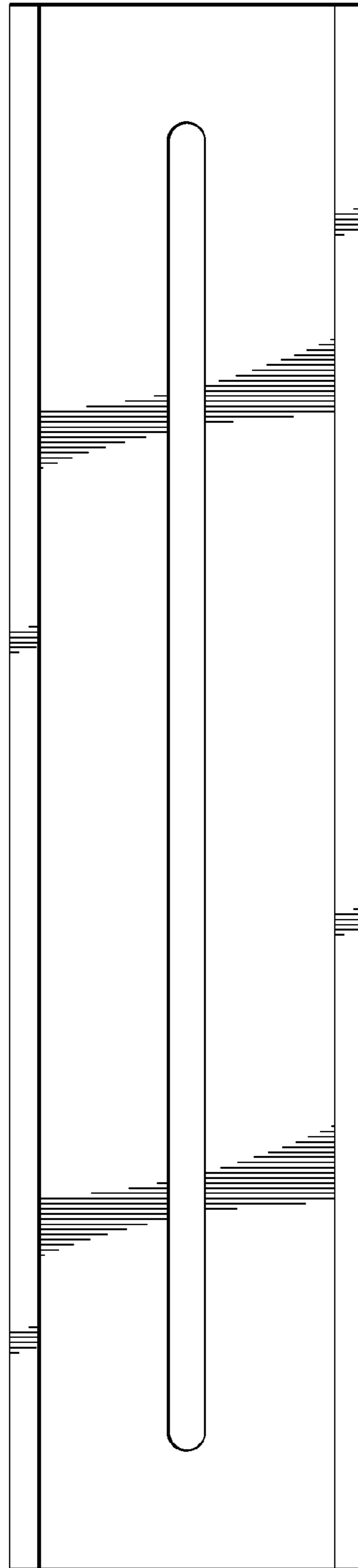
