FIG. 3 is a back view of the watch;

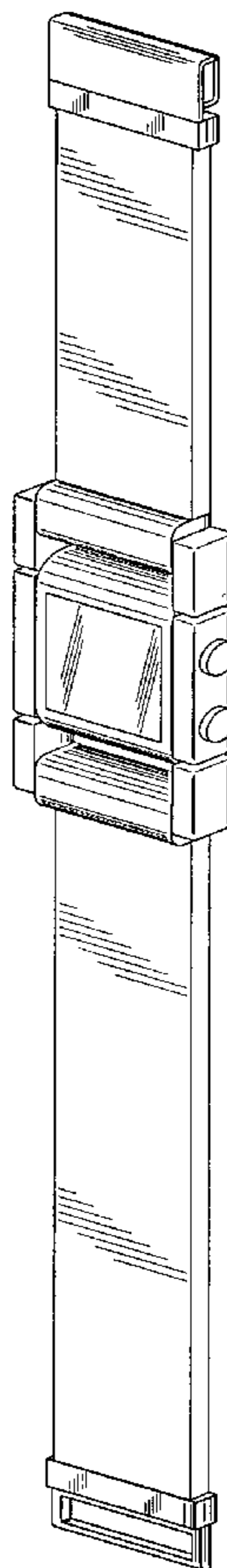
FIG. 4 is a left side view of the watch;

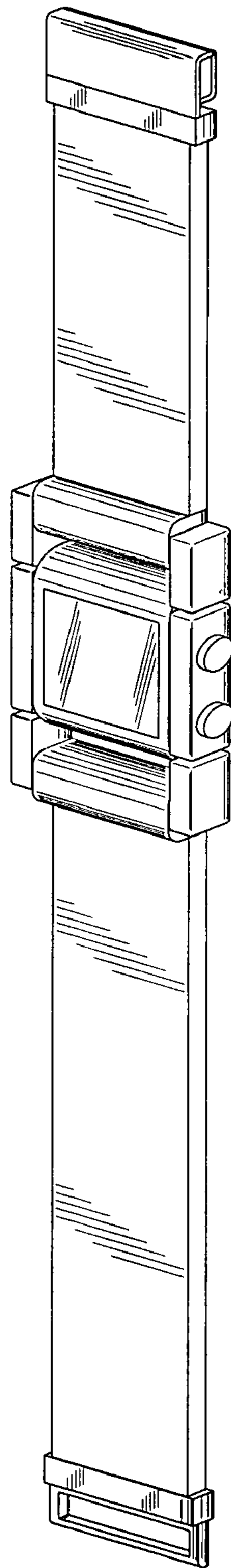

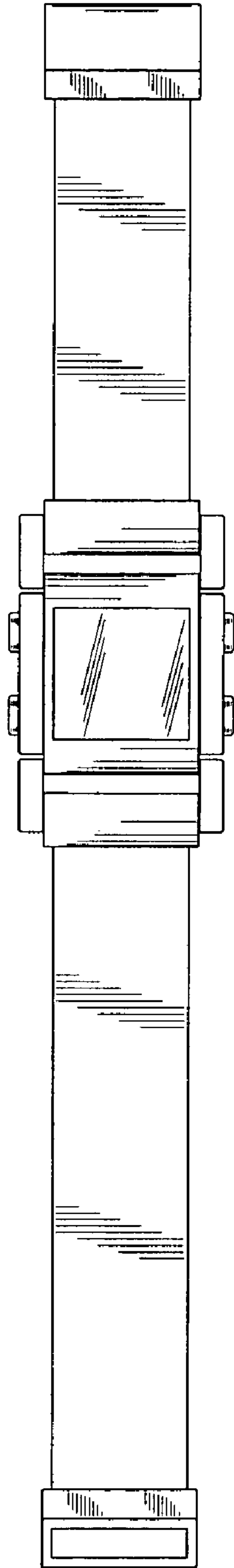

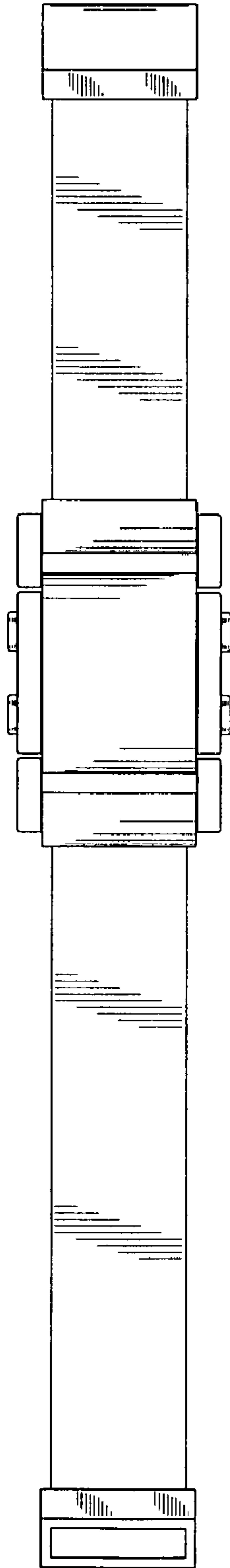

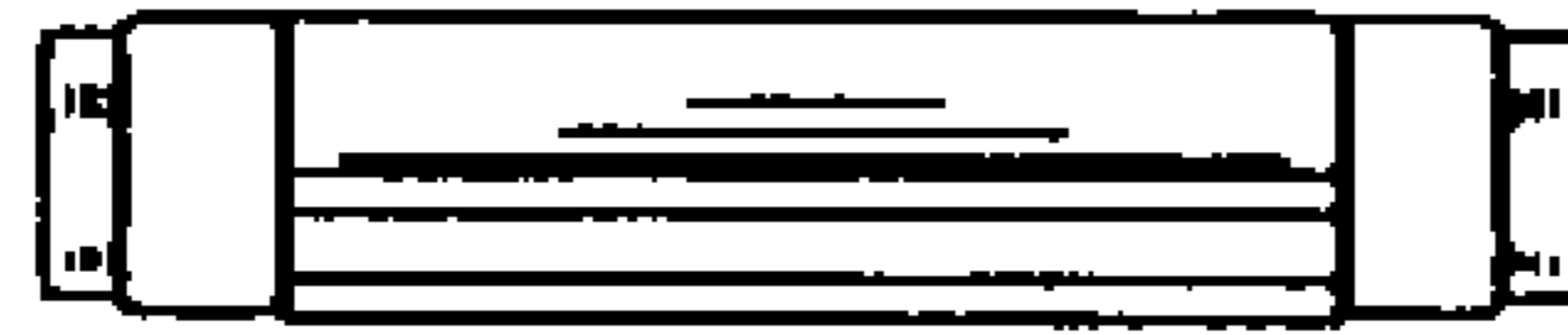
