FIG. 3 is a left view of the device.

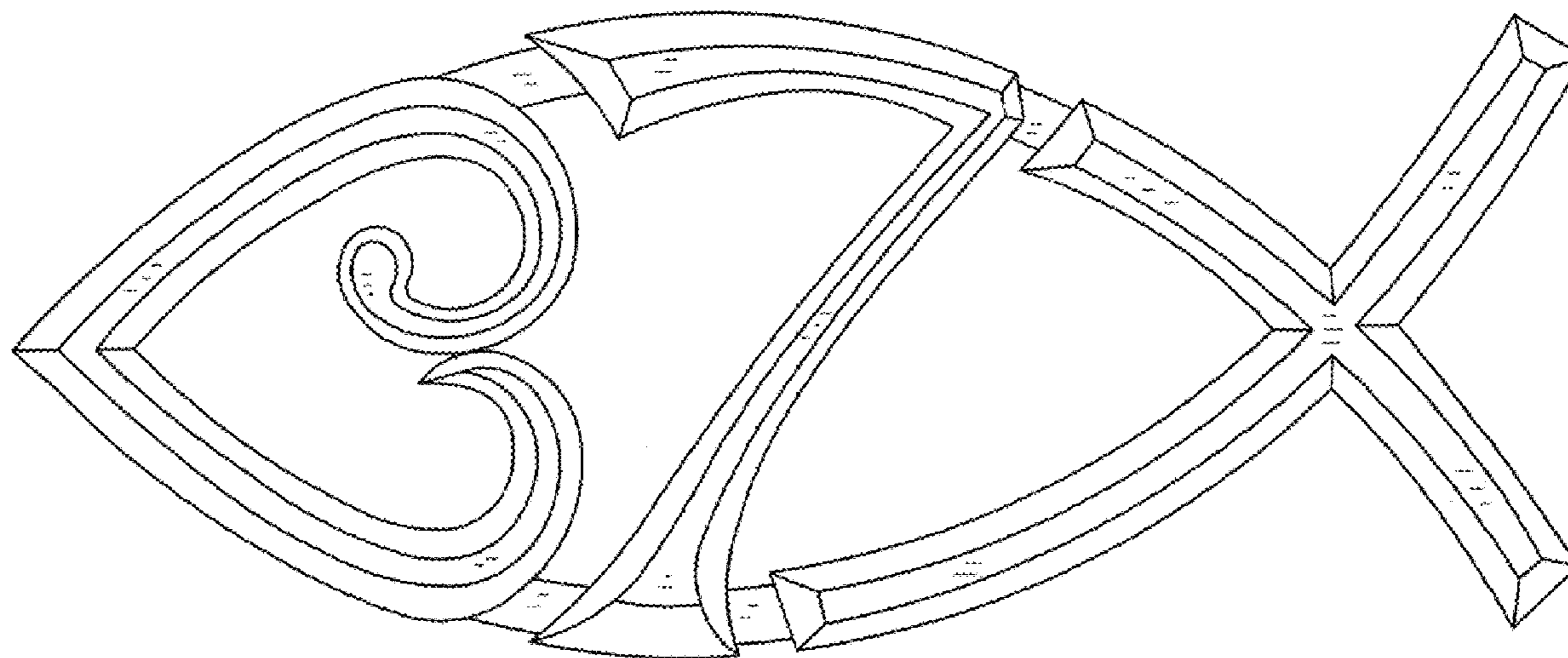
FIG. 4 is a right view of the device.

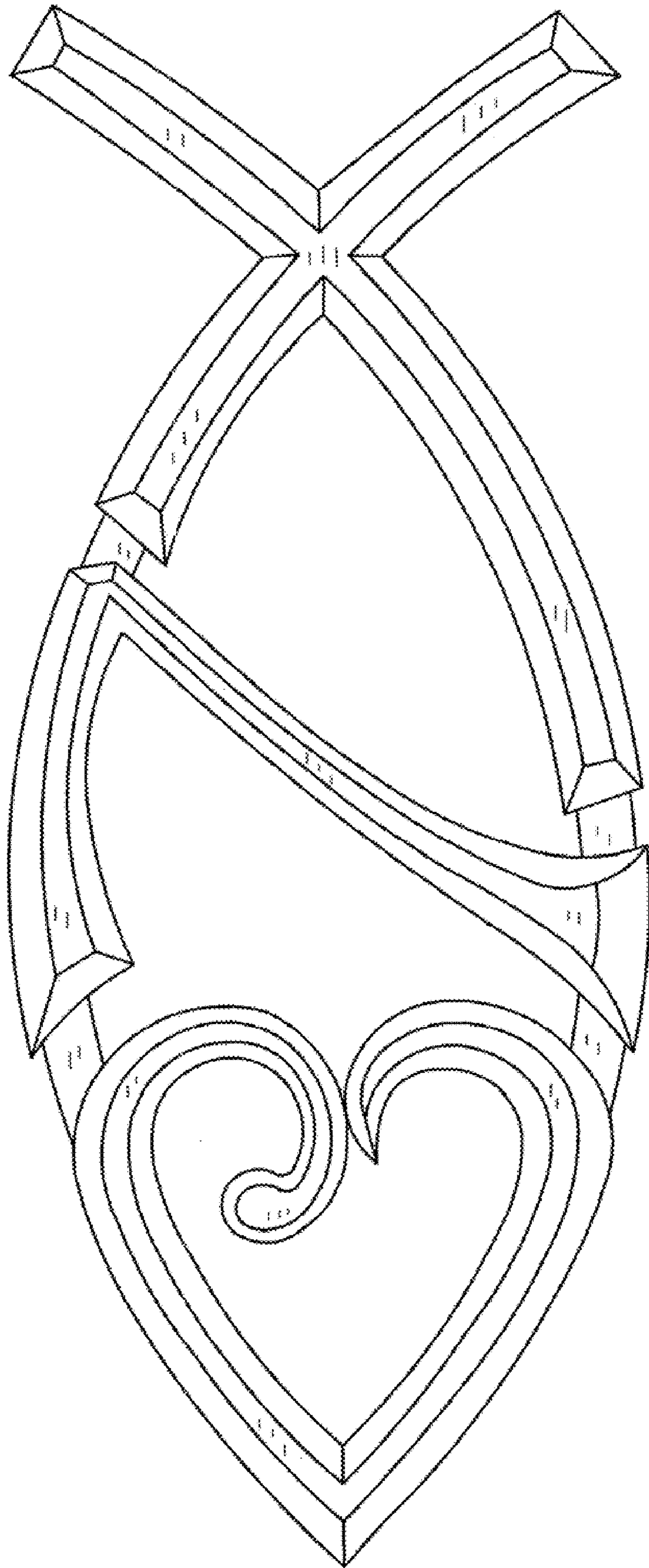

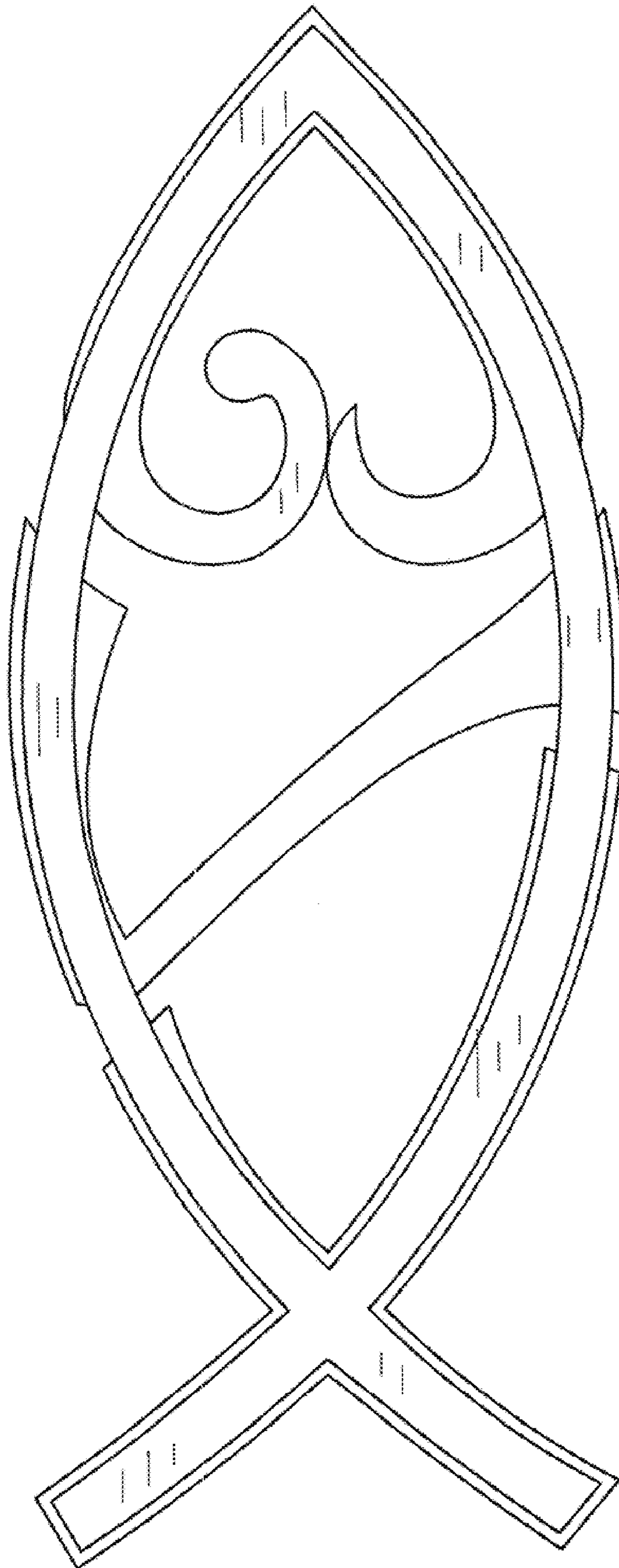

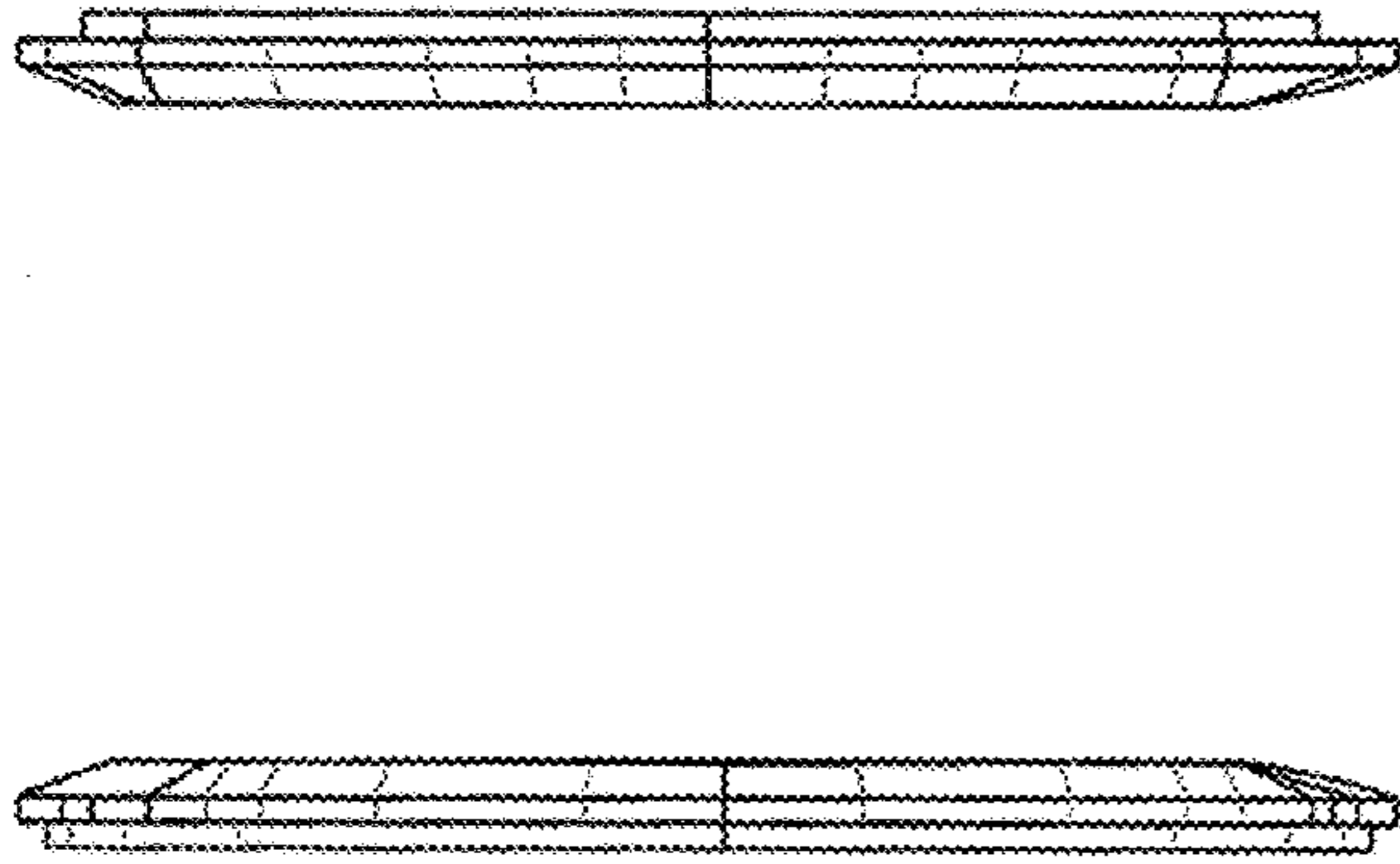


FIG. 3 FIG. 4

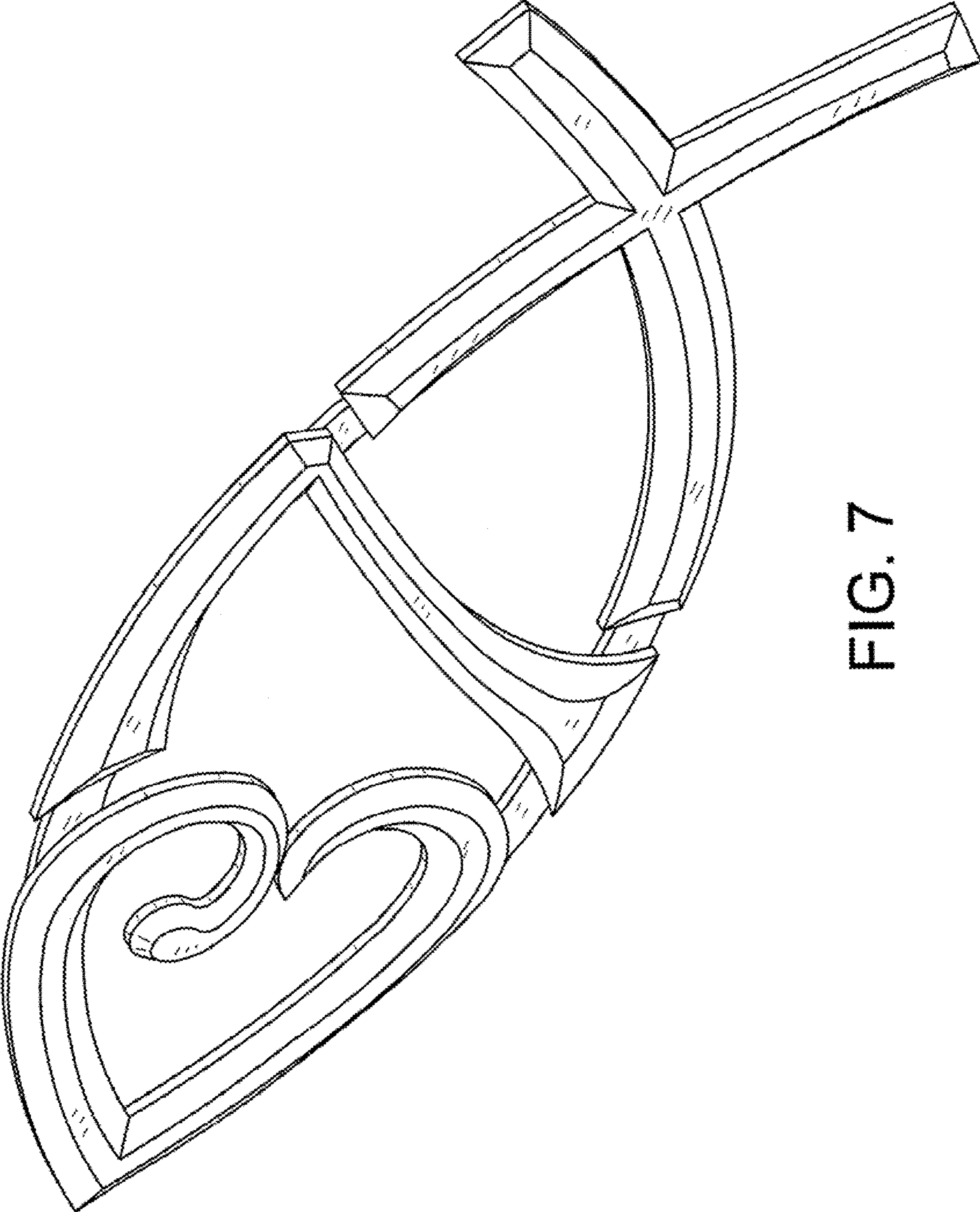
