FIG. 4 is a rear view of the charger.

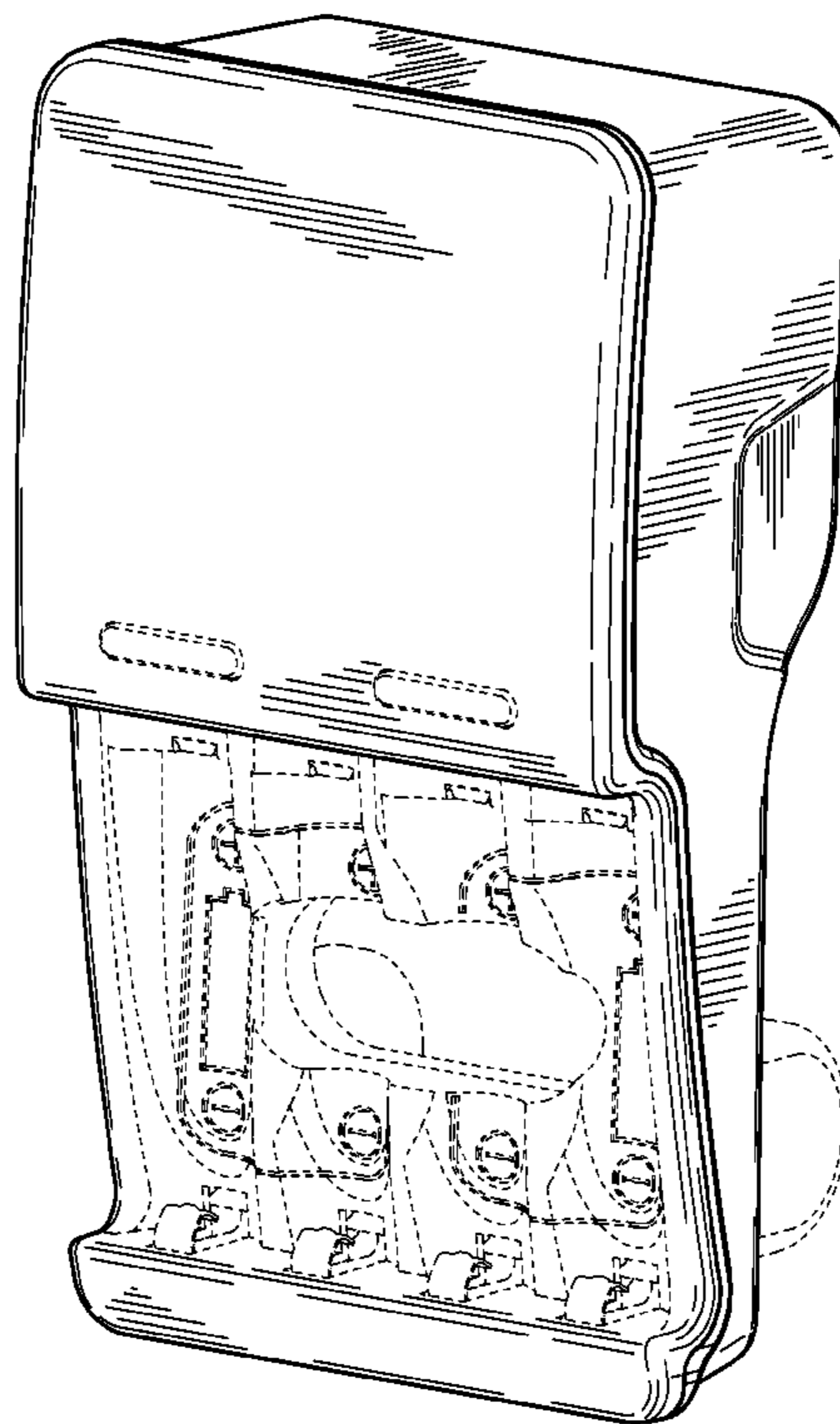
FIG. 5 is a right side view of the charger.

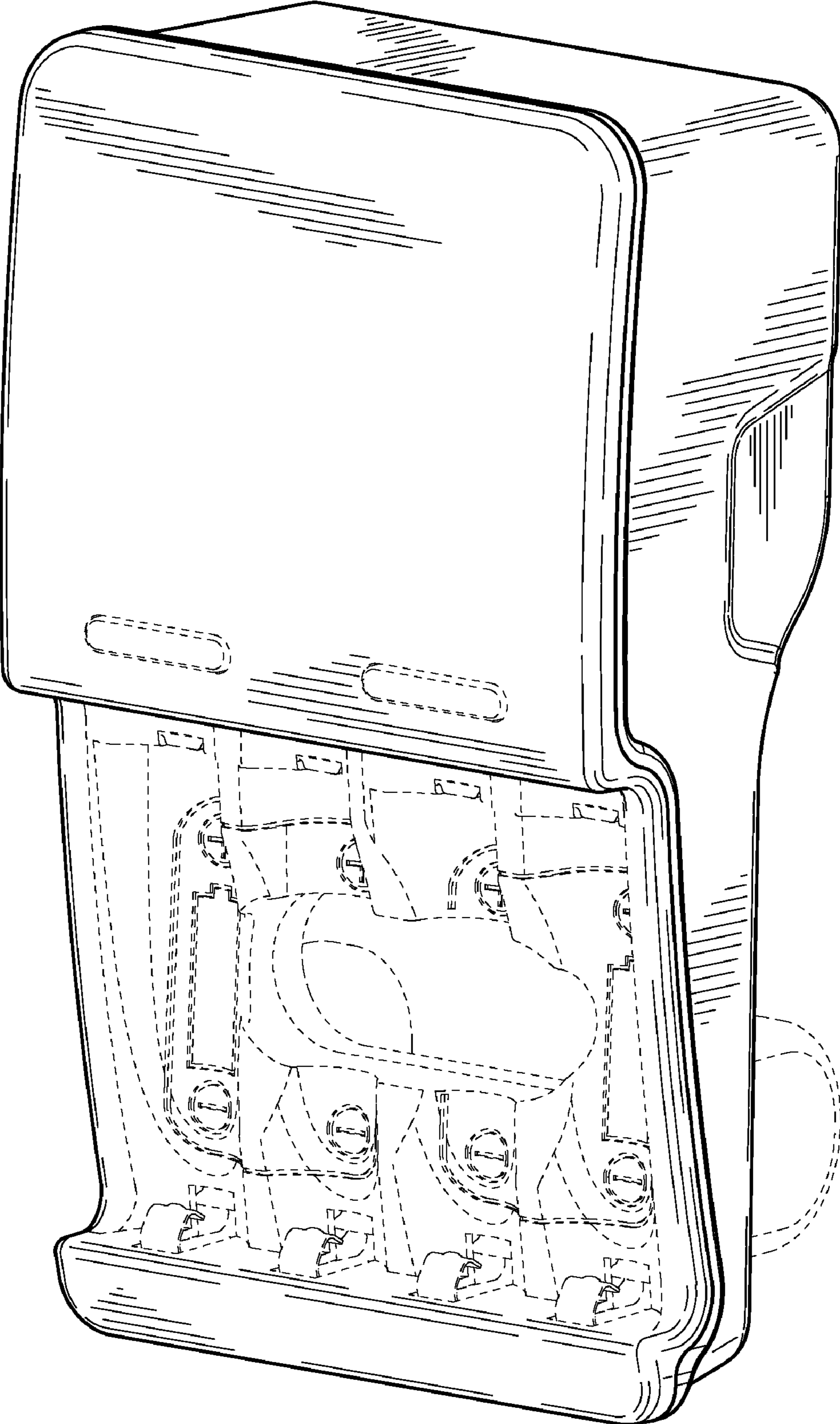

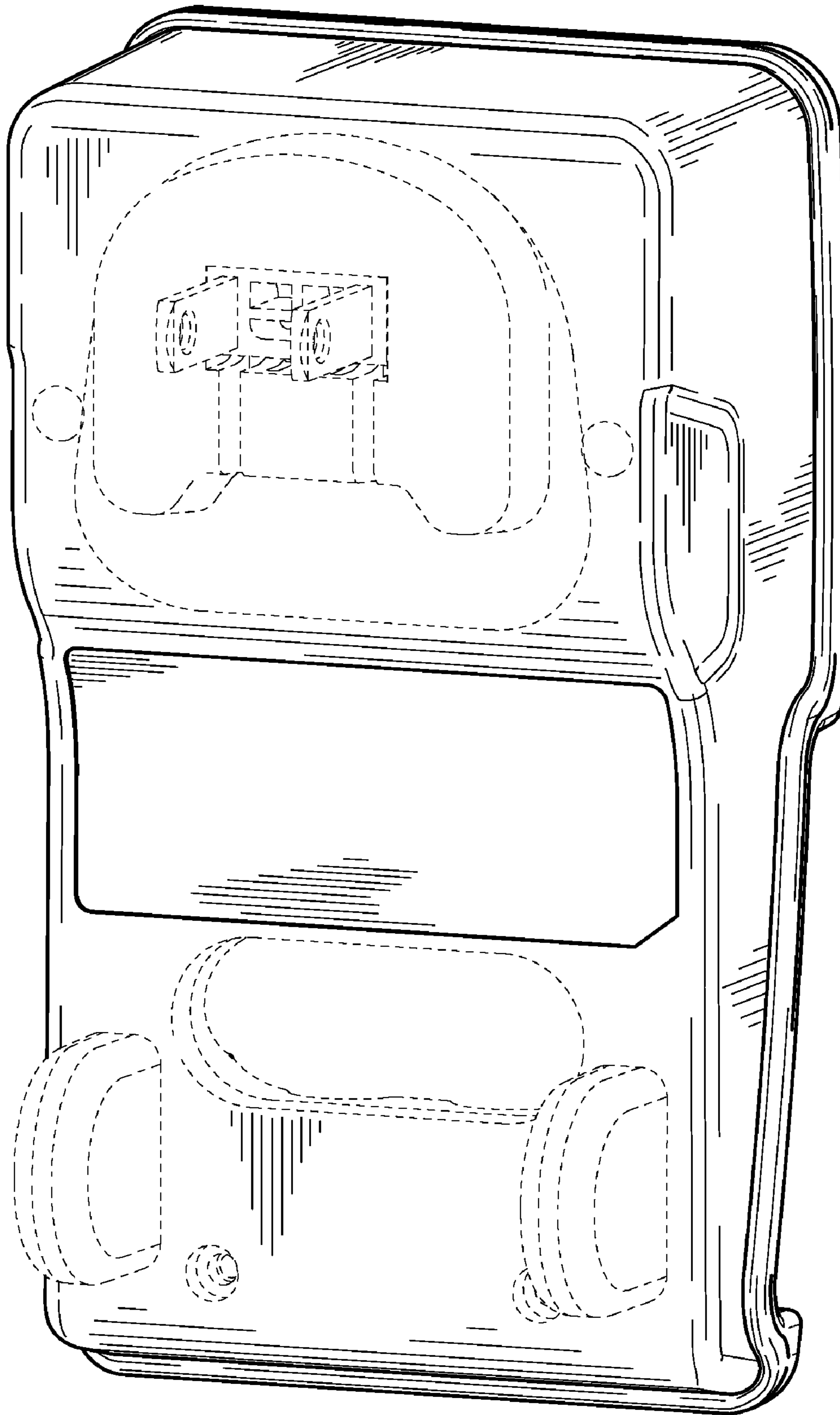

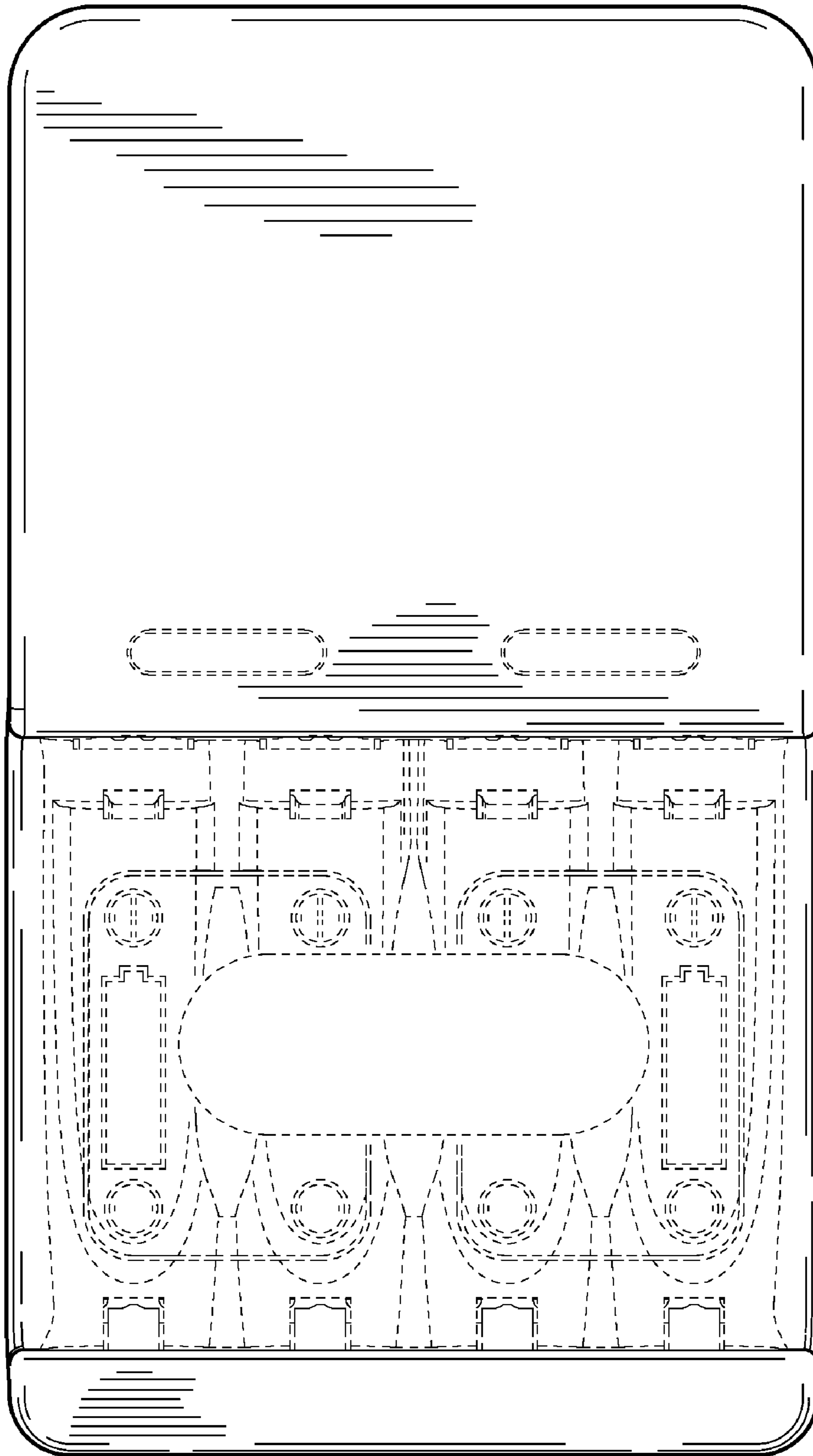

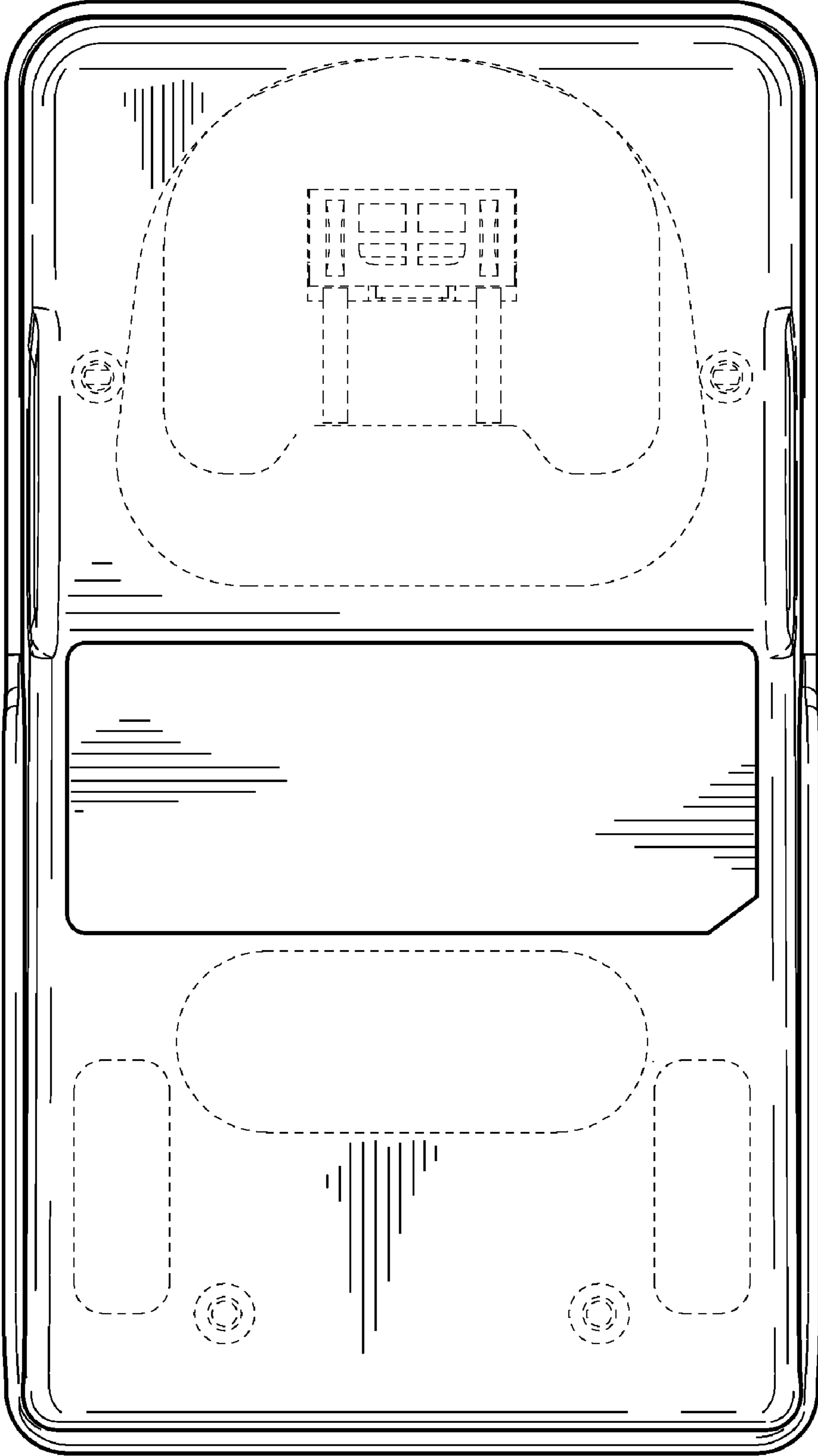

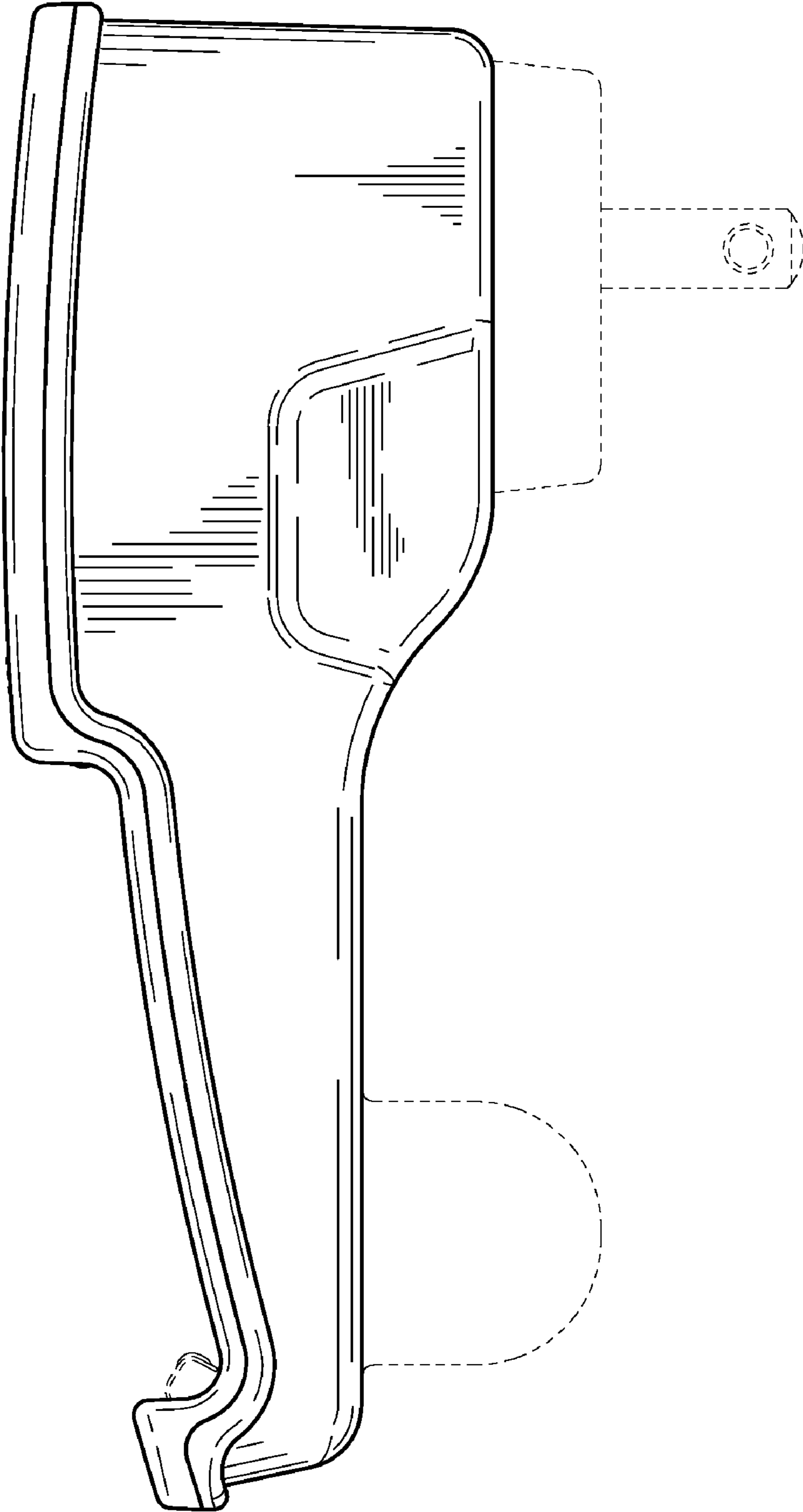

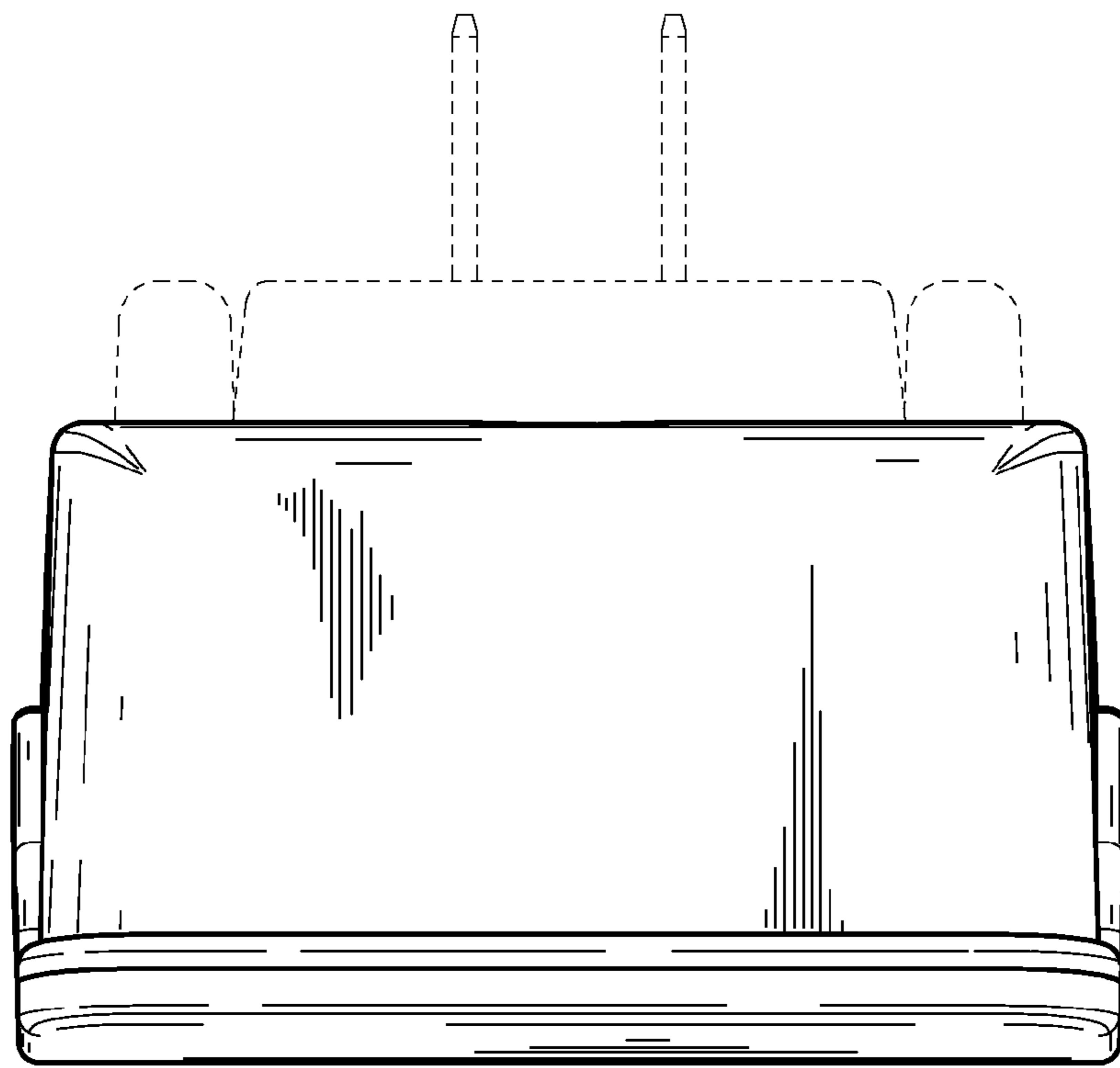

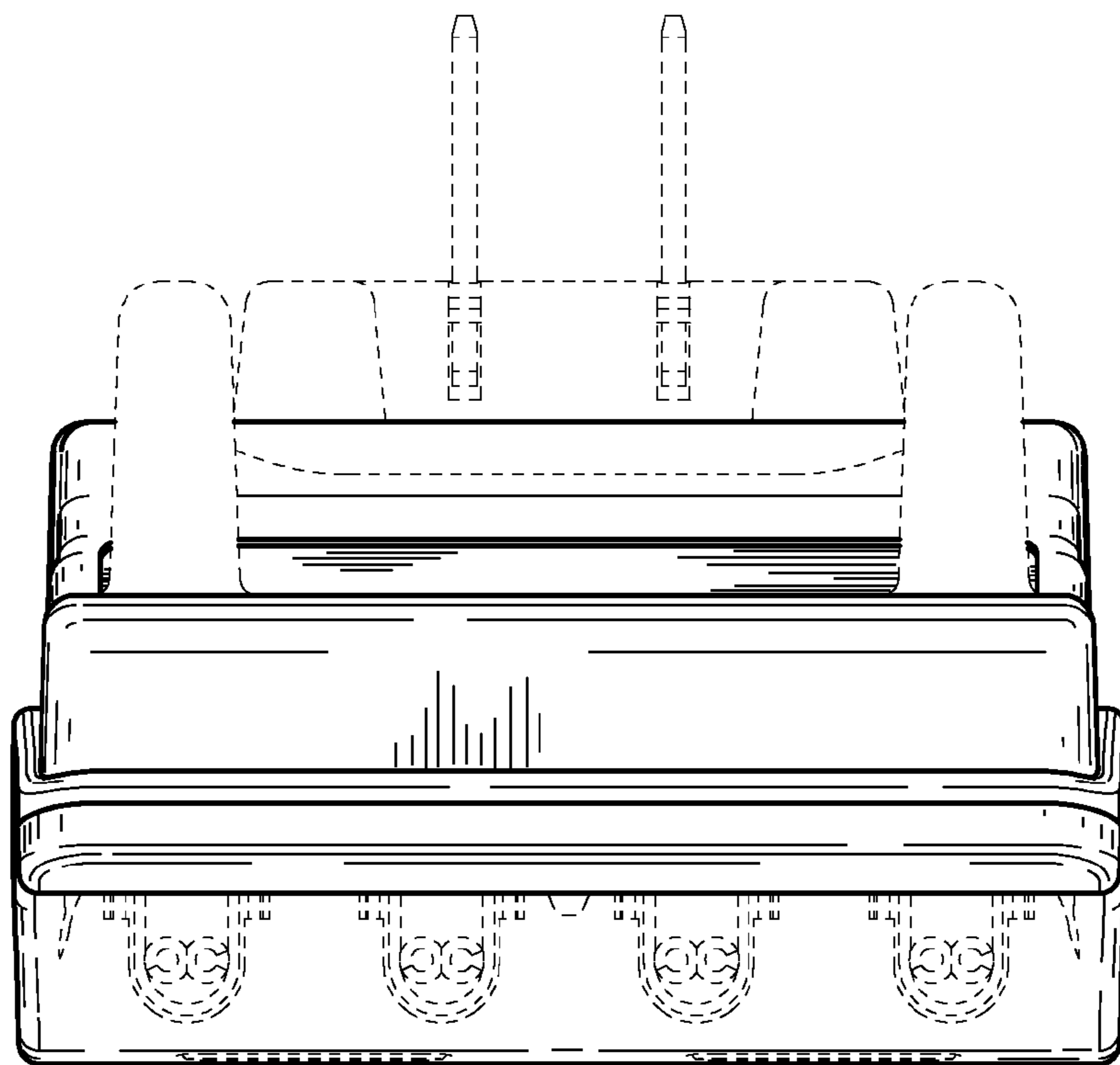
