(57) **CLAIM**

The ornamental design for a remote control for digital entertainment content, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a remote control for digital entertainment content with a bottom portion contracted;

FIG. 2 is a front perspective view of the remote control for digital entertainment content with the bottom portion expanded;

FIG. 3 is top plan view of the remote control for digital entertainment content with the bottom portion contracted;

FIG. 4 is a top plan view of the remote control for digital entertainment content with the bottom portion expanded;

FIG. 5 is a first side view of FIG. 1;

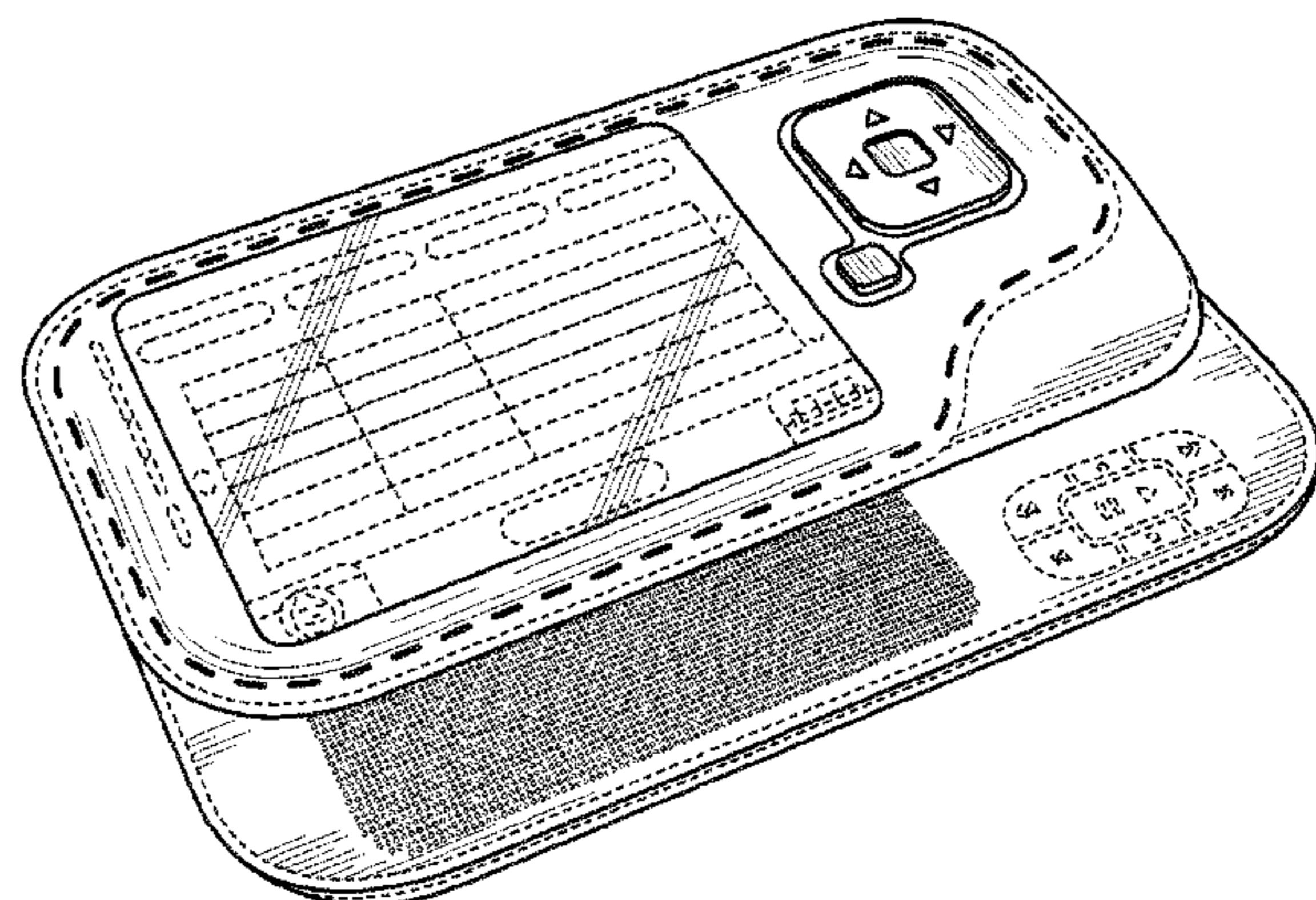
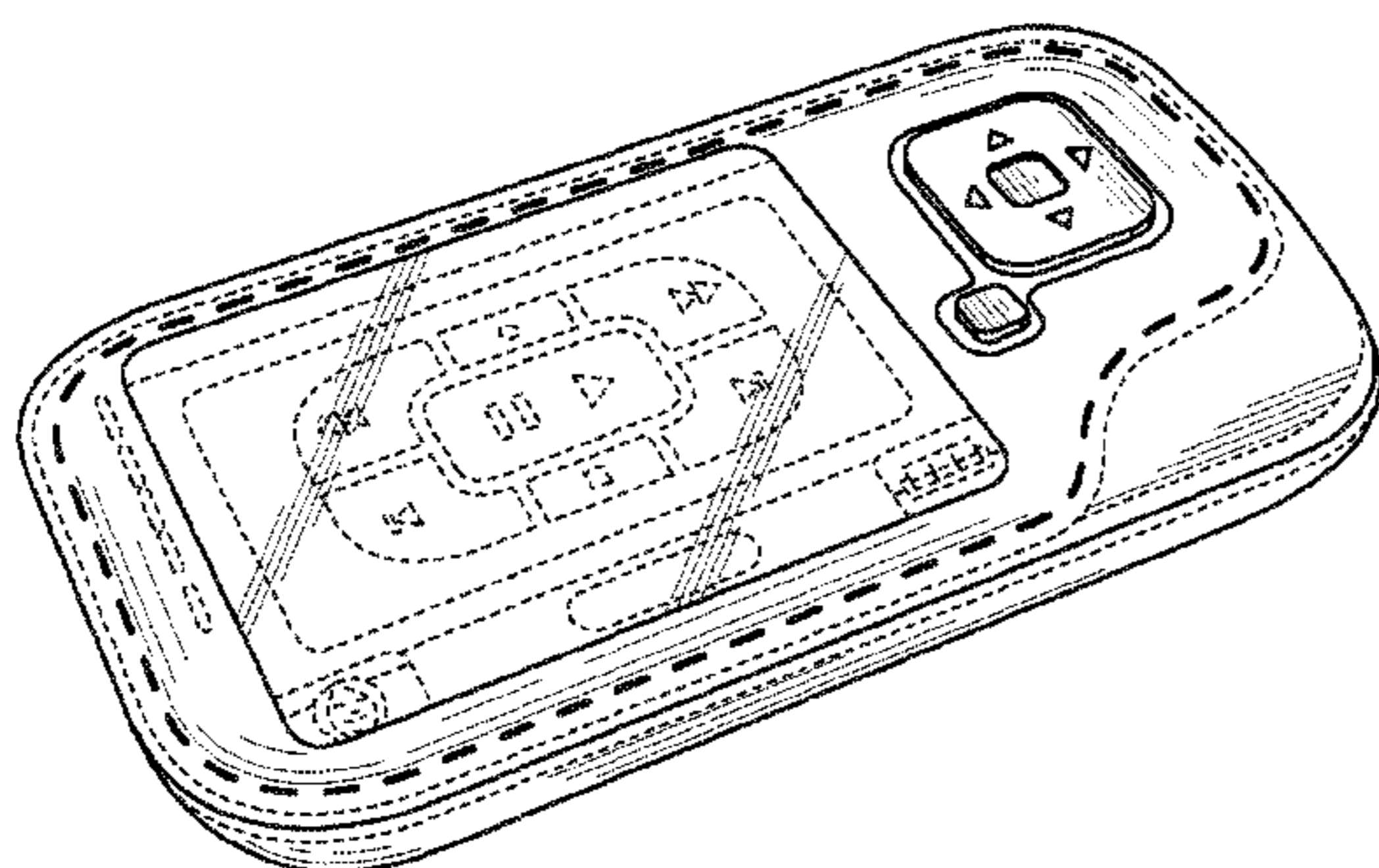
FIG. 6 is a second side view of FIG. 1;

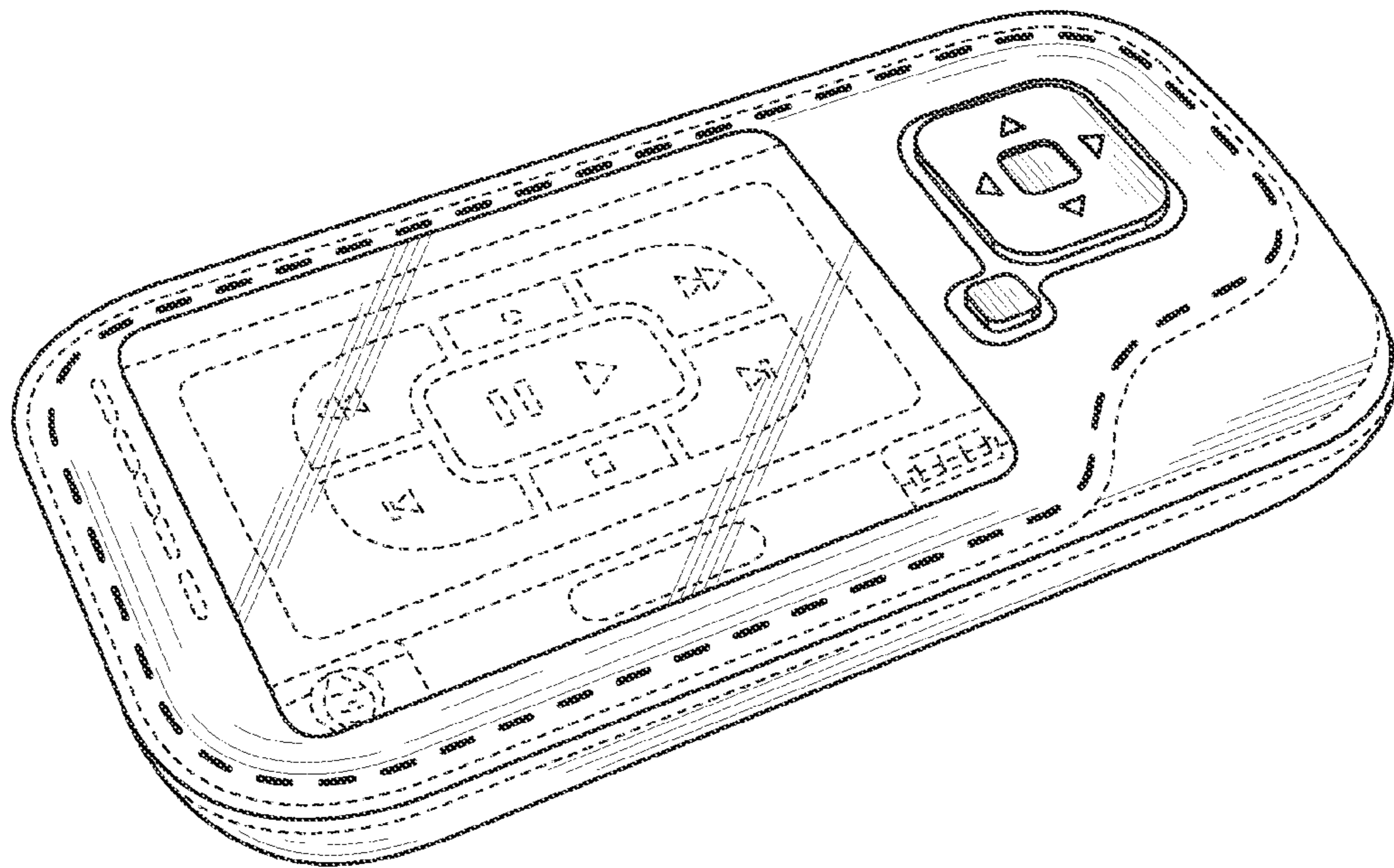

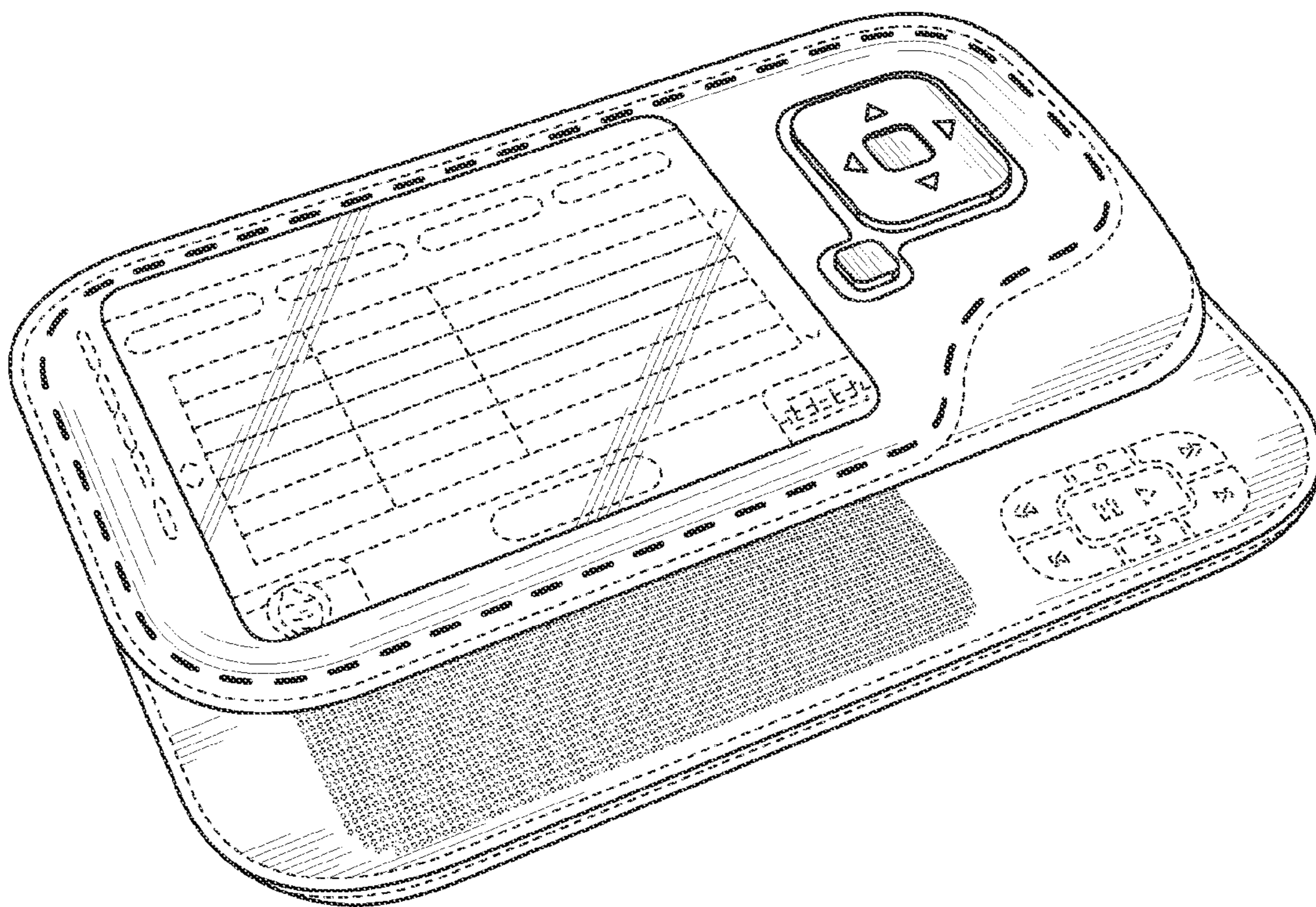

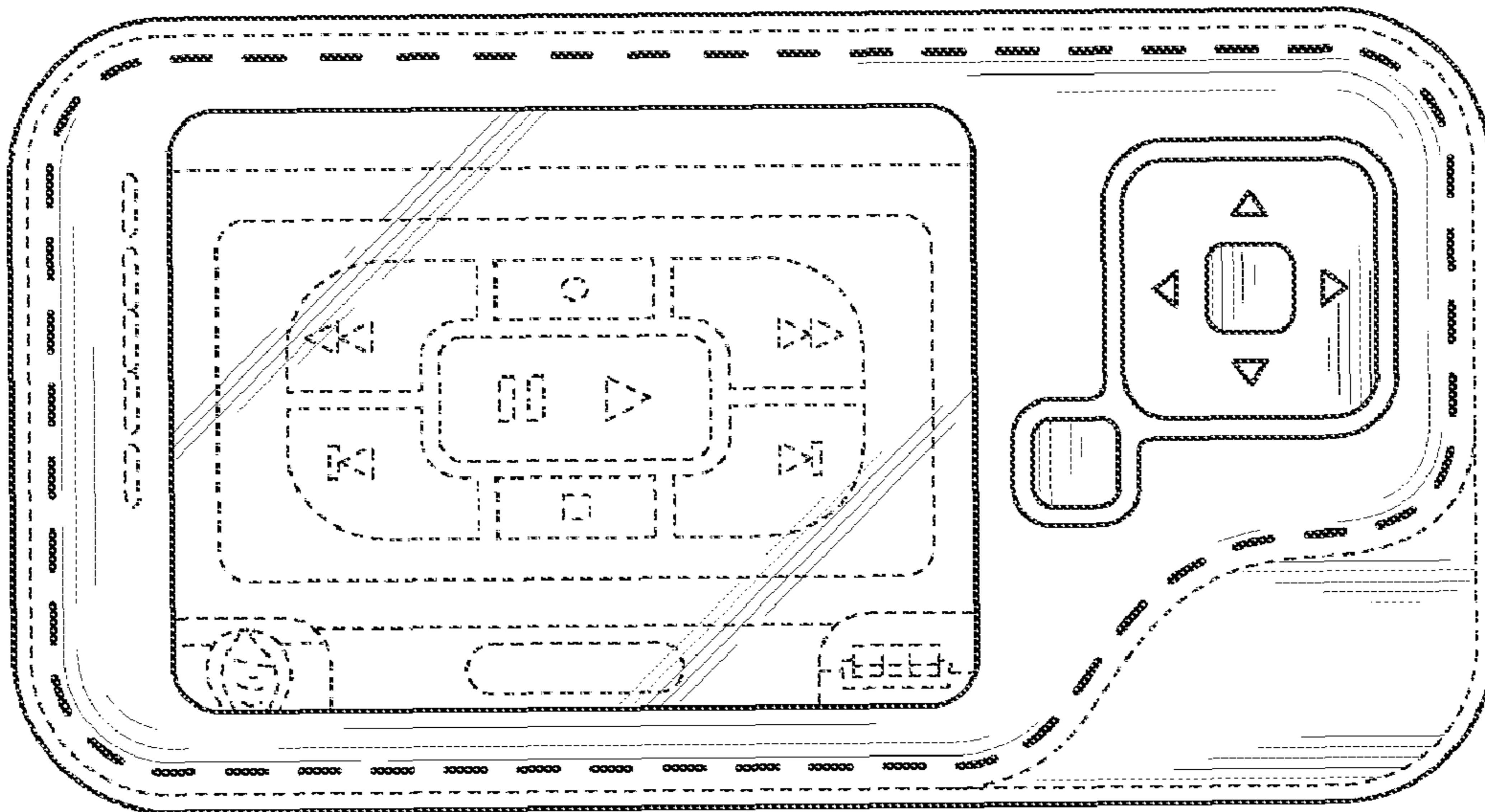

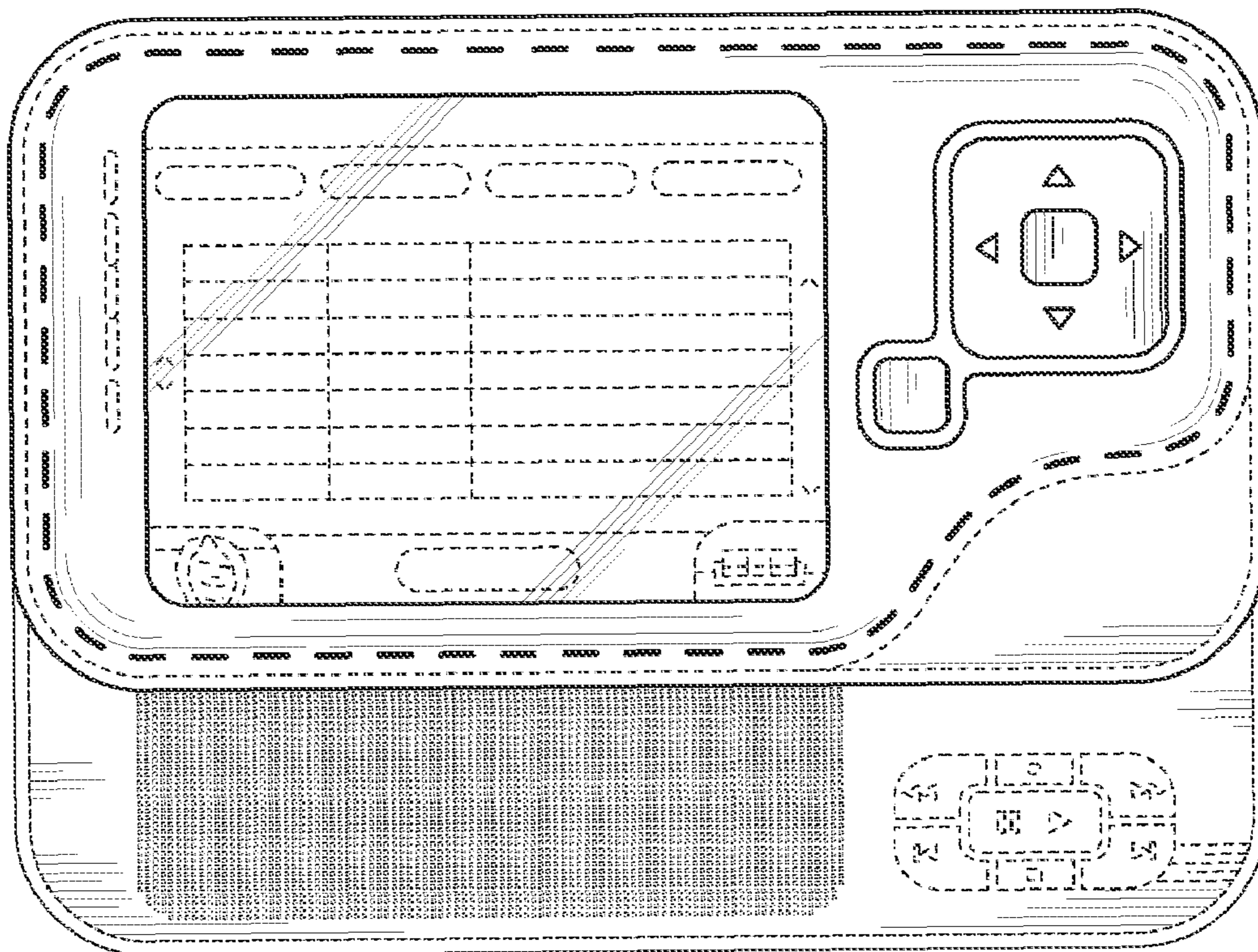

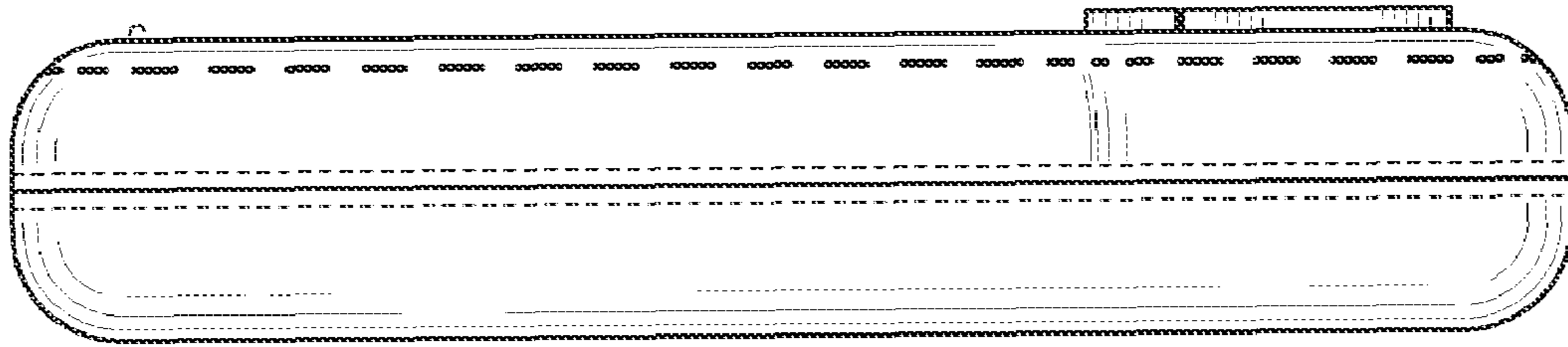

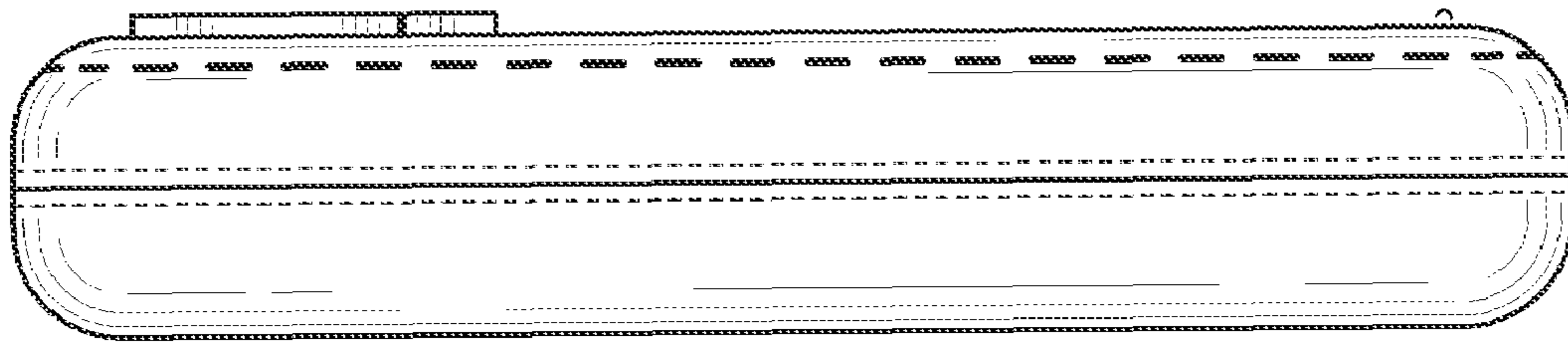

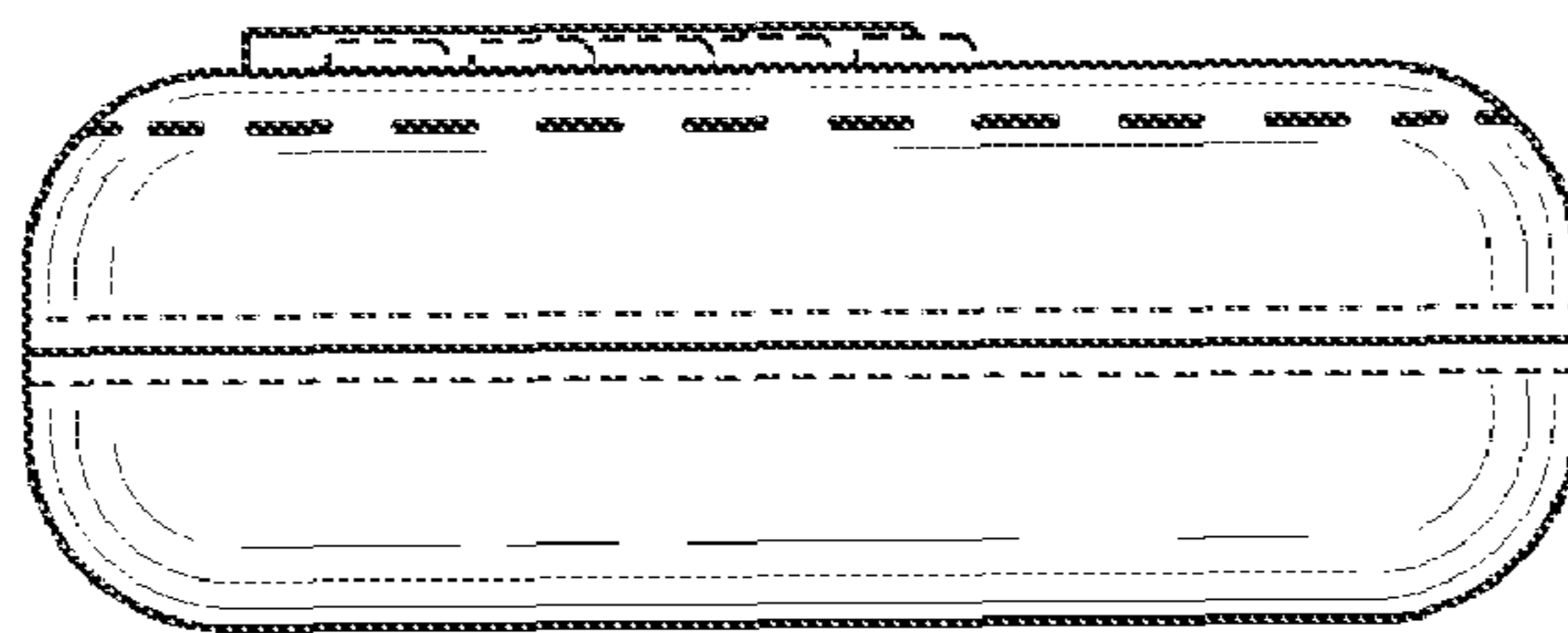

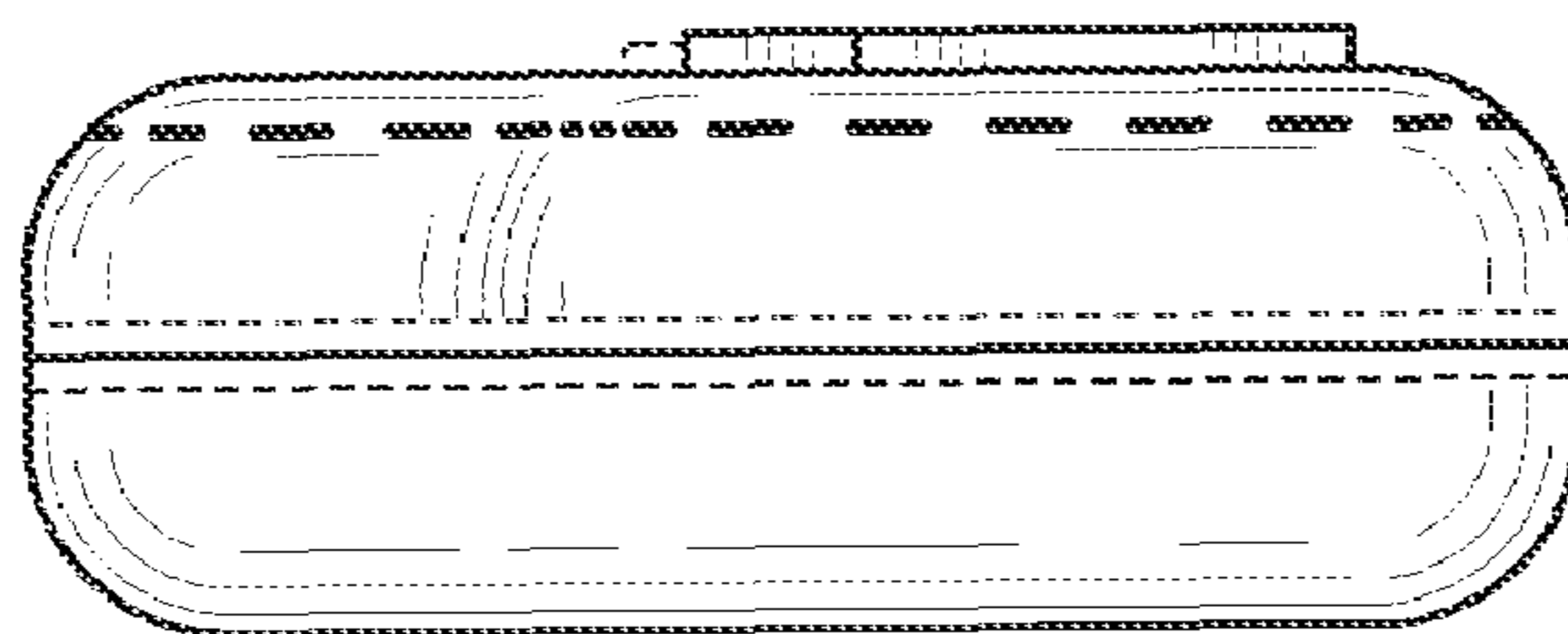
