The ornamental design for adapter plates for flat panel display  
mounting assembly, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of the adapter plates for a flat  
panel display mounting assembly;

FIG. 2 is a rear elevation view thereof;

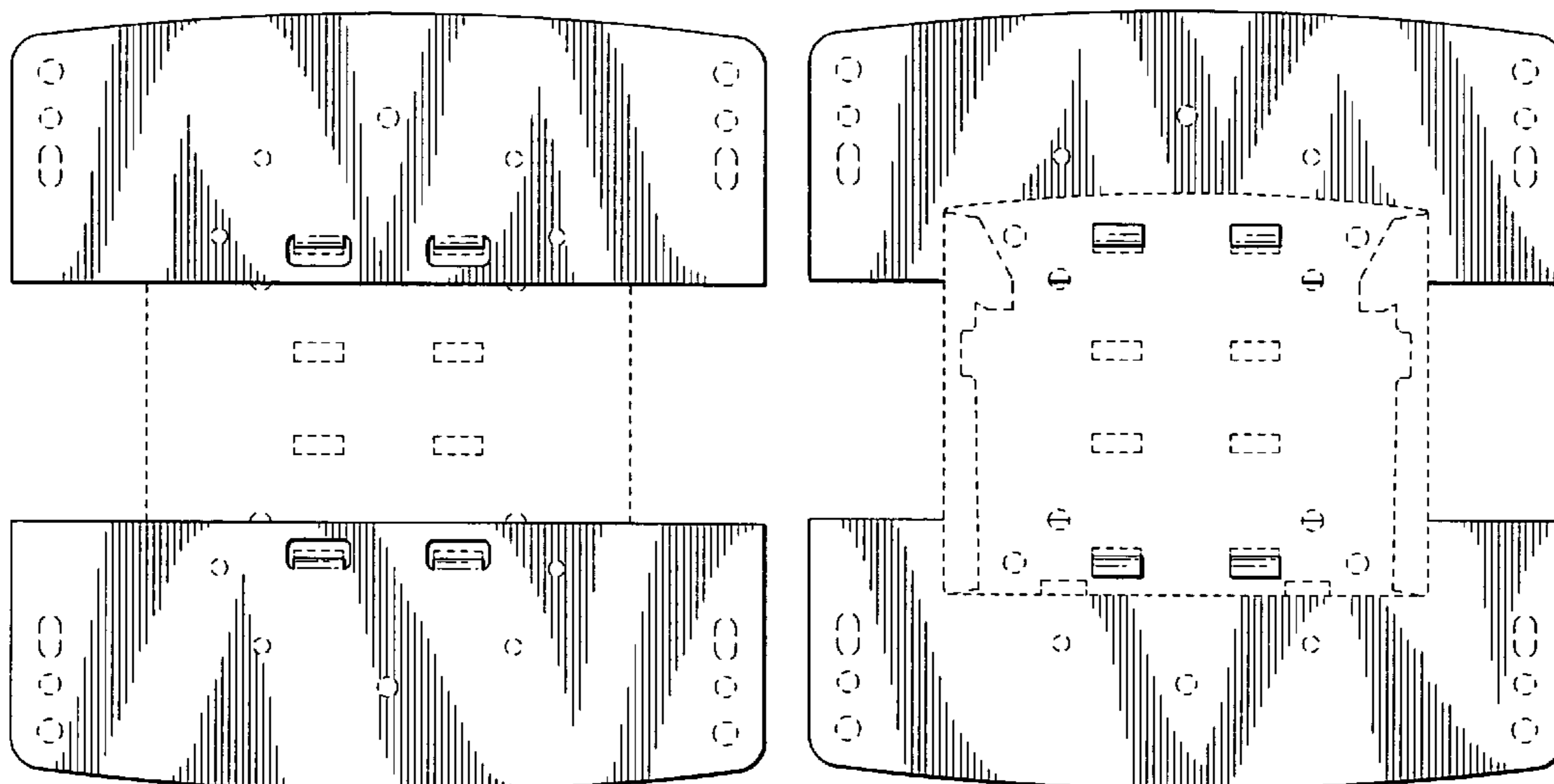
FIG. 3 is a right side view thereof (the left side view being a

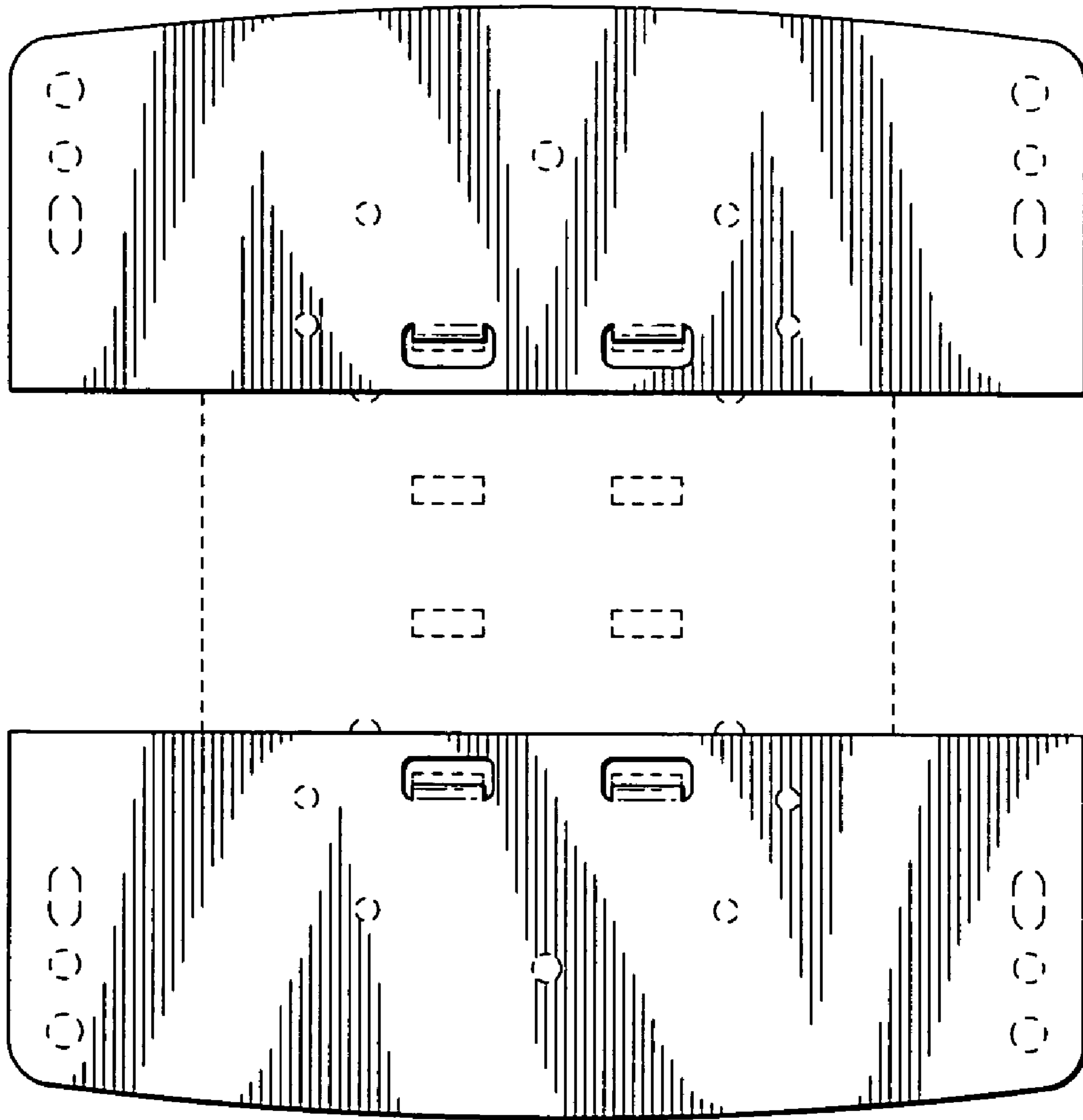

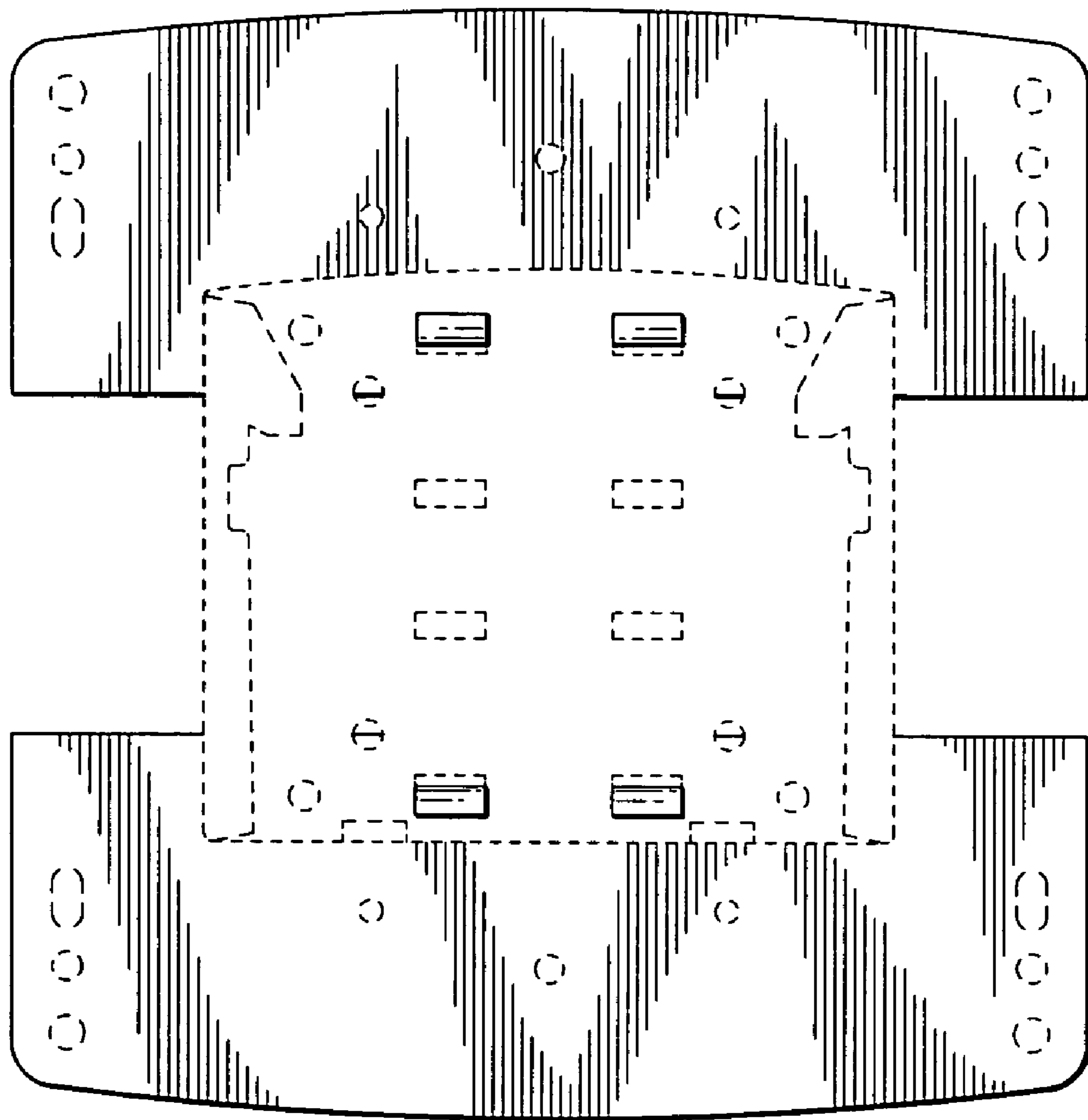

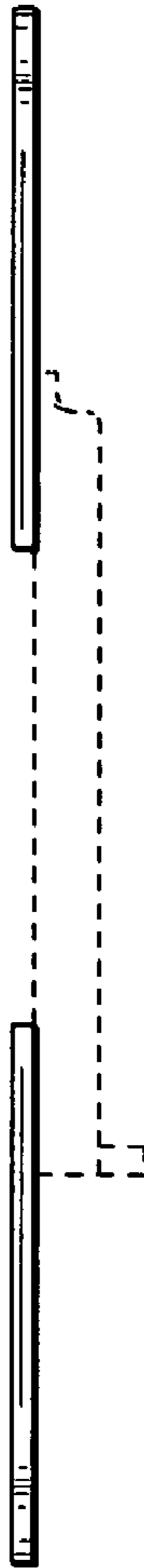

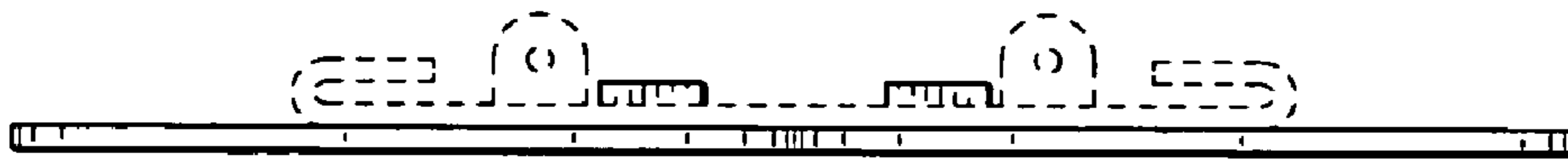
