(57) **CLAIM**

The ornamental design for goggles with face drape, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of the goggles with face drape; the shading illustrated in cross-hatch is for illustrative purposes only and forms no part of the claimed design; the goggles and/or face drape may additionally have shapes imprinted or otherwise shown thereon (e.g., camouflage, polygons, letters, not depicted), which shapes do not form any part of the claimed design;

FIG. 2 is a front elevational view thereof; an exemplary camouflage pattern is shown in broken line for illustrative purposes only and forms no part of the claimed design;

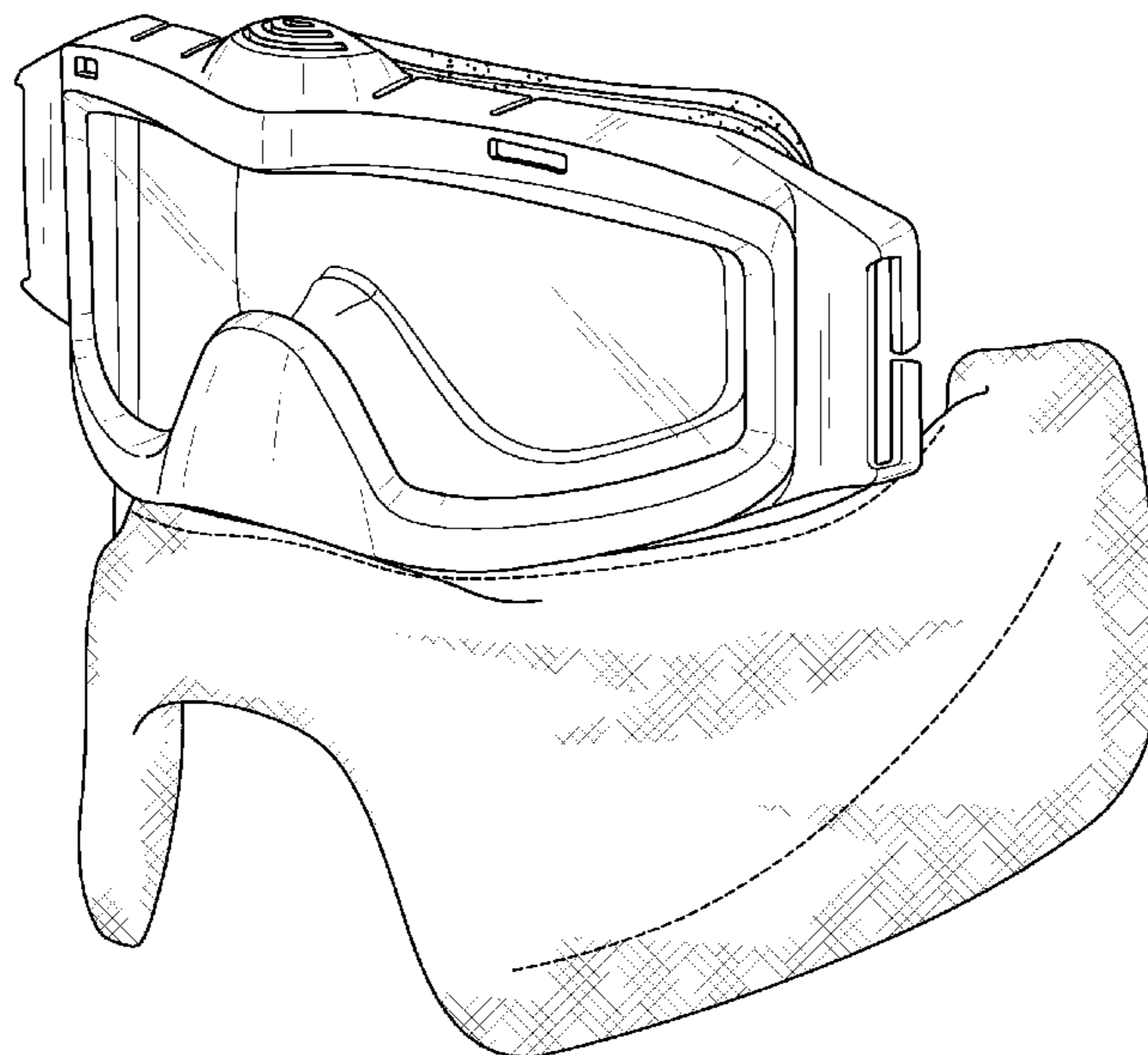
FIG. 3 is a rear elevational view thereof; an exemplary camouflage pattern is shown in broken line for illustrative purposes only and forms no part of the claimed design;

FIG. 4 is a first side elevational view thereof, the opposite side being symmetrical and thus not included herein as a separate figure;

FIG. 5 is a bottom plan view thereof; and,

FIG. 6 is a top plan view thereof.

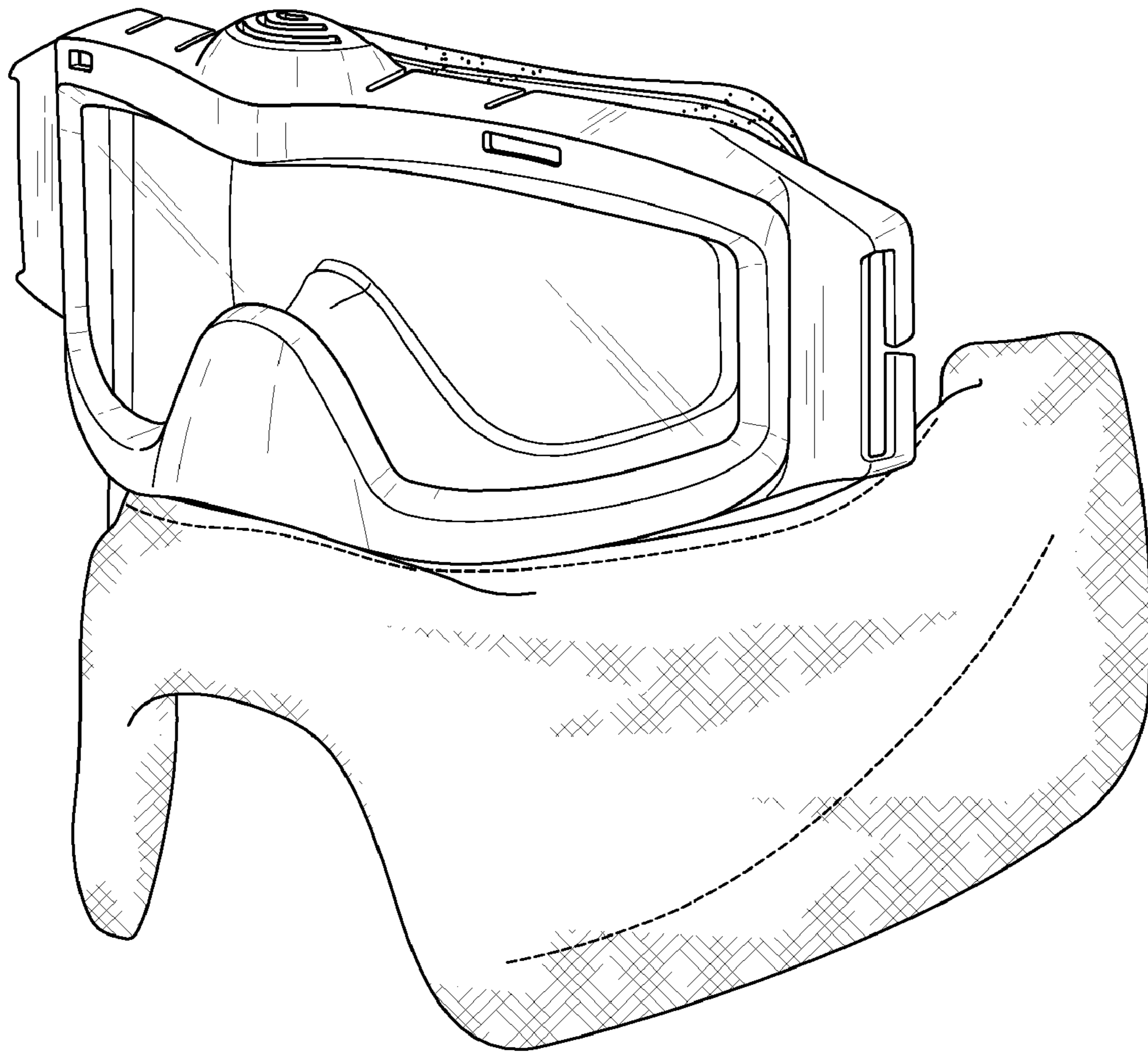

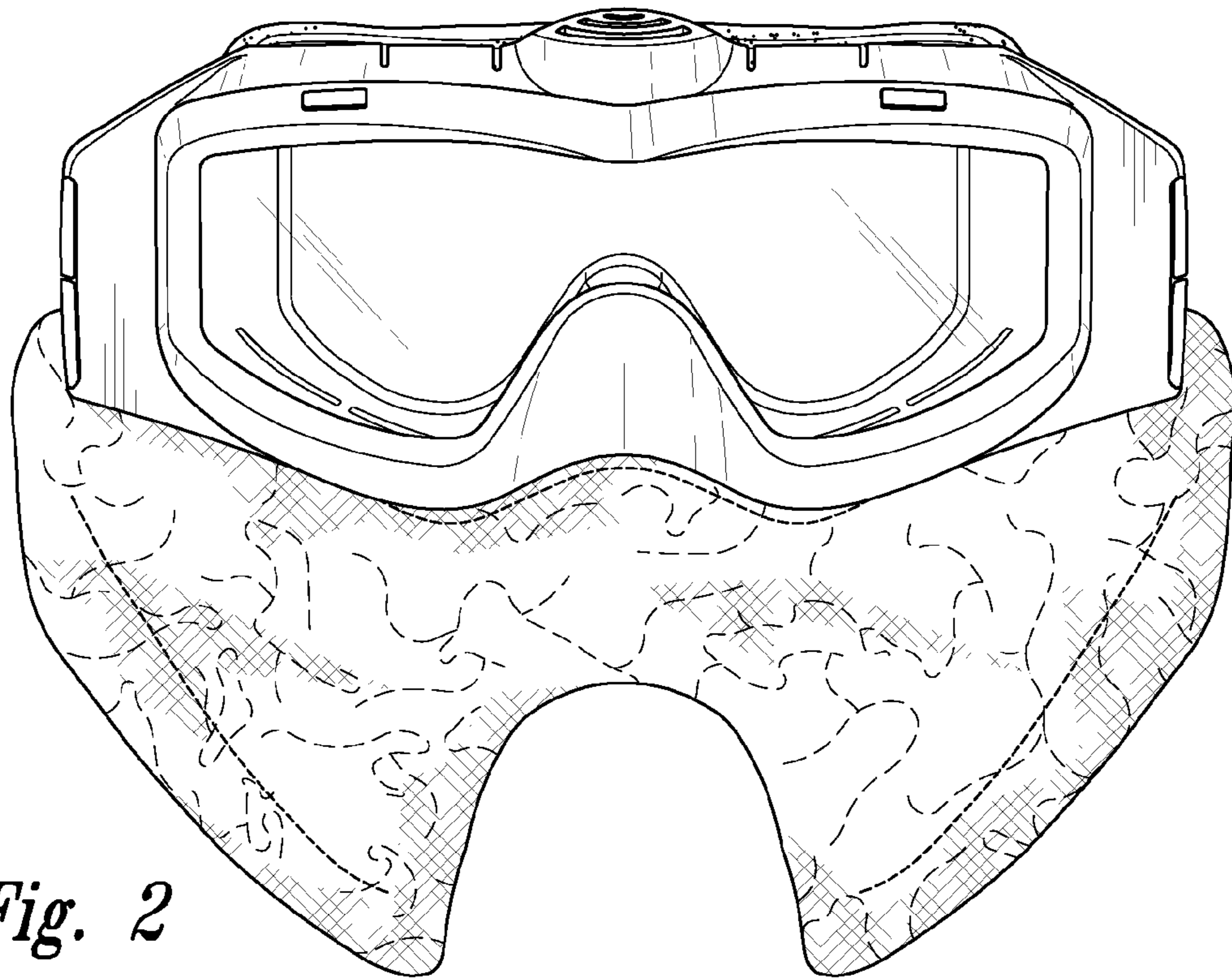

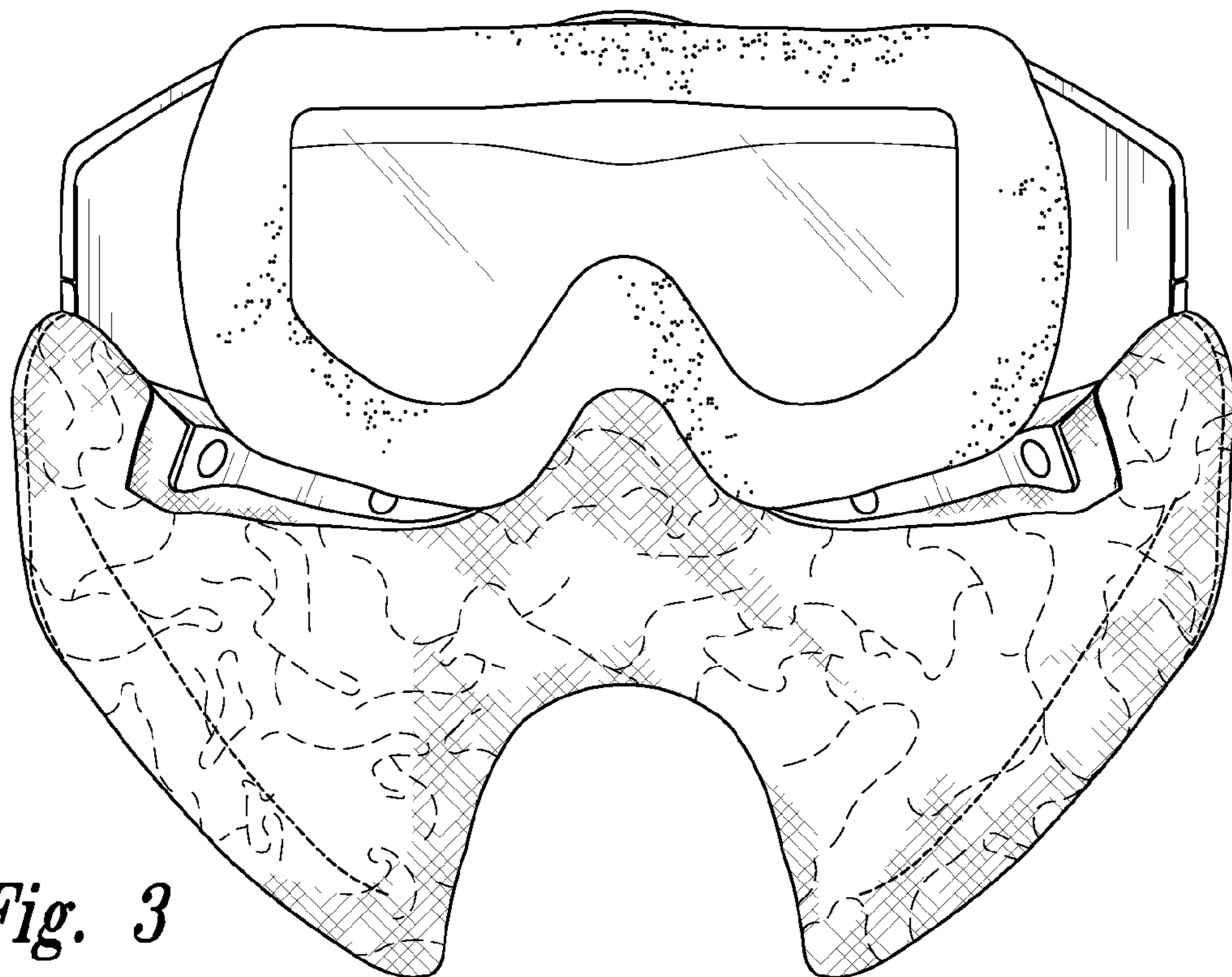

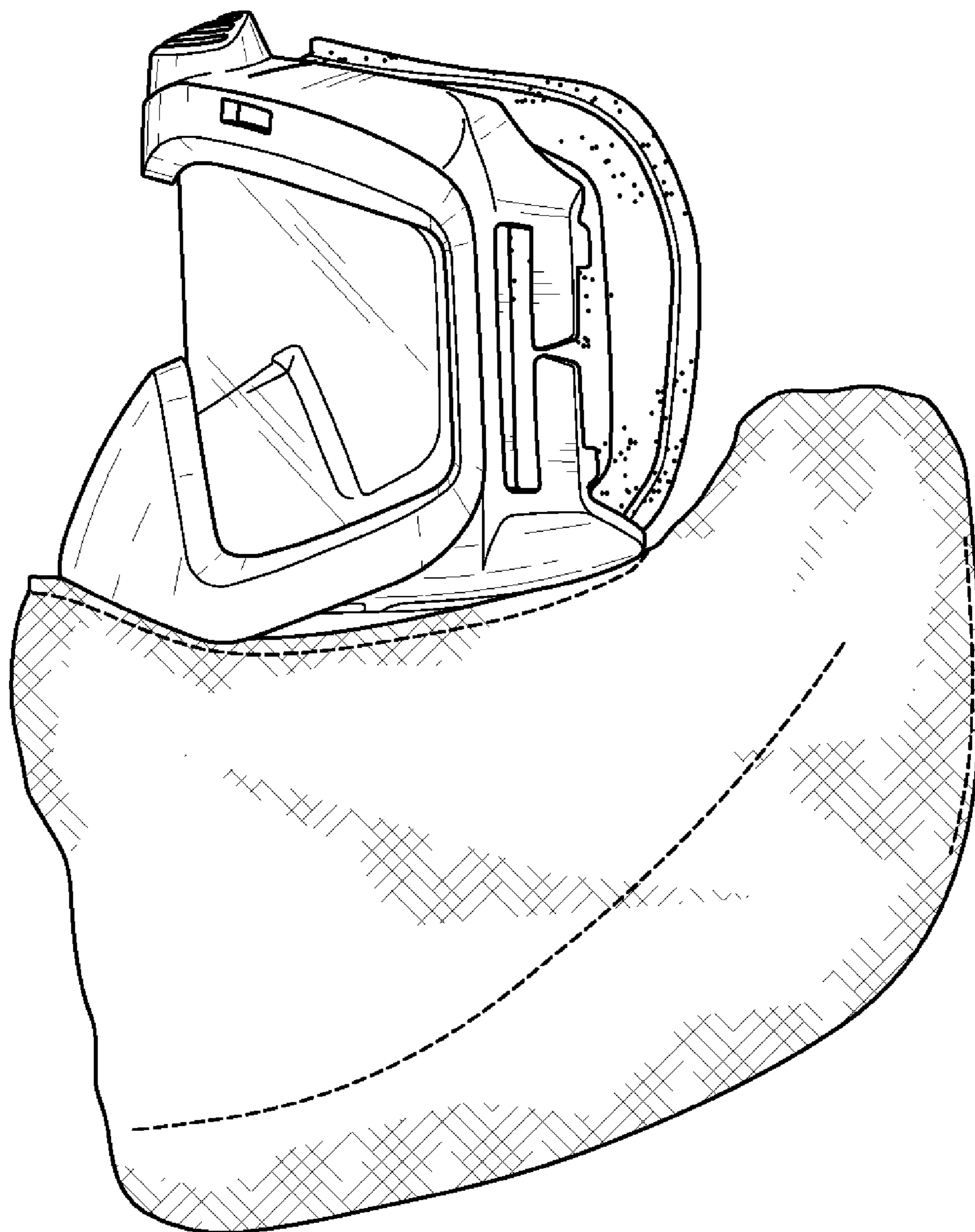

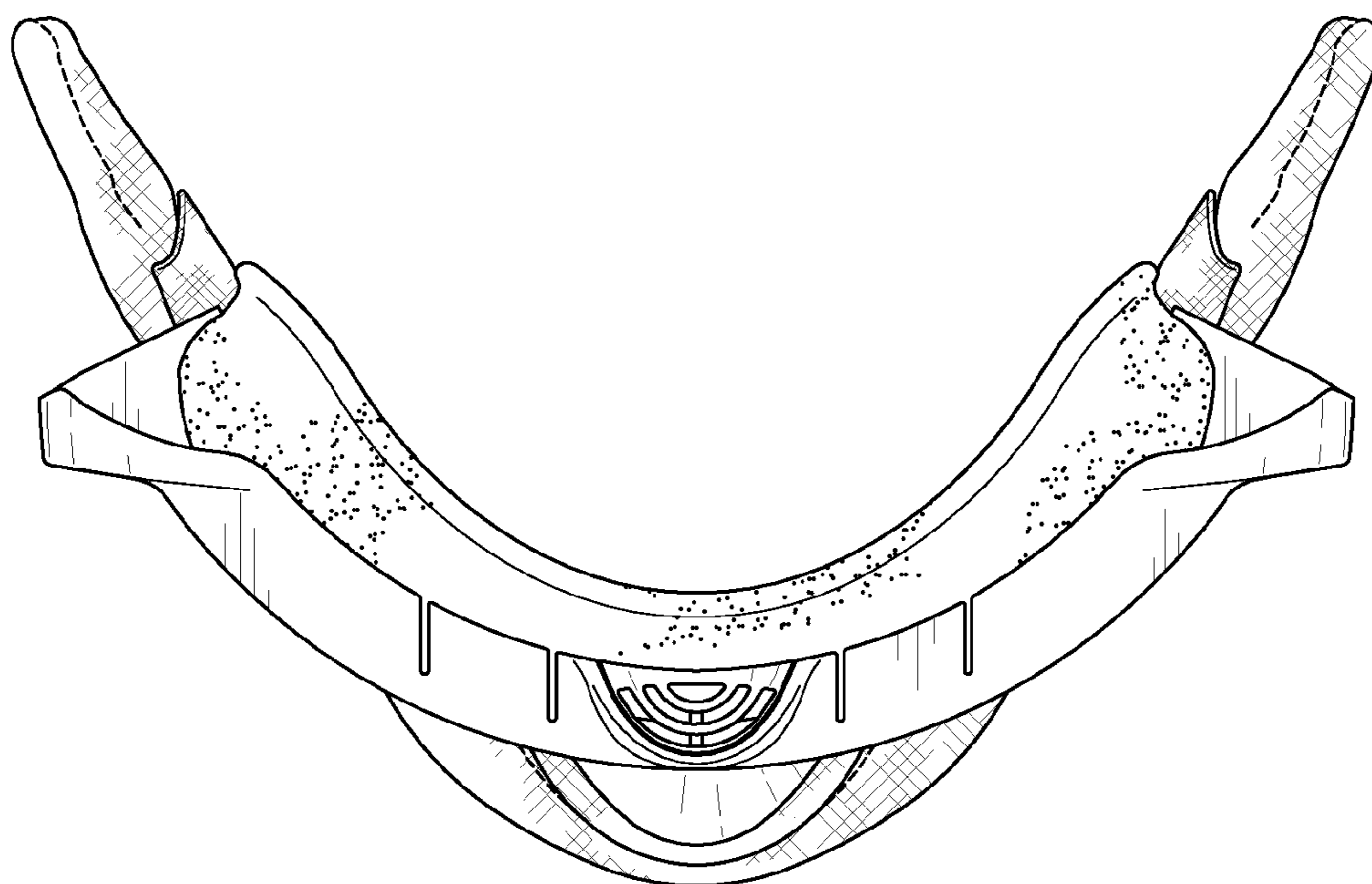

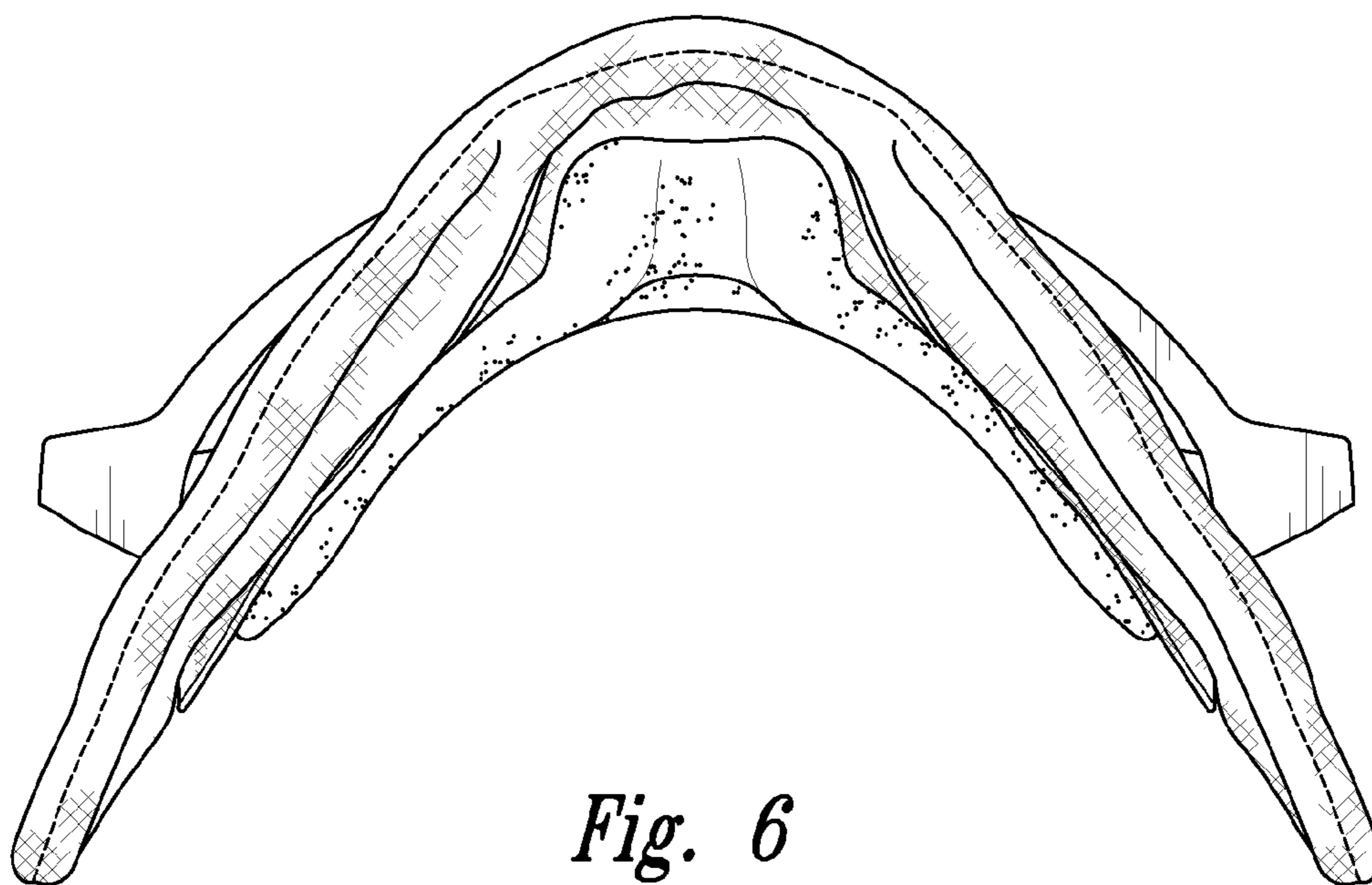
